FIG. 3 is the left side view of the toe protector of FIG. 1;

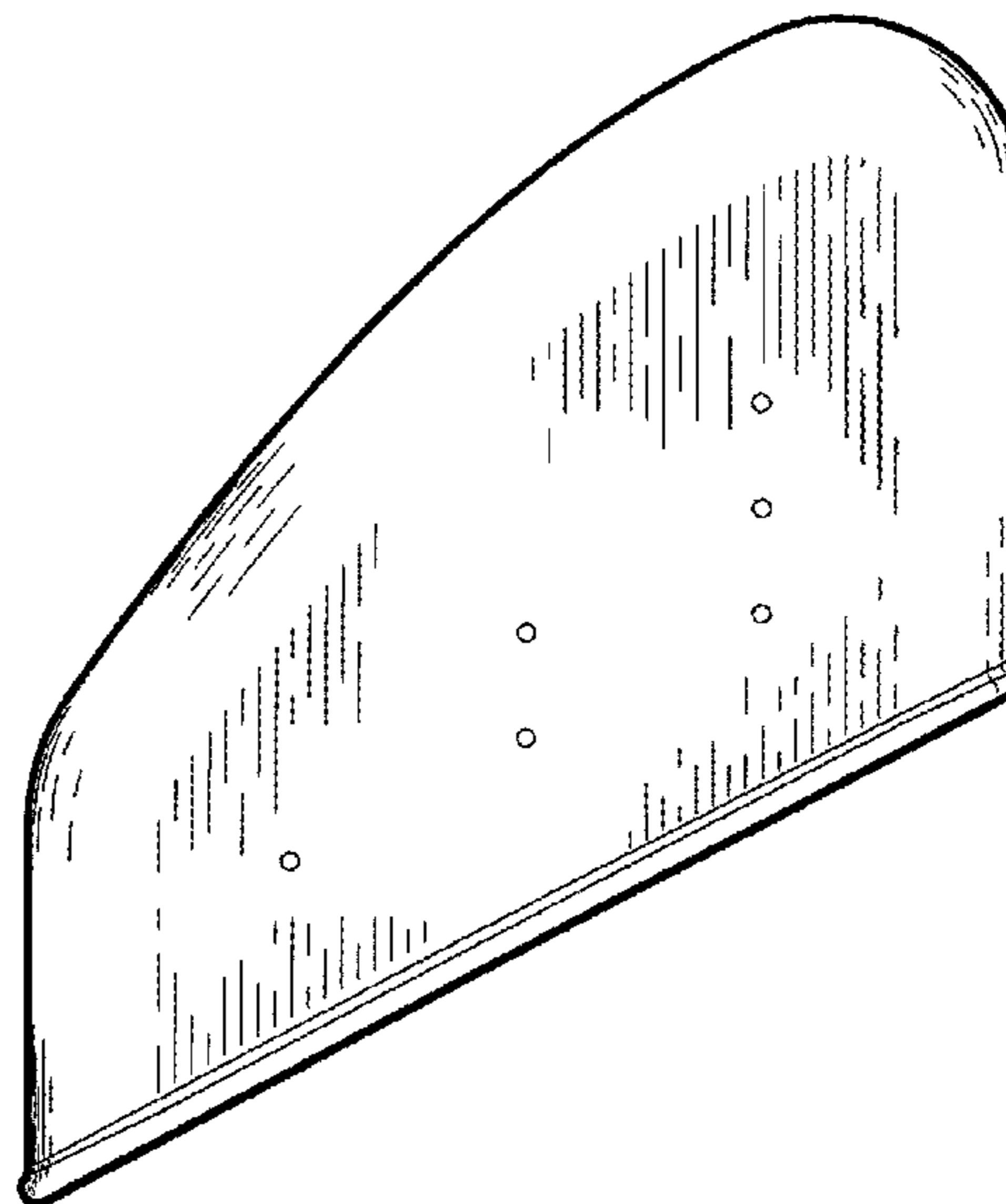
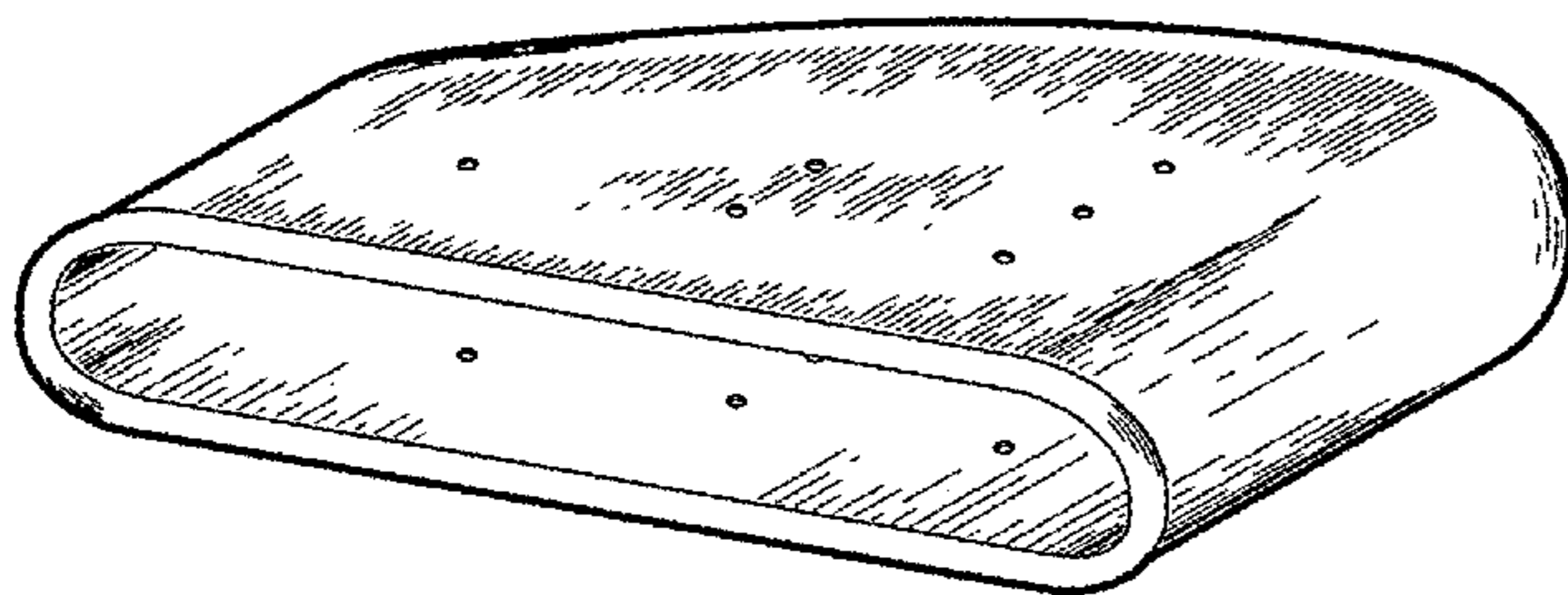
FIG. 4 is the right side view of the toe protector of FIG. 1;

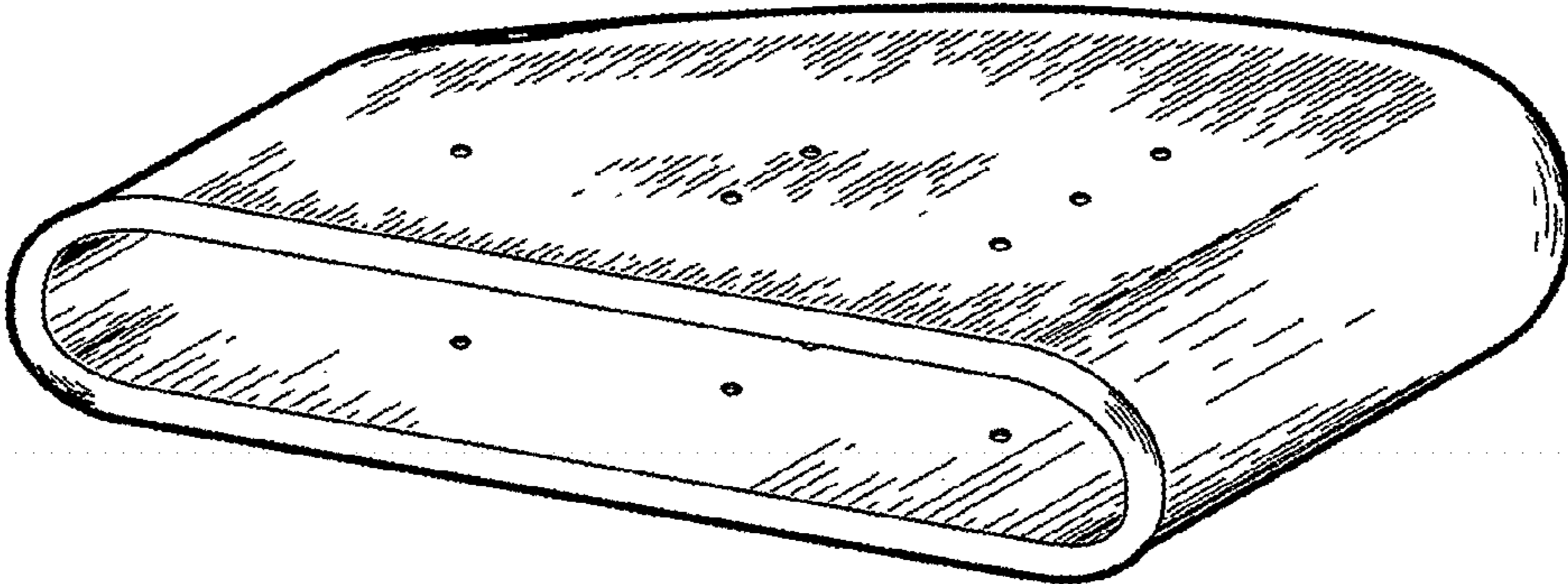

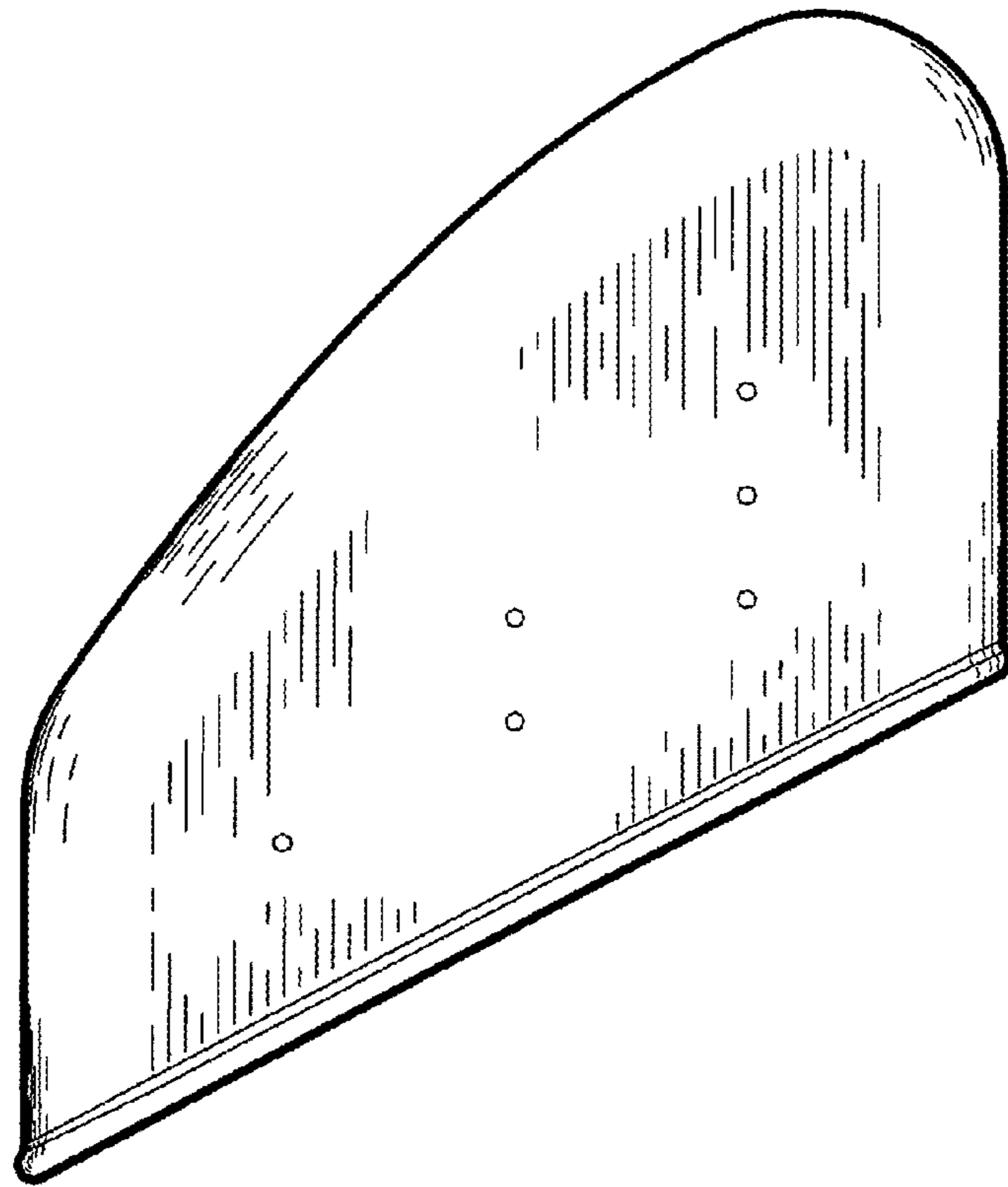

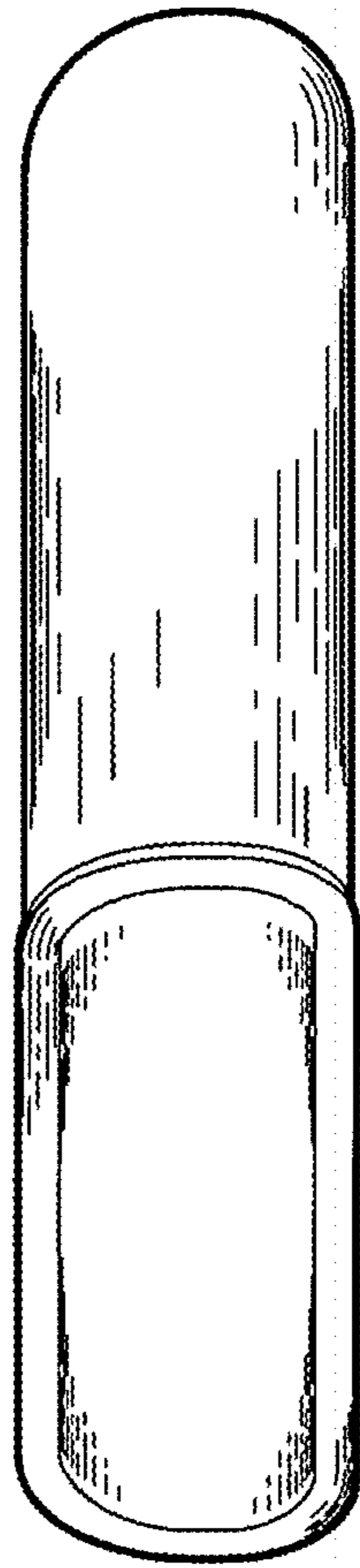

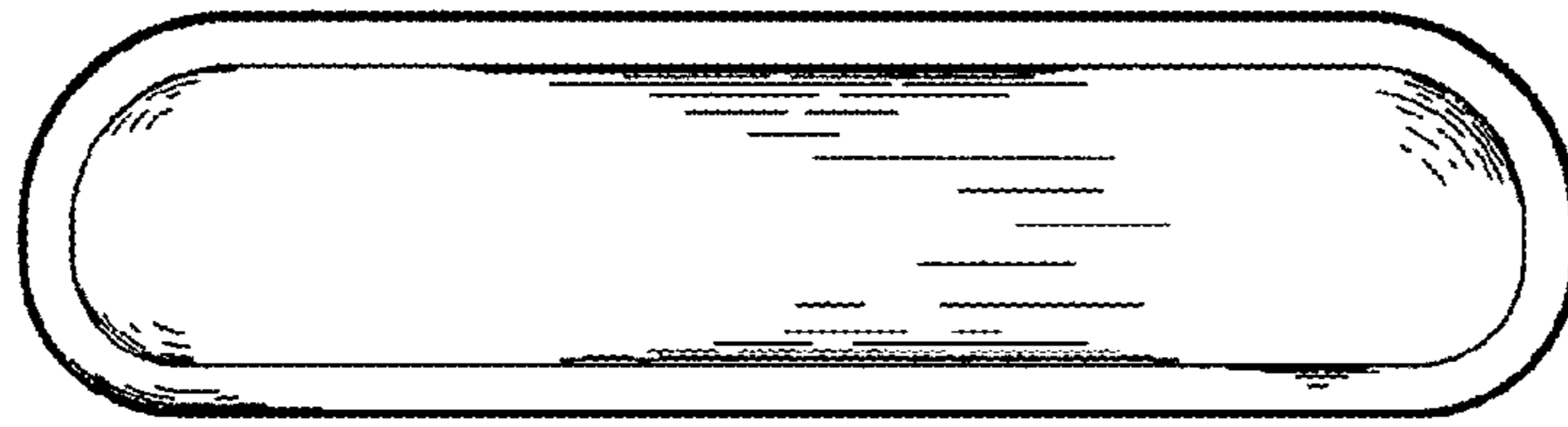

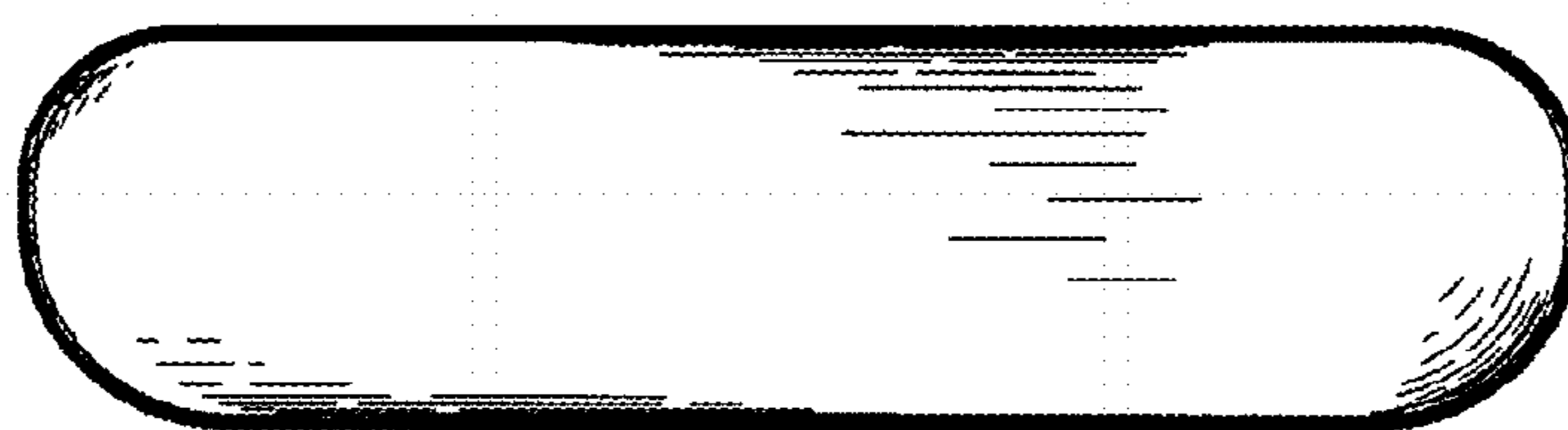

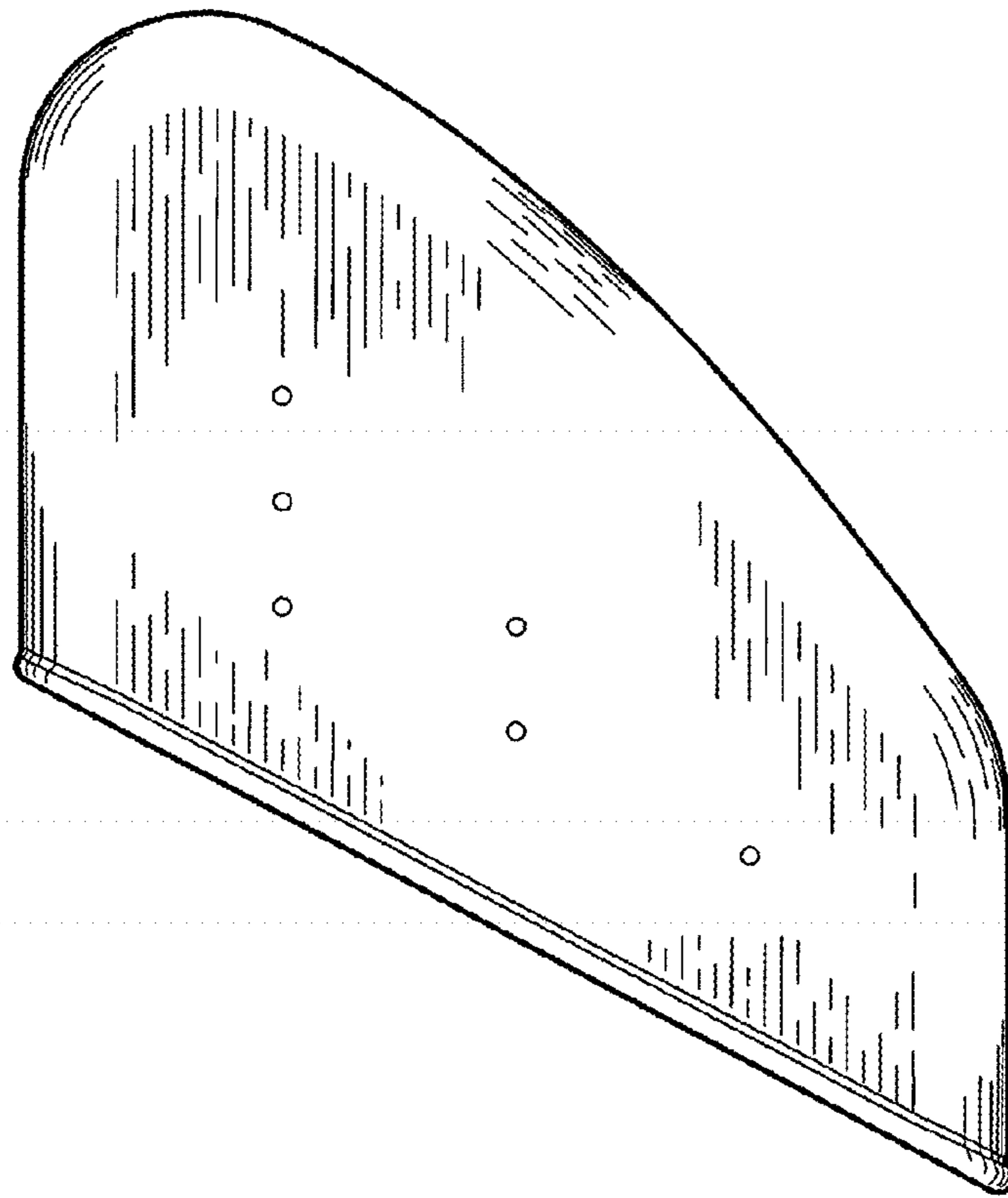
