(57) **CLAIM**

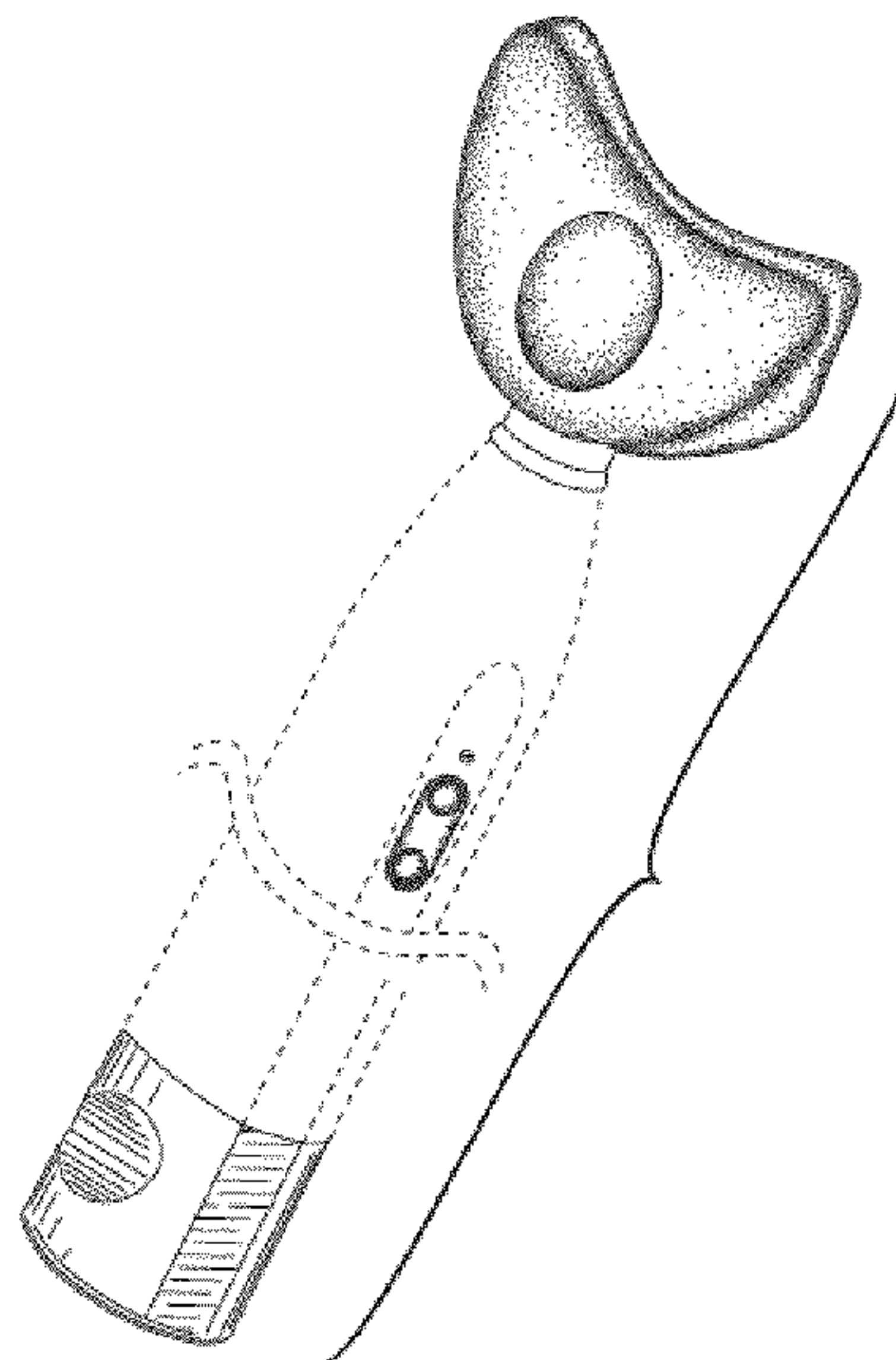
The ornamental design for a gum massager, as shown and described.

**DESCRIPTION**

FIG. 1 shows a perspective view of the gum massager I claim; FIG. 2 shows an exploded perspective view thereof; FIG. 3 shows an exploded front elevation view thereof; FIG. 4 shows an exploded left side elevation view thereof; FIG. 5 shows a top plan view thereof; and, FIG. 6 shows a bottom plan view thereof.

The dashed lines shown in FIGS. 1-4 indicate environmental structure and do not form any part of the claimed design. The bracketed broken away symbols shown in FIGS. 1-4 indicate that any portion of the article beyond what is shown forms no part of the claimed design. The stippled shading of the massager head in FIGS. 1-6 and the intensity level selectors in FIGS. 1-4 represent a surface contrast. The parallel shade lines in FIGS. 1-4 illustrate contour and not surface ornamentation.

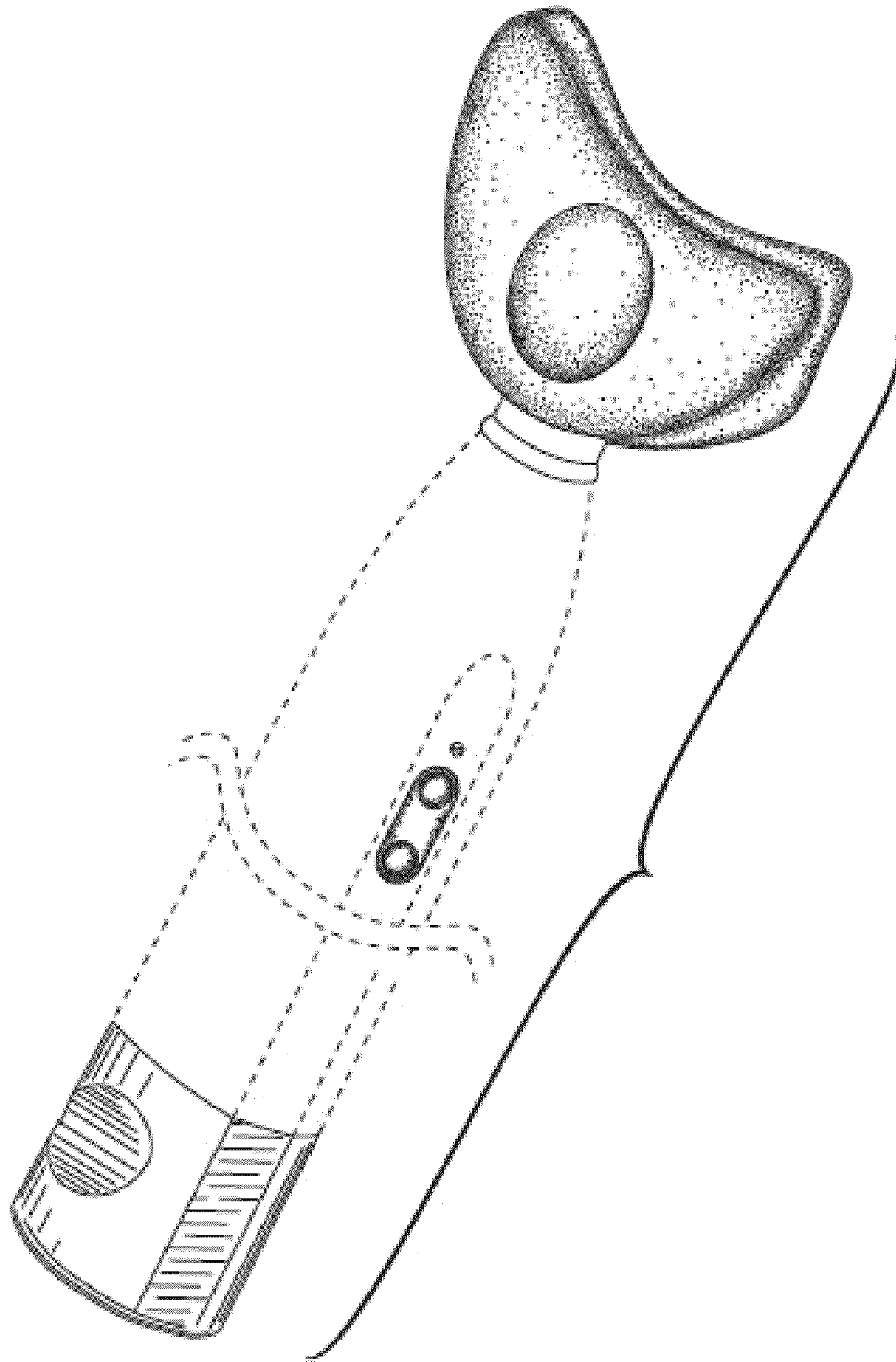

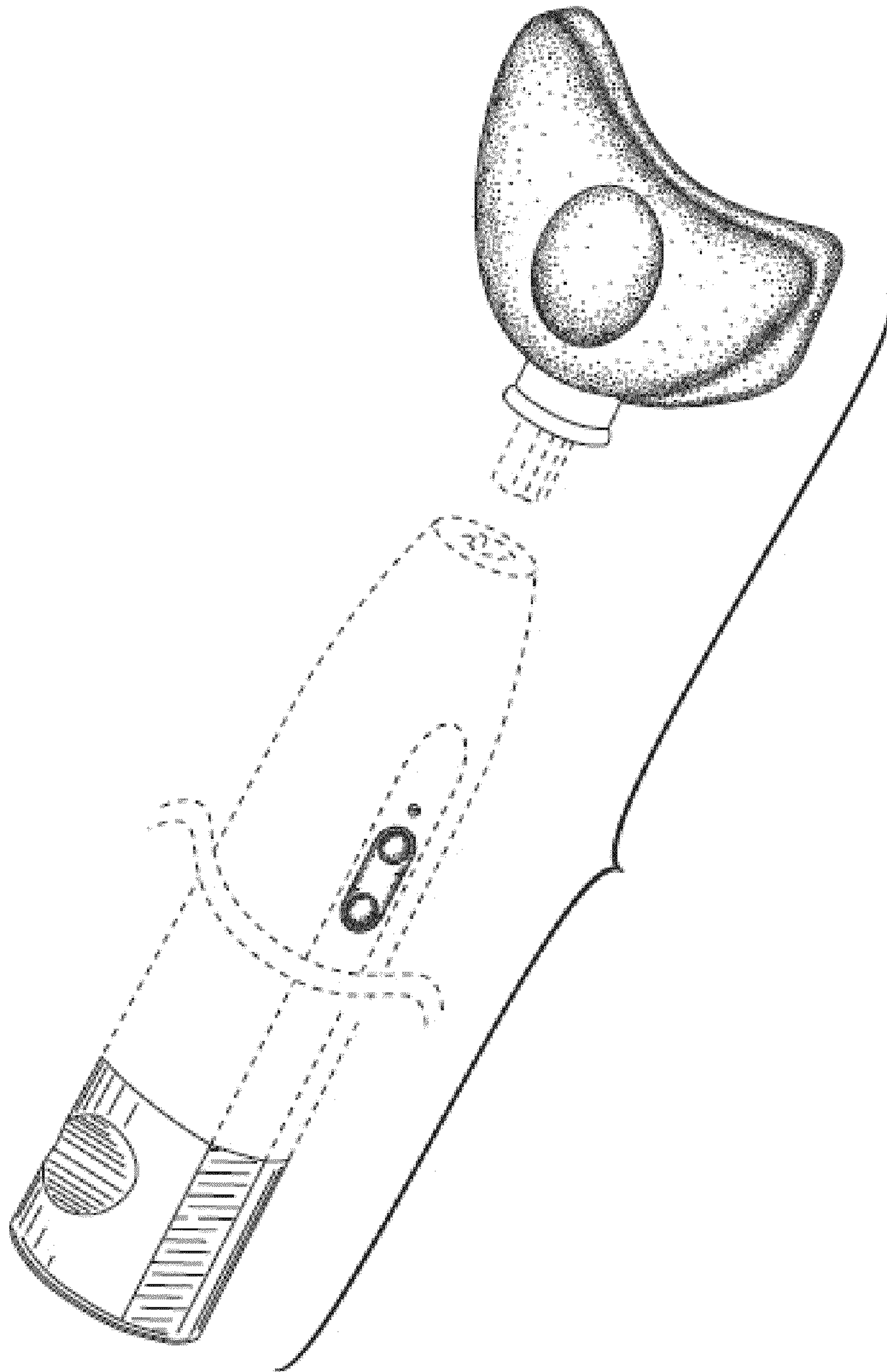

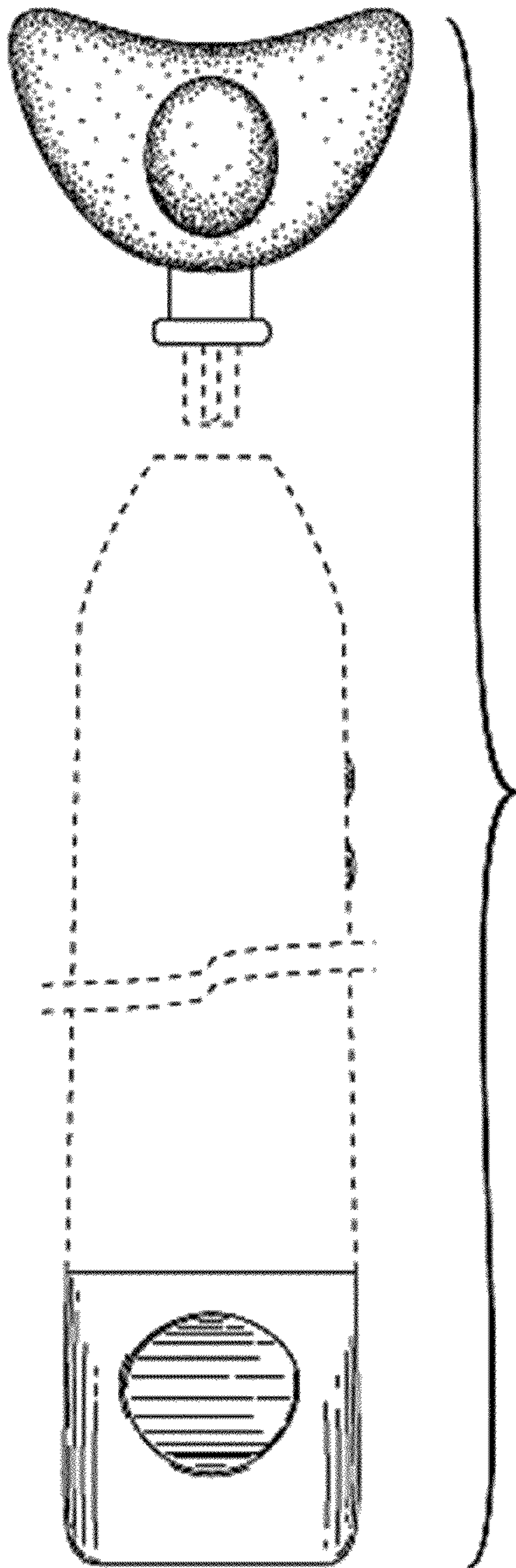

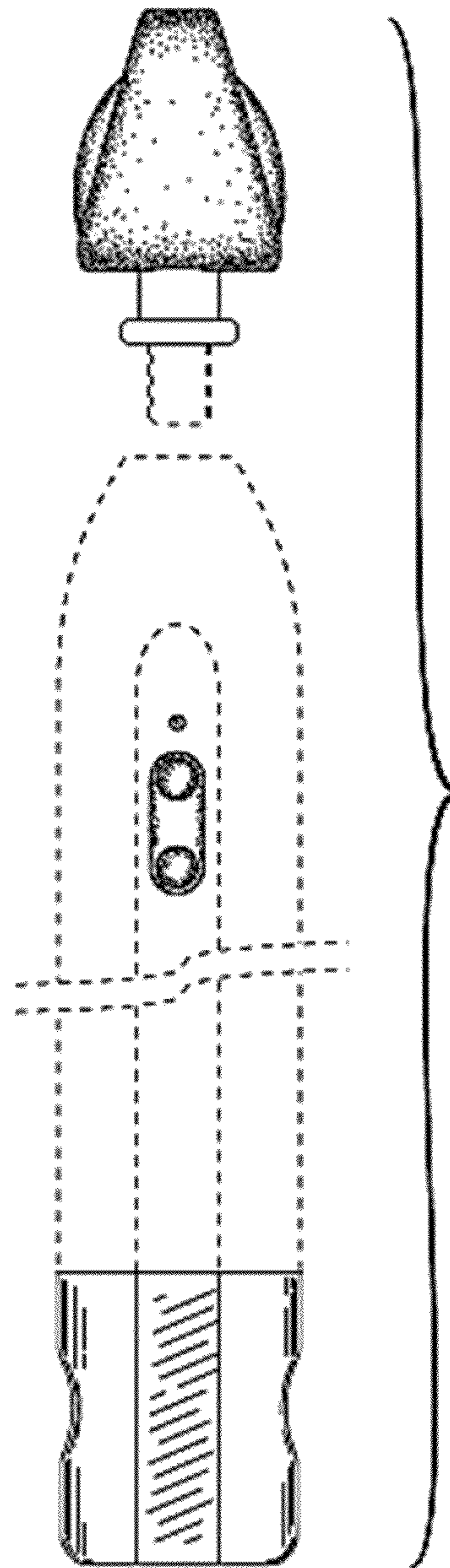

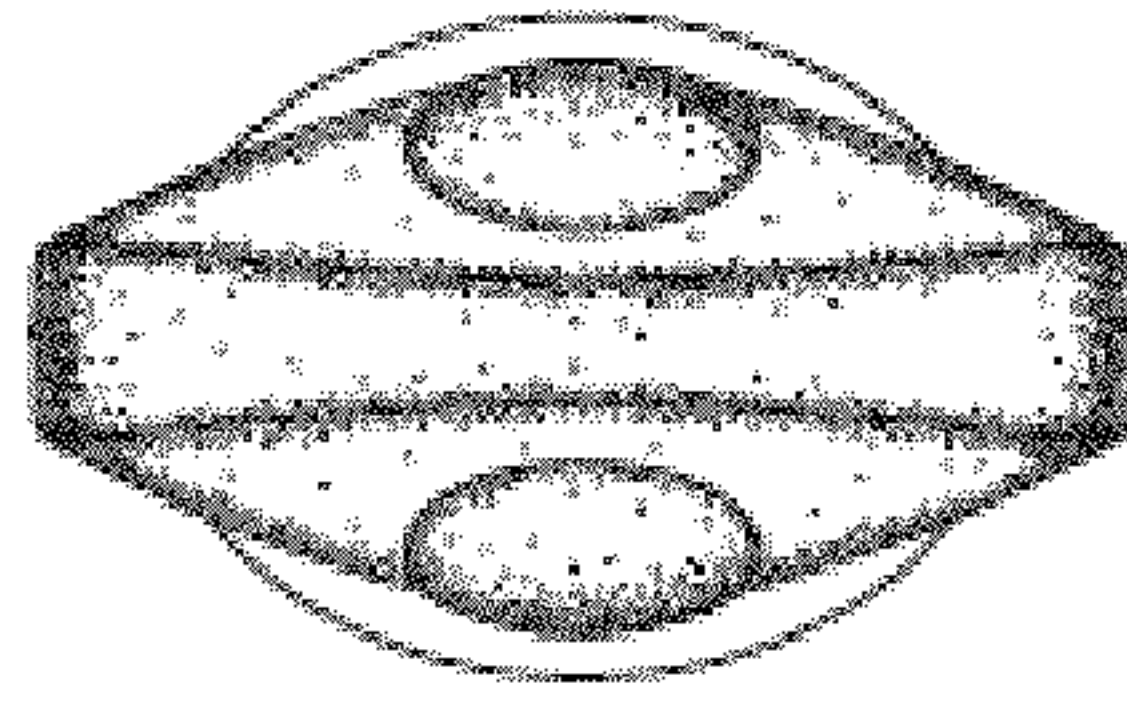

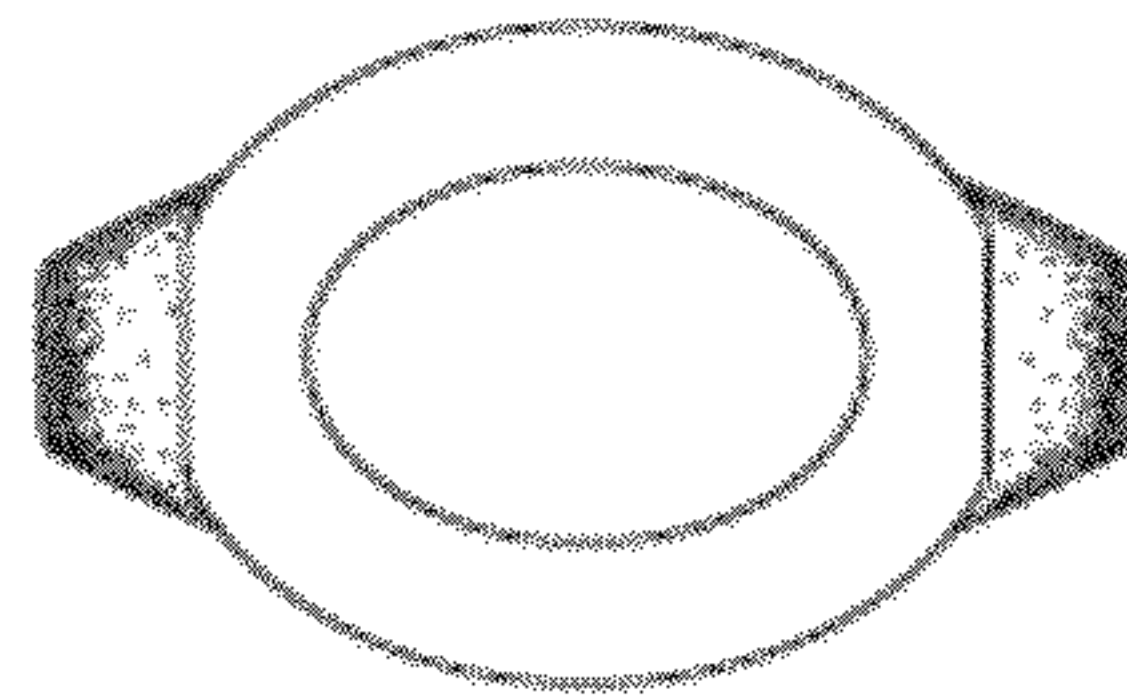
