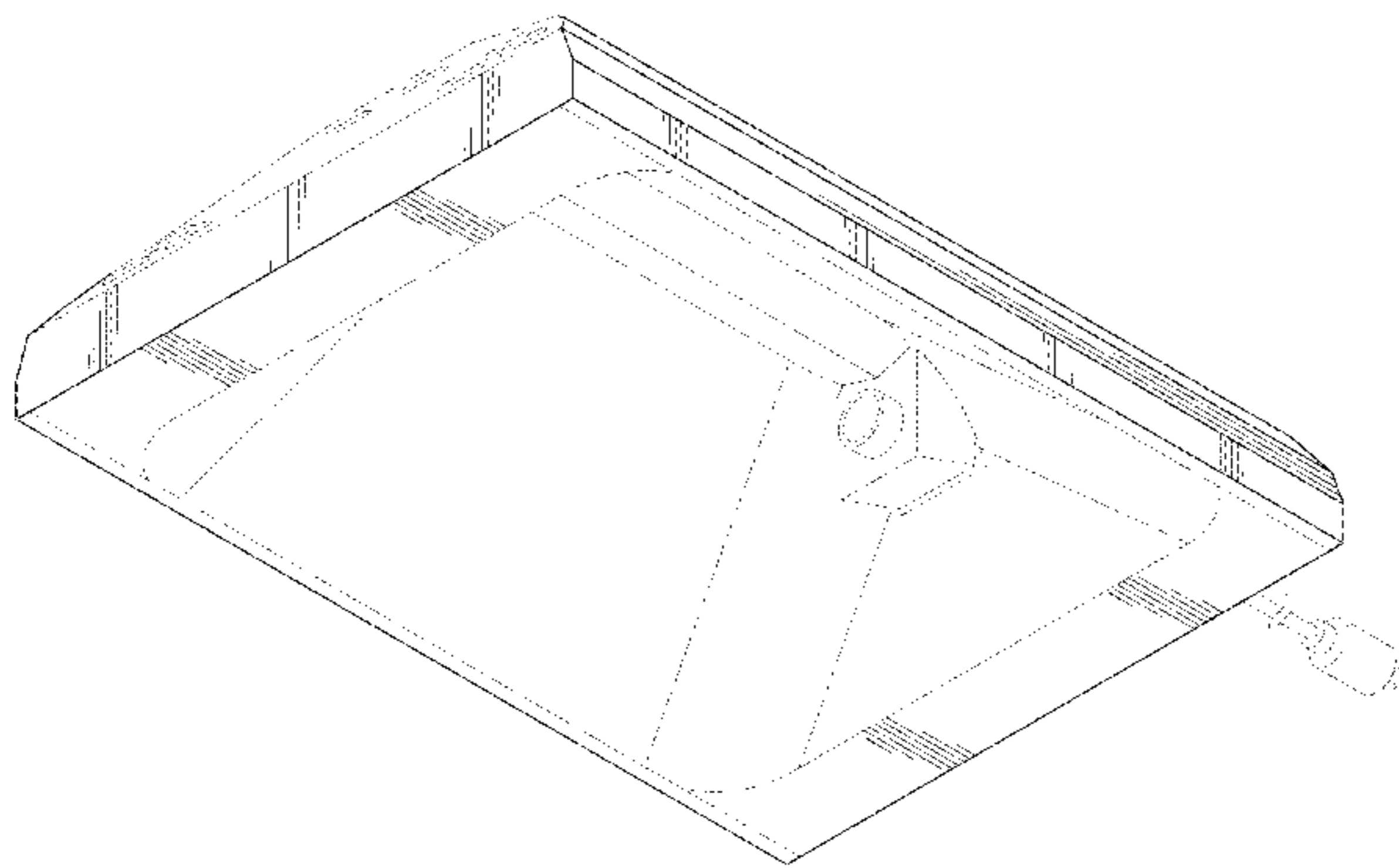

(57) **CLAIM**

The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light fixture, as viewed from below, showing my new design;

FIG. 2 is a perspective view of the light fixture shown in FIG. 1, as viewed from above;

FIG. 3 is a left side view of the light fixture shown in FIG. 1;

FIG. 4 is a right side view of the light fixture shown in FIG. 1;

FIG. 5 is a front elevation view of the light fixture shown in FIG. 1;

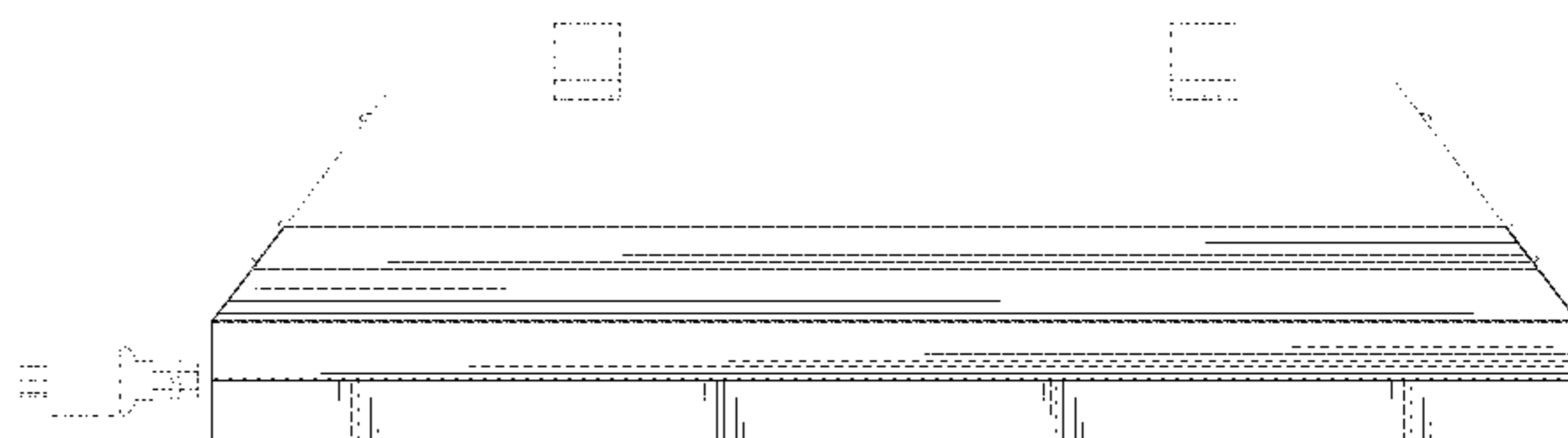
FIG. 6 is a rear elevation view of the light fixture shown in FIG. 1;

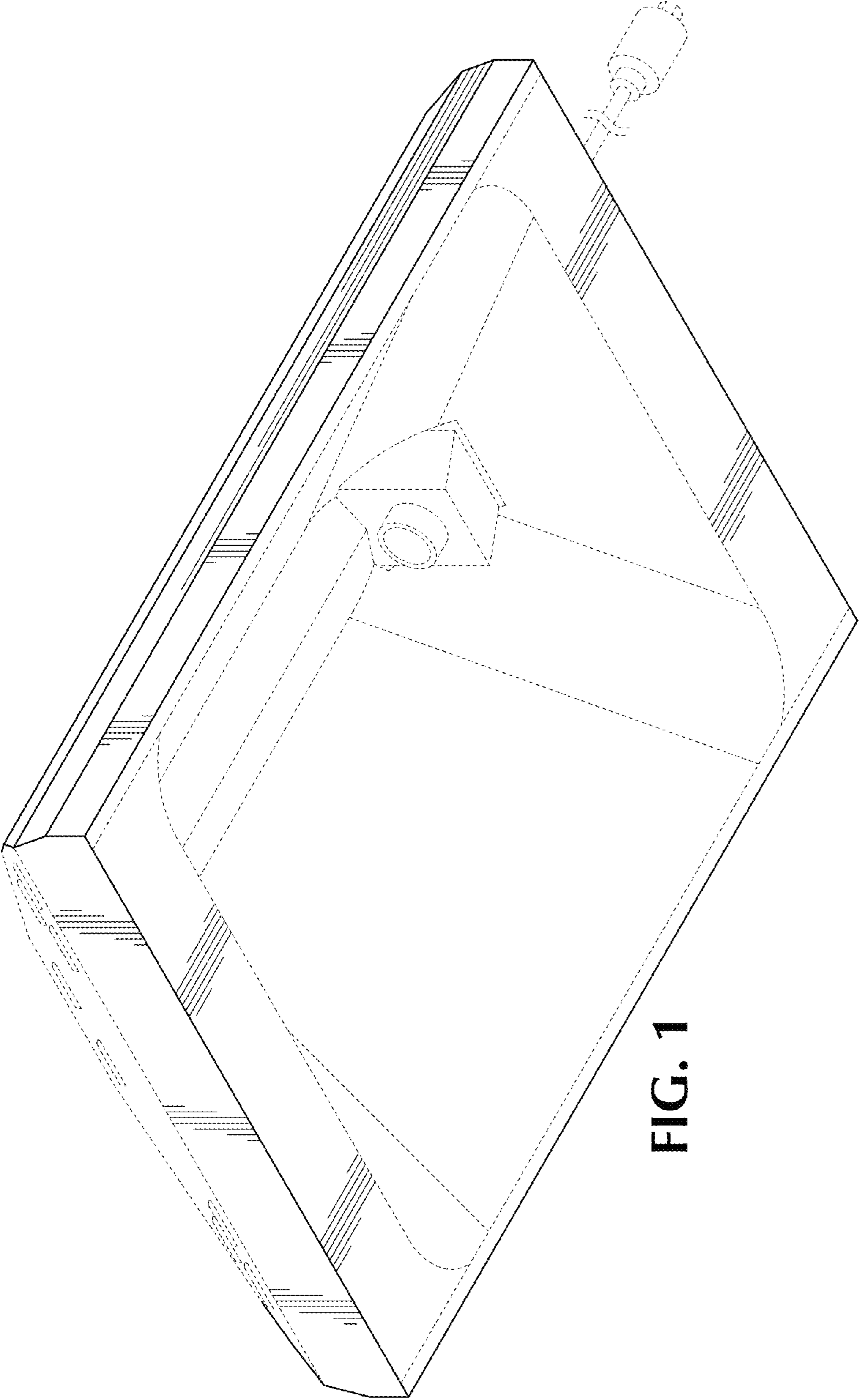

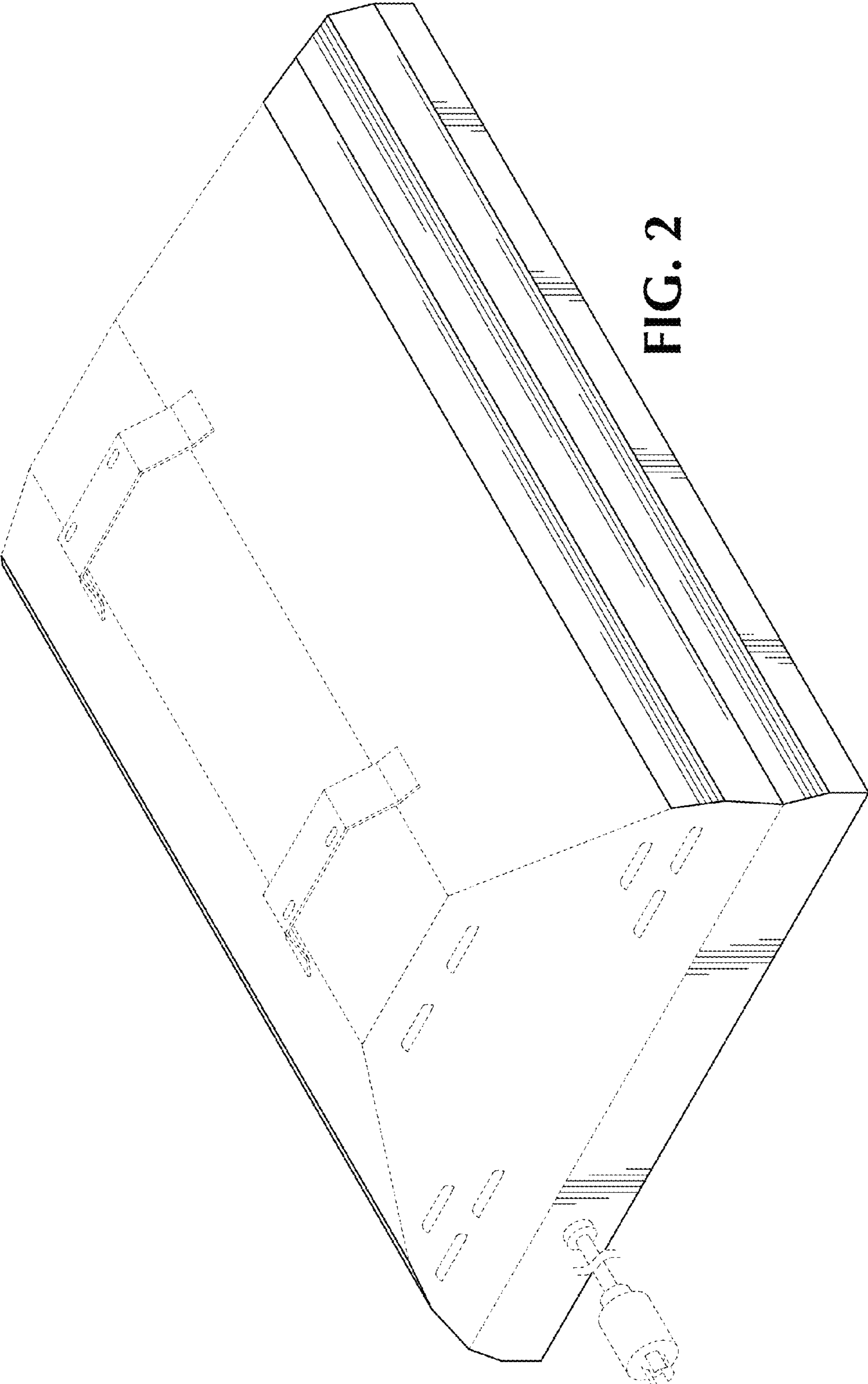

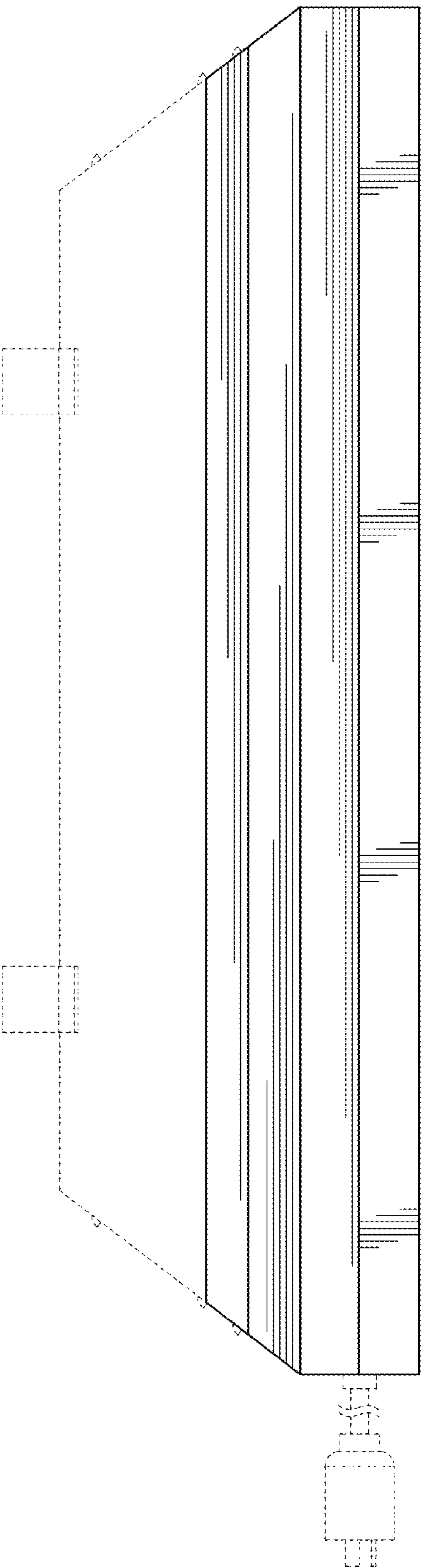

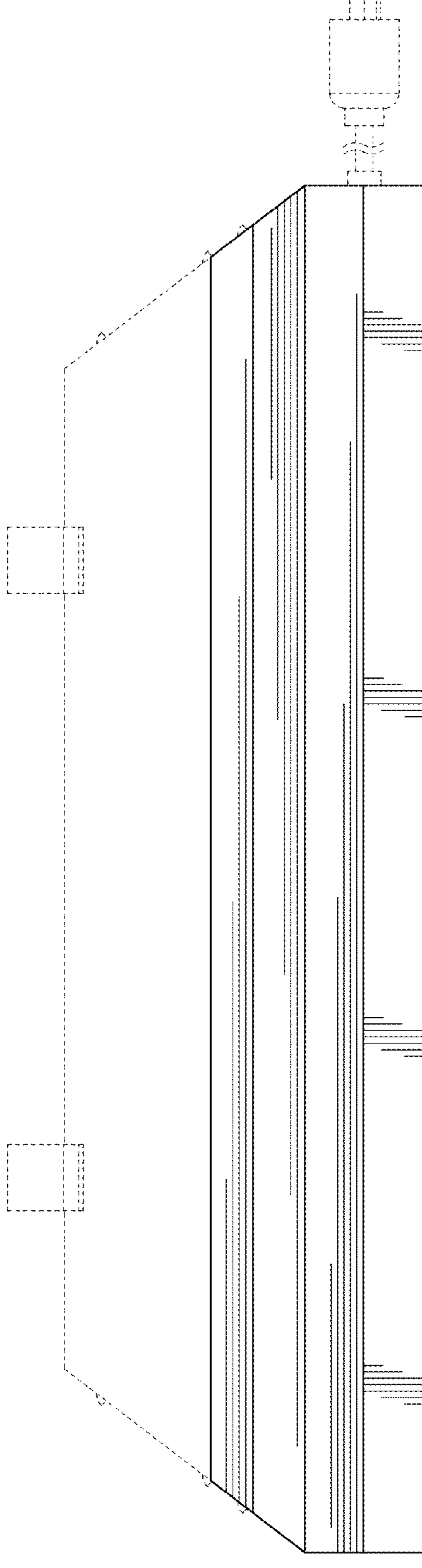

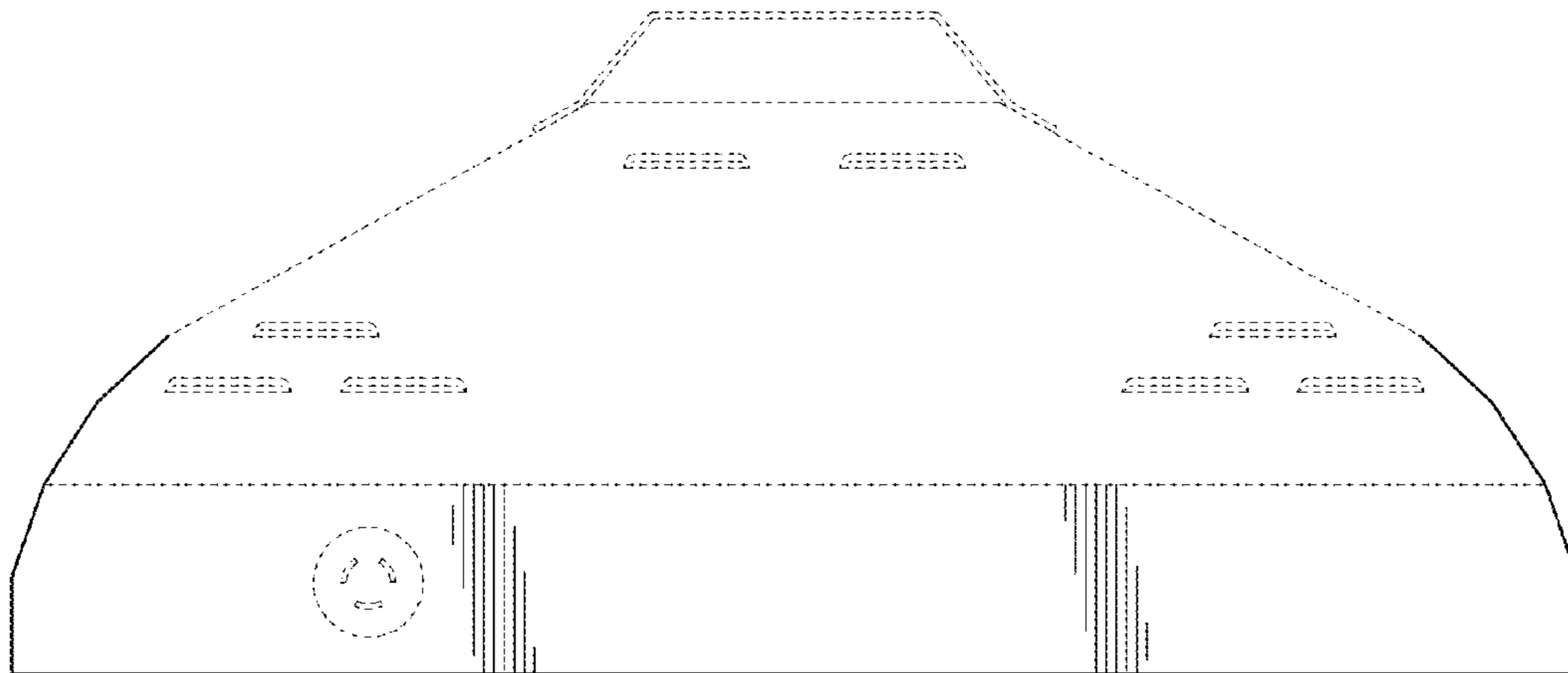

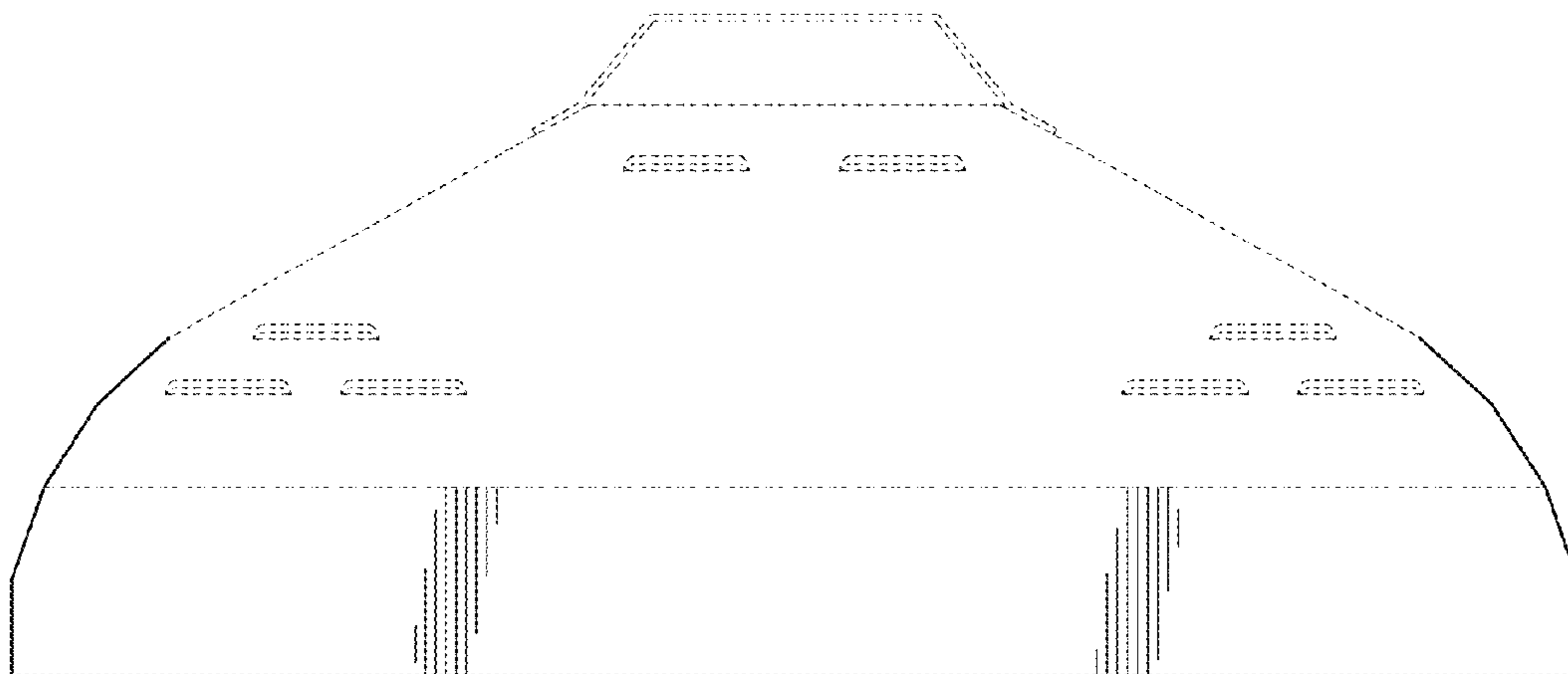

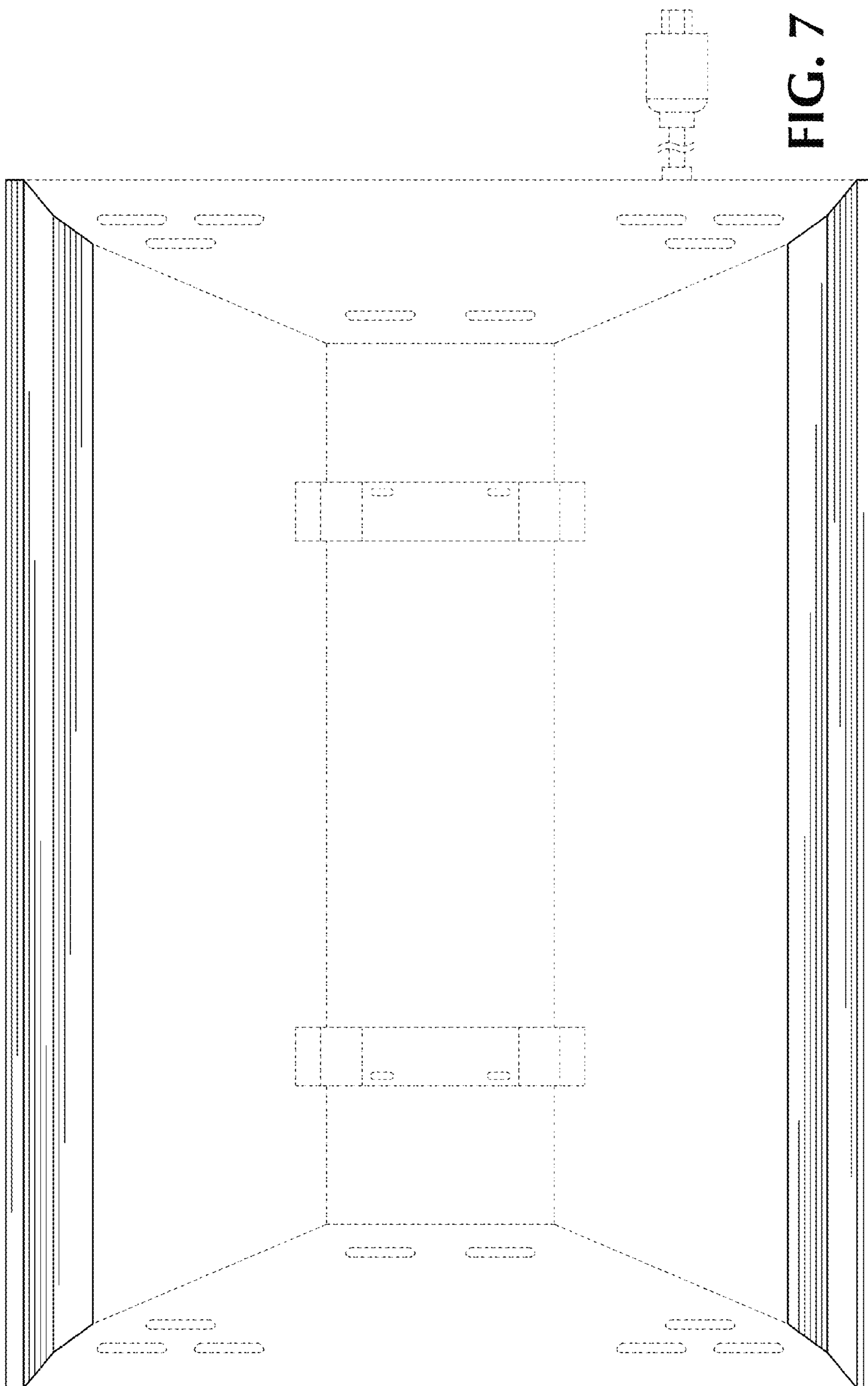

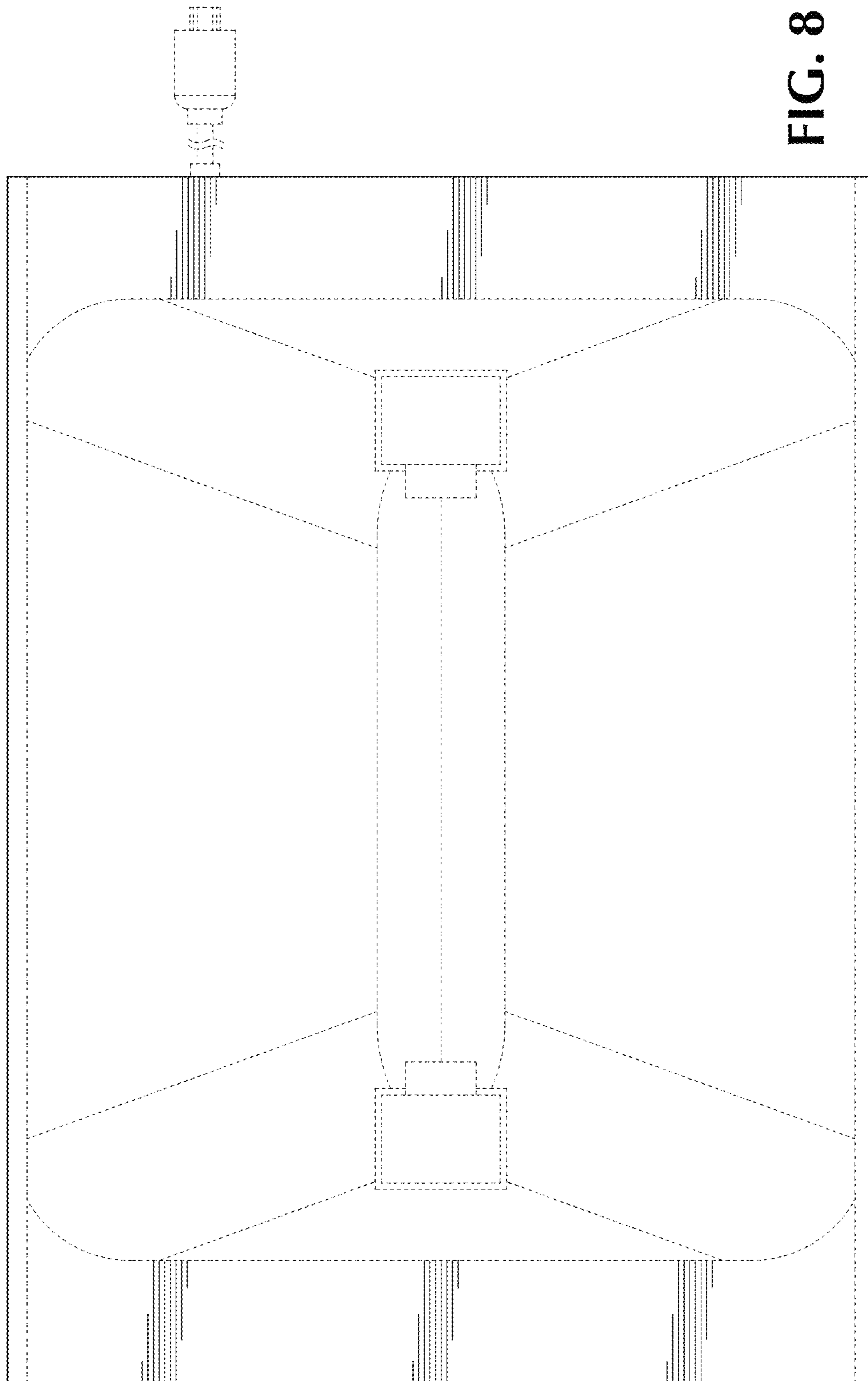
