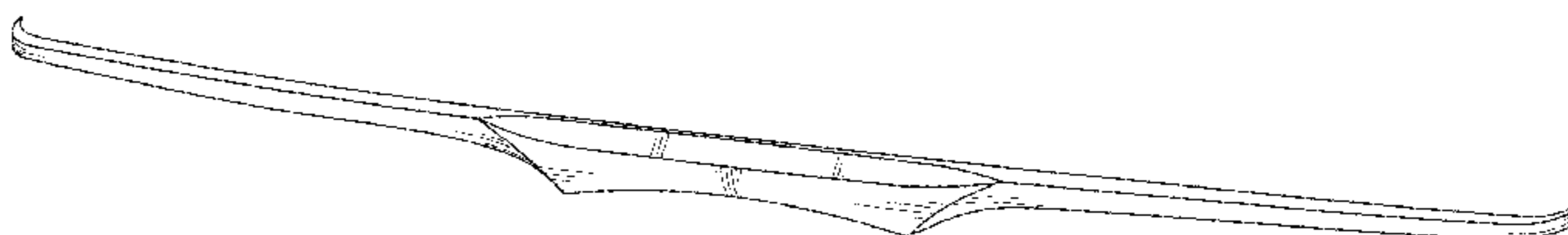
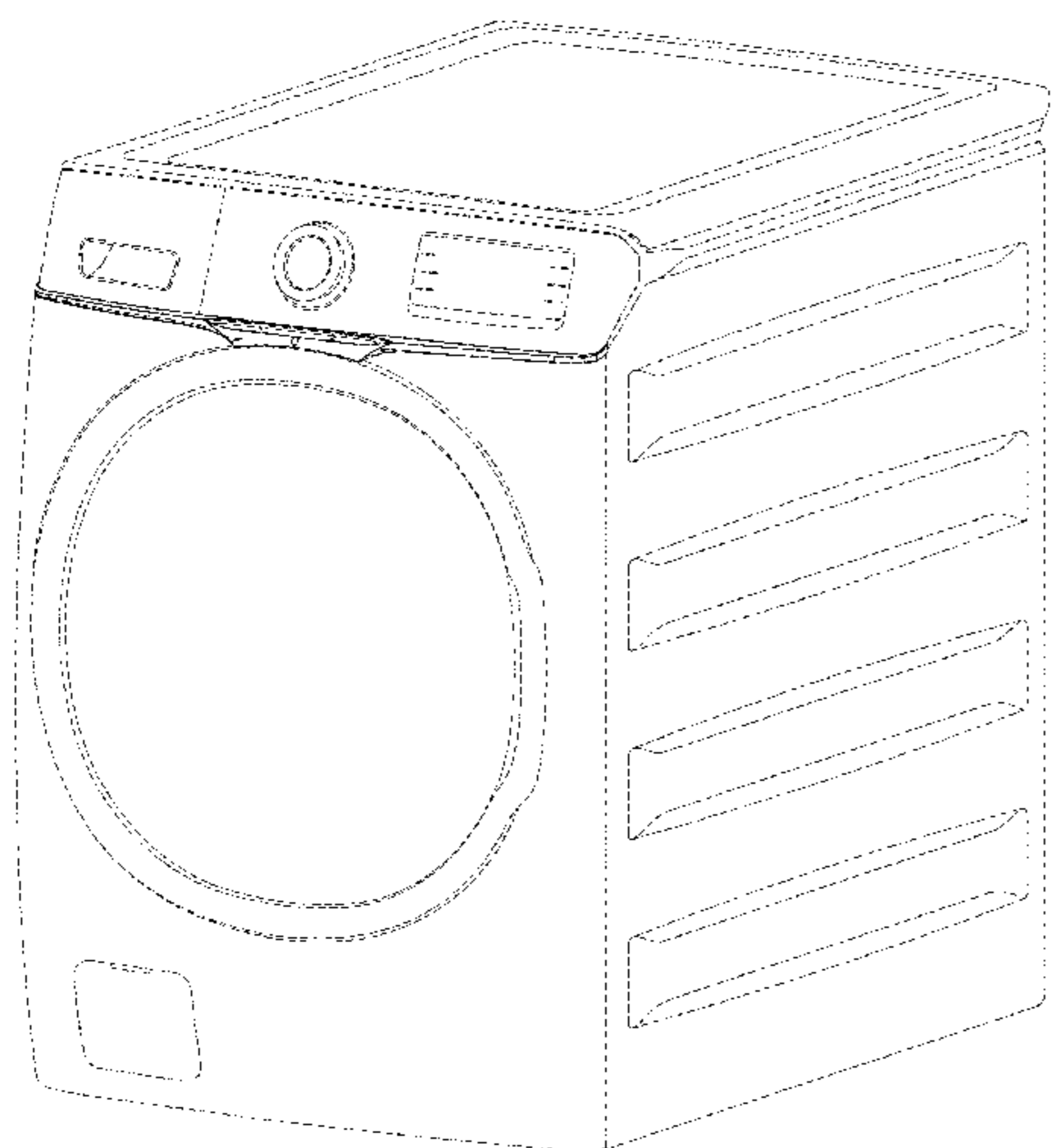
We claim, the ornamental design for a washing machine, as shown and described.

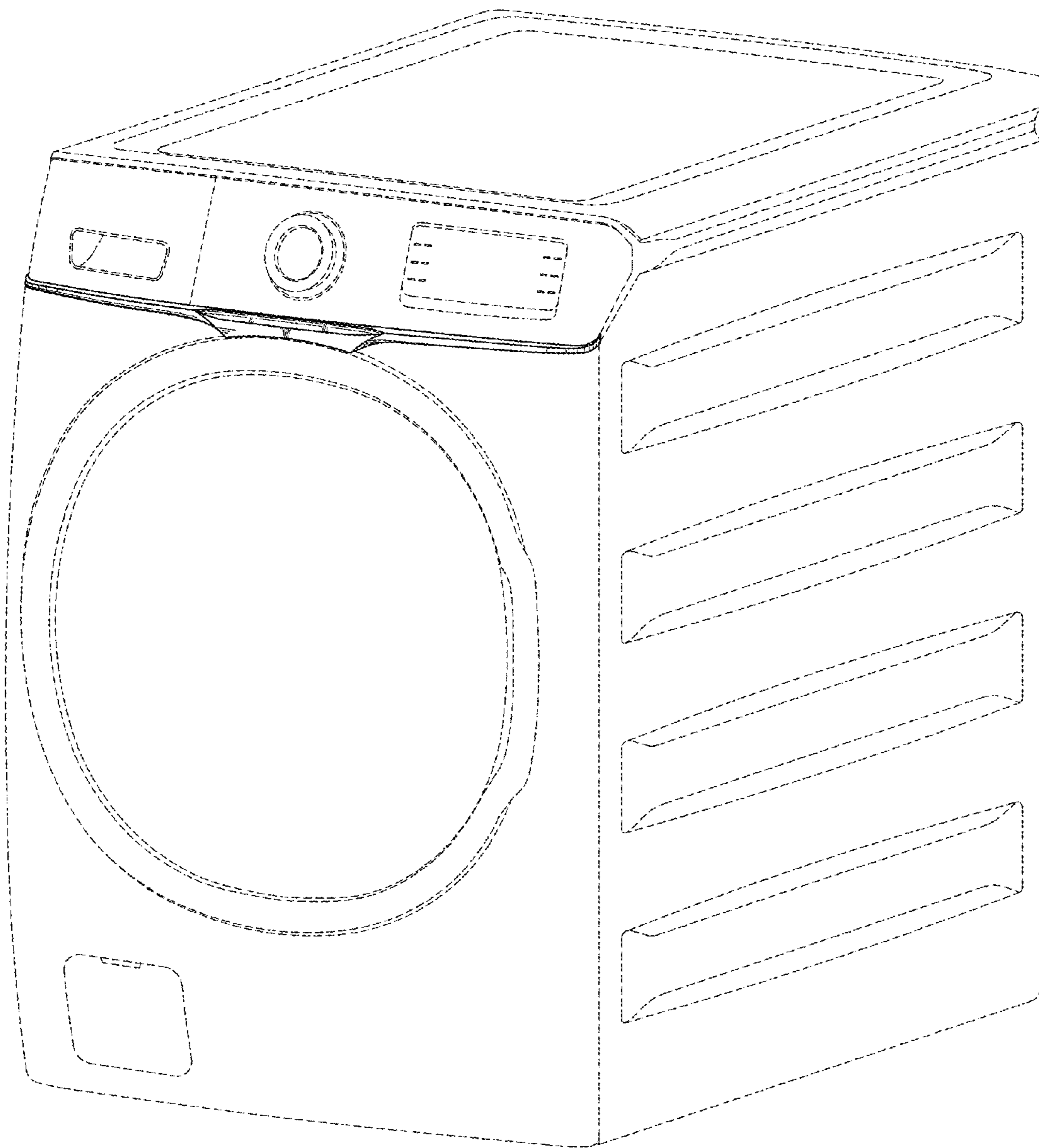

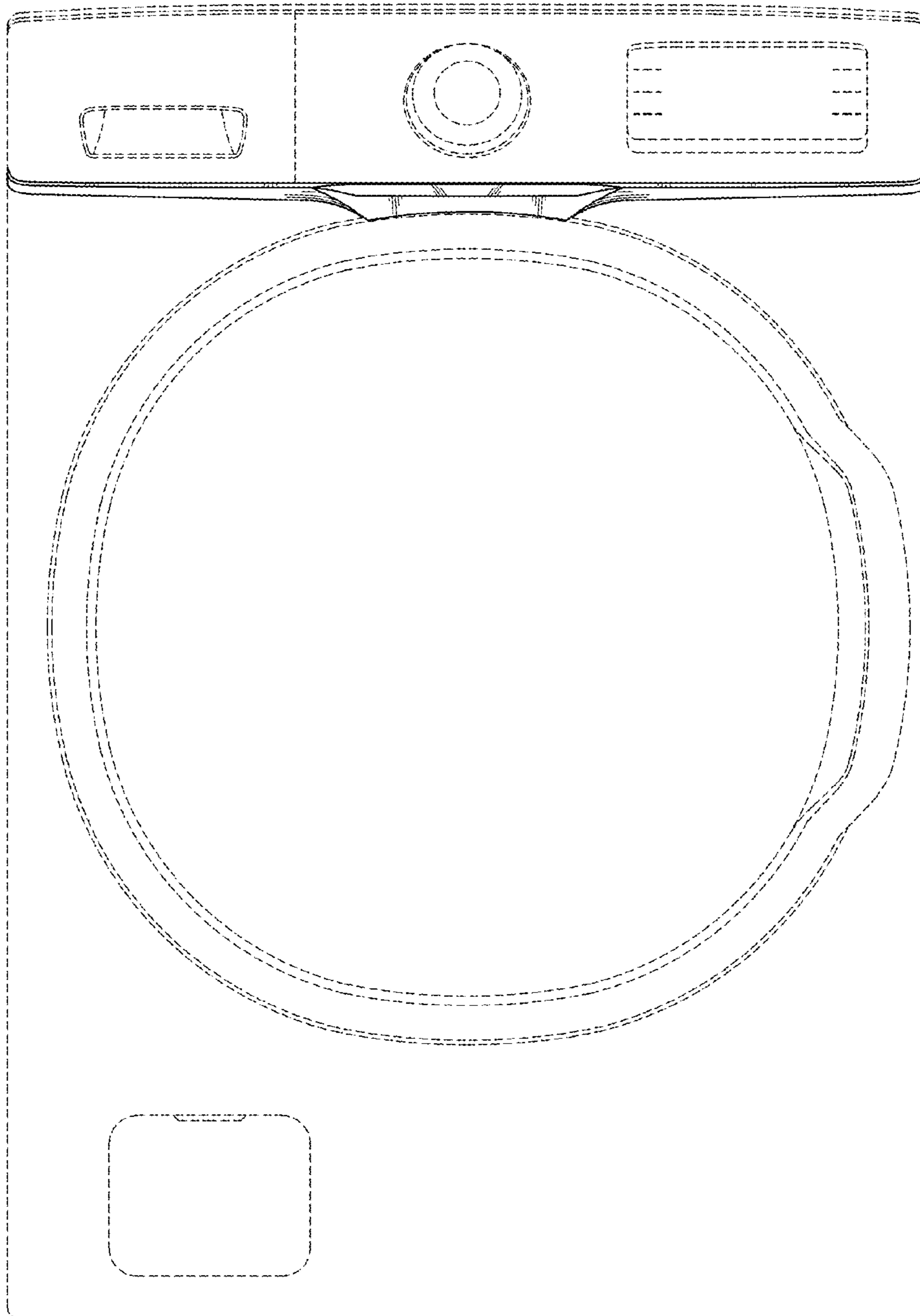

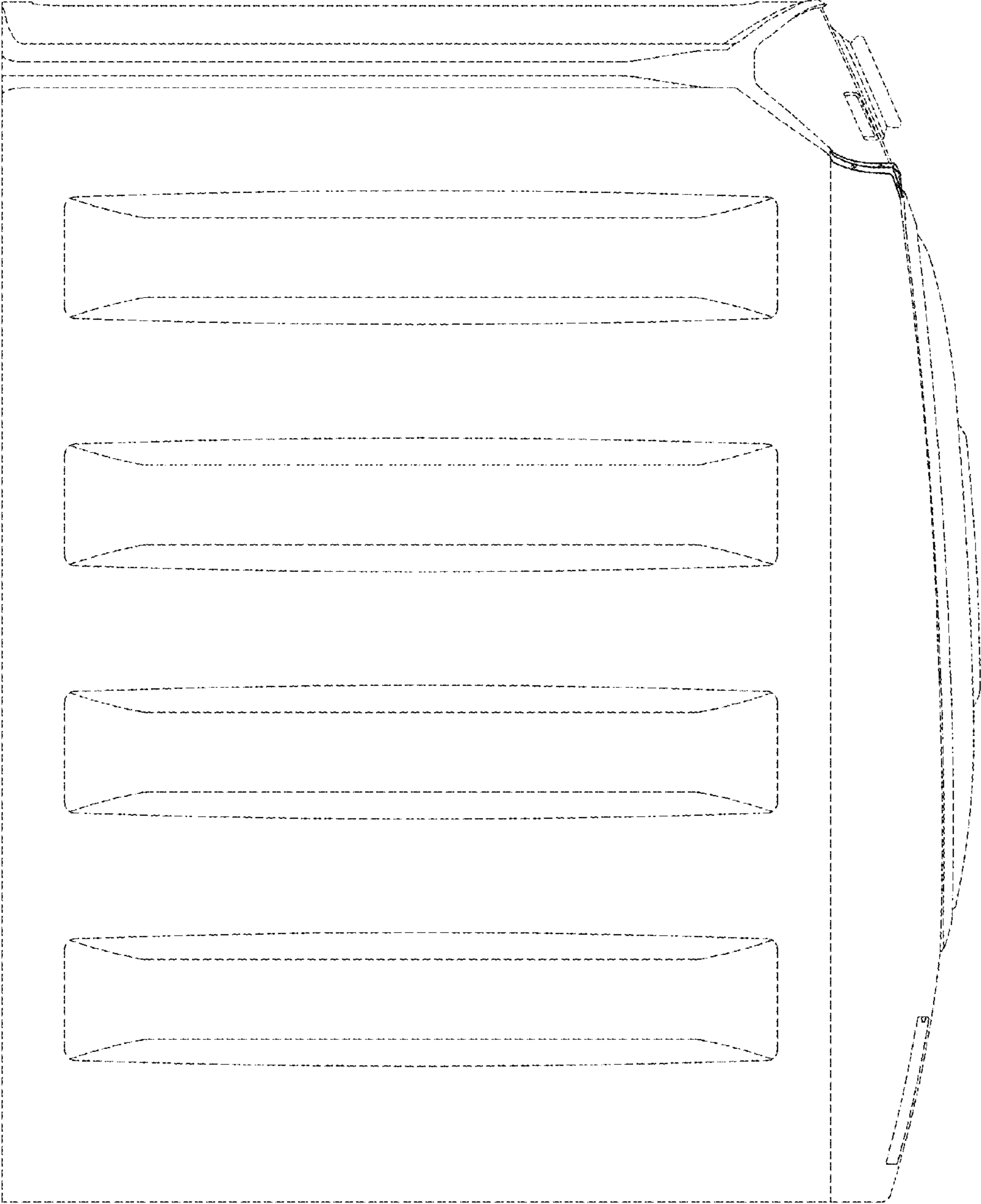

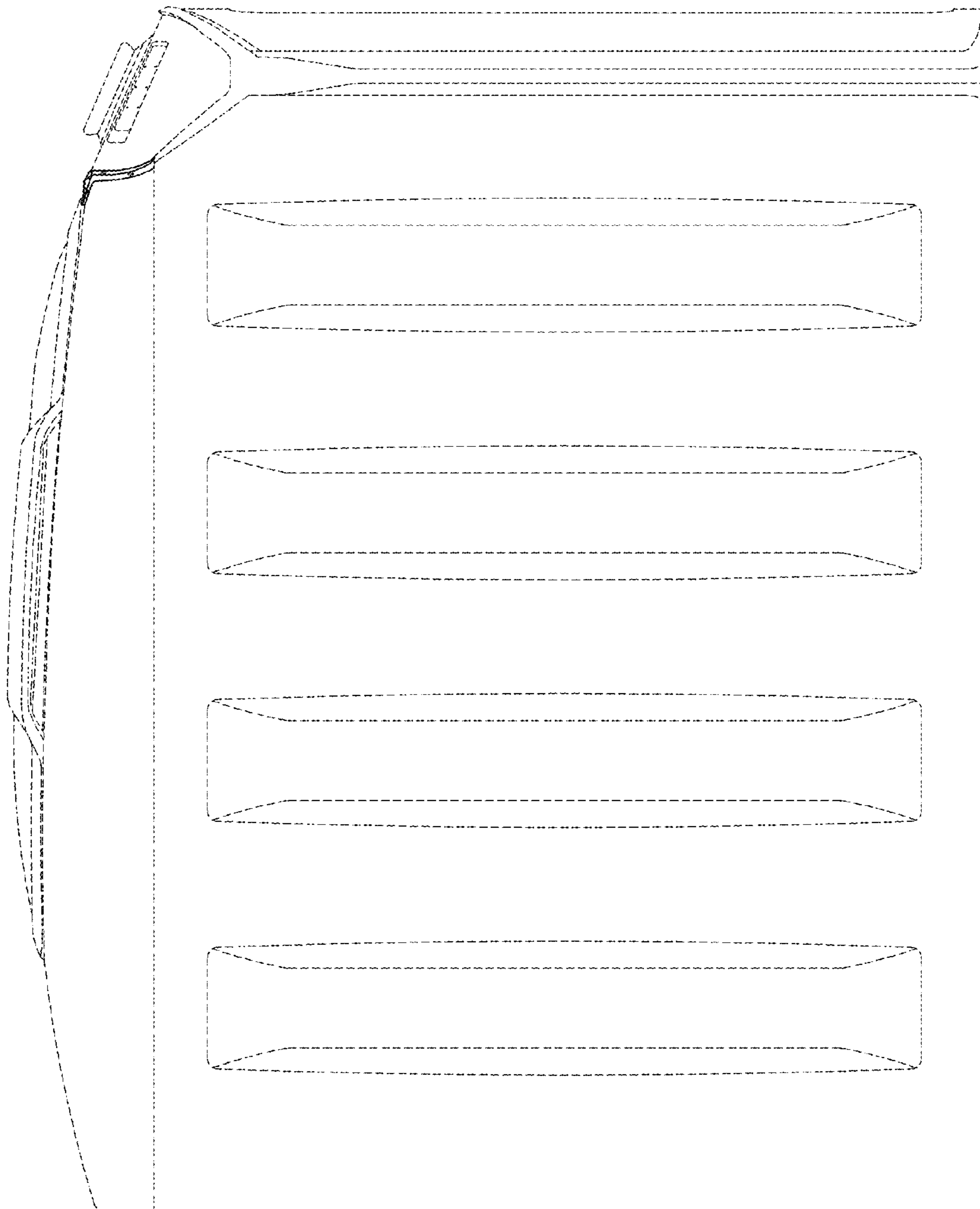

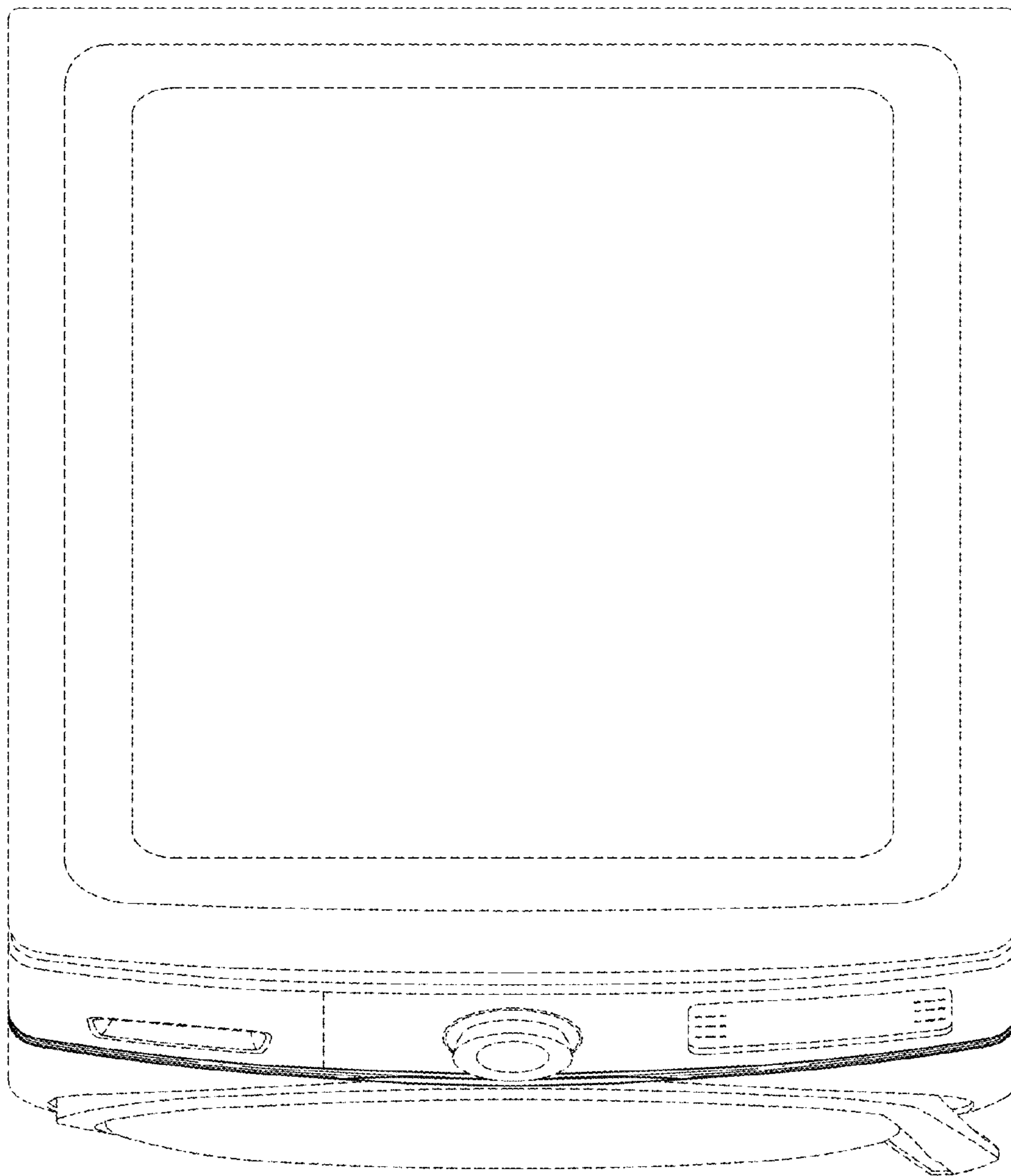

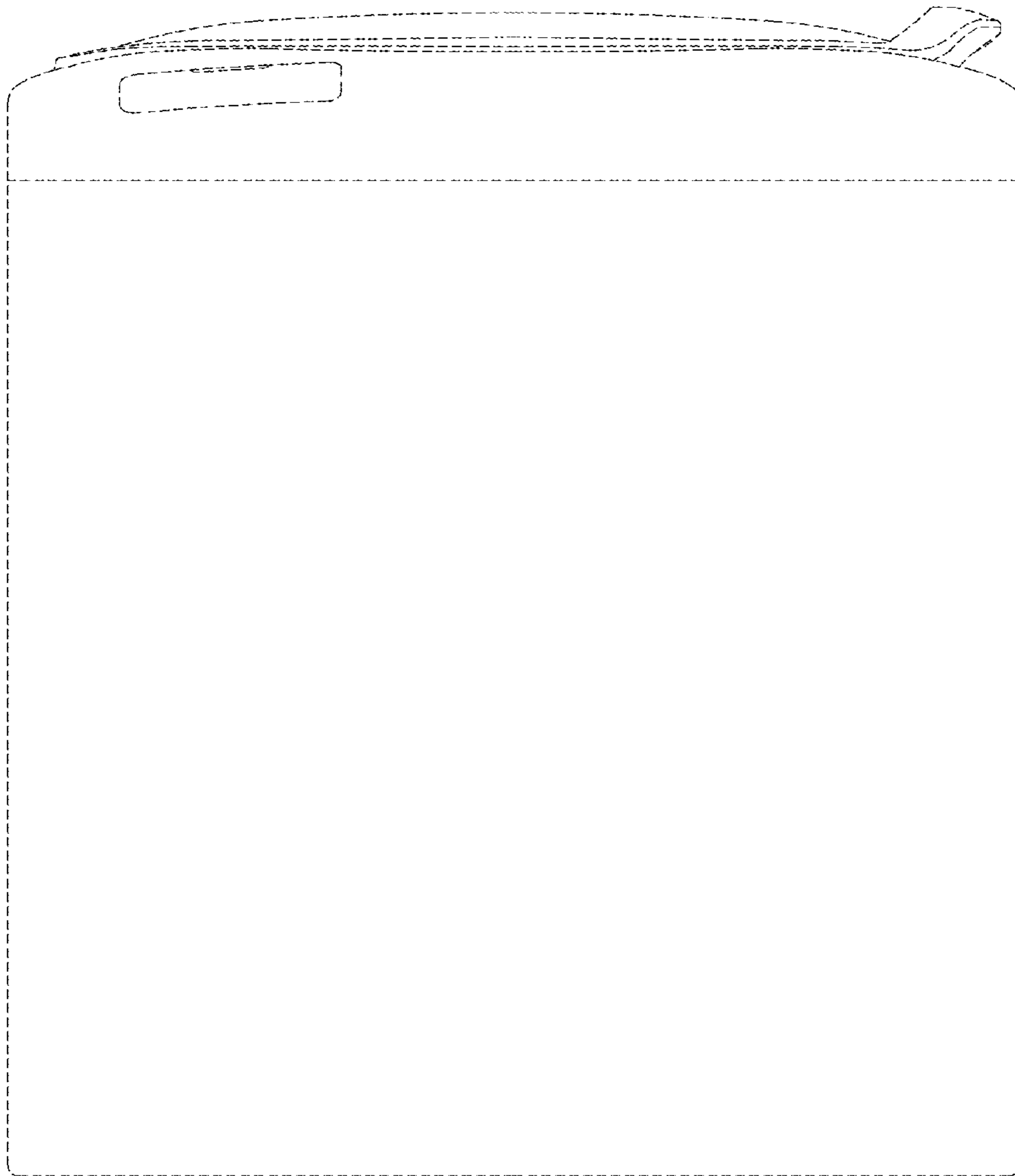

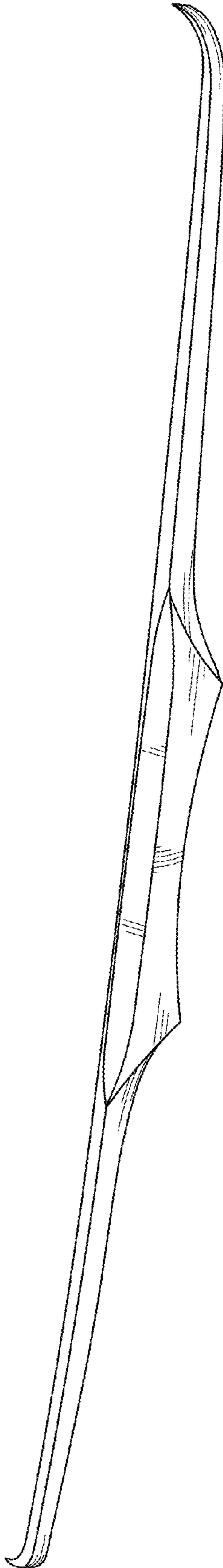
