(57) **CLAIM**

The ornamental design for a spunbond polypropylene disposable hat, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of the spunbond polypropylene disposable hat embodying the design of the present invention;

FIG. 2 is a top down view of the design of FIG. 1 disassembled, unfolded and laid flat;

FIG. 3 is a rear view of the design of FIG. 1 showing the two parts of the spunbond polypropylene disposable hat partially assembled.

FIG. 4 is a front view of the design of FIG. 1;

FIG. 5 is a rear view thereof;

FIG. 6 is a left side view thereof;

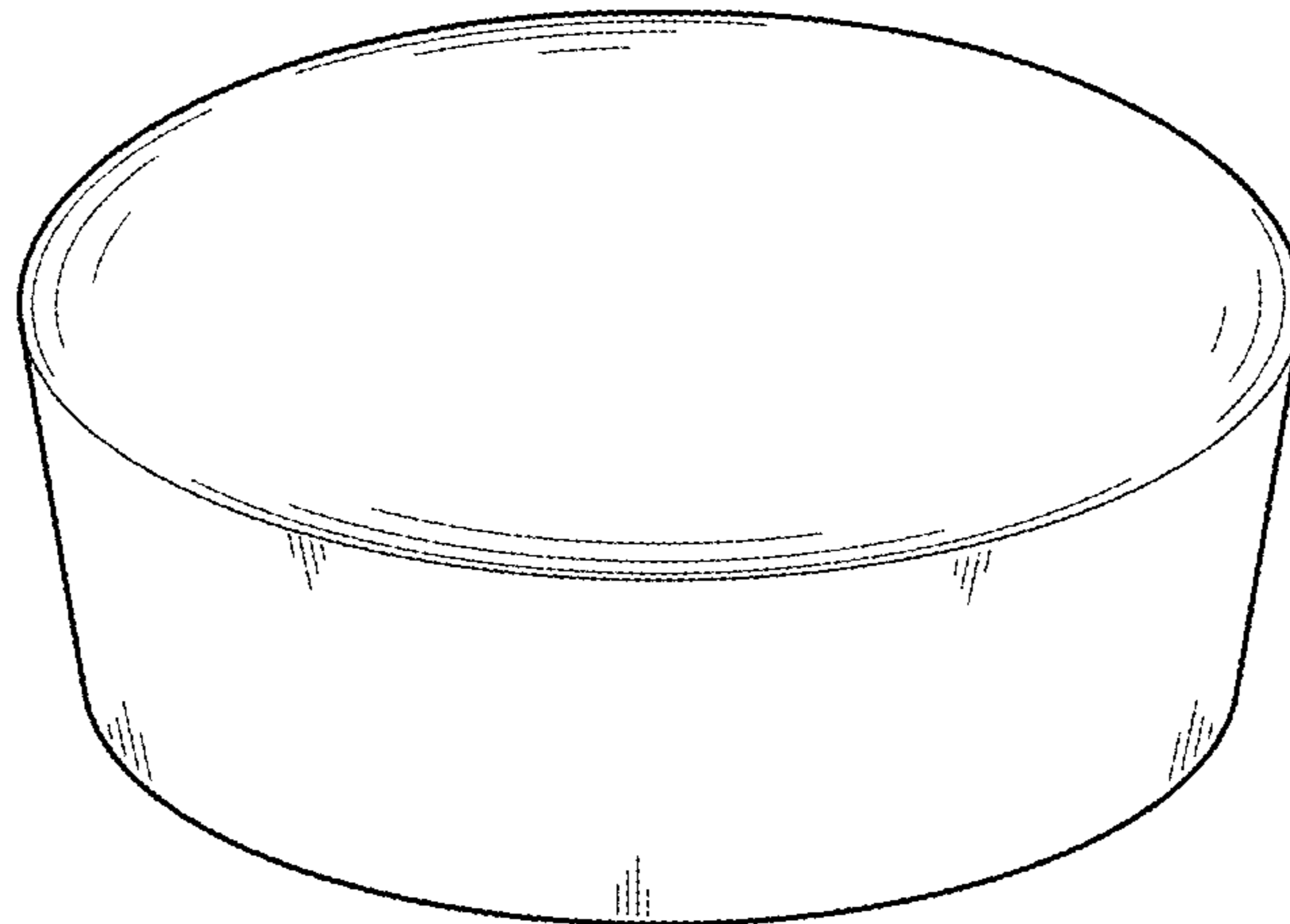
FIG. 7 is a right side view thereof;

FIG. 8 is a top down view thereof; and,

FIG. 9 is a bottom plan view thereof.

In FIGS. 2, 3, 5, and 9, the evenly segmented broken lines indicate portions of the spunbond polypropylene disposable hat that forms no part of the claimed design. The dash-dash broken lines and intersecting looped features in the interior of the design shown in FIG. 3 depict stitching elements.

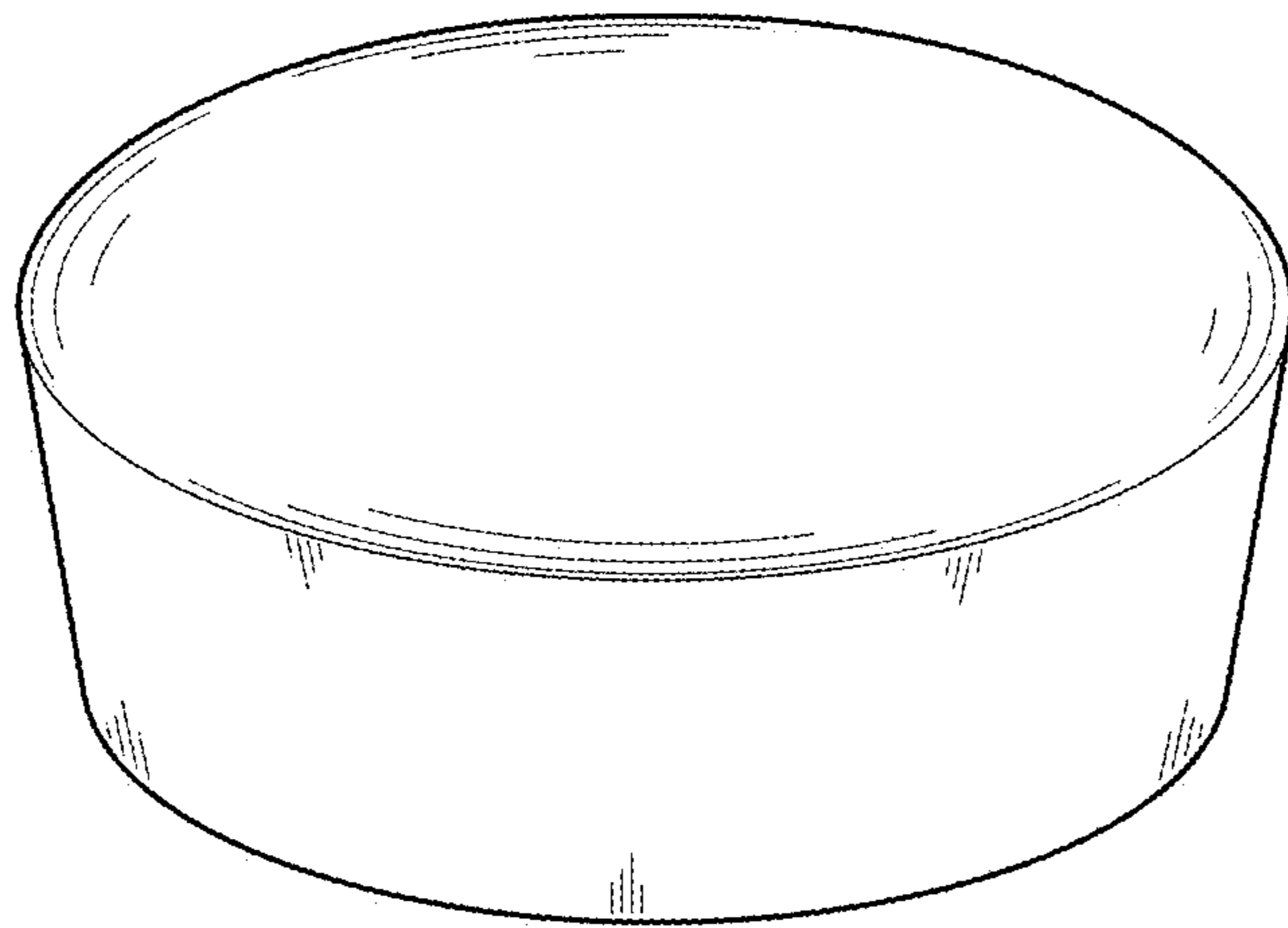

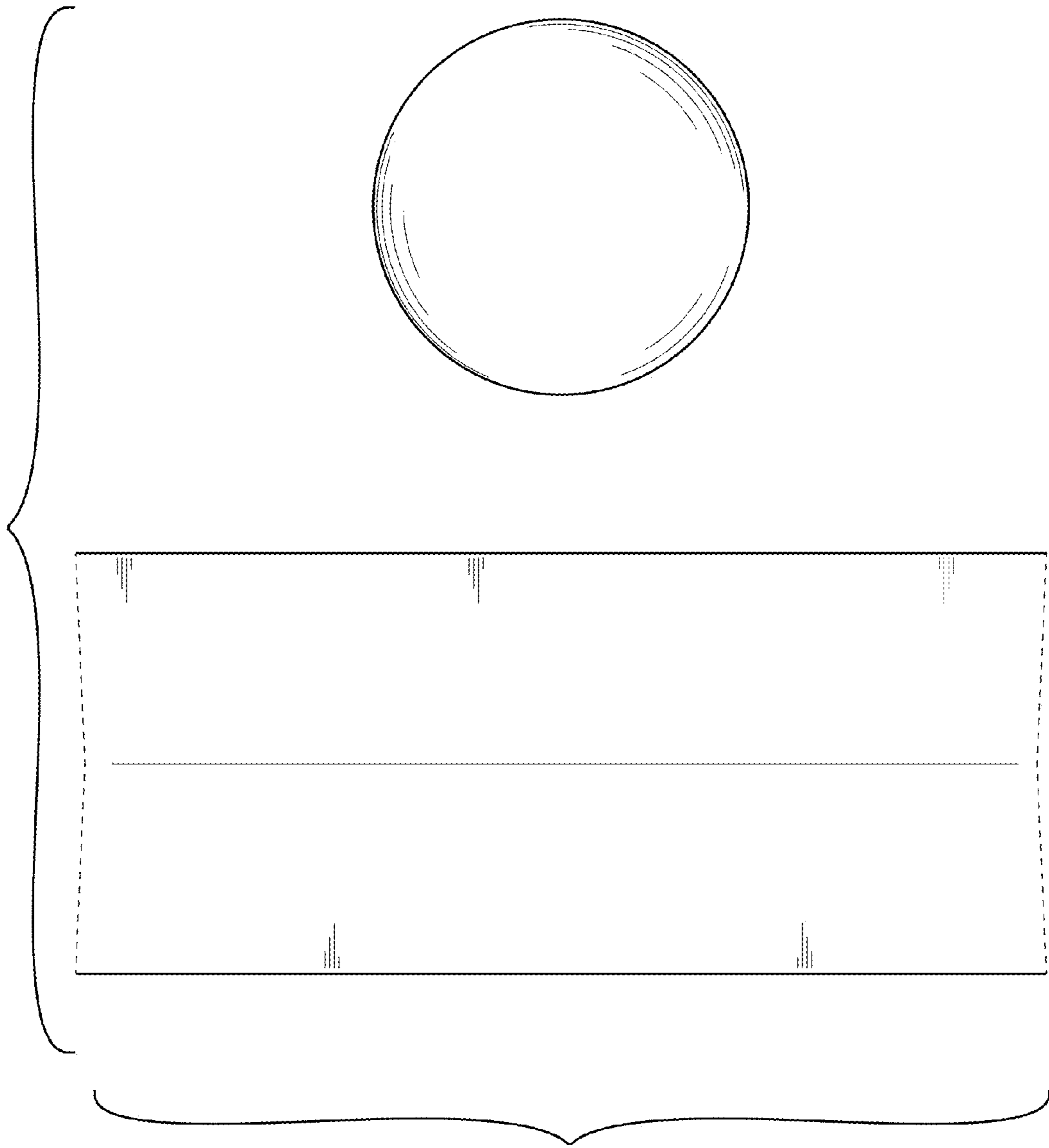

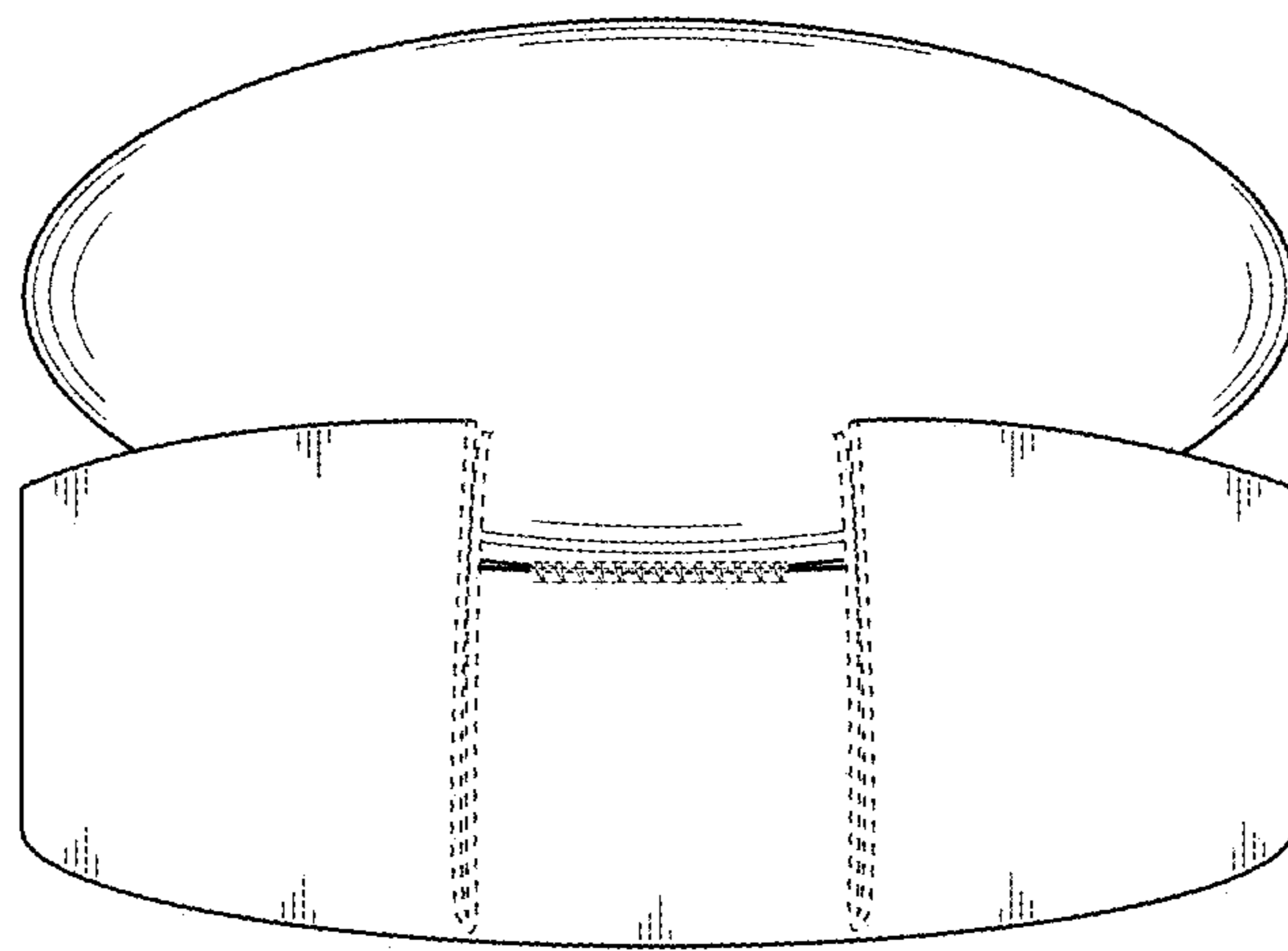

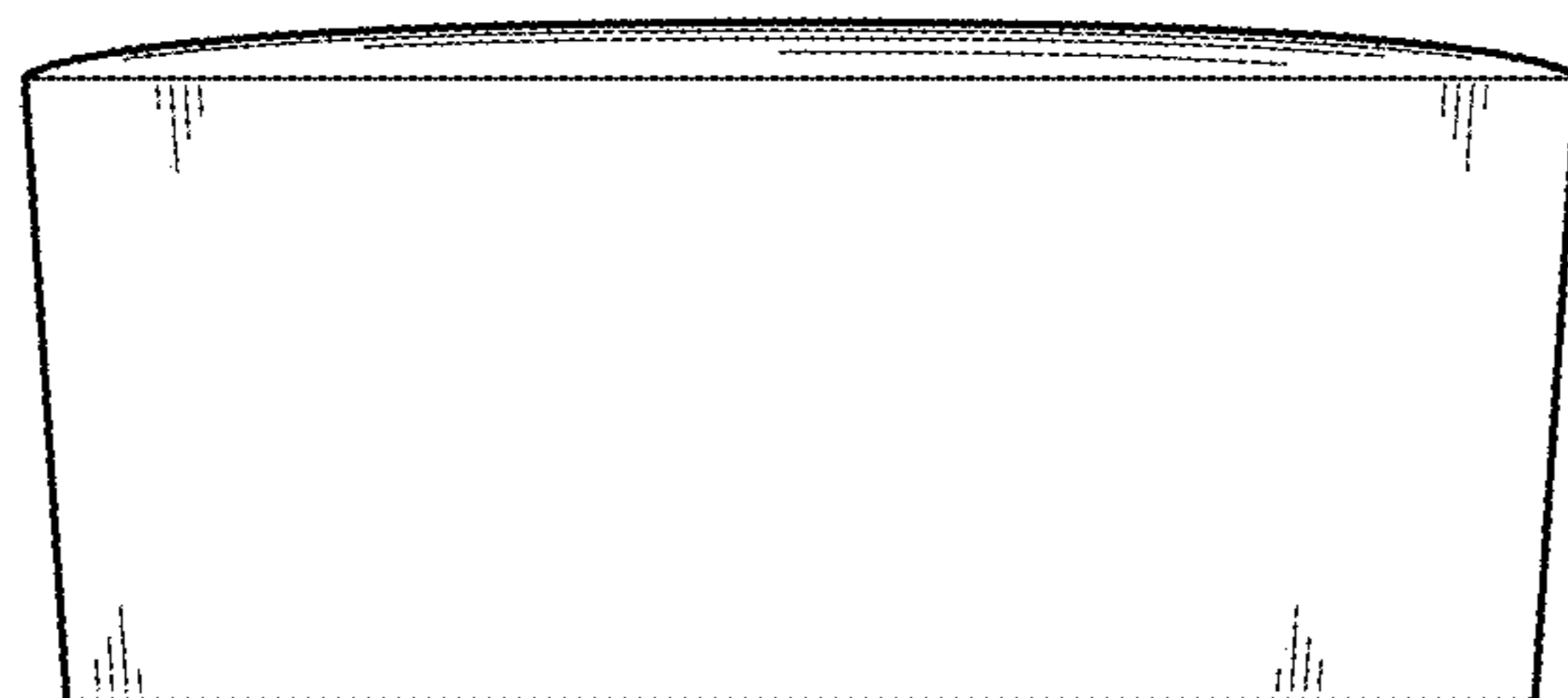

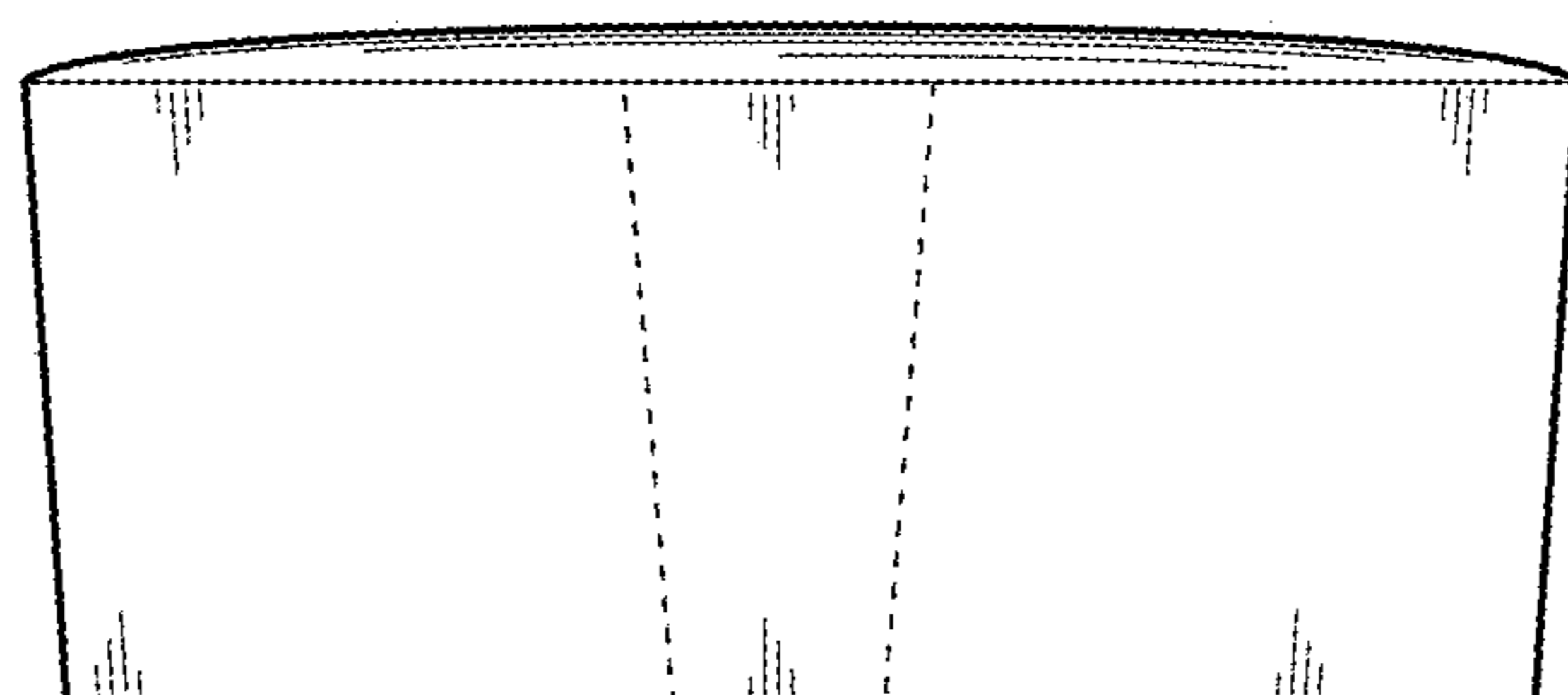

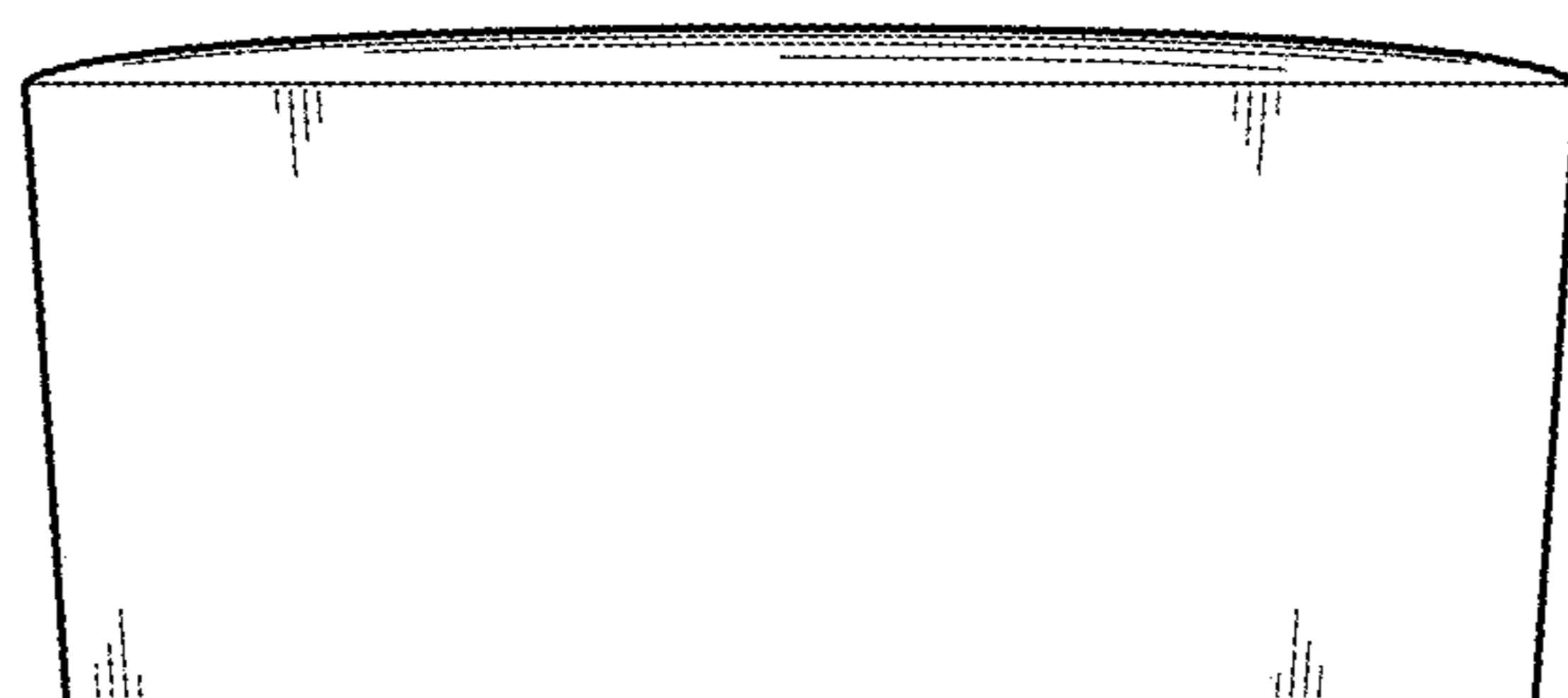

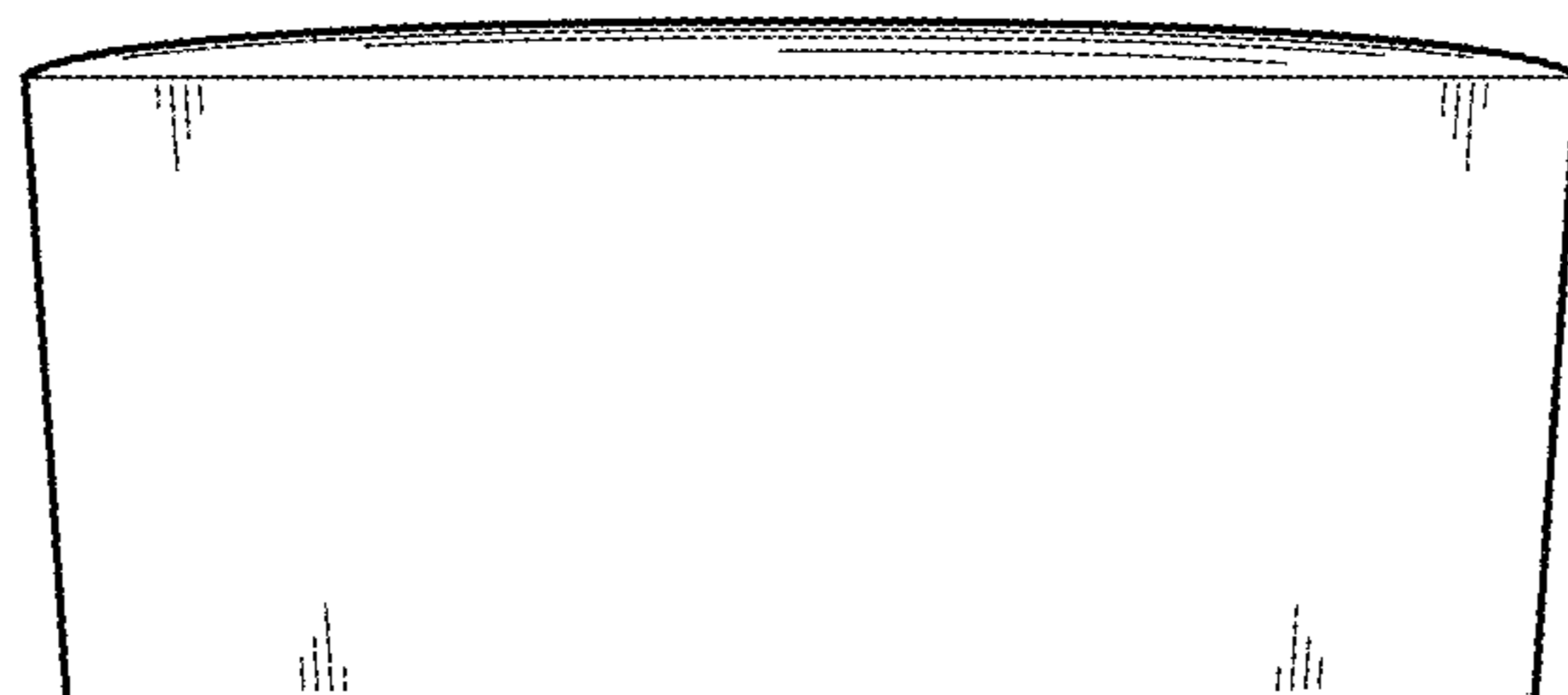

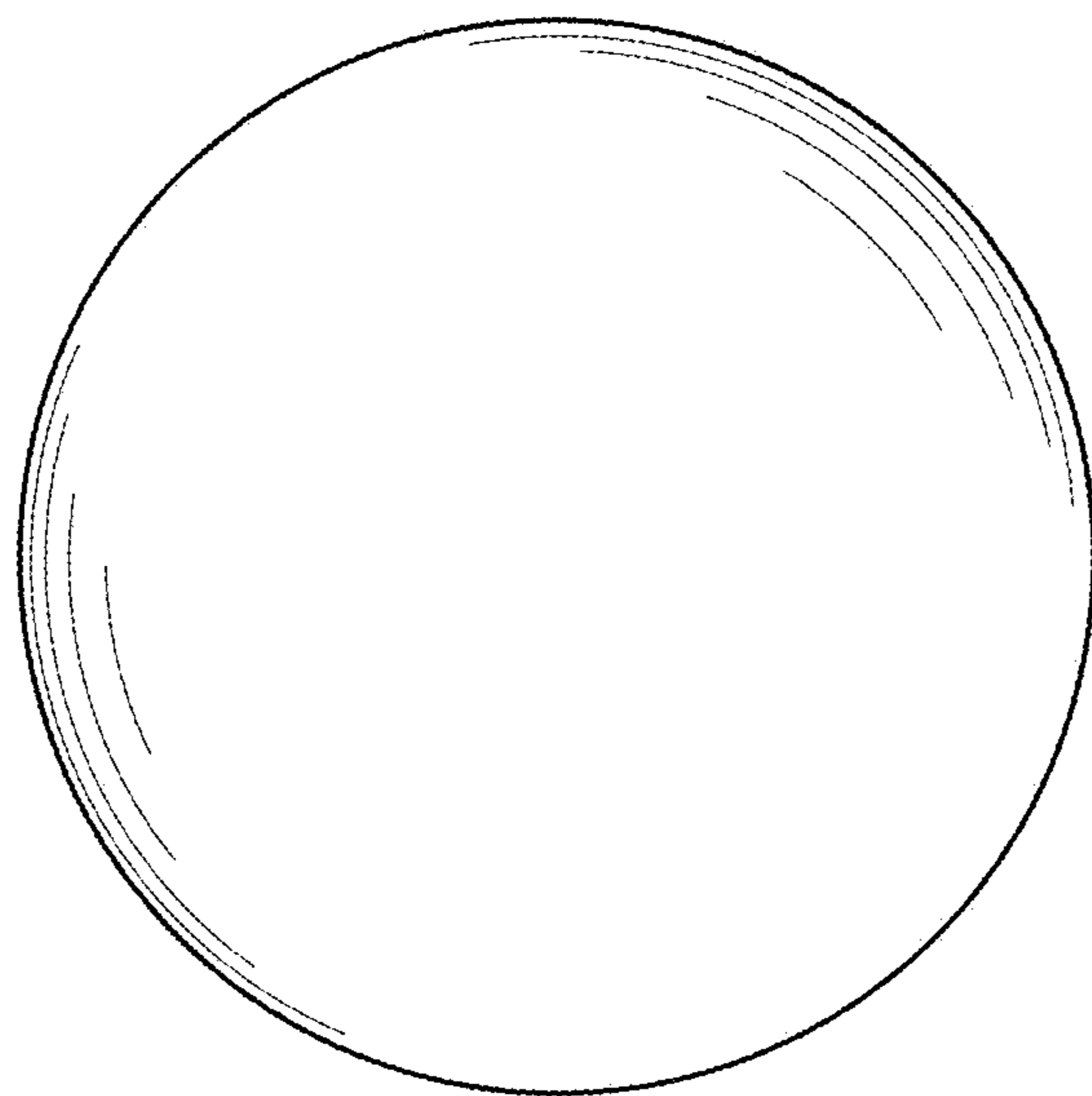

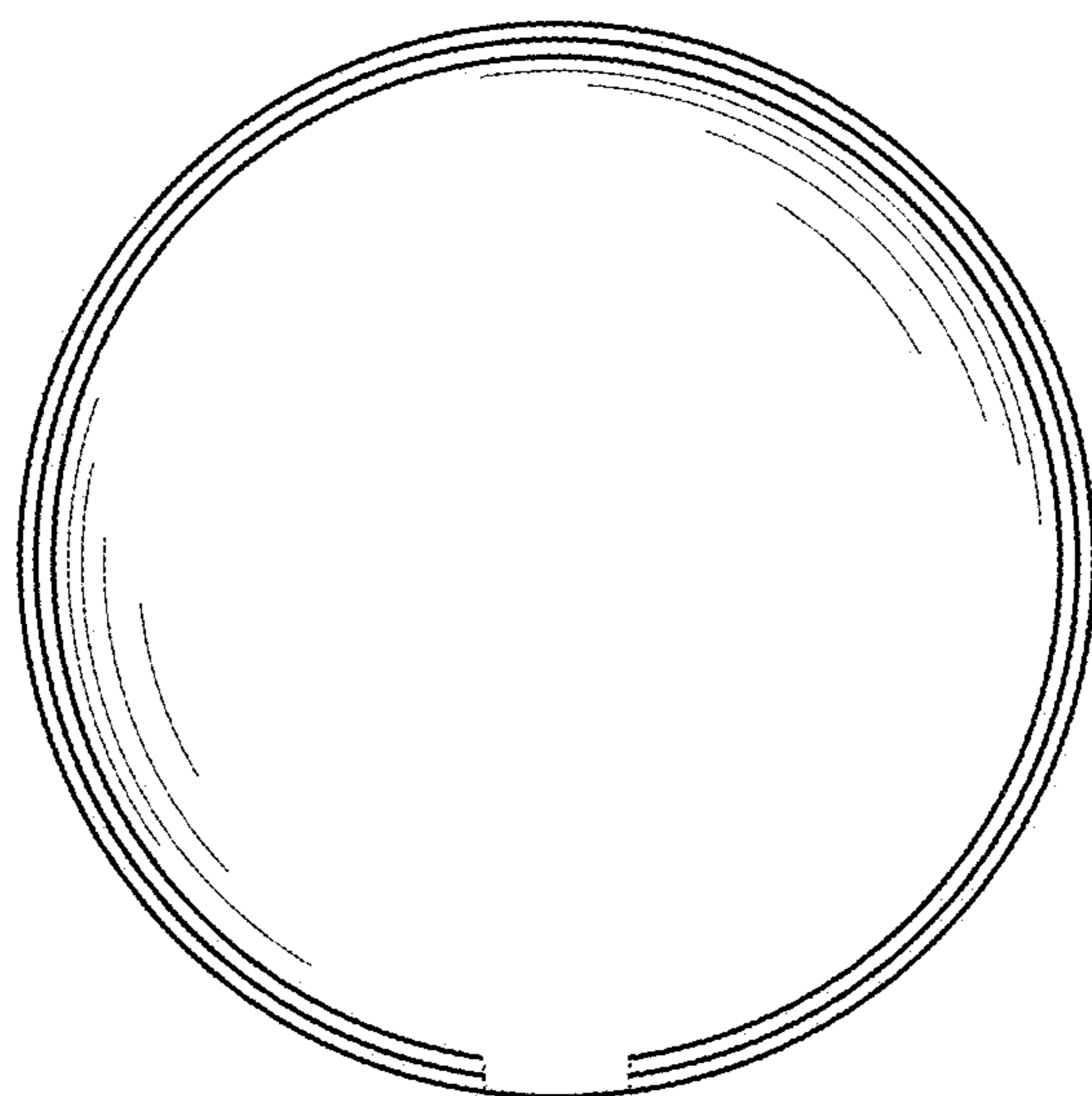
