(57) **CLAIM**

The ornamental design for a sole, substantially as shown and described.

DESCRIPTION

FIG. 1 is a rear, top, left-hand side perspective view of a sole comprising a new, original and ornamental design;

FIG. 2 is a rear view thereof;

FIG. 3 is a bottom view thereof, with the unclaimed pattern of tread grooves seen in FIGS. 2 and 4 omitted;

FIG. 4 is a front view thereof;

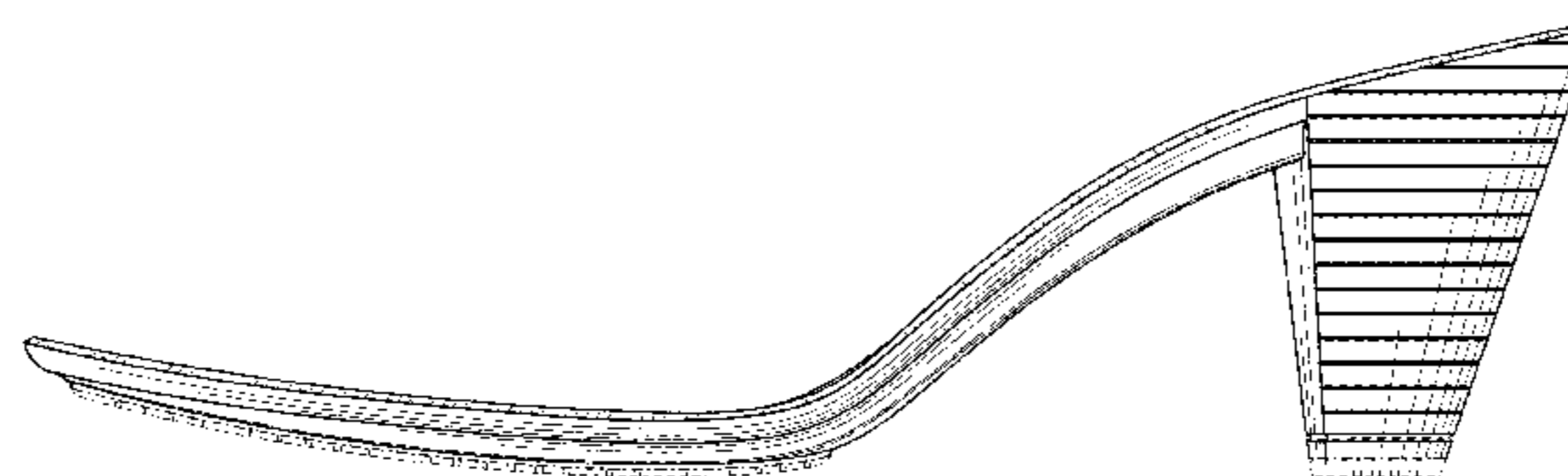
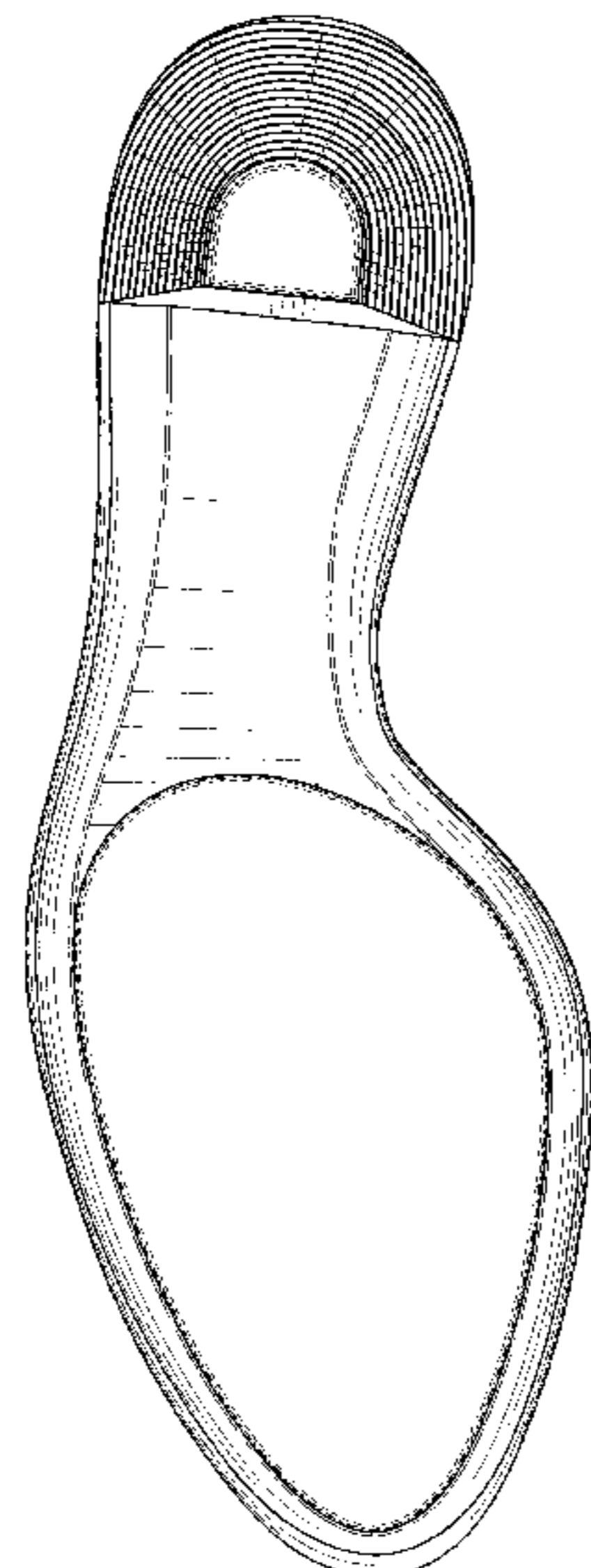
FIG. 5 is a left-hand side view thereof;

FIG. 6 is a right-hand side view thereof; and,

FIG. 7 is a top view thereof.

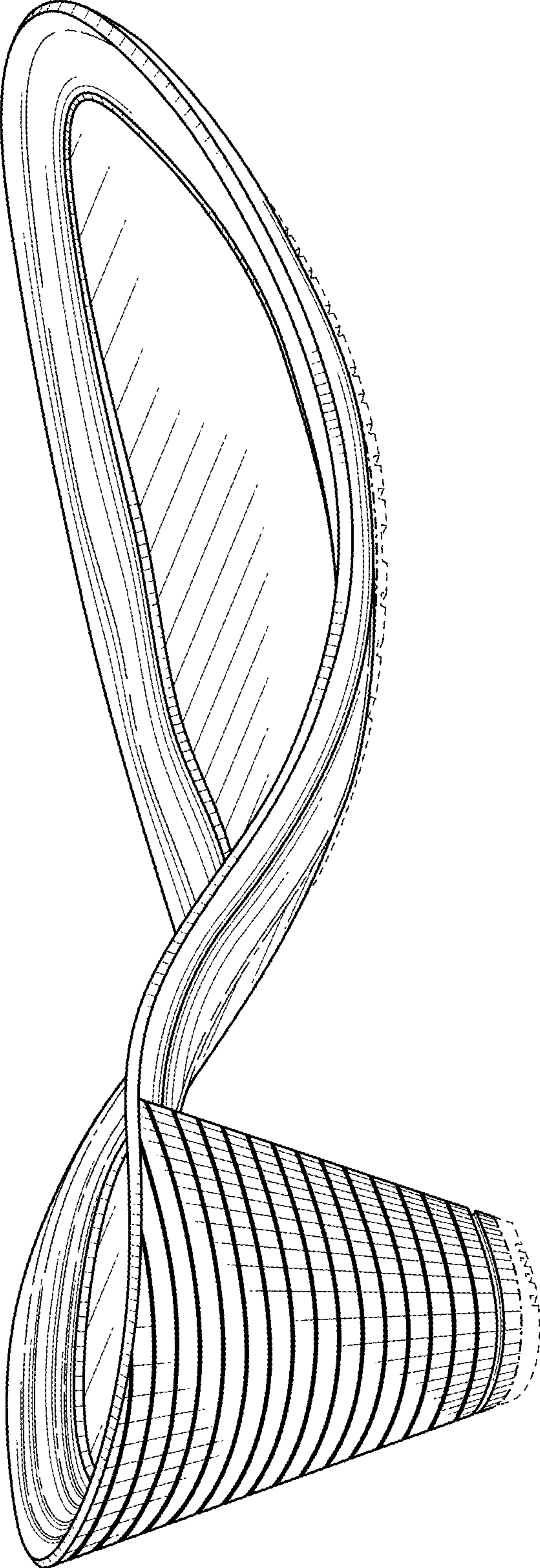

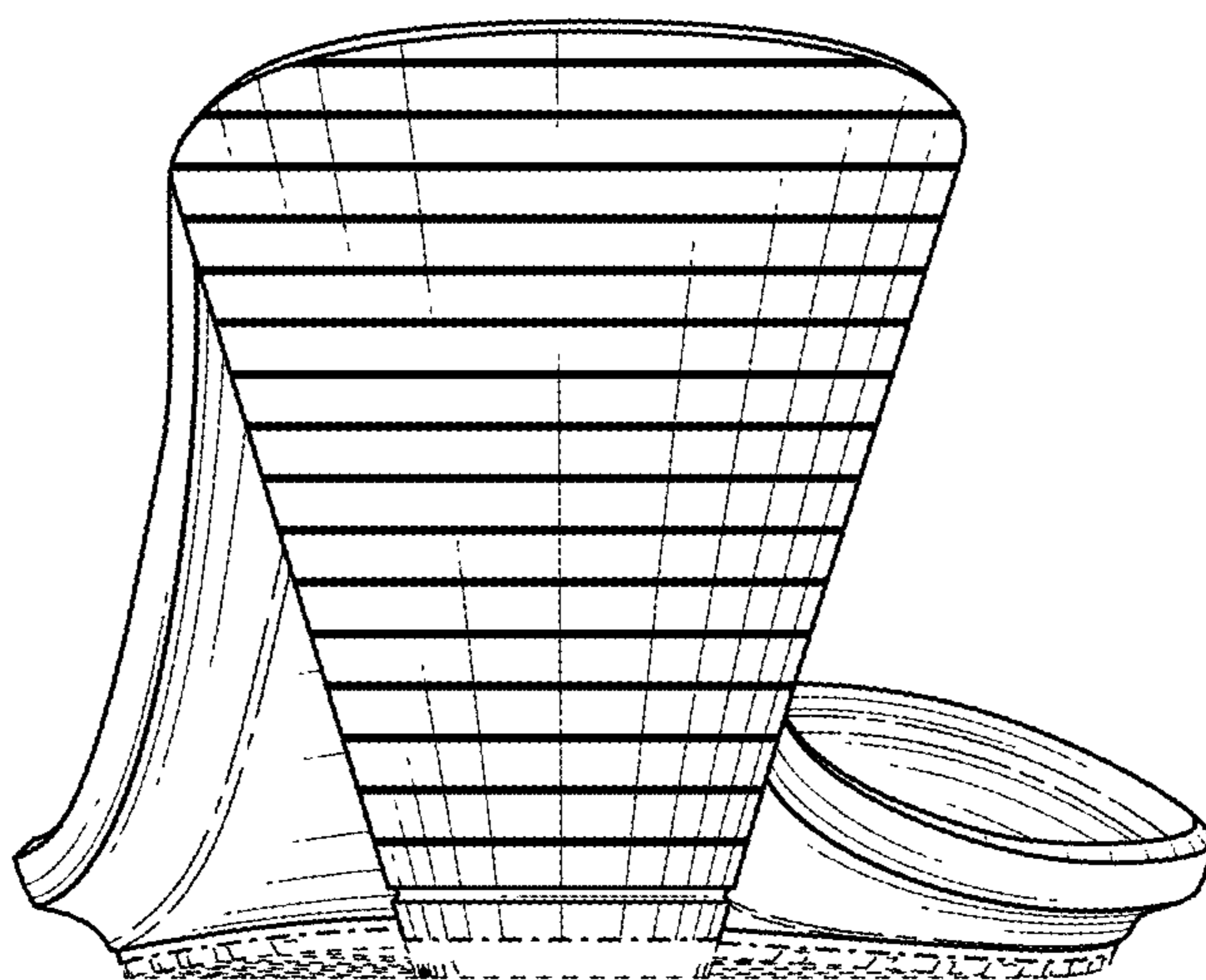

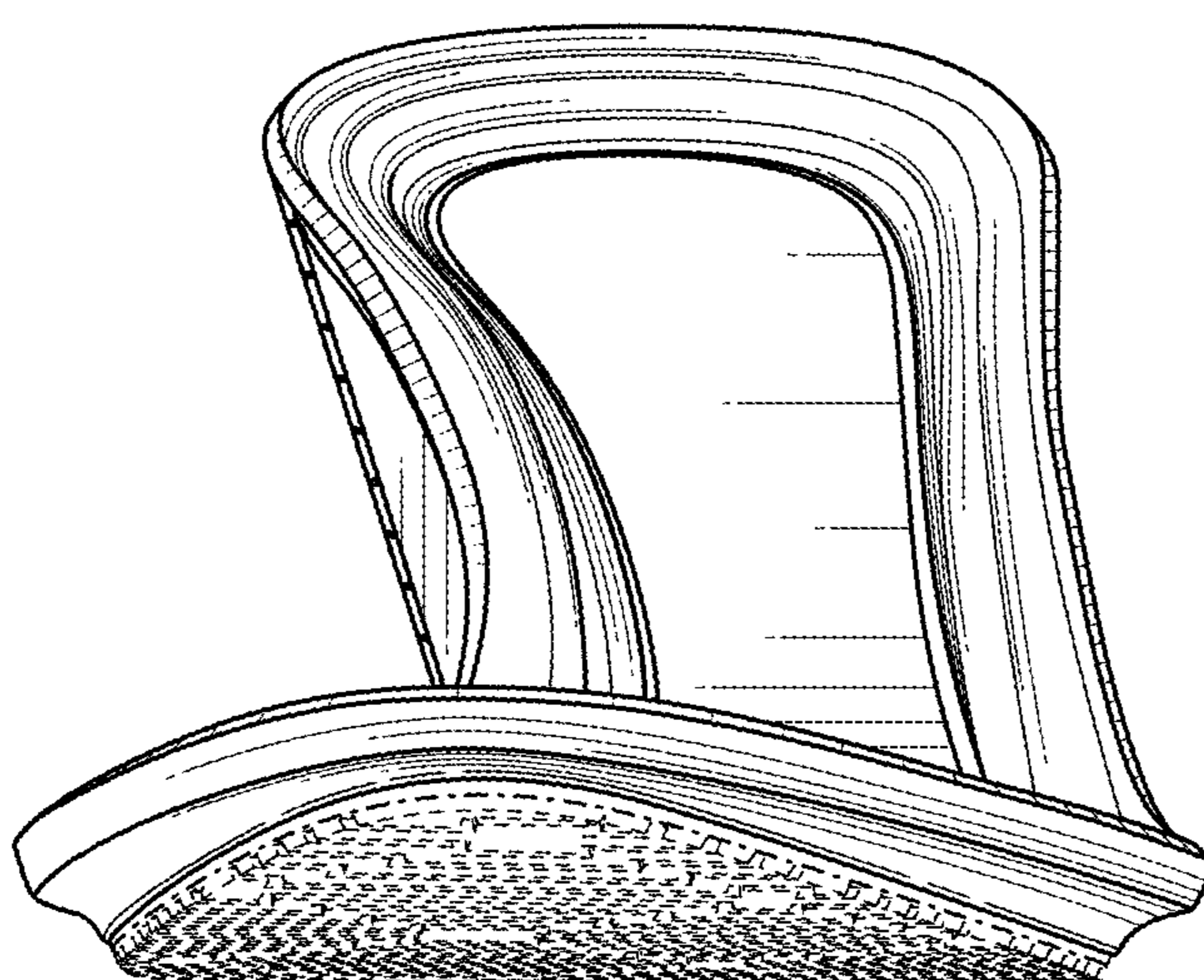

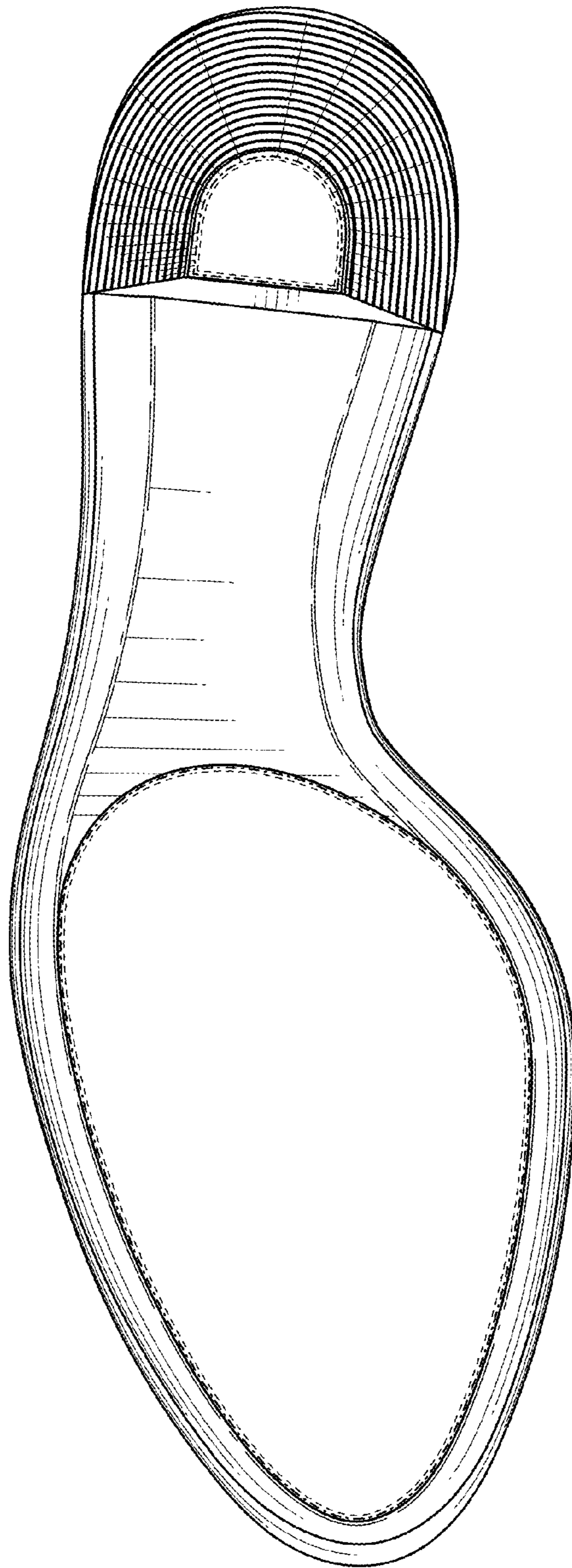

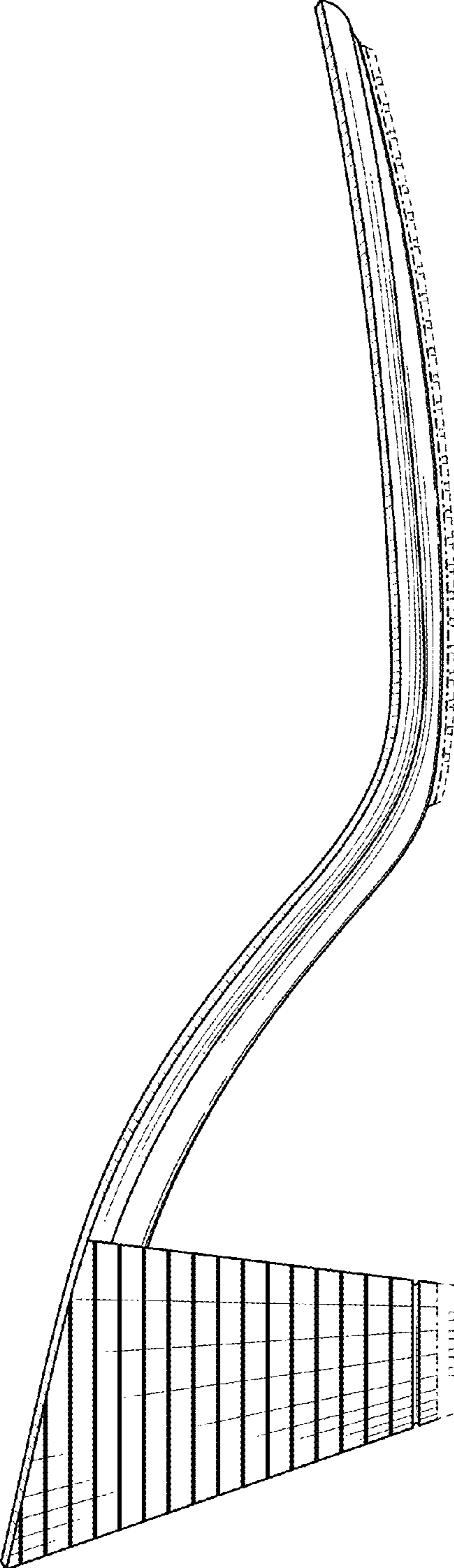

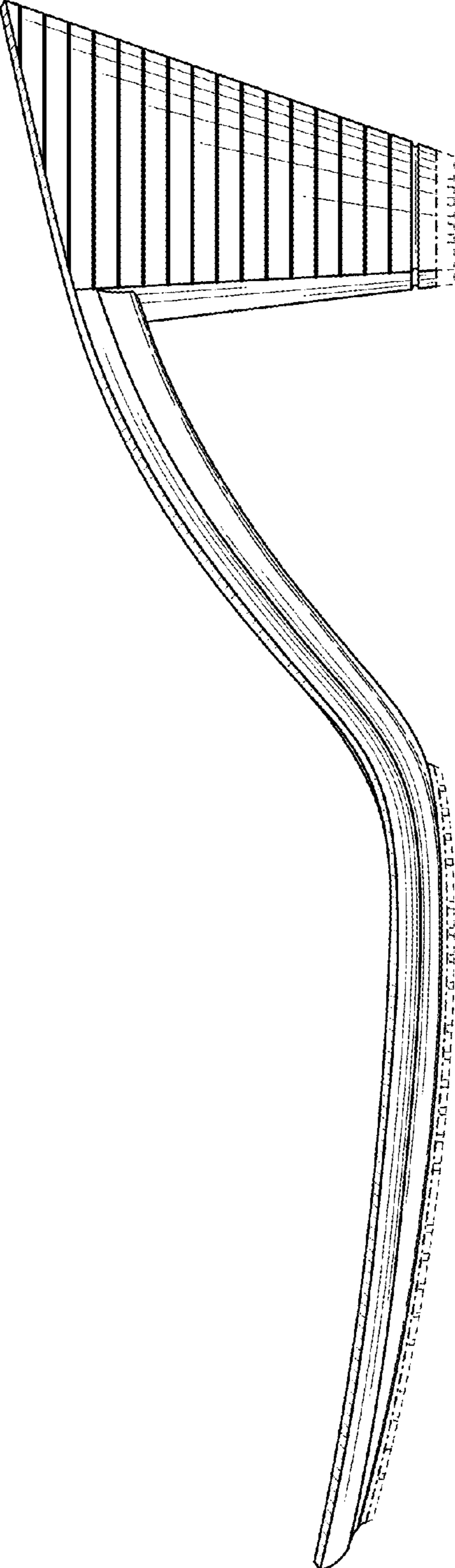

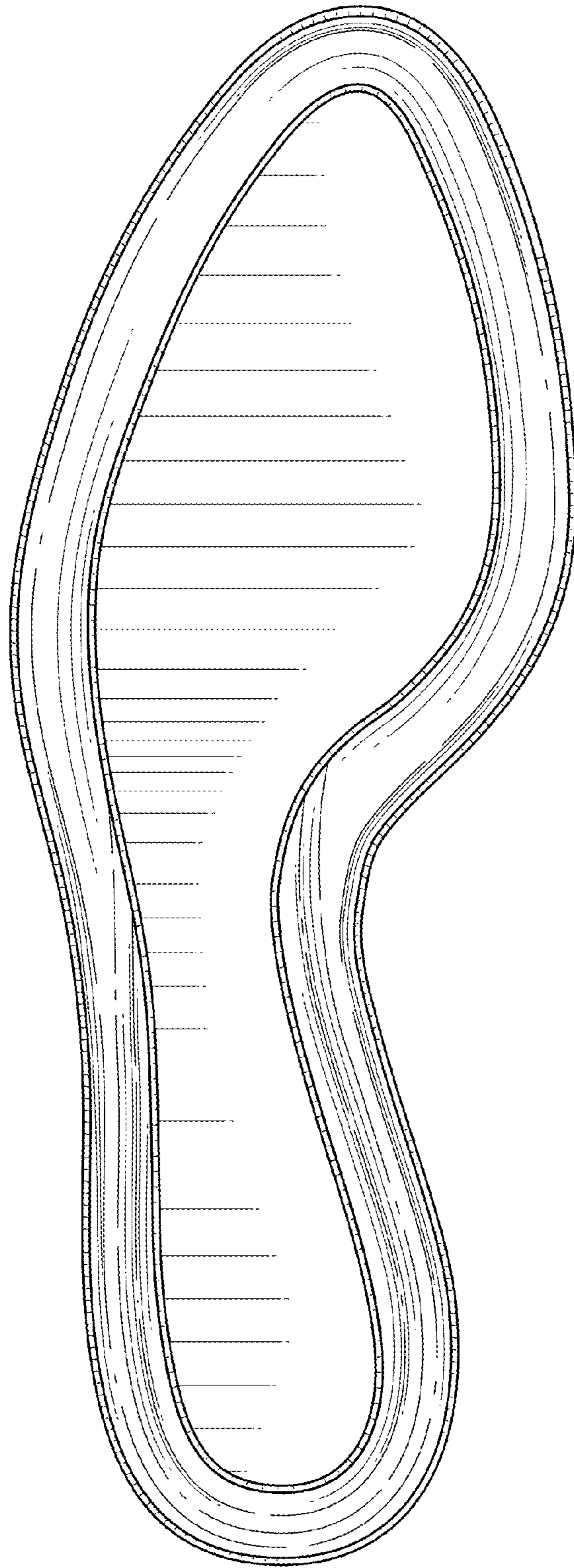
