(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side perspective view of the embodiment of the present invention.

FIG. 2 is a front elevation view of the embodiment shown in FIG. 1.

FIG. 3 is a rear elevation view of the embodiment shown in FIG. 1.

FIG. 4 is a bottom plan view of the embodiment shown in FIG. 1.

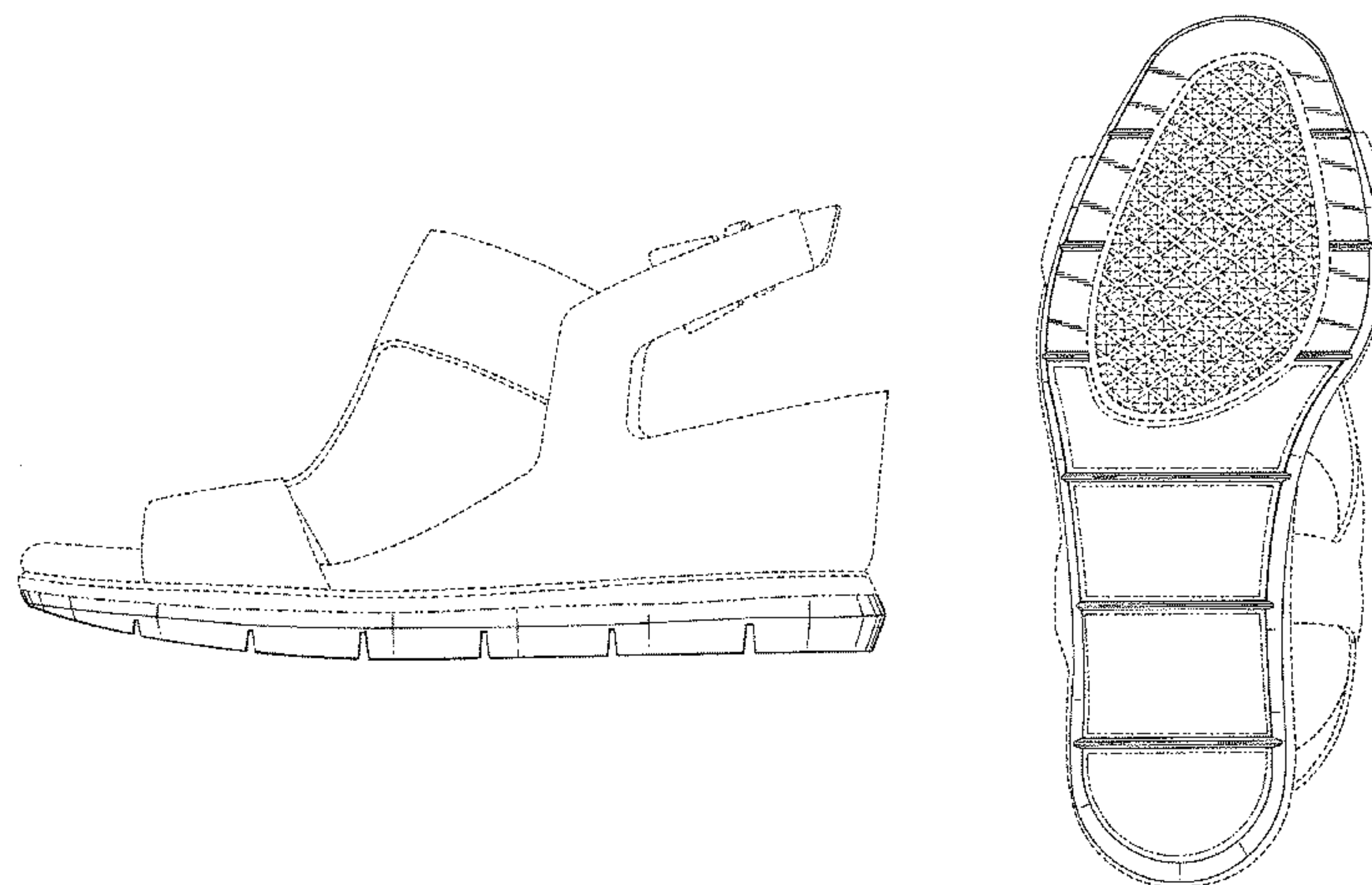
FIG. 5 is a top plan view of the embodiment shown in FIG. 1.

FIG. 6 is a right side elevation view of the embodiment shown in FIG. 1; and,

FIG. 7 is a left side elevation view of the embodiment shown in FIG. 1.

No claim is made to the dashed line regions on the shoe sole or the inner tread portions or diamond boundary outside the disclaimed break-lines as shown, nor is any claim made to the shoe upper as the dashed lines indicate disclaimed portions forming no part of the claimed design. No claimed portion is visible from the top, and FIG. 5 is provided to confirm.

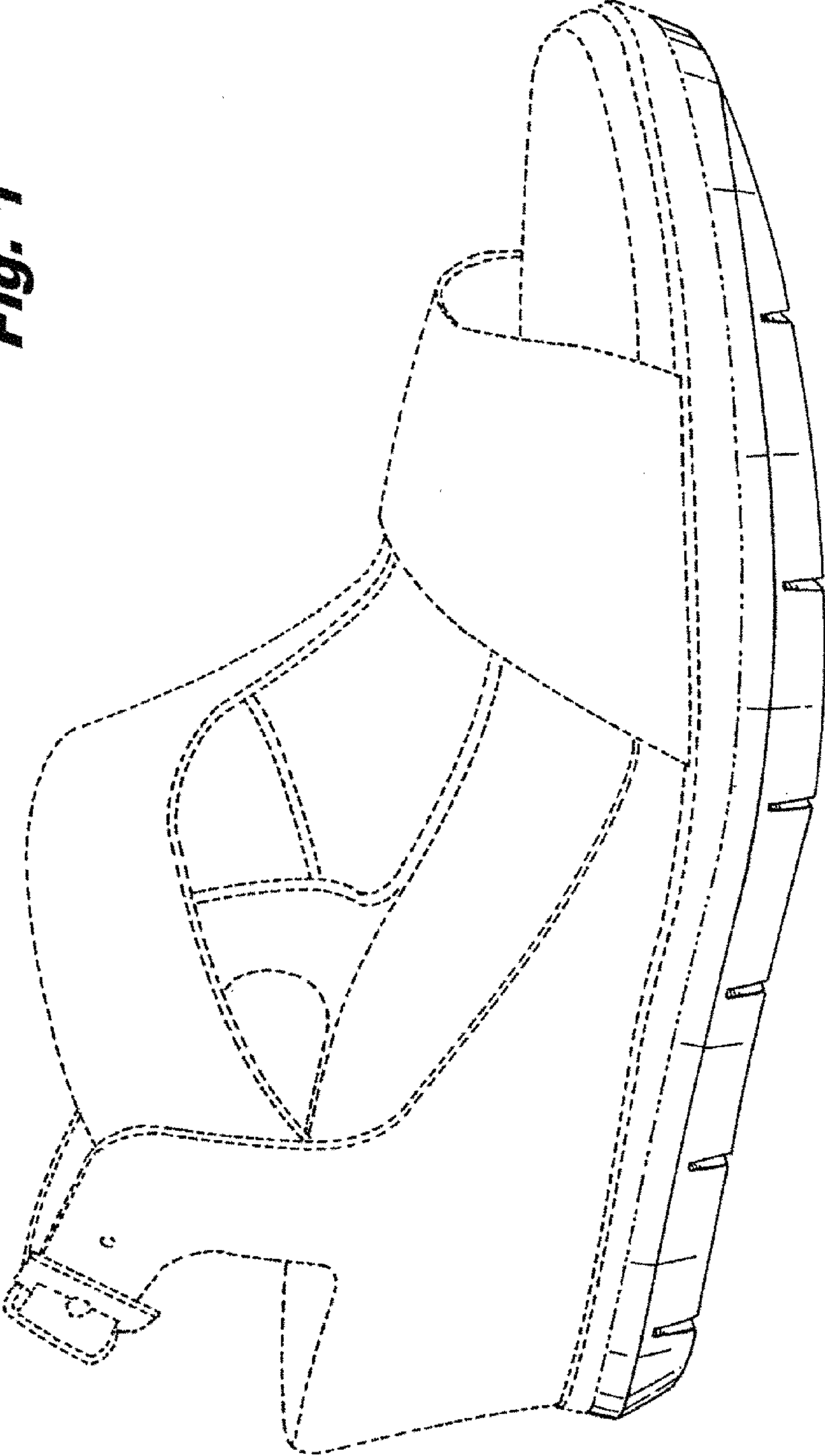

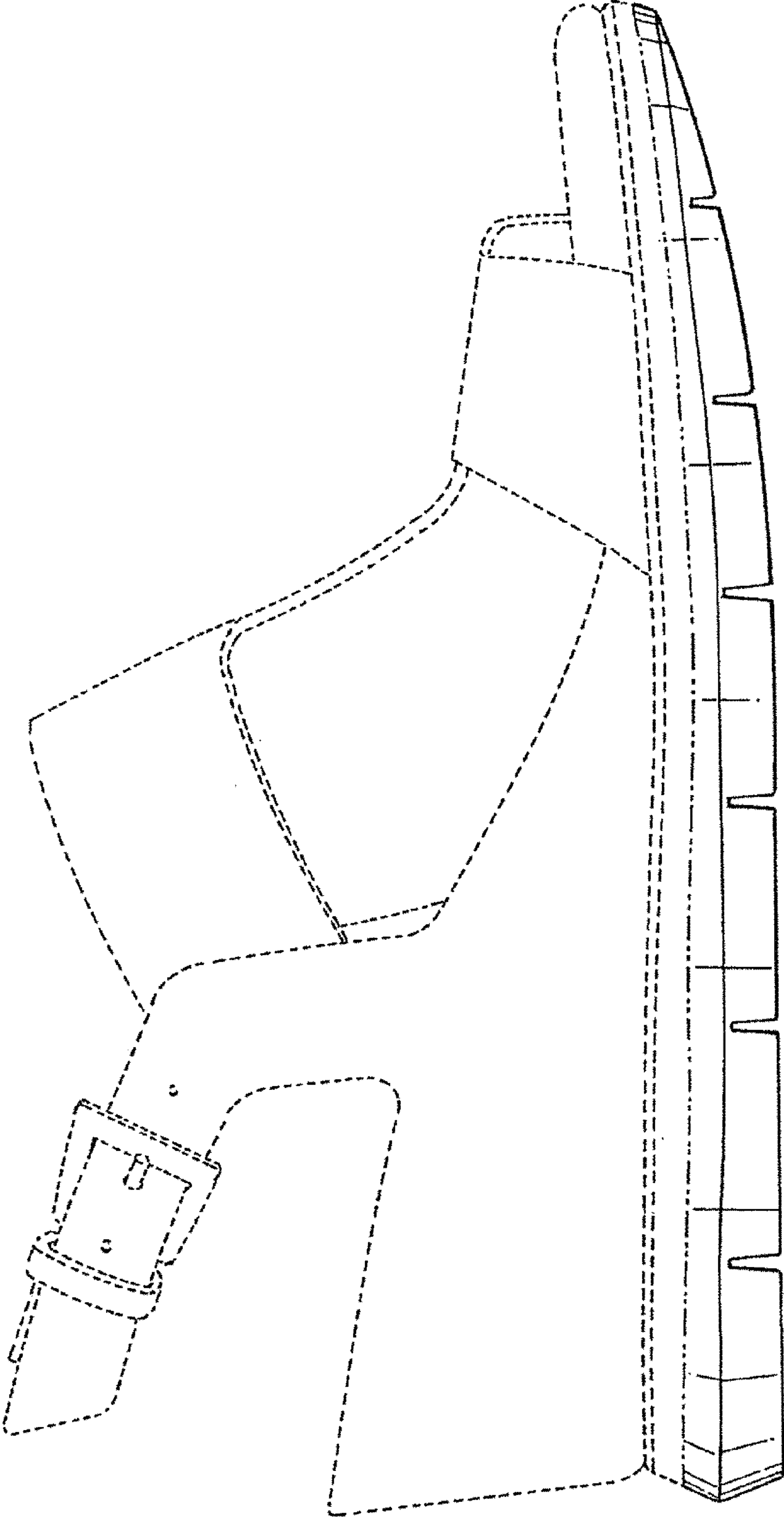

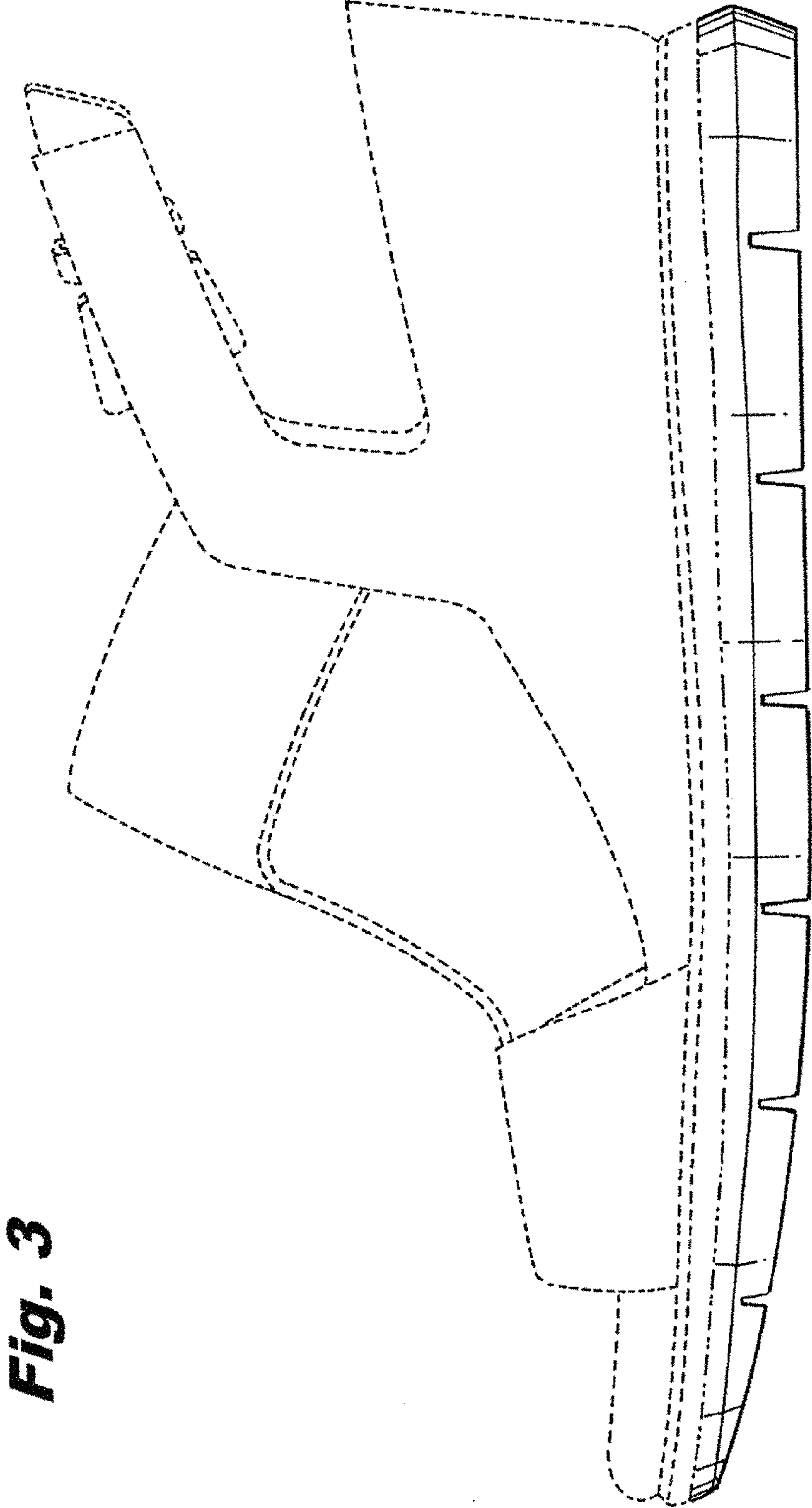

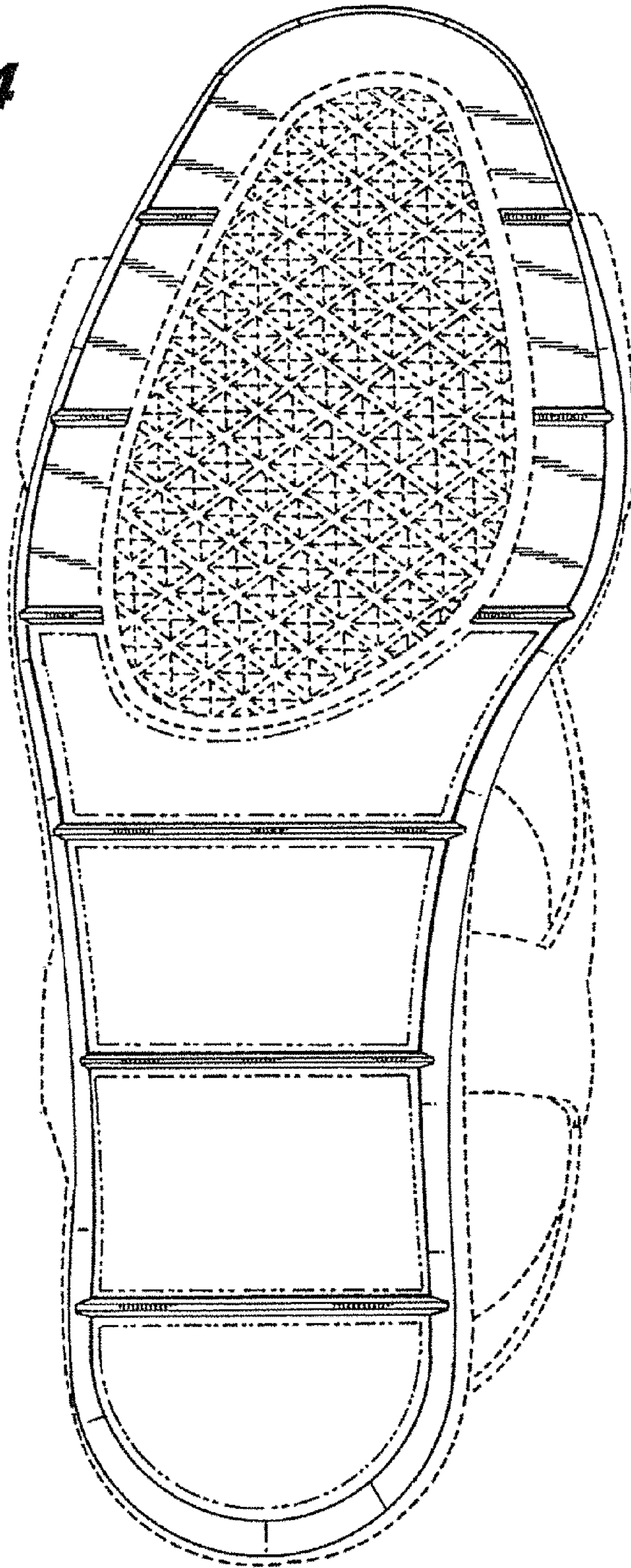

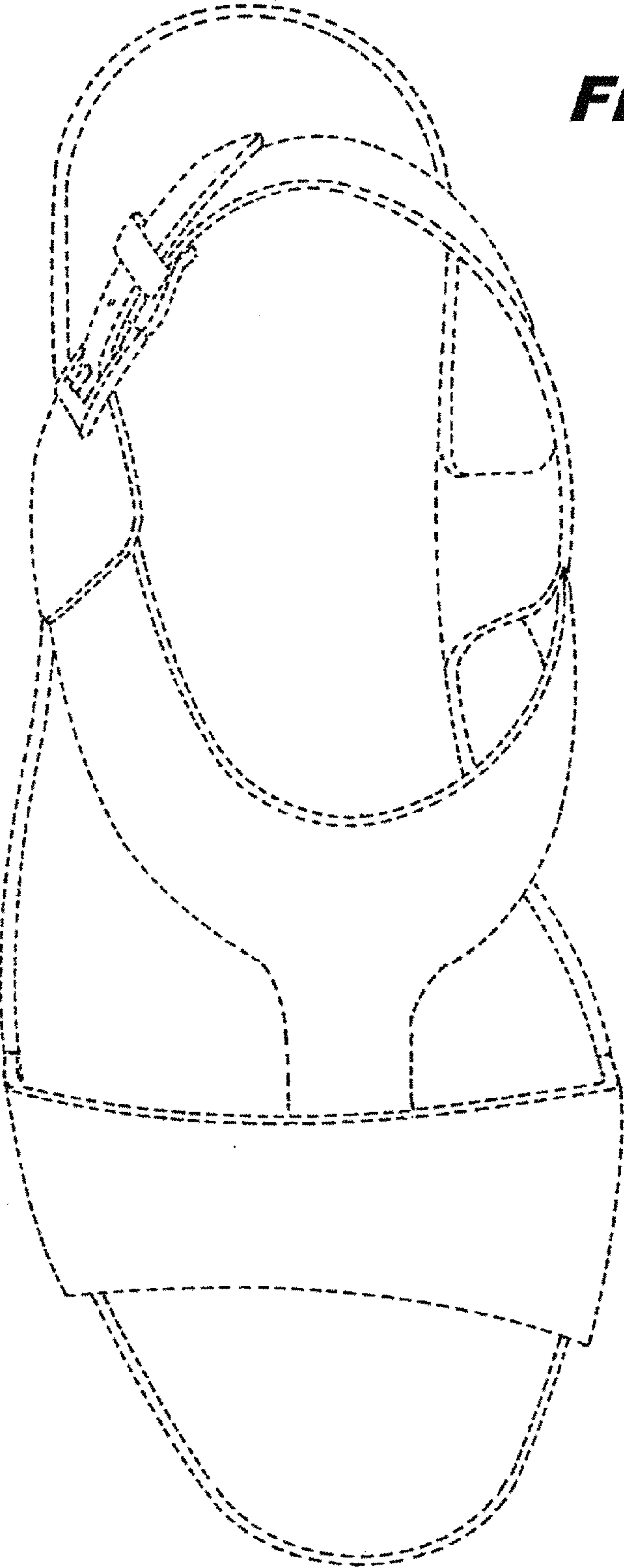

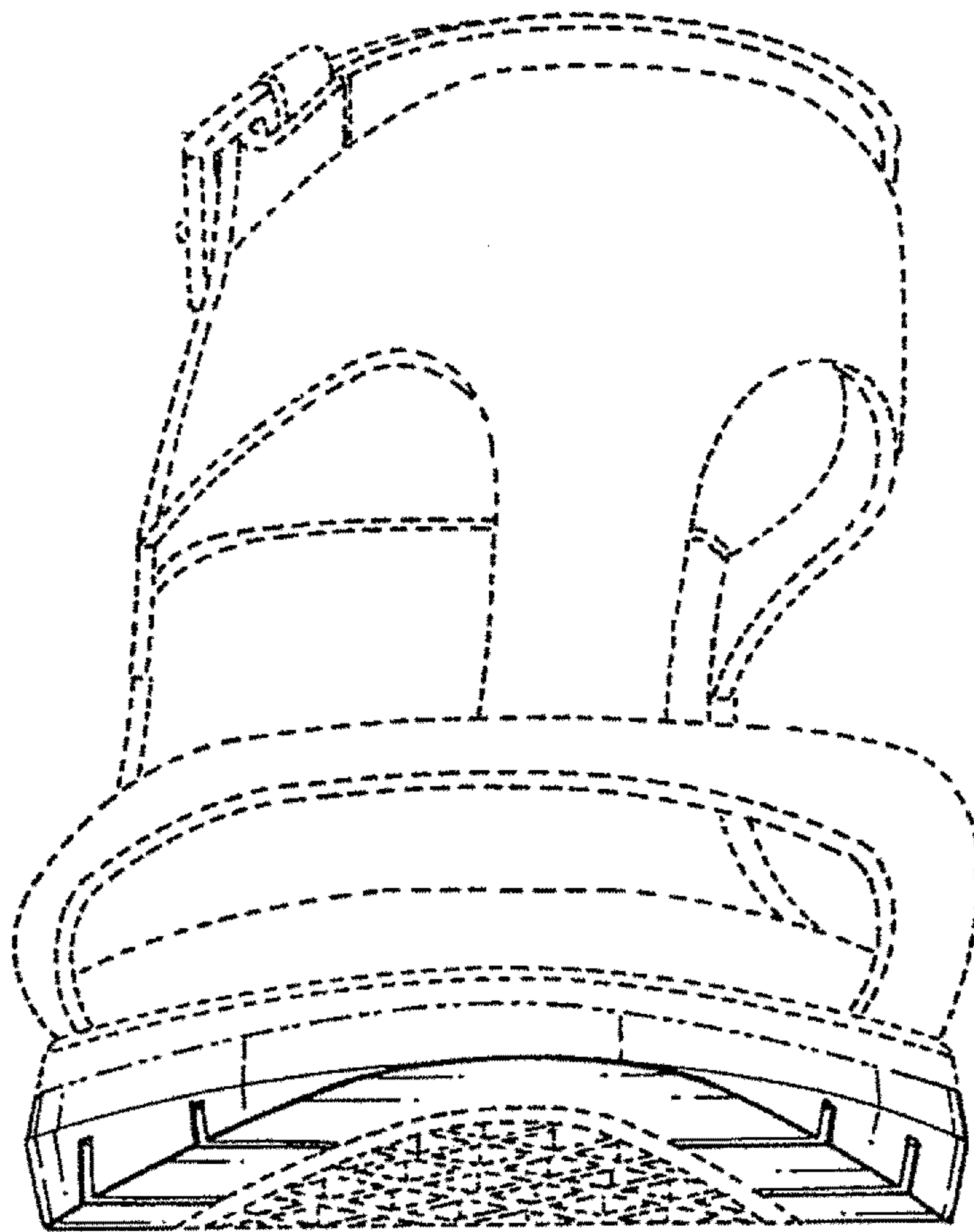
