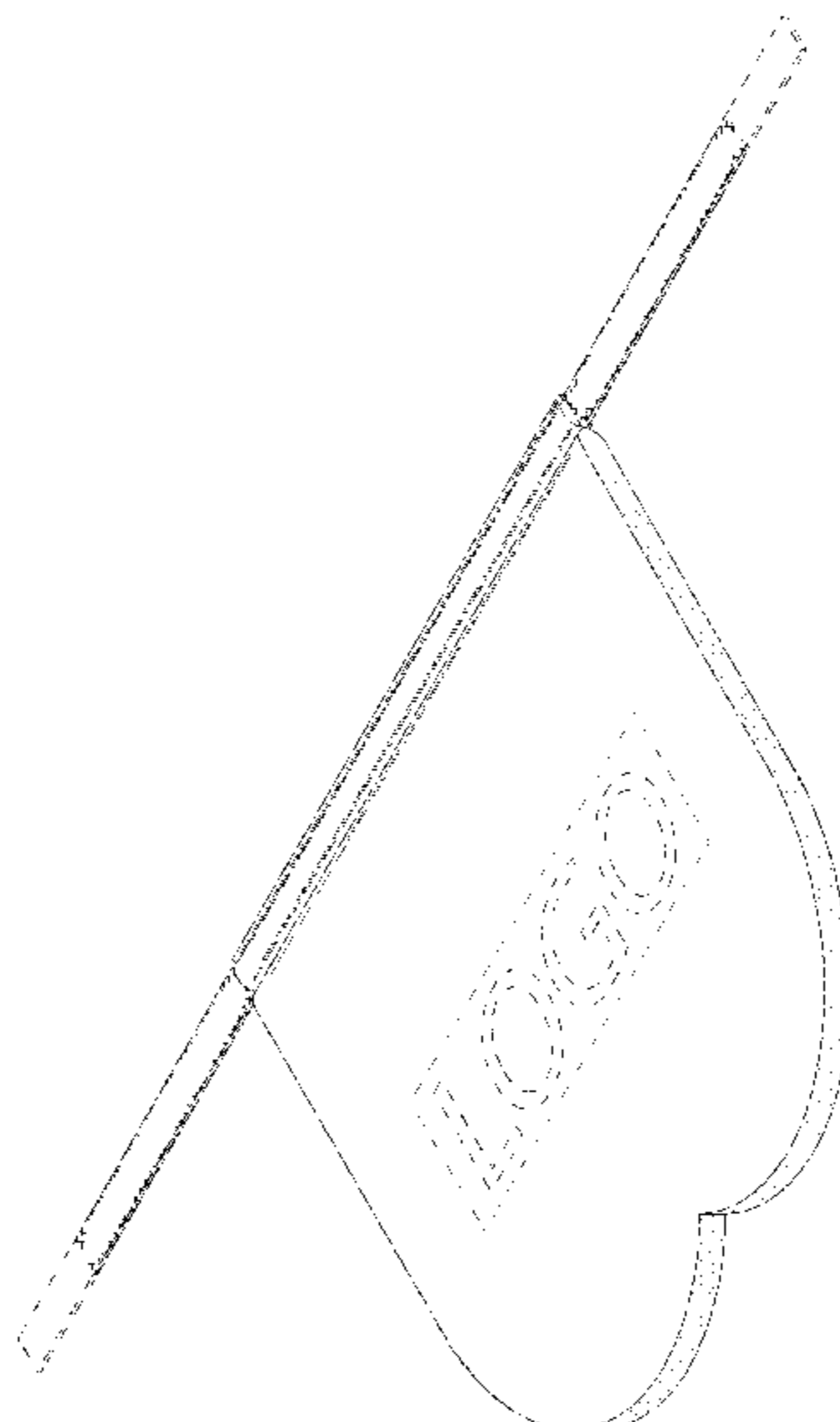
(57) **CLAIM**

The ornamental design for a strap on countoured stadium cushion, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of my new design for a strap on countoured stadium cushion;

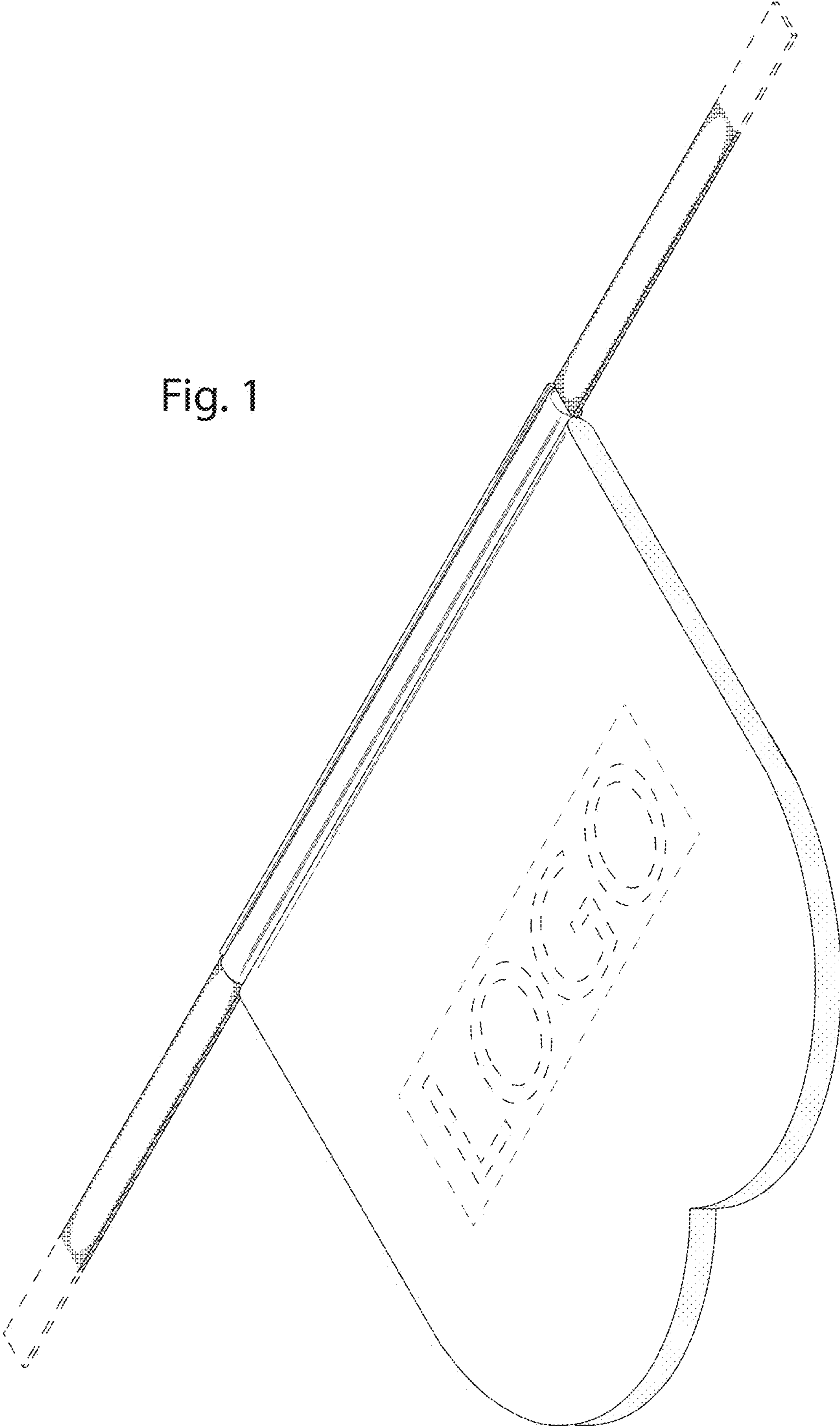

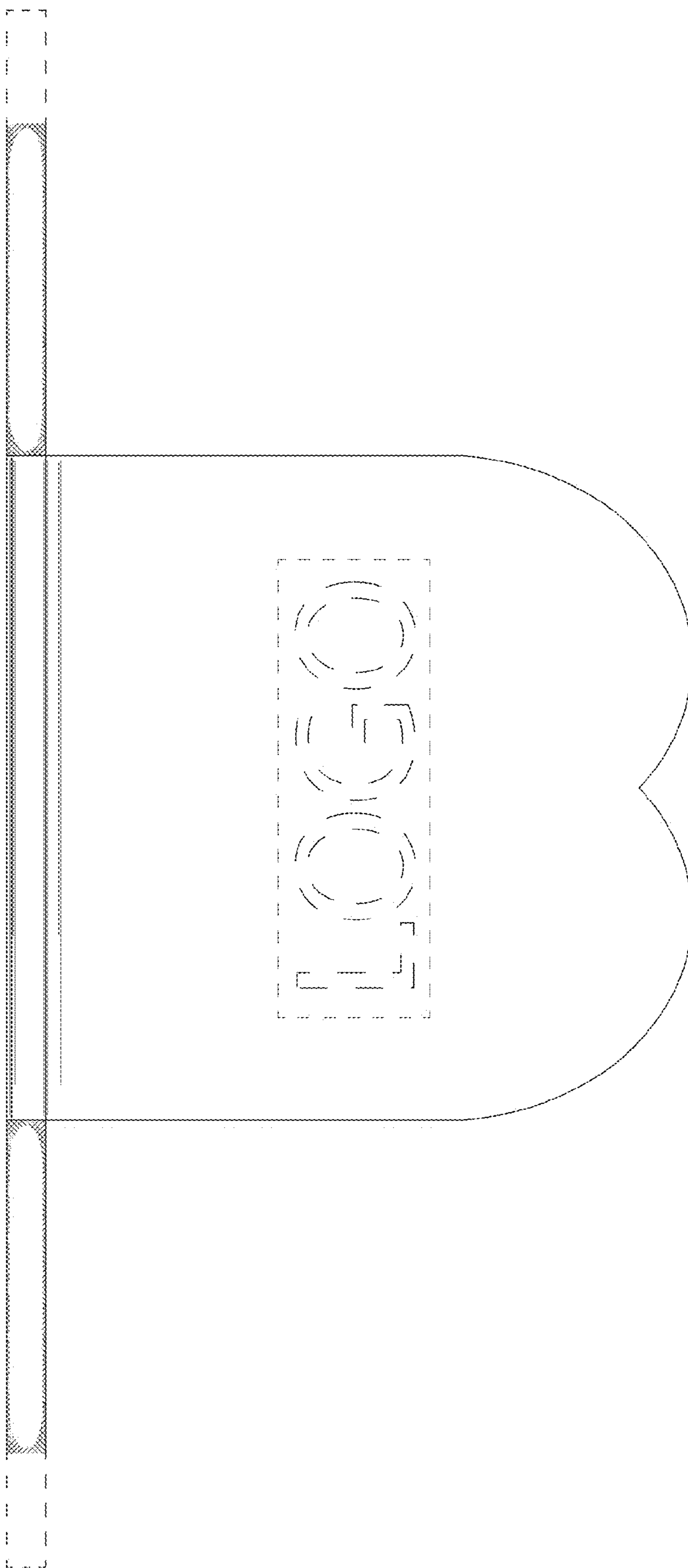

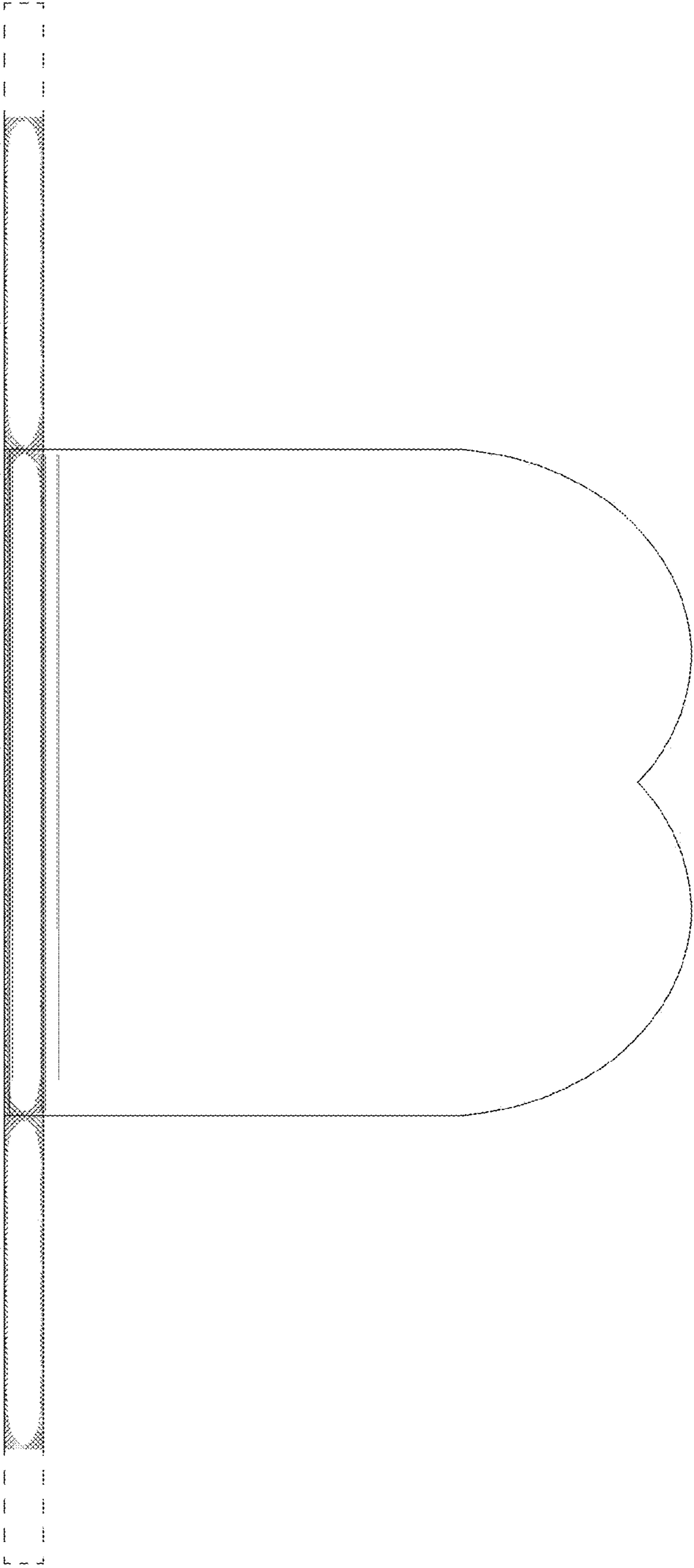

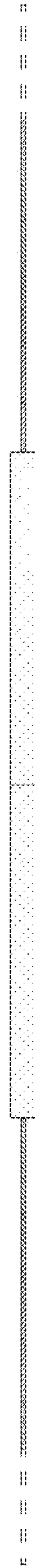

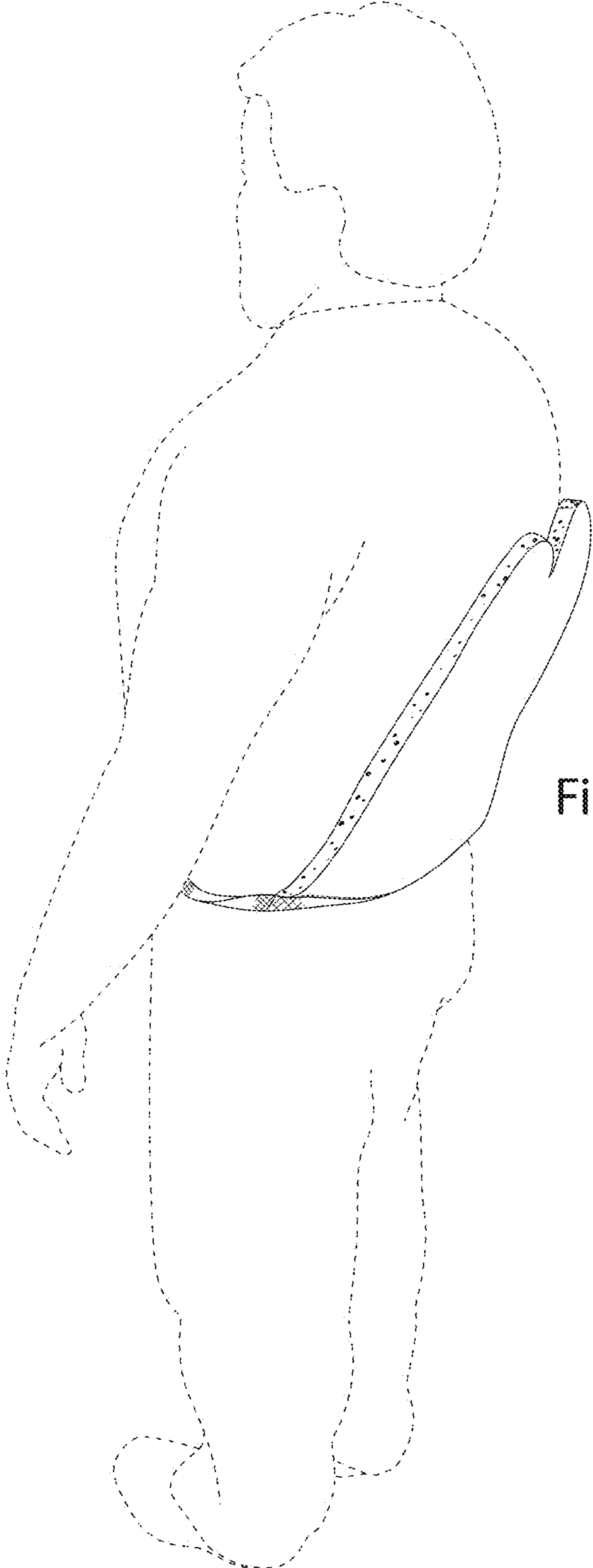

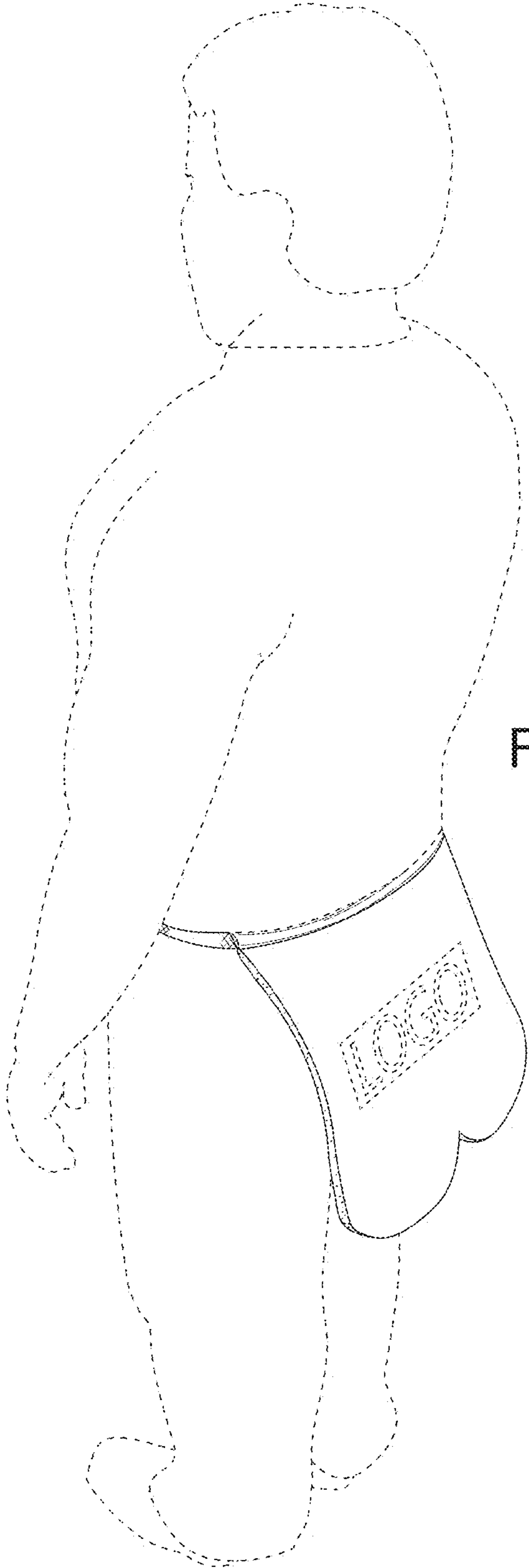

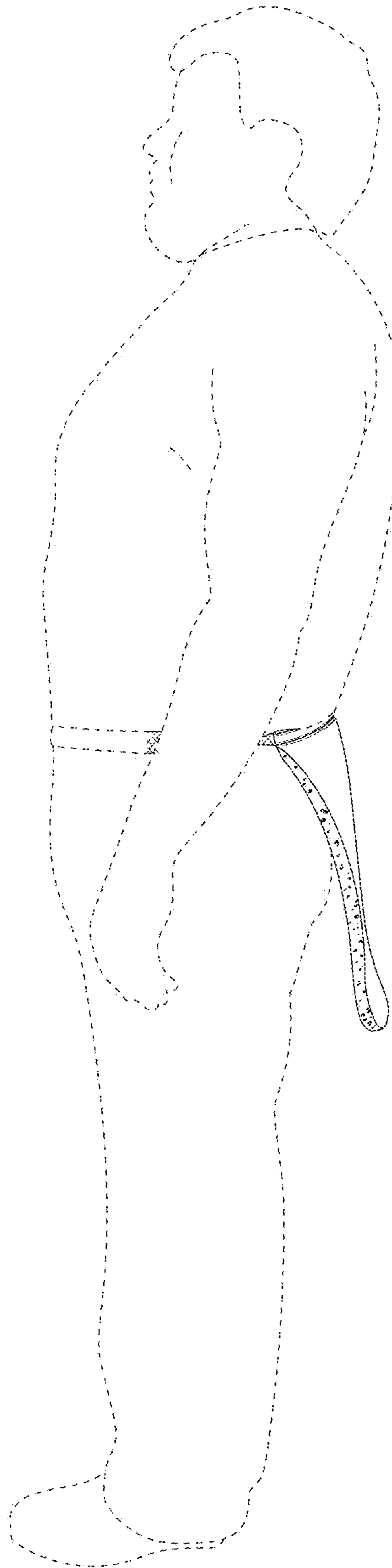

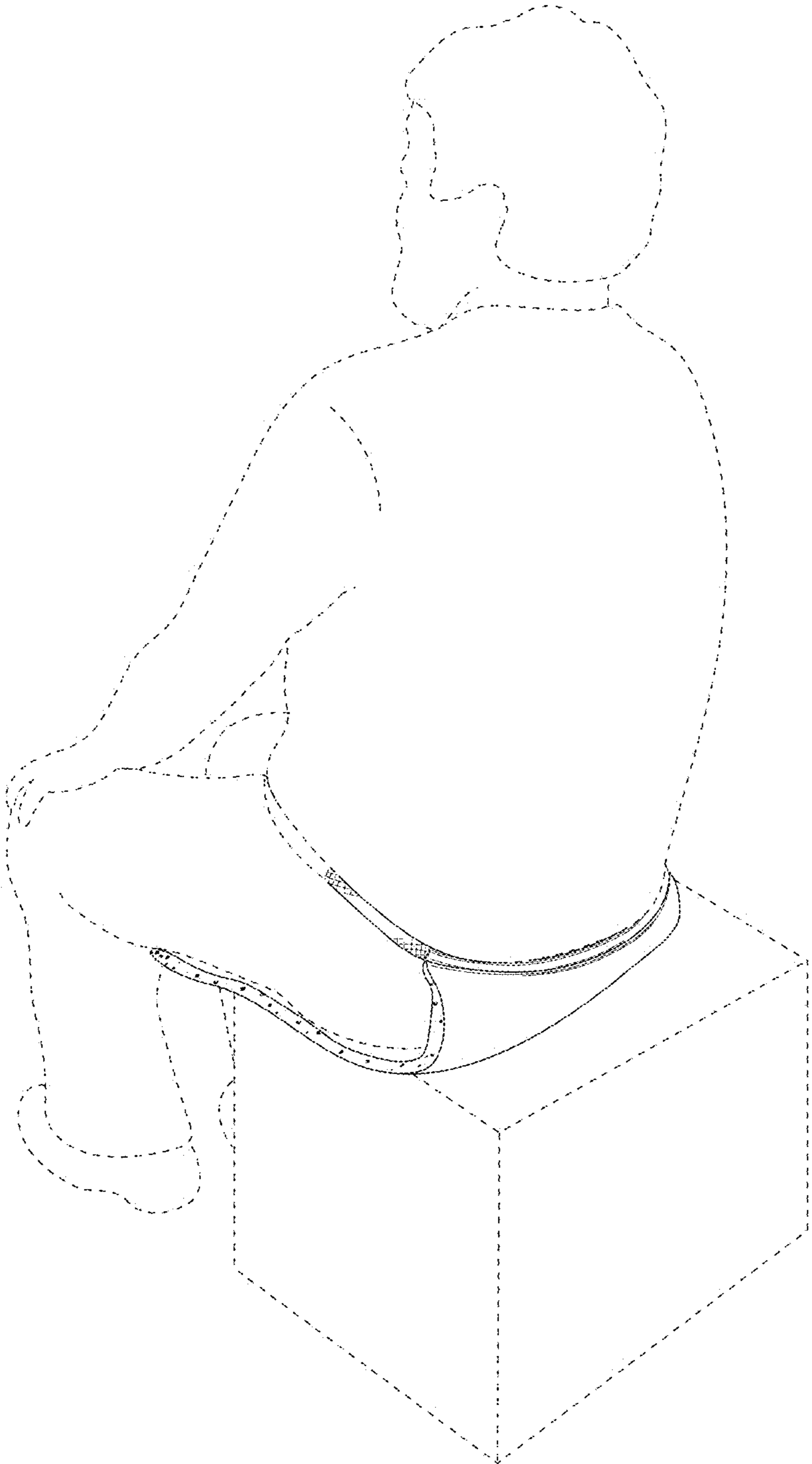
