DESCRIPTION

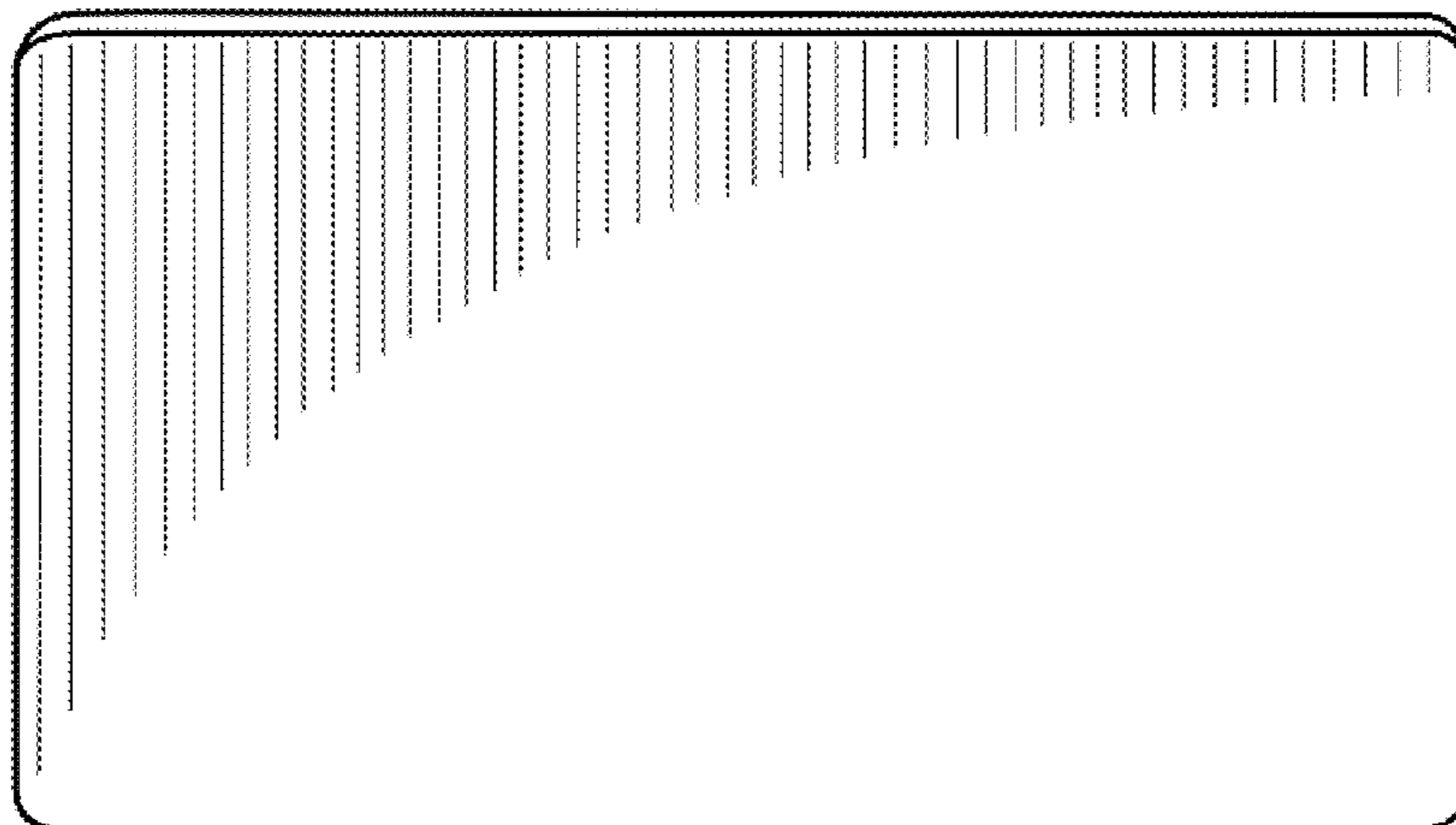
FIG. 1 is a top plan view of a single sided merchandiser;

 FIG. 9 is a front isometric view thereof, showing its front door open, and the removable bins seen in FIG. 8 set aside.

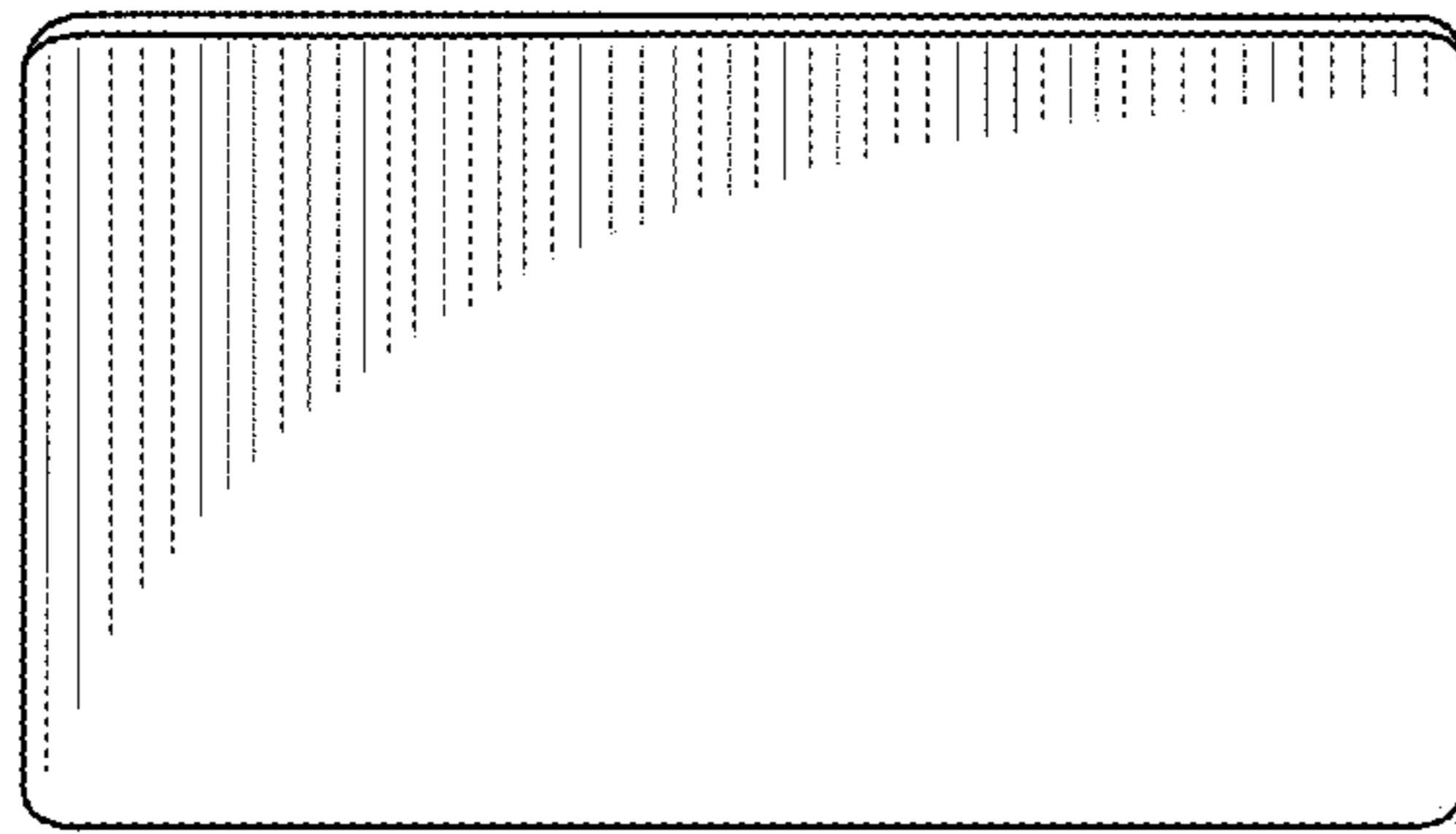

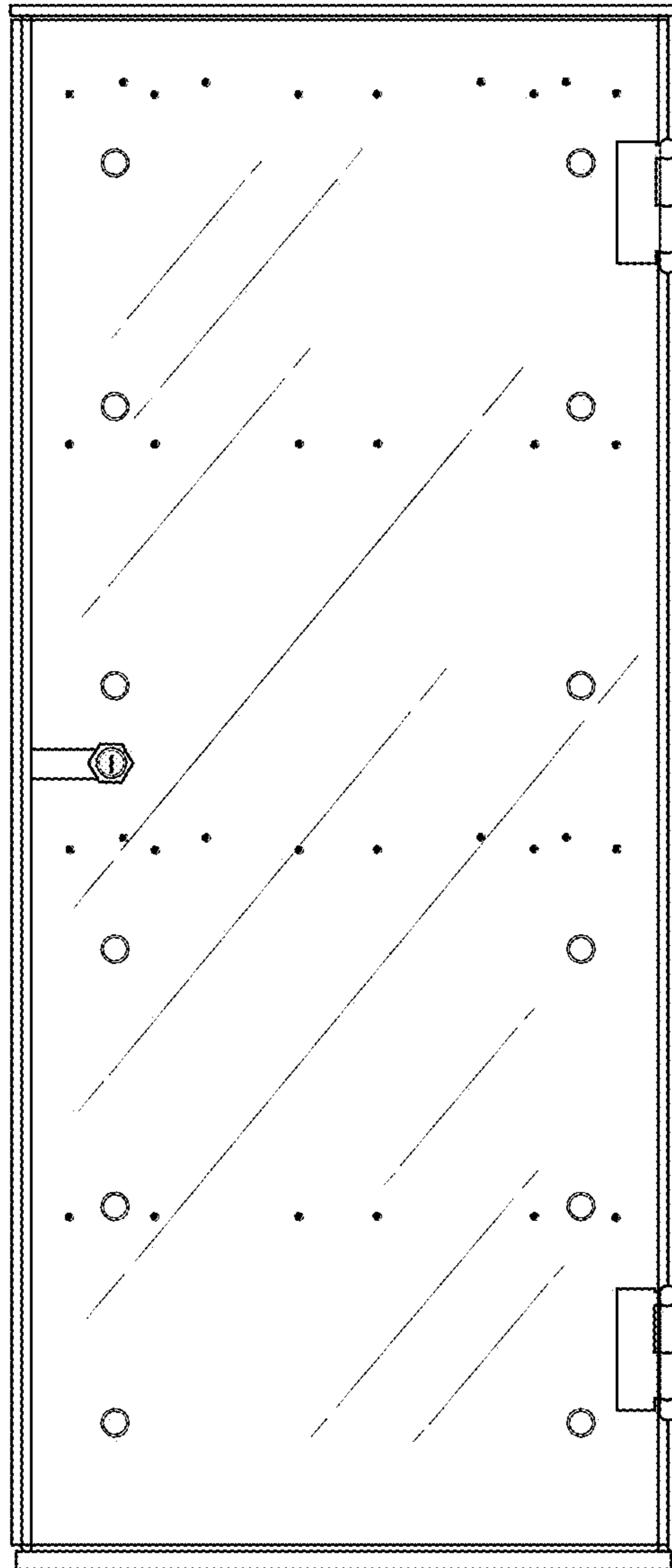

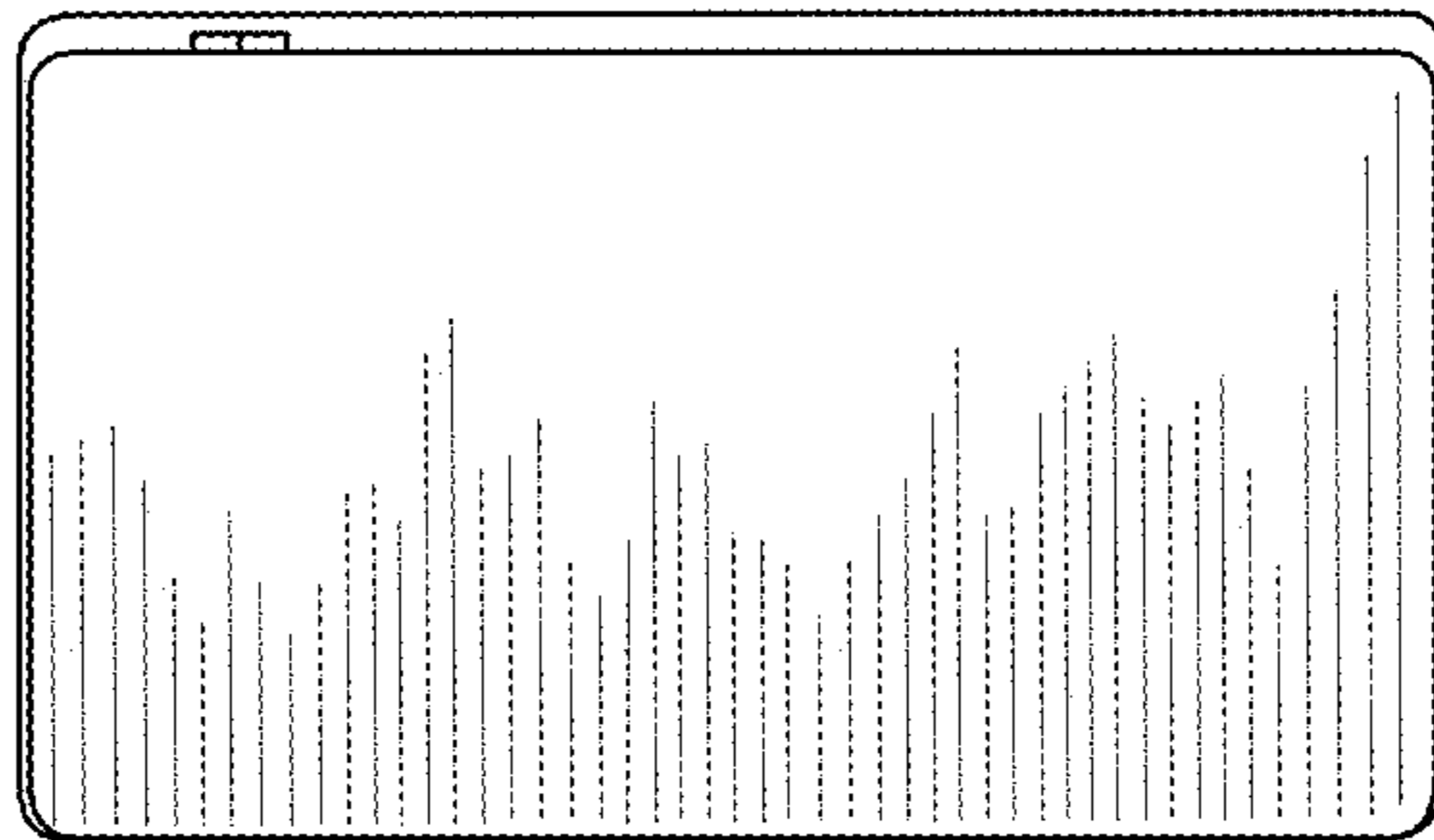

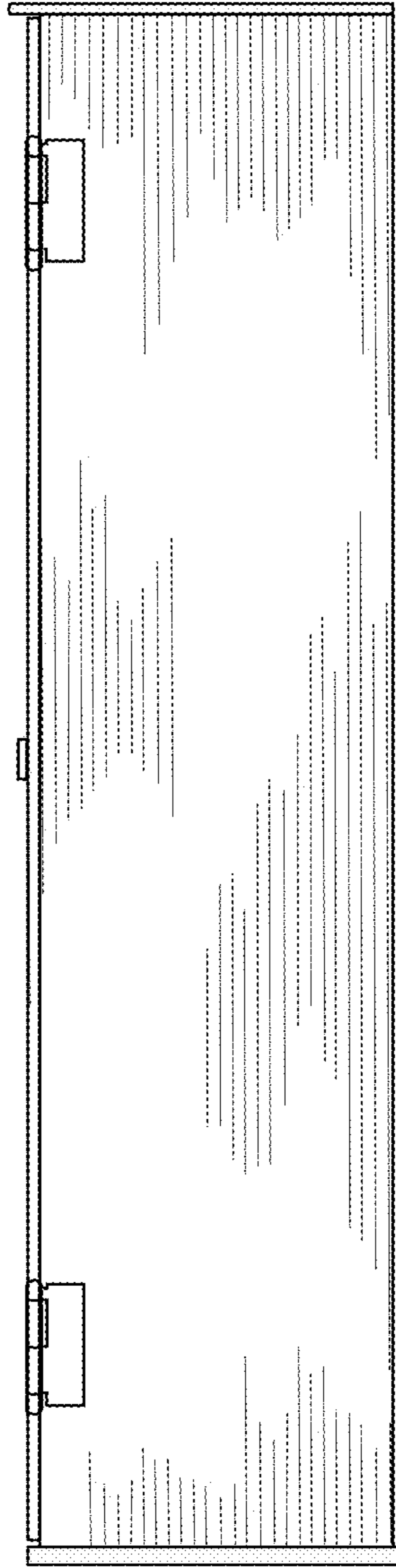

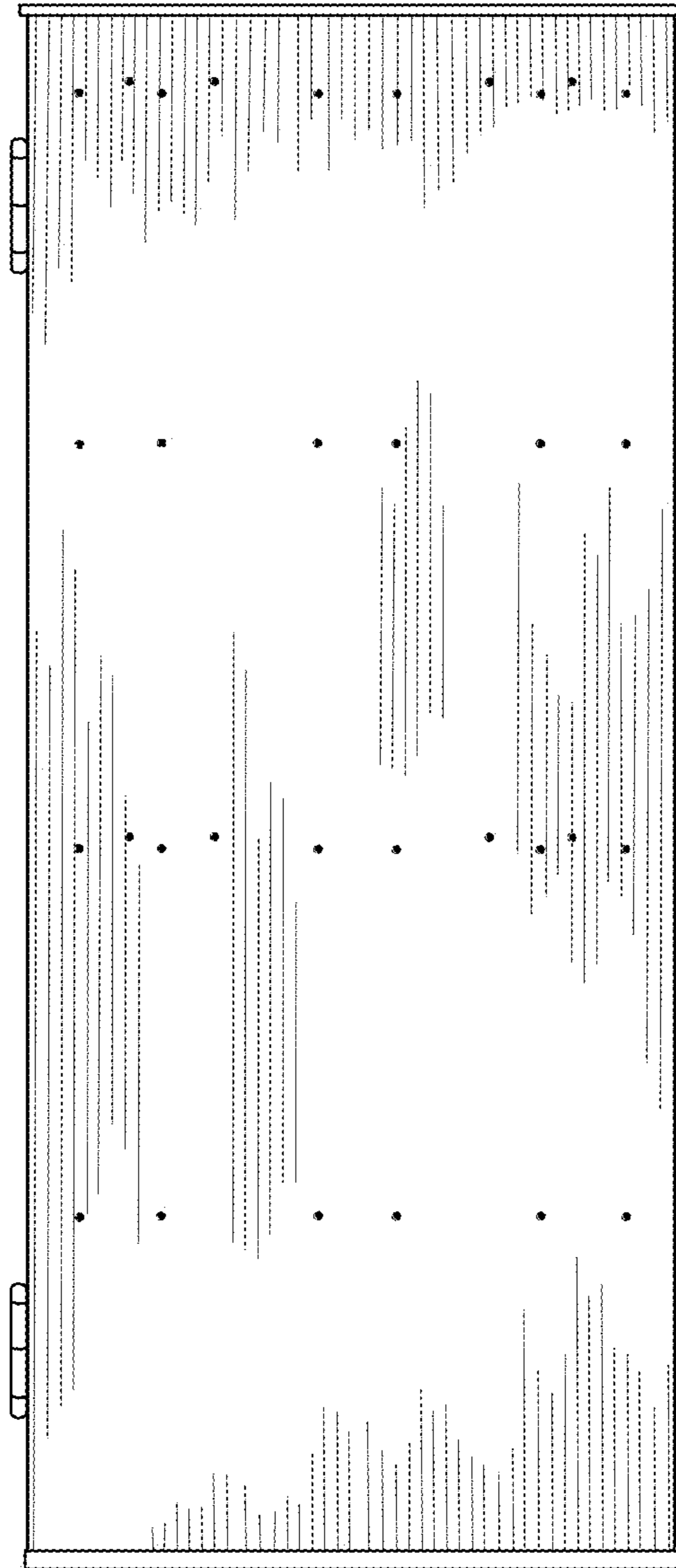

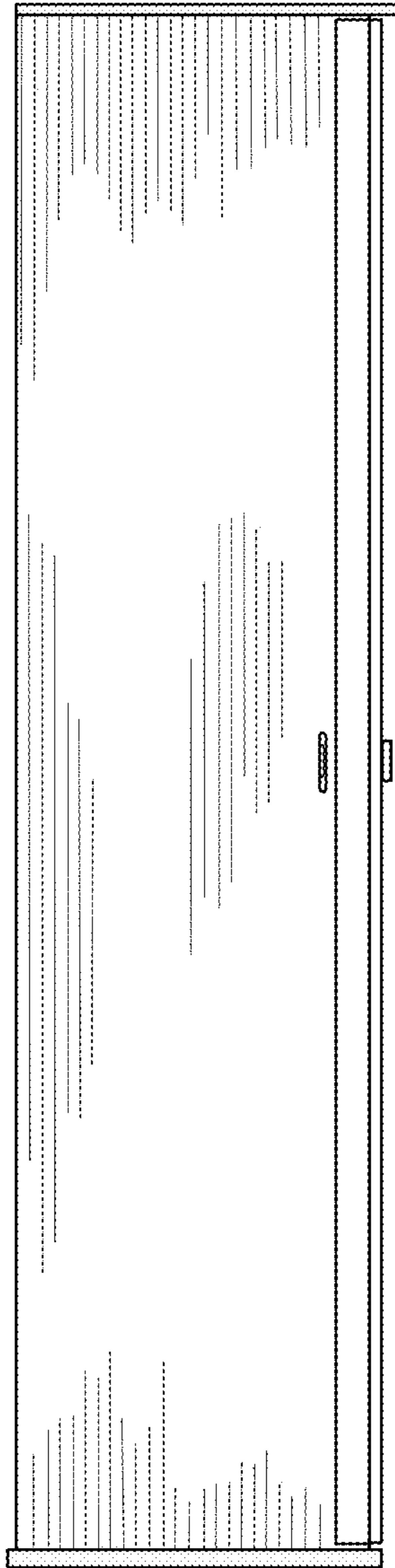

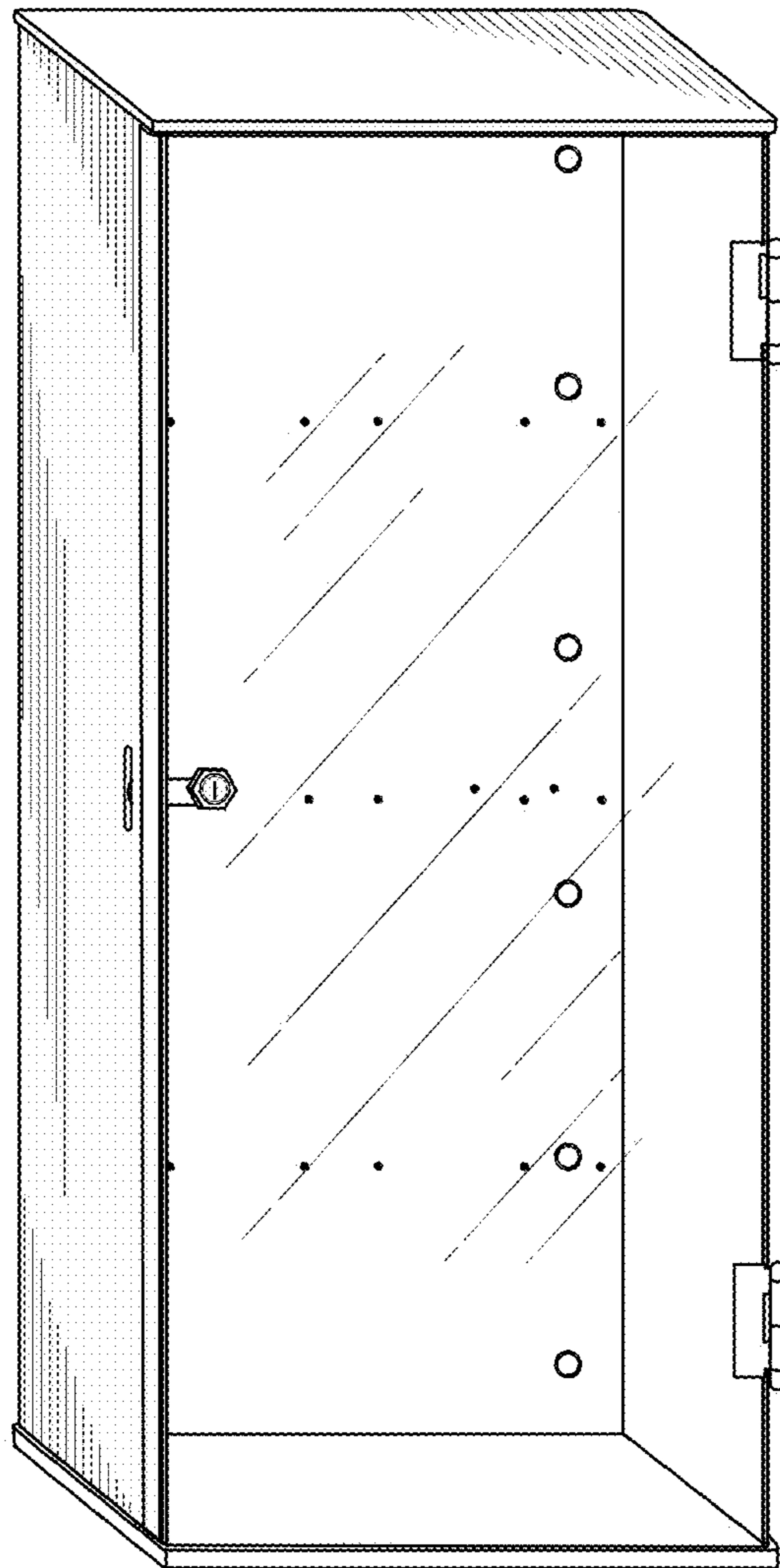

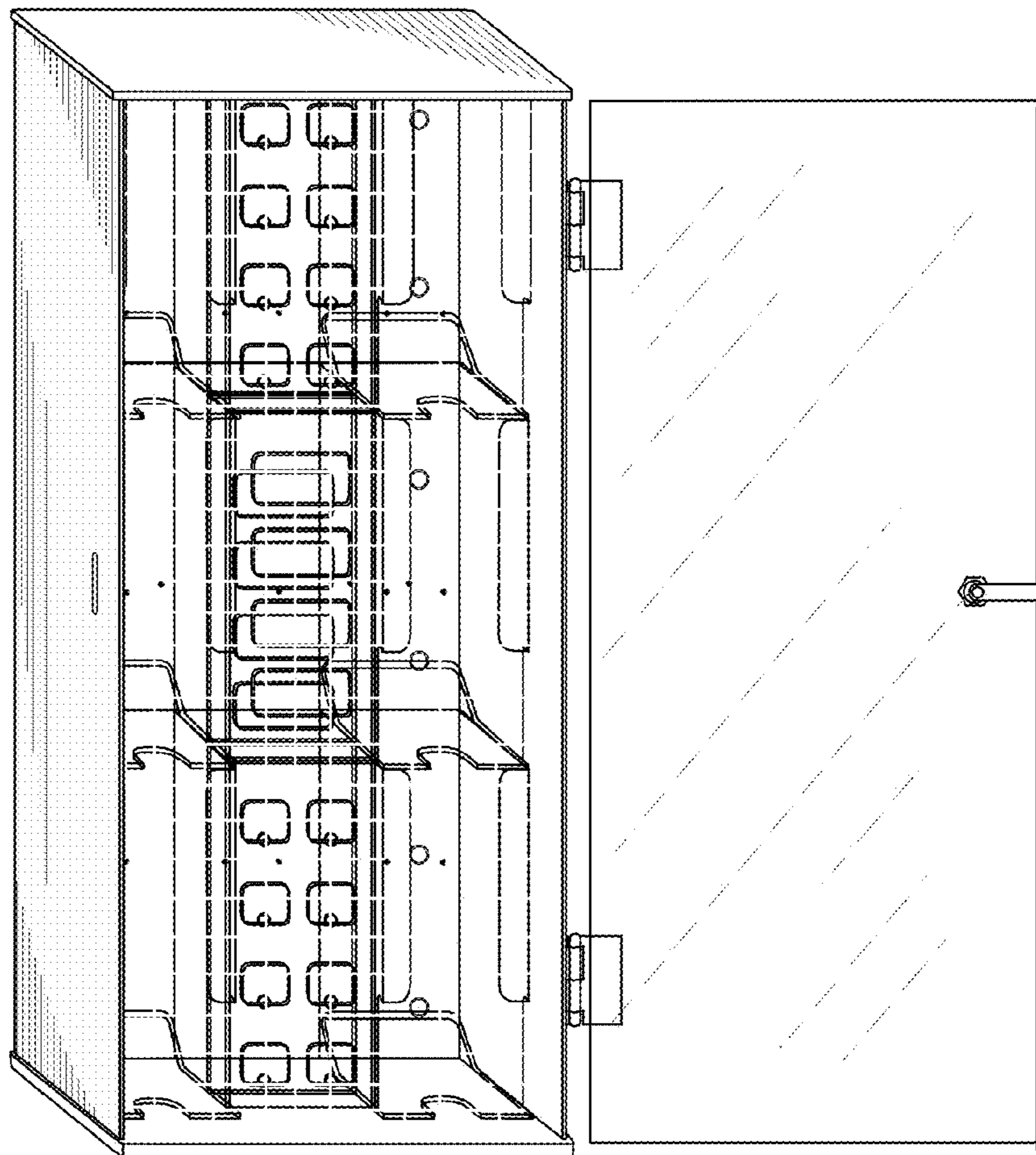

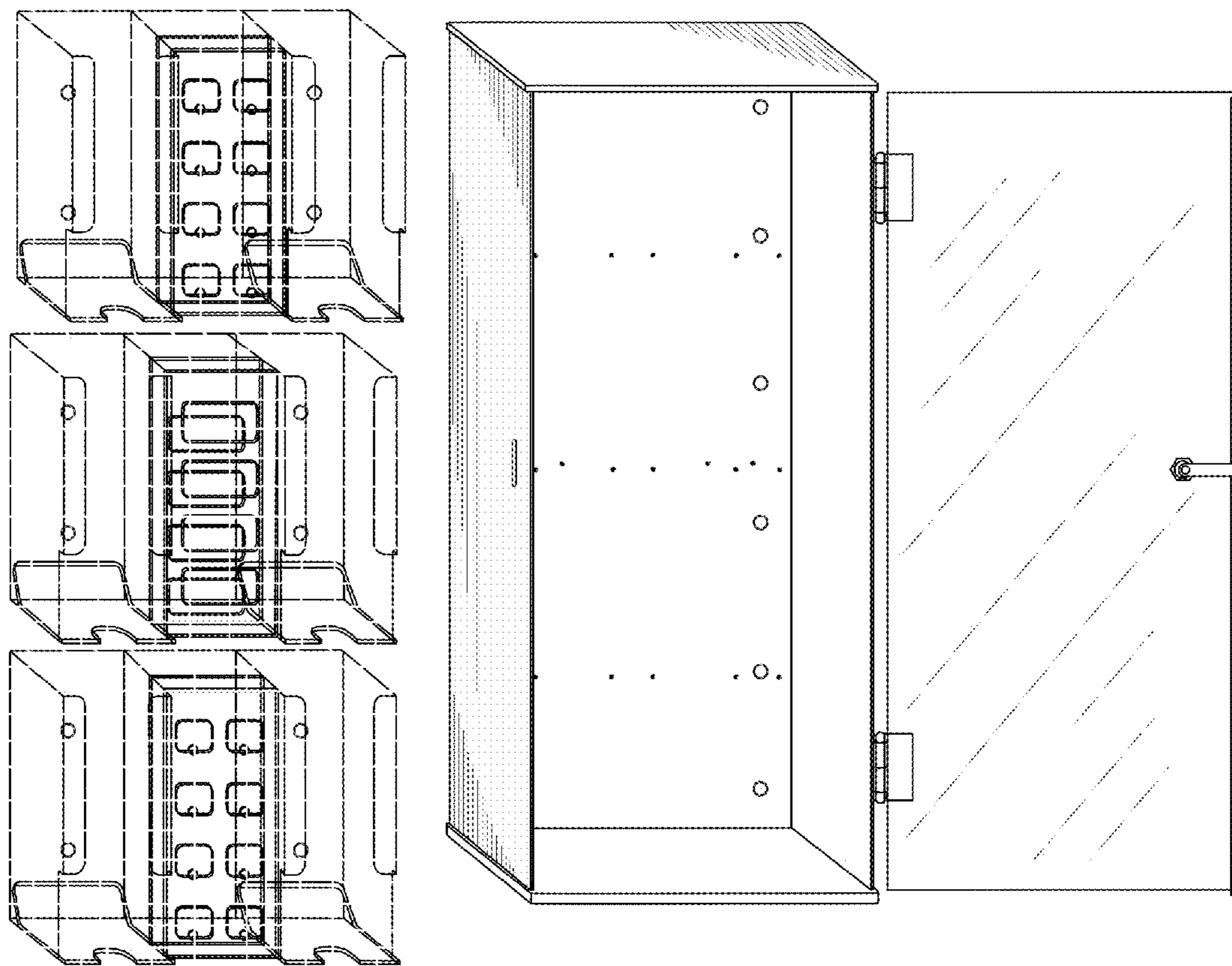
