(57) **CLAIM**

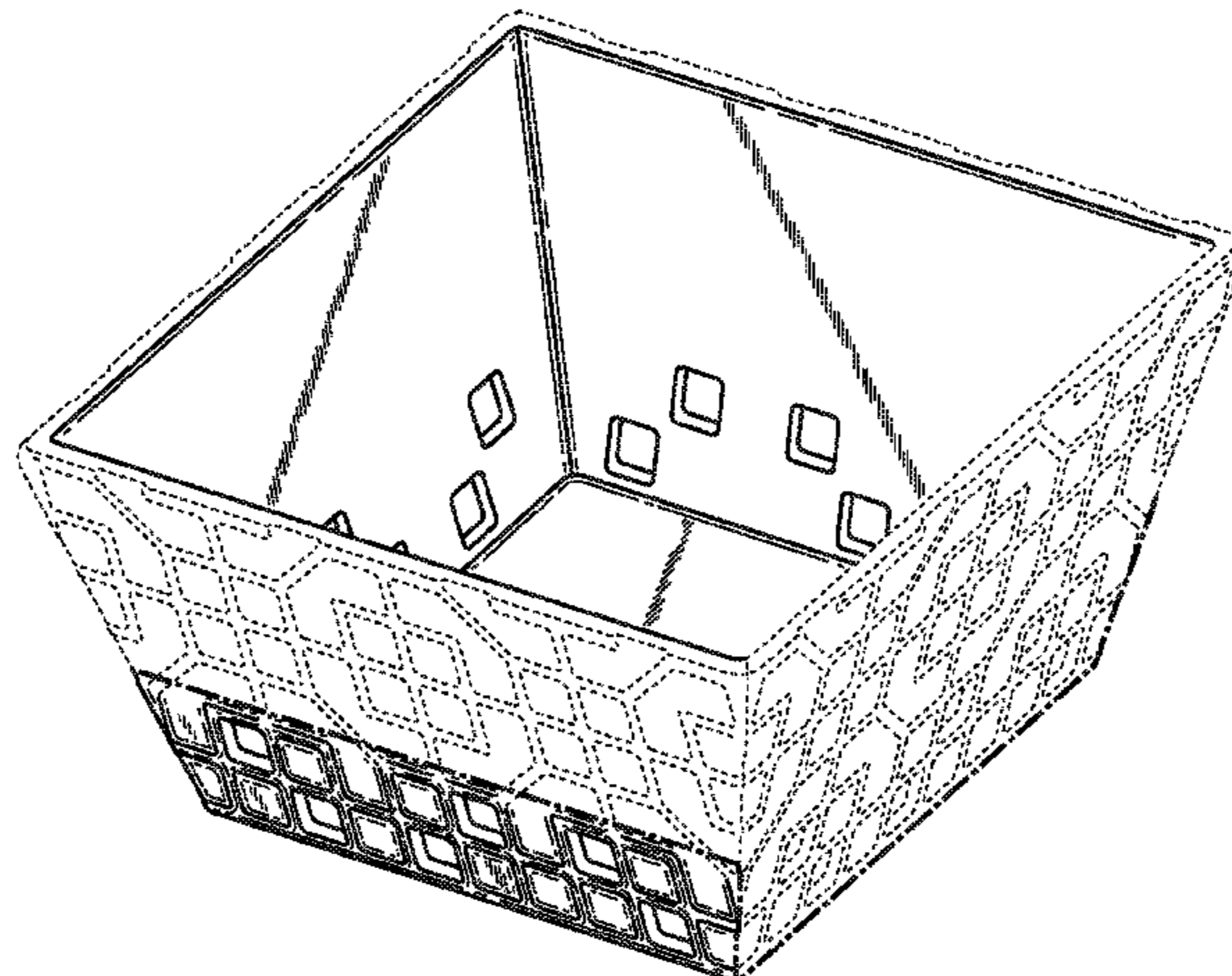
The ornamental design for a container, as shown and
described.

DESCRIPTION

FIG. 1 is a top, front, perspective view of a container showing
our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view.

The features shown in broken lines are portions of the con-
tainer, such as raised surface ornamentation on the front,
back, and left sides of the container or the right side wall of the
container, forming no part of the claimed design. Shaded
surfaces of the container shown, for example, in the perspec-
tive, front, back, left side, and bottom views are part of the
claimed design. The long dash-short dash bolded broken lines
indicate the bounds of the claimed design and otherwise form
no part of the claimed design.

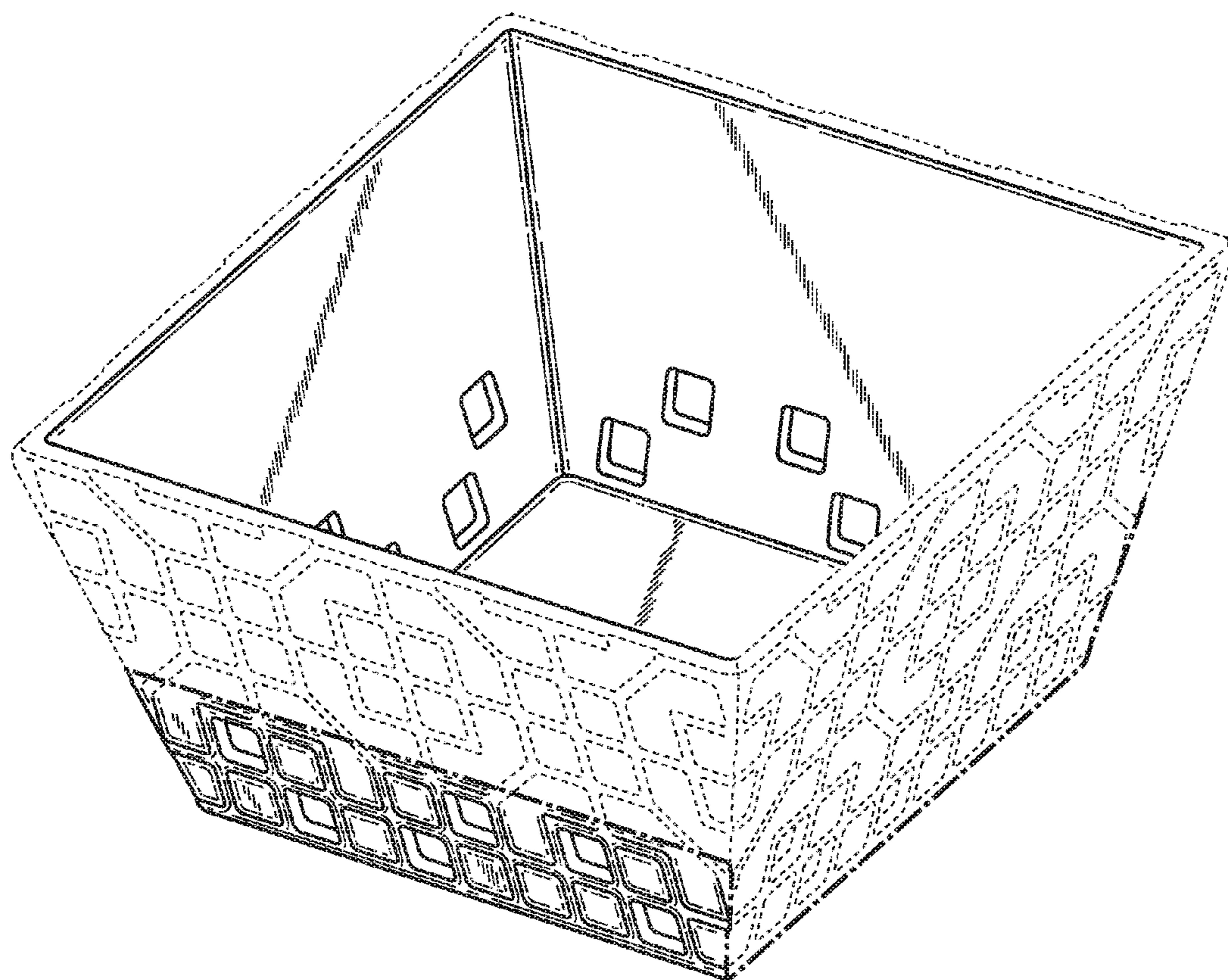

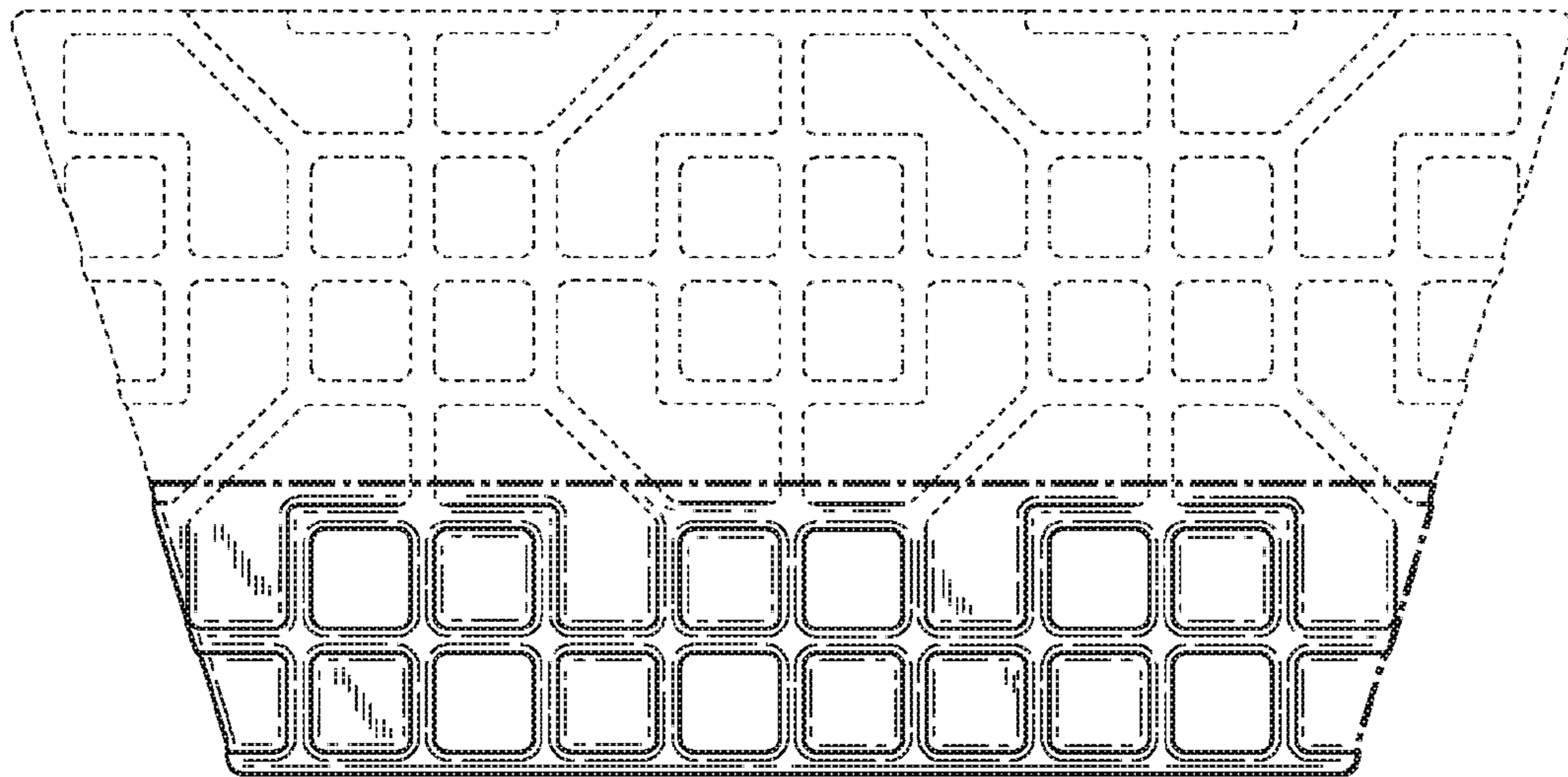

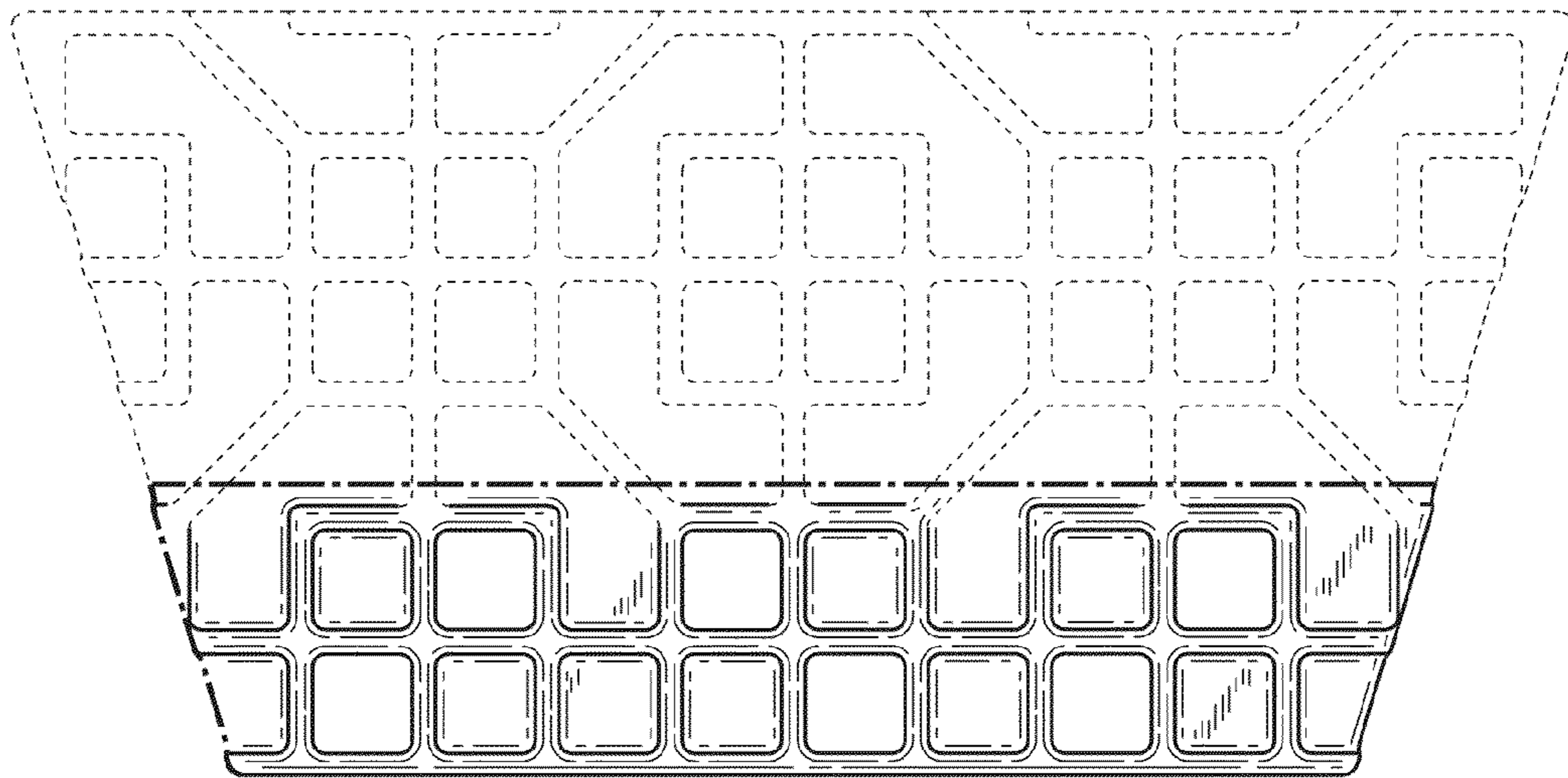

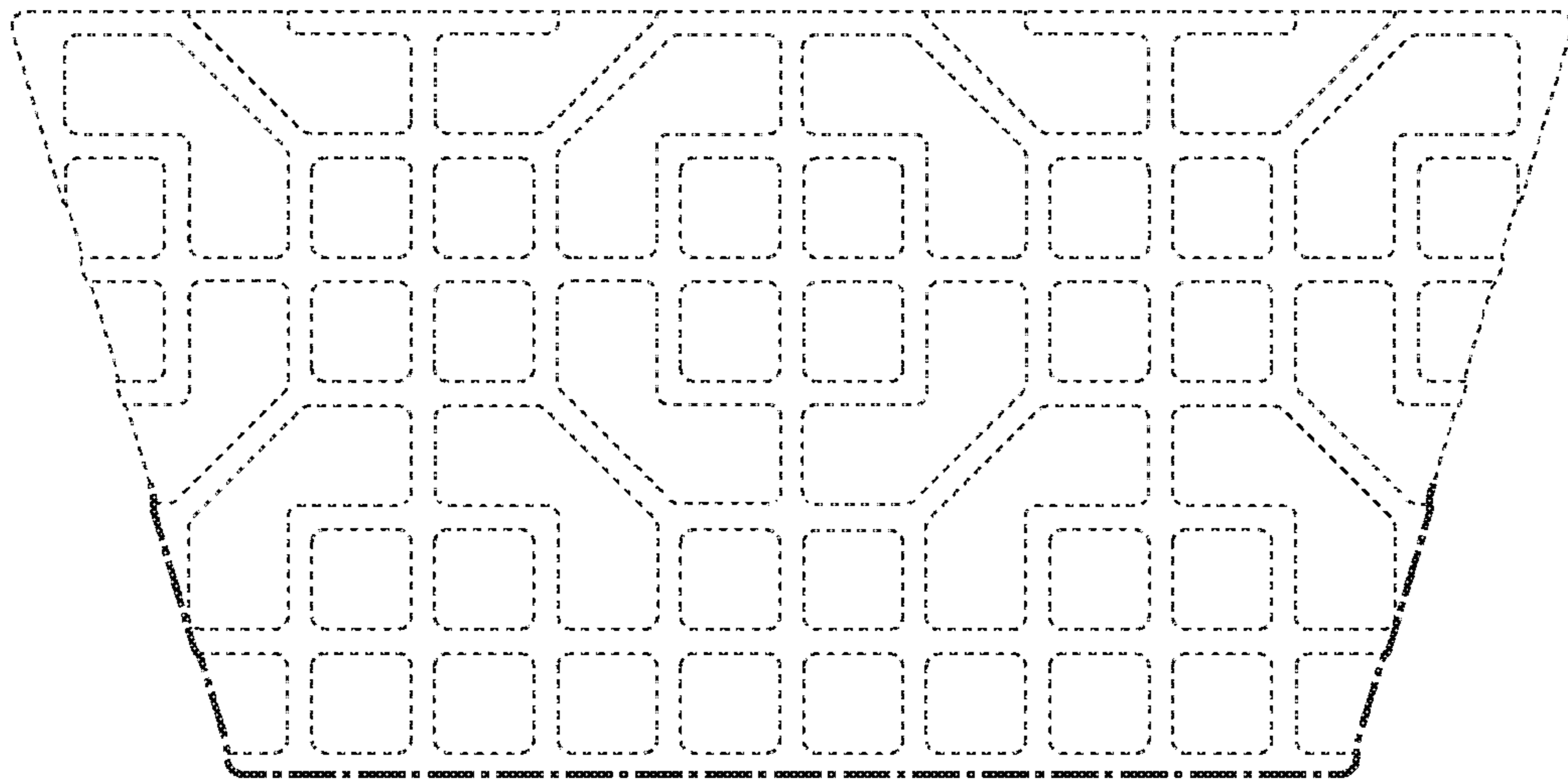

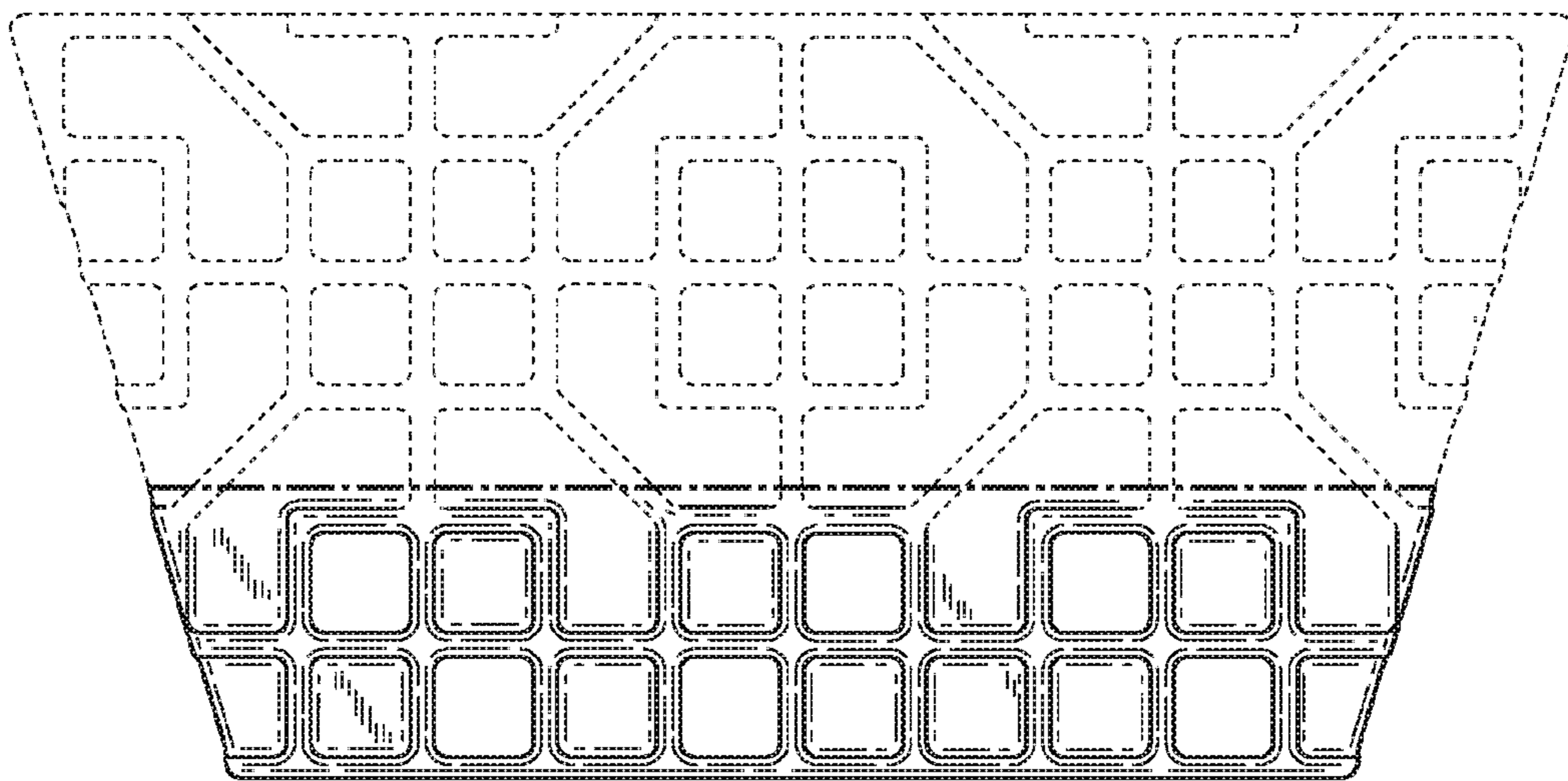

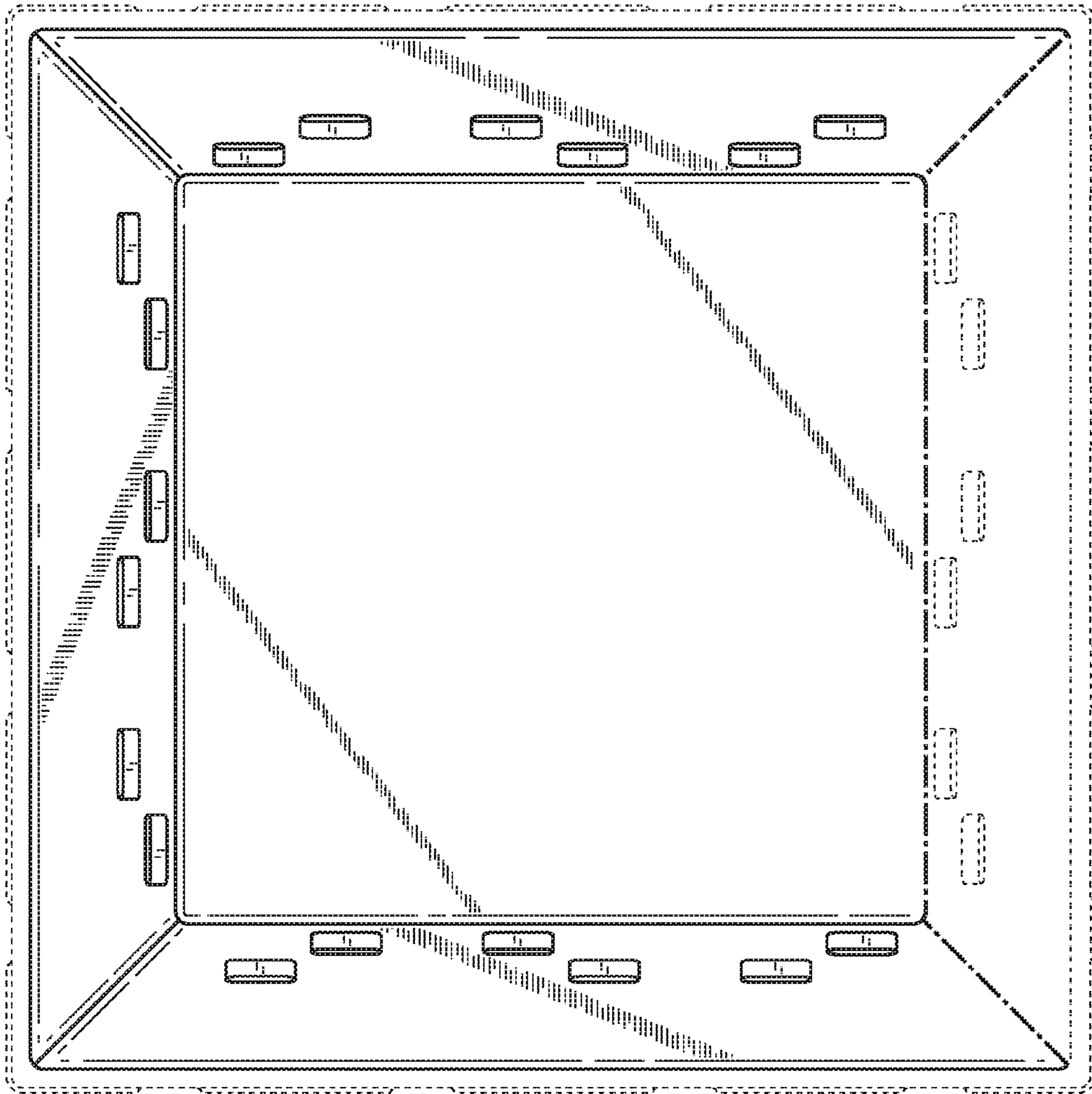

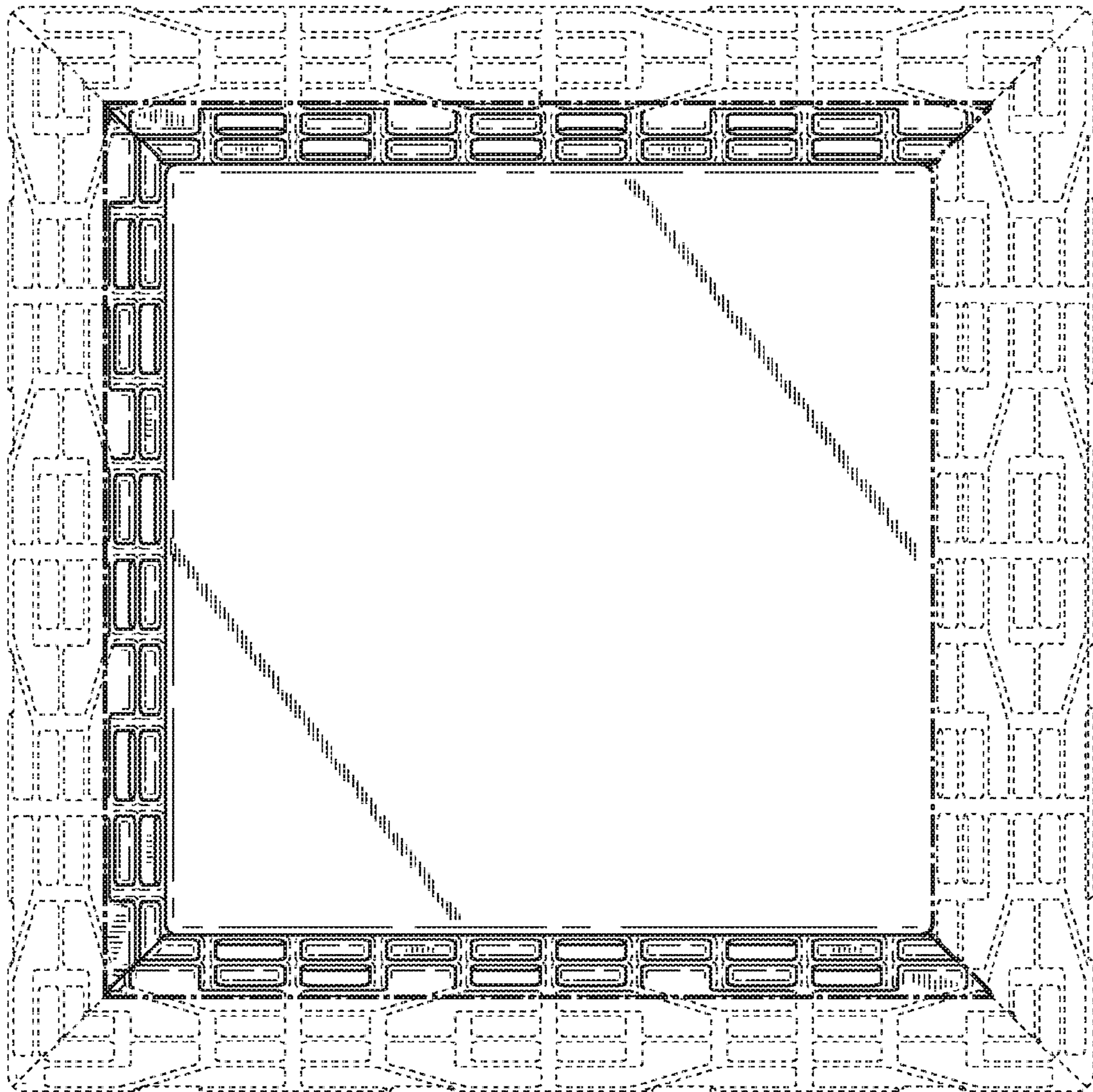
