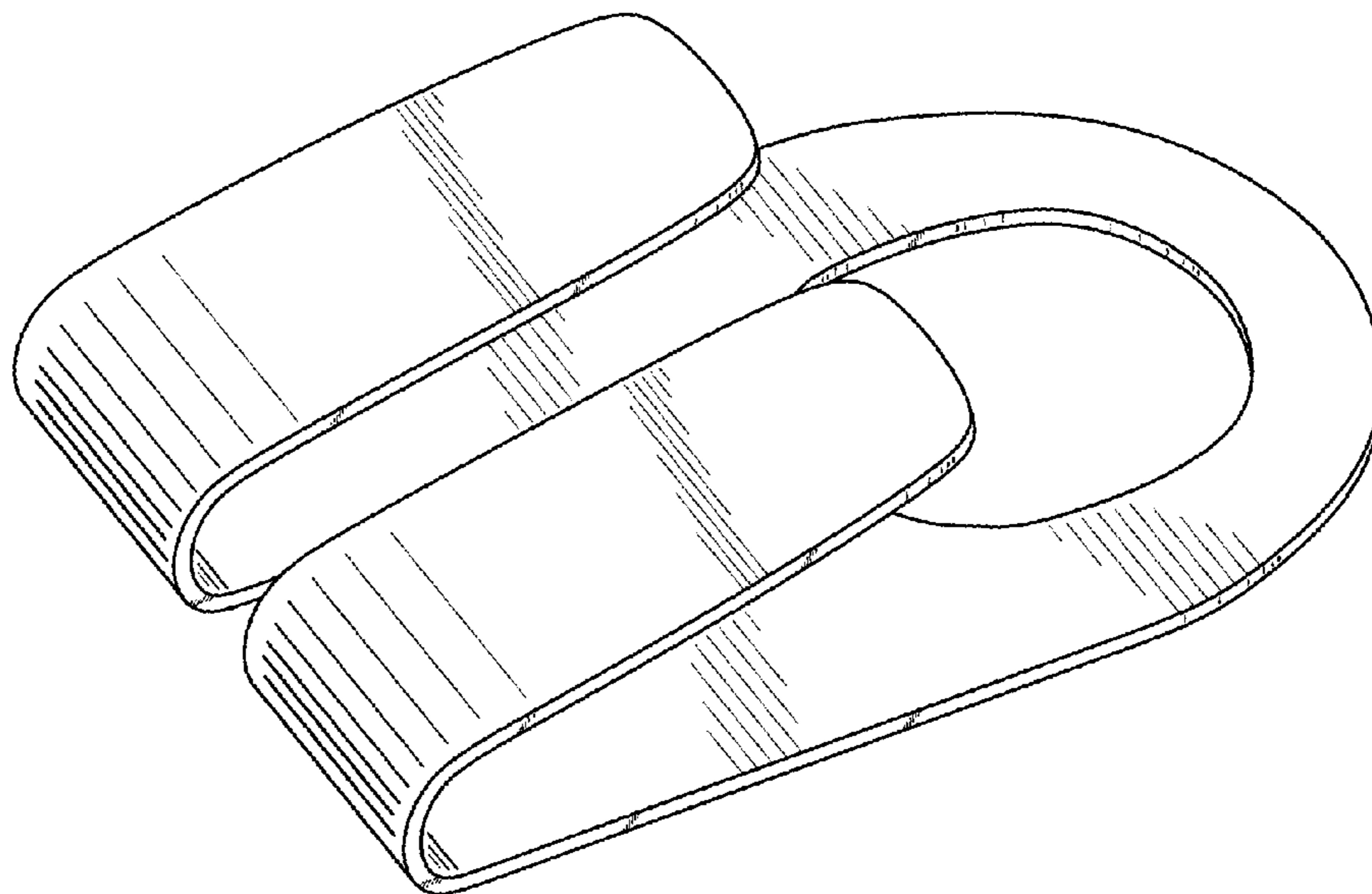
(57) **CLAIM**

The ornamental design for a wire cage tow bar assisting hook, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top front view of the wire cage tow bar assisting hook, showing our new design;
 FIG. 2 is a front side view thereof;

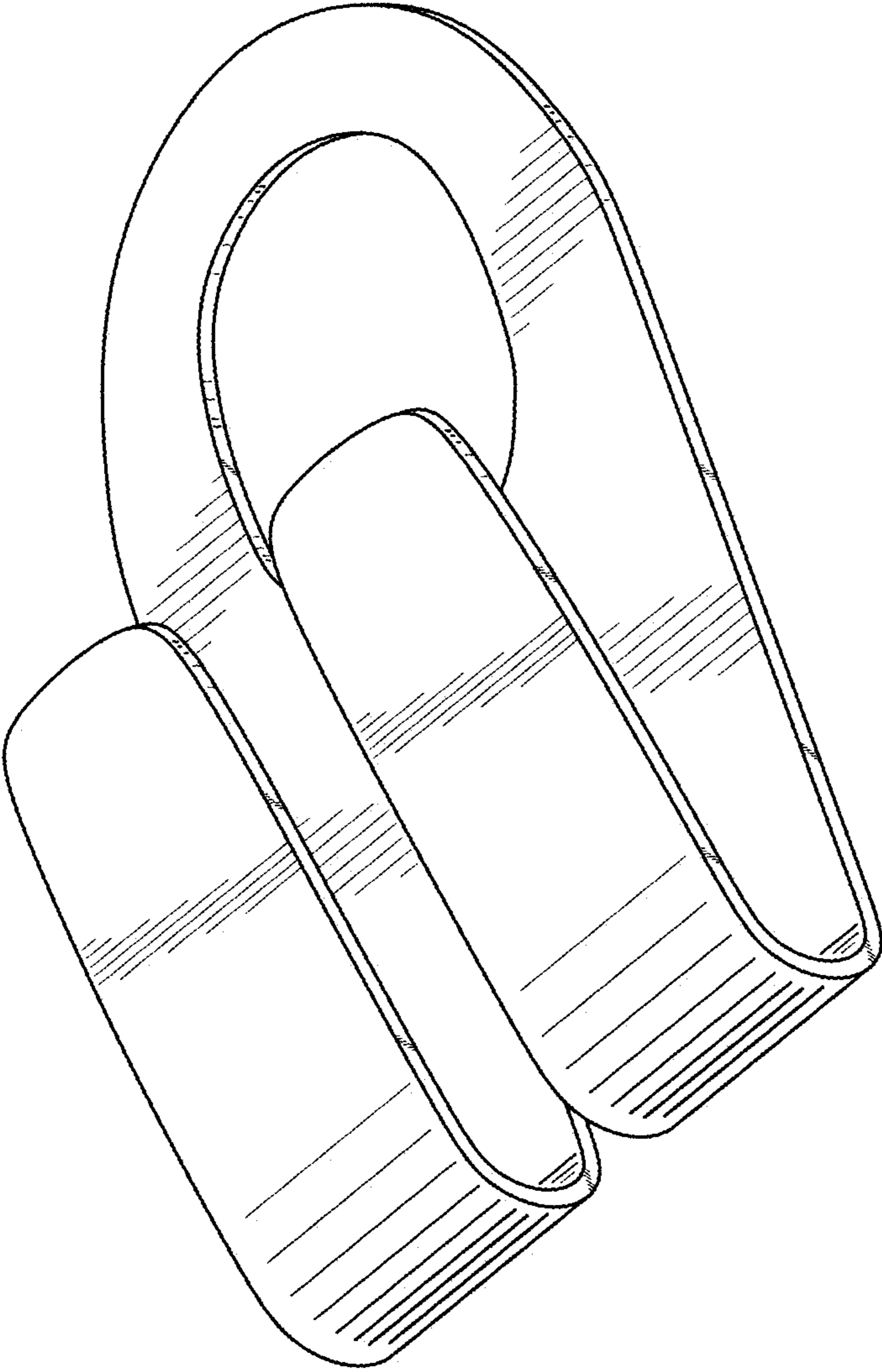

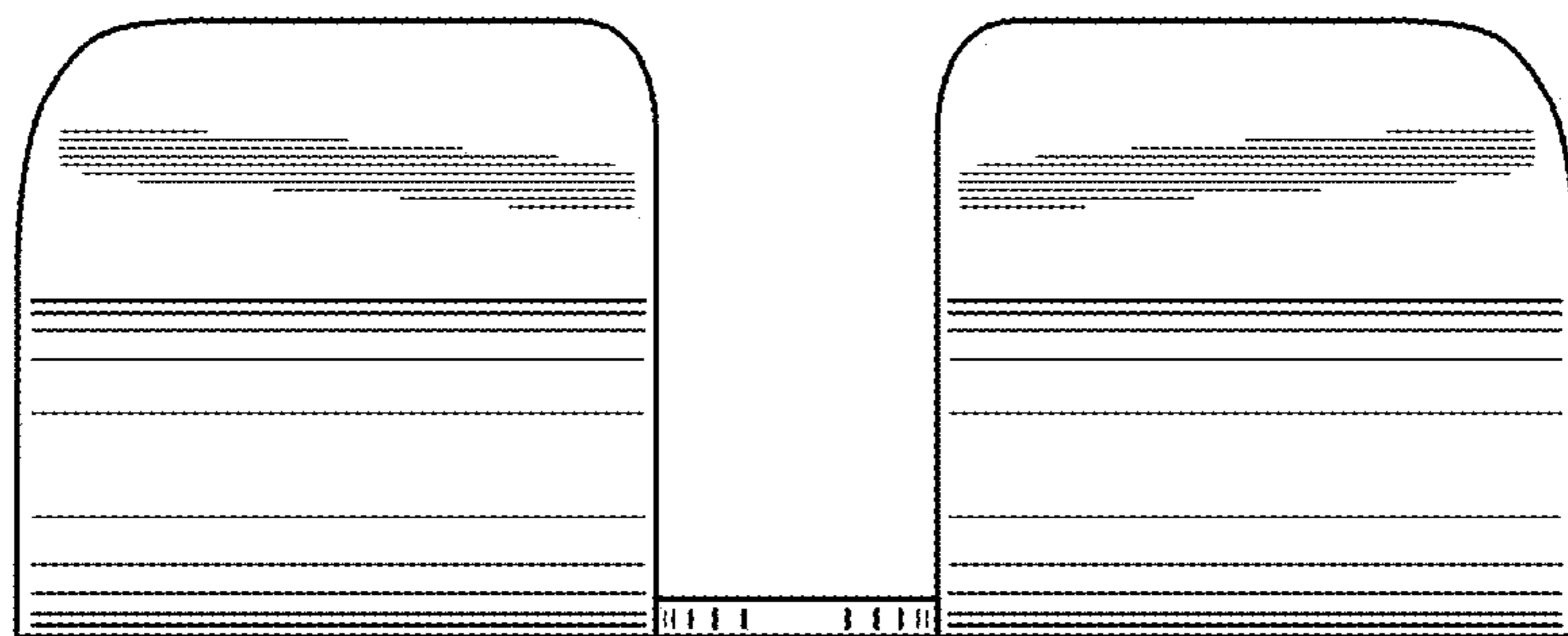

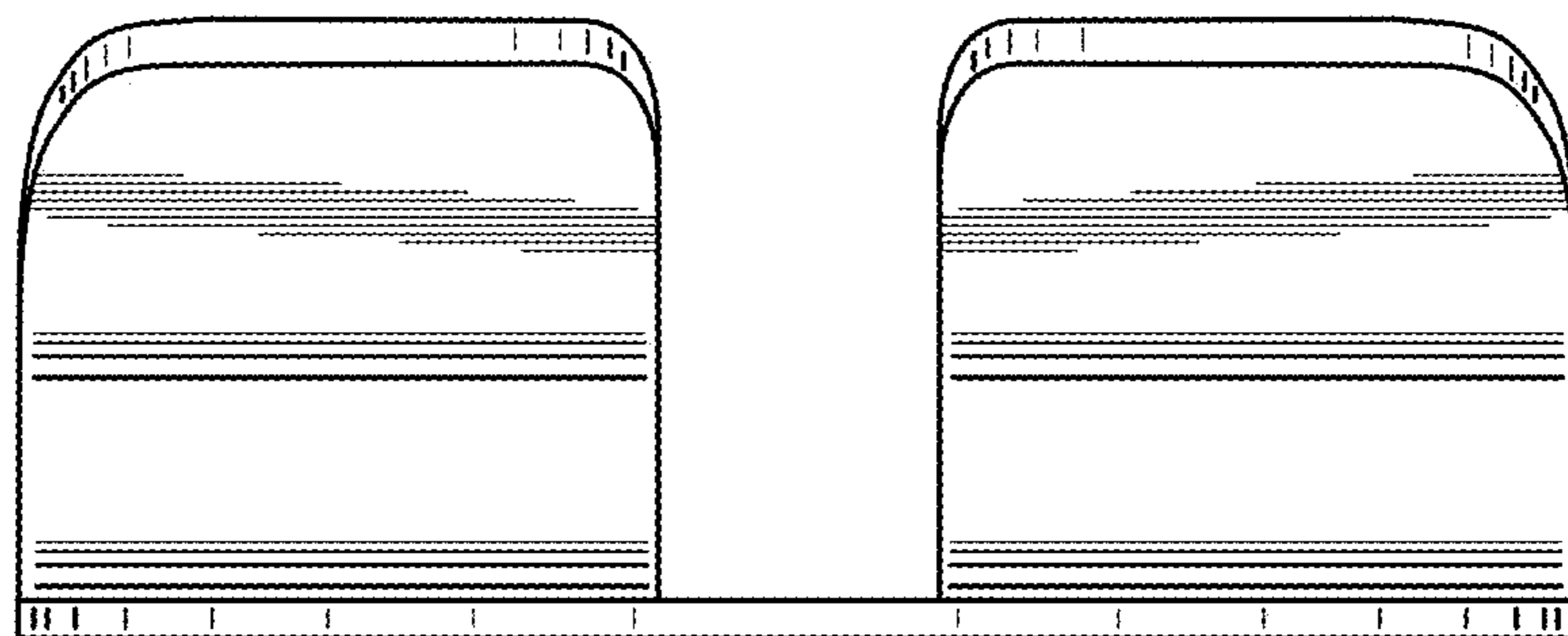

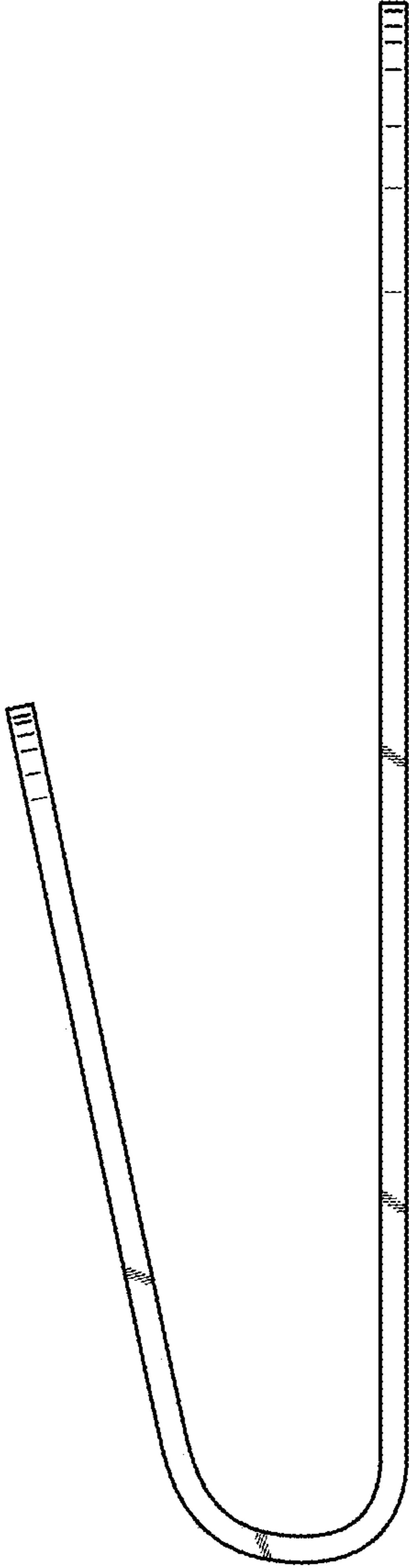

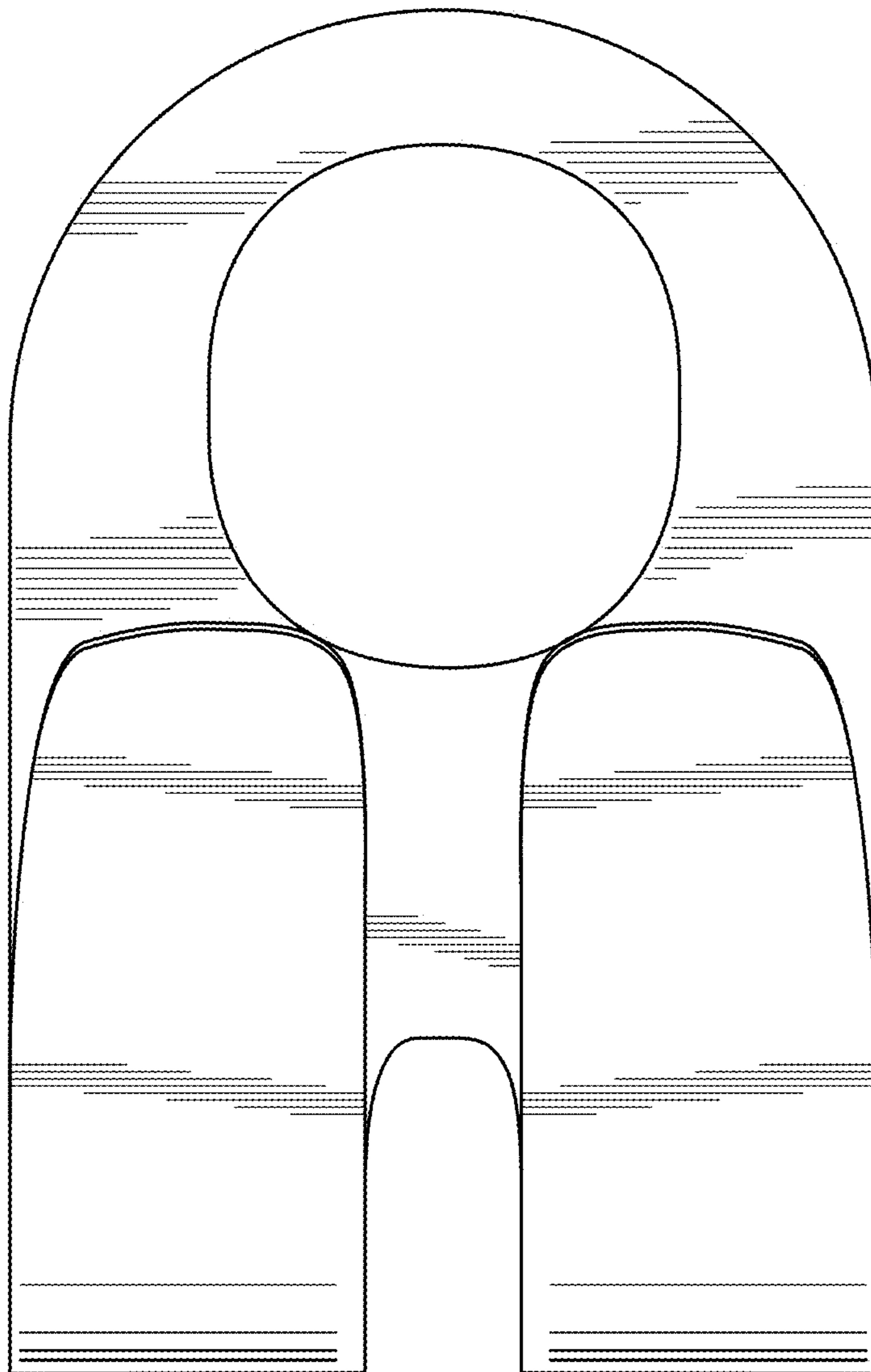

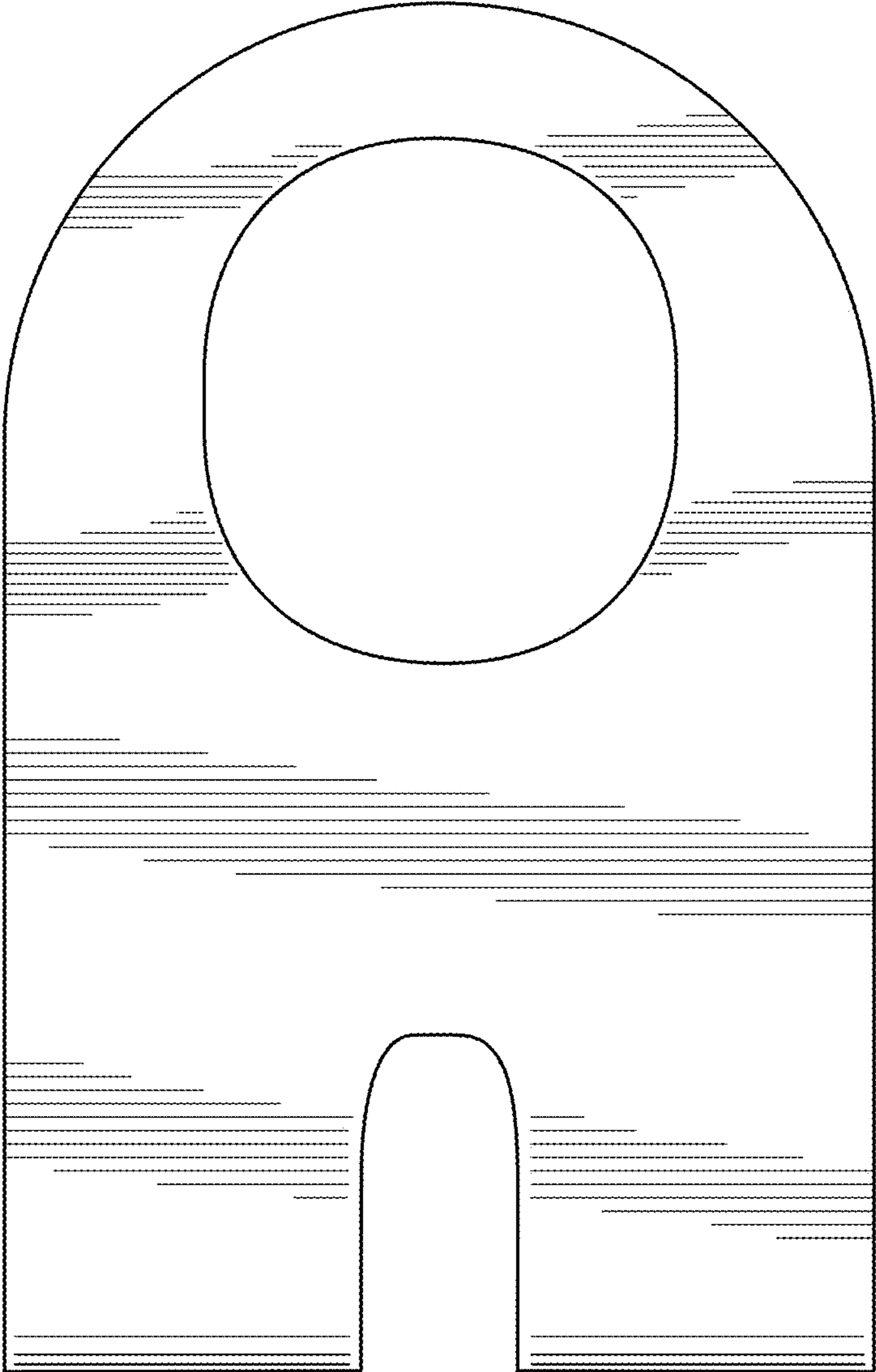
