(57) **CLAIM**

The ornamental design for a gift box, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective of a gift box according to the present invention, wherein the broken lines do not form a claimed feature of the present invention;

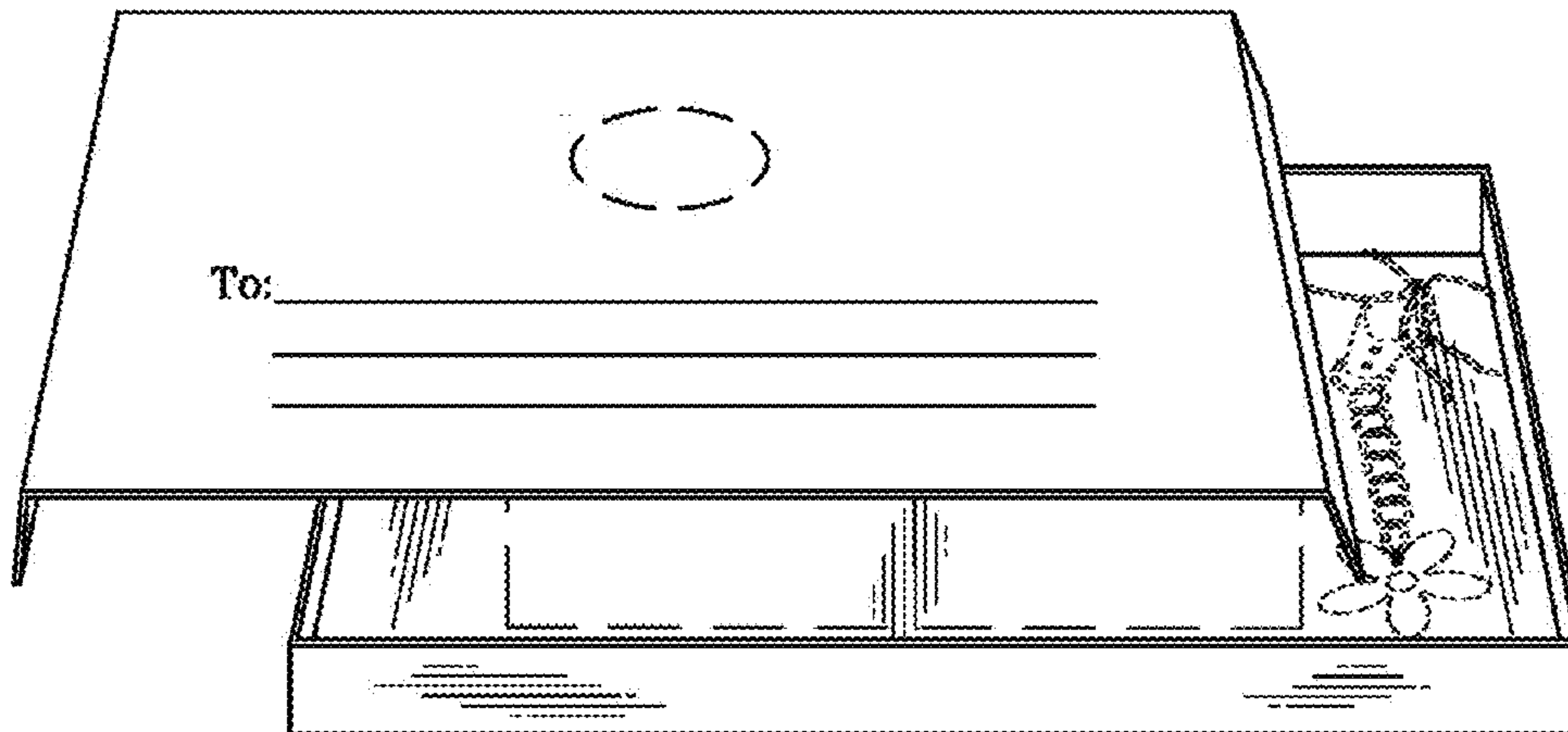
FIG. 2 is a top plan view thereof;

FIG. 3 is a front perspective view of the gift box in an opened position, wherein the broken lines do not form a claimed feature of the present invention;

FIG. 4 is an exploded elevation view of the gift box, showing the inside of the top portion in a flat and unfolded position and a bottom plan view thereof, wherein the broken lines do not form a claimed feature of the present invention; and,

FIG. 5 is a top perspective view of the gift box in an opened position, wherein the broken lines do not form a claimed feature of the present invention.

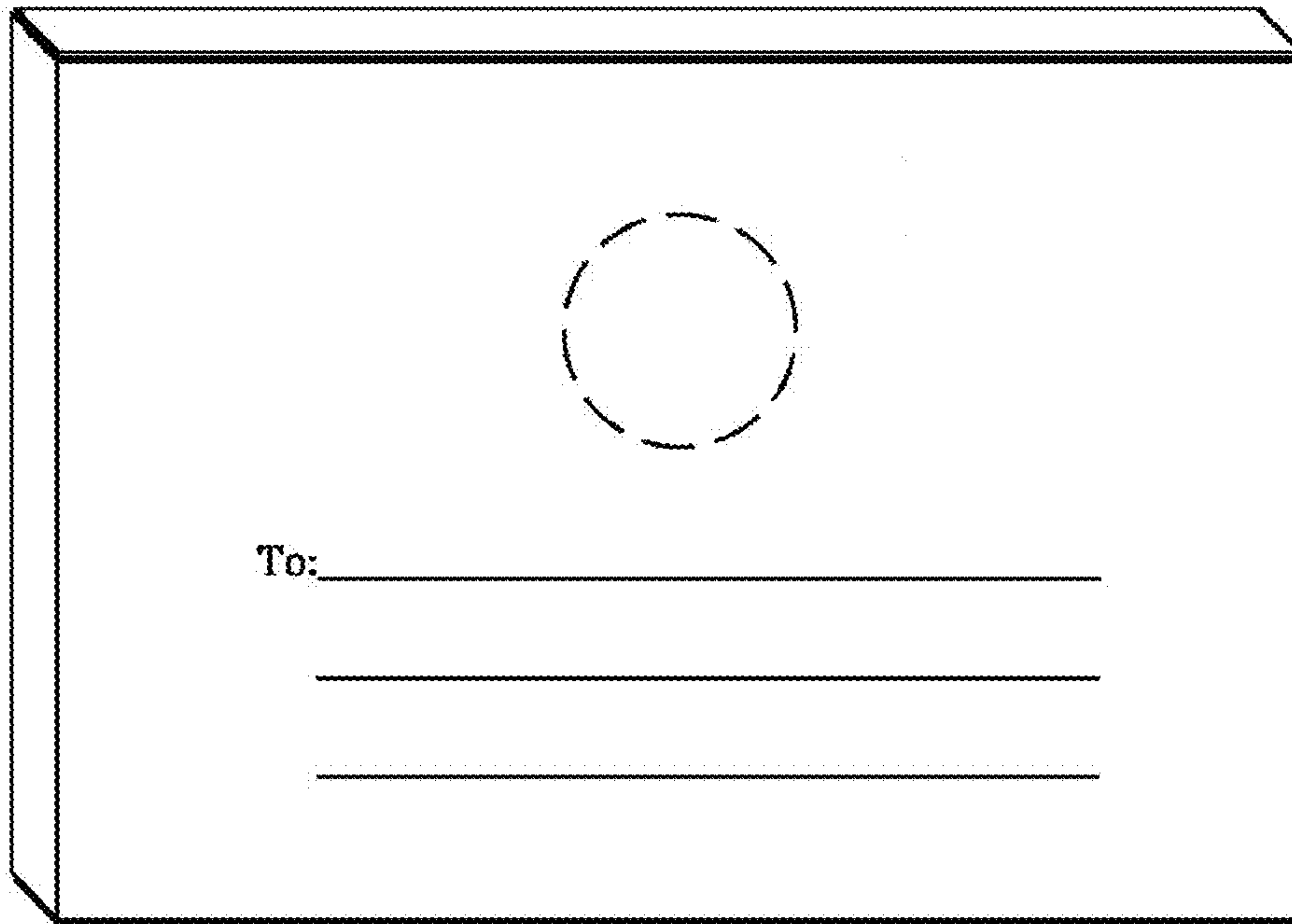

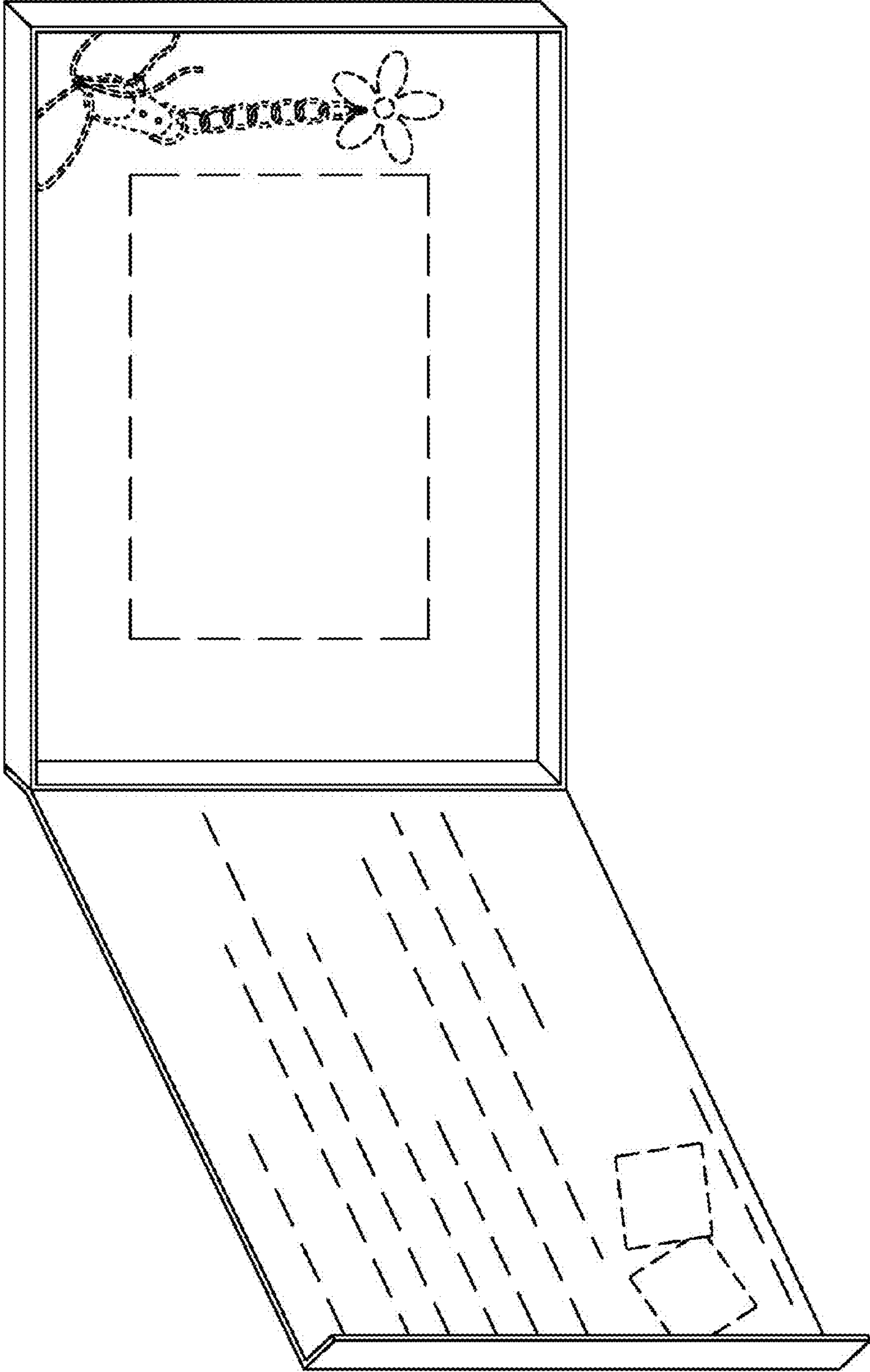

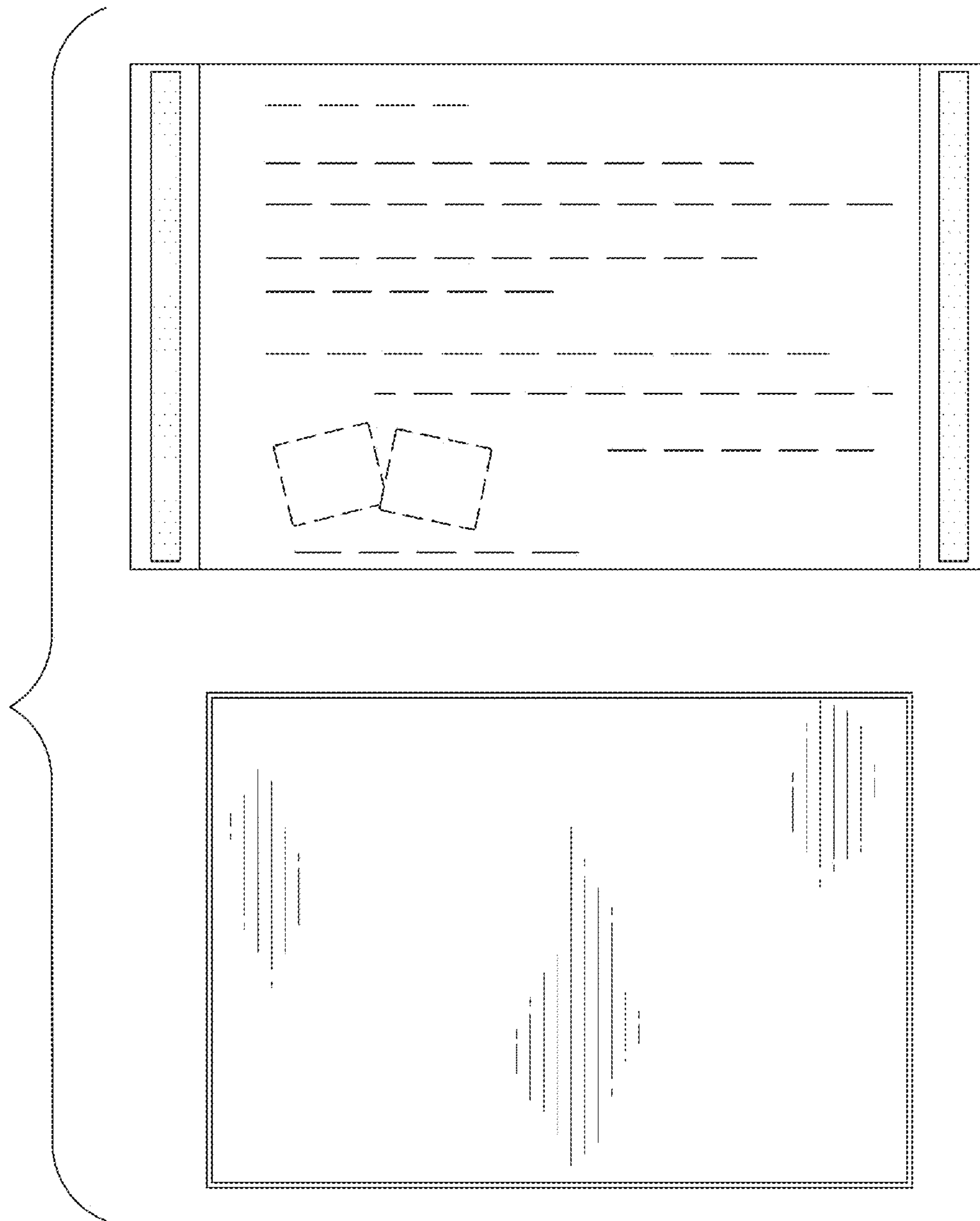

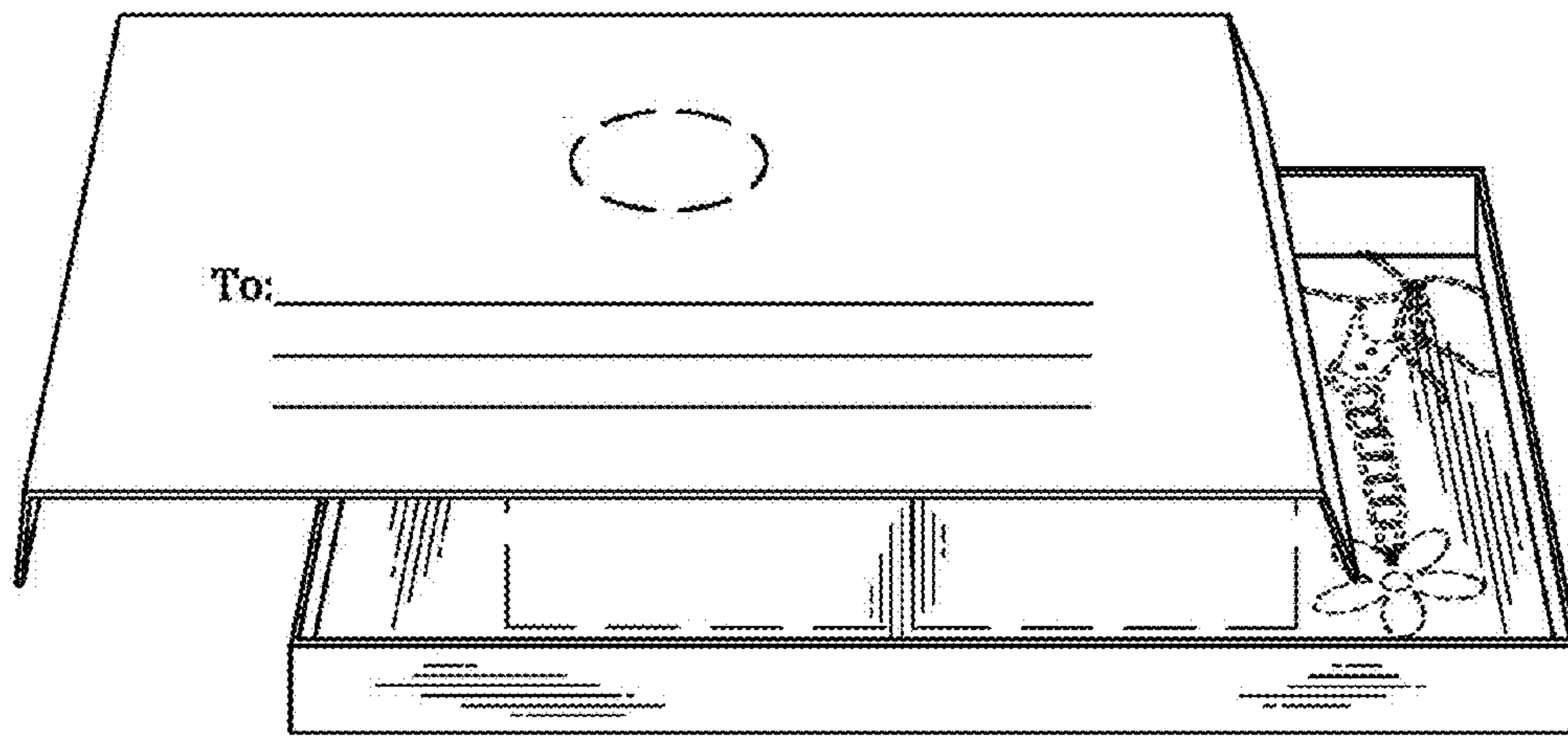
