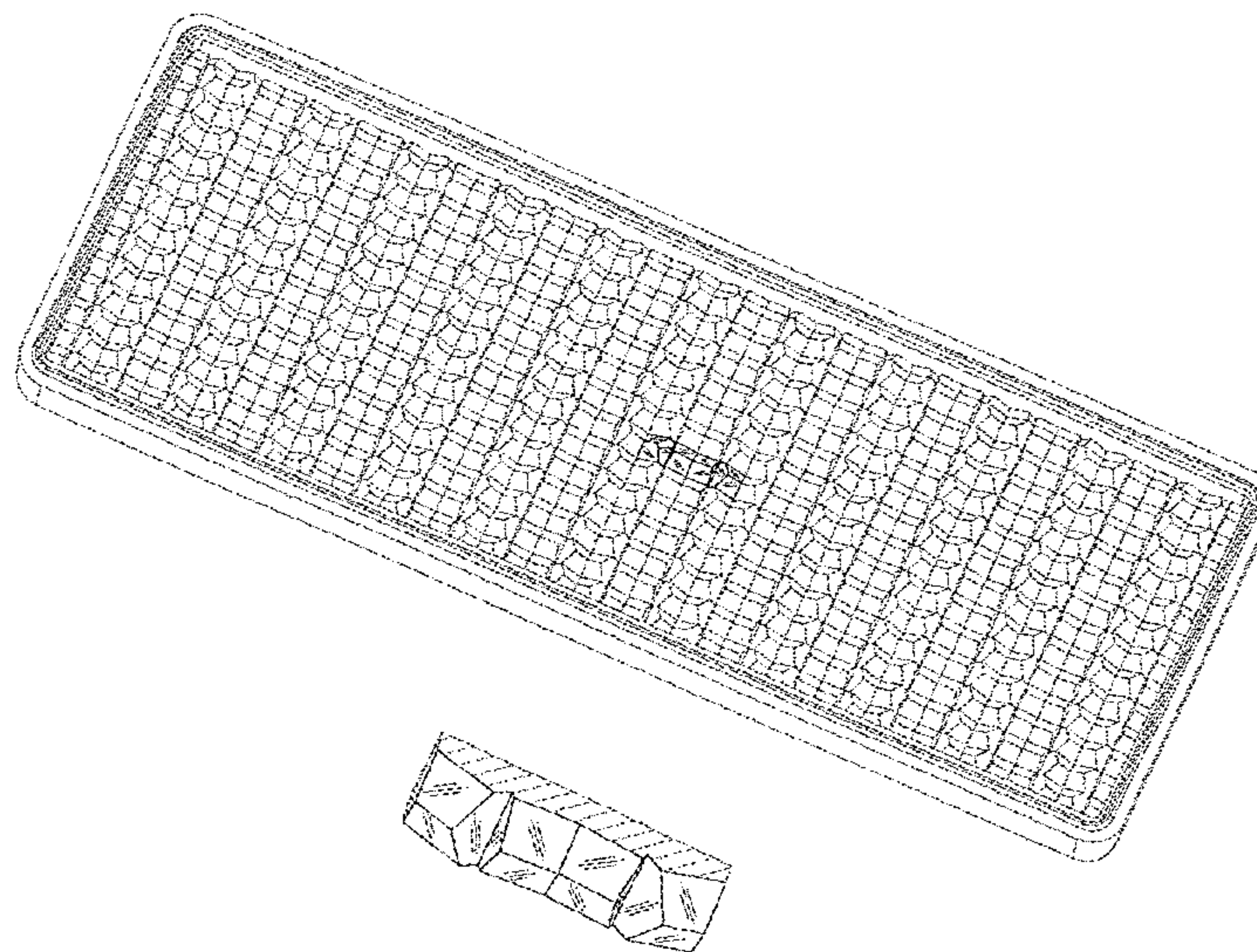
(57) **CLAIM**

The ornamental design for a wide angle retroreflective plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom and rear perspective view of a wide angle retroreflective plate in accordance with the present design; FIG. 2 is a front elevation view of the wide angle retroreflective plate shown in FIG. 1; FIG. 3 is a rear elevation view of the wide angle retroreflective plate shown in FIG. 1; FIG. 4 is a left side elevation view of the wide angle retroreflective plate shown in FIG. 1; FIG. 5 is a right side elevation view of the wide angle retroreflective plate shown in FIG. 1; FIG. 6 is a top plan view of the wide angle retroreflective plate shown in FIG. 1; FIG. 7 is a bottom plan view of the wide angle retroreflective plate shown in FIG. 1; FIG. 8 is a cross-sectional view of the wide angle retroreflective plate taken along line 8-8 in FIG. 3; FIG. 9 is an enlarged fragmental sectional view showing from FIG. 8; FIG. 10 is a cross-sectional view of the wide angle retroreflective plate taken along line 10-10 in FIG. 3; FIG. 11 is an enlarged fragmental sectional view showing from FIG. 10; FIG. 12 is a cross-sectional view of the wide angle retroreflective plate taken along line 12-12 in FIG. 3; FIG. 13 is an enlarged fragmental sectional view showing from FIG. 12; FIG. 14 is a cross-sectional view of the wide angle retroreflective plate taken along line 14-14 in FIG. 3; FIG. 15 is an enlarged fragmental sectional view showing from FIG. 14; FIG. 16 is an enlarged fragmental perspective view showing the unit illustrated by solid lines in FIG. 1; and, FIG. 17 is a reference perspective view showing a wide angle retroreflective plate made in accordance with present design. The broken lines showing the whole body of the wide angle retroreflective plate illustrate environmental structure that forms no part of the claimed design.

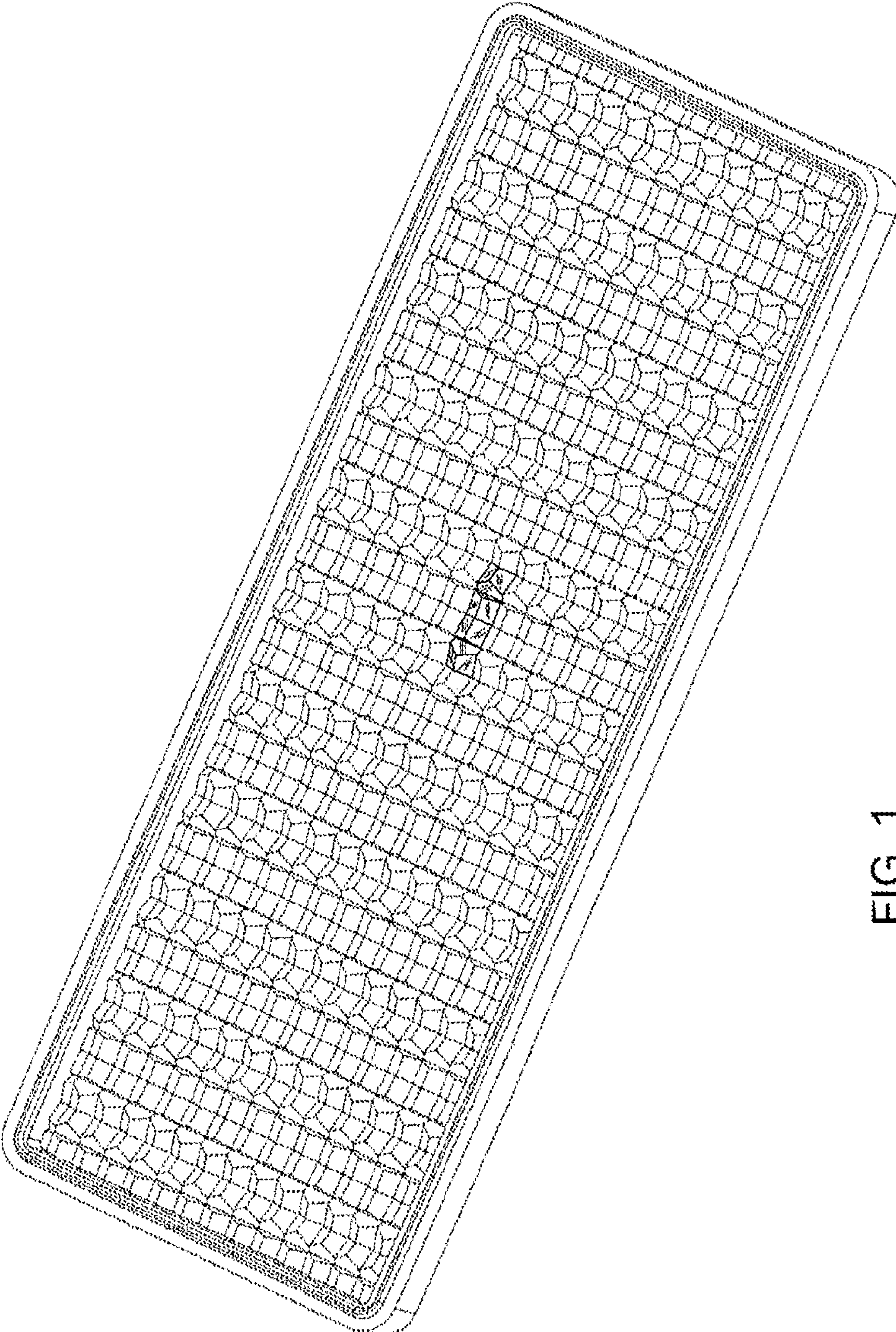

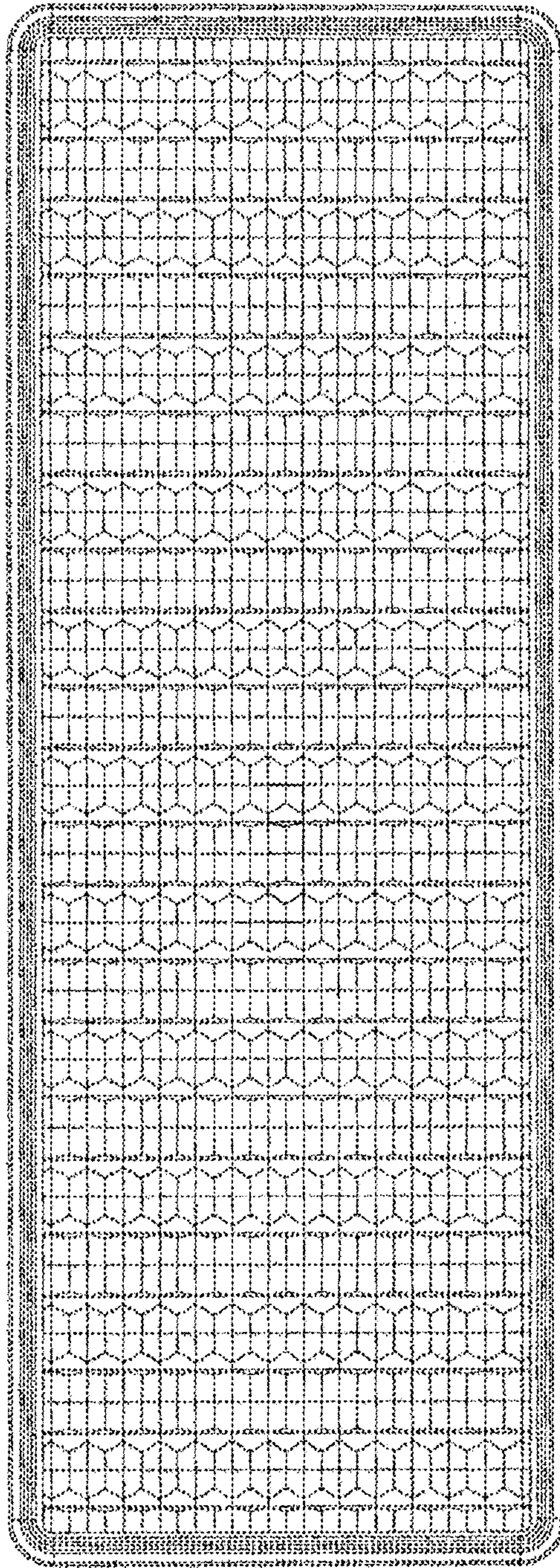

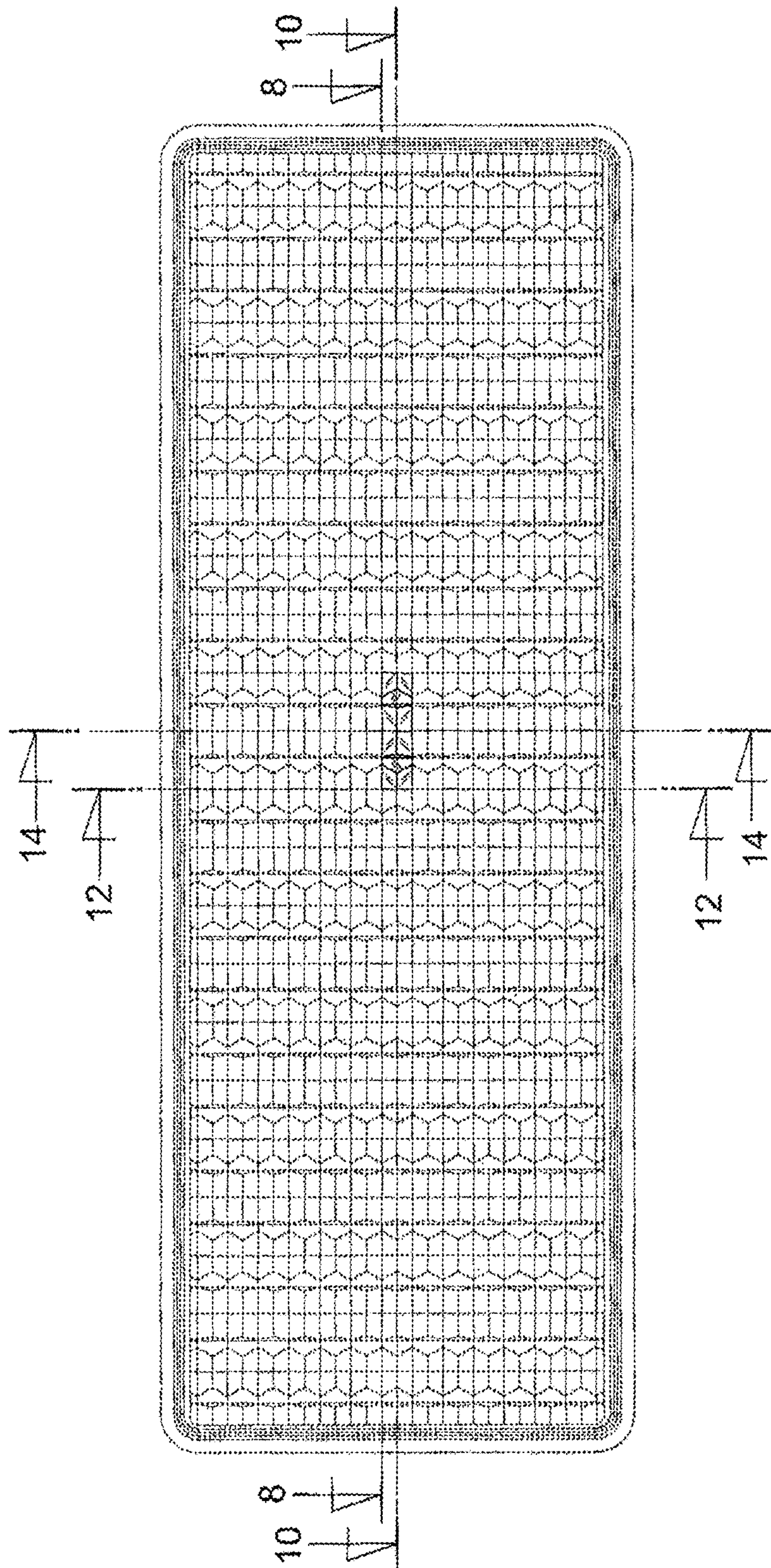

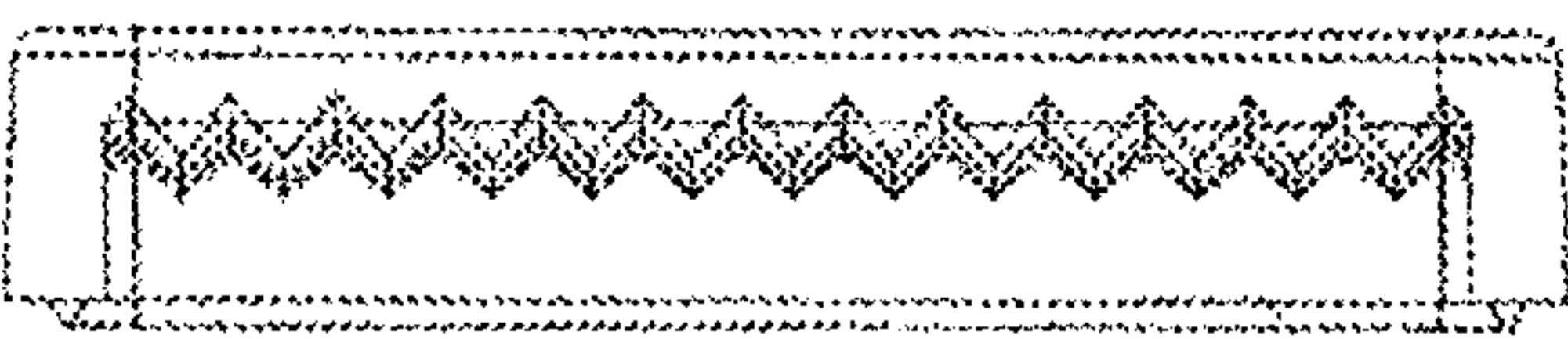

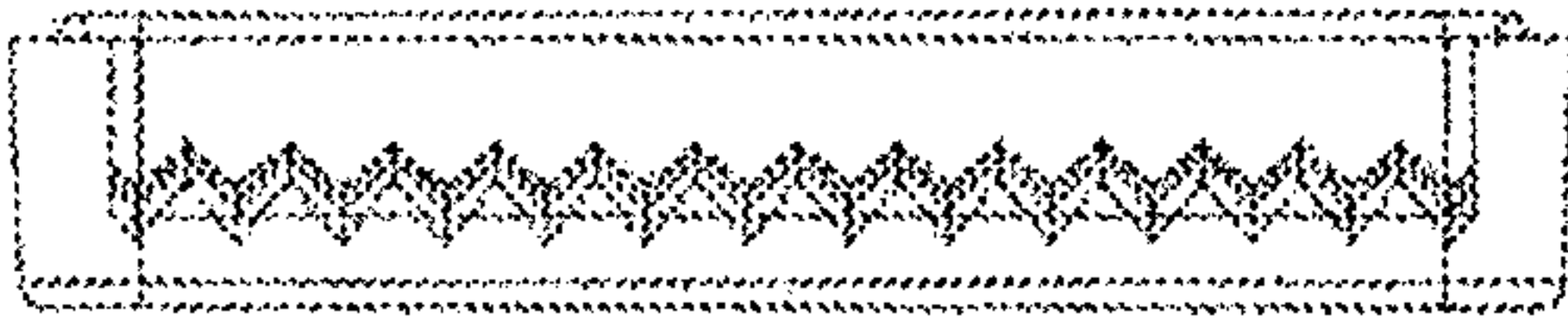

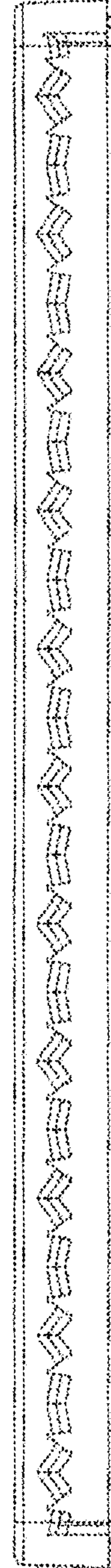

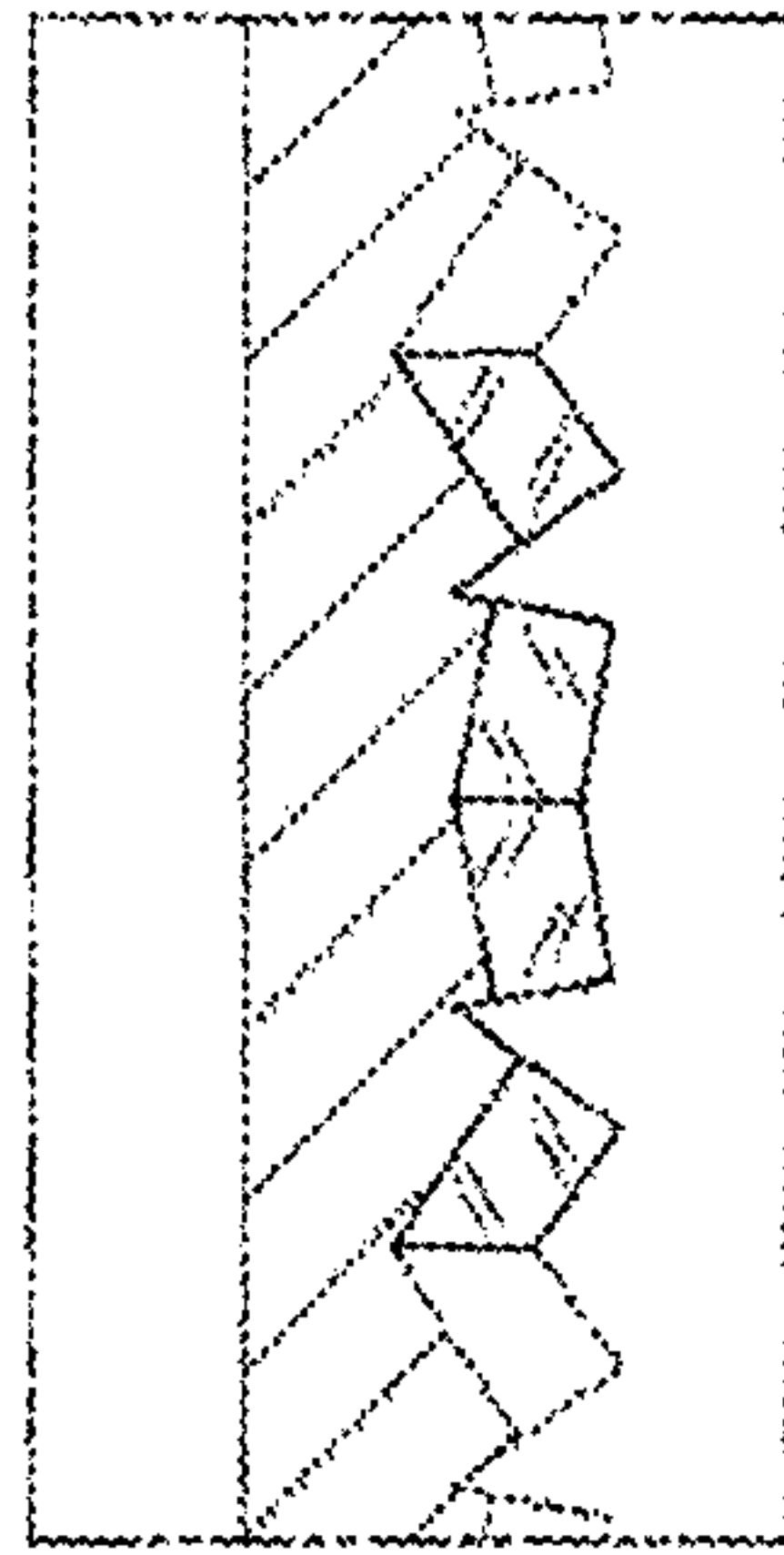

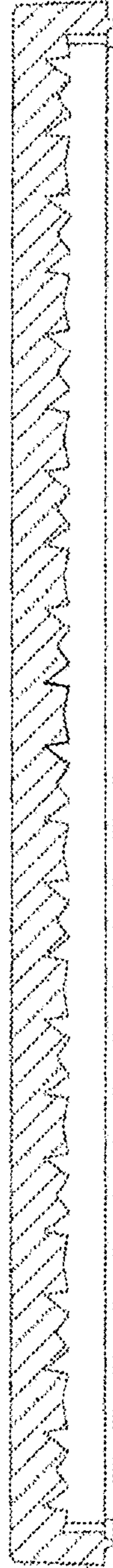

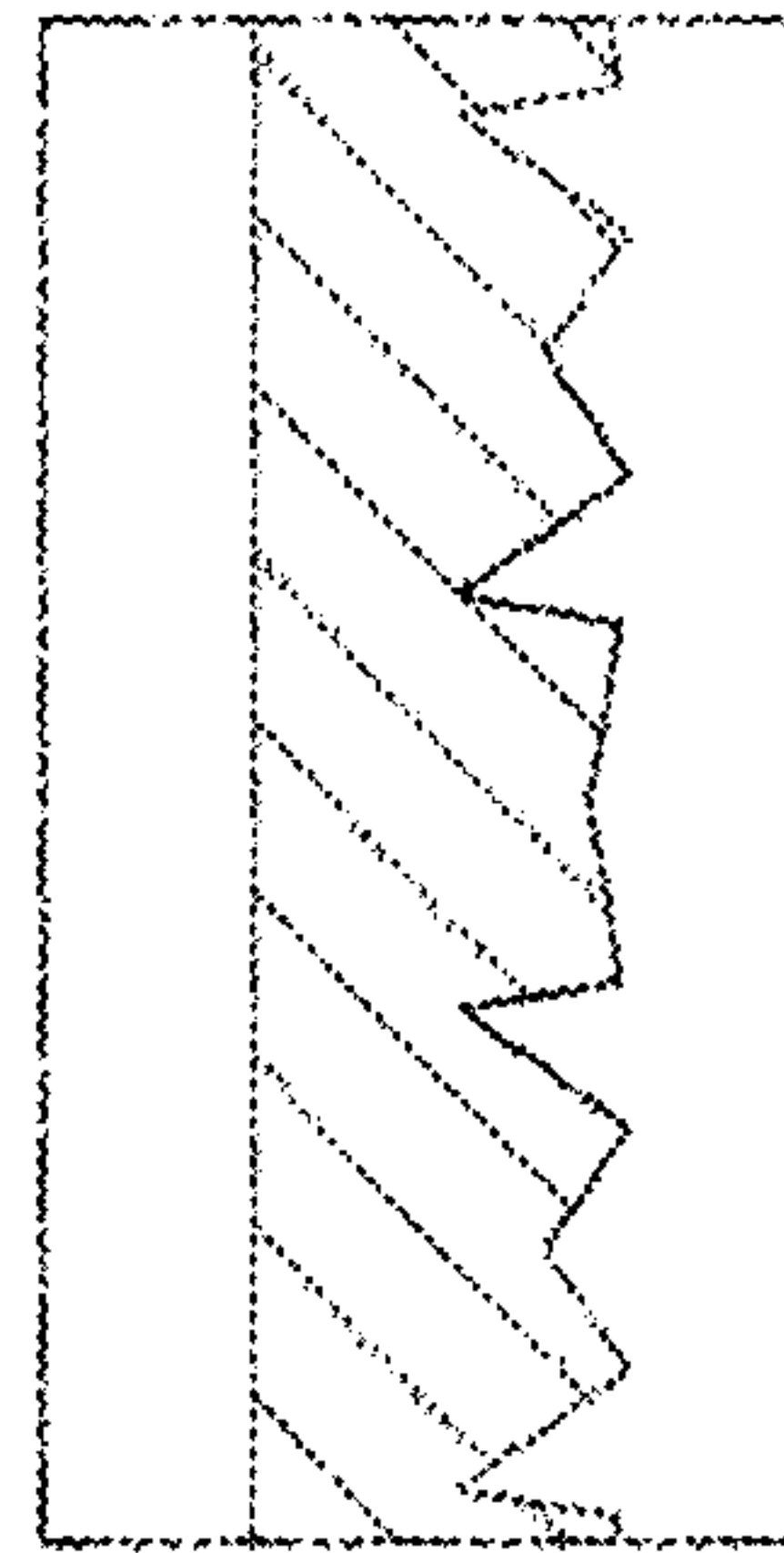

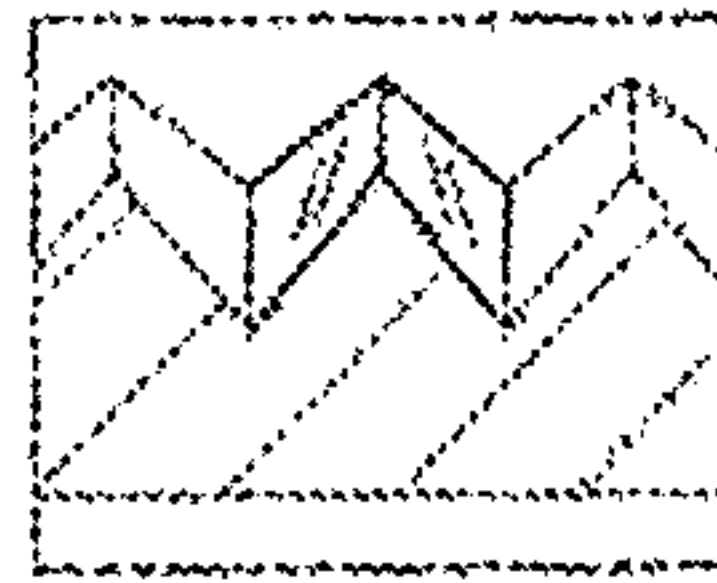

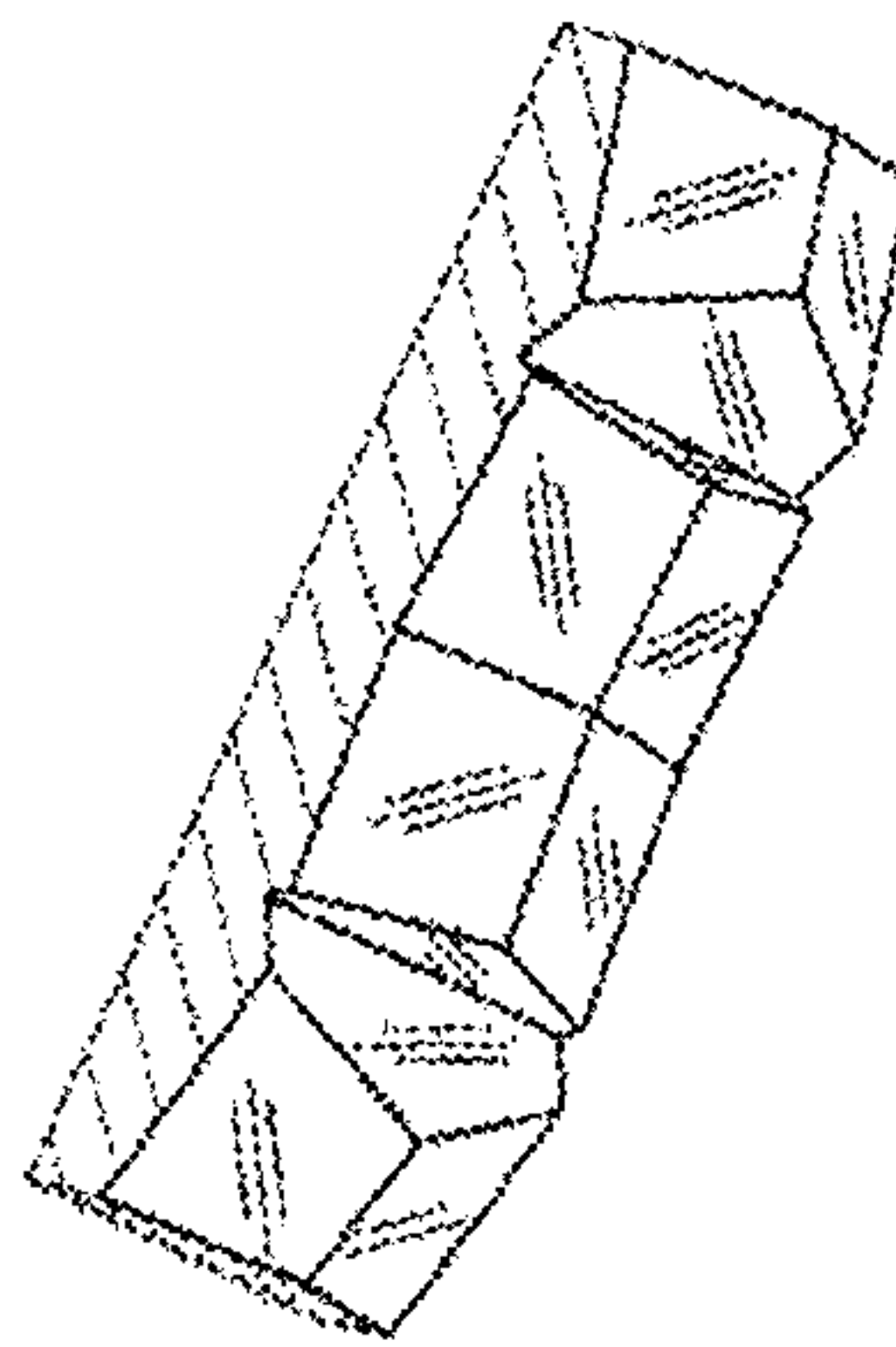

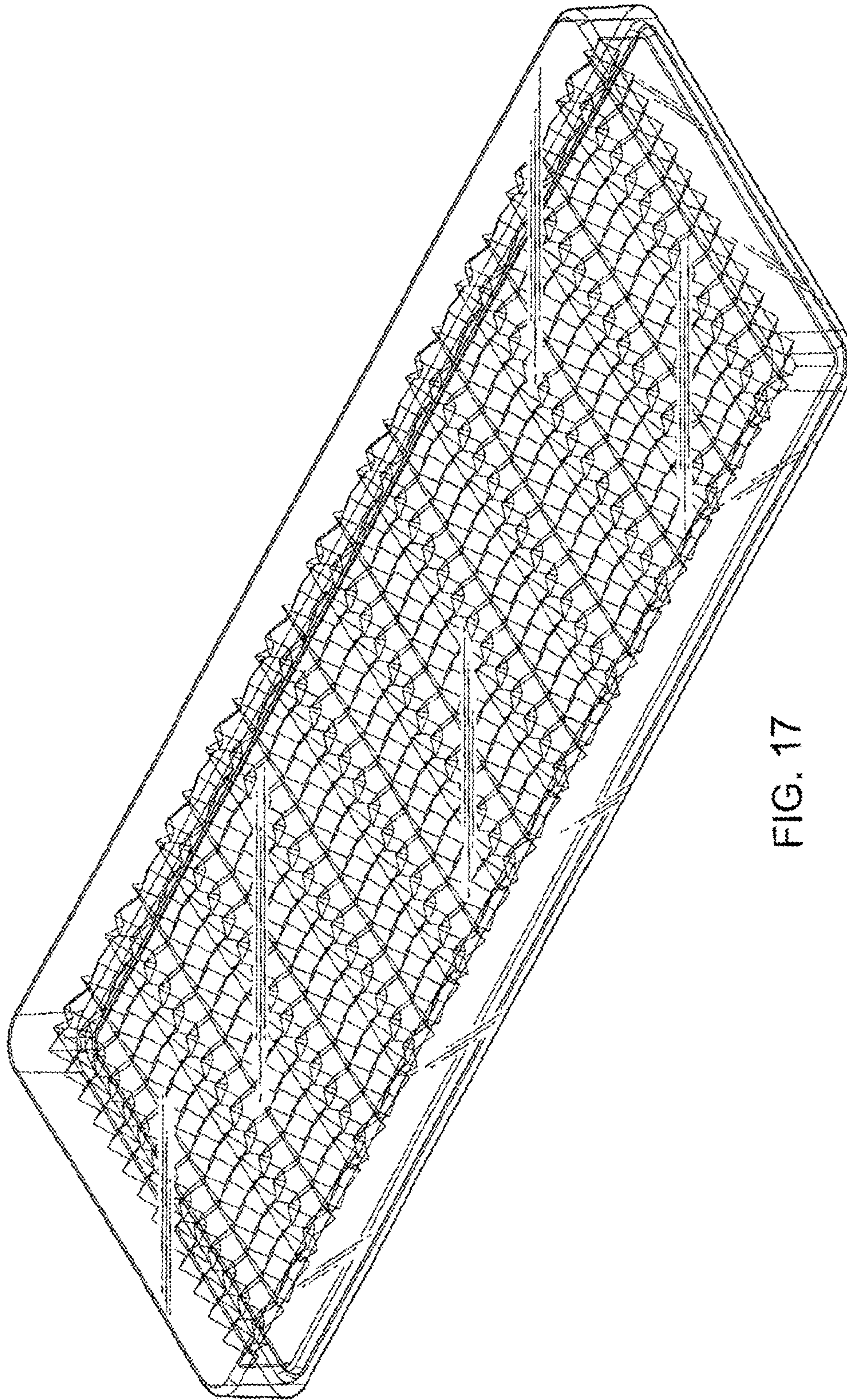
