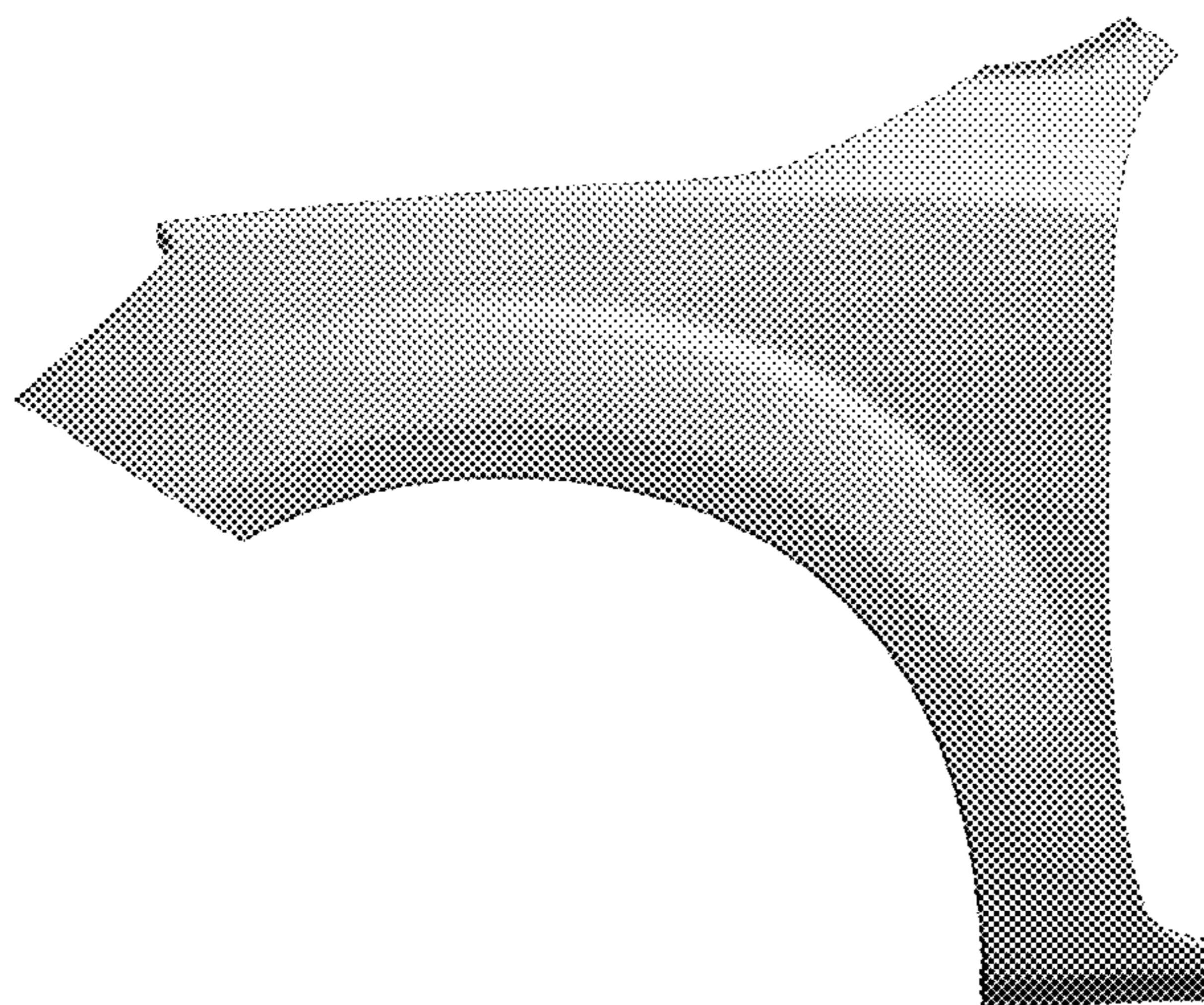
(57) **CLAIM**
The ornamental design for an automobile front fender, as shown and described.

DESCRIPTION

FIG. 1 is an outside elevational view of an automobile front fender in accordance with our new design;
FIG. 2 is an inside elevational view of the front fender in accordance with our new design of FIG. 1;
FIG. 3 is a top plan view of the front fender in accordance with our new design of FIGS. 1 and 2;
FIG. 4 is a bottom plan view of the front fender in accordance with our new design of FIGS. 1 to 3;
FIG. 5 is a rear end elevational view of the front fender in accordance with our new design of FIGS. 1 to 4;
FIG. 6 is a front end elevational view of the front fender in accordance with our new design of FIGS. 1 to 5;
FIG. 7 is a front-outside perspective view of the front fender in accordance with our new design of FIGS. 1 to 6; and,
FIG. 8 is a rear-outside perspective view of the front fender in accordance with our new design of FIGS. 1 to 7.

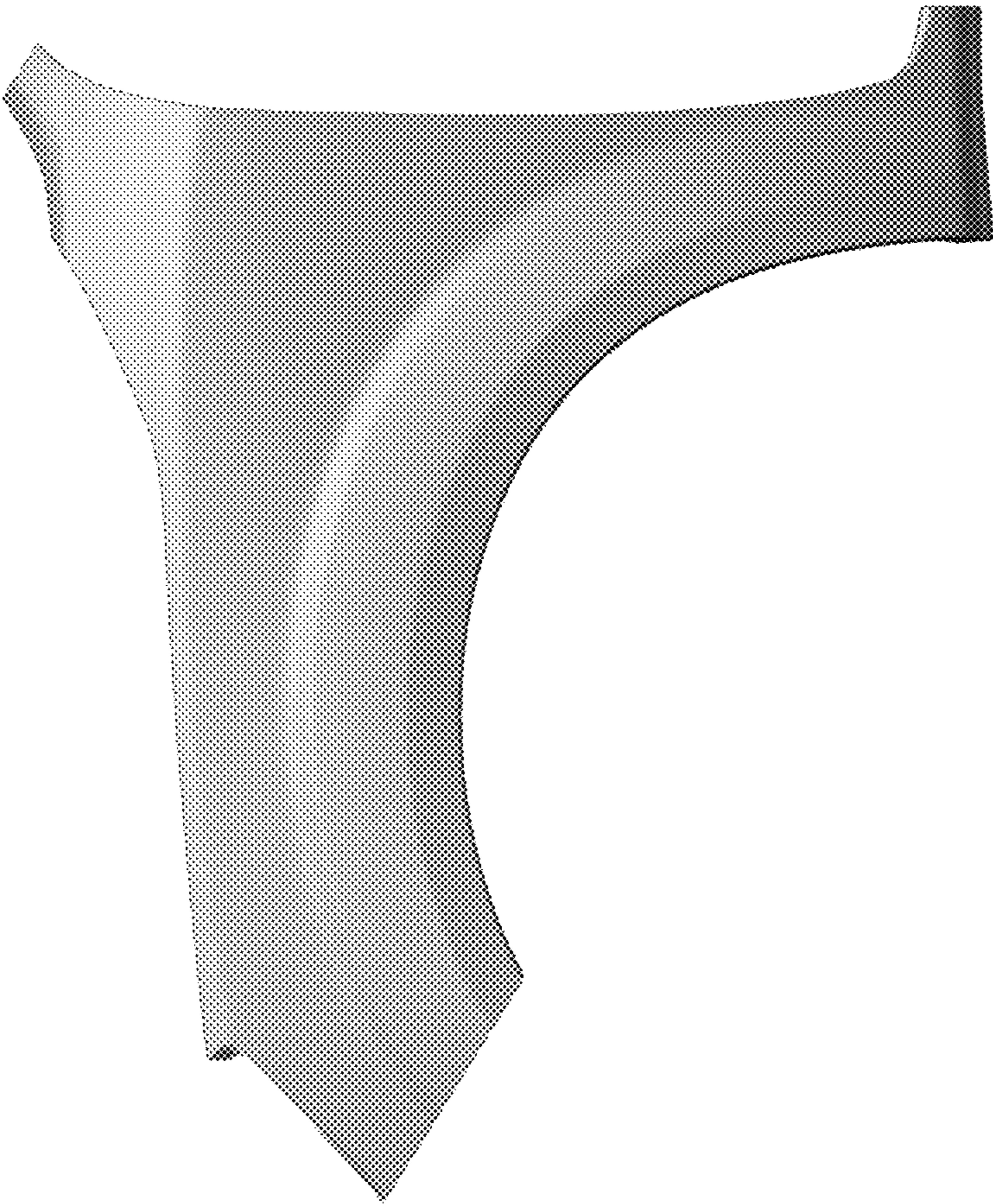

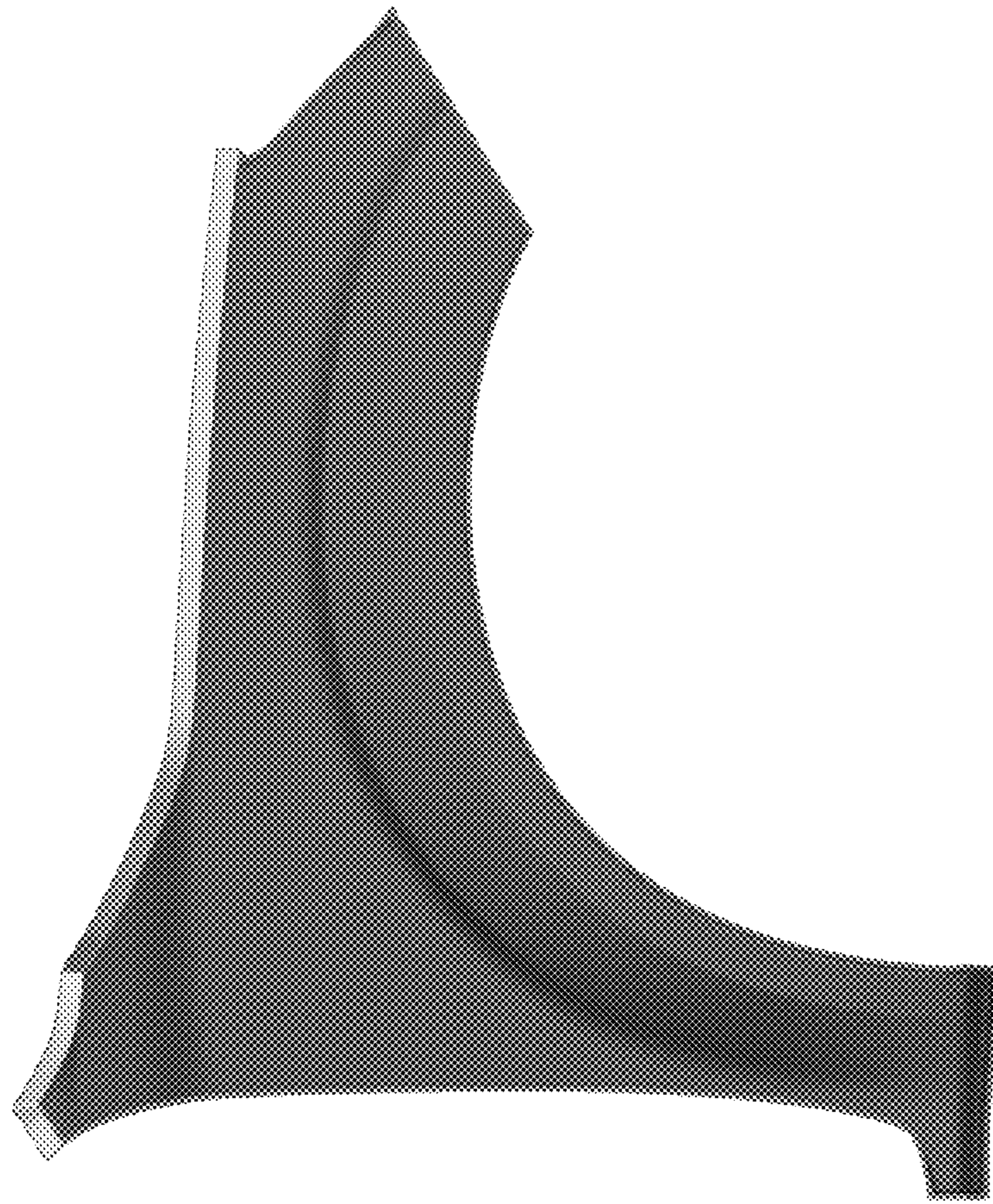

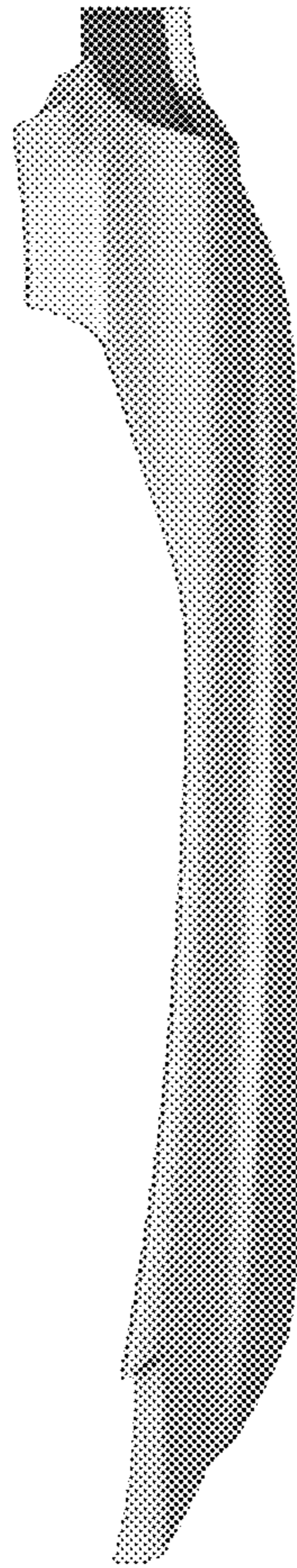

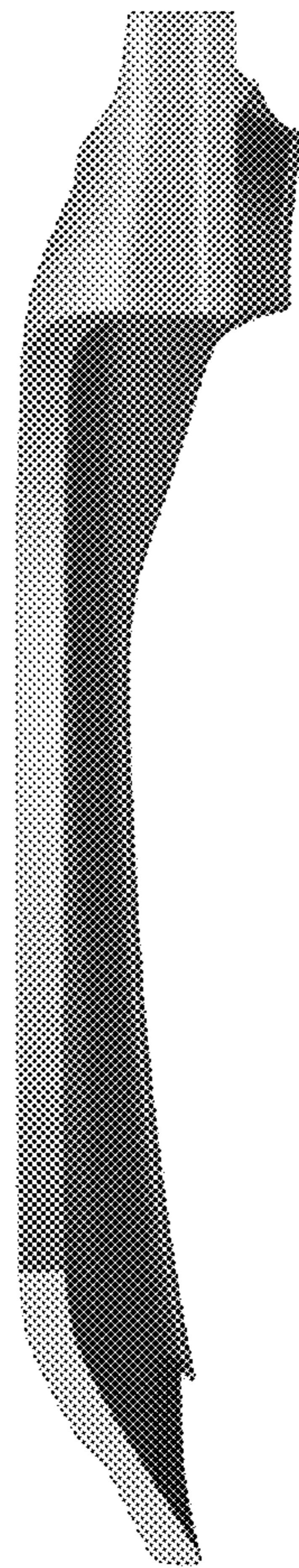

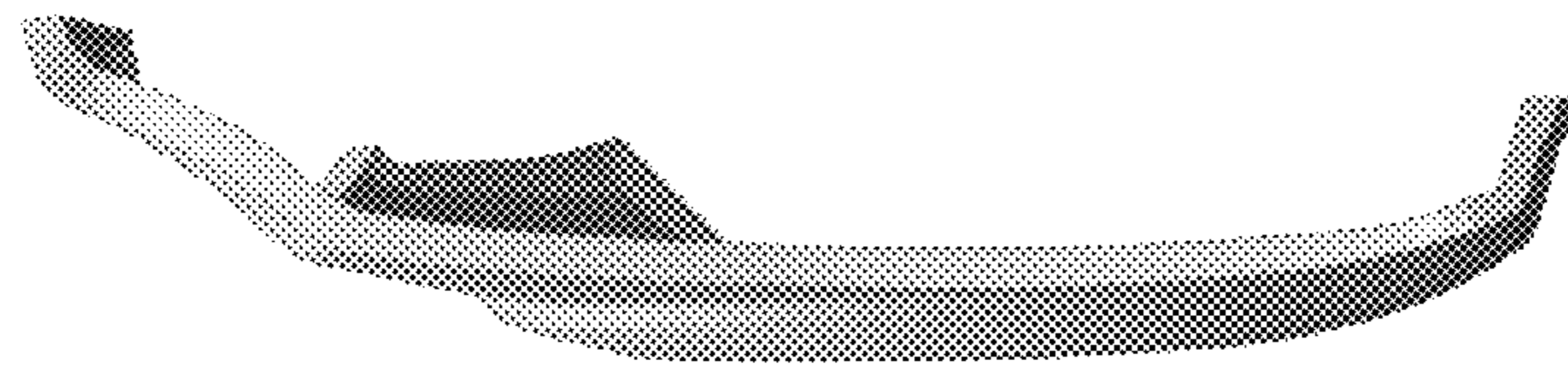

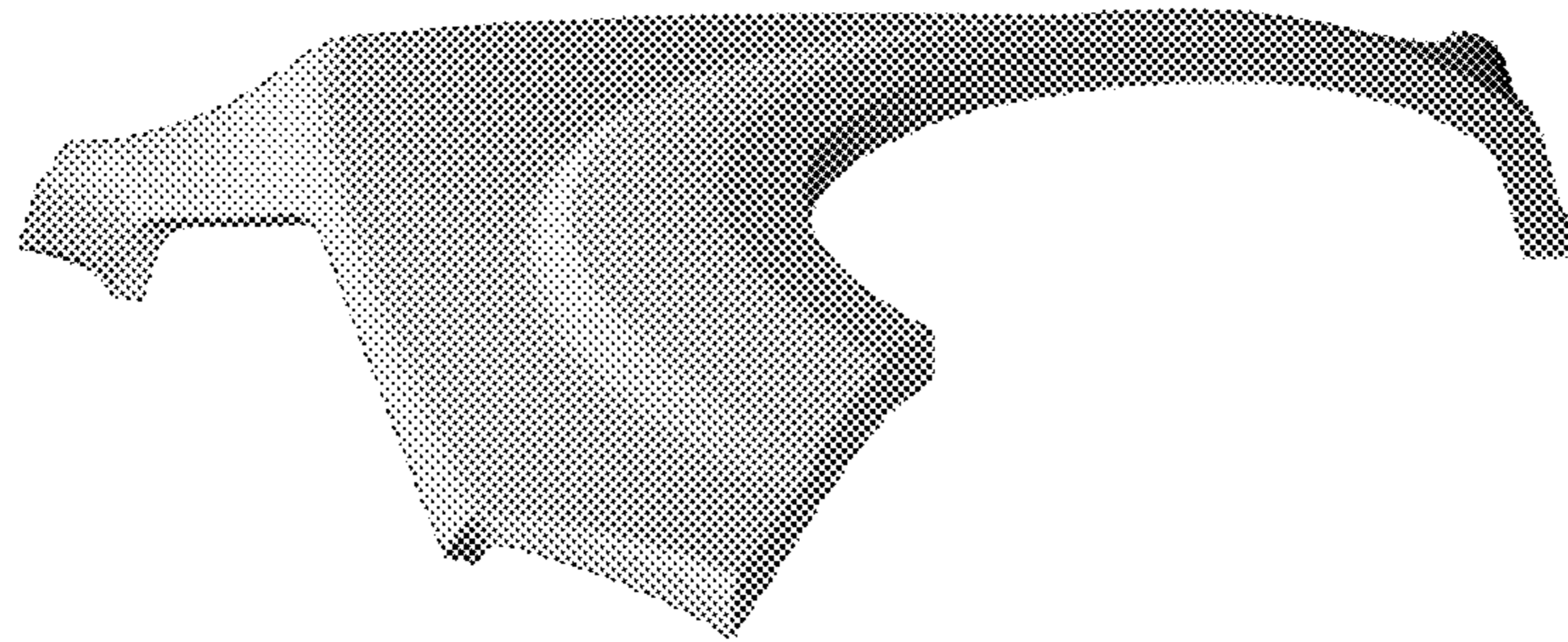

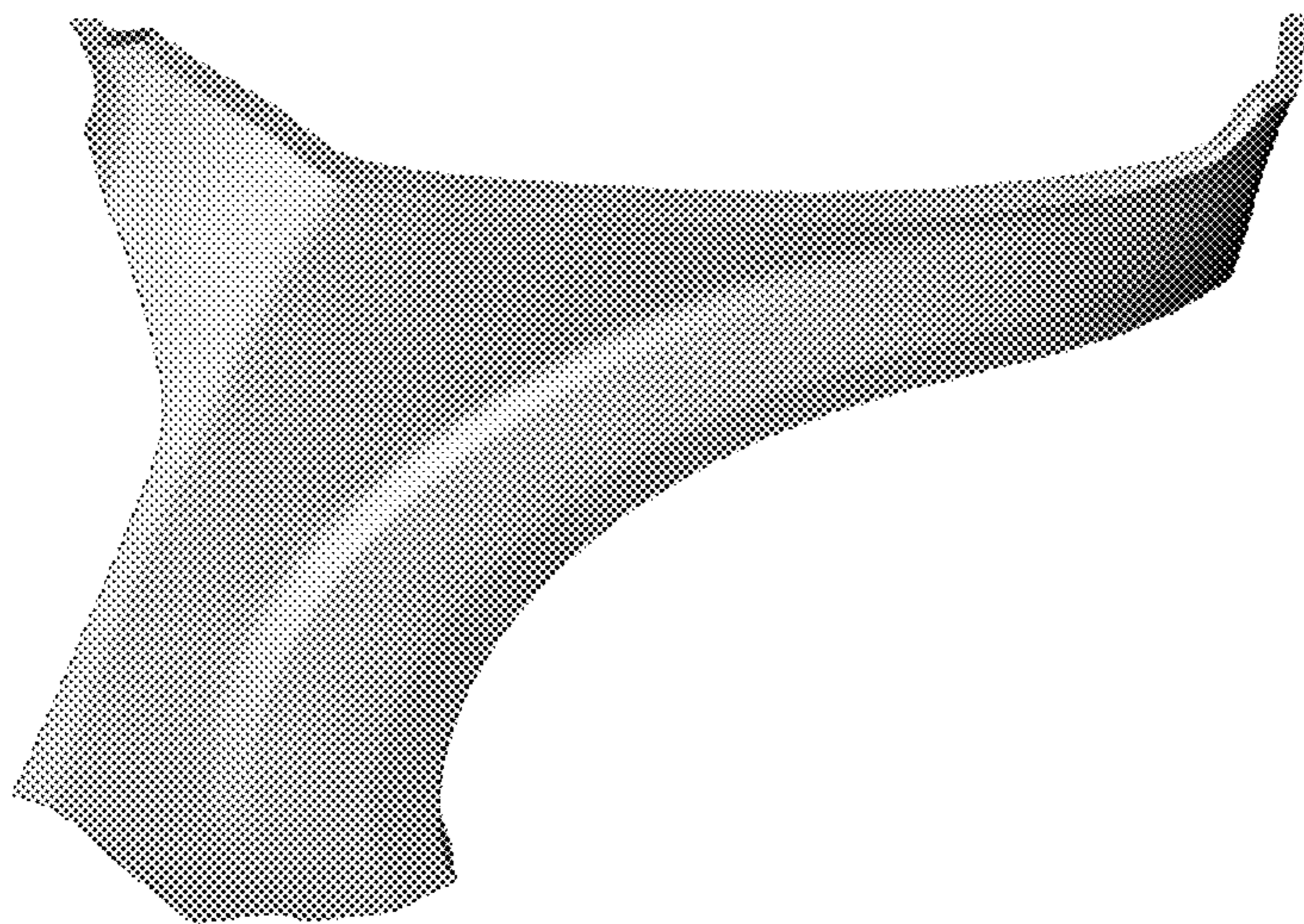
