DESCRIPTION

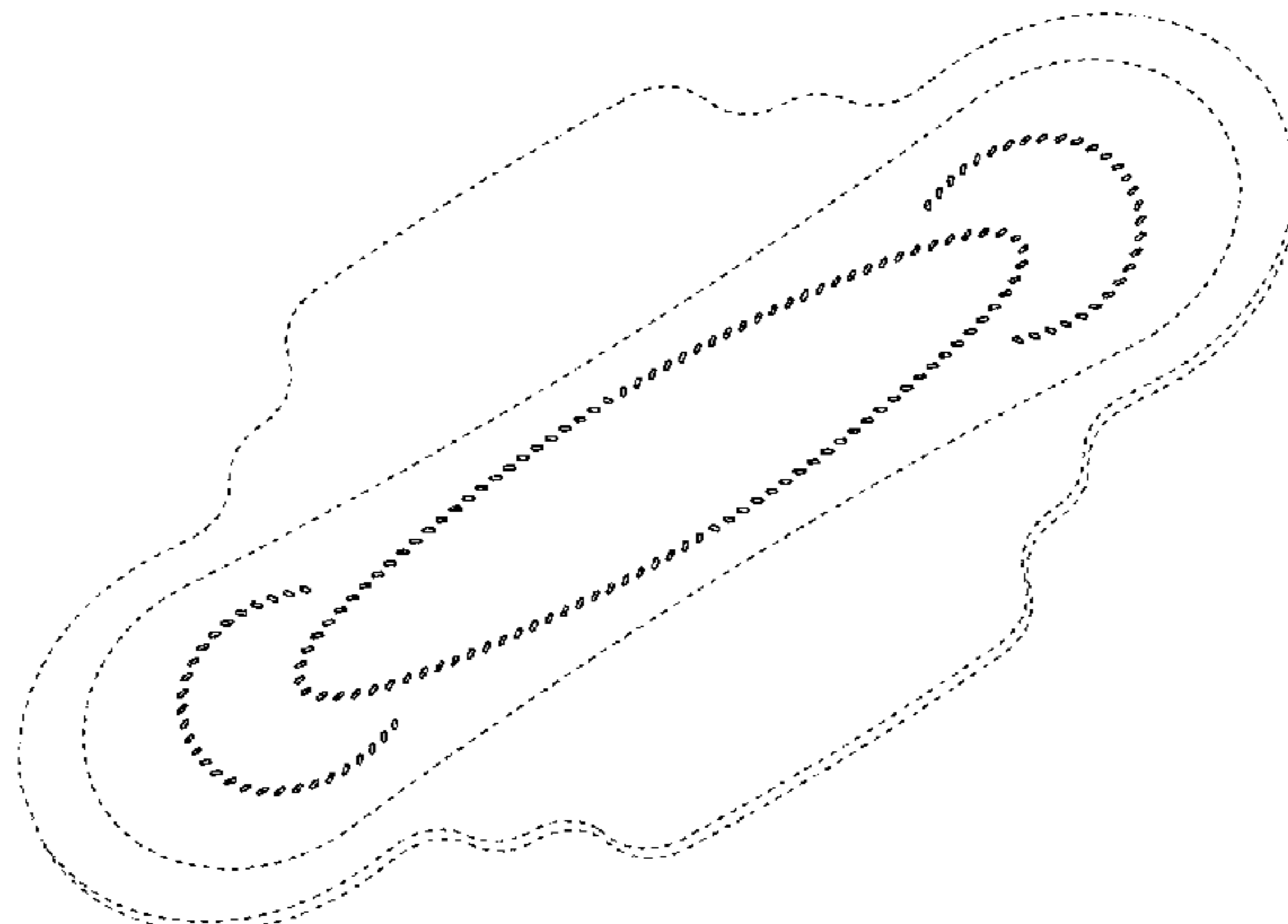
FIG. 1 is a perspective top view of a sanitary napkin, embodying the new design;

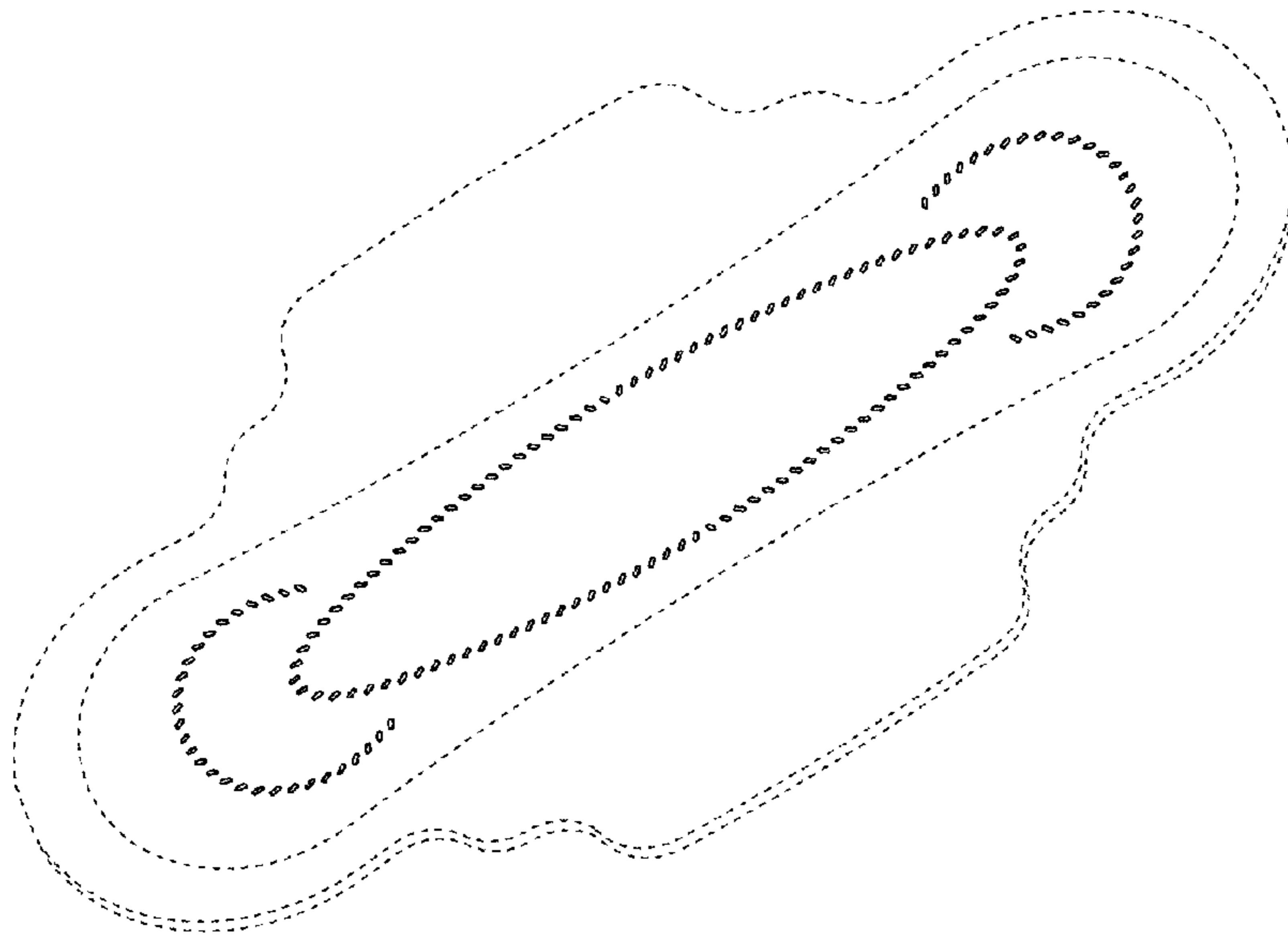

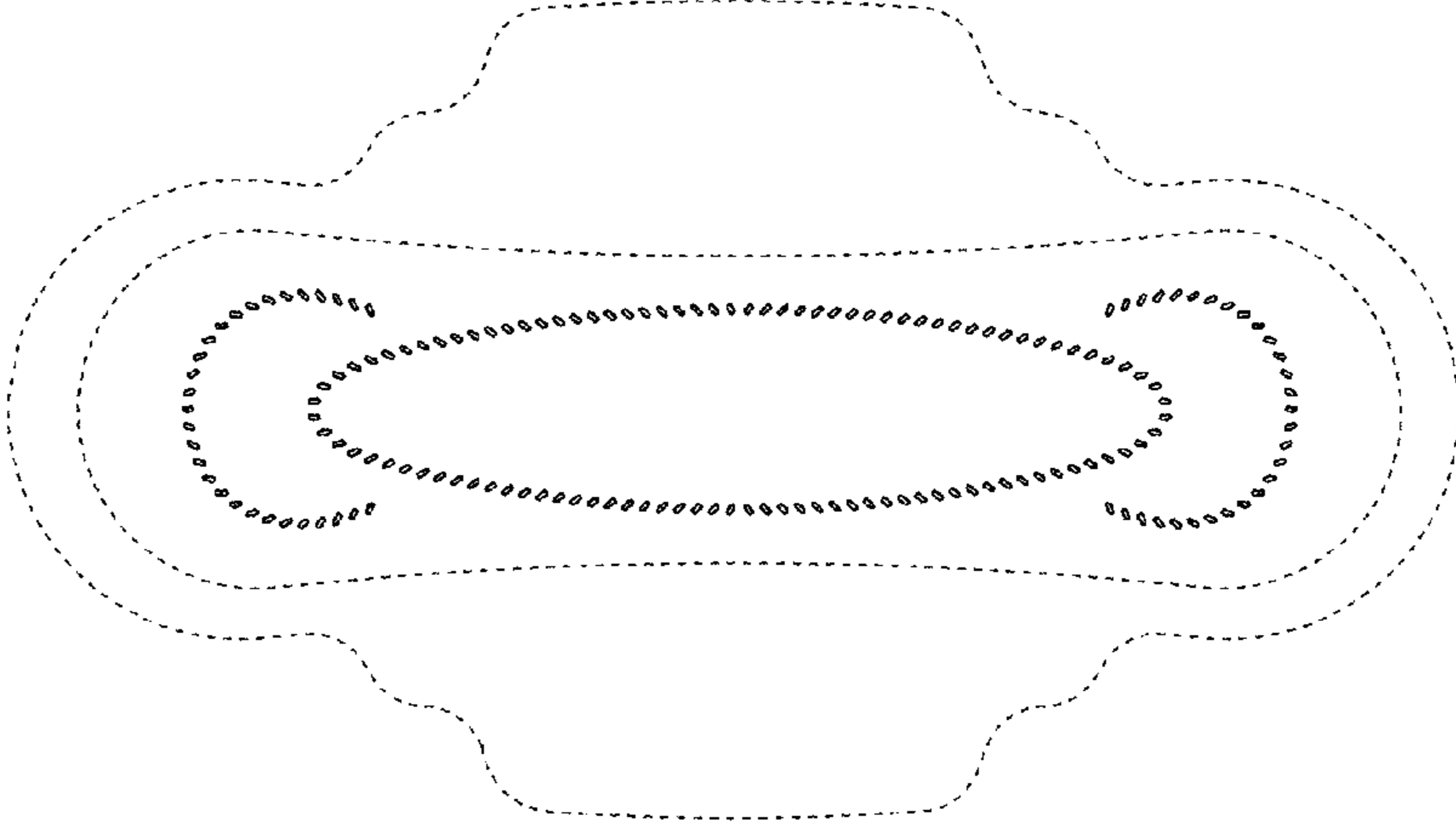

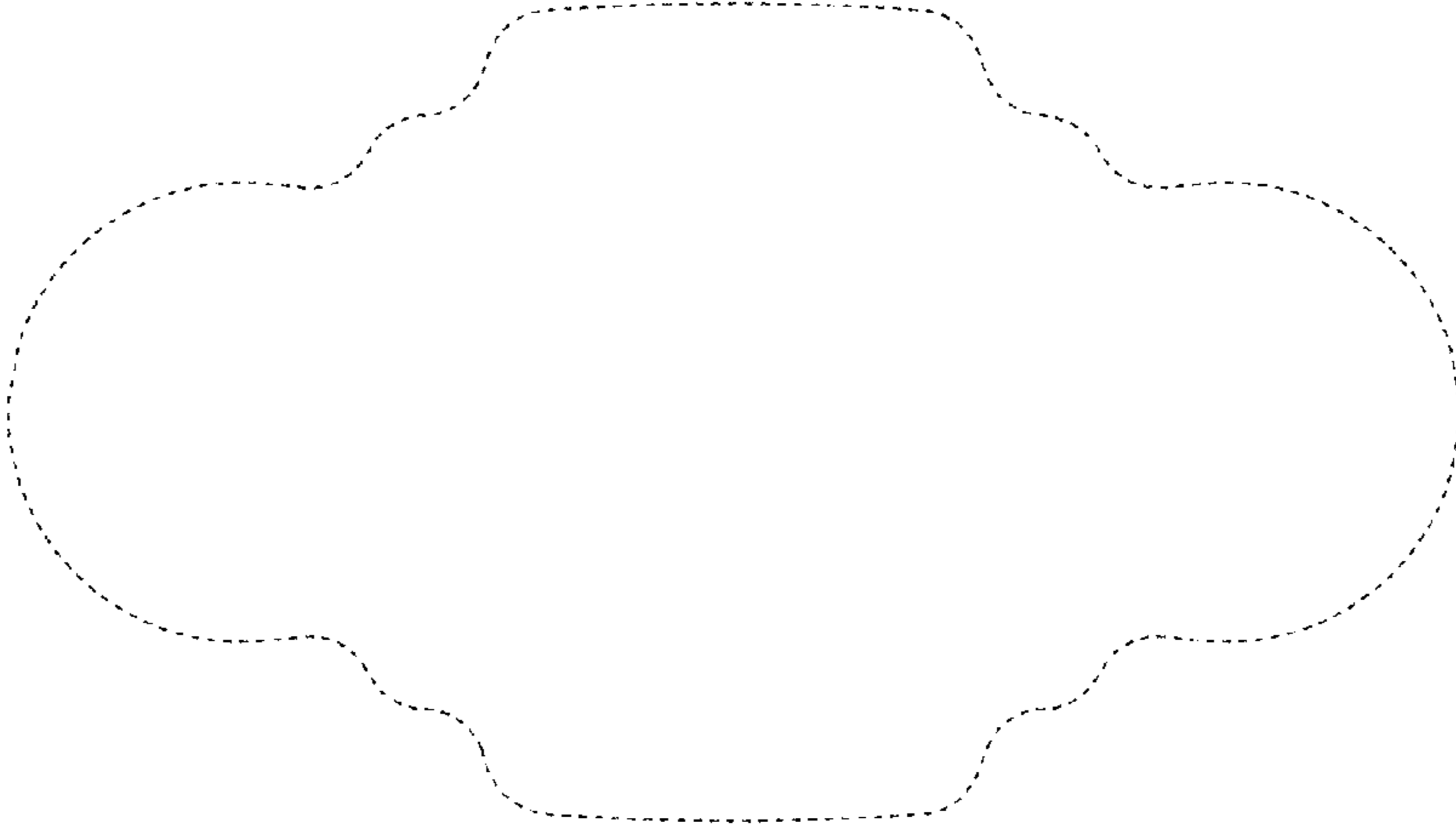

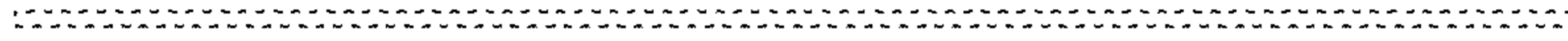

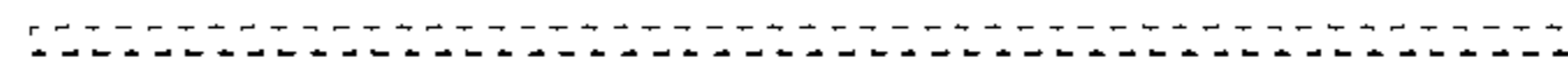

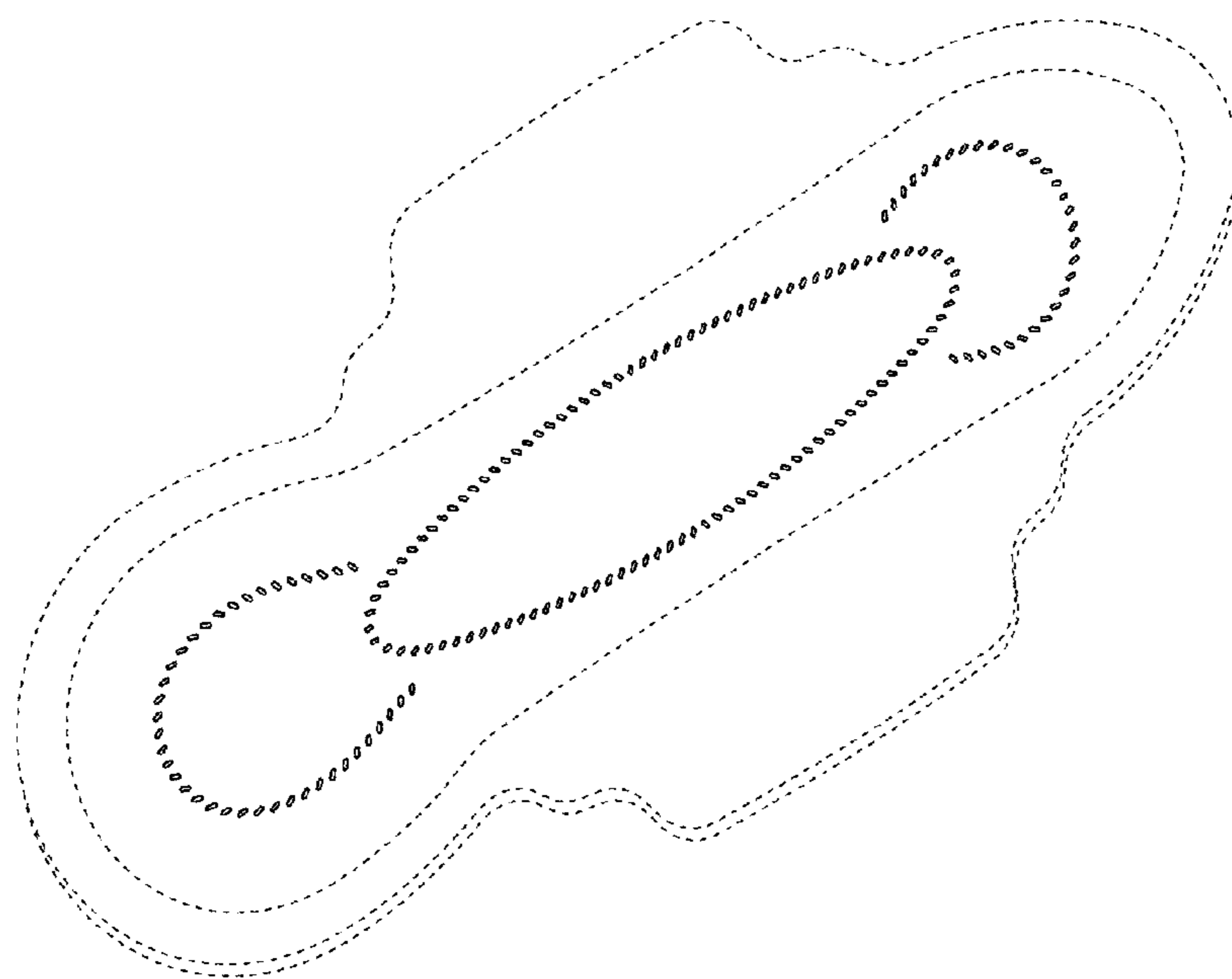

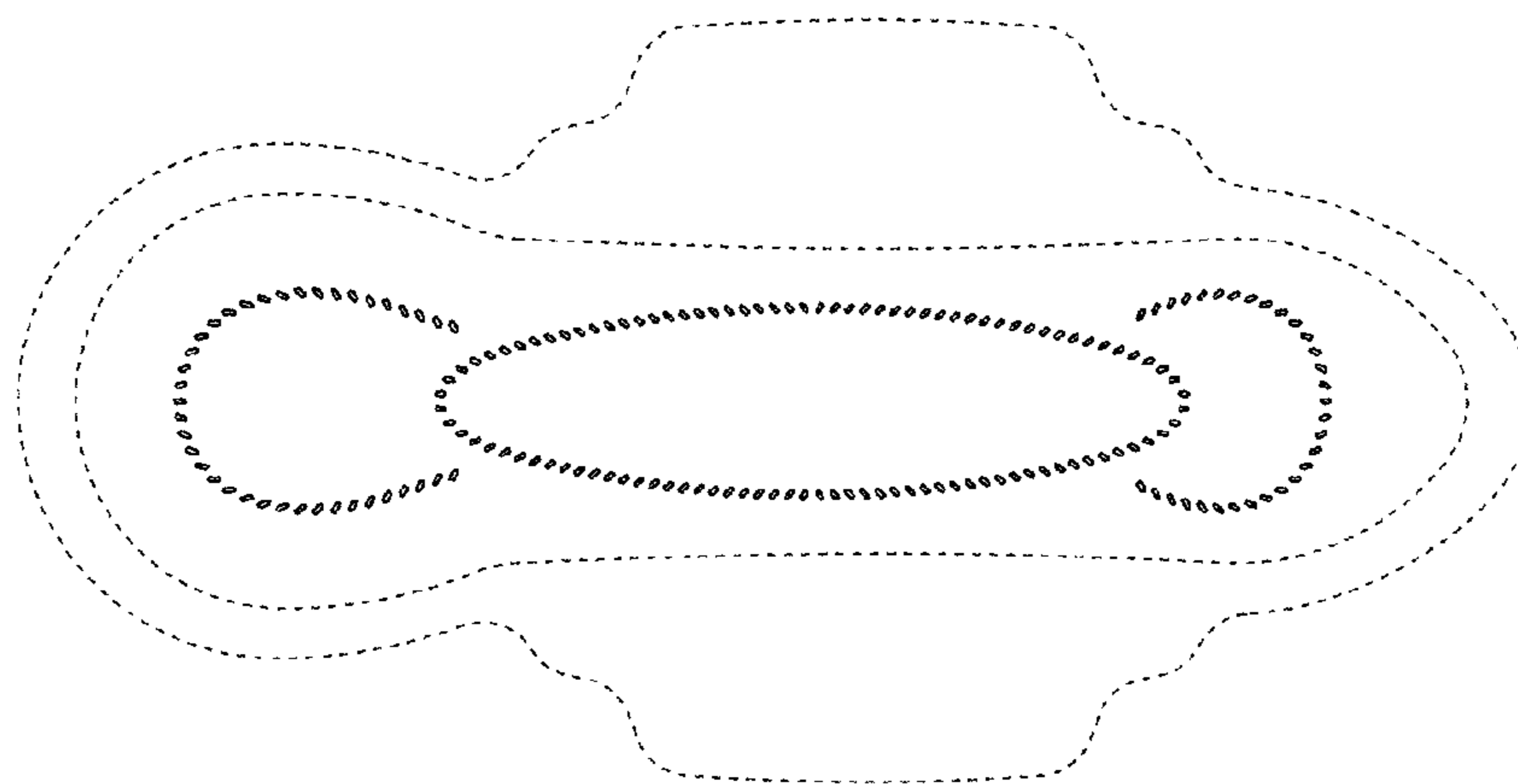

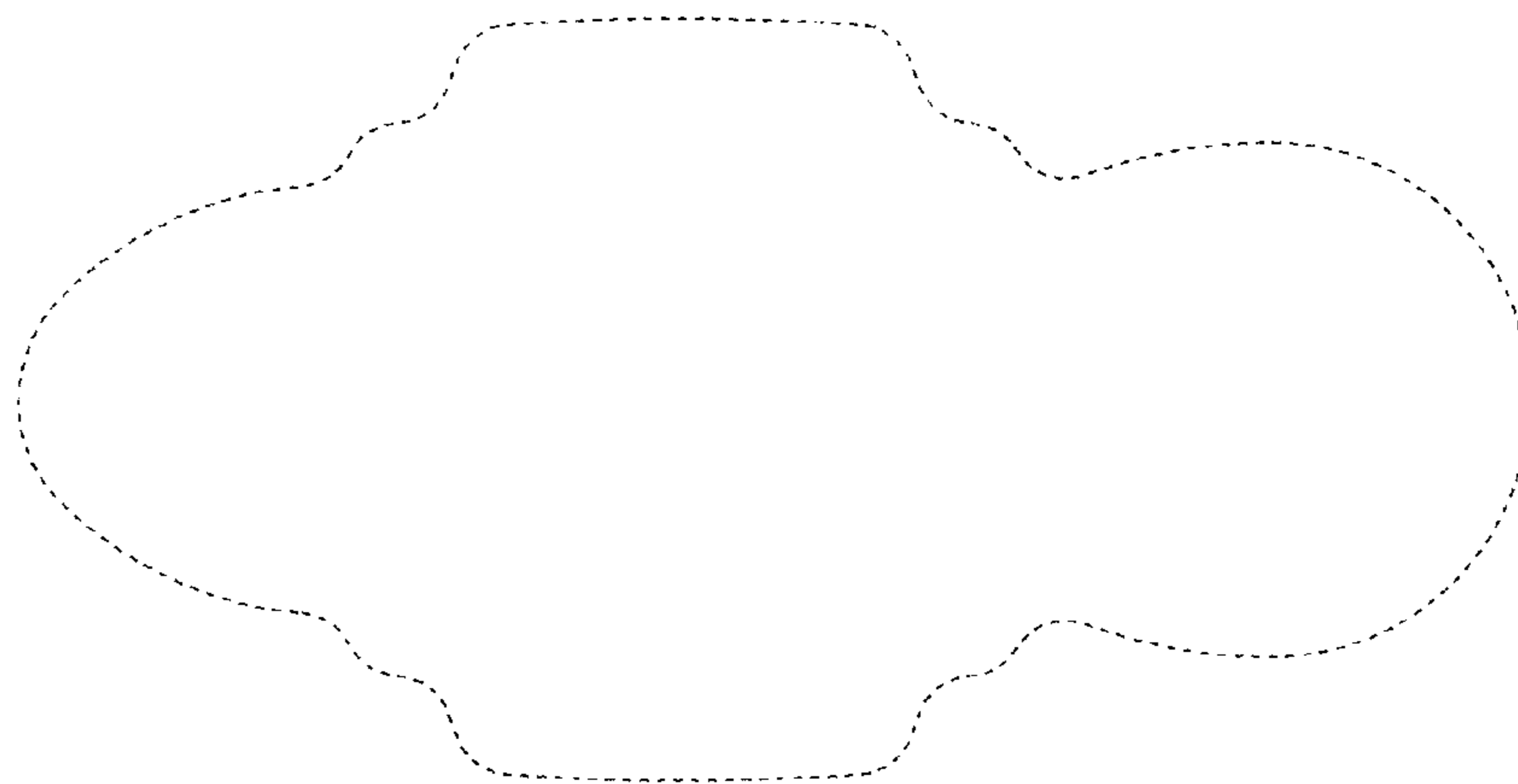

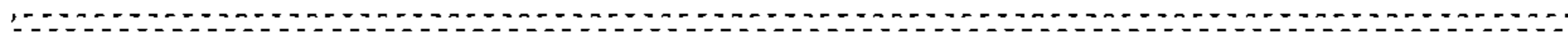
