The broken lines shown in the drawings are for the purpose of illustrating unclaimed portions of the jewelry cleaner, and form no part of the claimed design.

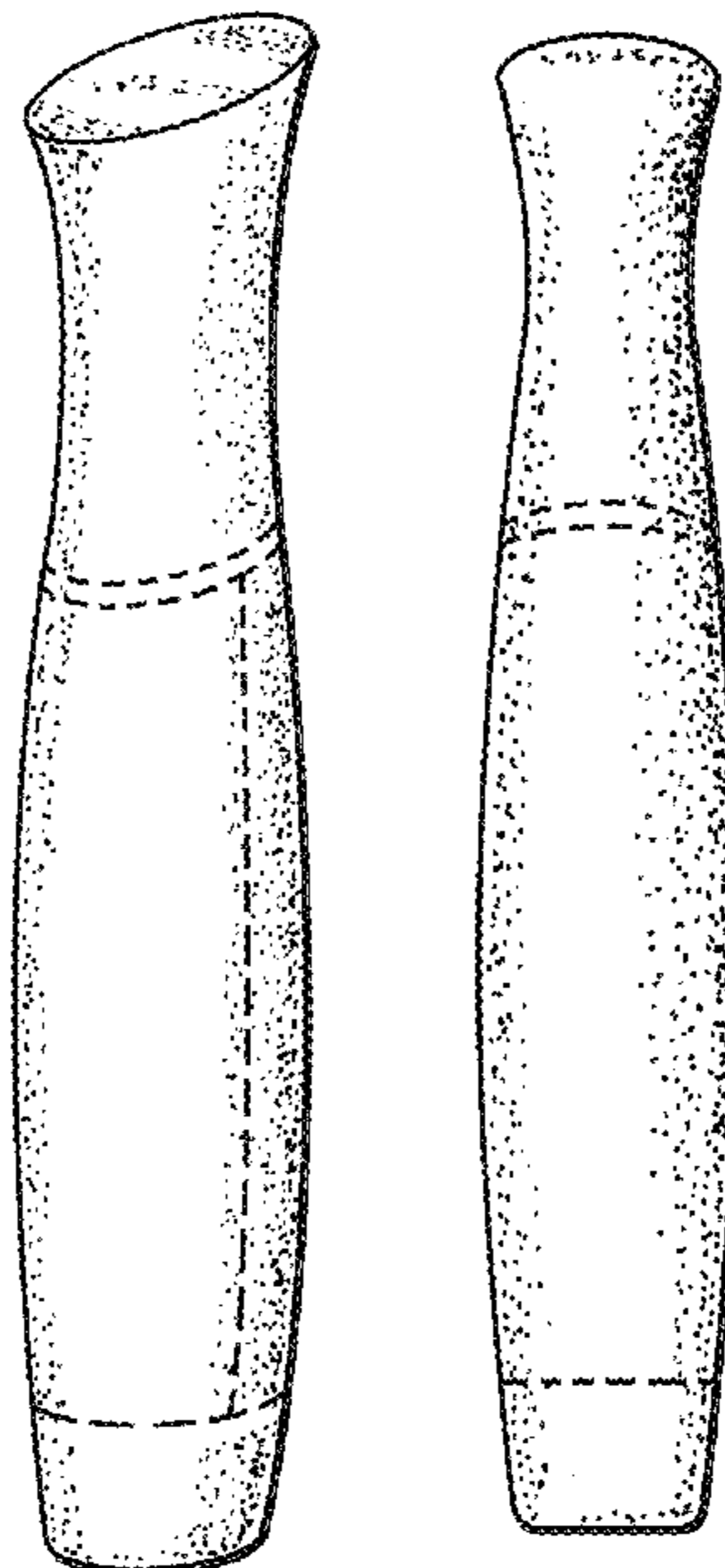

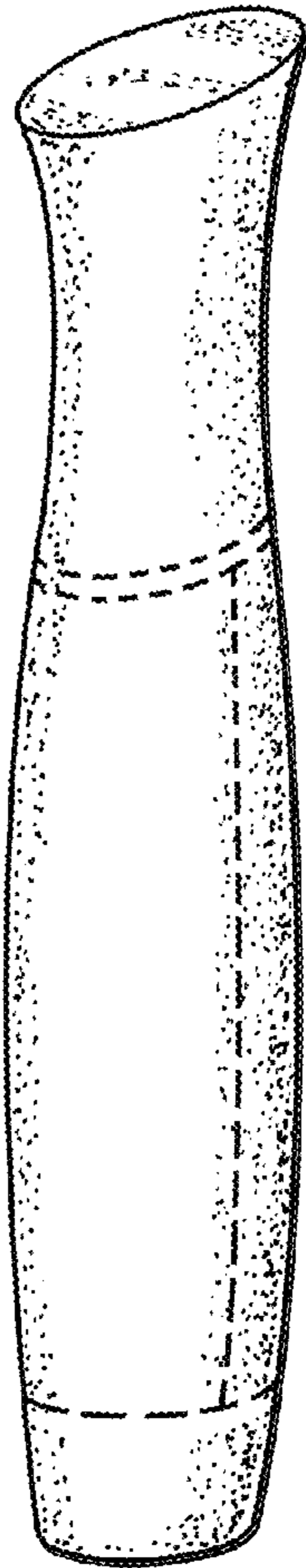

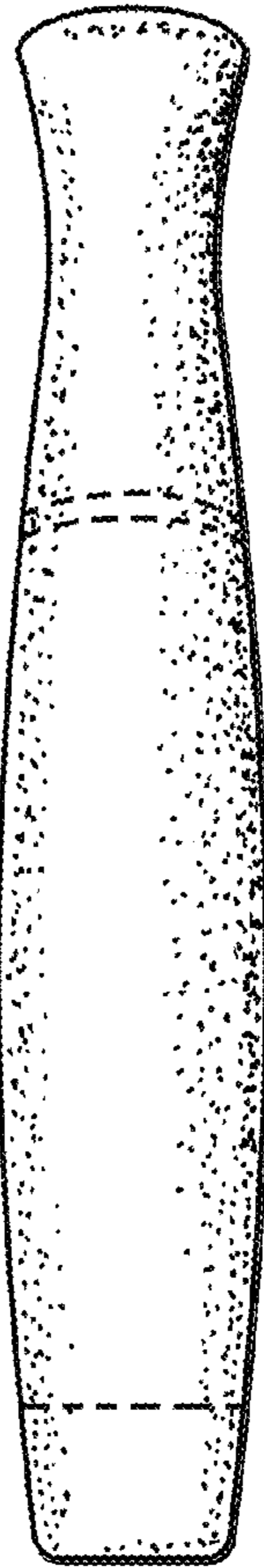

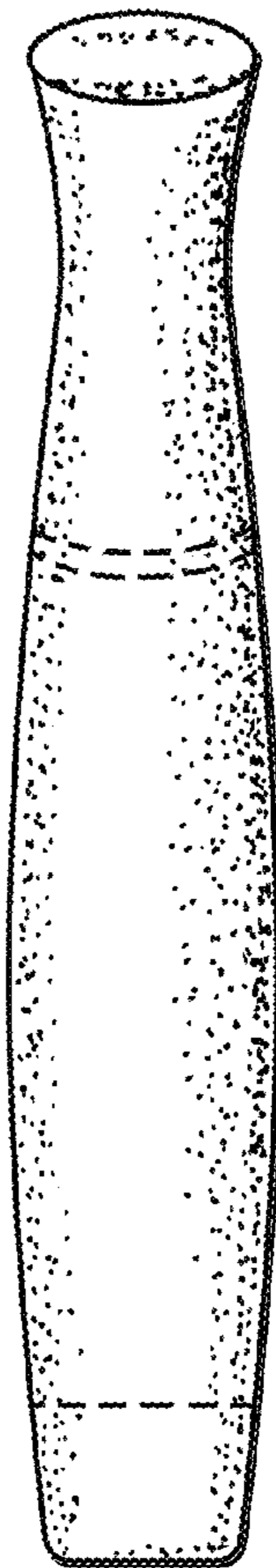

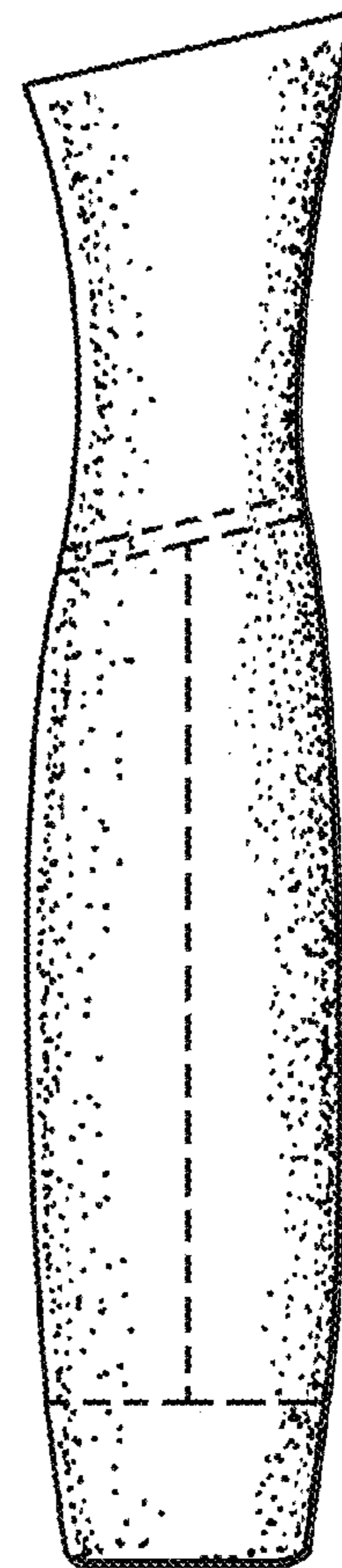

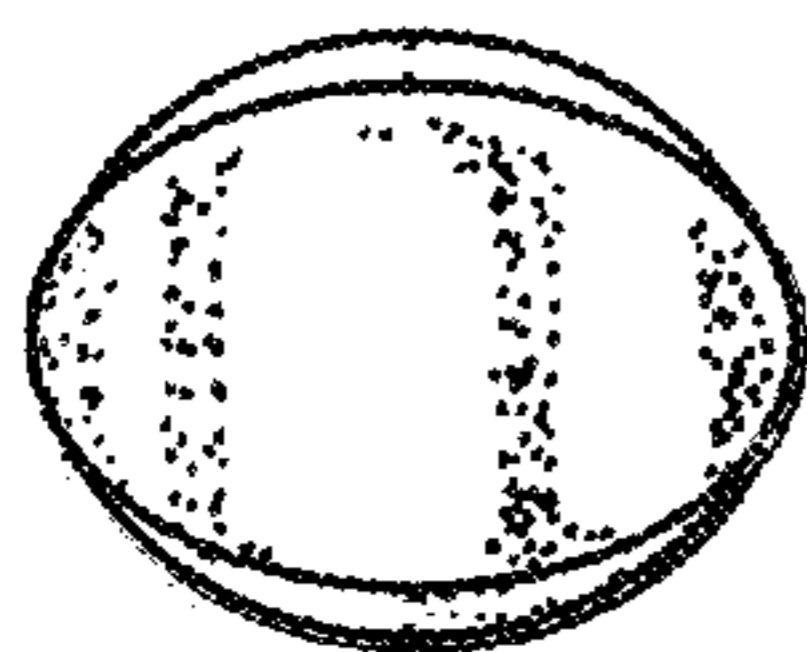
