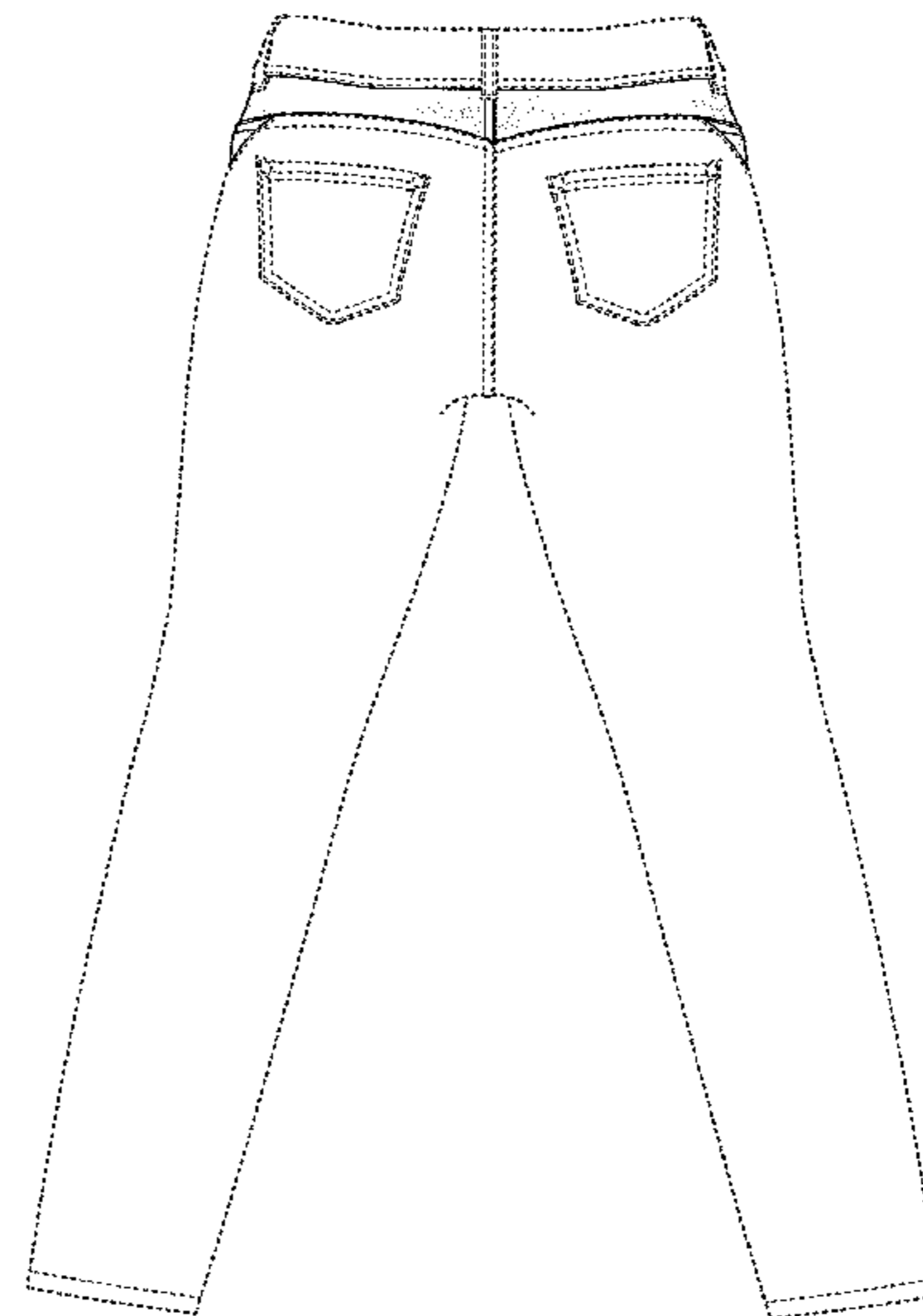
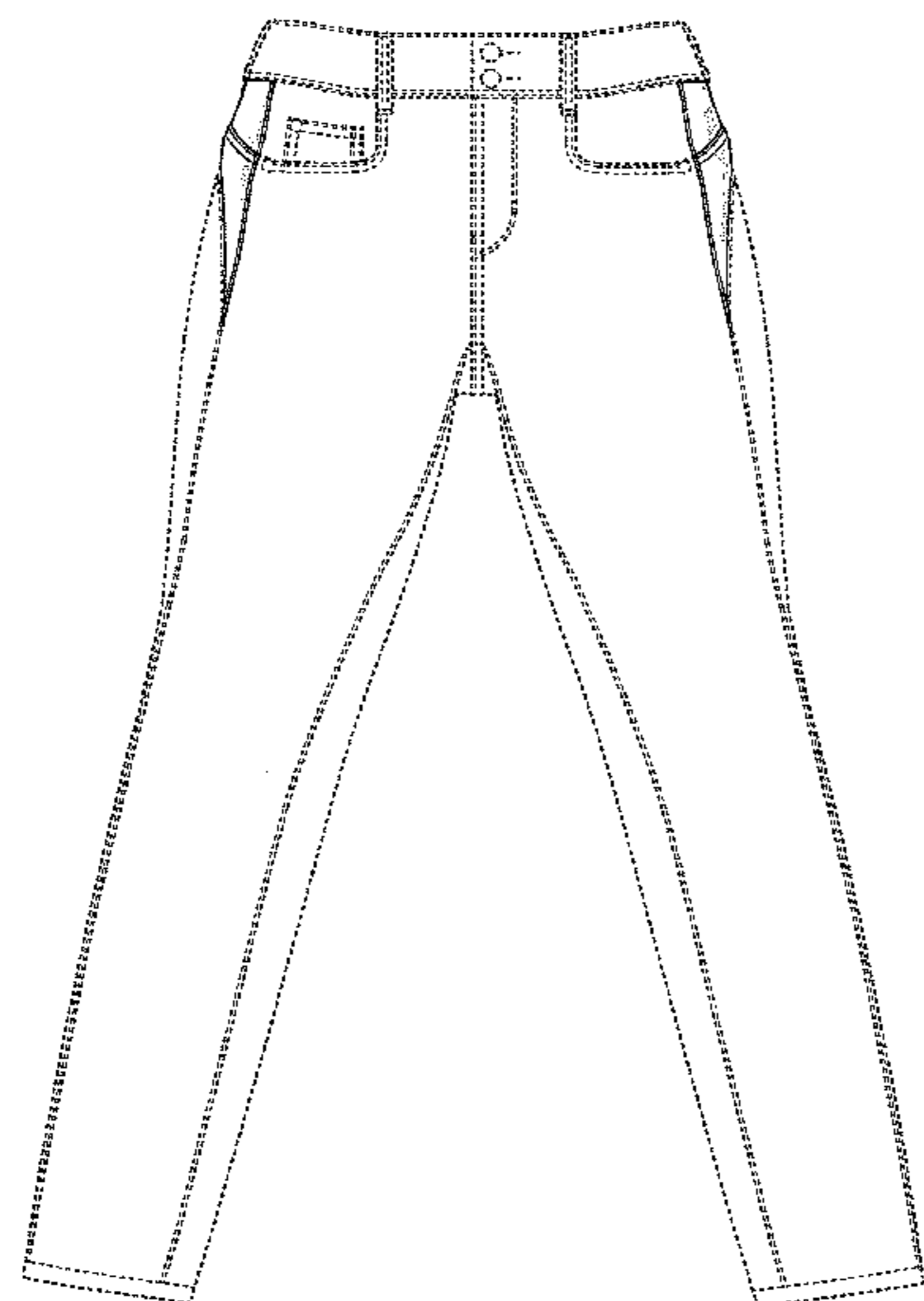
(57) **CLAIM**

I claim the design for the jeans, as shown and described.

**DESCRIPTION**

FIG. 1 is a frontal view of the jeans showing the new design; FIG. 2 is a rear view of the jeans of FIG. 1; FIG. 3 is a left view of the jeans of FIG. 1; and, FIG. 4 is a right view of the jeans of FIG. 1. The broken lines are included for the purpose of illustrating portions of the jeans that form no part of the claimed design.

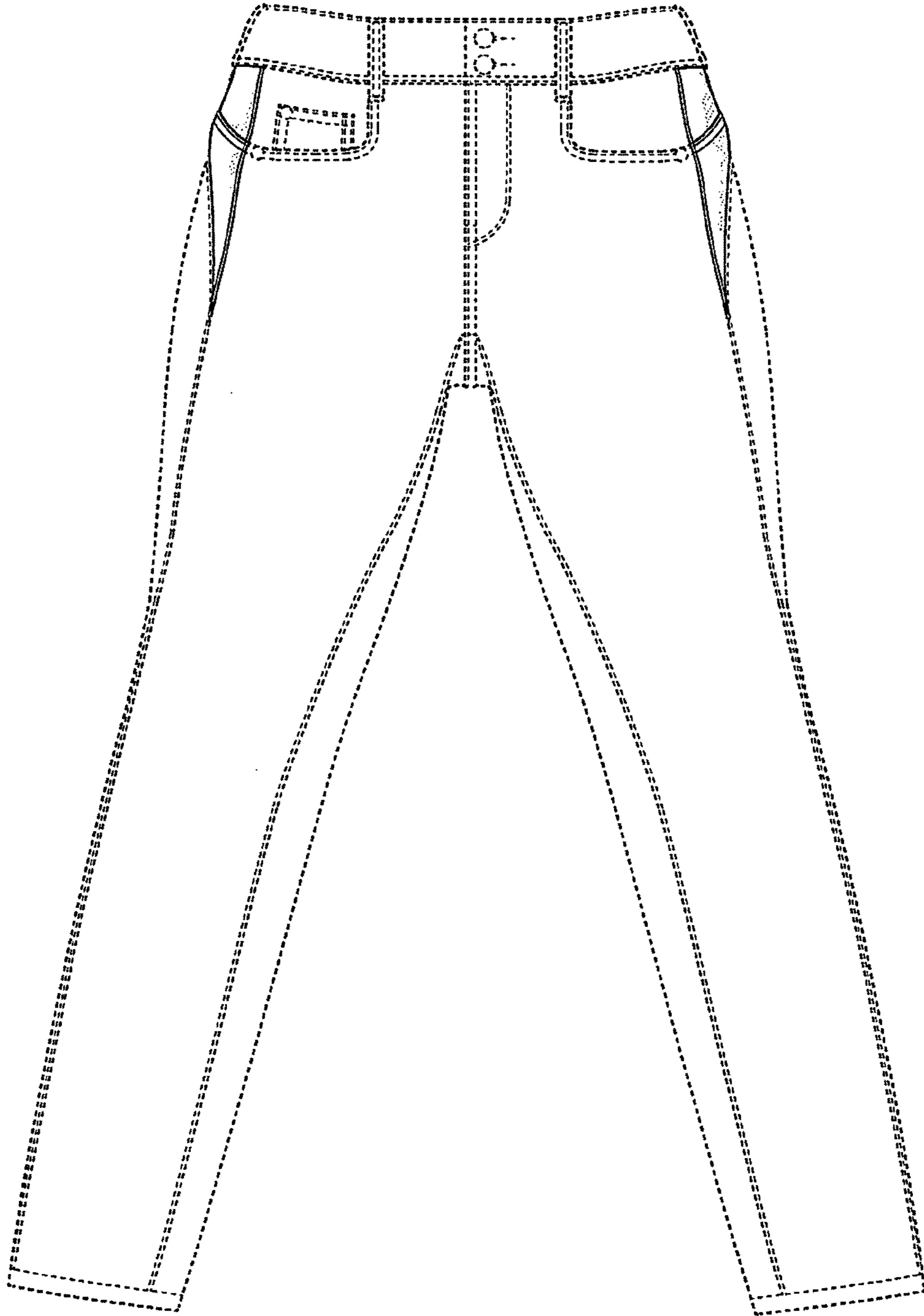

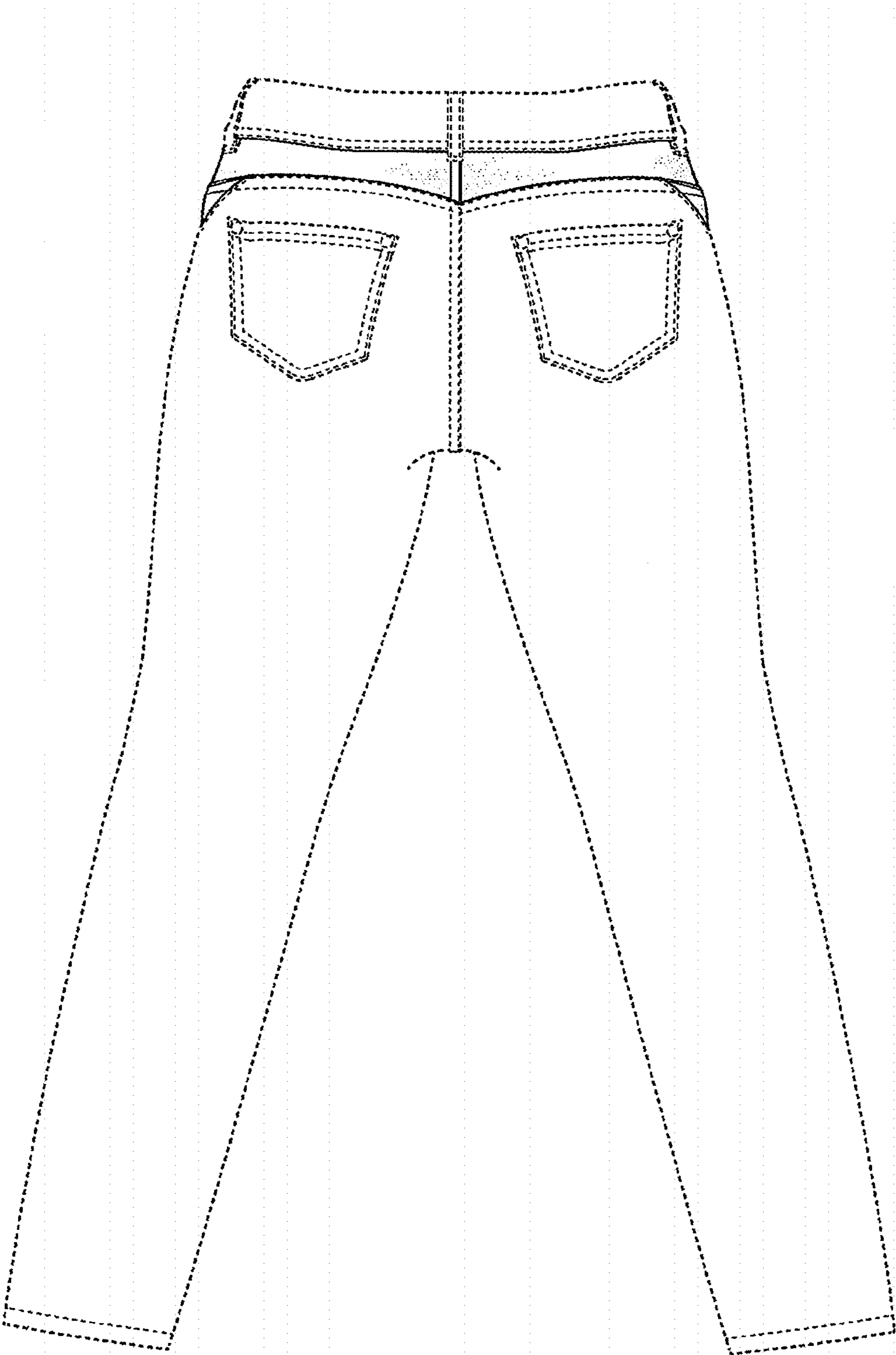

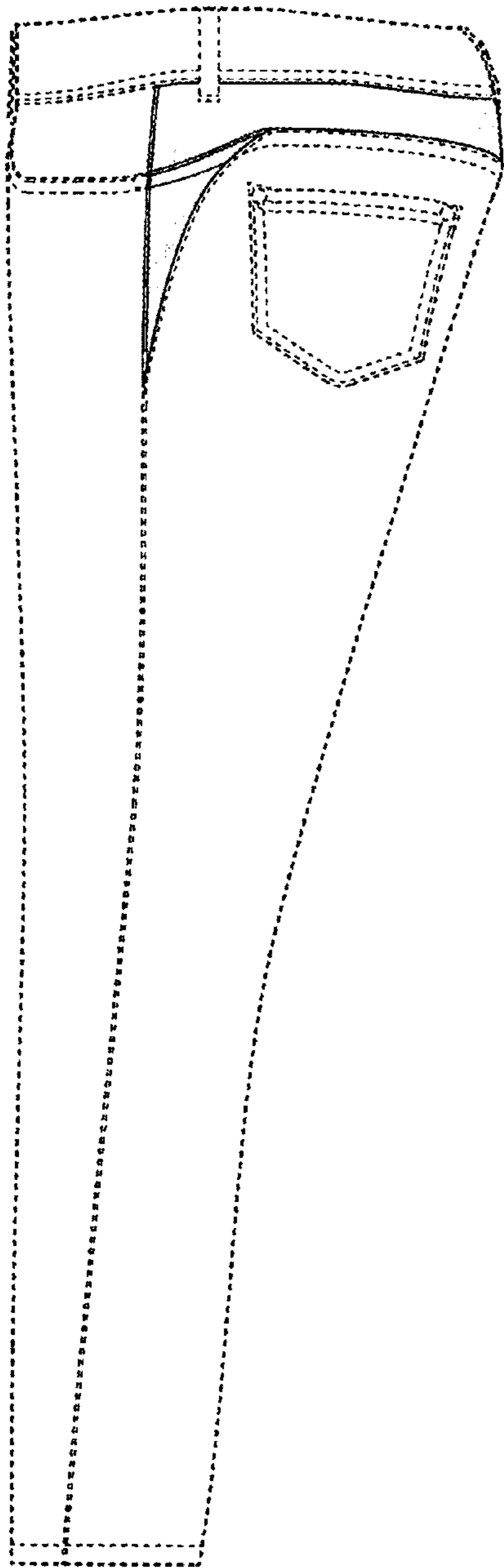

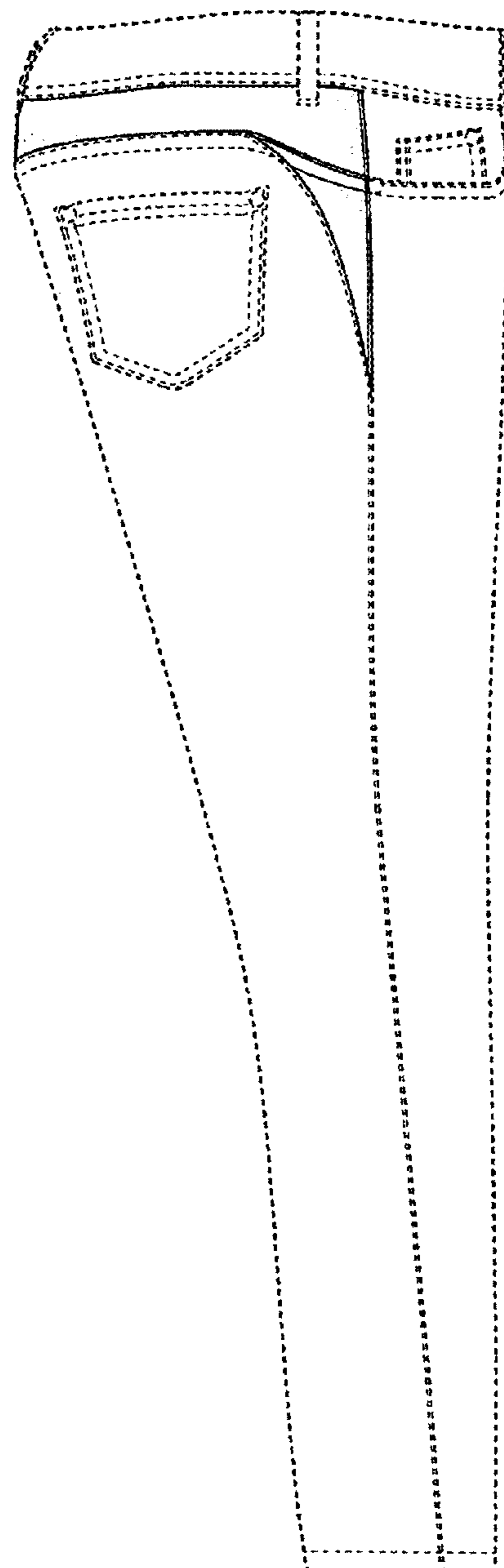
