(57) **CLAIM**

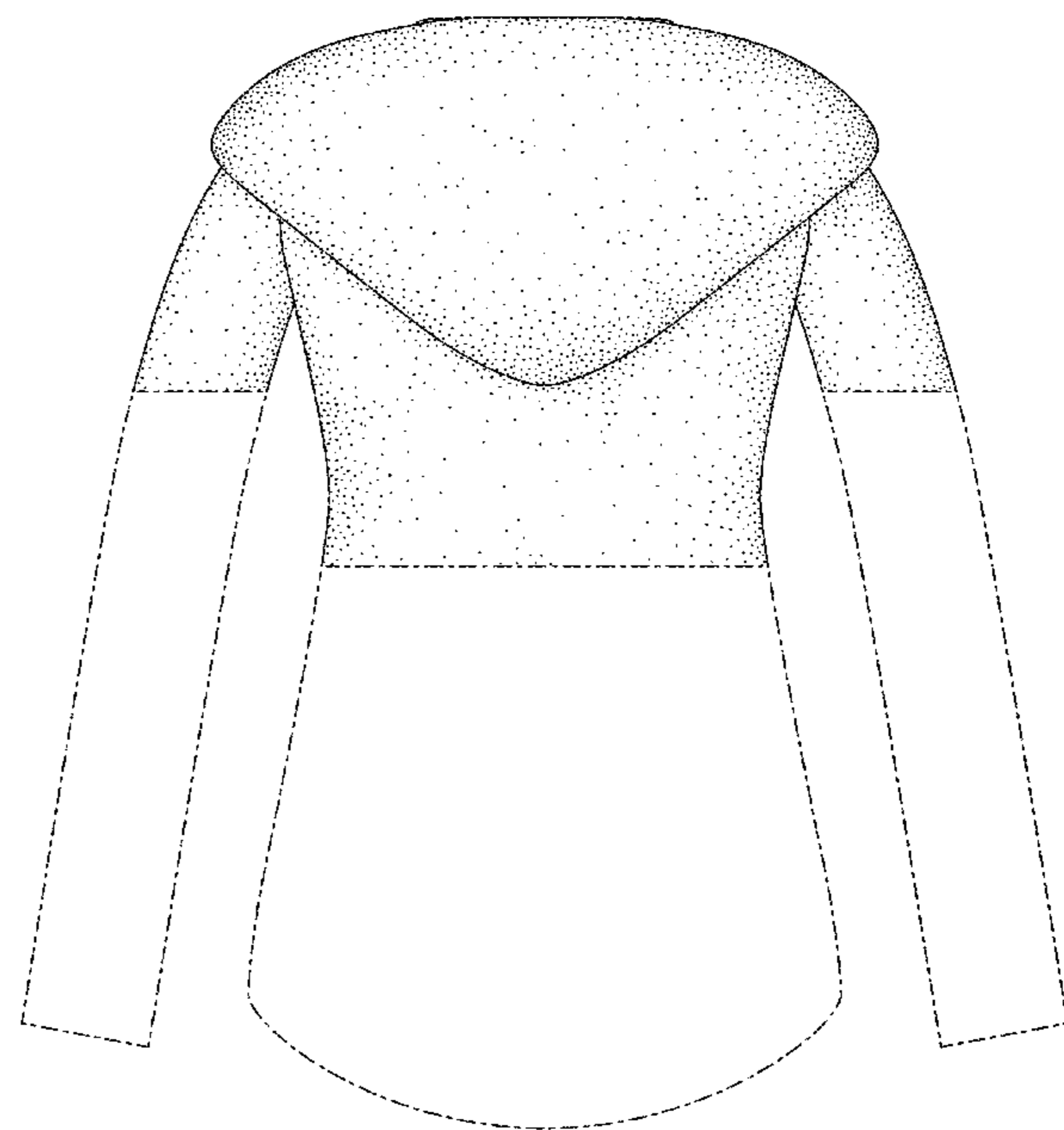
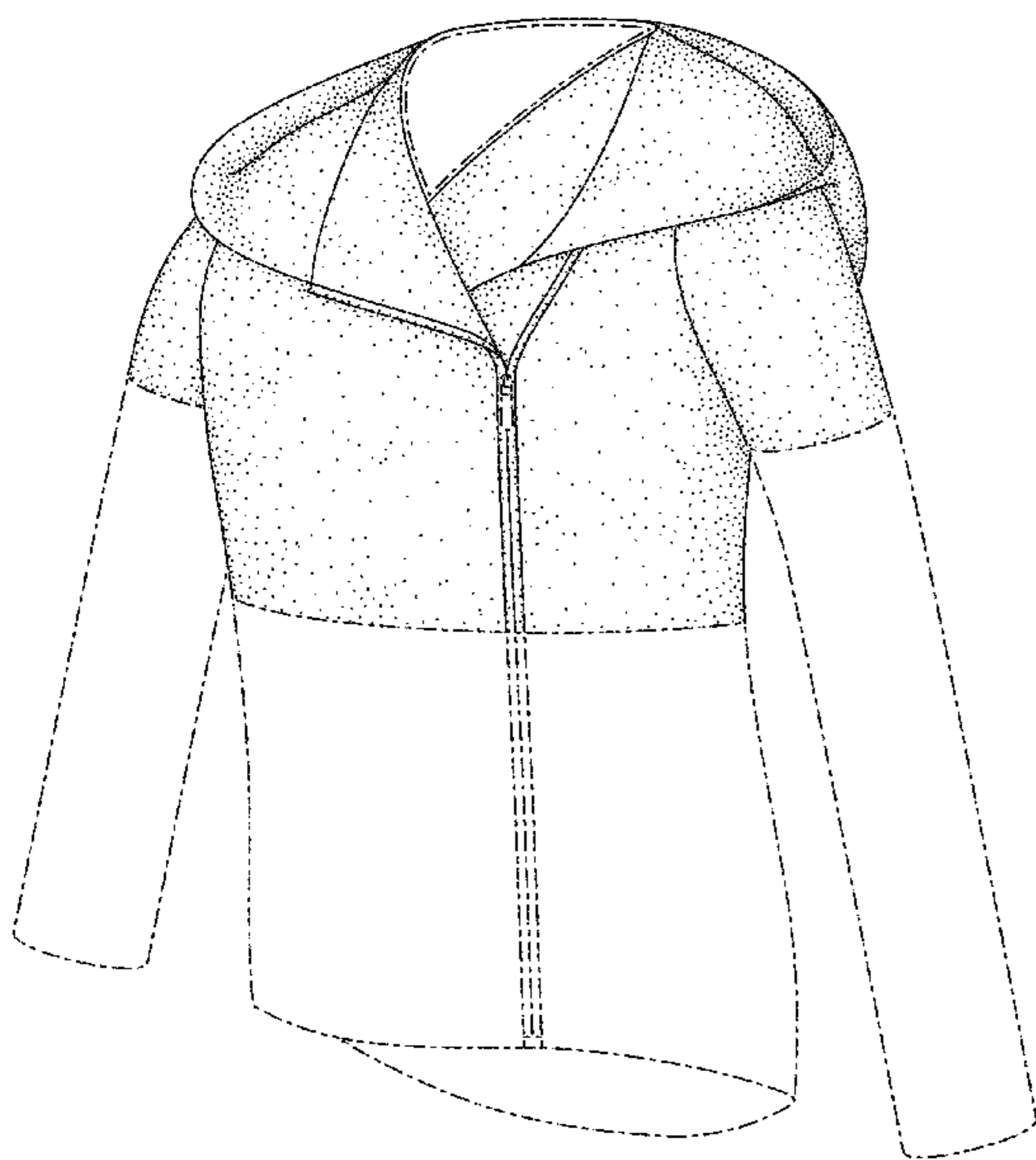
The ornamental design for a hooded garment, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a hooded garment showing our new design in an in-use configuration; FIG. 2 is a front left perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right side view thereof; and, FIG. 6 is a left side view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded regions, demarcated by broken lines, represent unclaimed portions of the hooded garment and form no part of the claimed design. the broken lines showing the remainder of the hooded garment are for environmental purposes only and form no part of the claimed design.

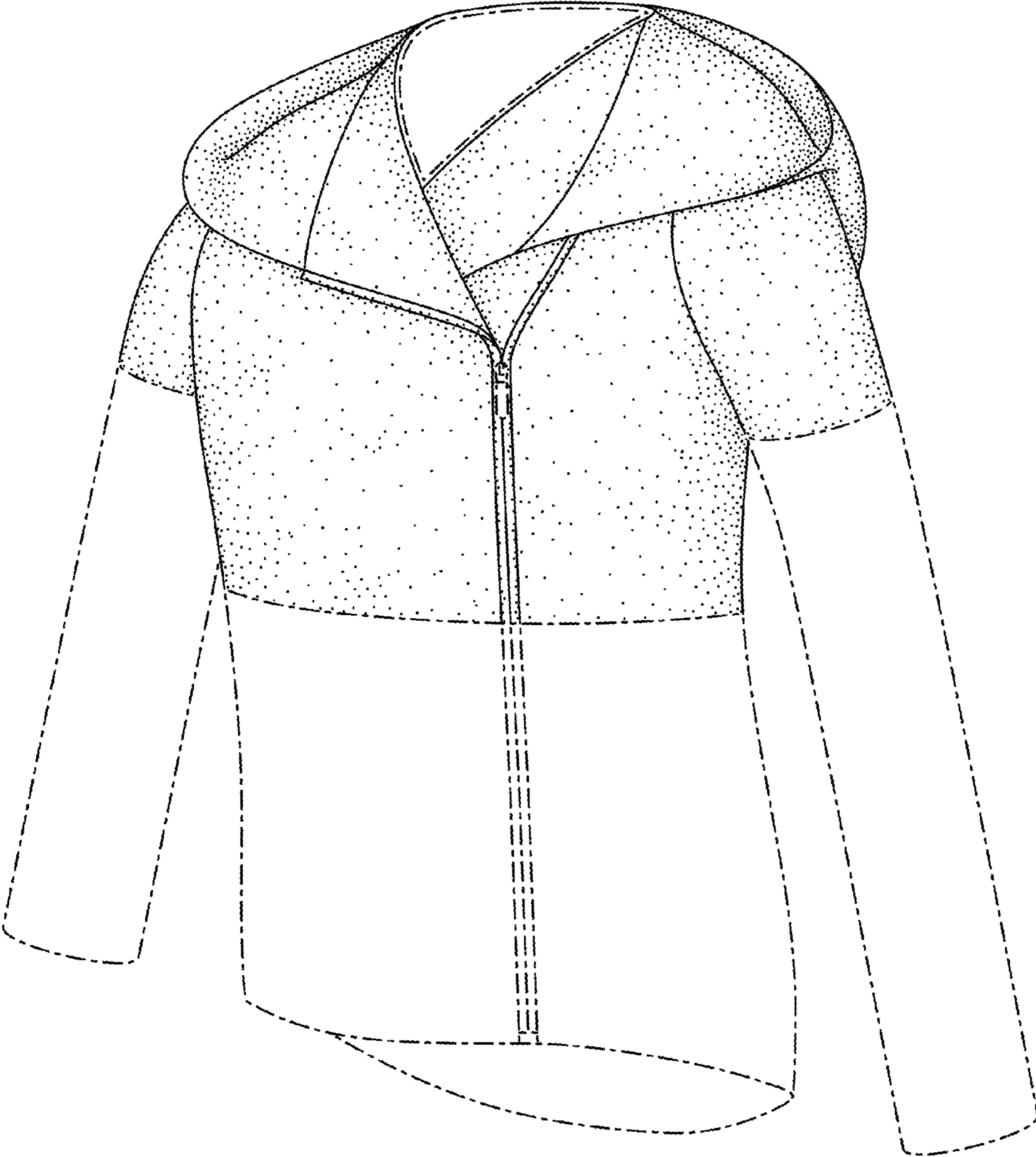

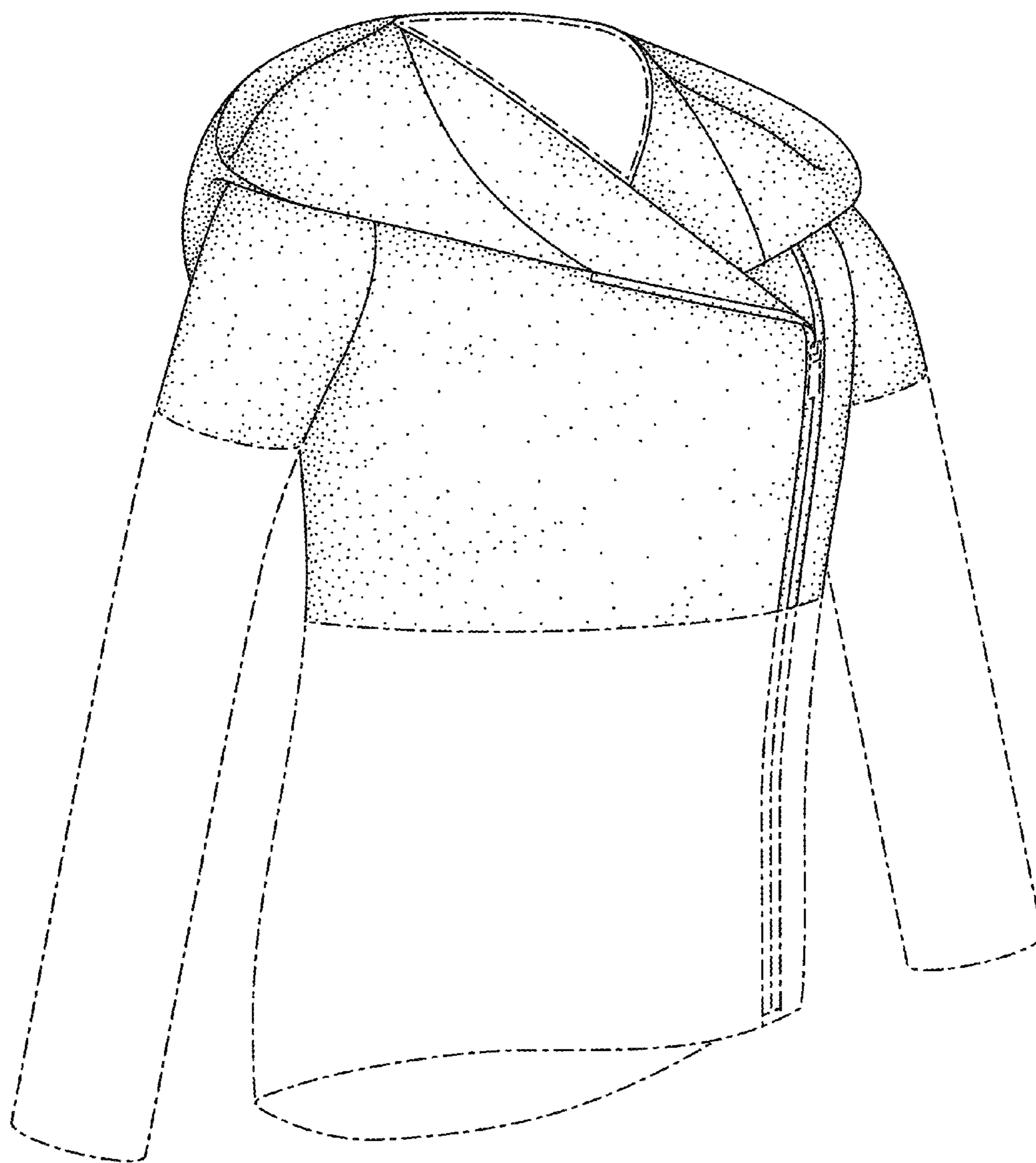

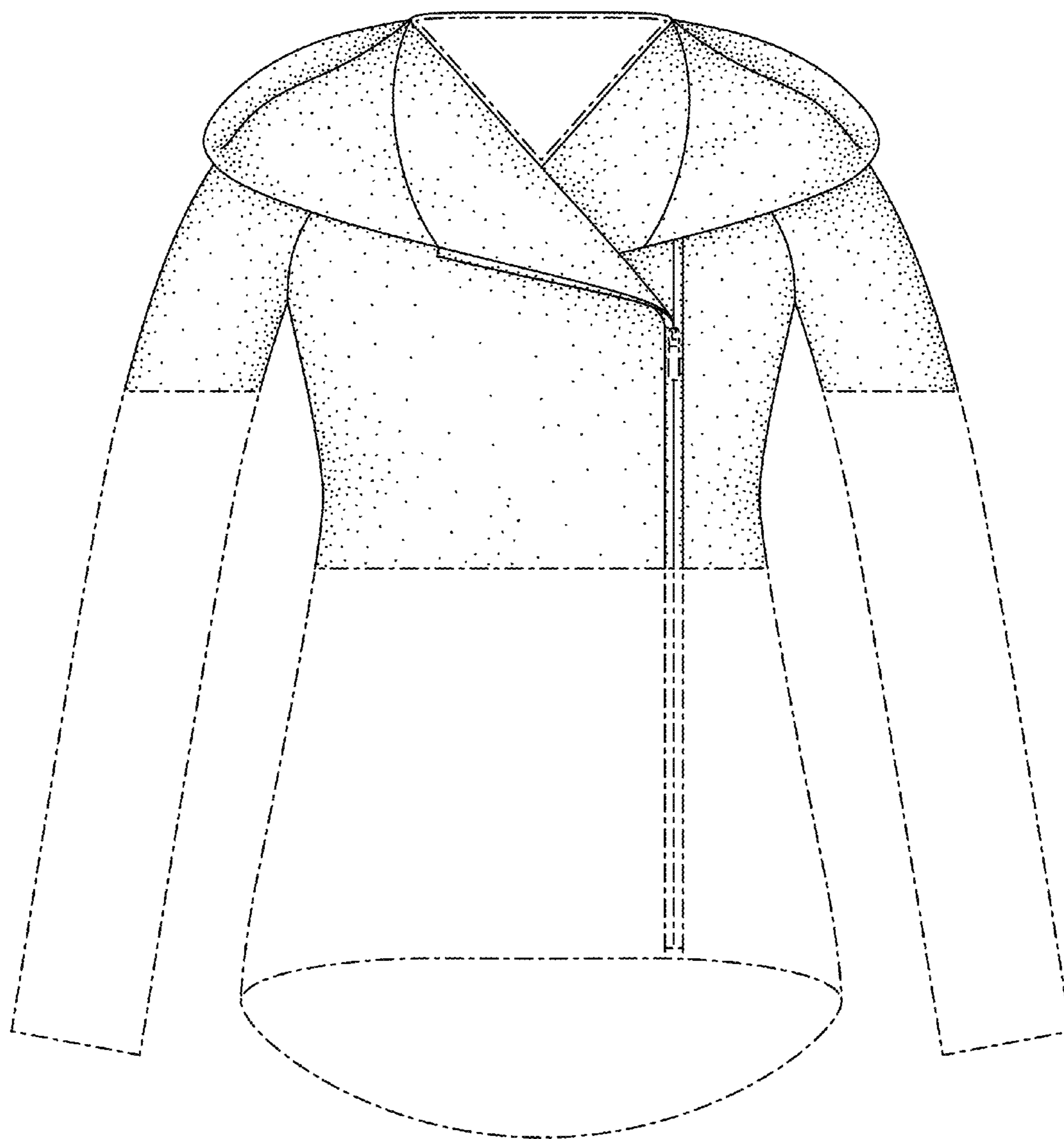

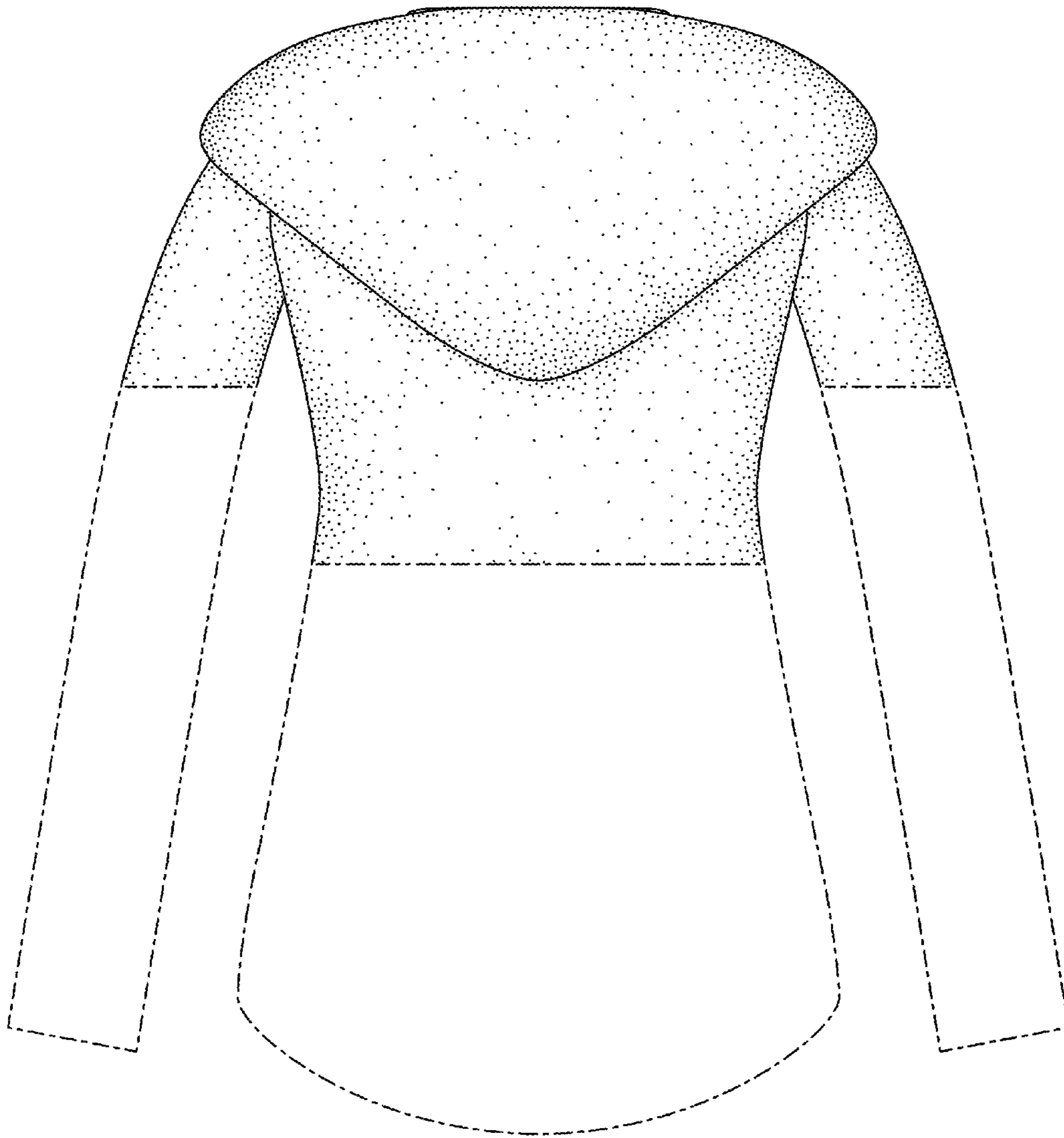

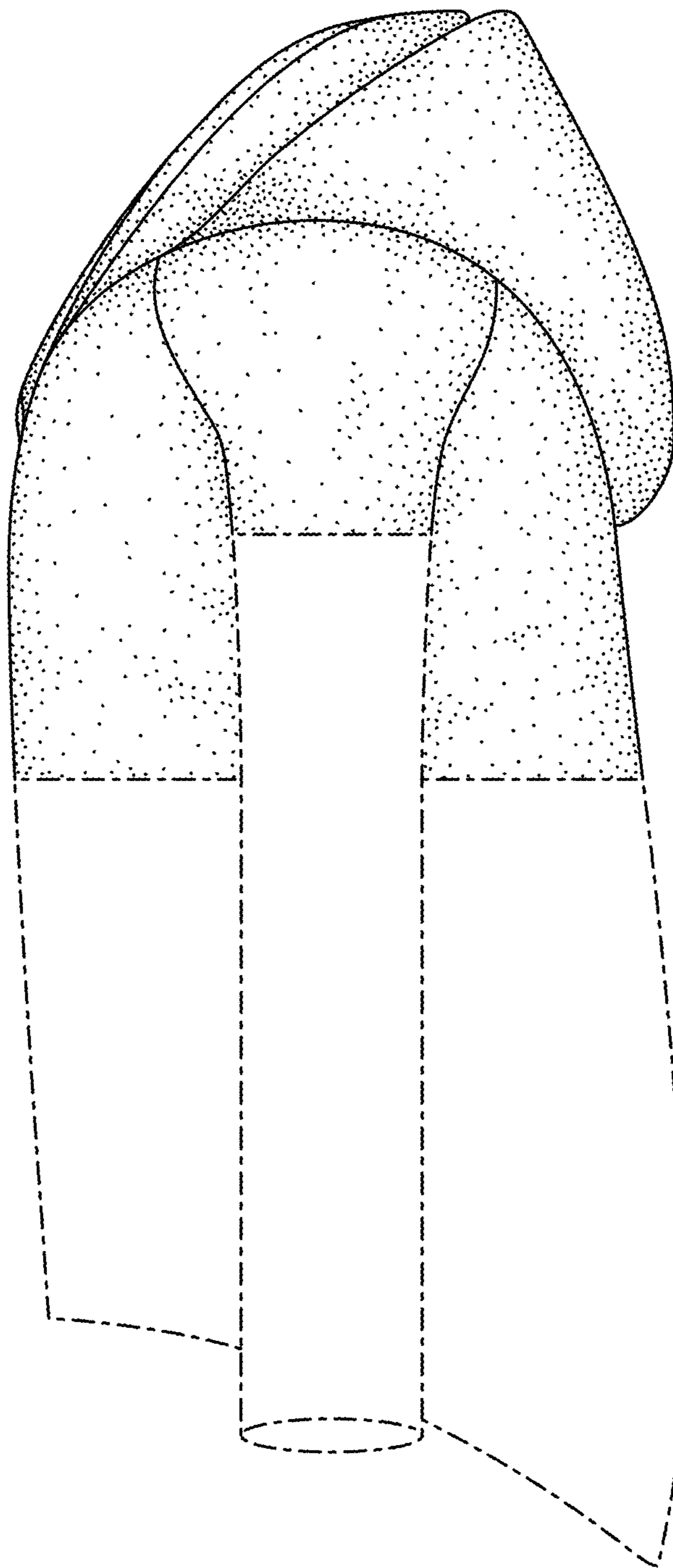

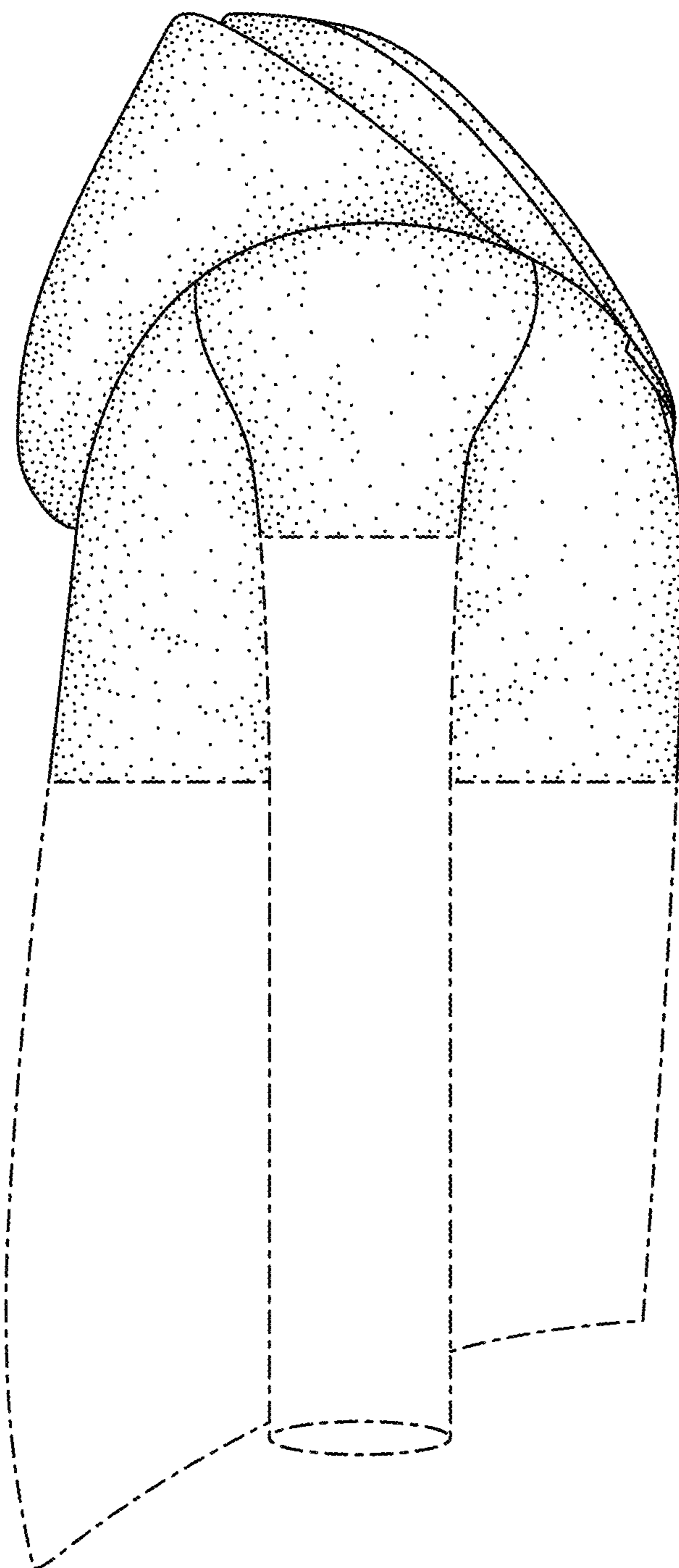
