(57) **CLAIM**

The ornamental design for a golf shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a golf shoe showing our new design;

FIG. 2 is a lateral side elevation view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a medial side elevation view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevation view thereof; and,

FIG. 7 is a front elevation view thereof.

The broken line portions of FIGS. 1, 2, and 4-7 are included to show unclaimed subject matter only and form no part of the claimed design.

The heavy weight white and light black broken lines on the shoe in FIGS. 1-7 are included to show claimed stitching on the article.

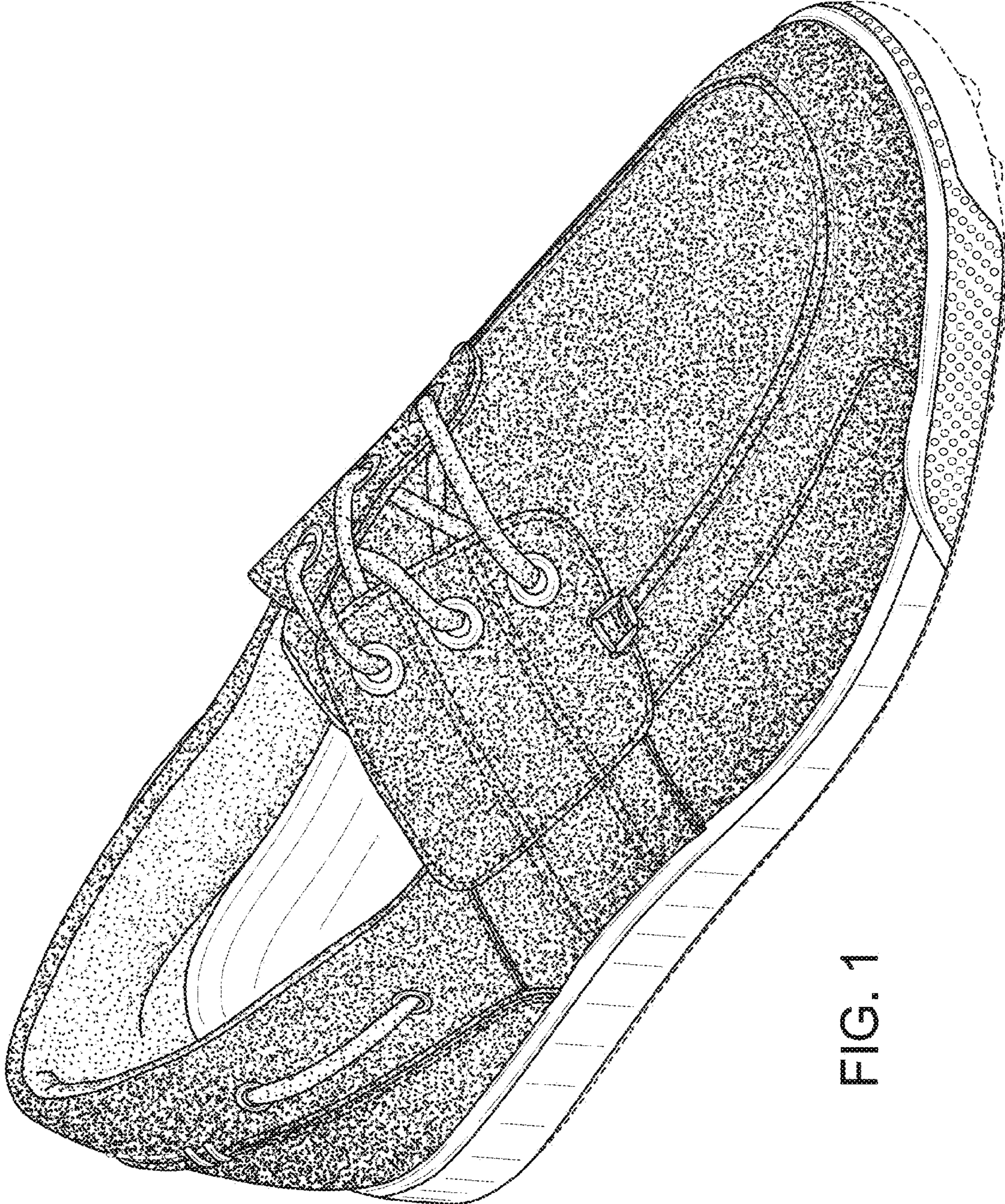

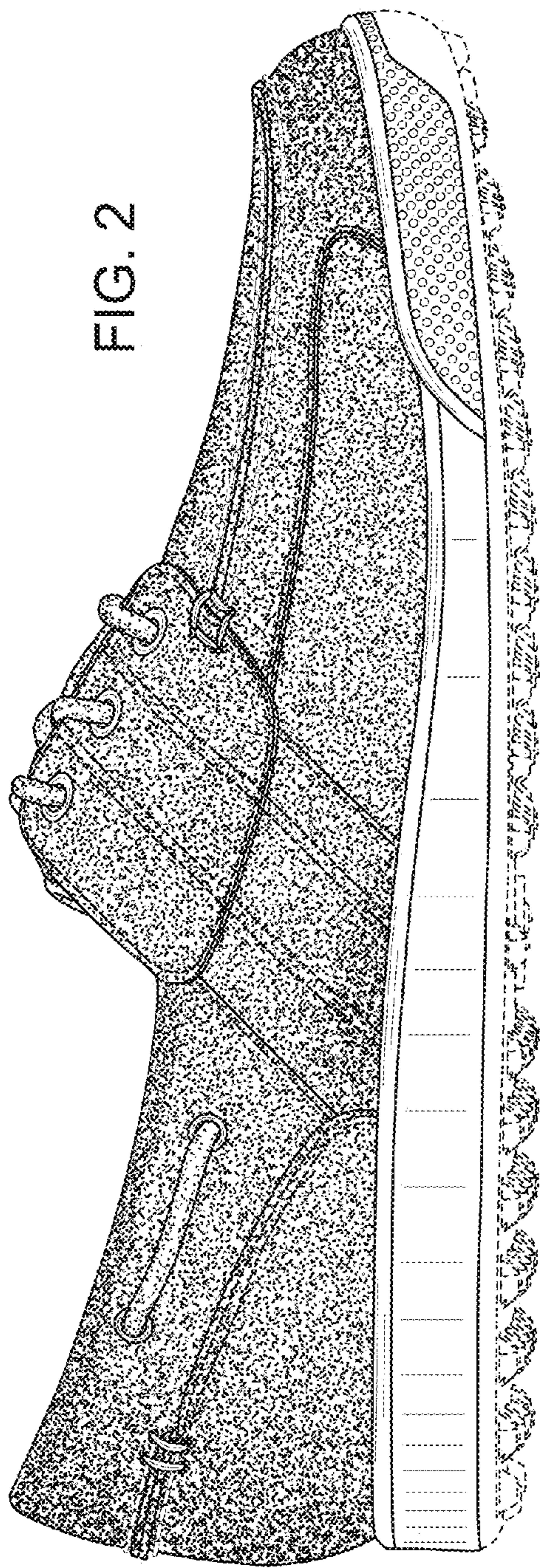
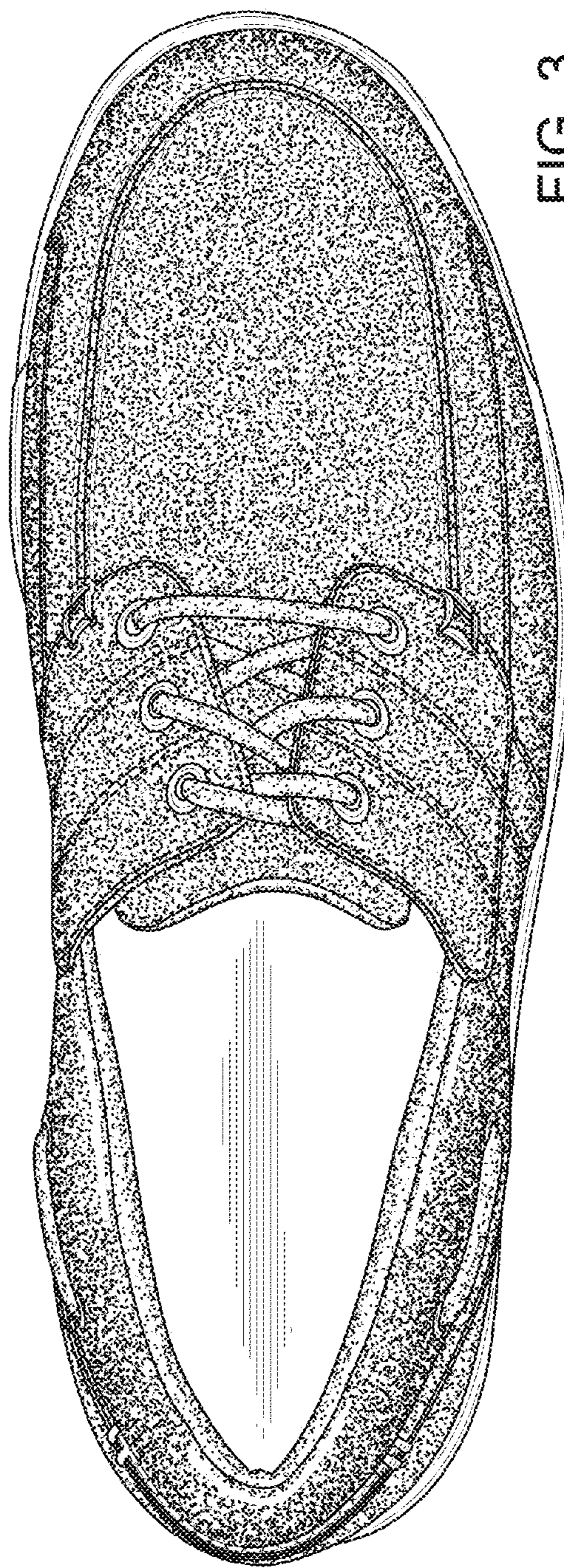

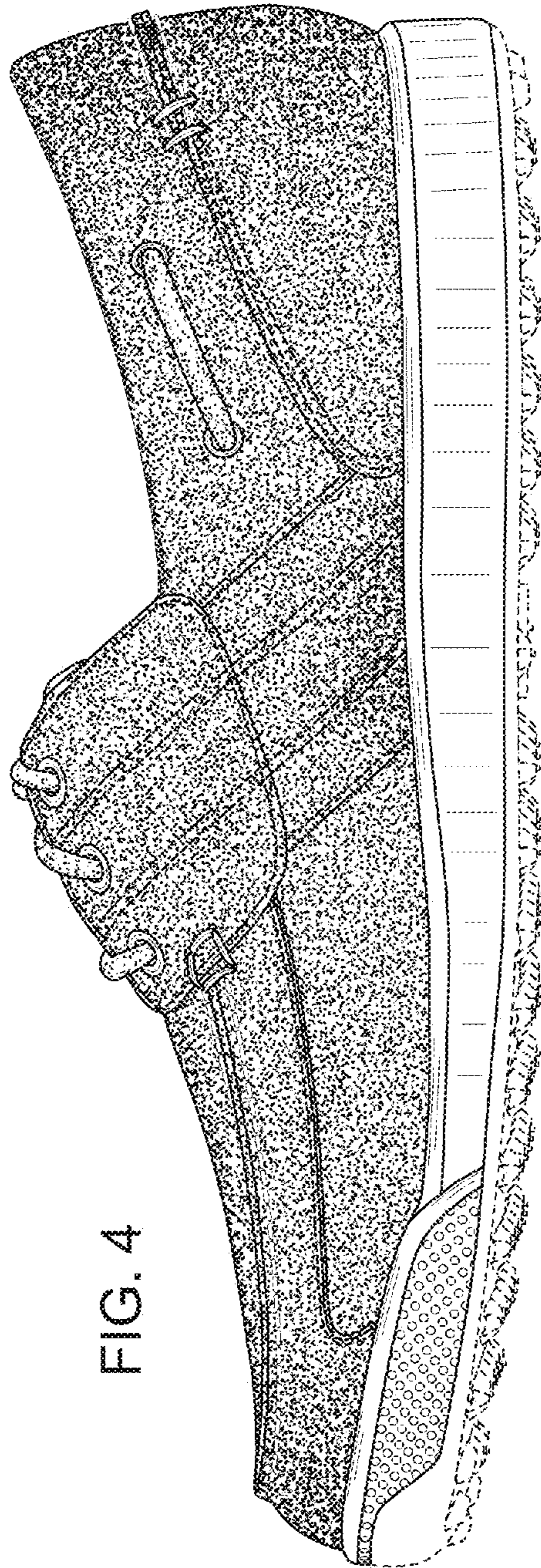

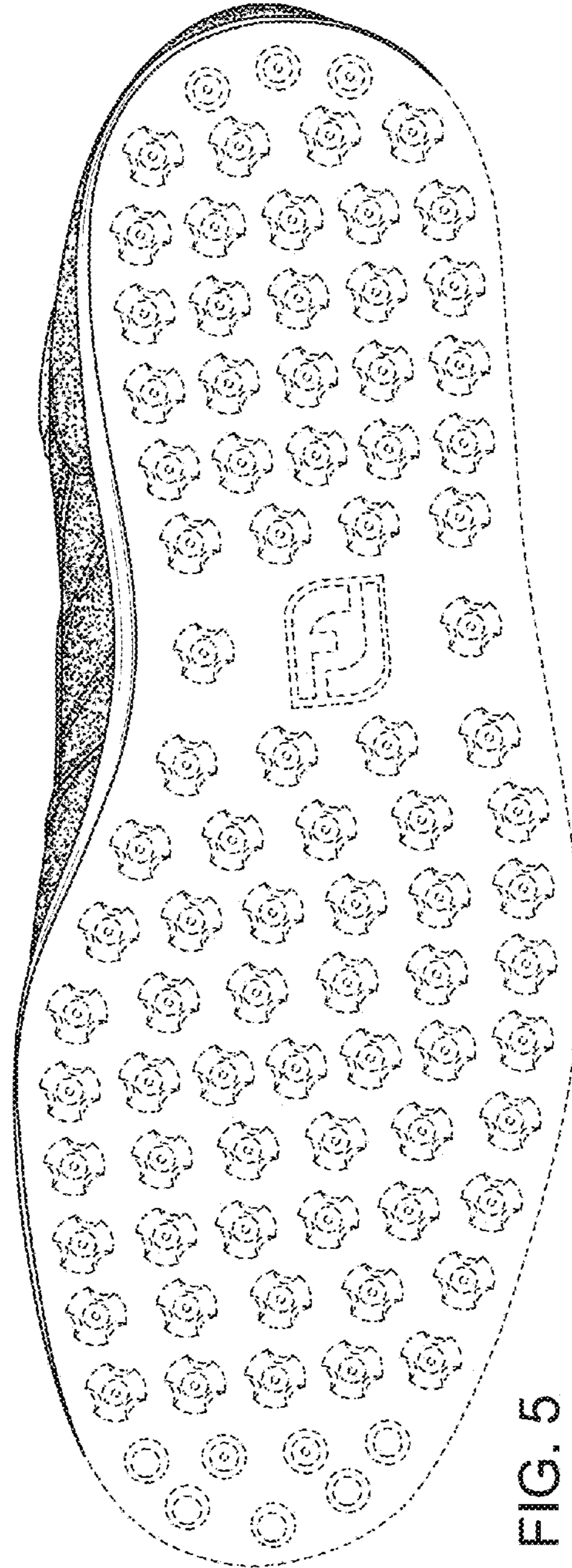

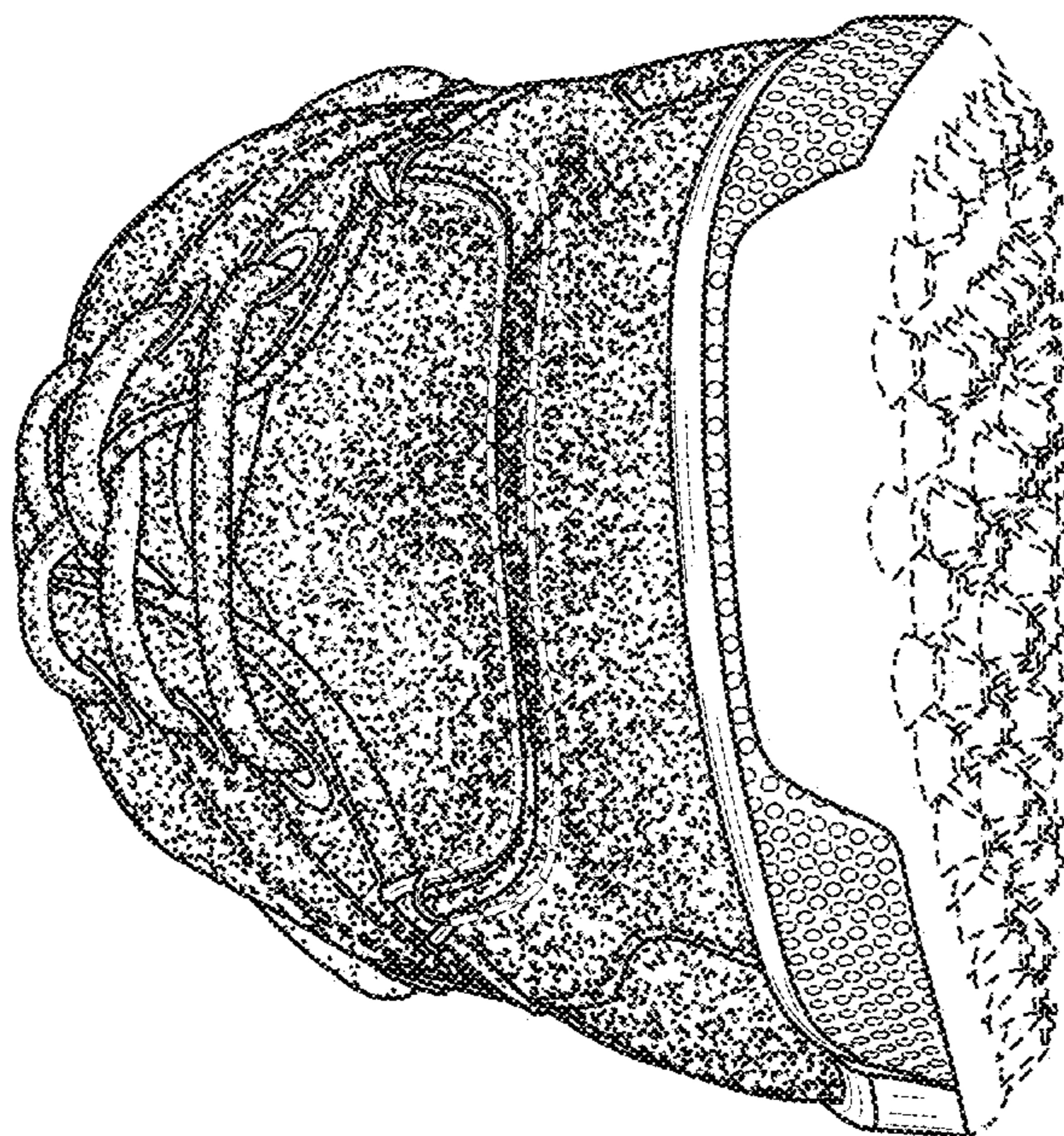

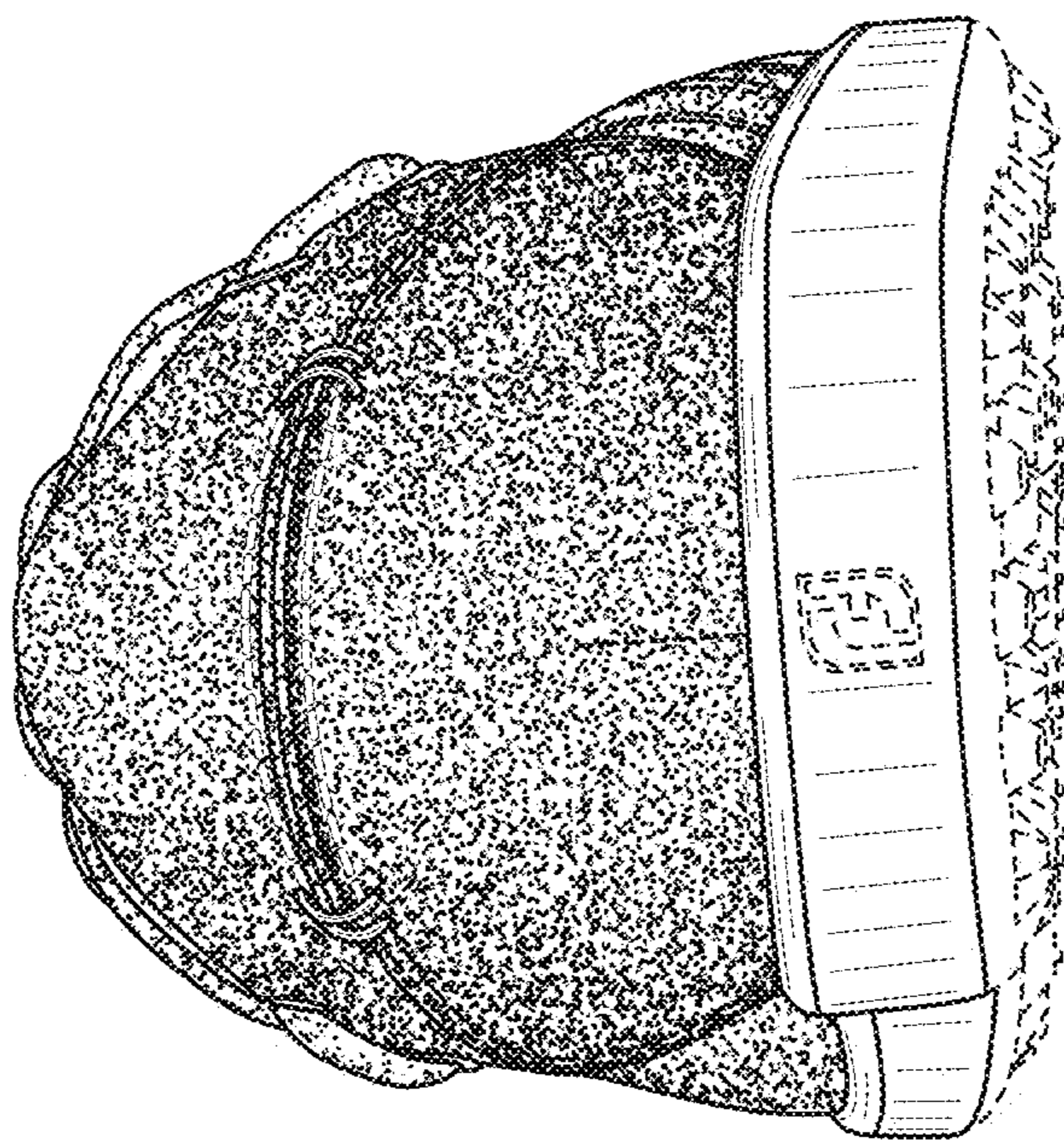
