FIG. 4 is a back elevation view thereof;

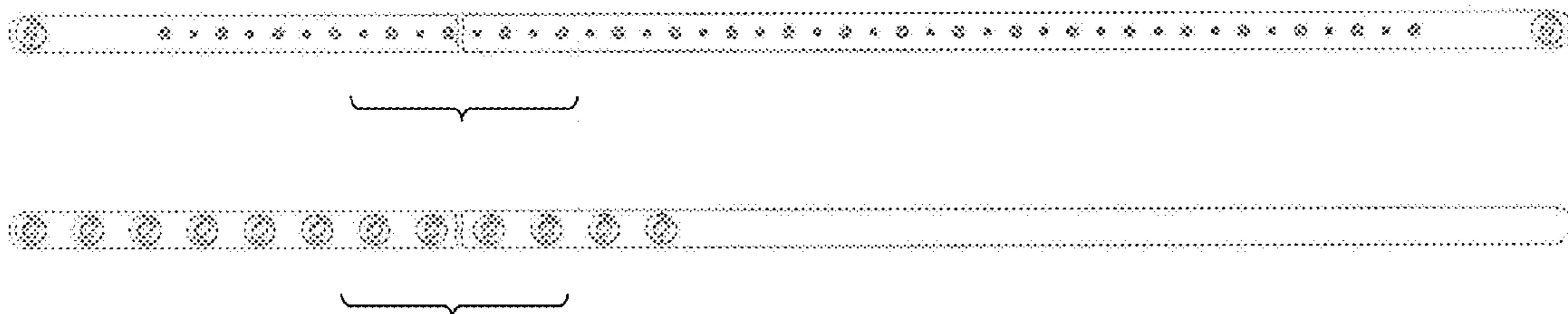
FIG. 5 is a left side elevation view thereof;

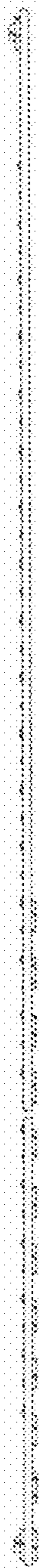

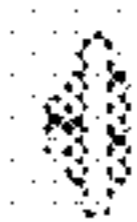


FIG. 5 FIG. 6

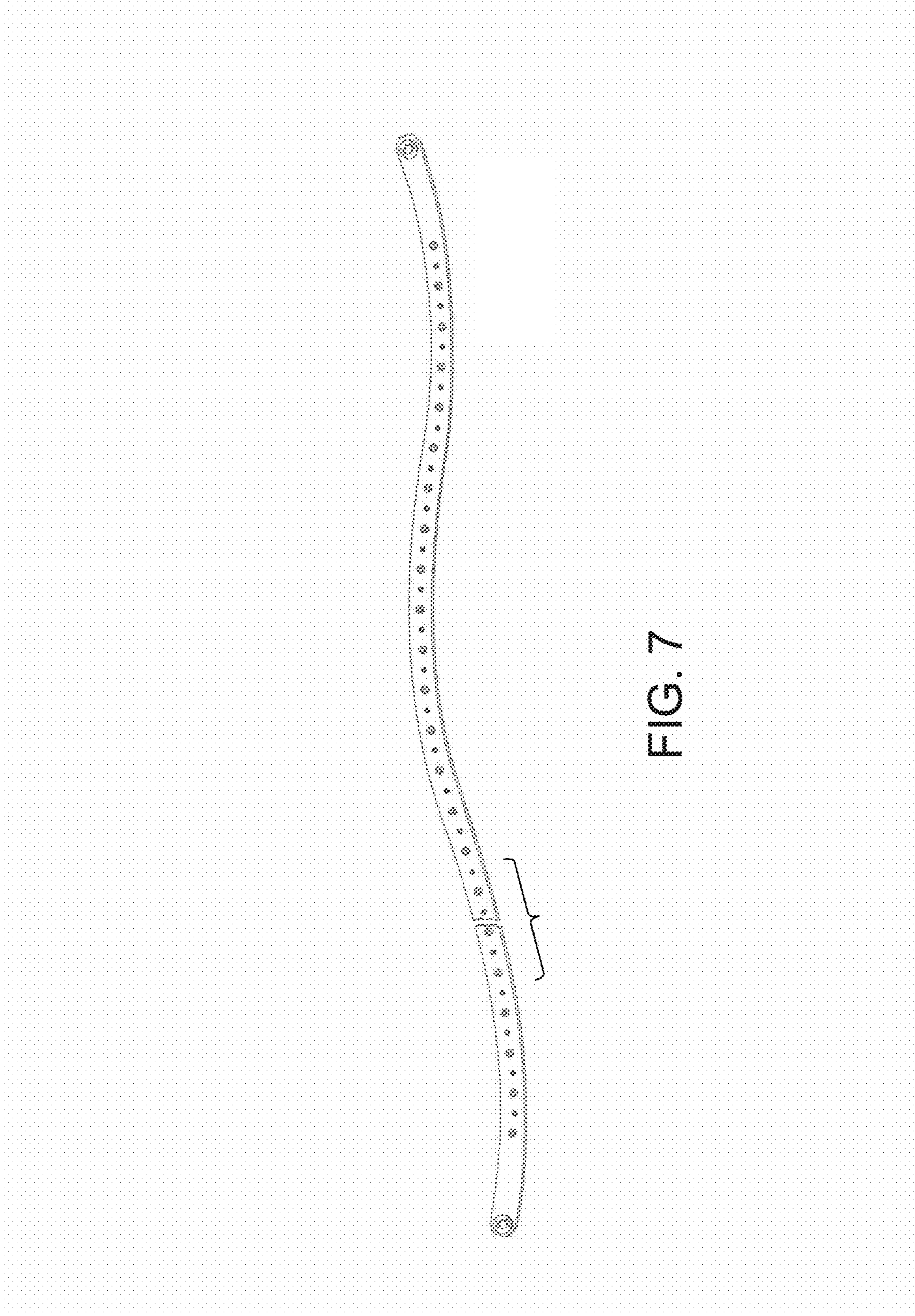
