(57) **CLAIM**

The ornamental design for a personal accessory holder, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom, and side perspective view of a personal accessory holder in a first position embodying our new design.

FIG. 2 is a front view thereof.

FIG. 3 is a rear view thereof.

FIG. 4 is a first side view thereof.

FIG. 5 is a second side view thereof.

FIG. 6 is a top view thereof.

FIG. 7 is a bottom view thereof.

FIG. 8 is a front, bottom, and side perspective view of the personal accessory holder in a second position.

FIG. 9 is a front view thereof.

FIG. 10 is a rear view thereof.

FIG. 11 is a first side view thereof.

FIG. 12 is a second side view thereof.

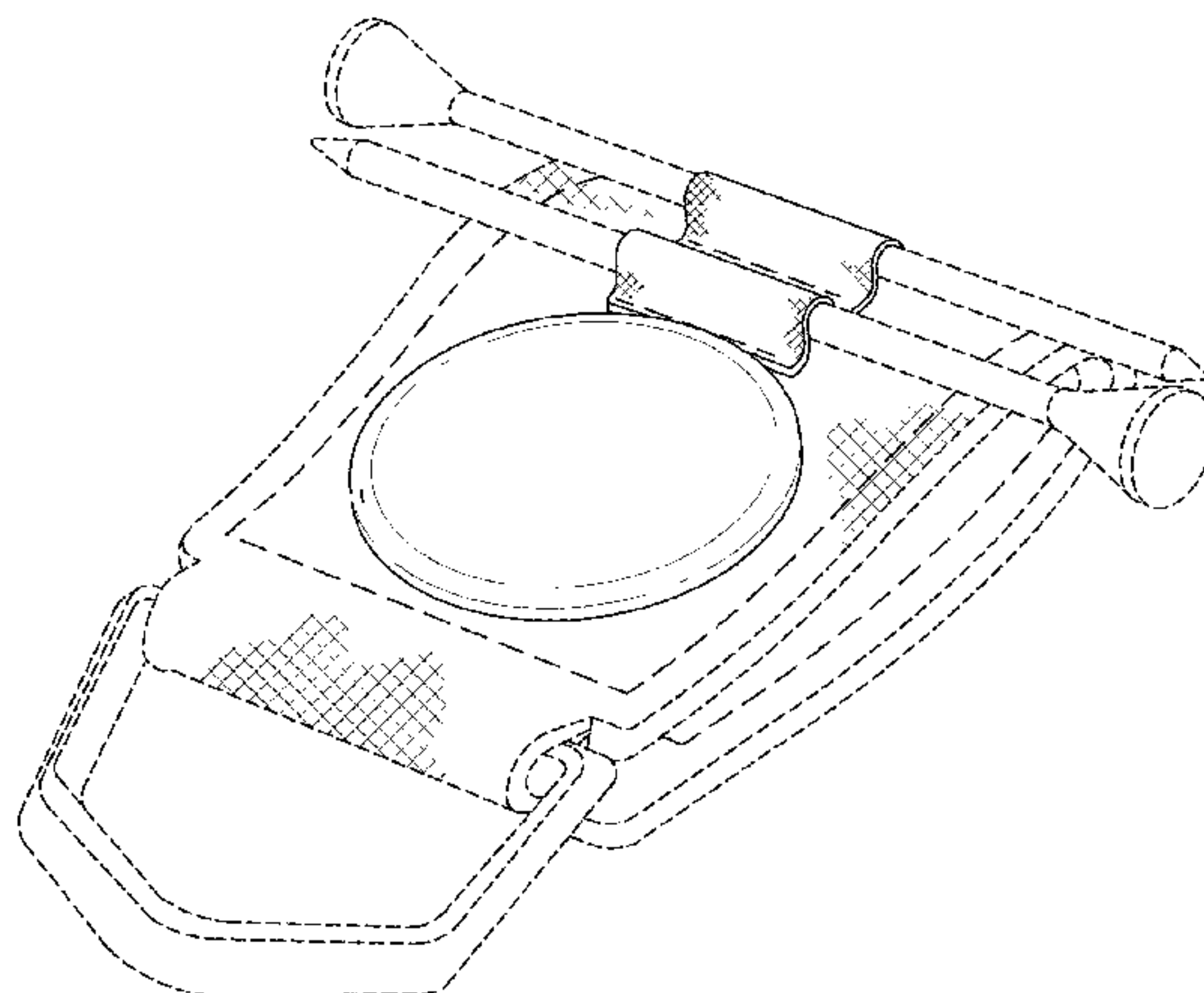
FIG. 13 is a top view thereof.

Broken lines are used to illustrate features of the personal accessory holder which form no part of the claimed design. Cross hatching lines are used to illustrate representative surface shading. Large broken lines illustrate stitching on the main body and golf tee holder which forms no part of the claimed design. The personal accessory hanger is shown in broken lines which form no part of the claimed design. Features on the back of the main body in the second position, including a magnetic clasp, are shown in broken lines which form no part of the claimed design of the second embodiment. The first position illustrates a typical in use orientation.

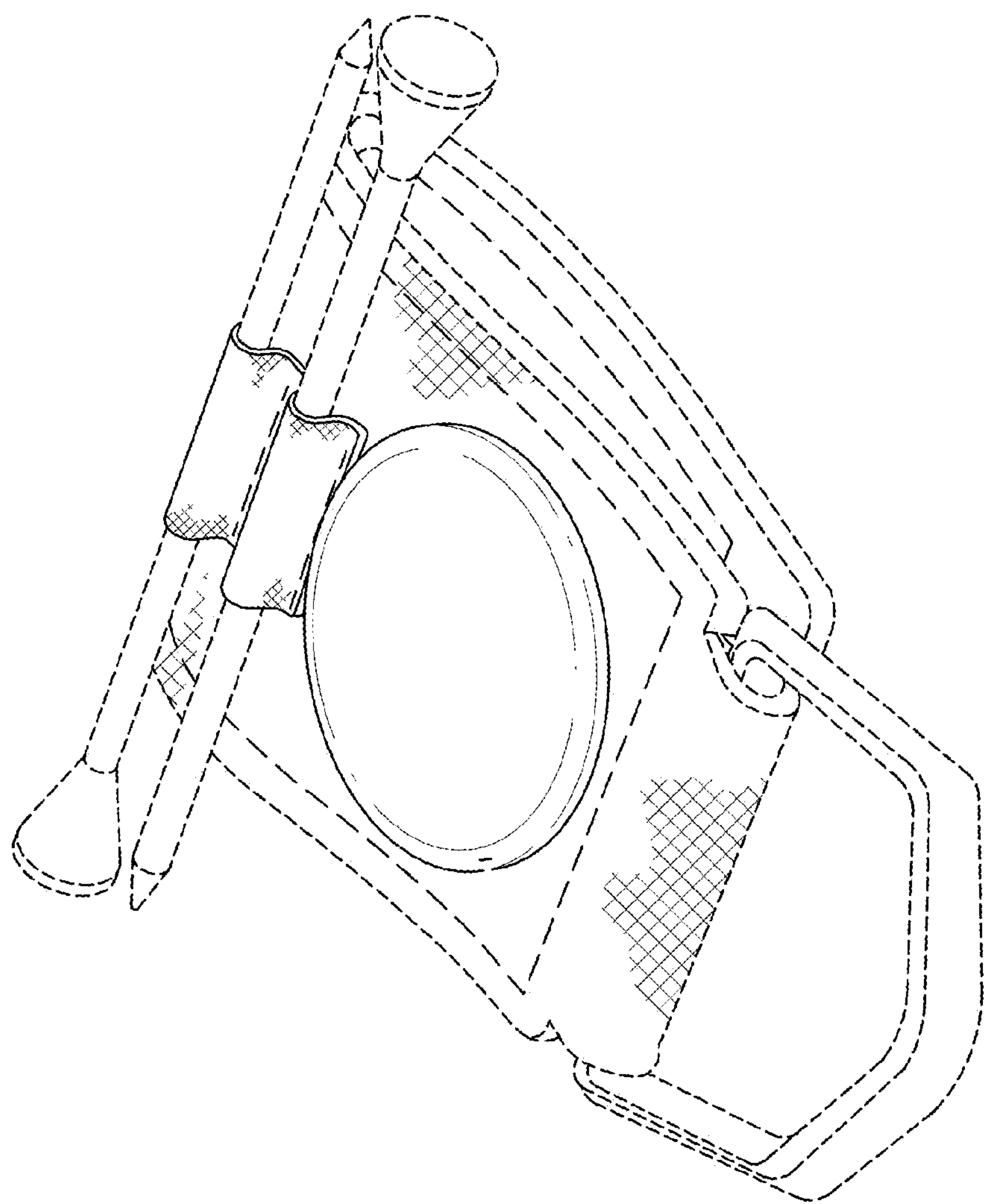

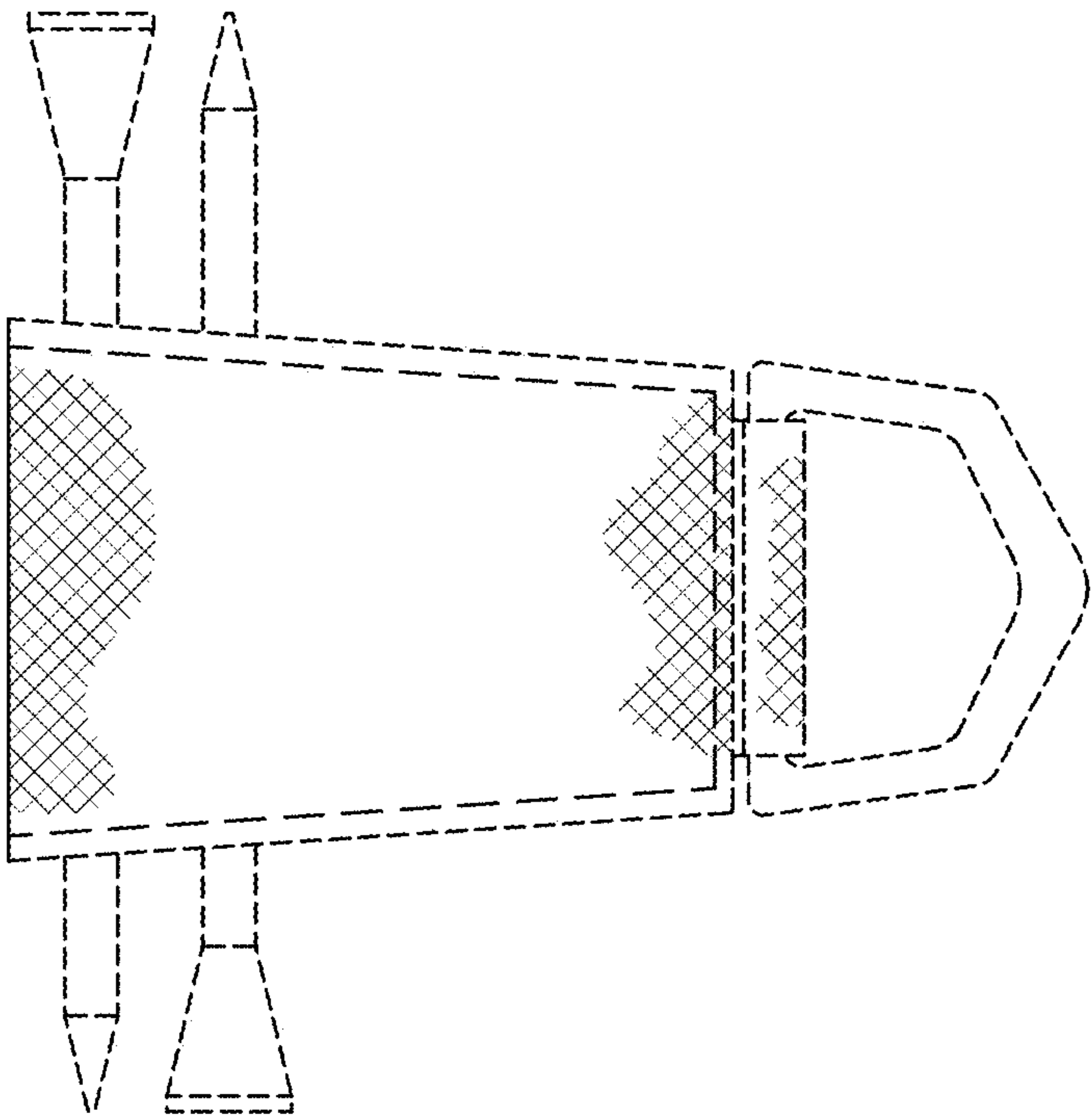

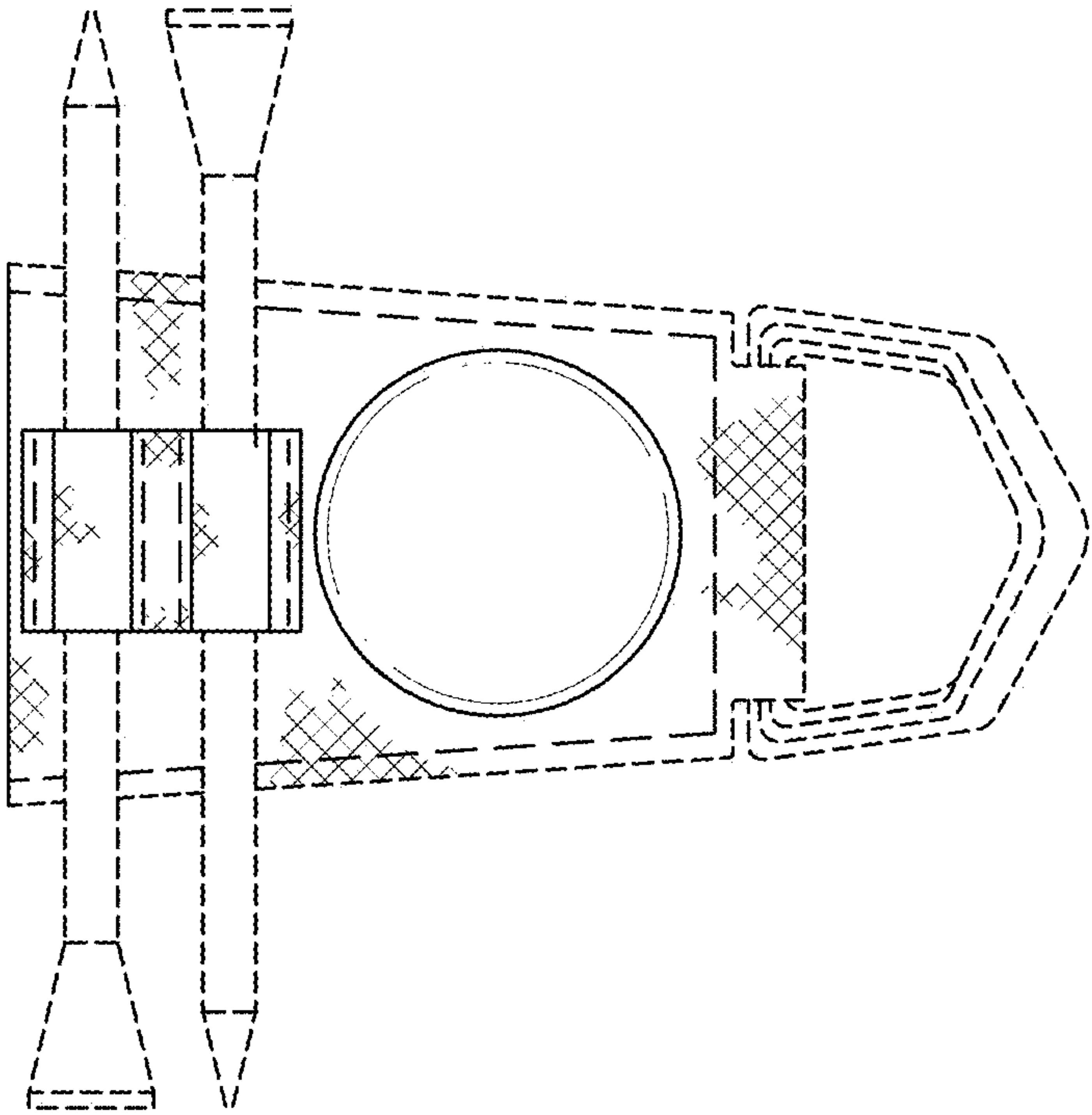

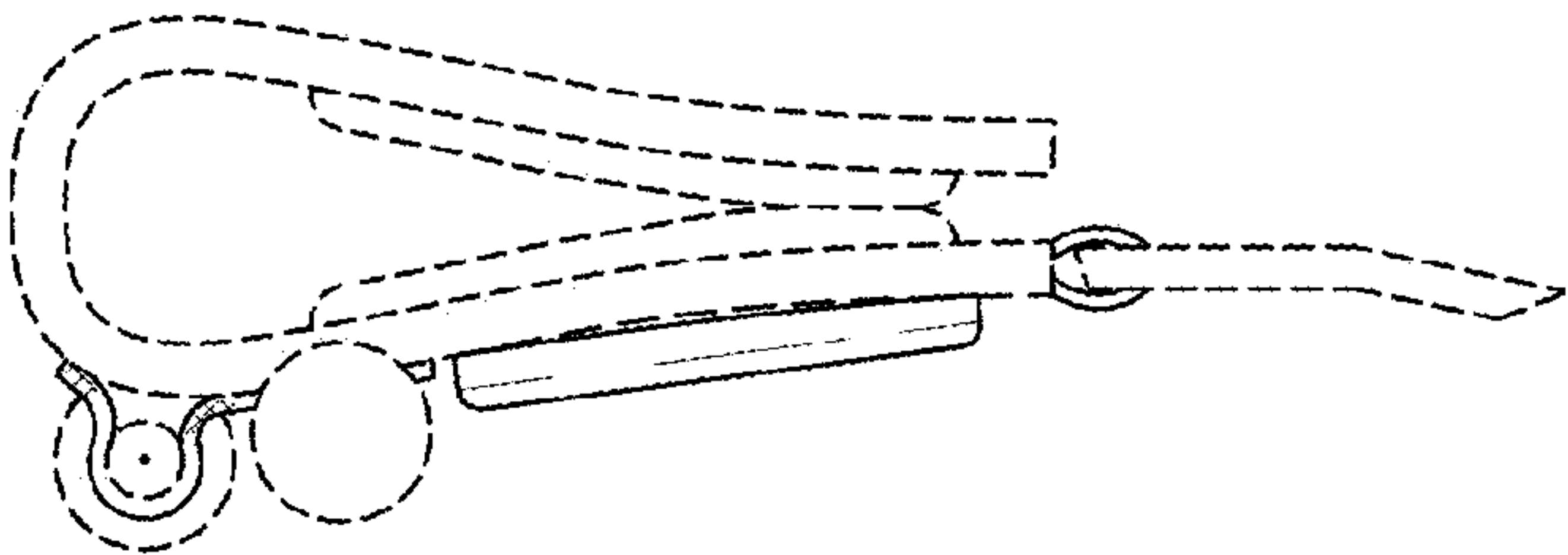

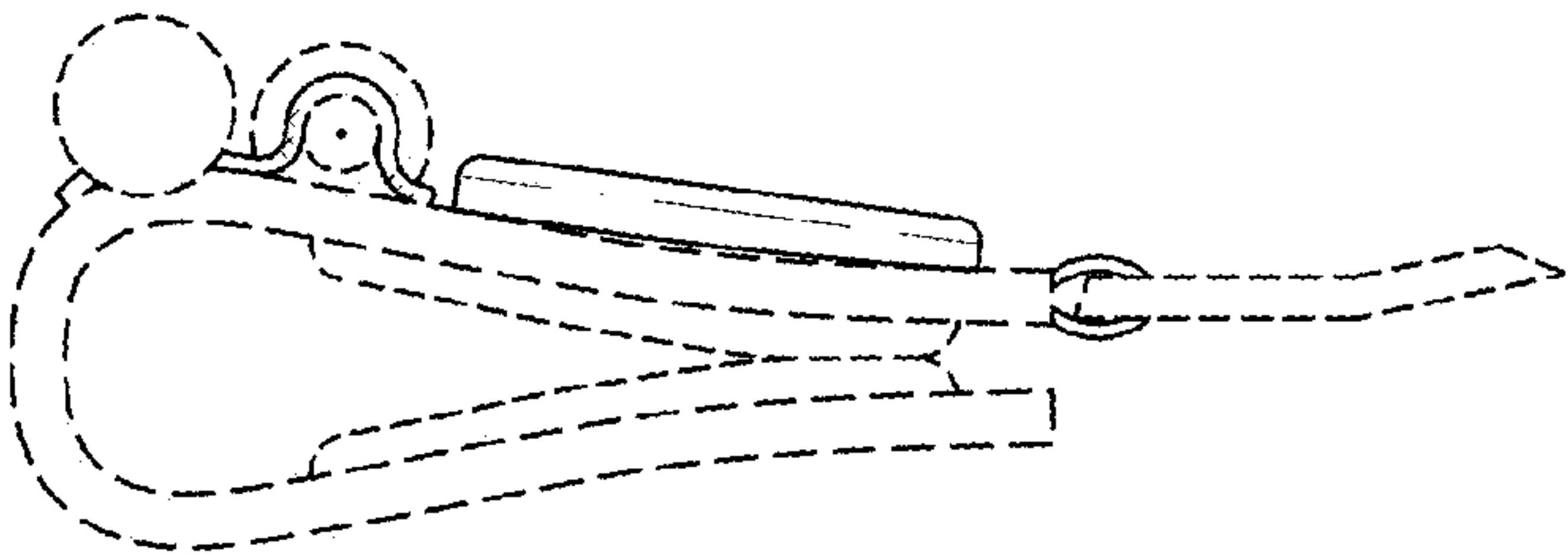

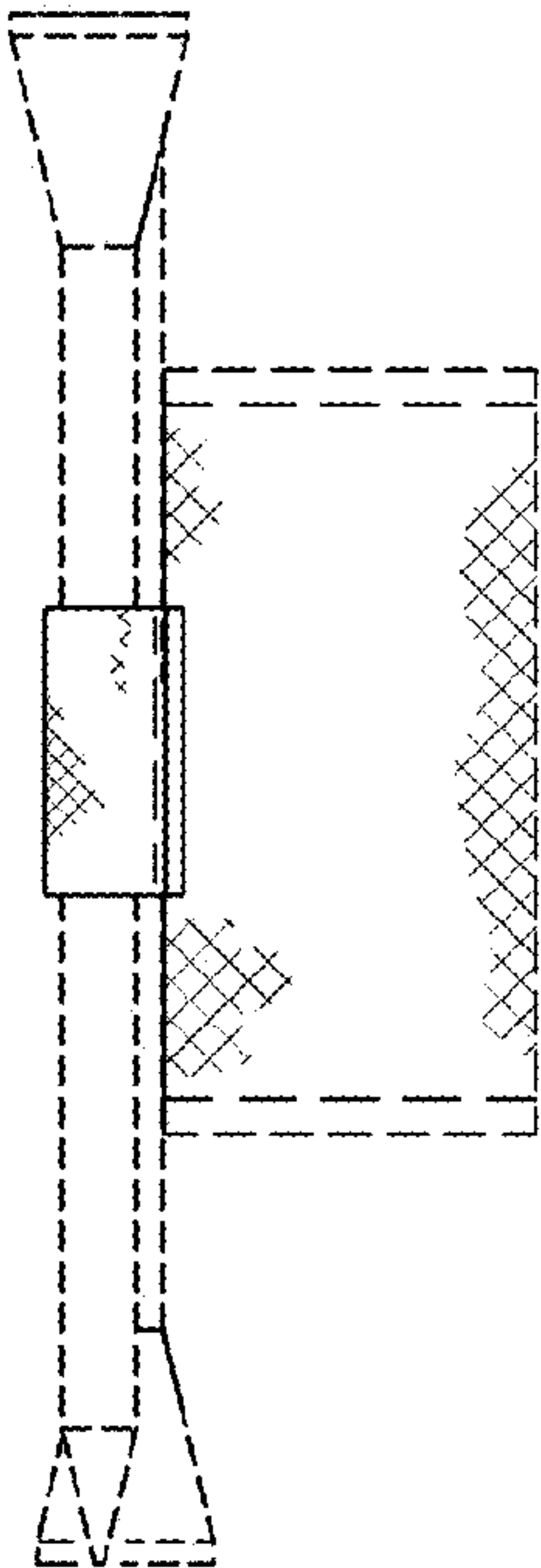

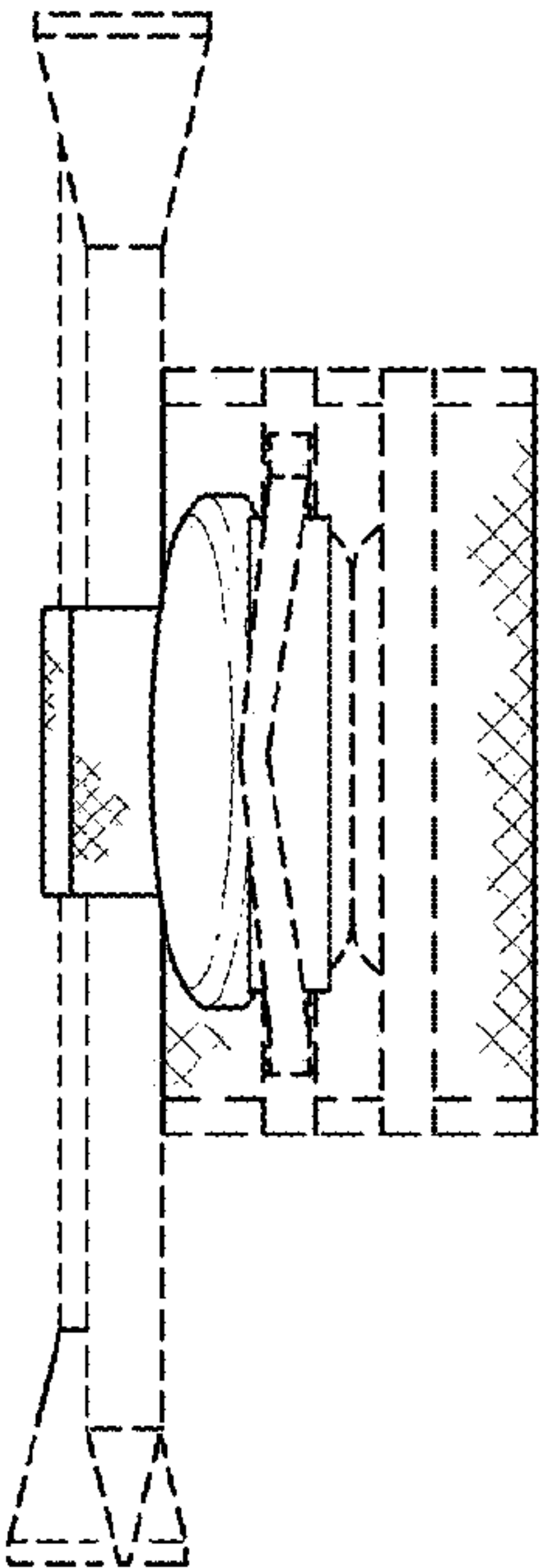

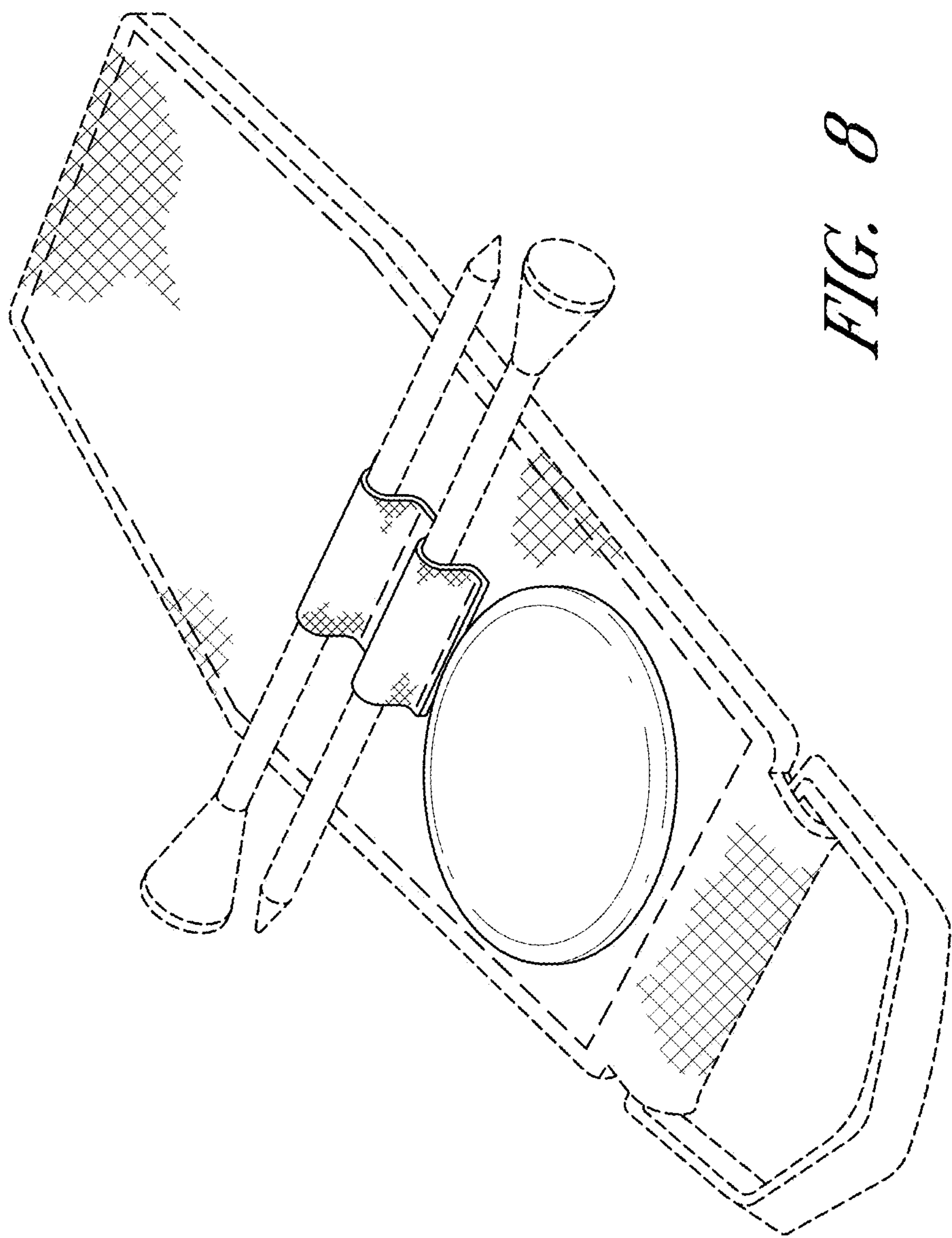

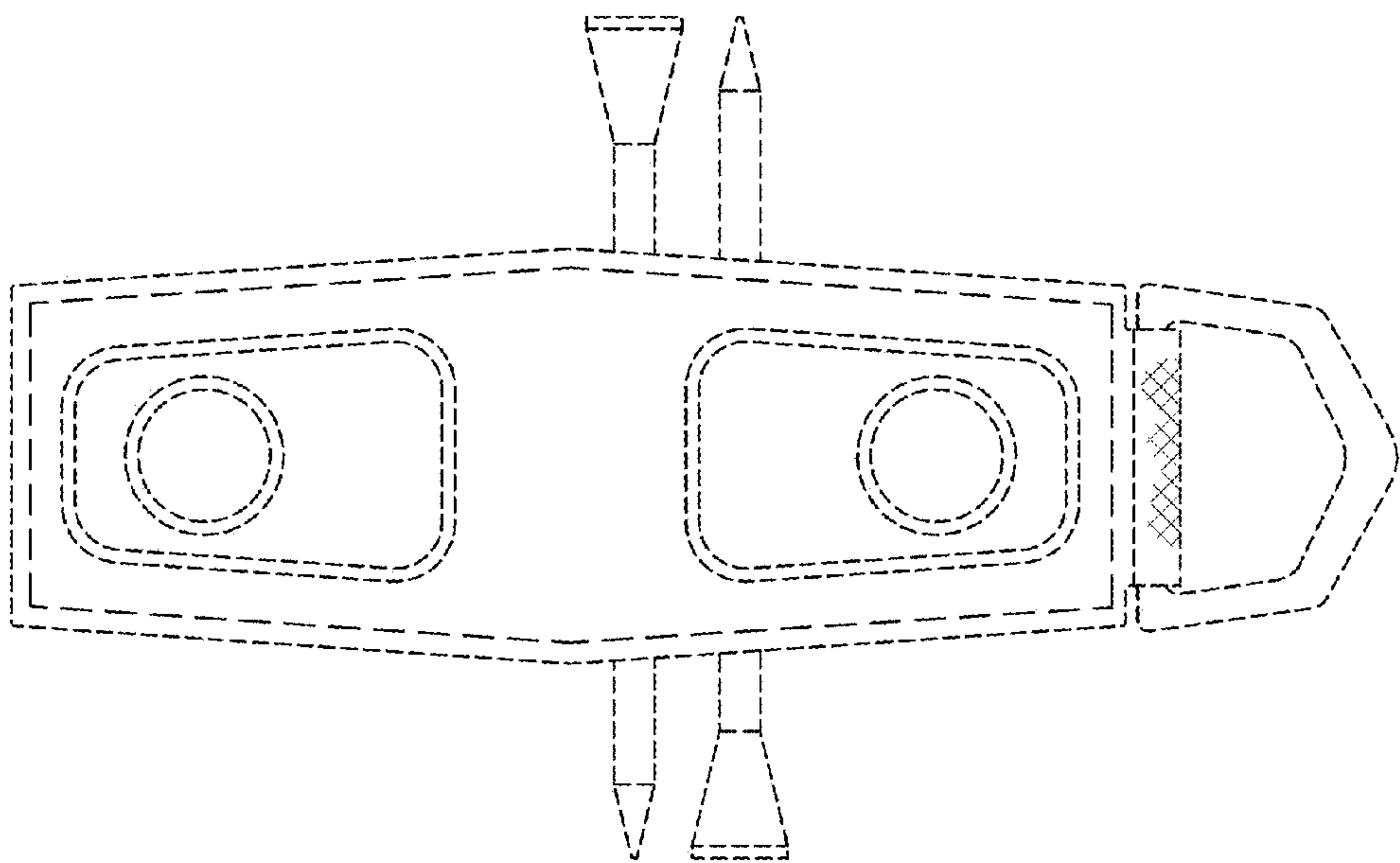

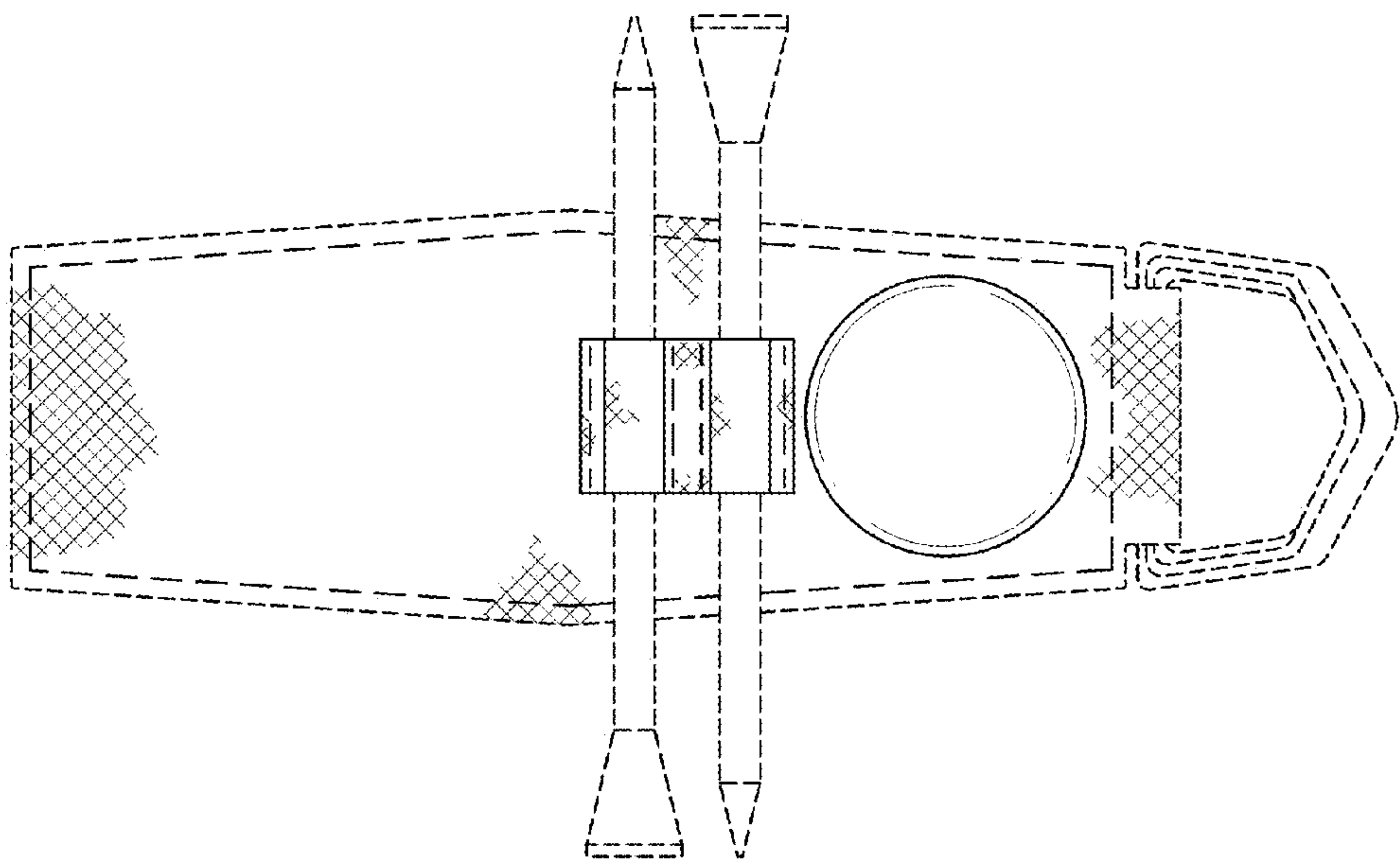
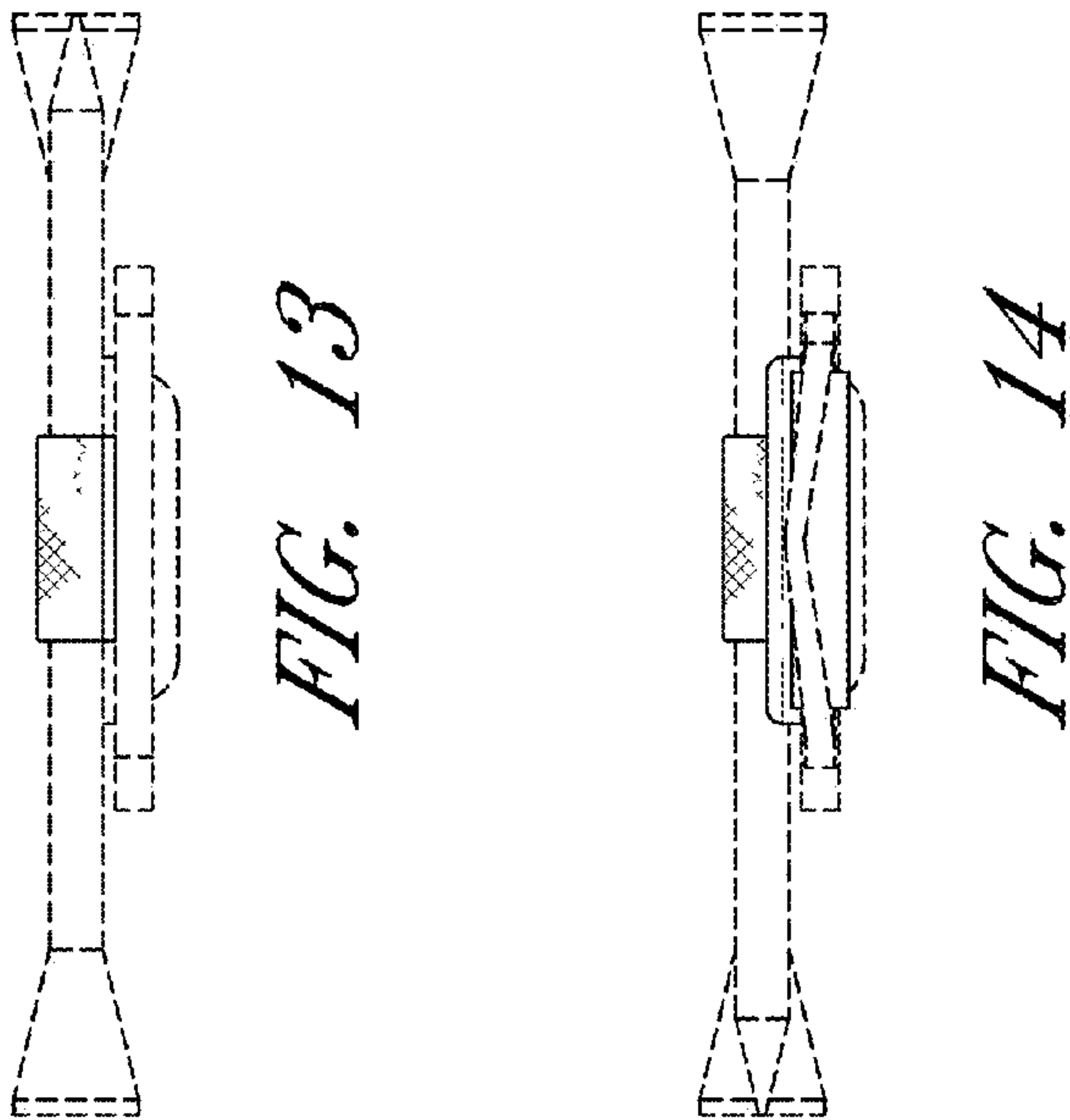
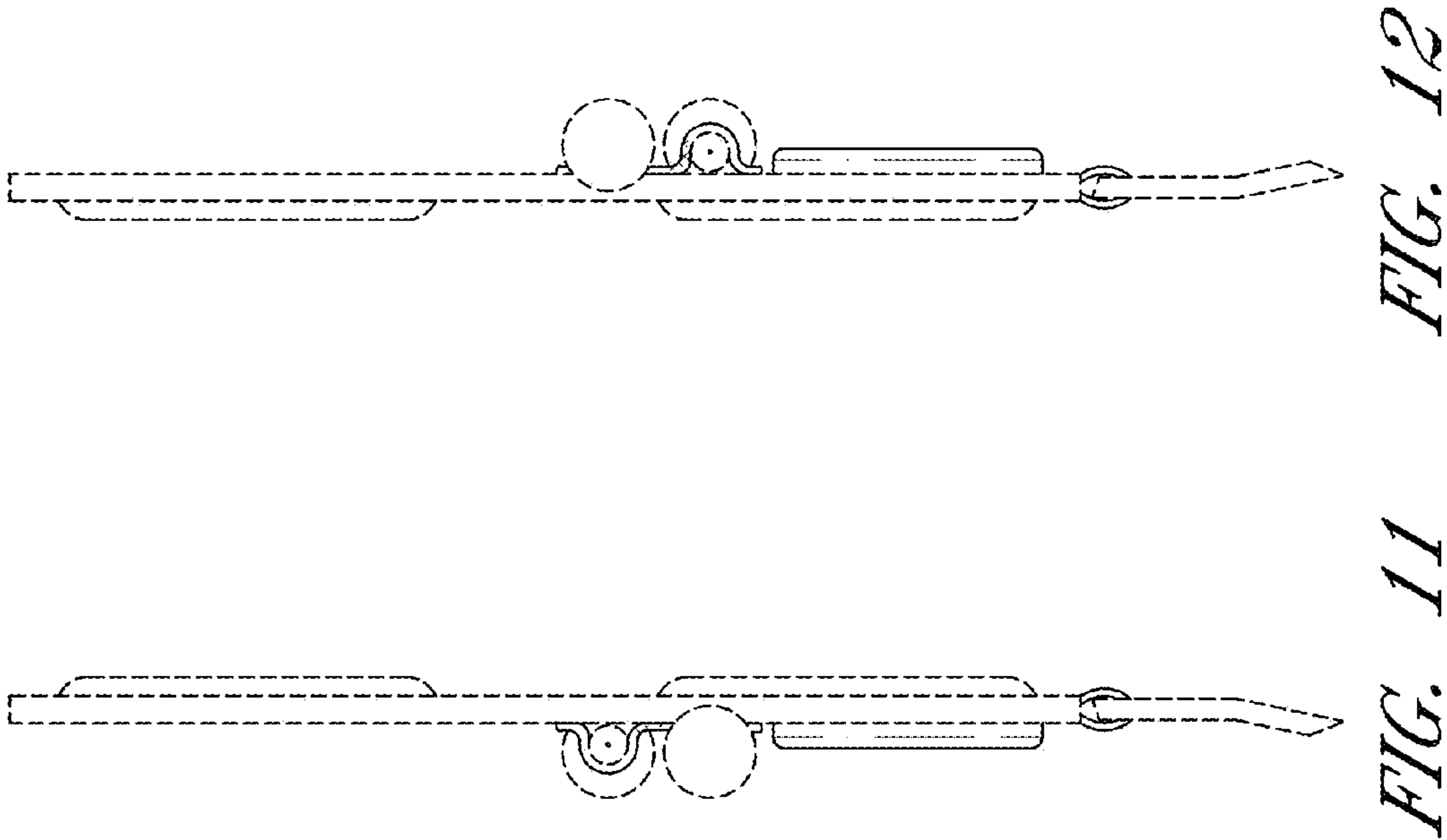

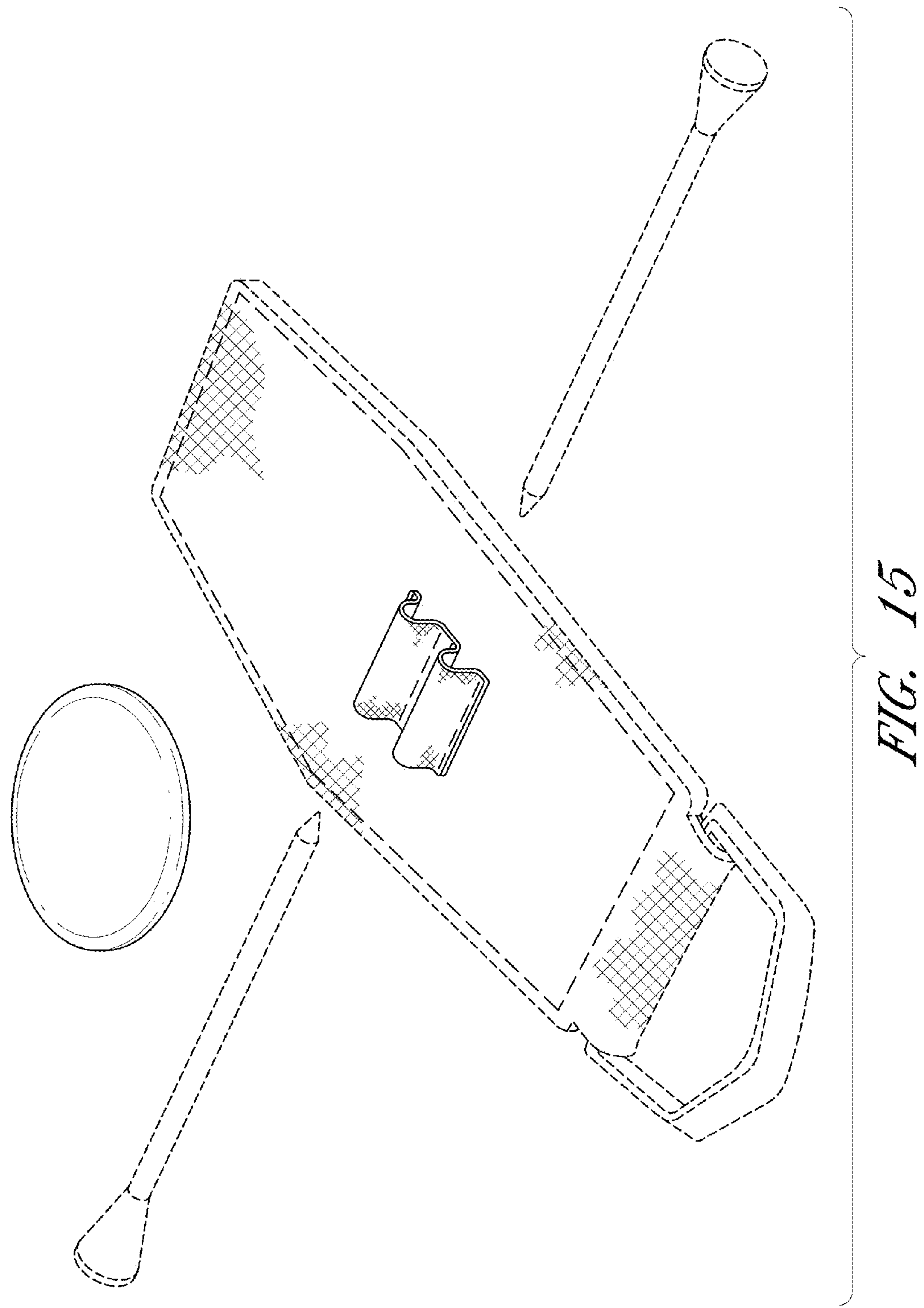
