The ornamental design for an alphabet tote, as shown and described.

DESCRIPTION

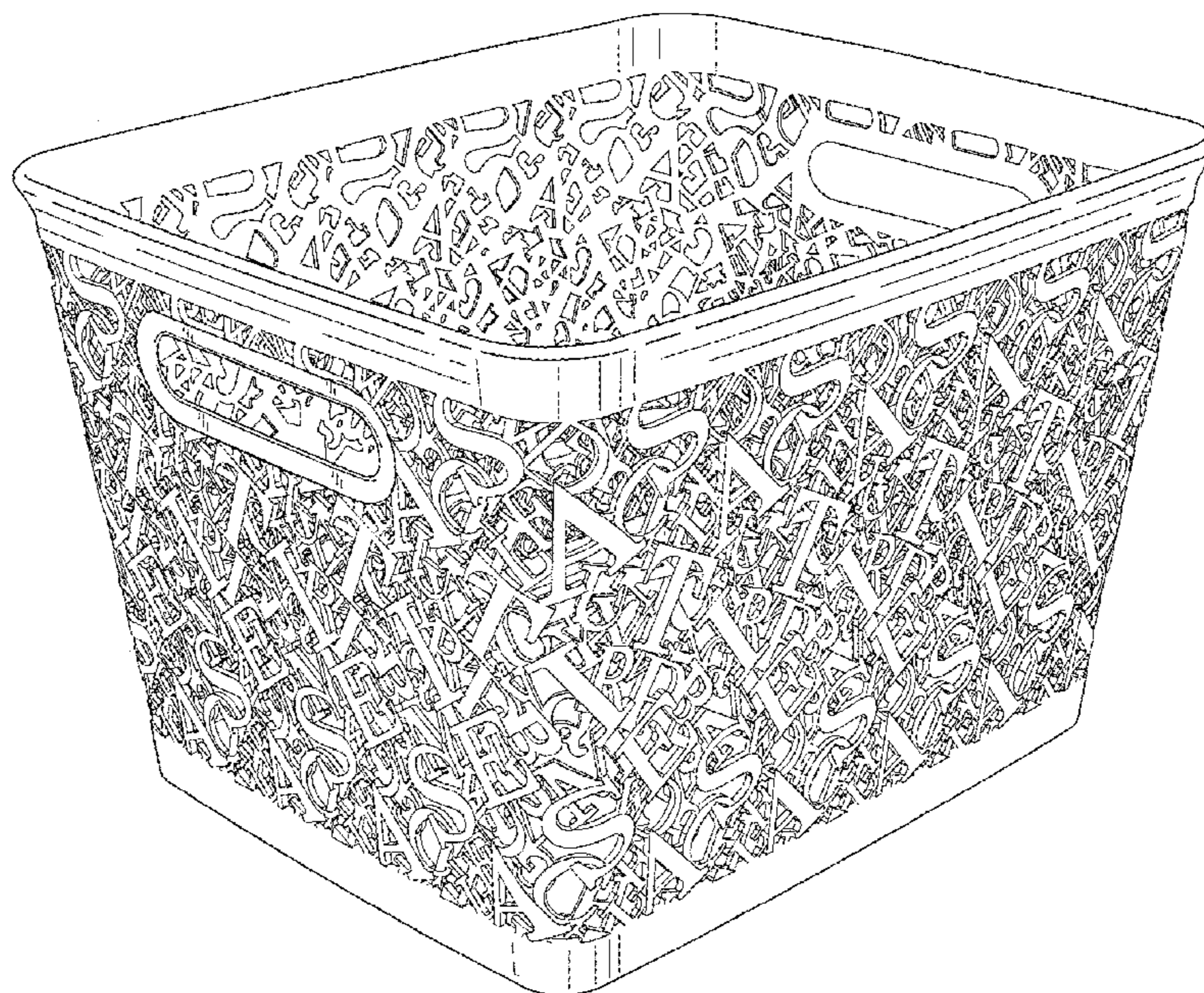
FIG. 1 is a top perspective view of an alphabet tote showing the new design;

FIG. 2 is a front elevation view of the alphabet tote shown in FIG. 1 (the rear elevation view of the alphabet tote is a mirror image of the view shown in FIG. 4); and,

FIG. 3 is a right side elevation view of the alphabet tote shown in FIG. 1; (the left side elevation view of the alphabet tote is a mirror image of the view shown in FIG. 3).

The broken lines shown in the drawing views are included for the purpose of showing environmental structure that forms no part of the claimed design.

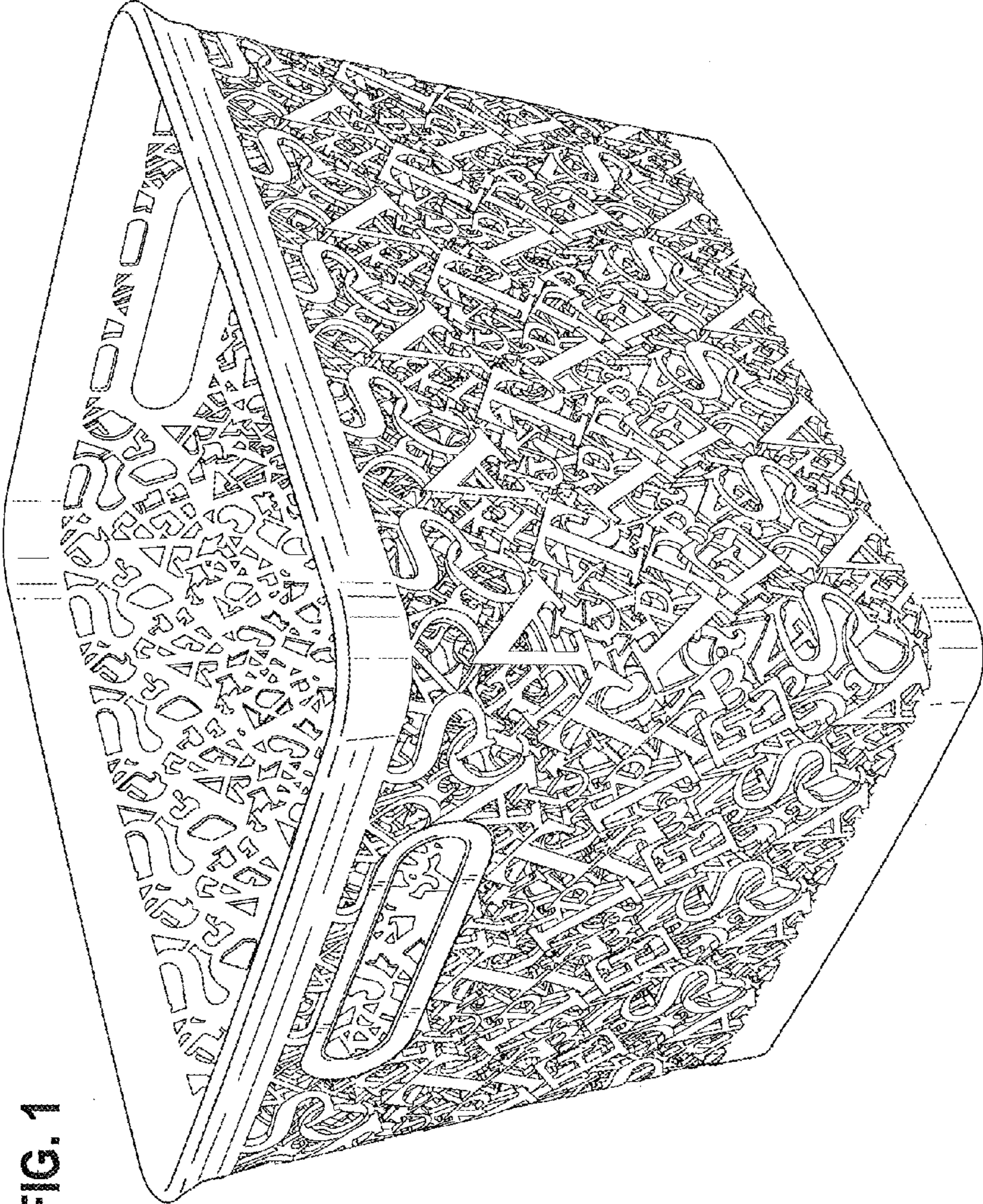

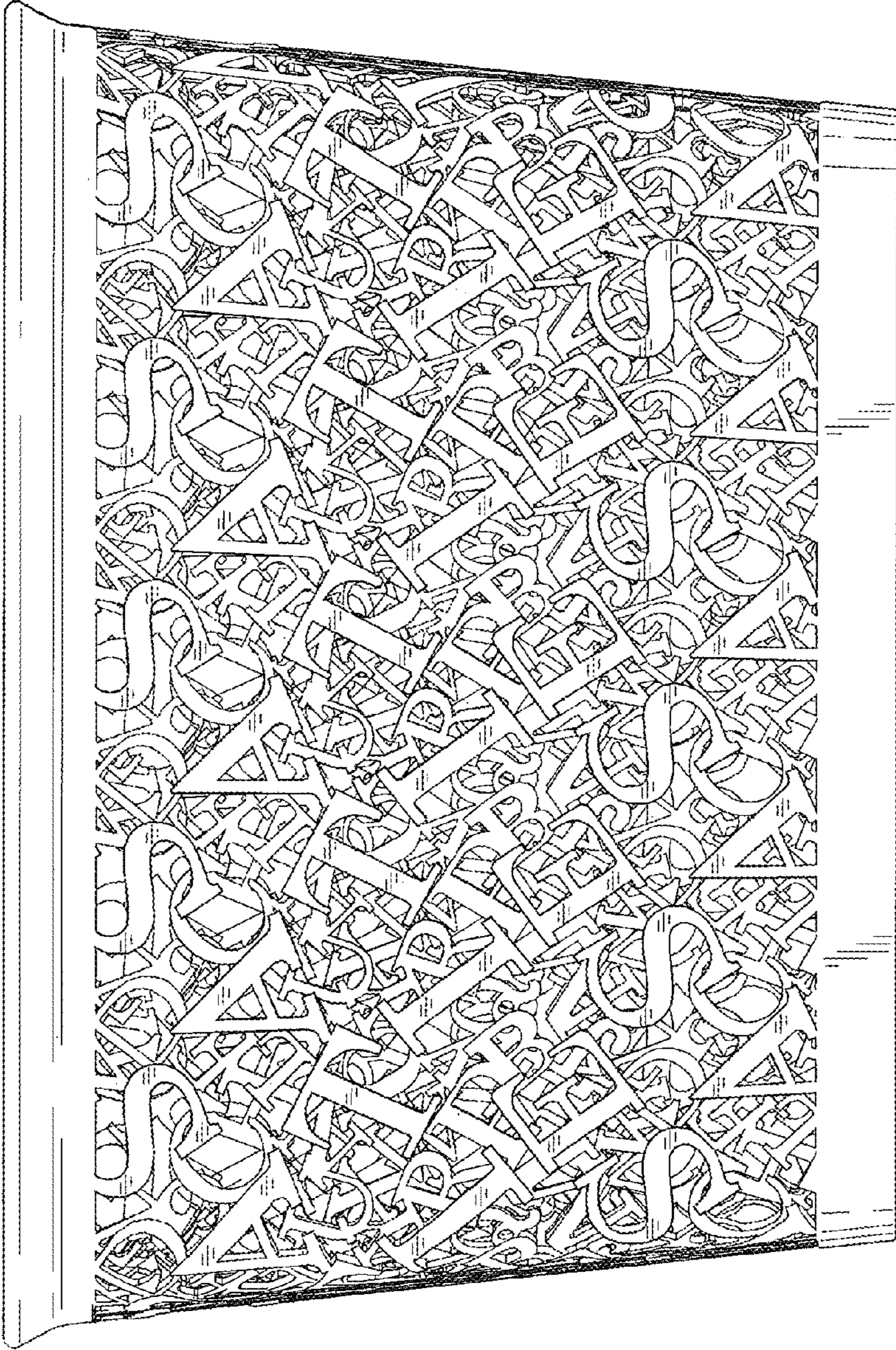

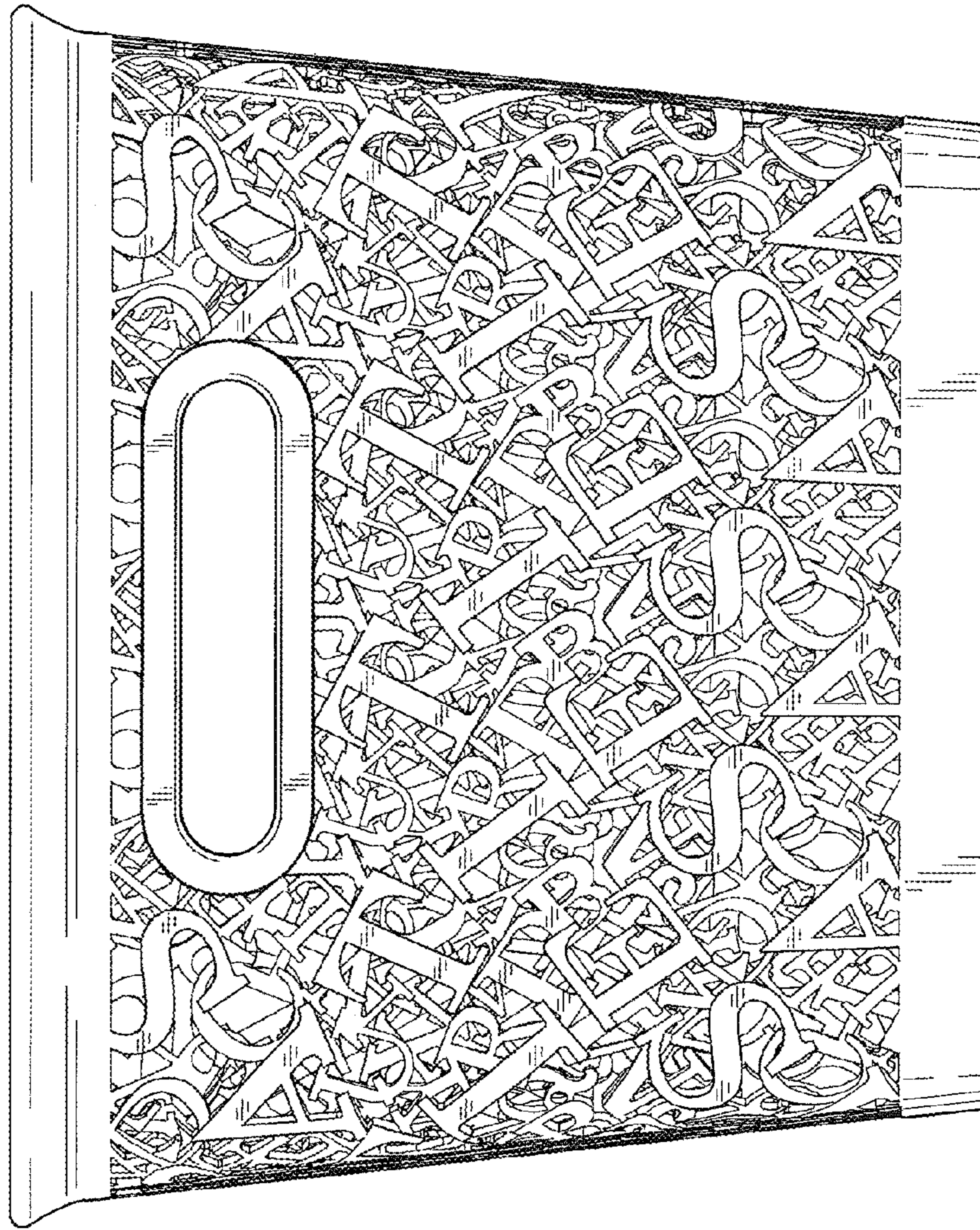
