FIG. 7 is a bottom plan view of the bag accessory of FIG. 1.

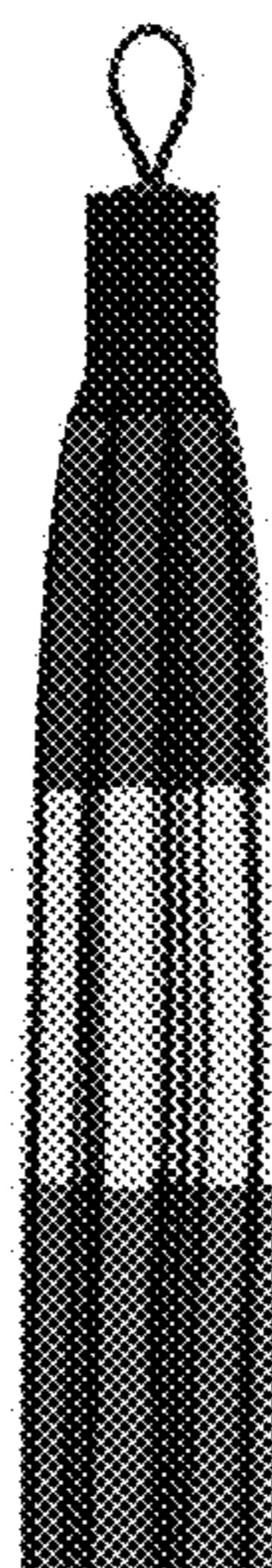

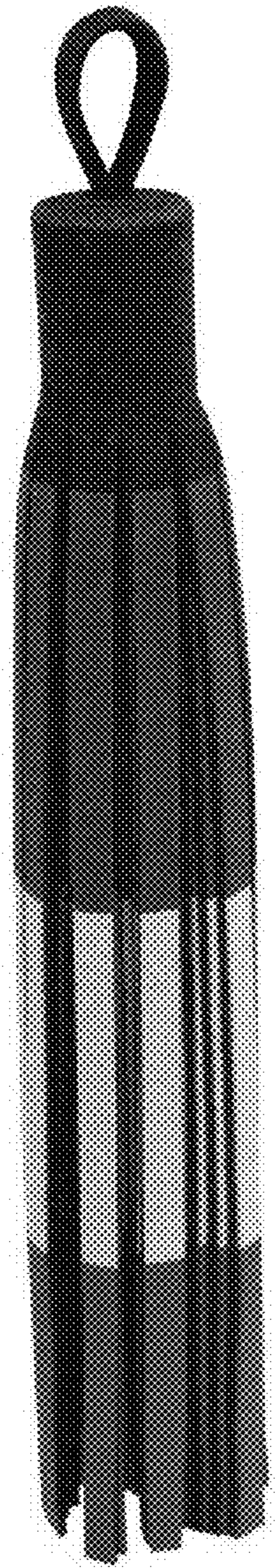

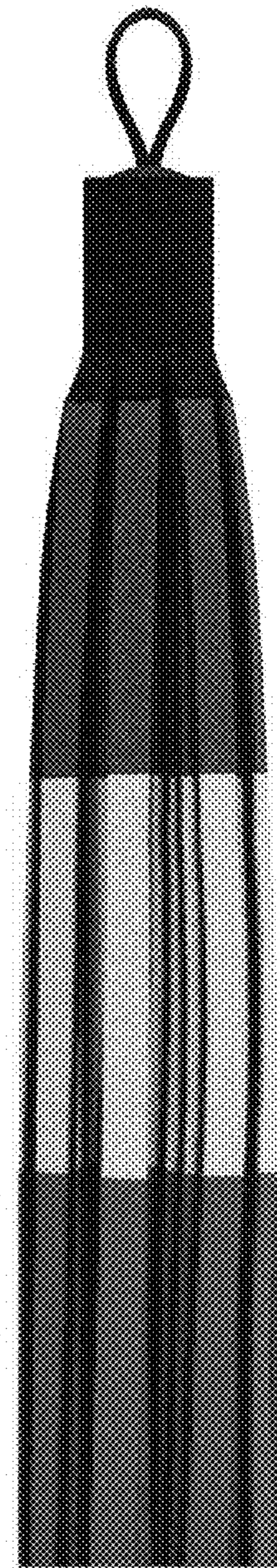

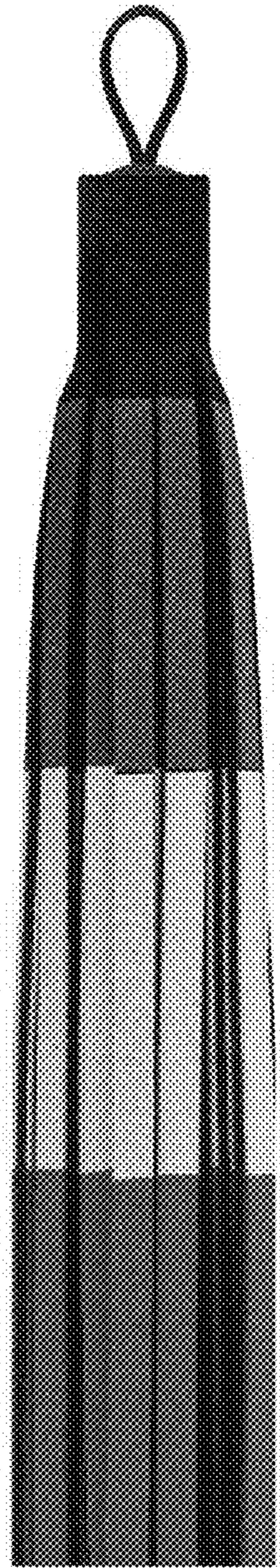

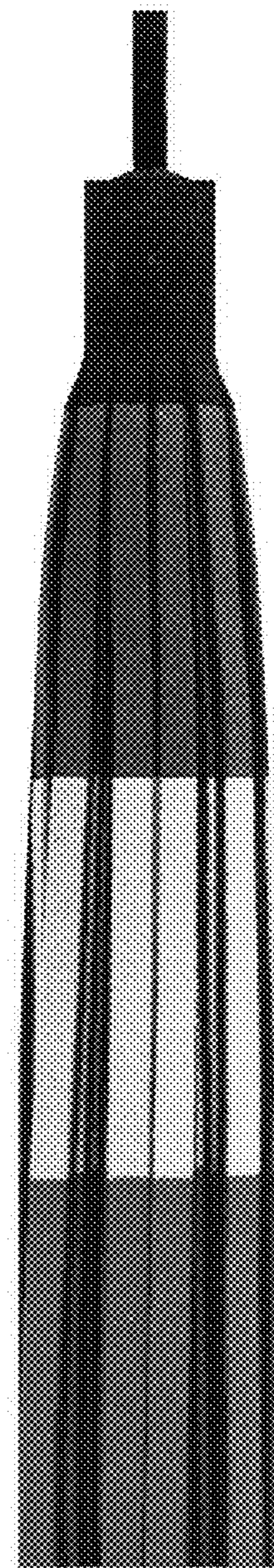

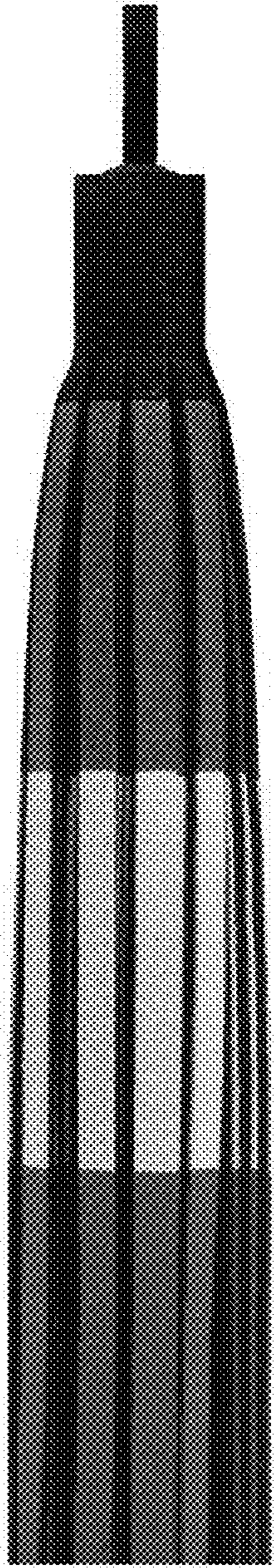

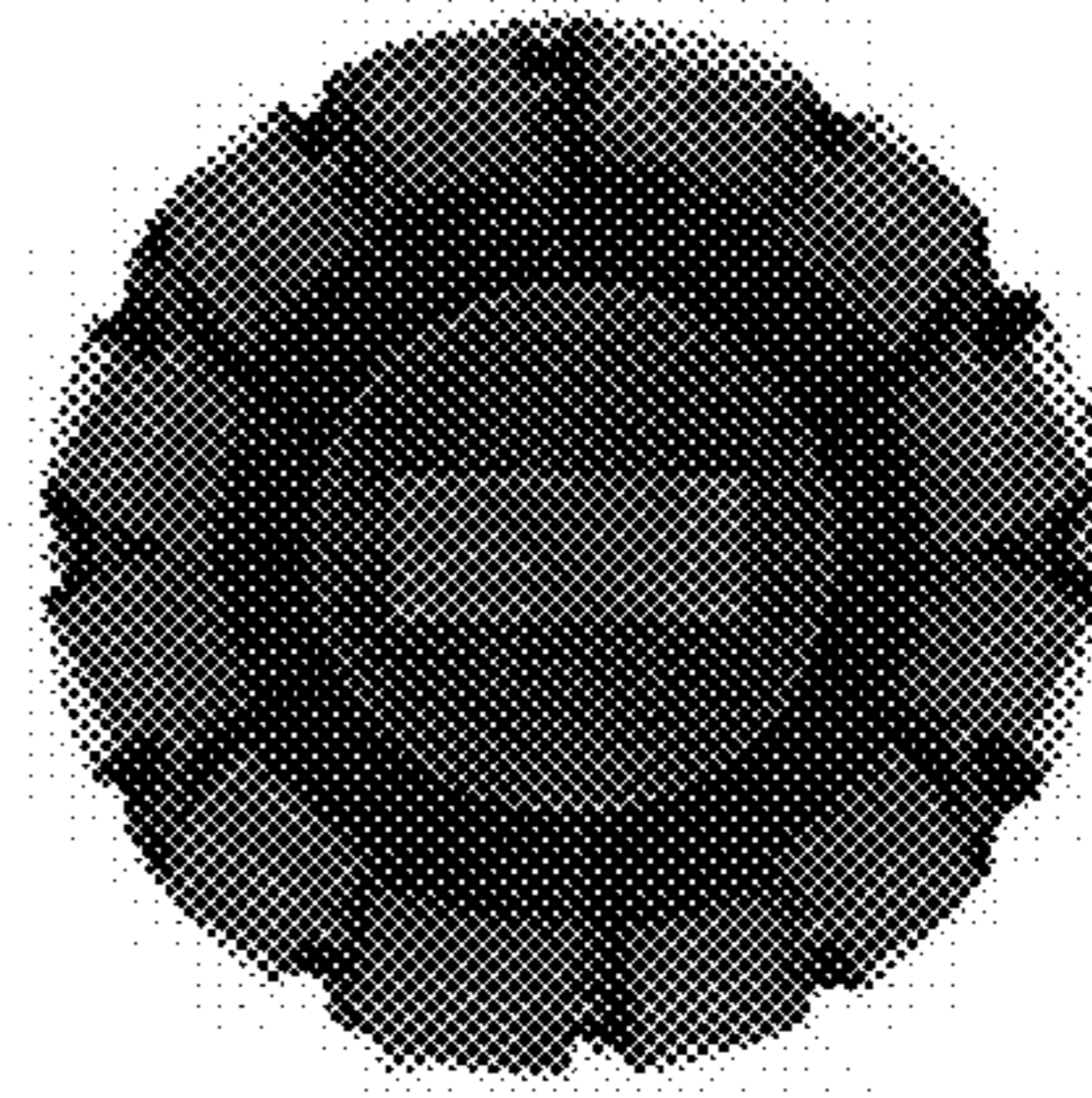

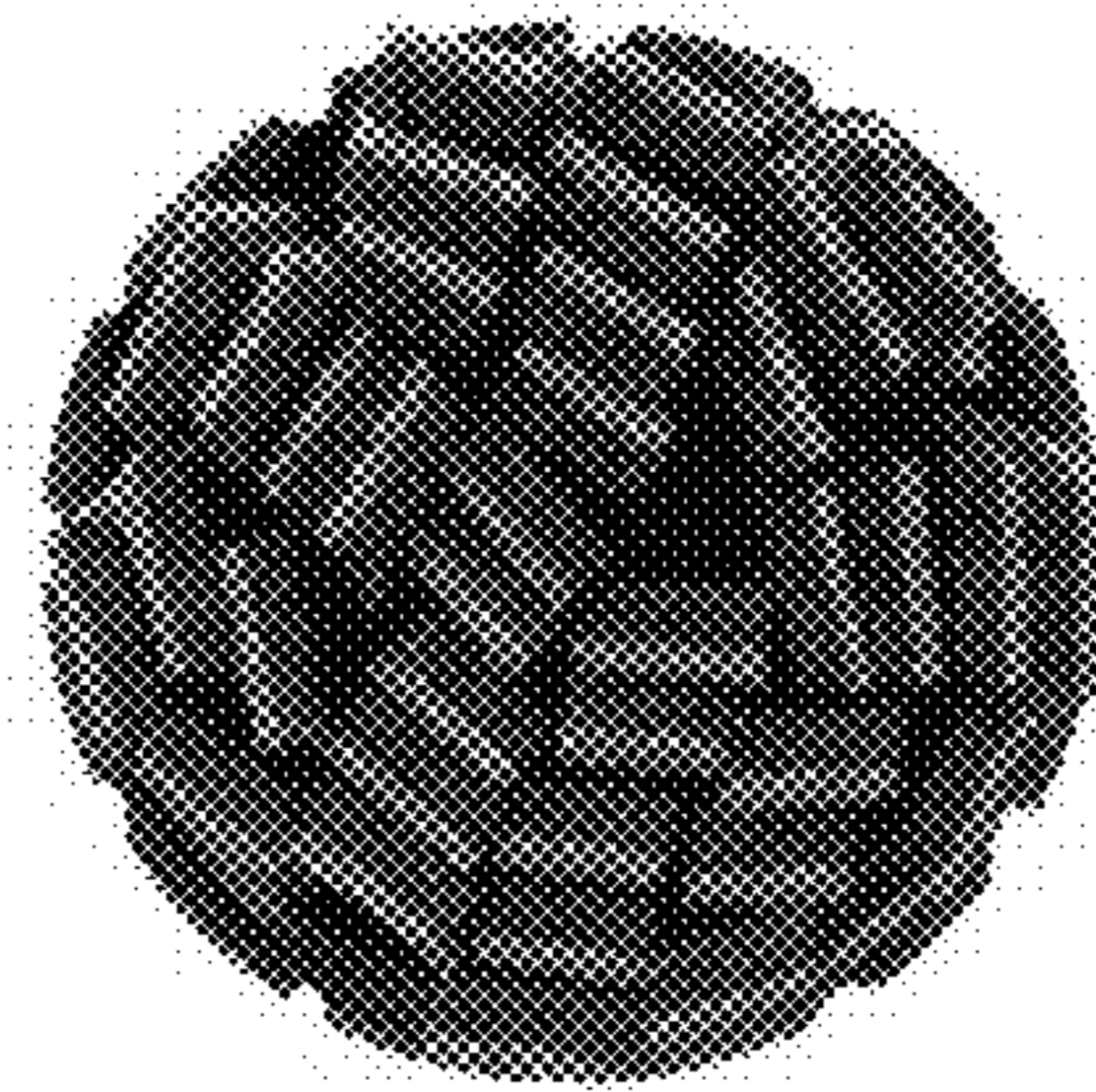
