(57) **CLAIM**

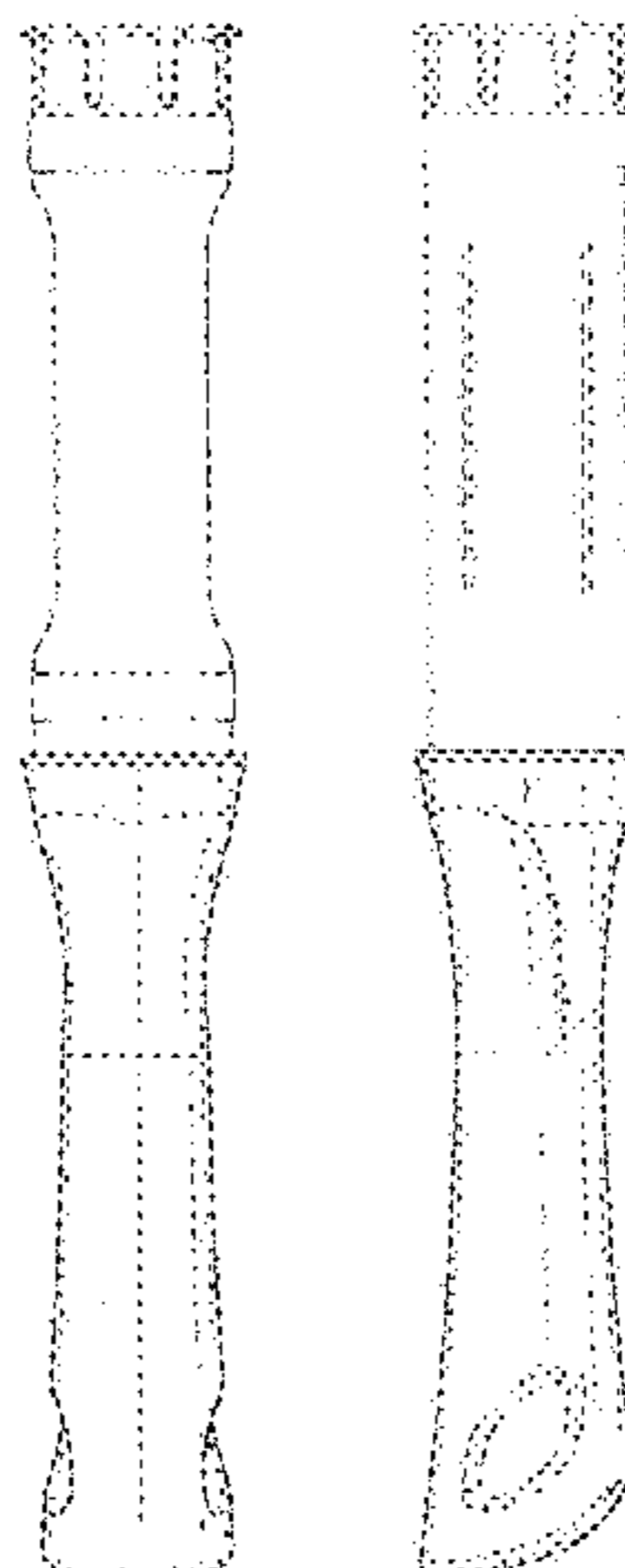
The ornamental design for a travel handle for a lint brush, as

DESCRIPTION

FIG. 1 is a perspective view of a travel handle for a lint brush;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof; and,

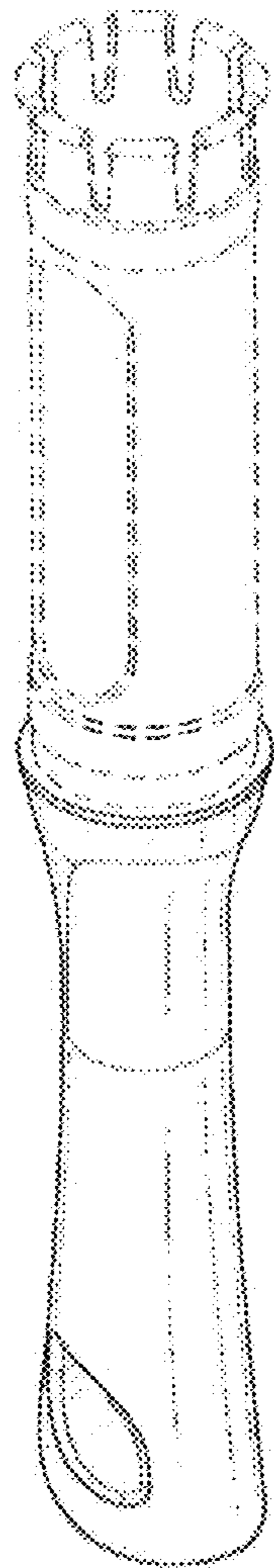

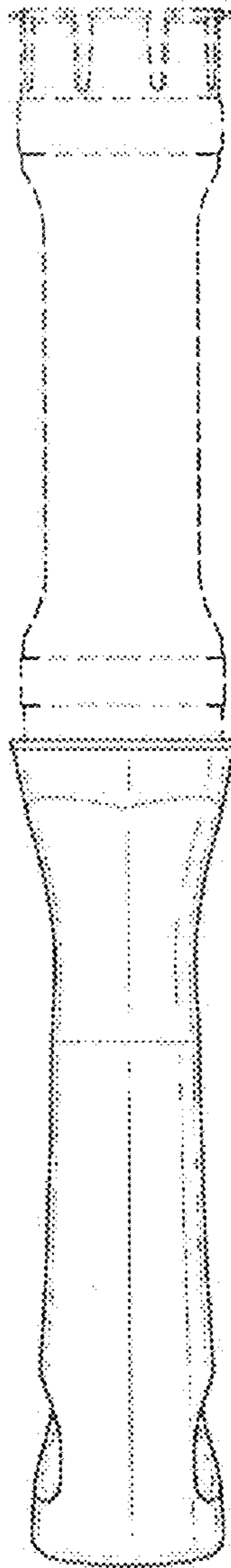

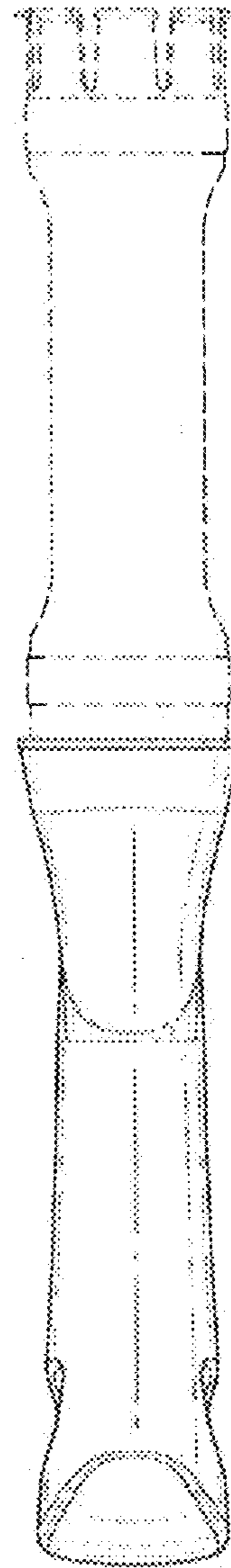

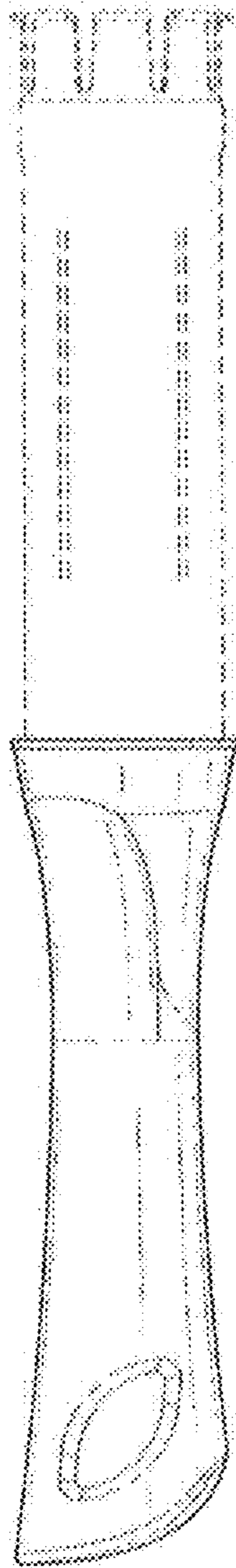

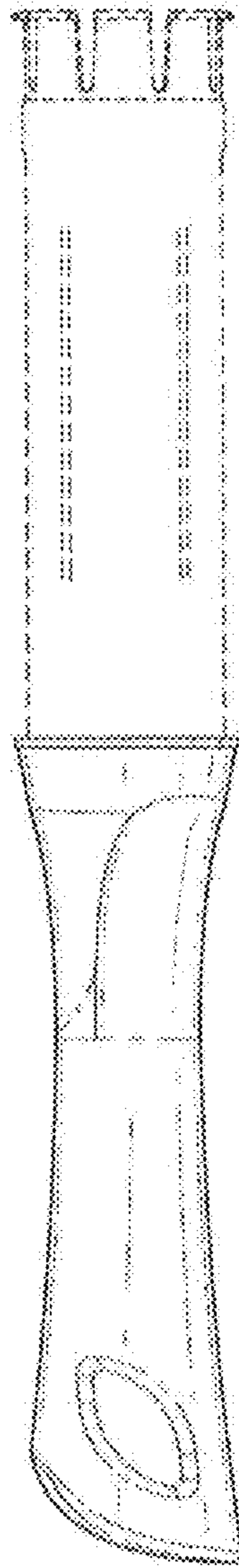

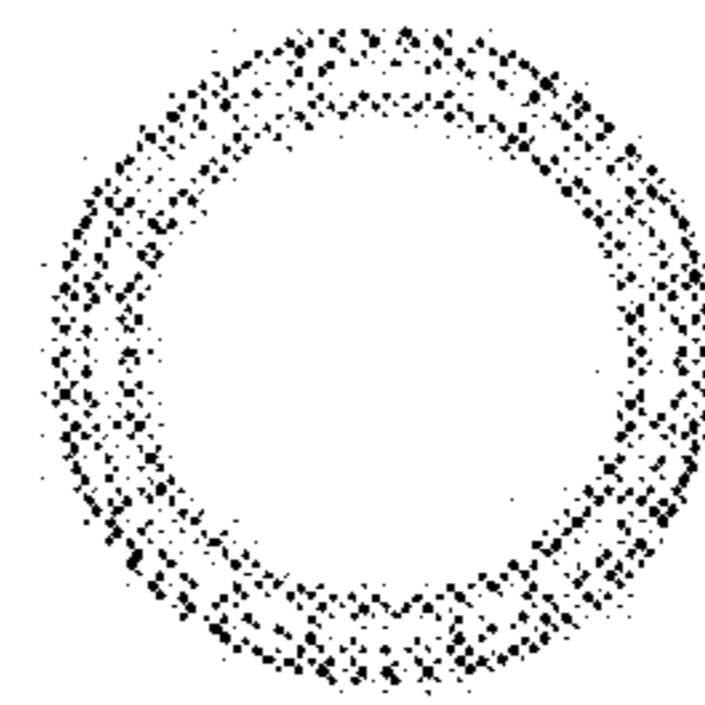

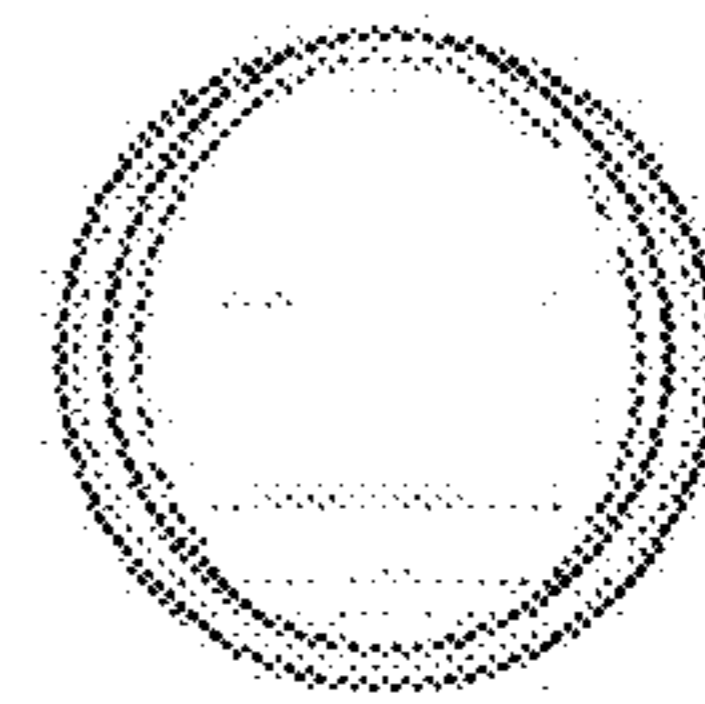
