FIG. 3 is a back elevational view thereof.

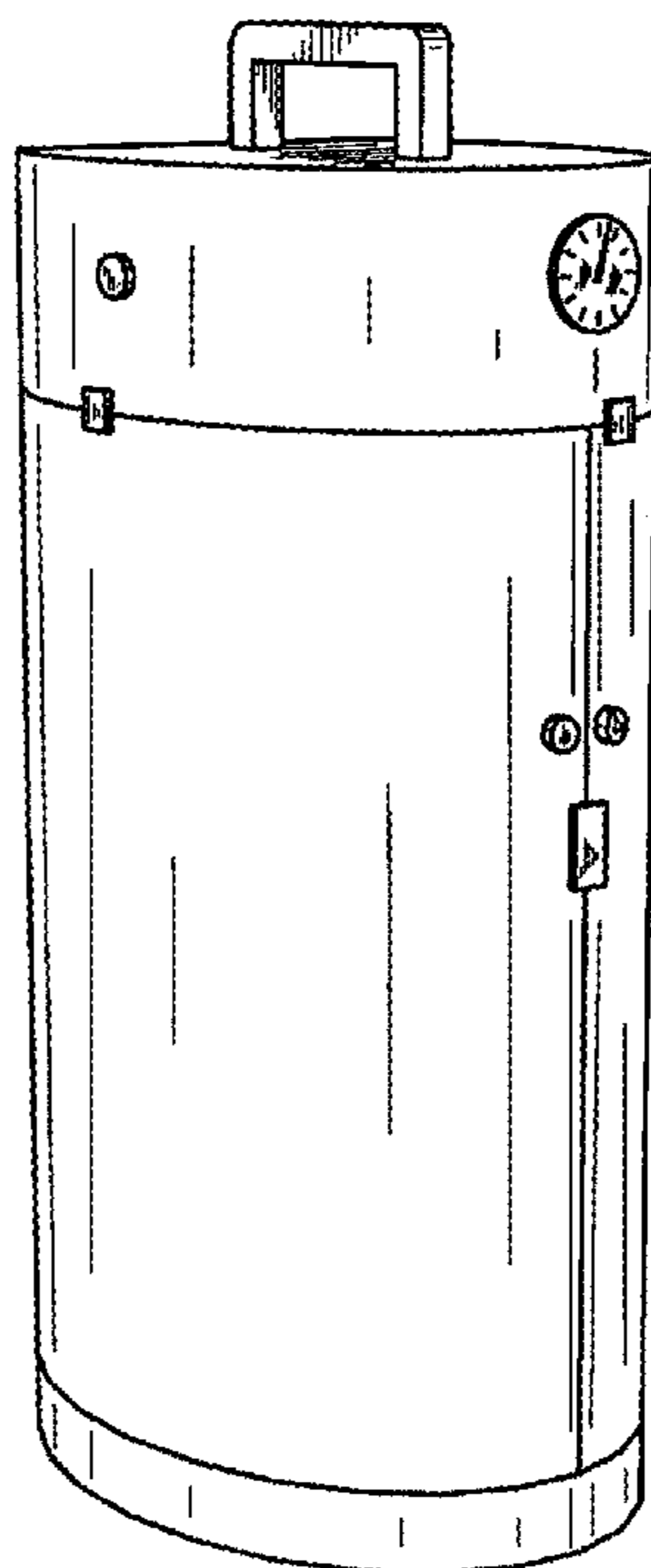
FIG. 4 is a left side elevational I view thereof.

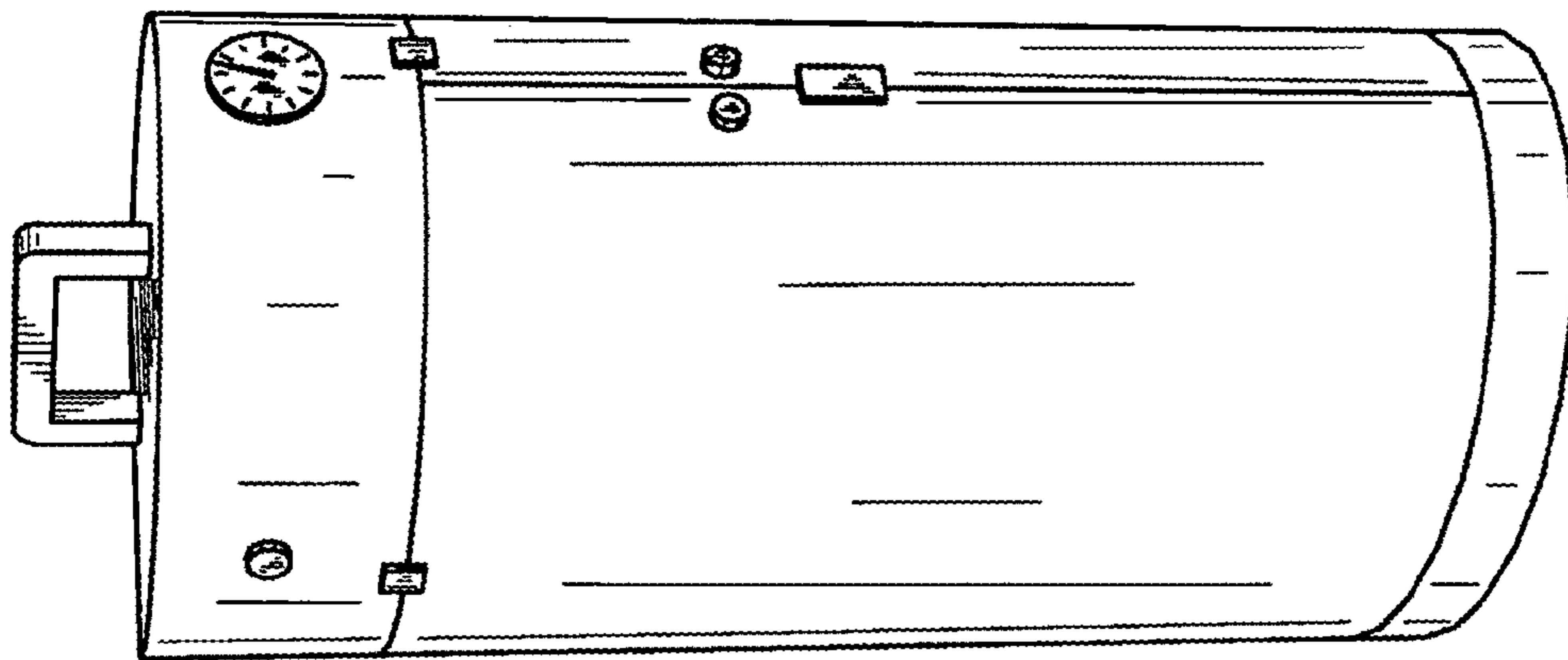

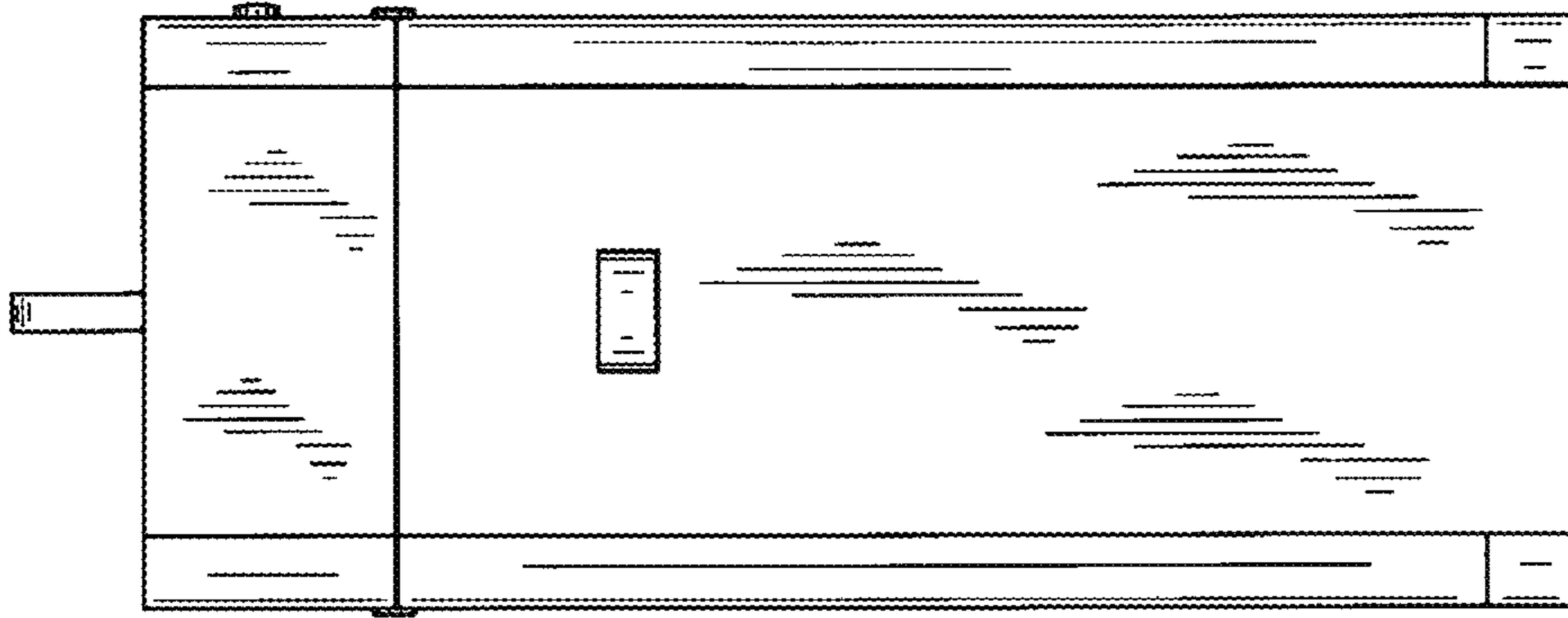

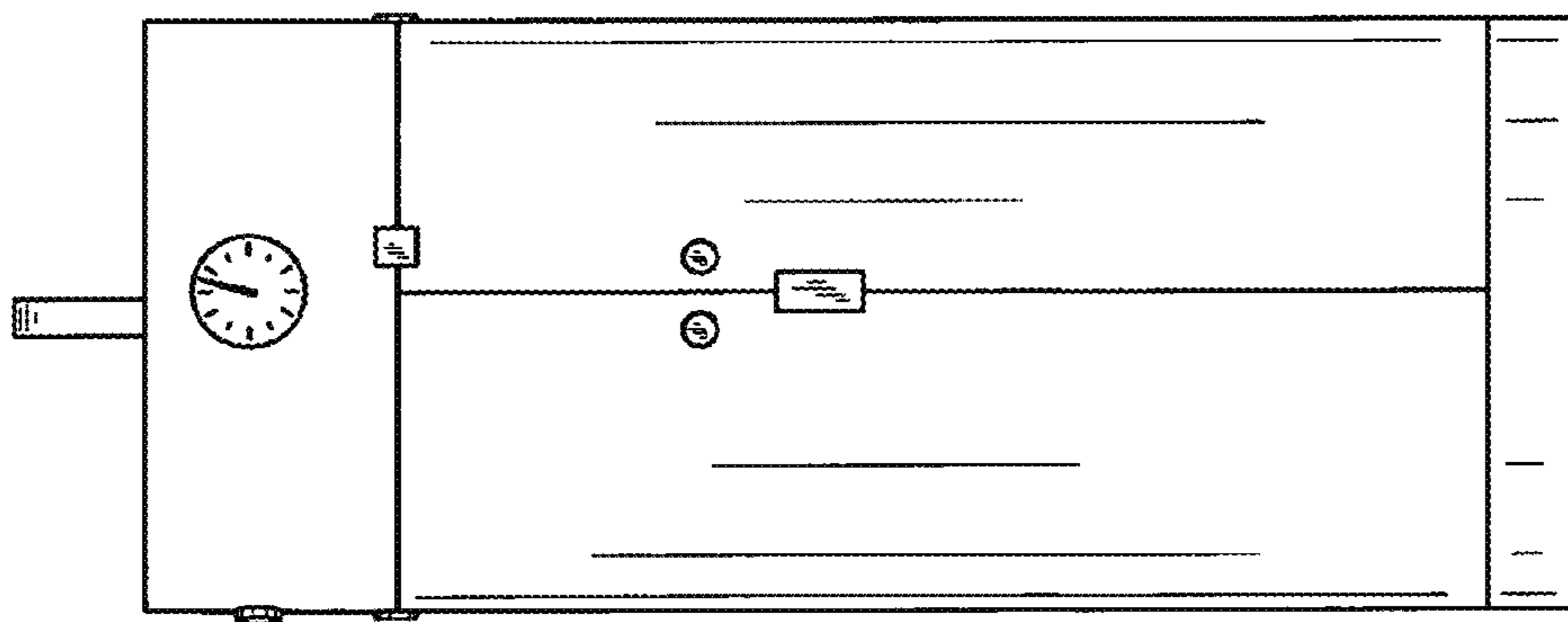

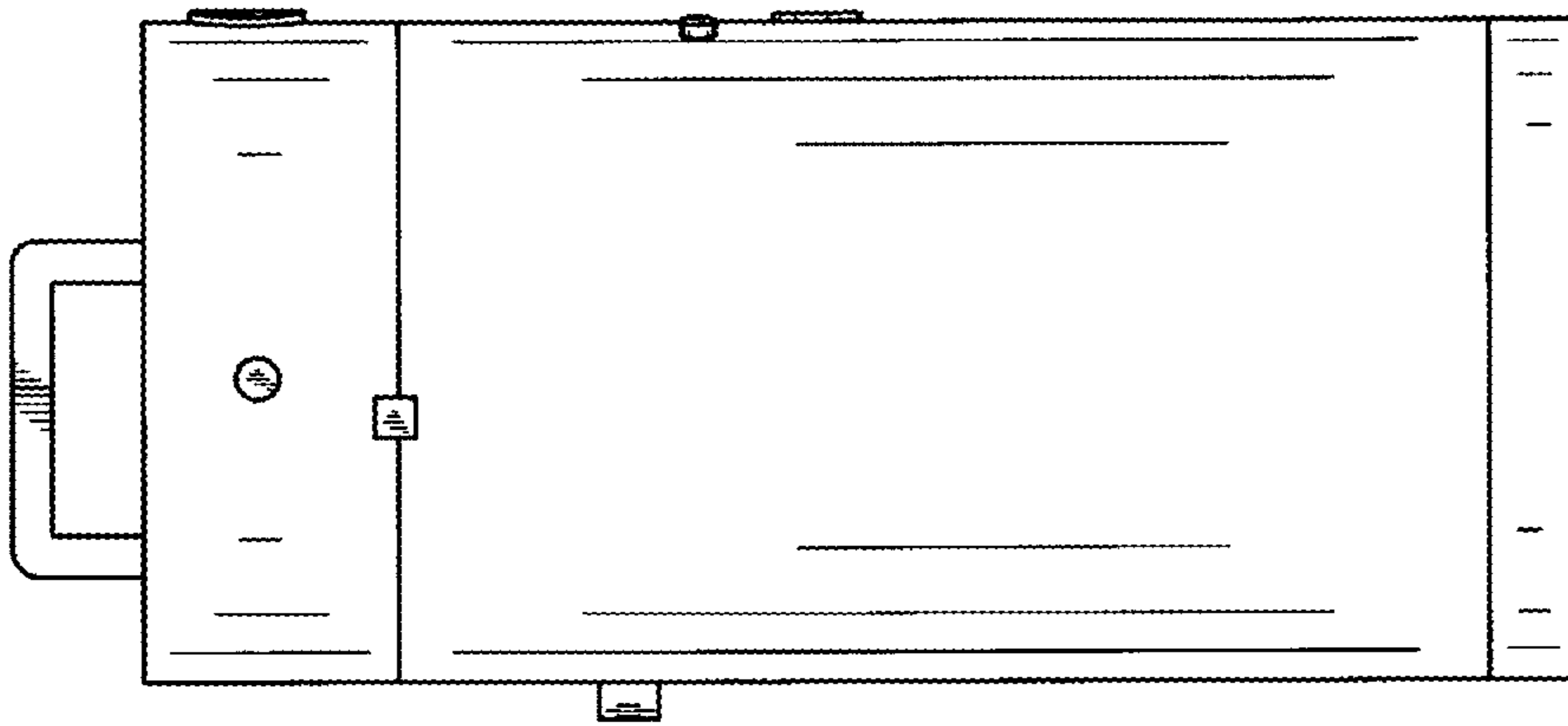

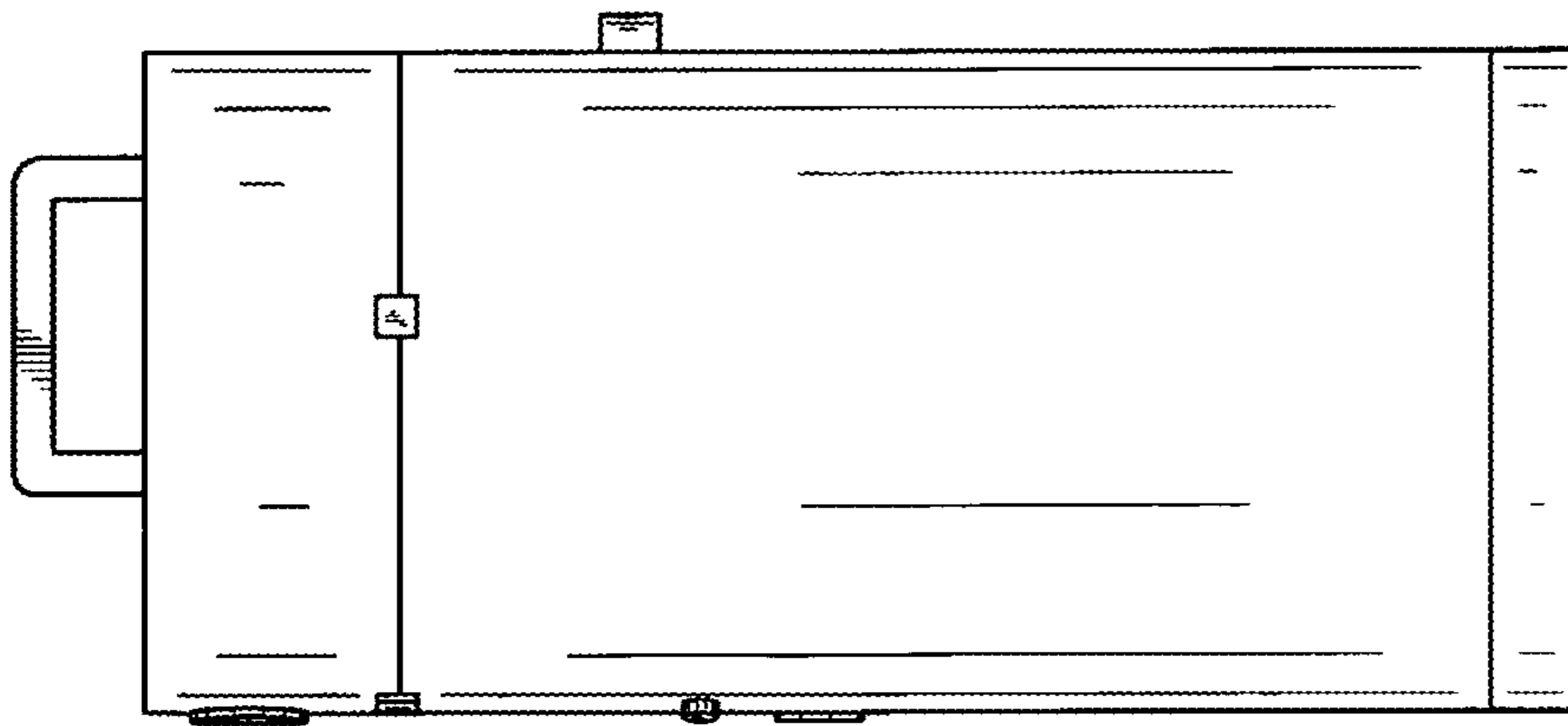

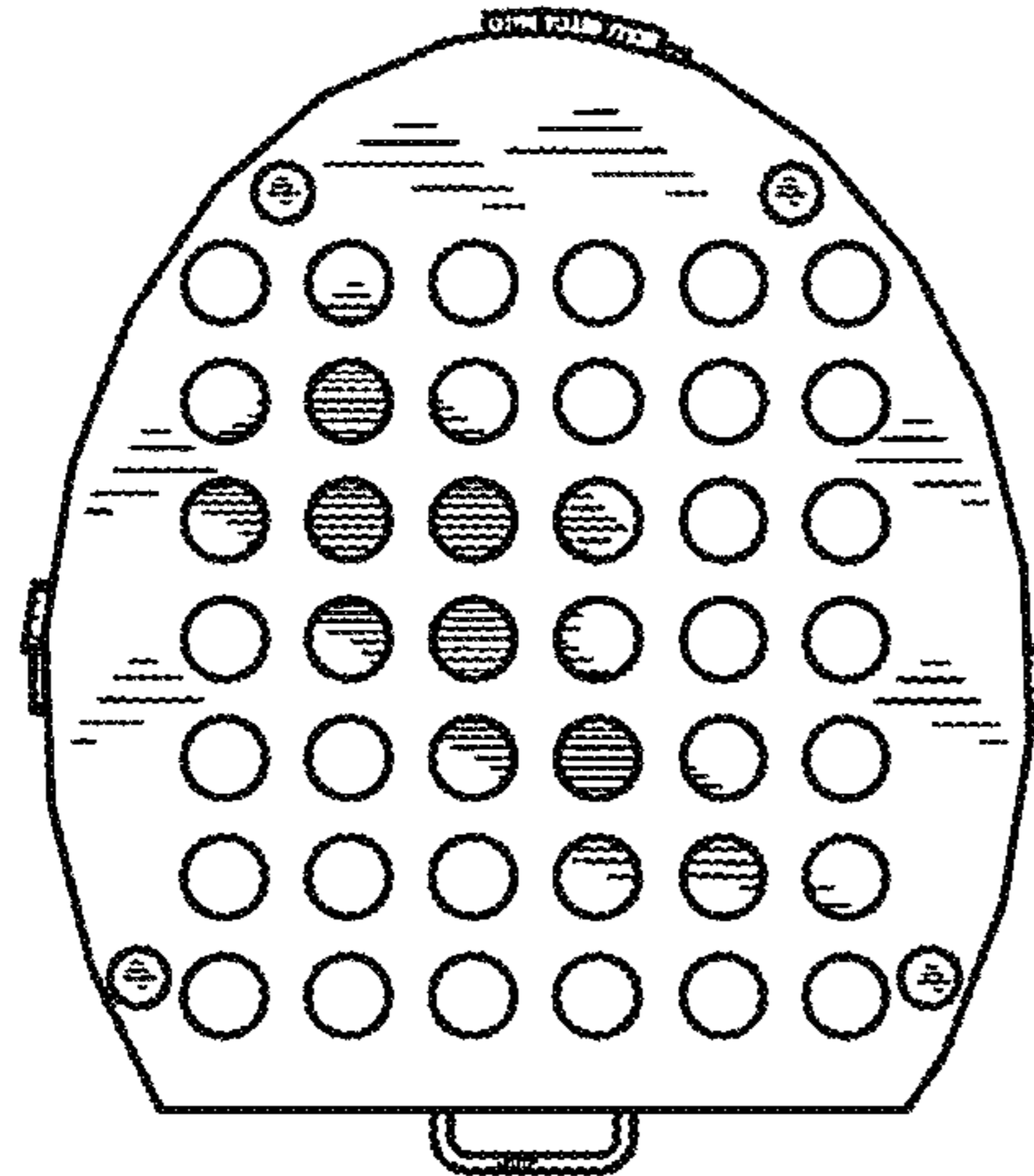

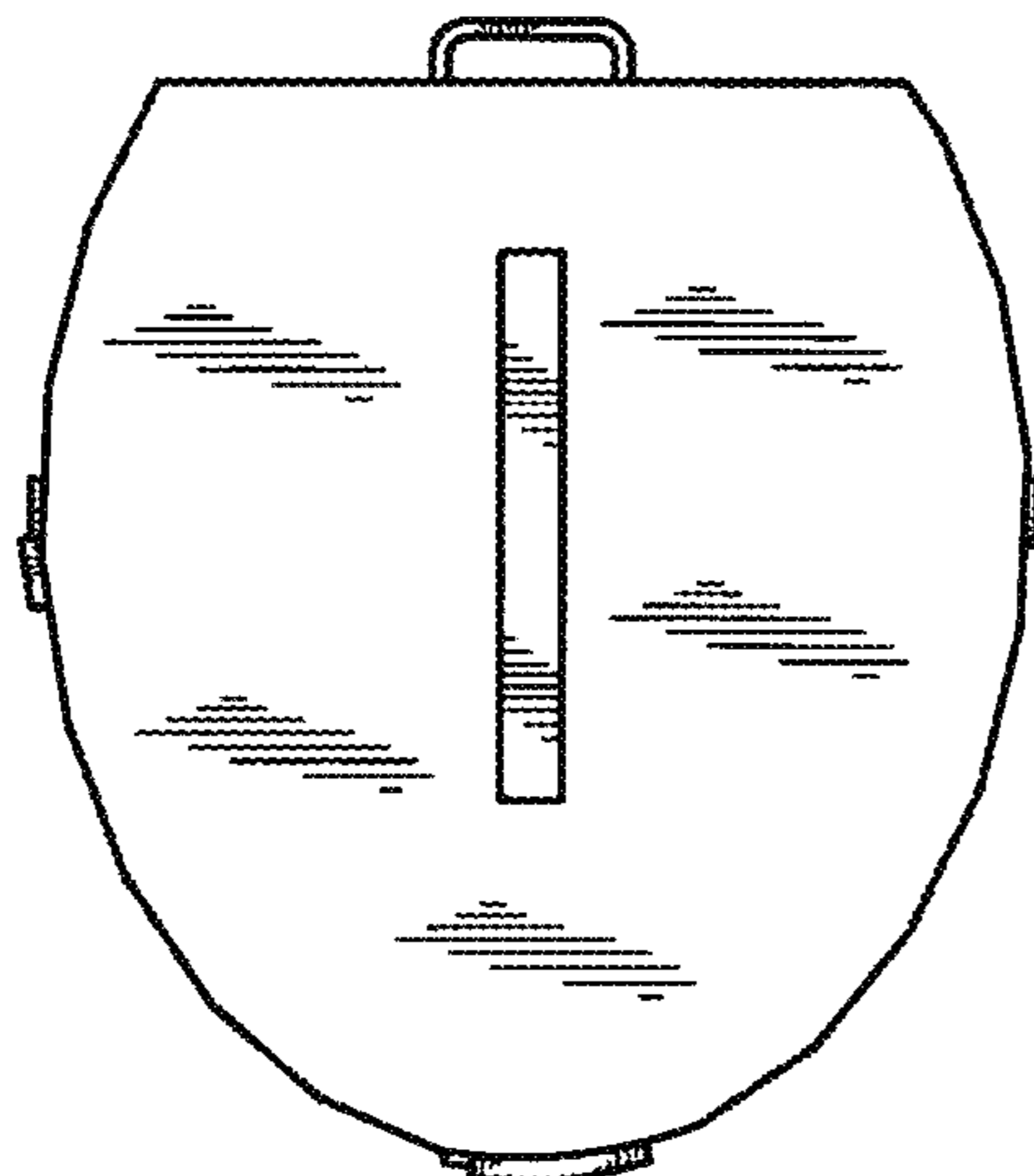
