(57) **CLAIM**

We claim the ornamental design for a display panel for a sampler, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a display panel for a sampler. FIG. 2 is a front view of the display panel with the sampler of FIG. 1.

FIG. 3 is a rear view of the display panel with the sampler of FIG. 1.

FIG. 4 is a right side view of the display panel with the sampler of FIG. 1.

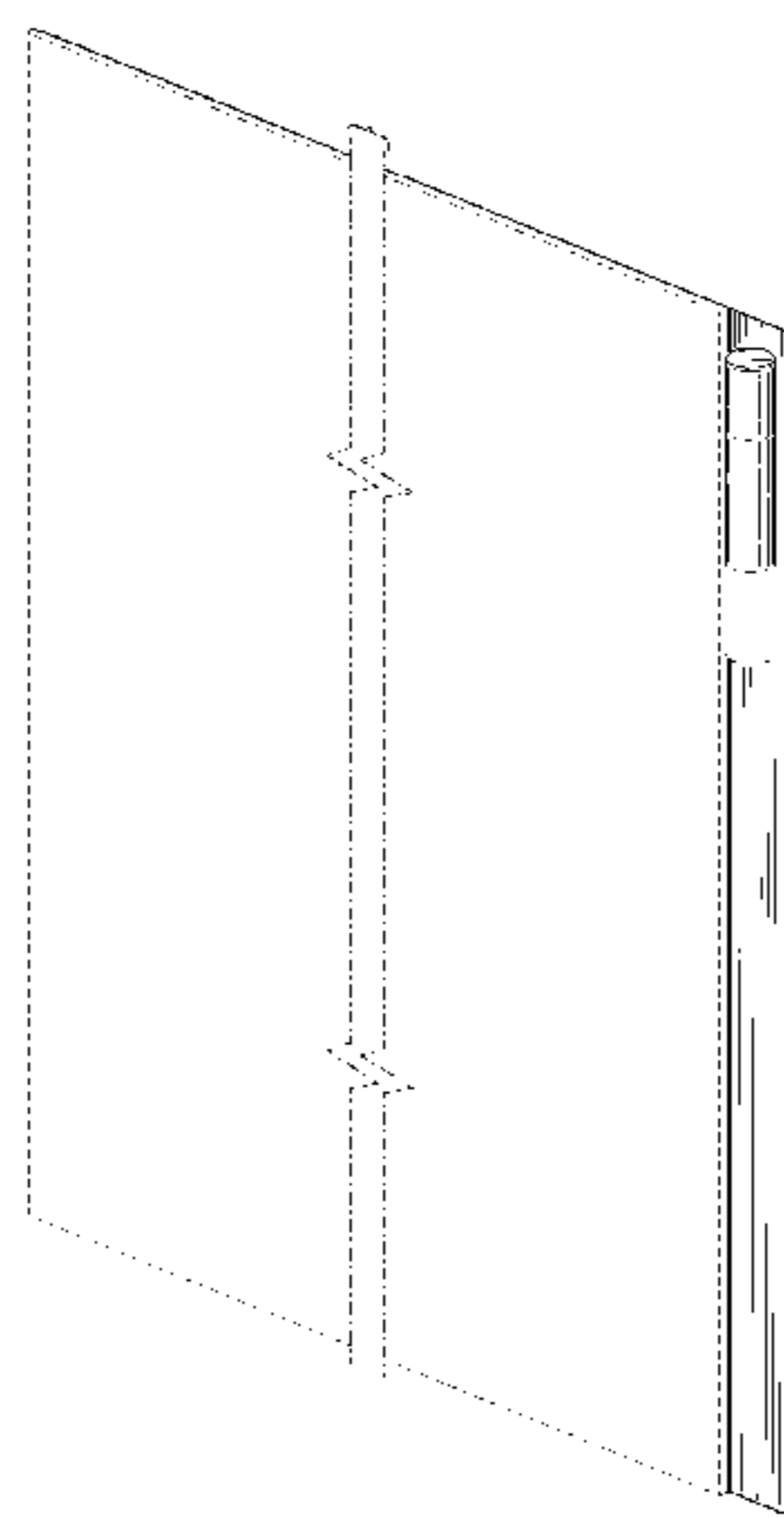
FIG. 5 is a left side view of the display panel with the sampler of FIG. 1.

FIG. 6 is a top view of the display panel with the sampler of FIG. 1; and,

FIG. 7 is a bottom view of the display panel with the sampler of FIG. 1.

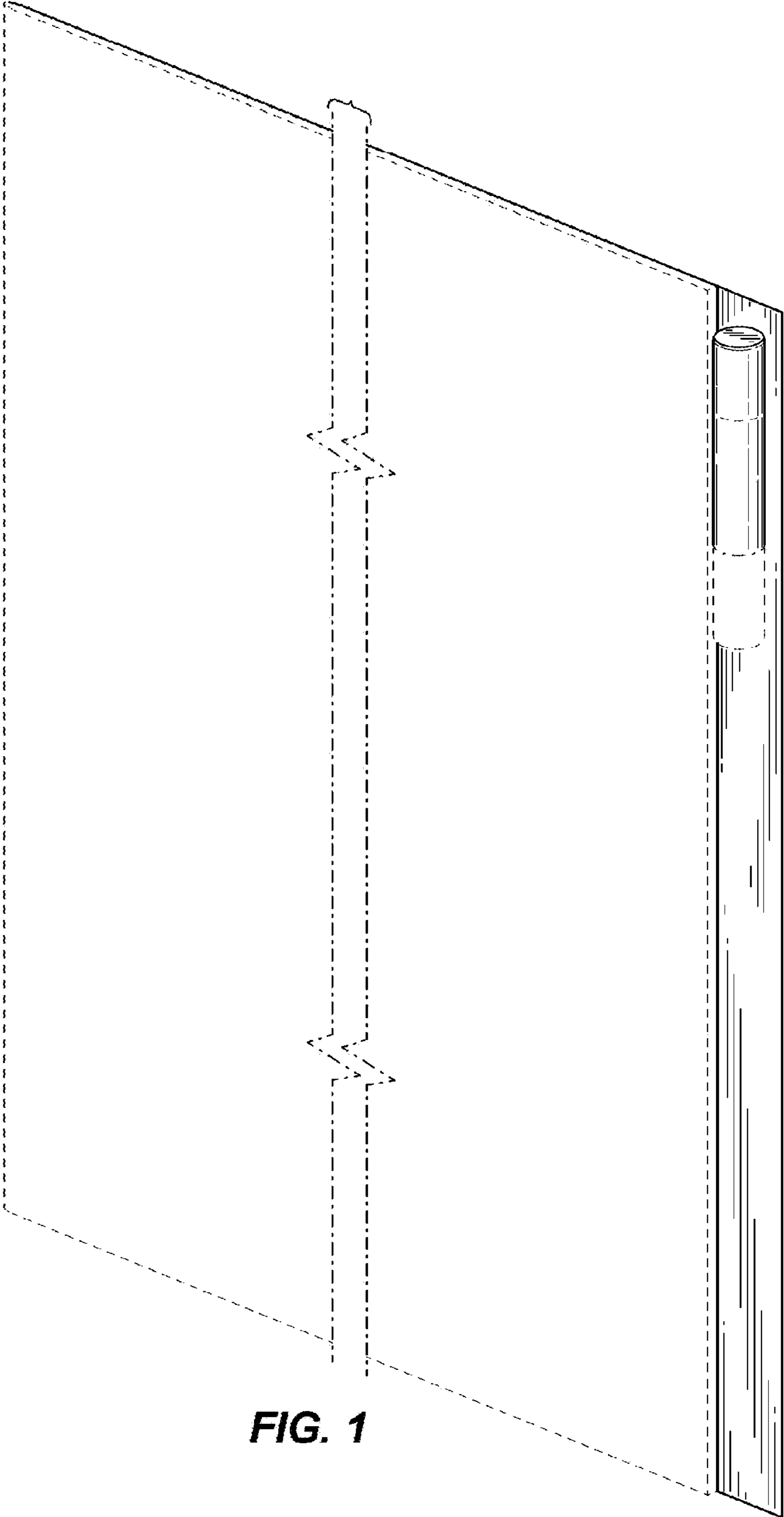

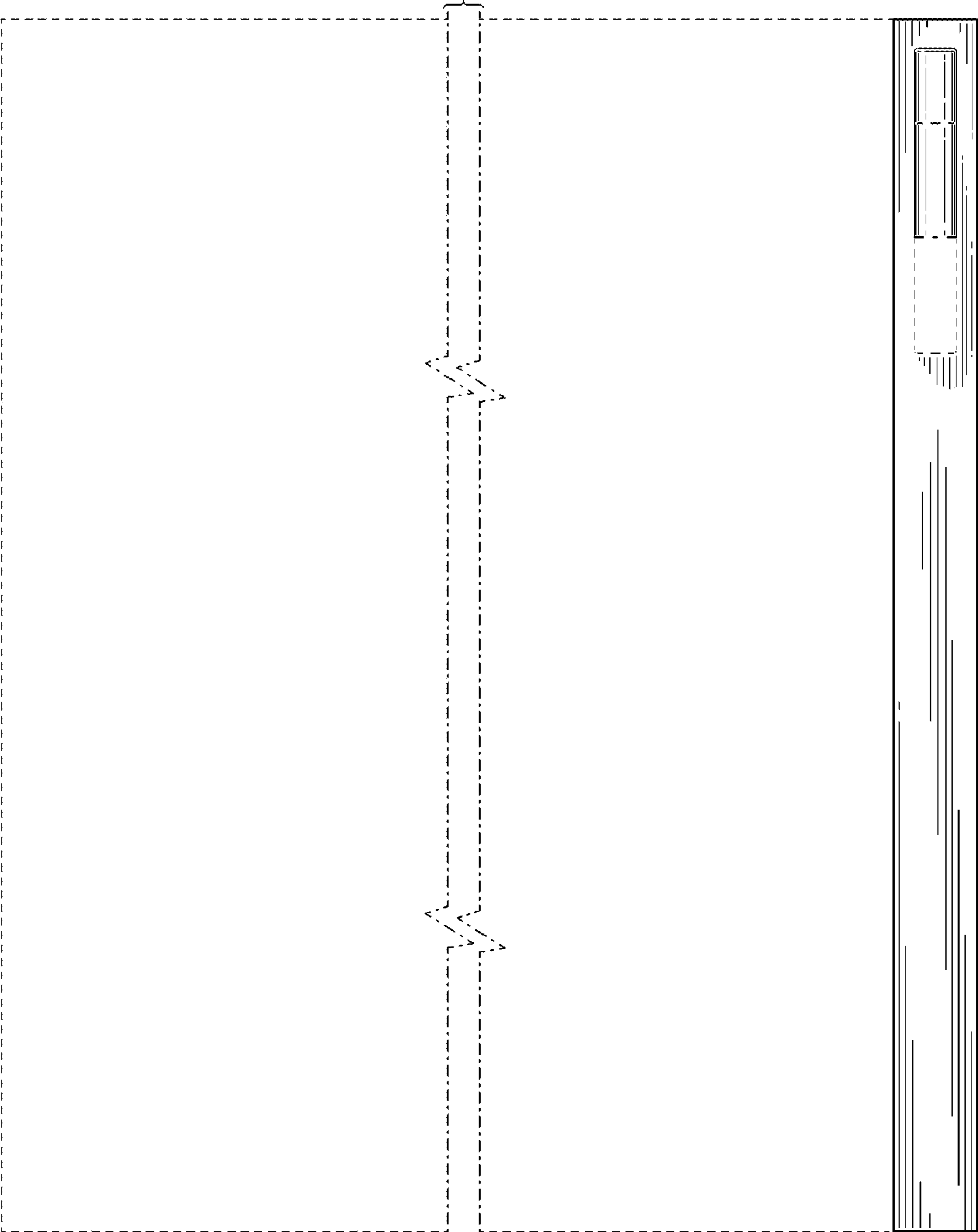

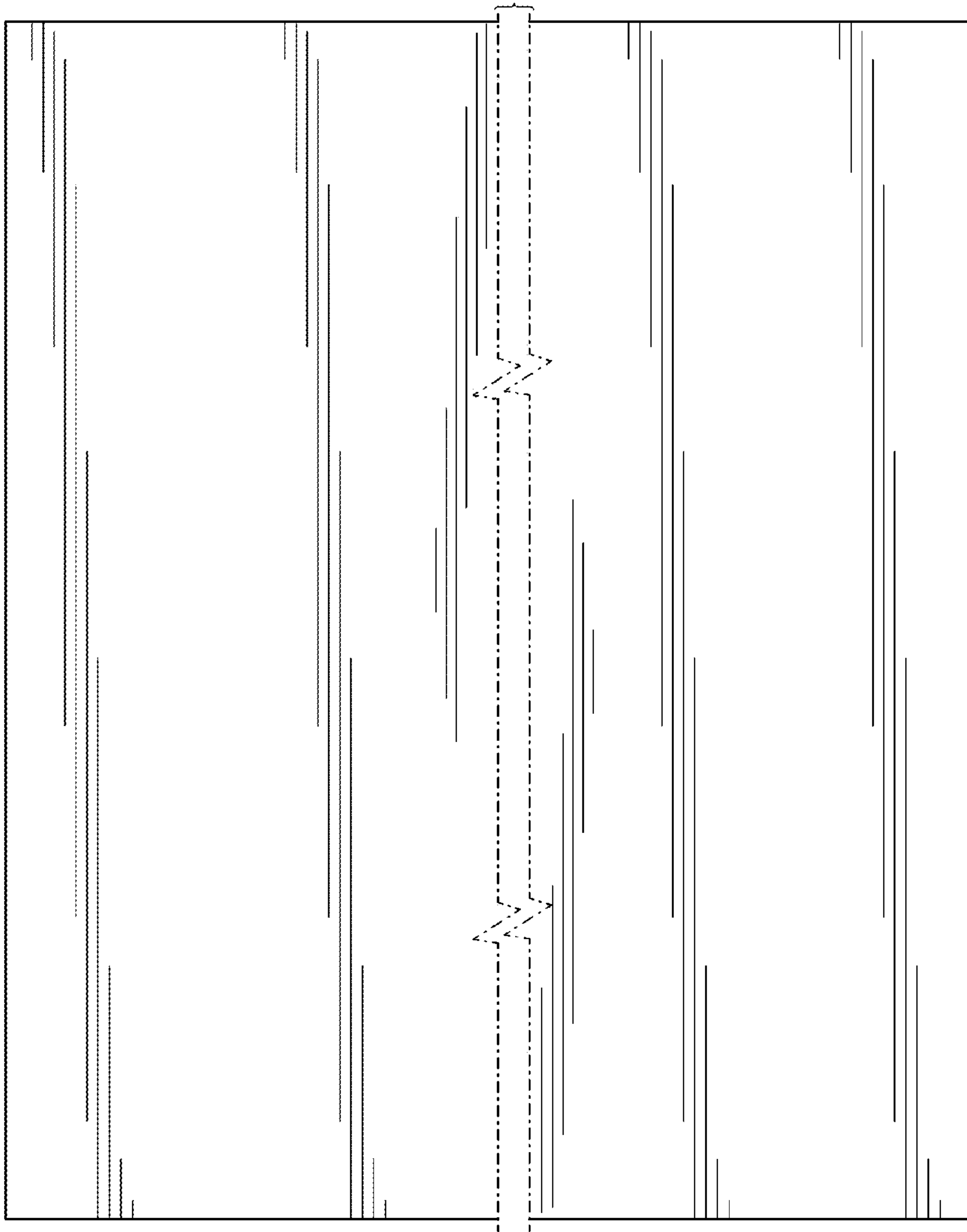

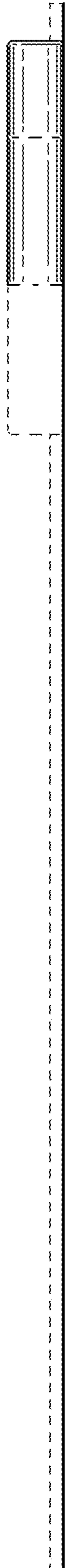

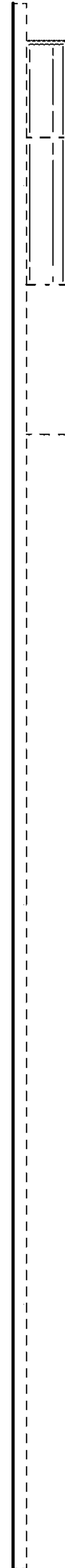
