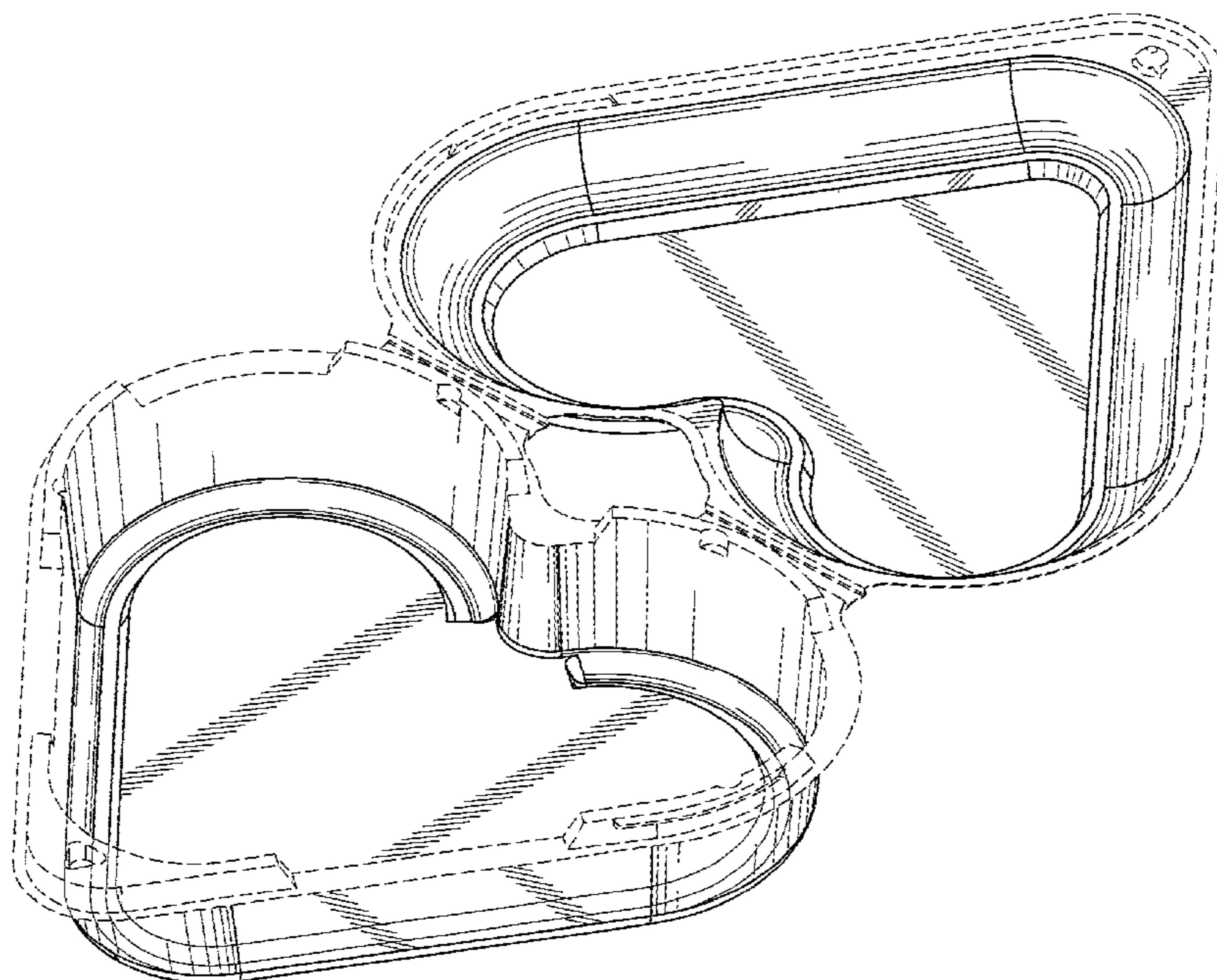

The ornamental design for a container, as shown and described.

DESCRIPTION
FIG. 1 is a top perspective view of a container showing our new design in an open position;
FIG. 2 is a top perspective view of the container in a closed position;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left elevational view thereof;
FIG. 6 is a right elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

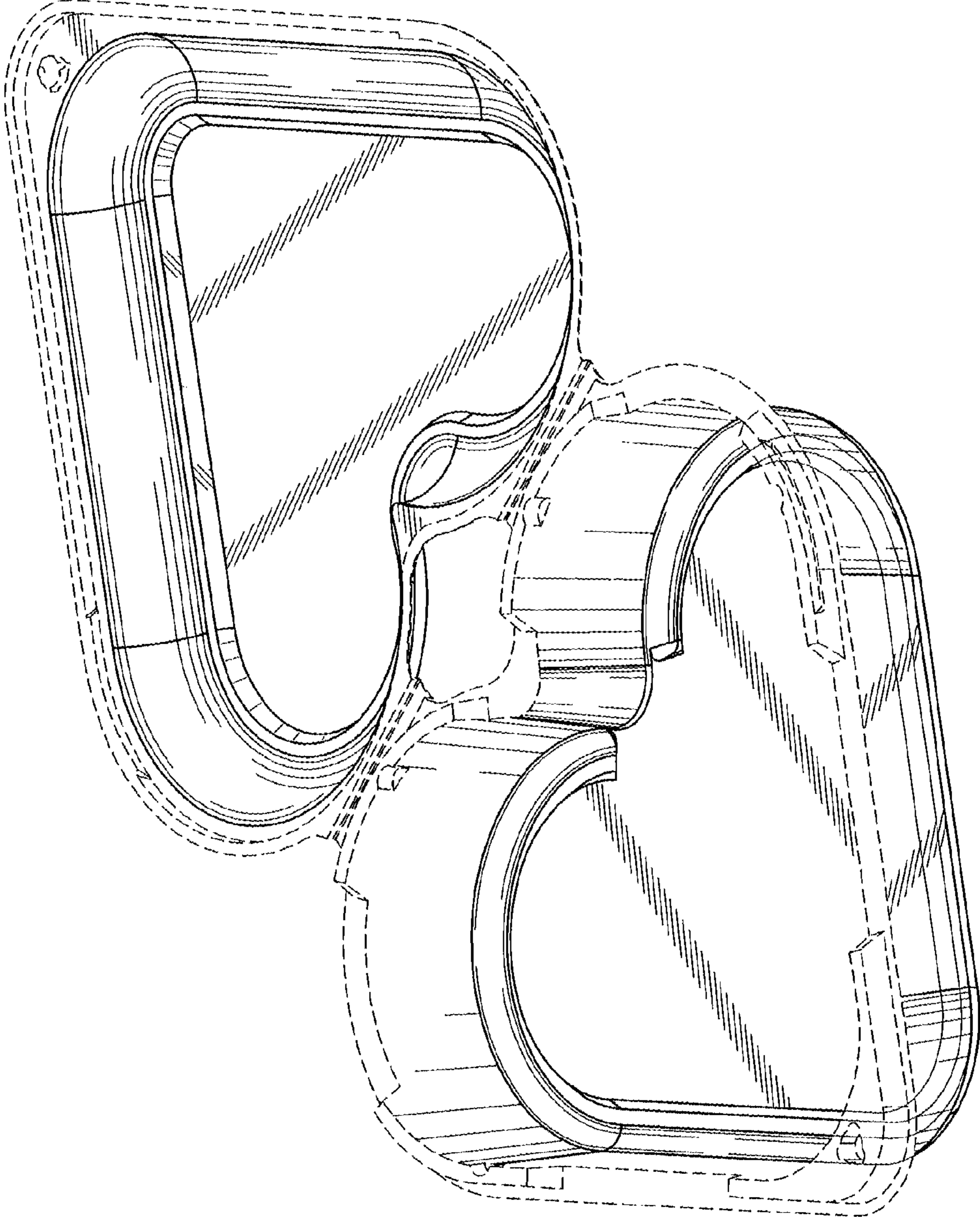

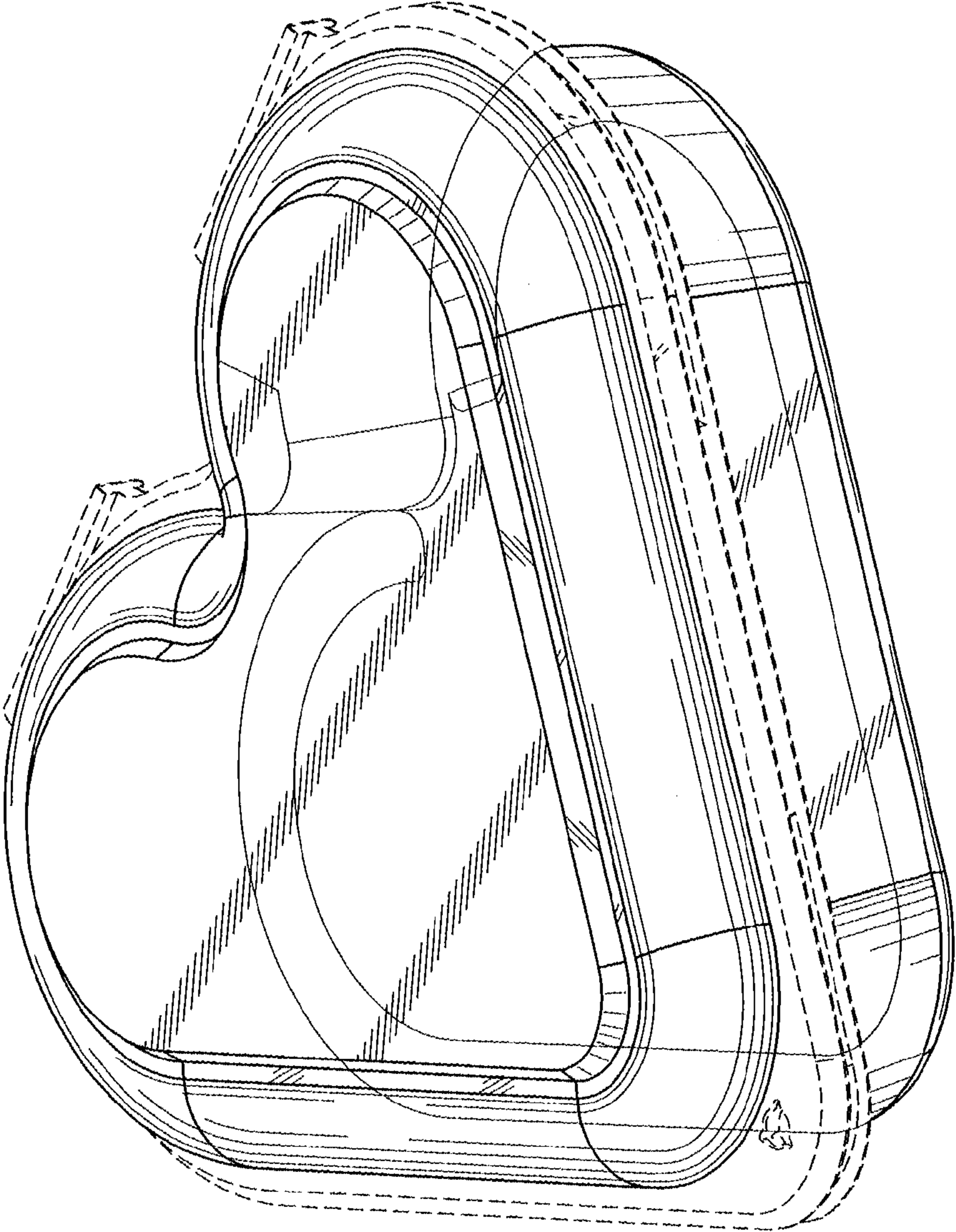

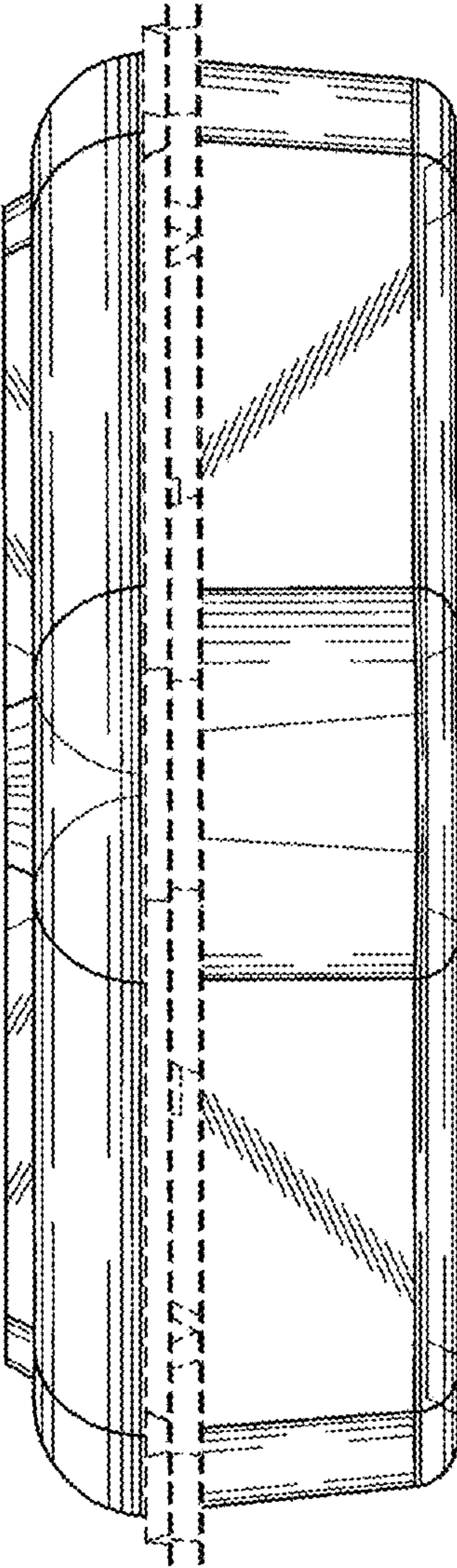

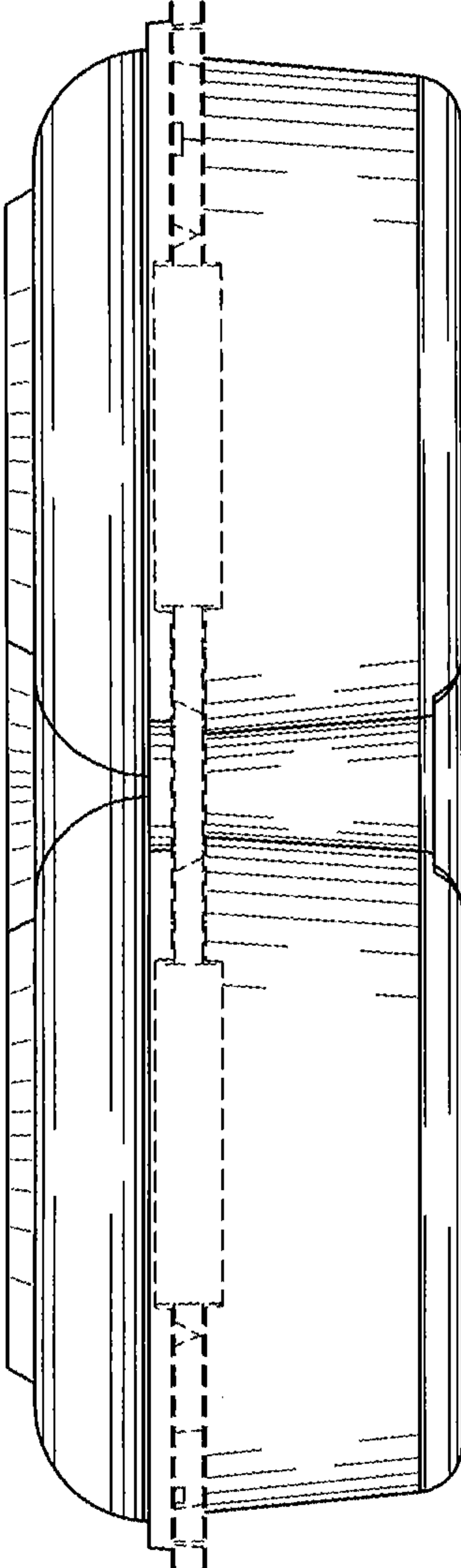

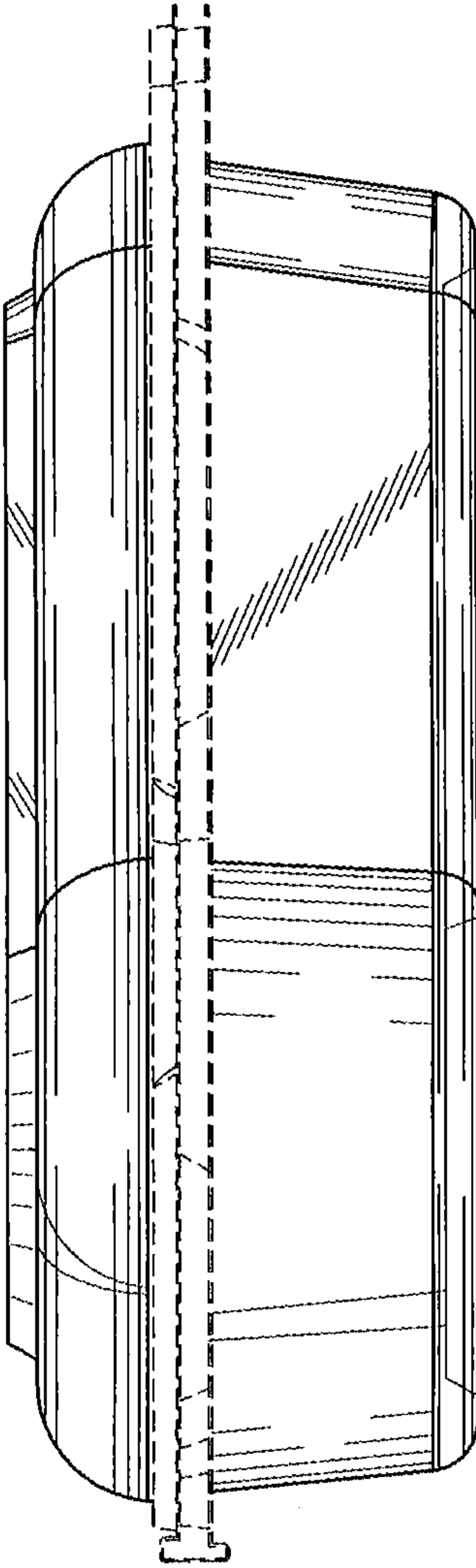

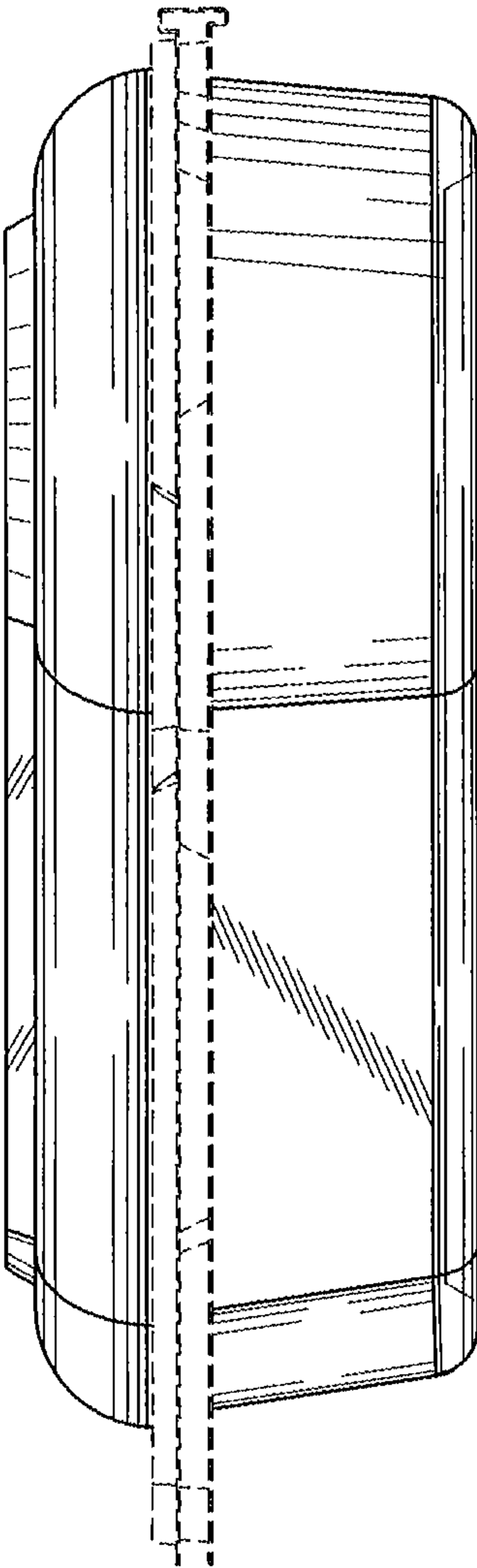

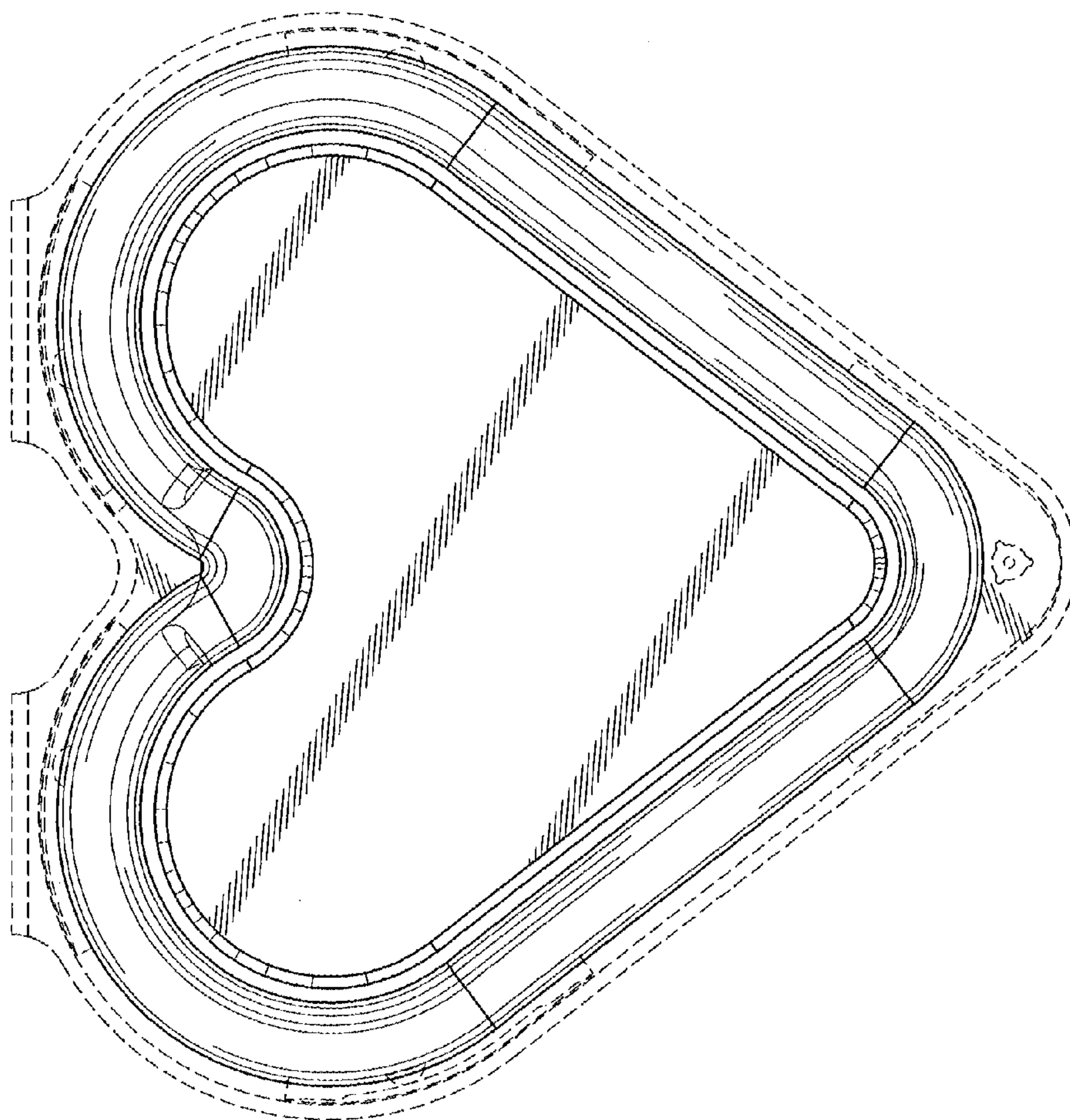

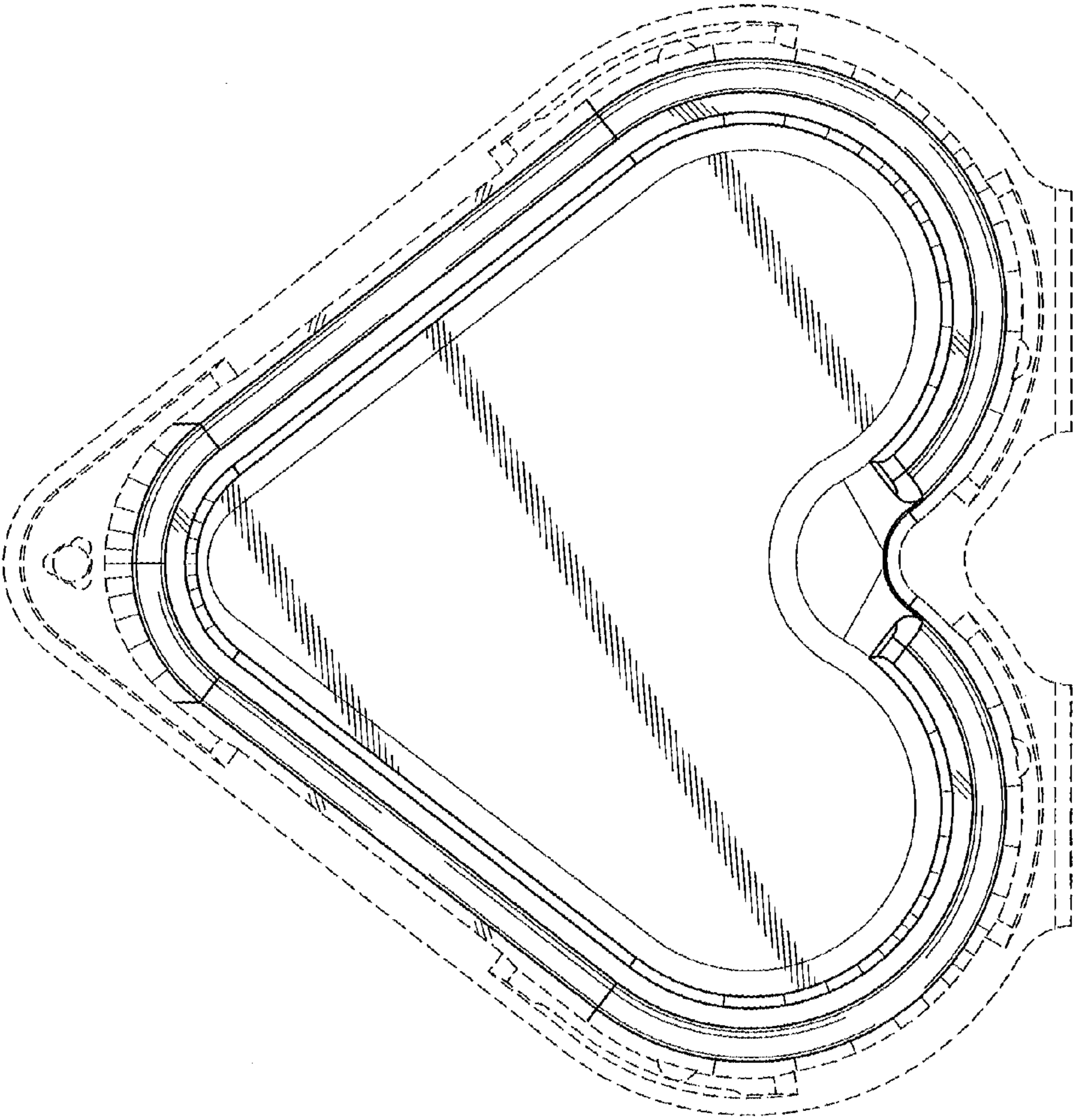
