DESCRIPTION

FIG. 1 is a perspective view from the front and right of an automobile, toy replica and/or other replicas.

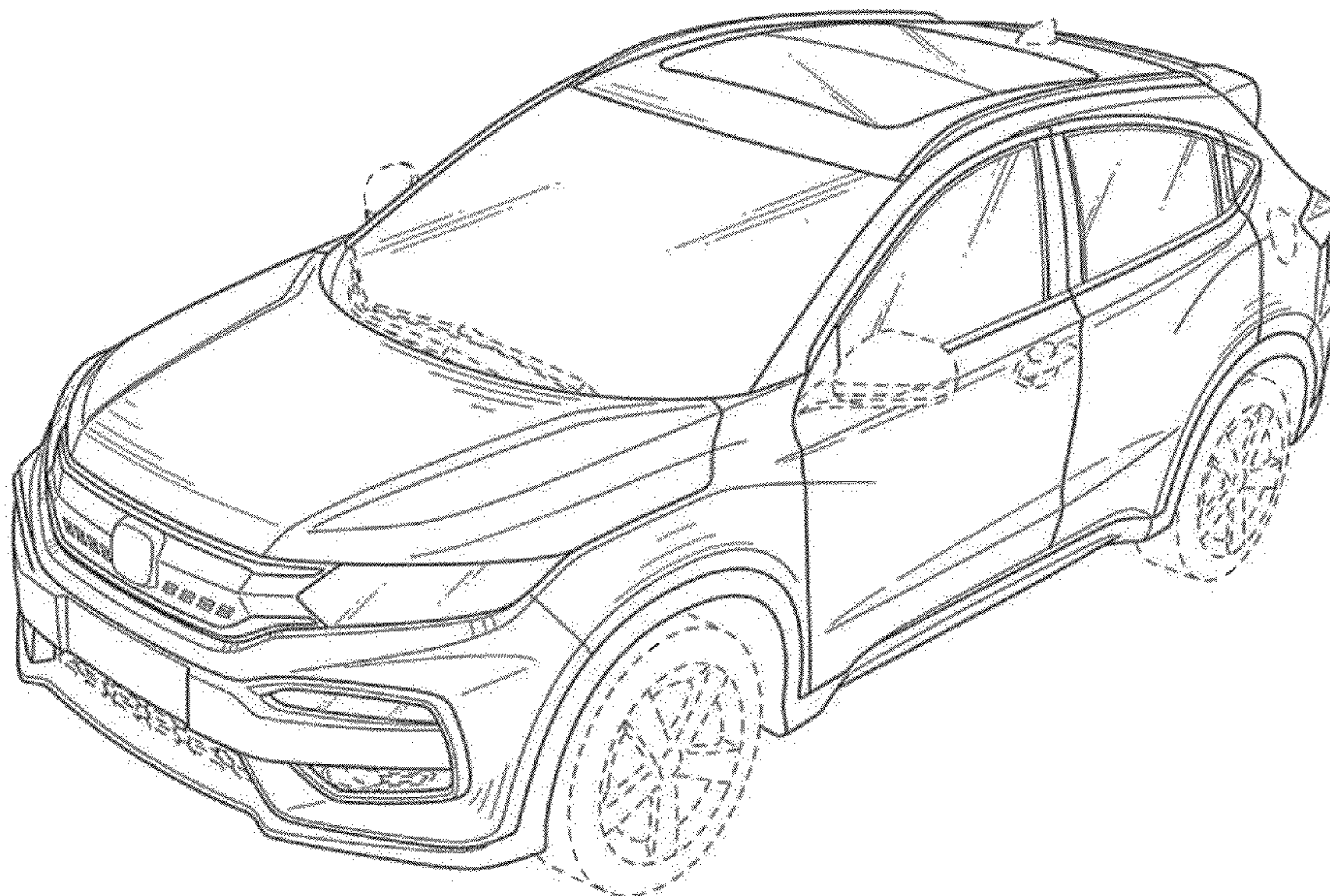

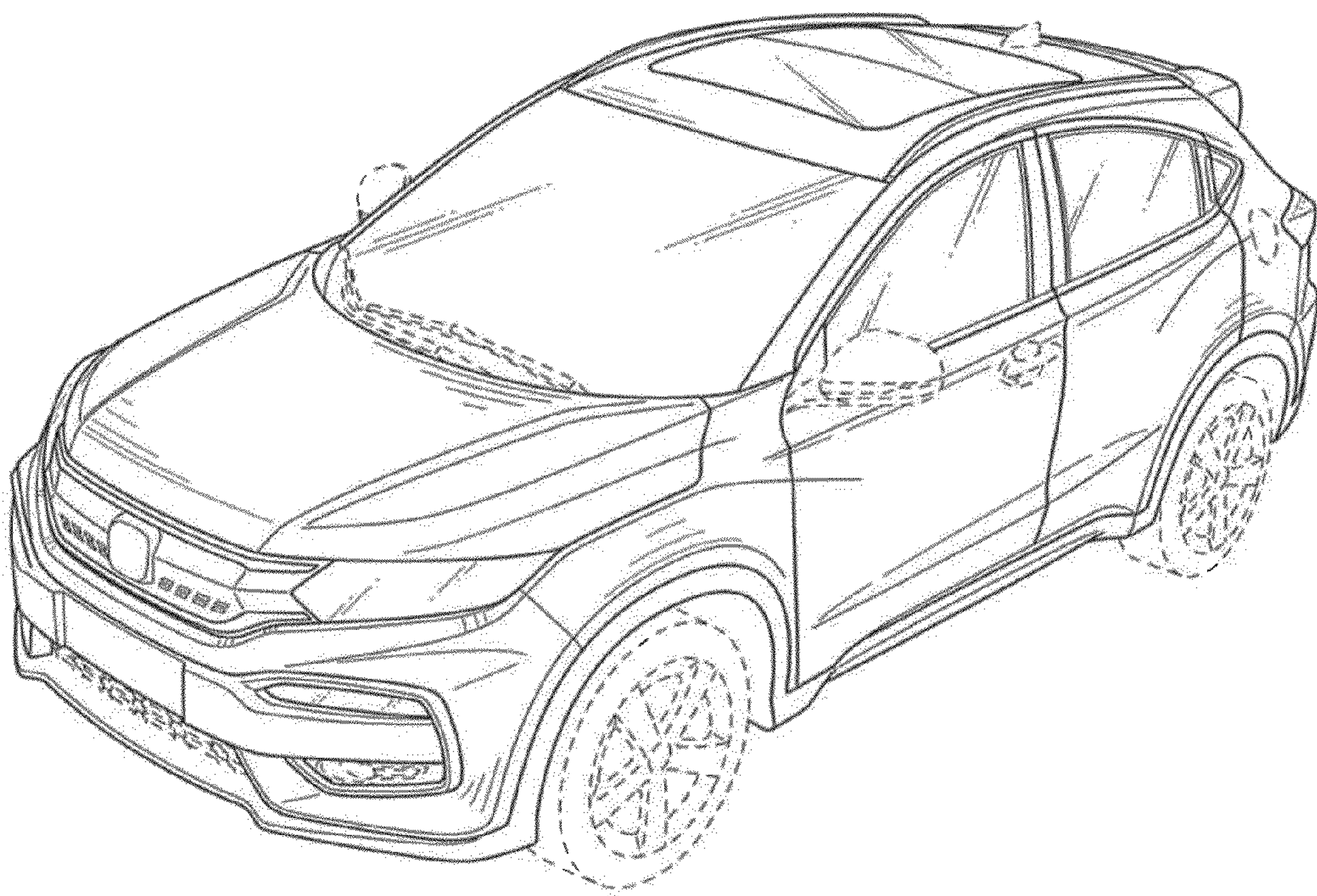

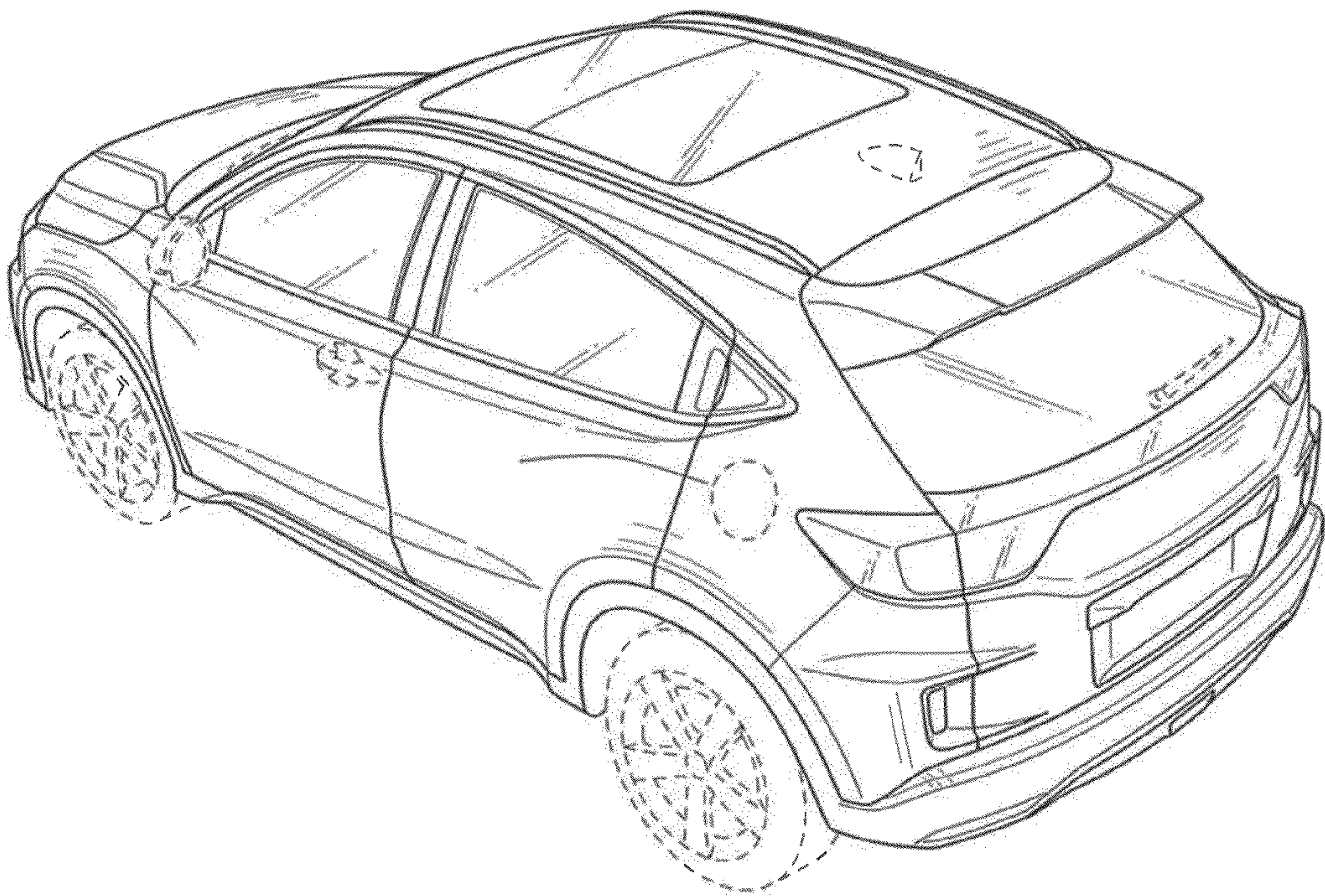

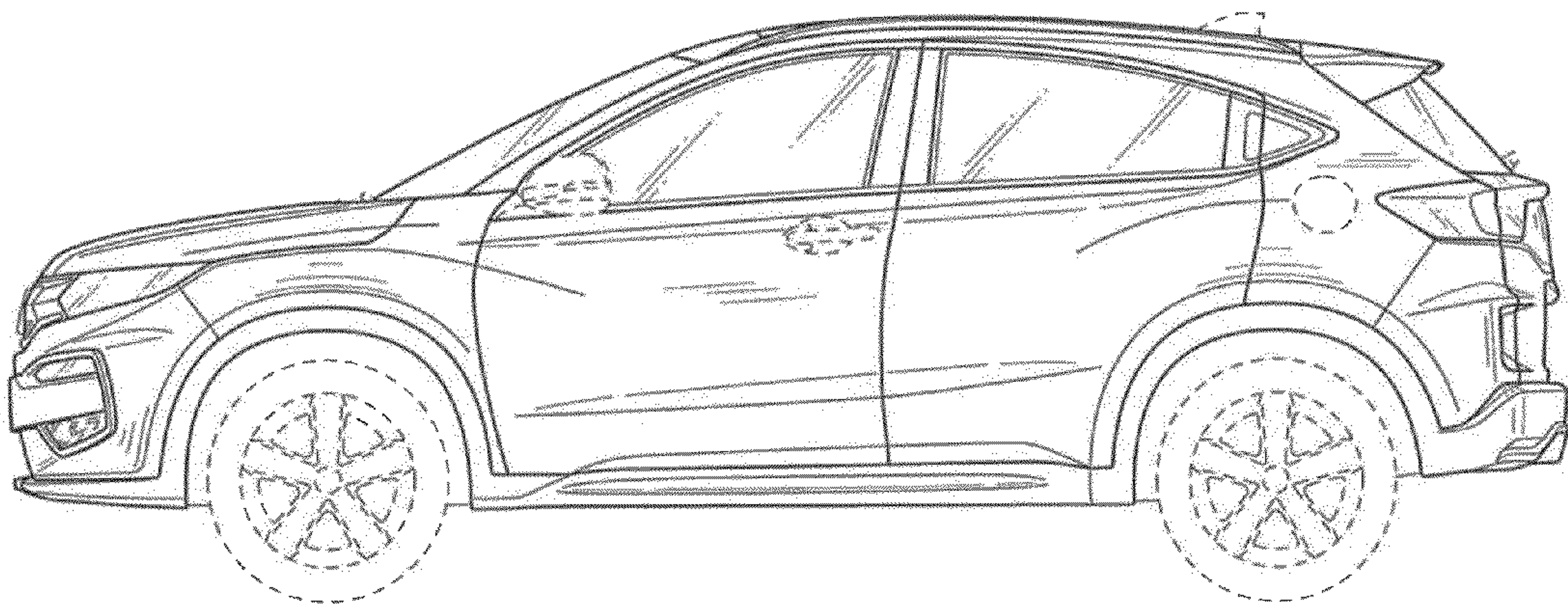

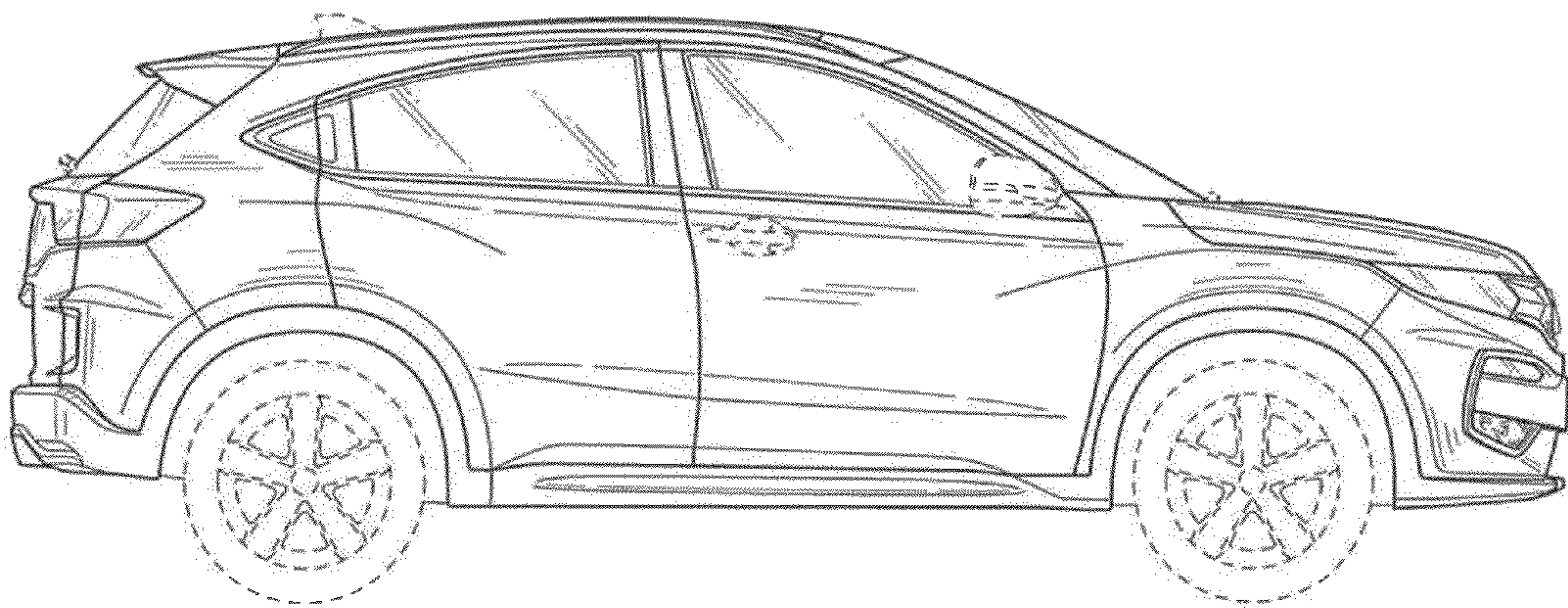

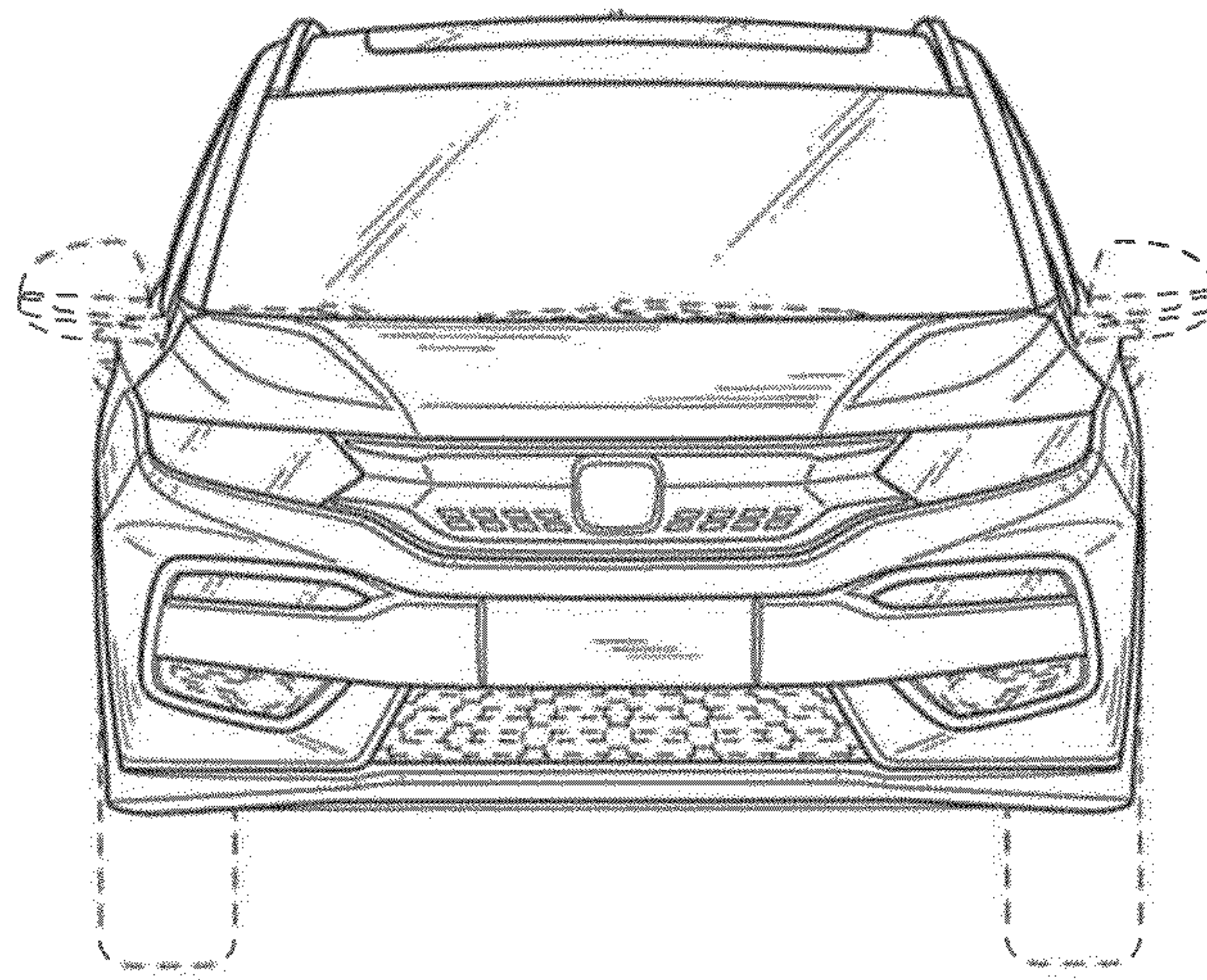

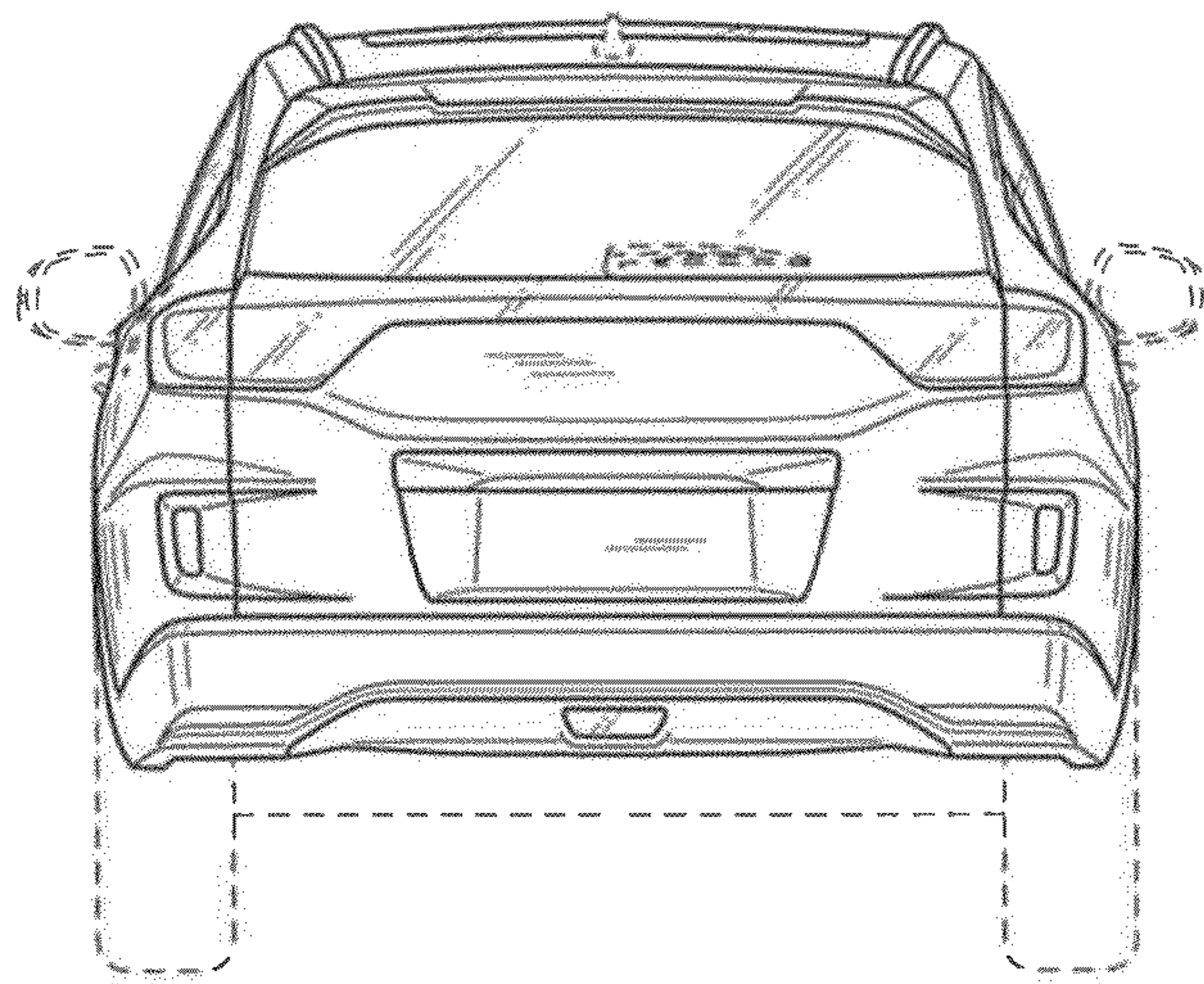
