**DESCRIPTION**

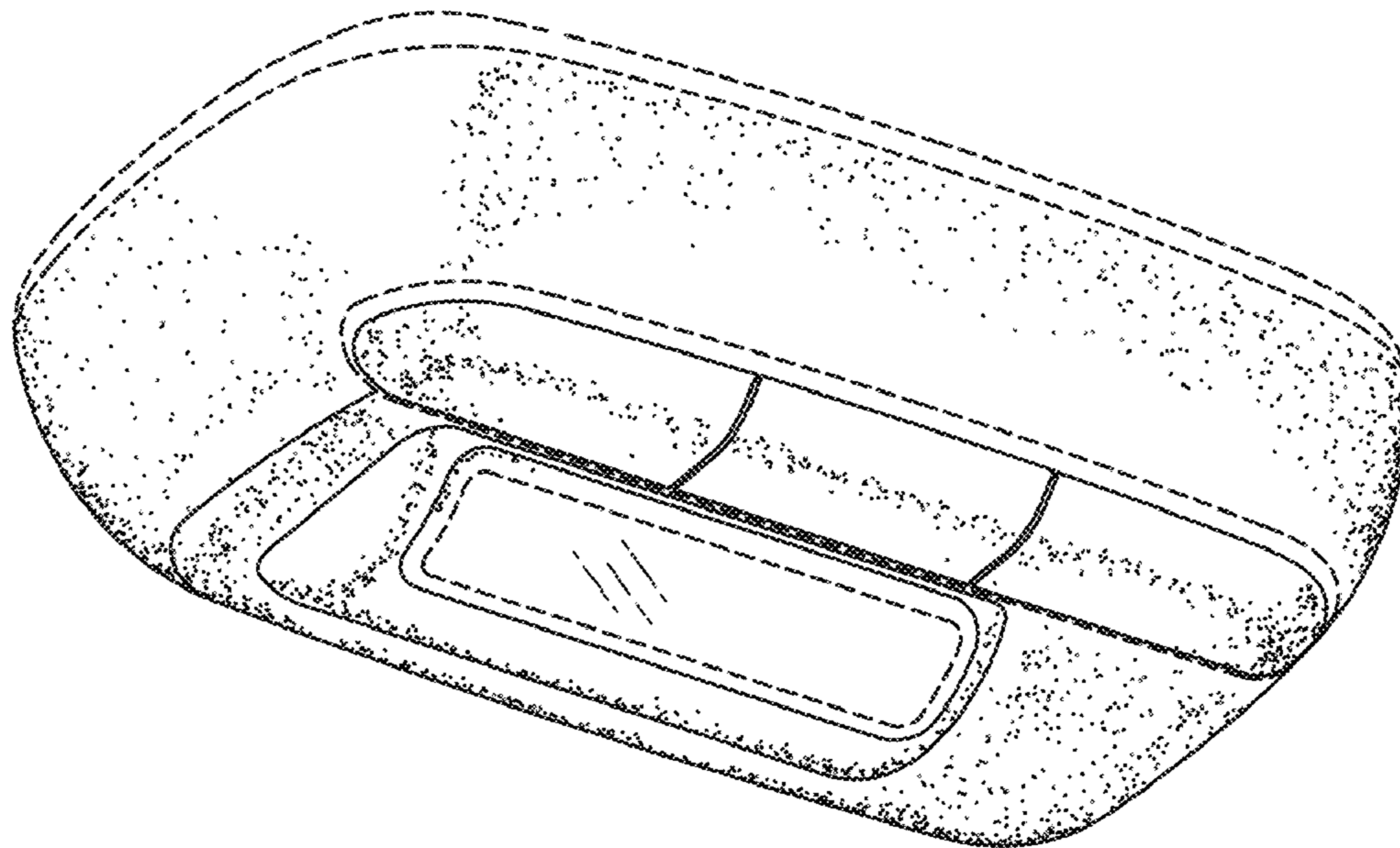
FIG. 1 is a front bottom perspective view of one embodiment of a vehicle module of the present disclosure;

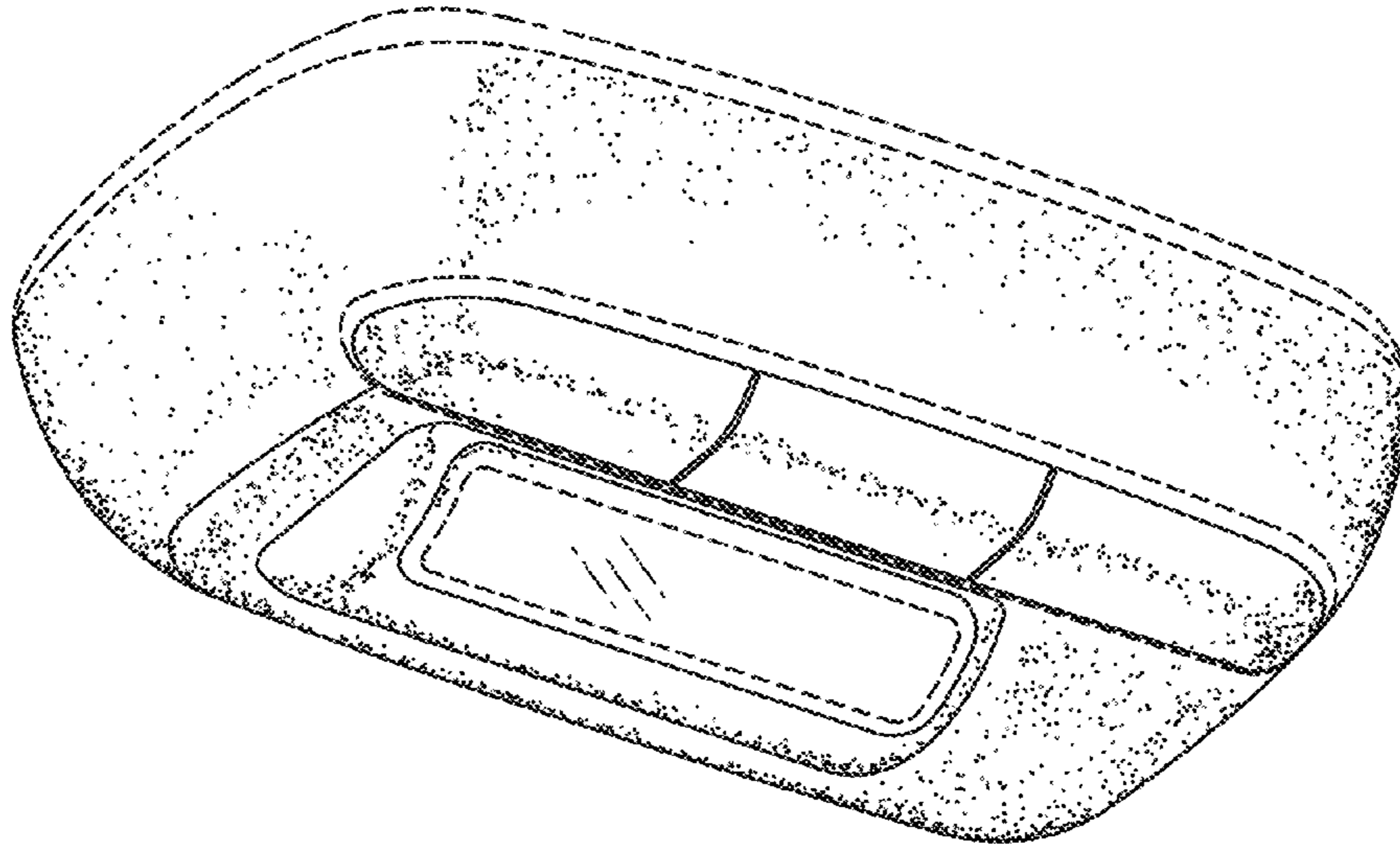

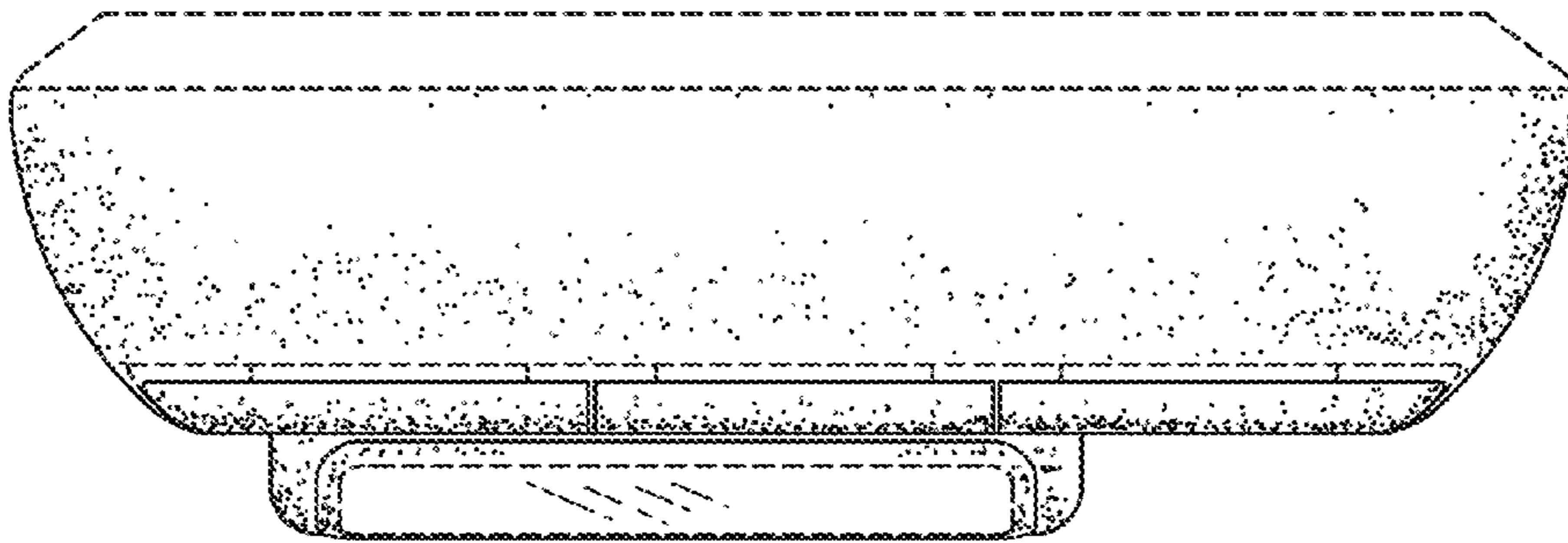

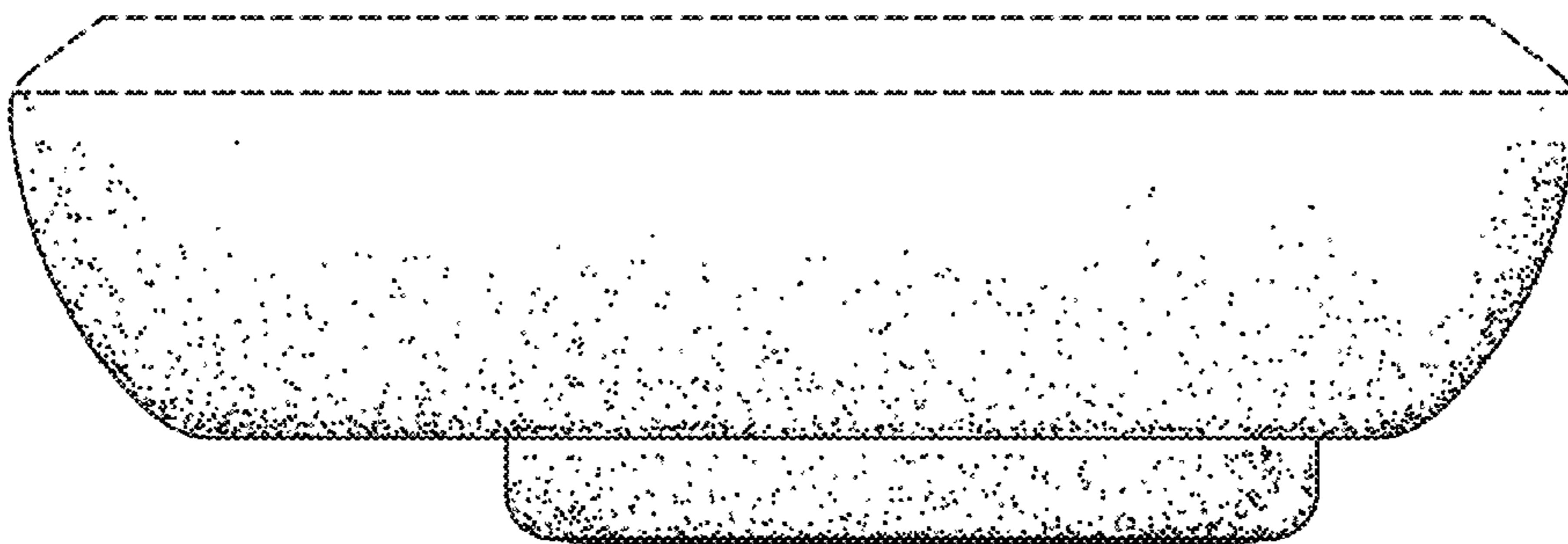

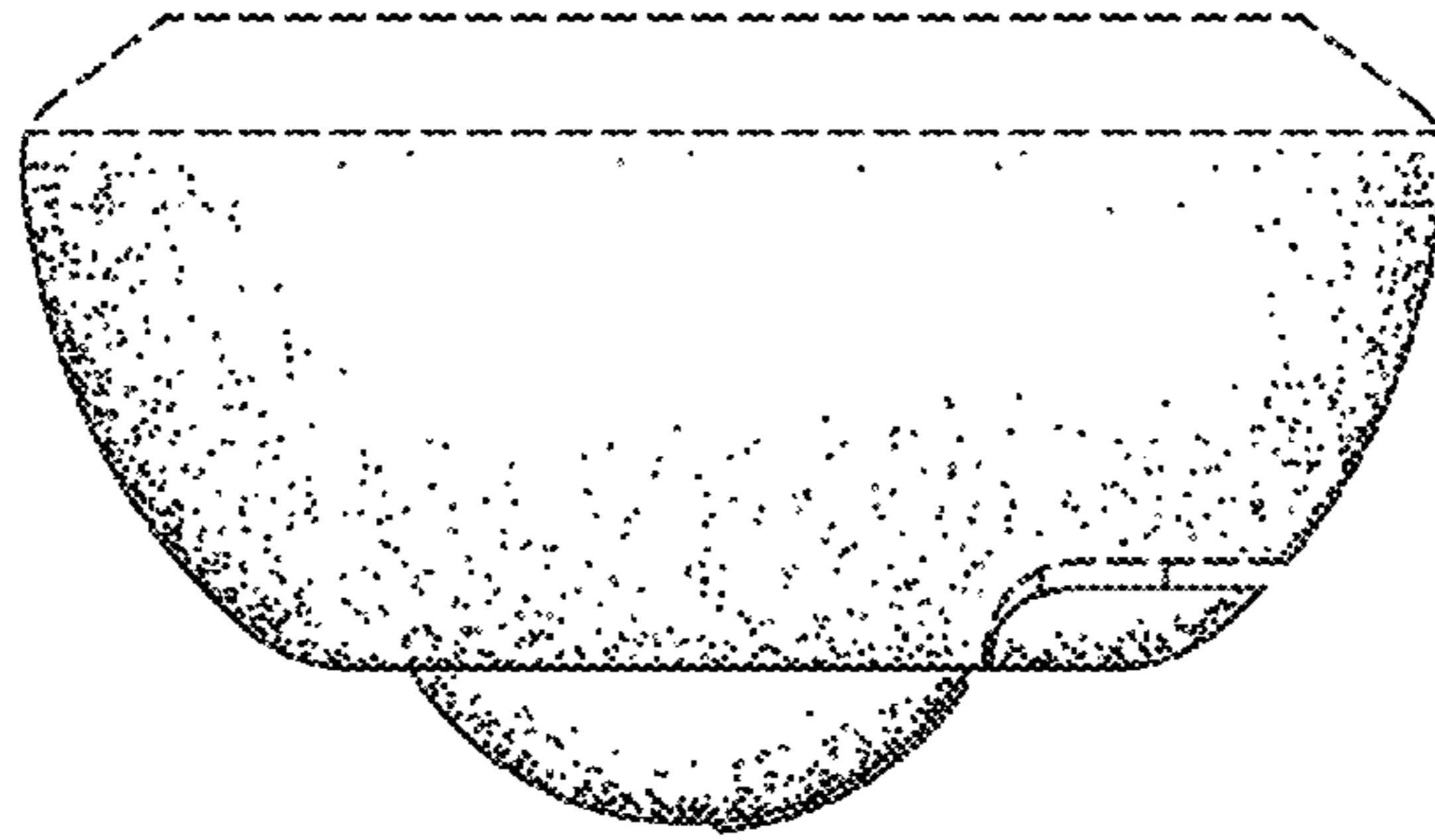

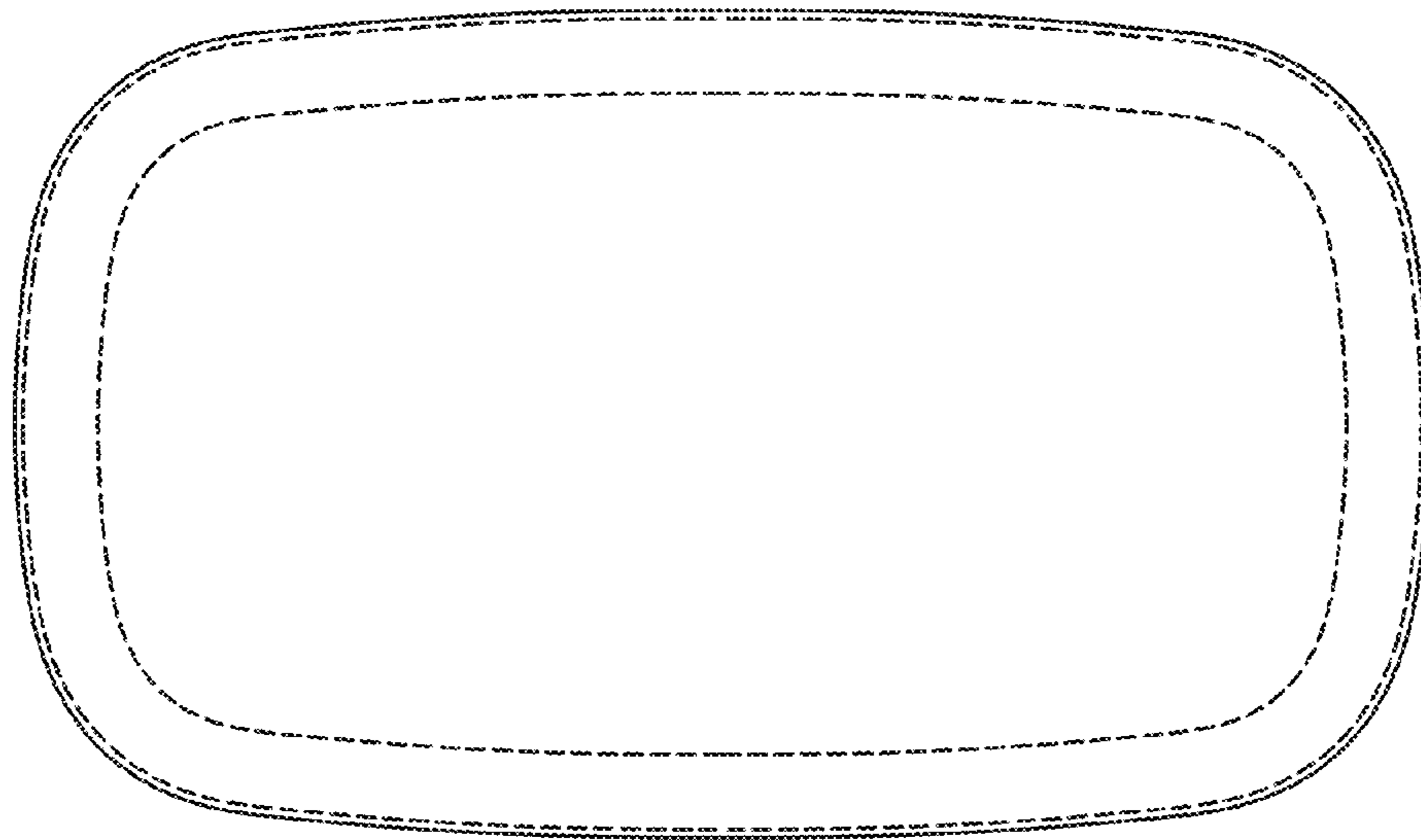

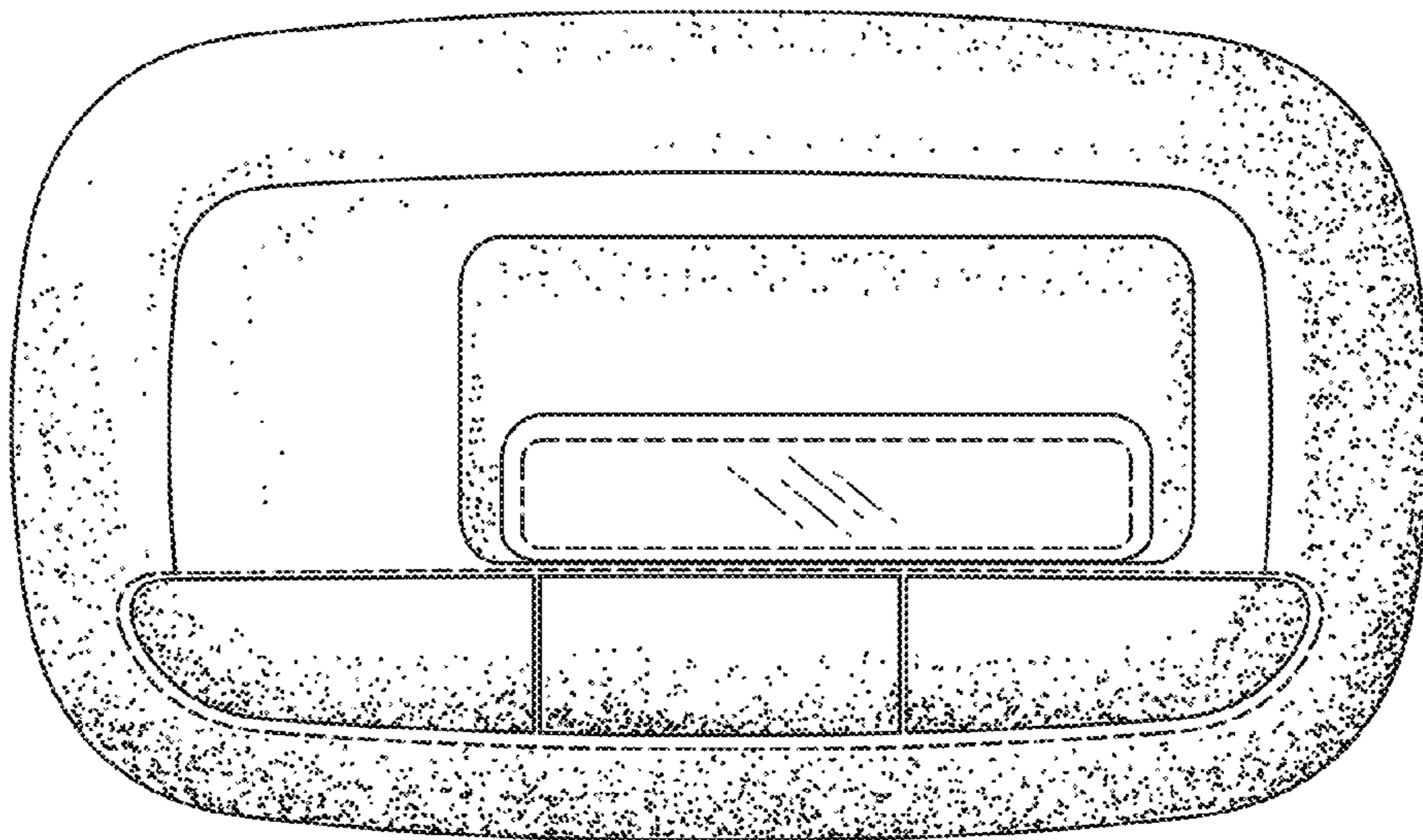
