(57) **CLAIM**

I claim the ornamental design for a tire tread, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a section of a tire tread as defined by lines A-A and B-B;

FIG. 2 is an enlarged view of the section of the tire tread defined by lines A-A and B-B in FIG. 1;

FIG. 3 is a front view of a section of the tire tread as defined by lines C-C and D-D;

FIG. 4 is an enlarged view of the section of the tire tread defined by lines C-C and D-D in FIG. 3;

FIG. 5 is a side view of a section of the tire tread as defined by lines E-E and F-F;

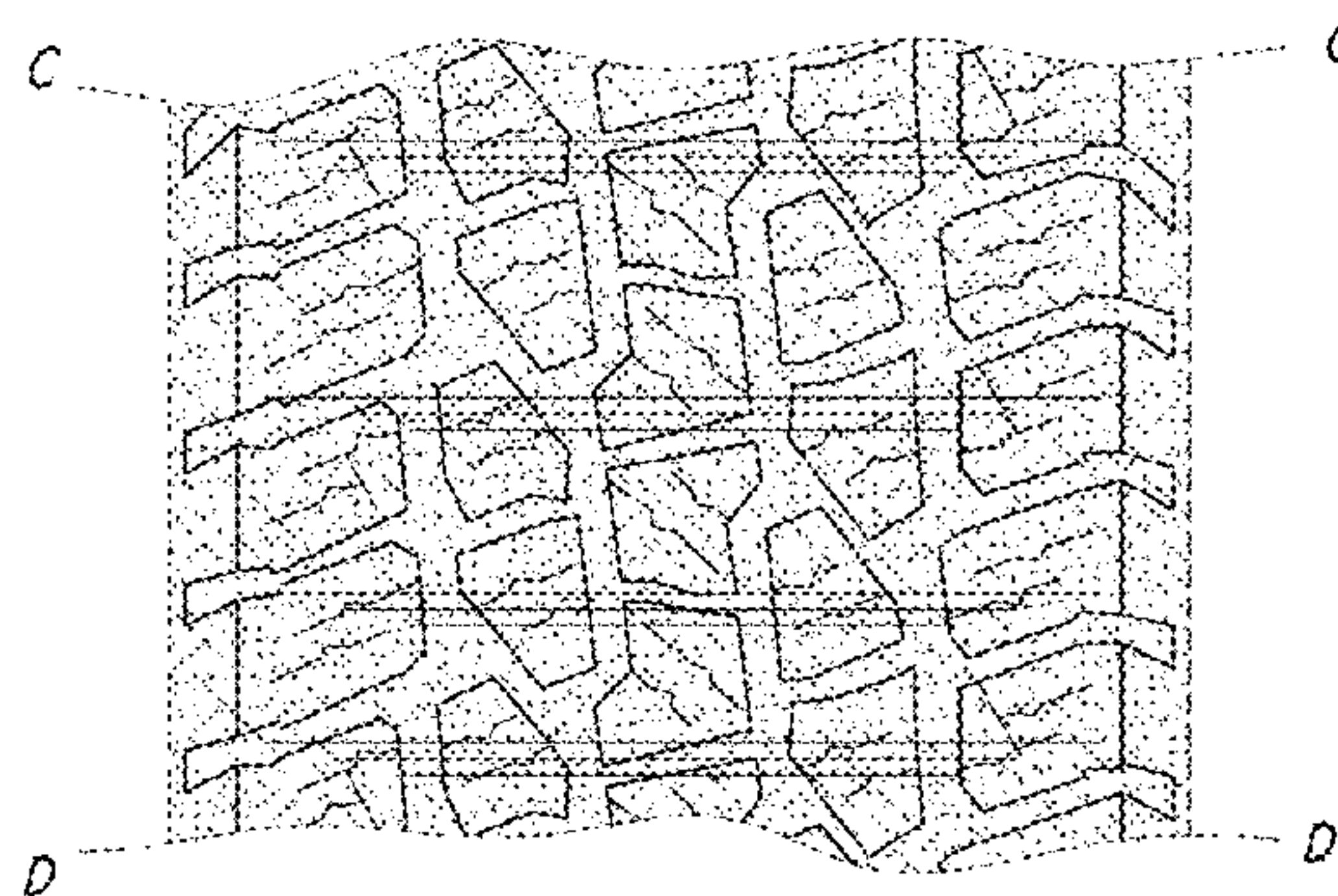
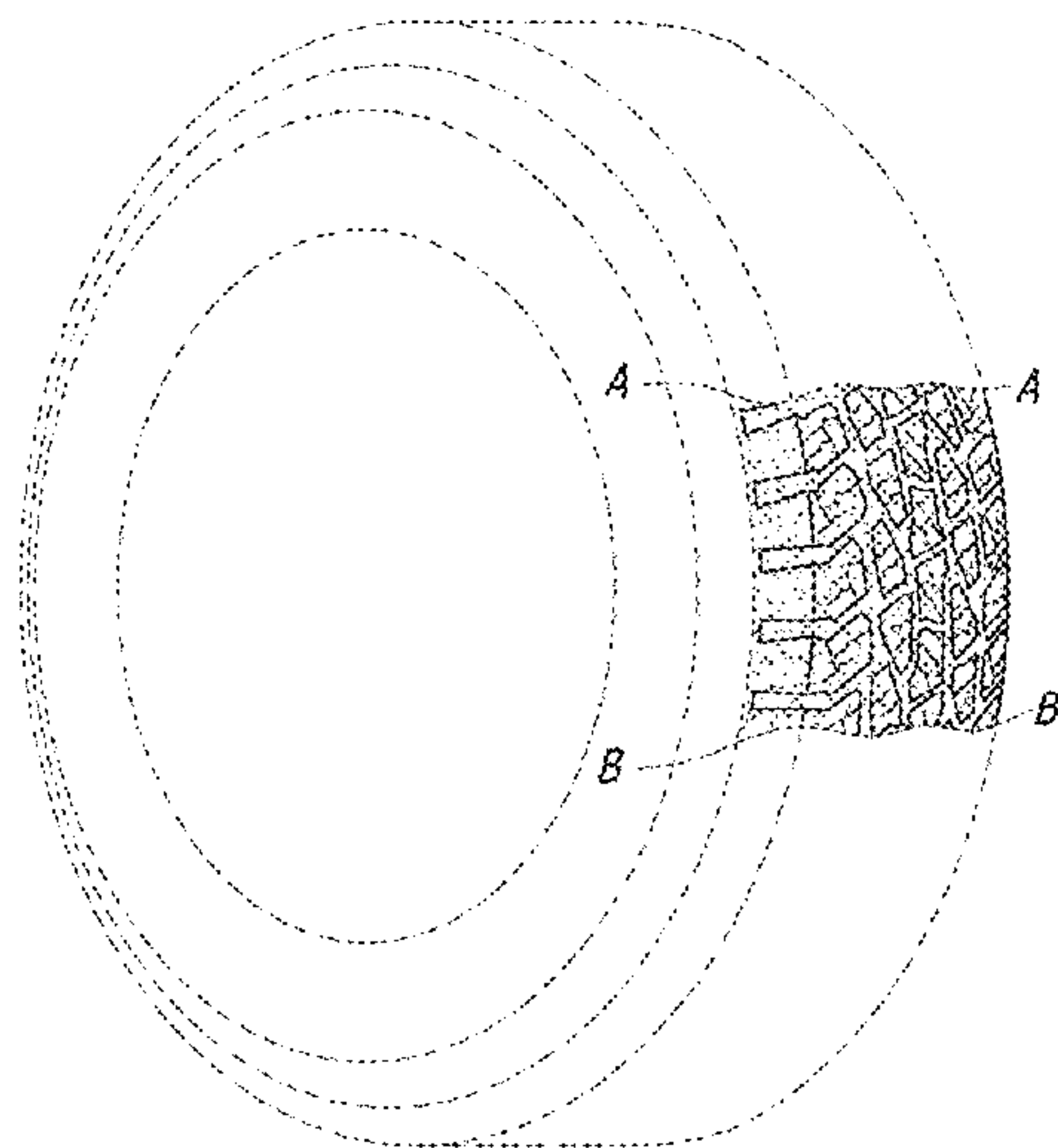
FIG. 6 is an enlarged view of the section of the tire tread defined by lines E-E and F-F;

FIG. 7 is another side view of a section of the tire tread as defined by lines G-G and H-H; and,

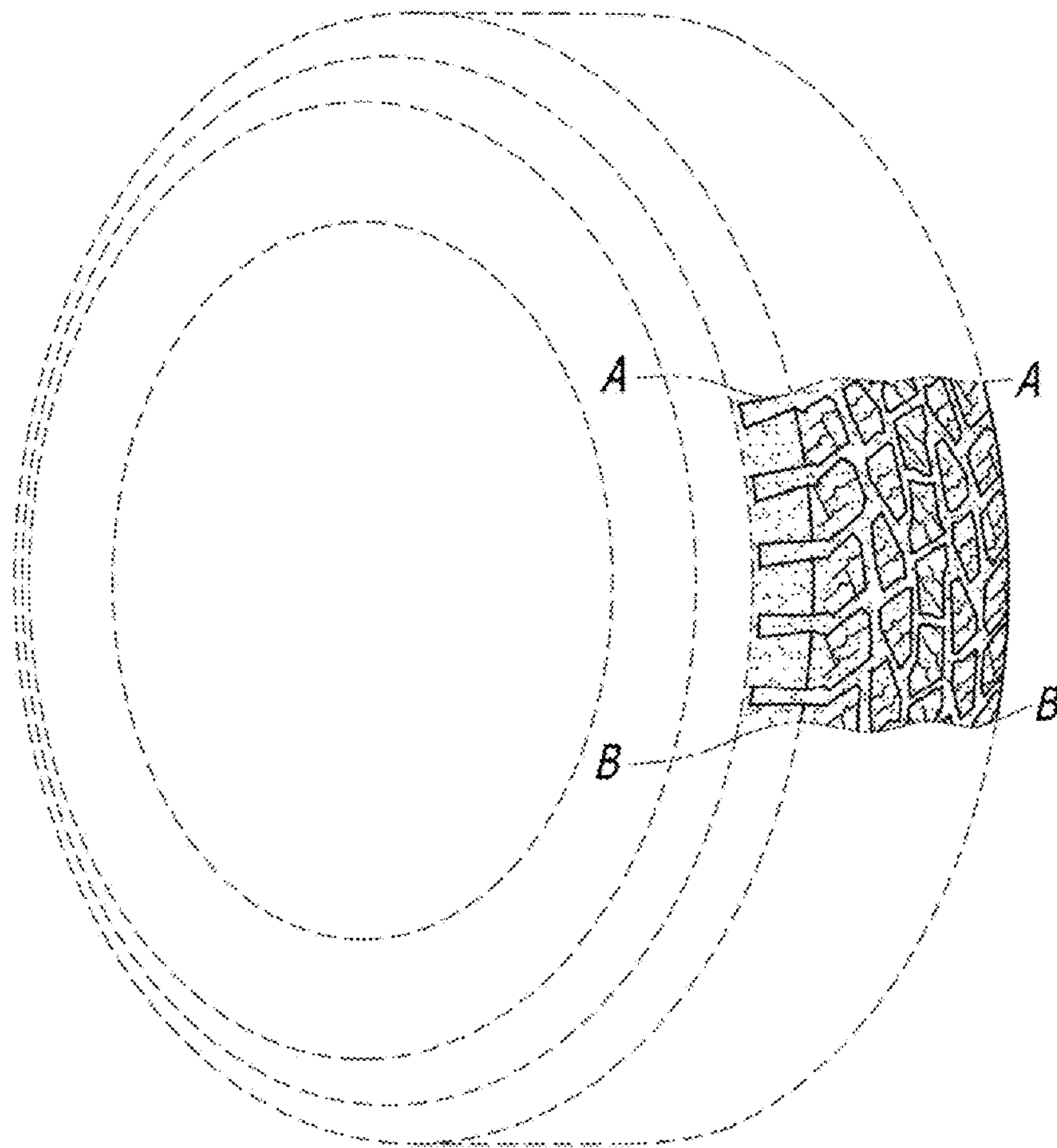

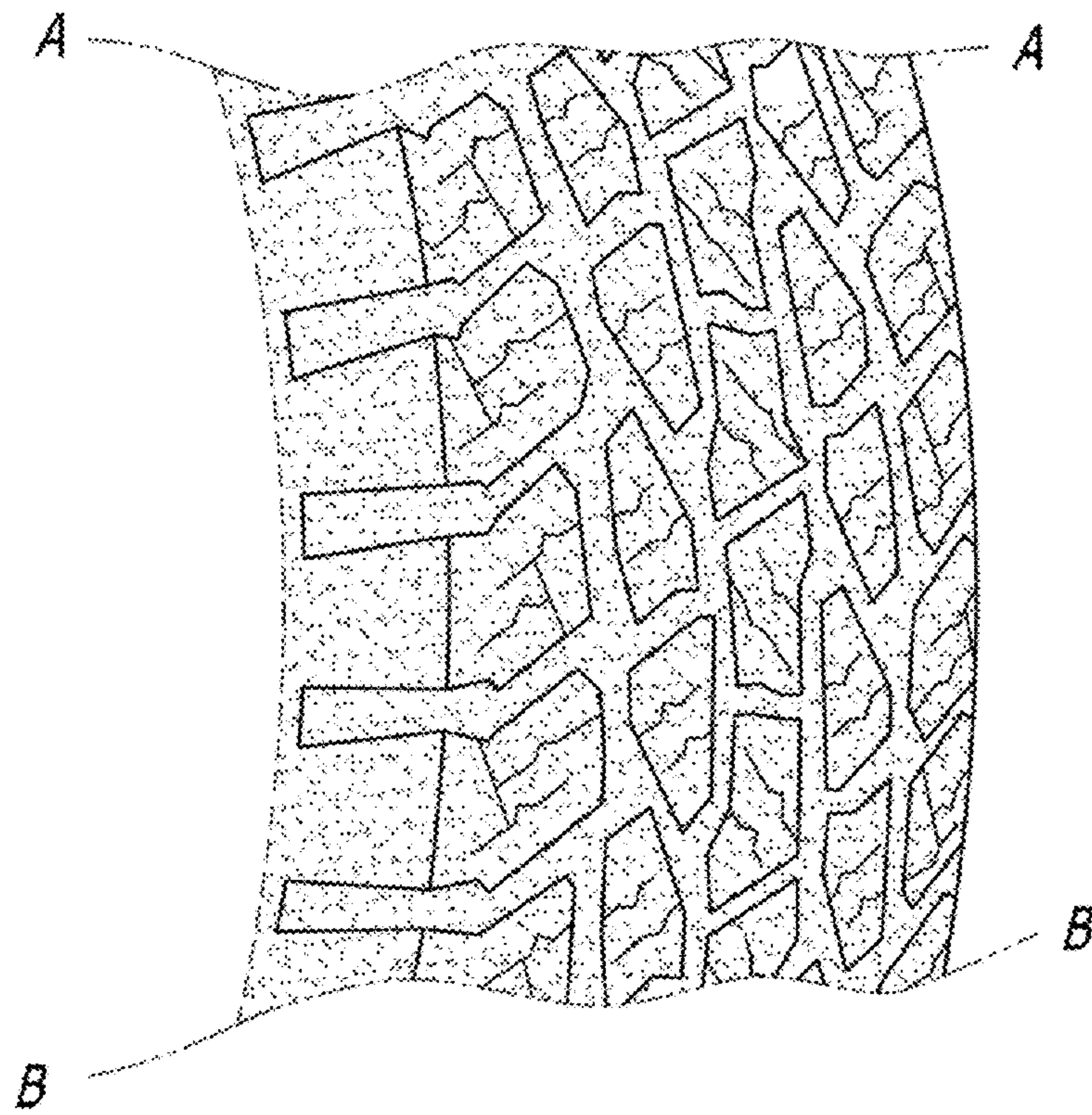

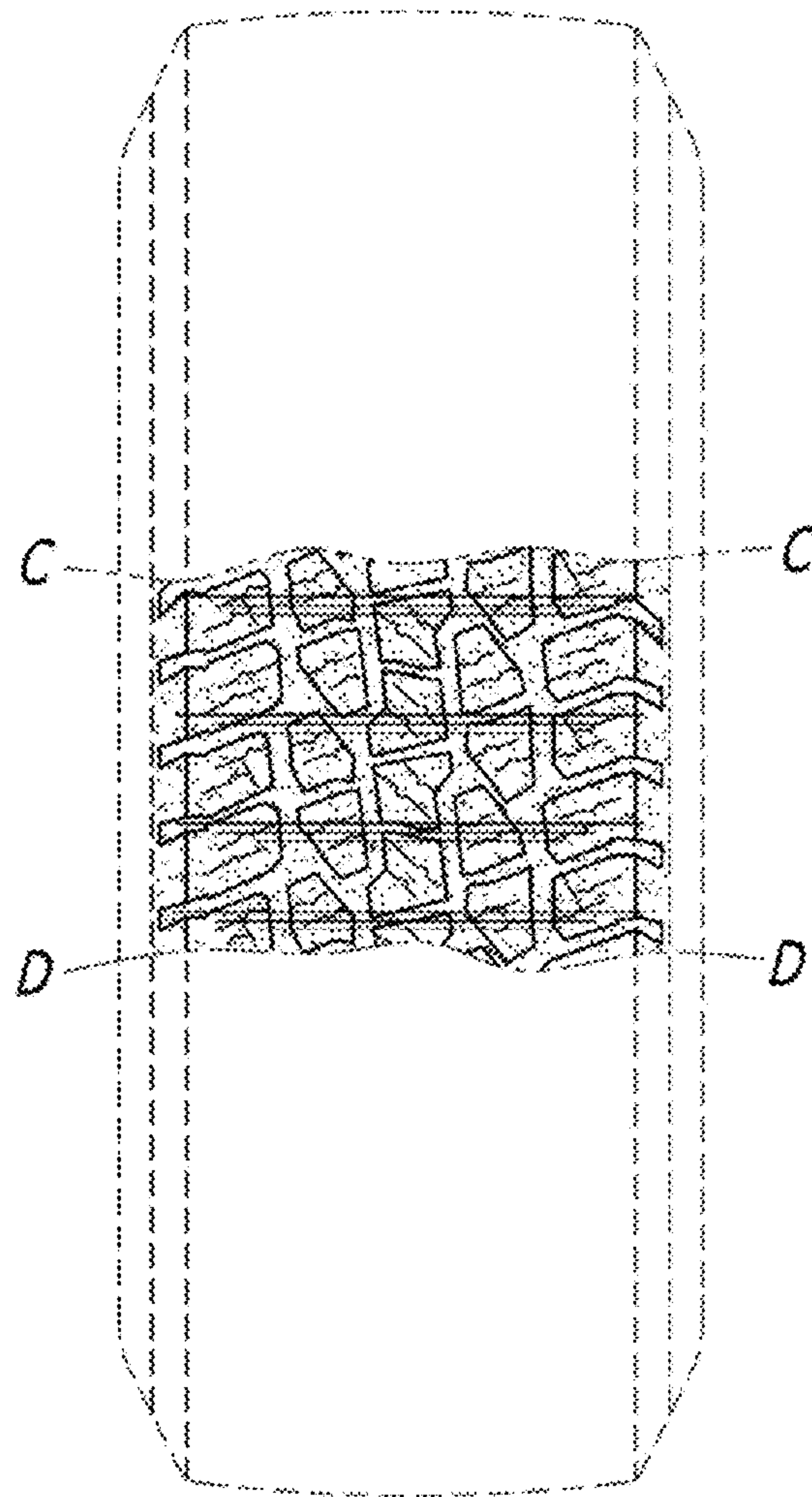

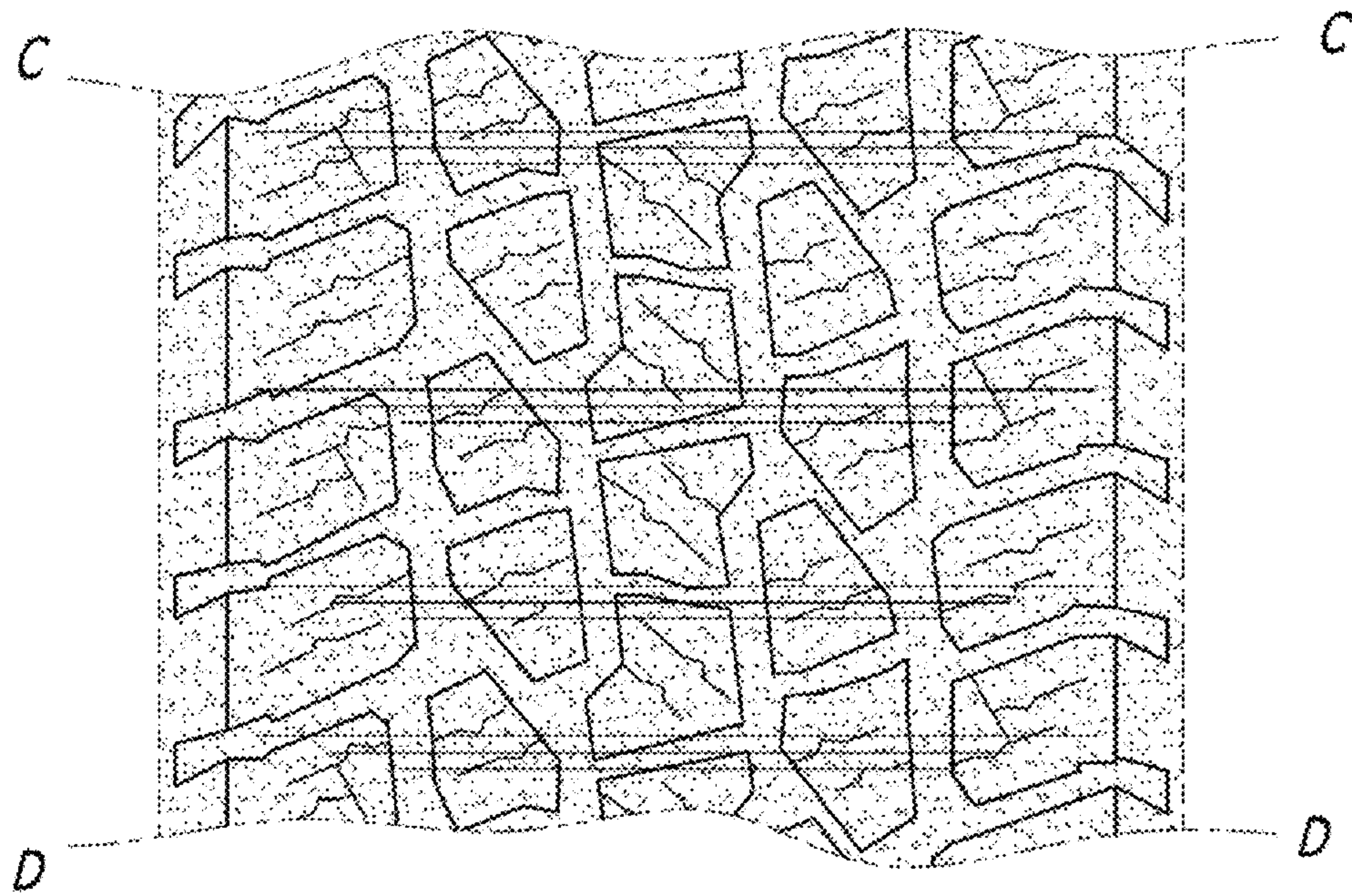

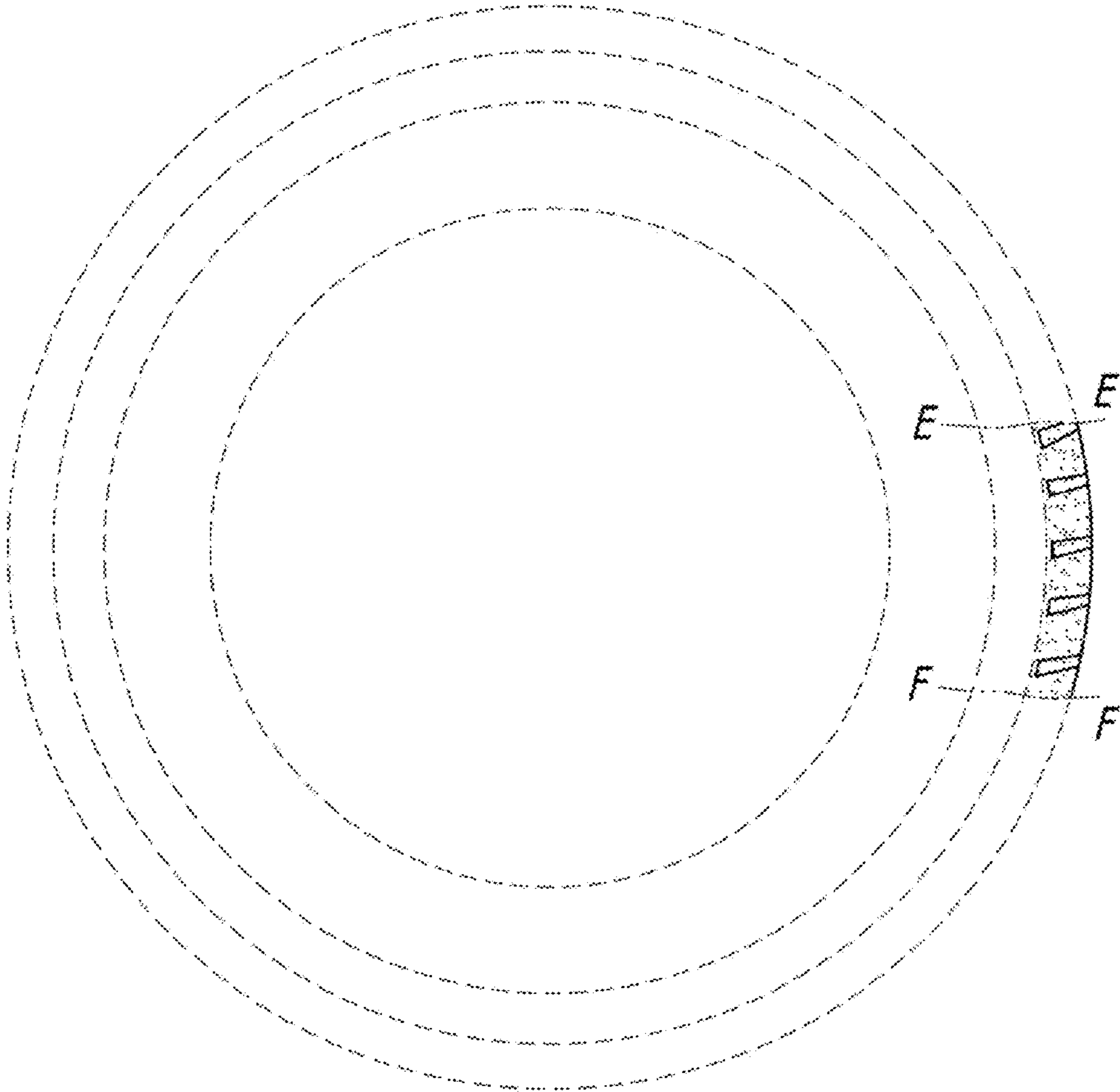

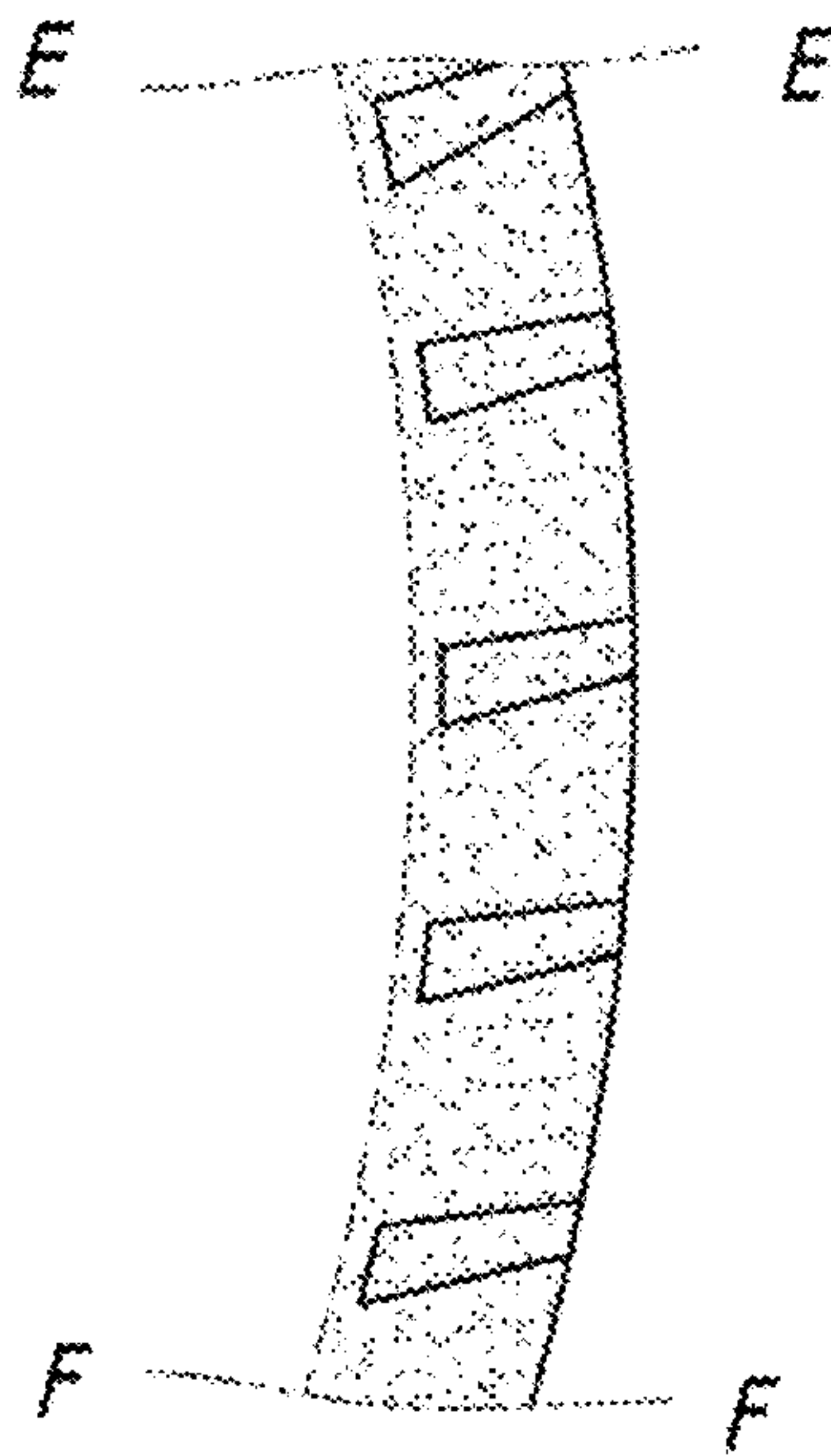

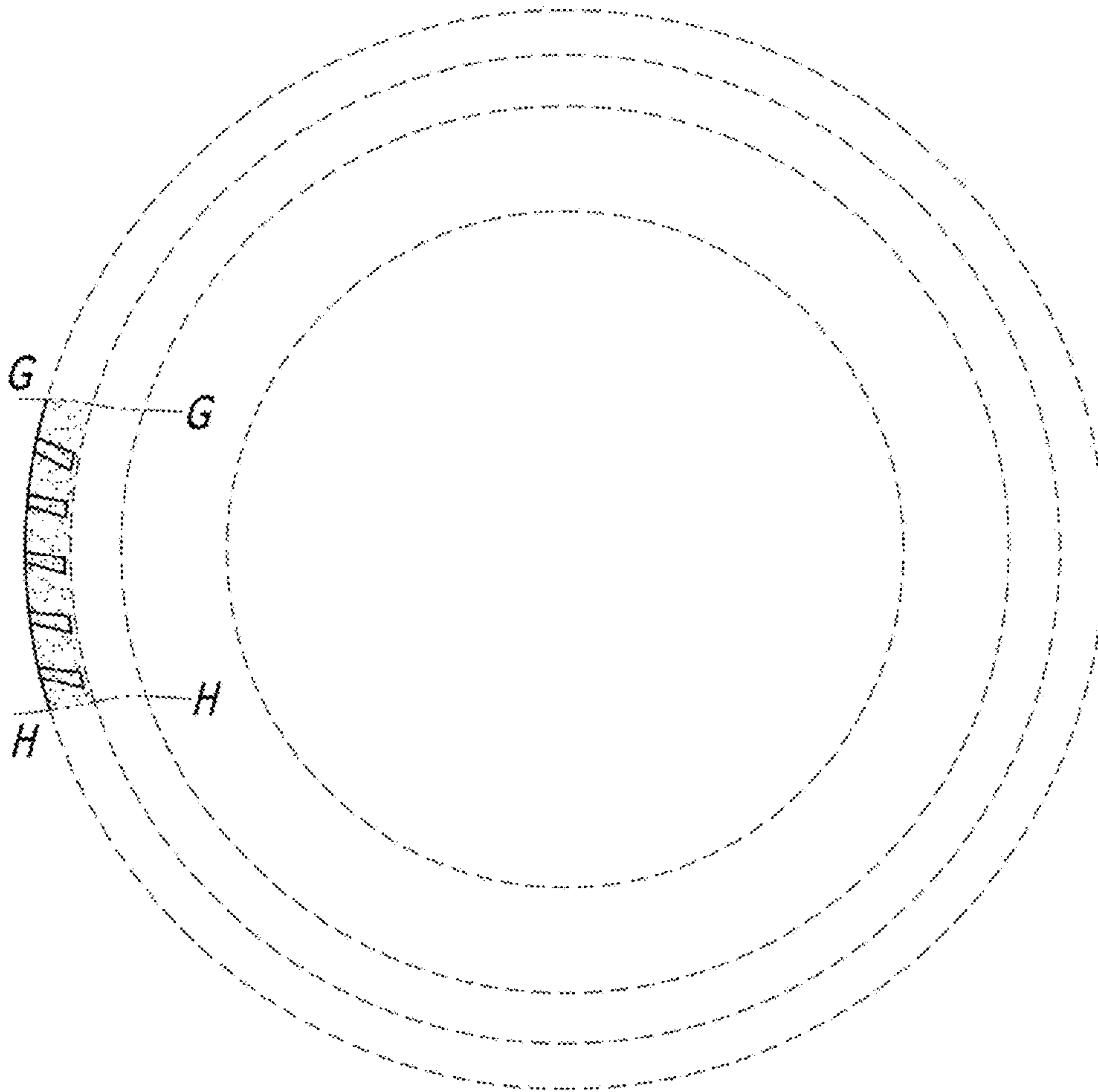

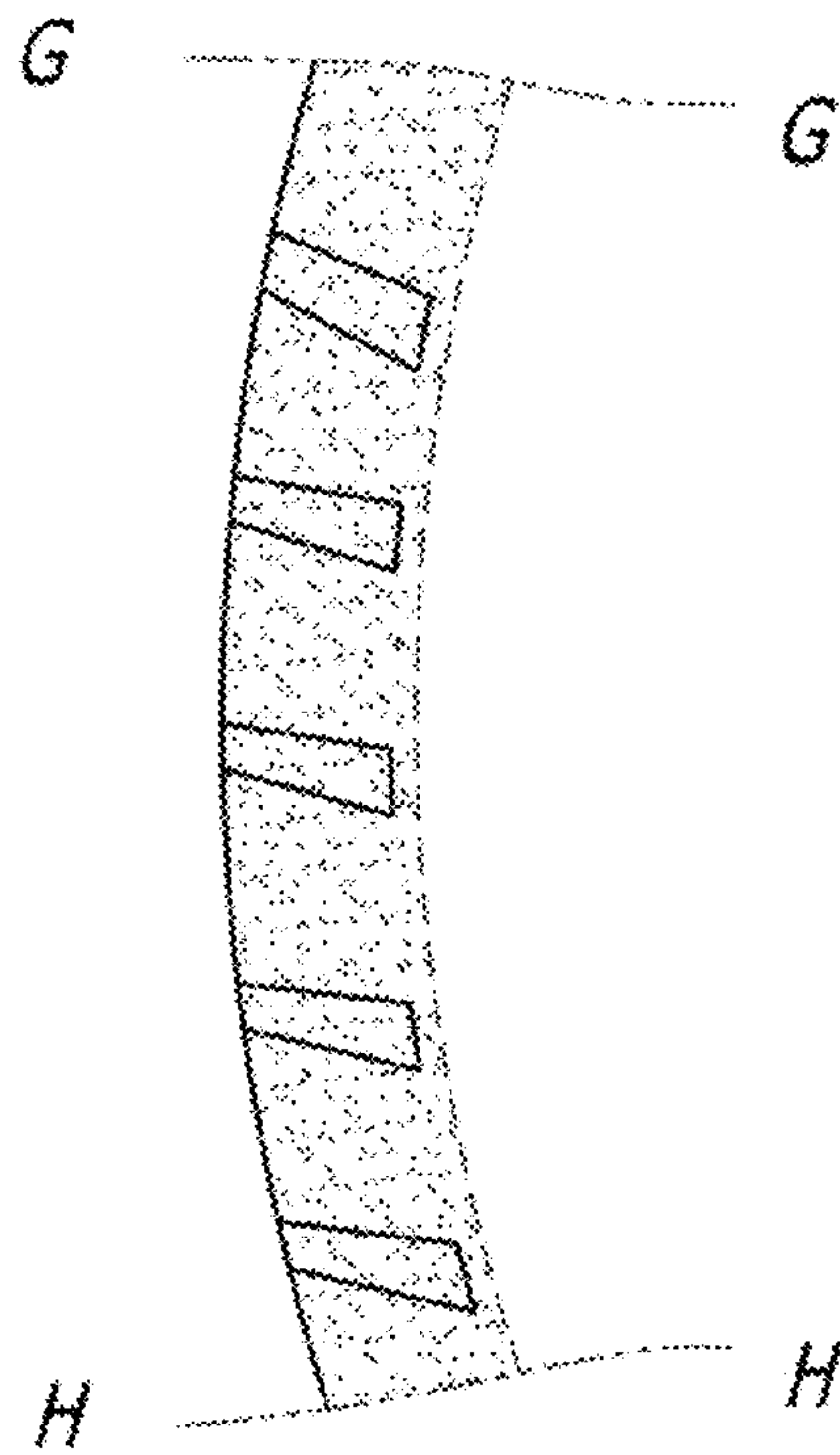
