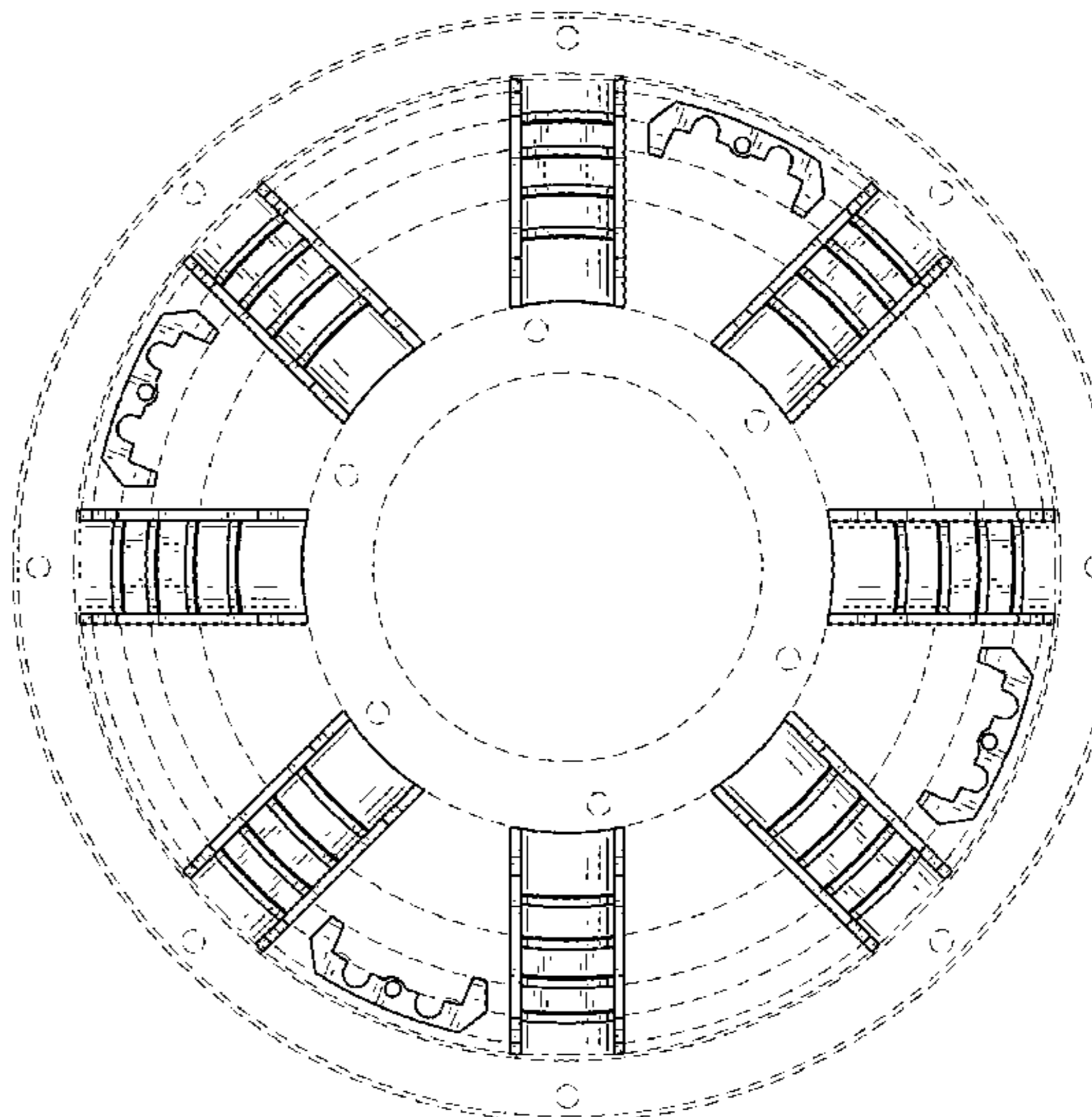
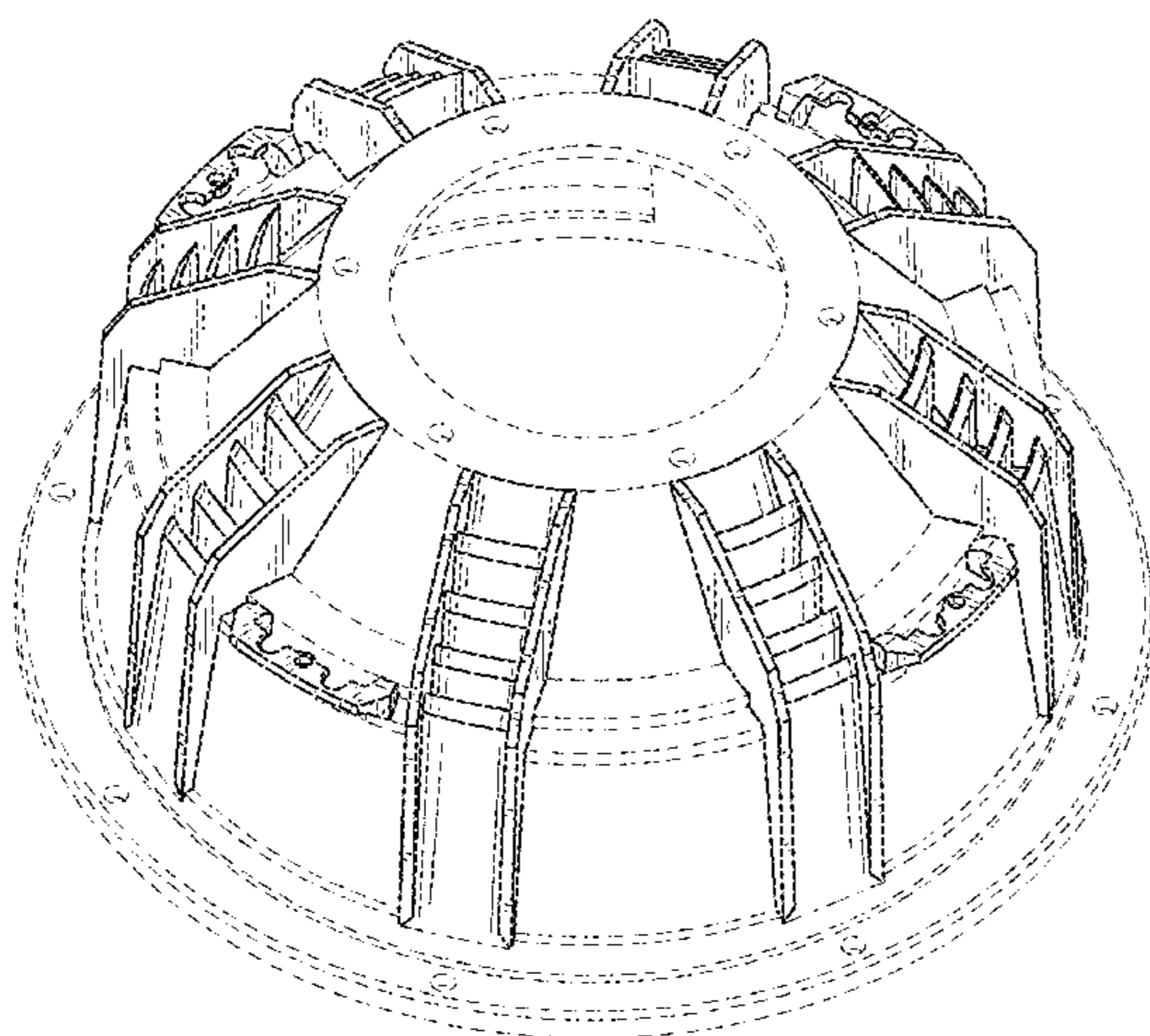

DESCRIPTION

FIG. 1 is a front perspective view of a speaker basket; FIG. 2 is a front elevation view of the speaker basket; a rear elevation view, a left side elevation view, and a right side elevation view all being identical images thereof; FIG. 3 is a top plan view of the speaker basket; and, FIG. 4 is a bottom plan view of the speaker basket. The broken lines shown in the drawings illustrate portions of the speaker basket that form no part of the claimed design.

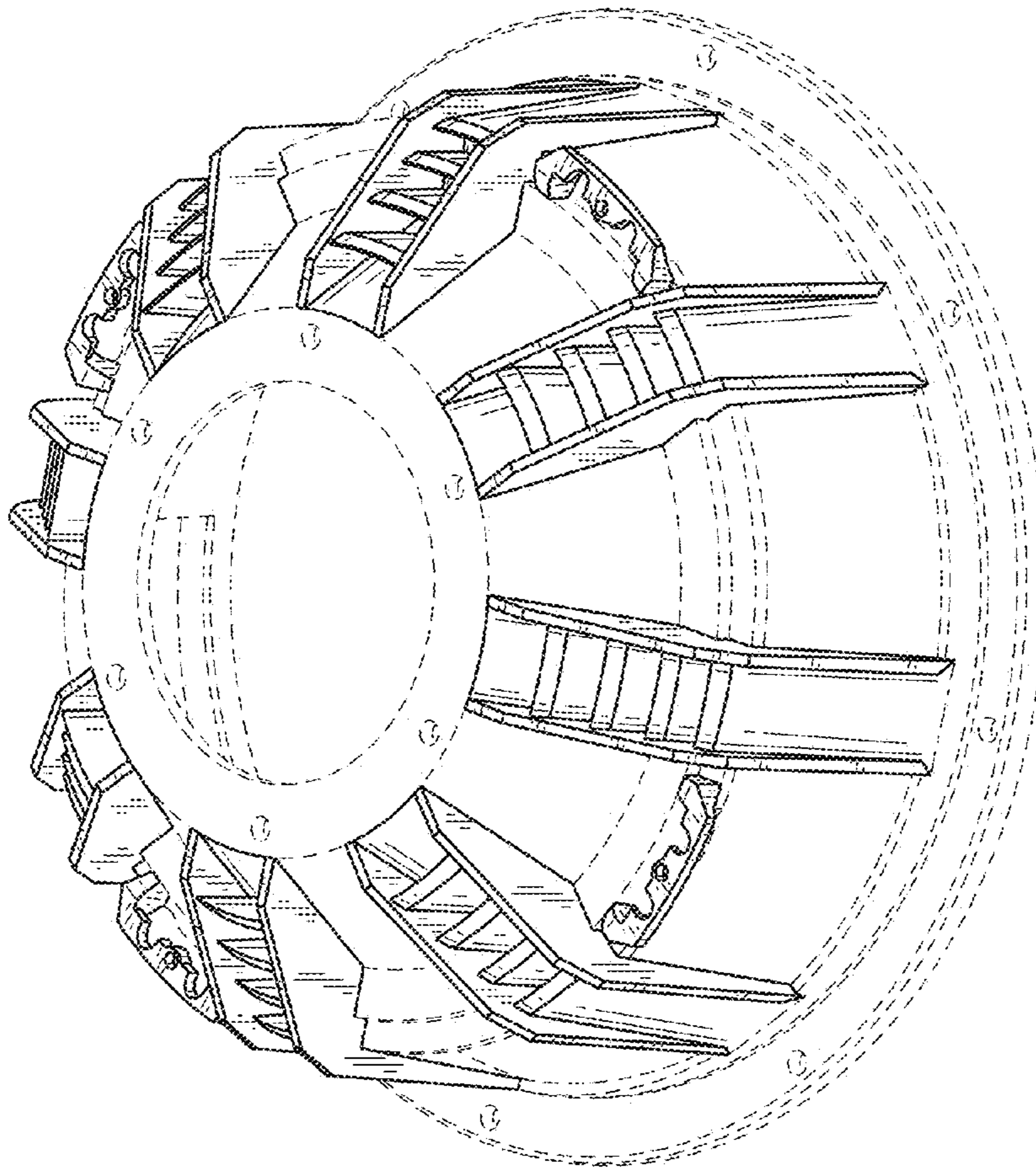

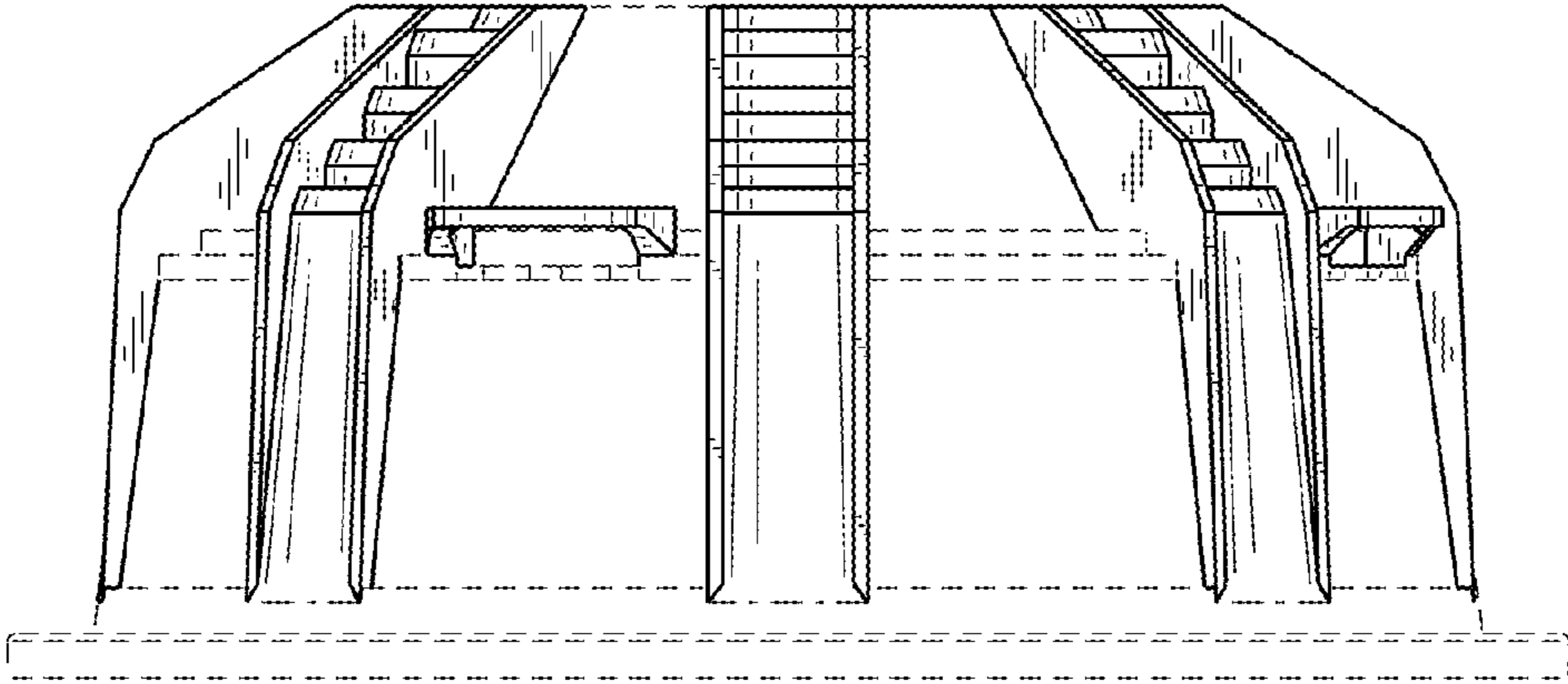
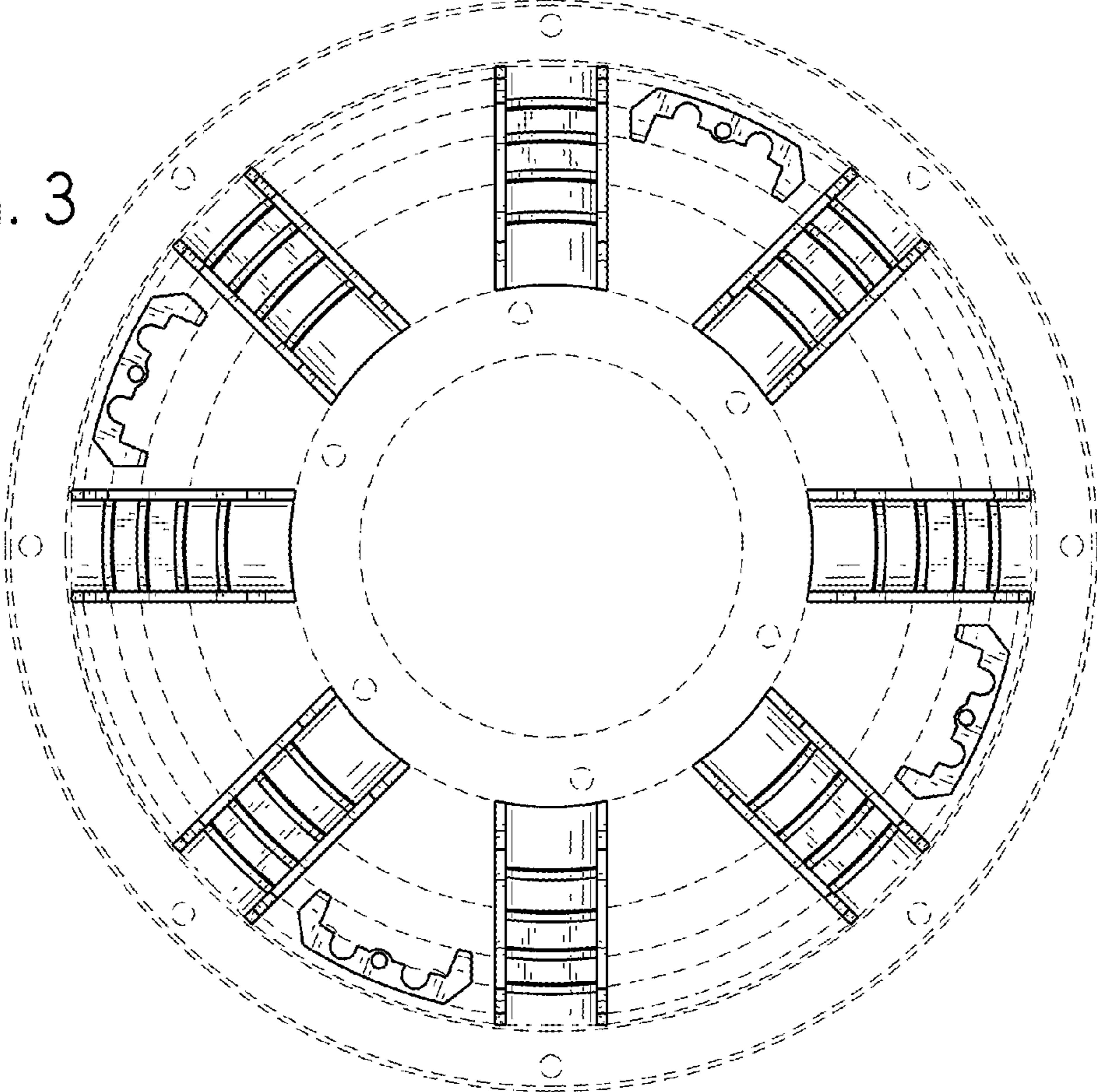

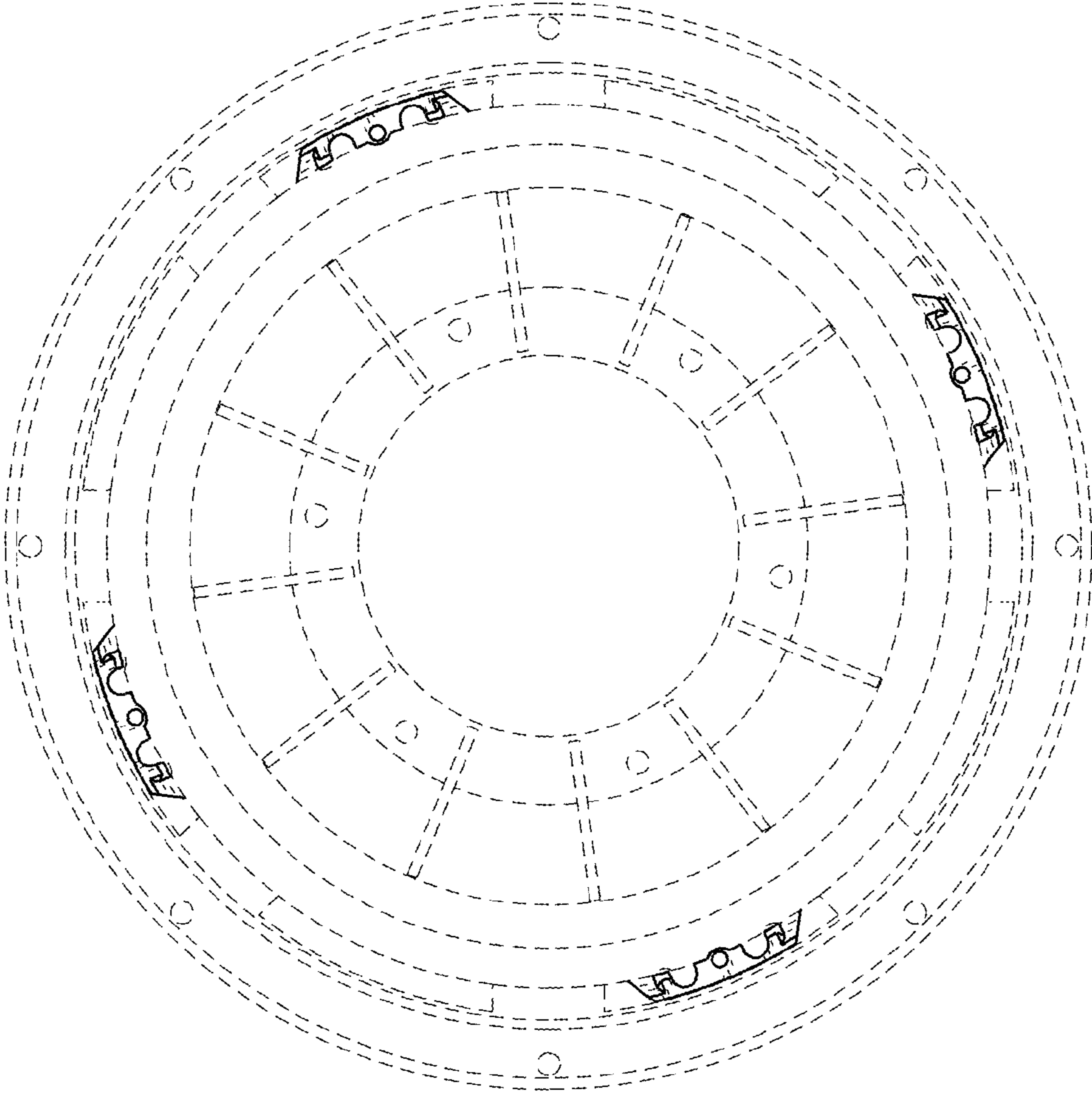
