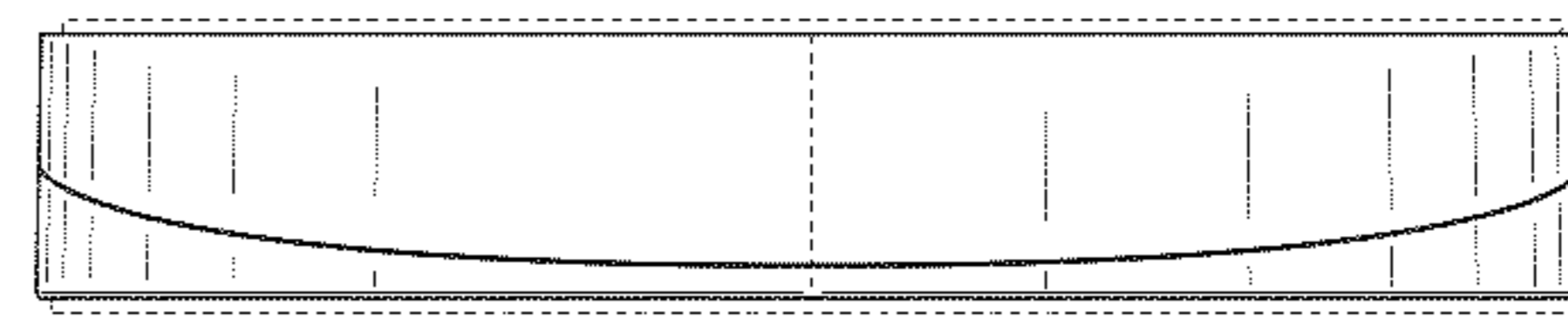
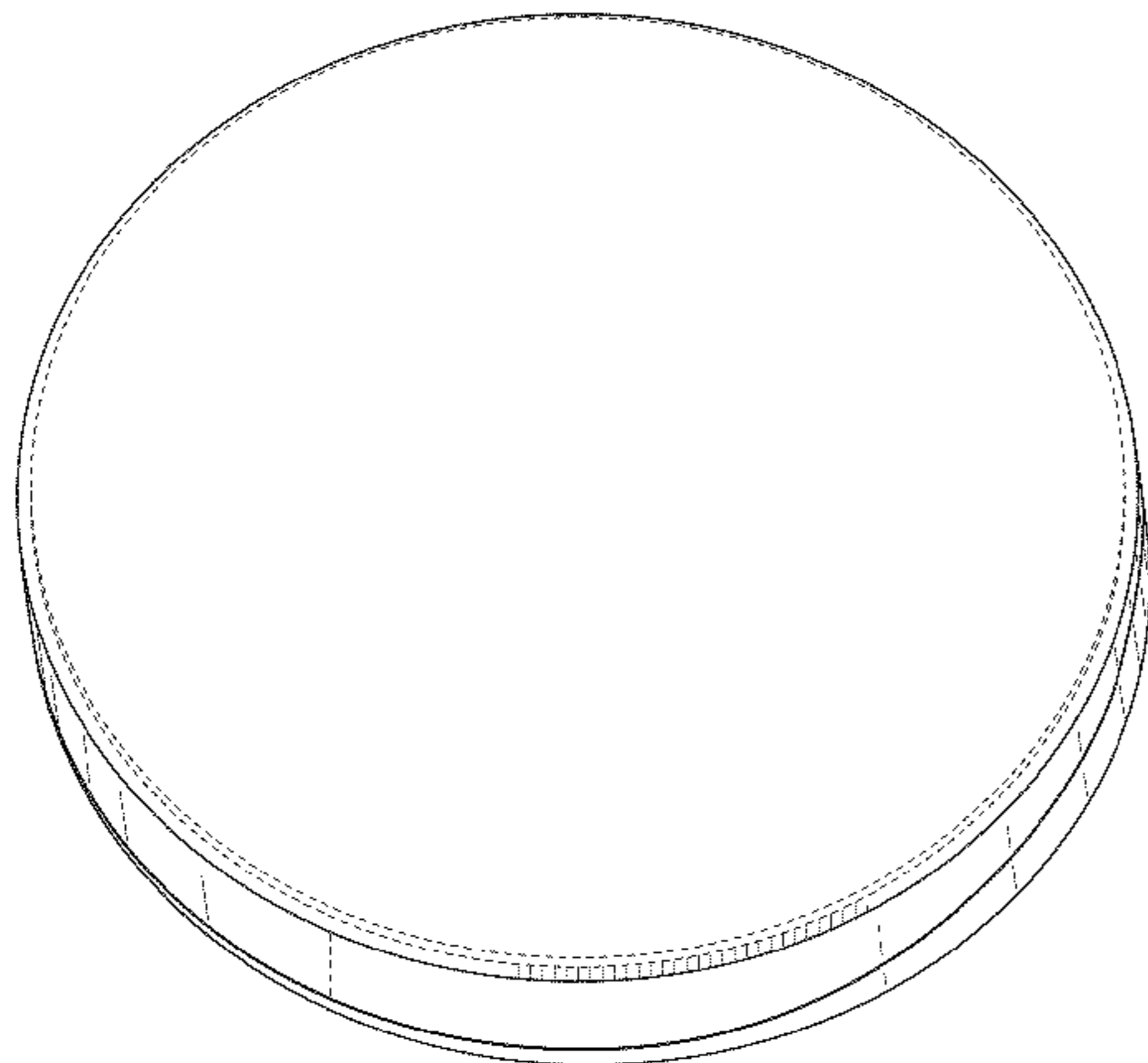

(57) **CLAIM**

We claim the ornamental design for a scanner turntable, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a scanner turntable;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a right side elevation view thereof; and,
 FIG. 7 is a left side elevation view thereof.
 The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines formed by dashes show unclaimed subject matter and form no part of the claimed design.

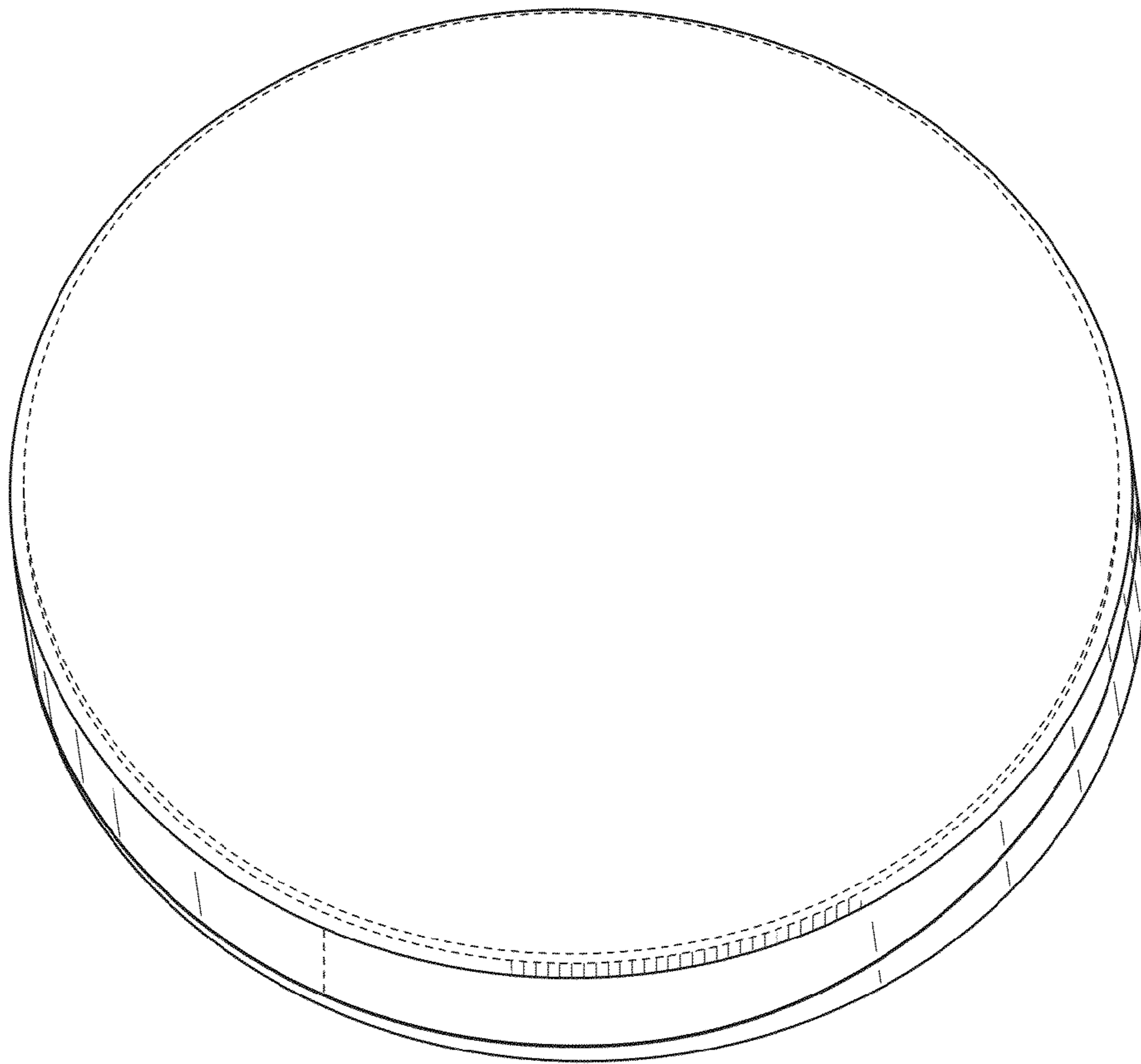

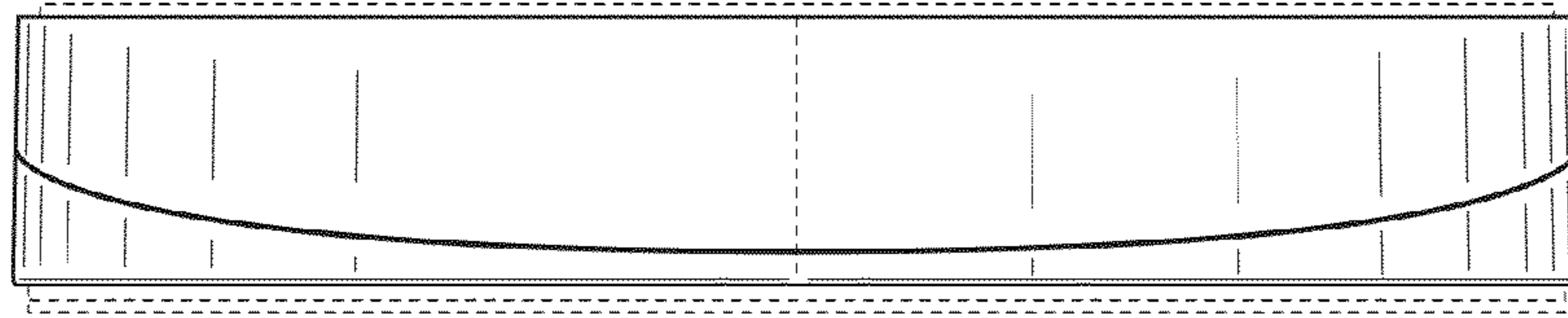

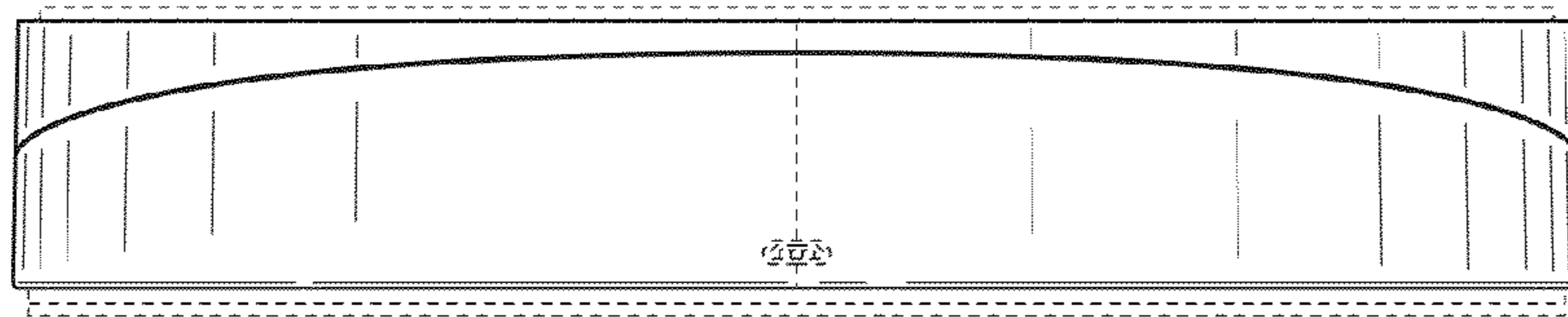

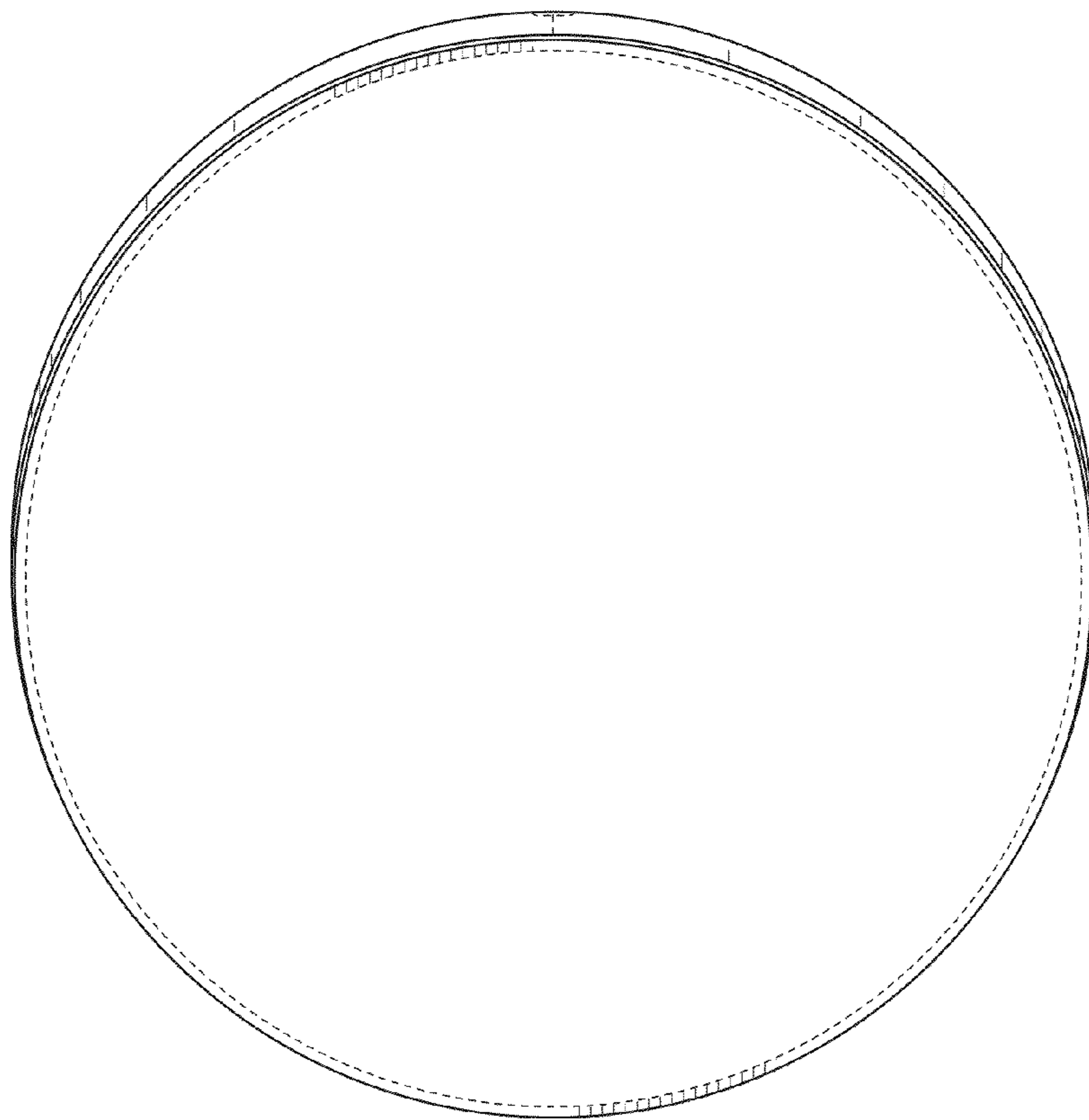

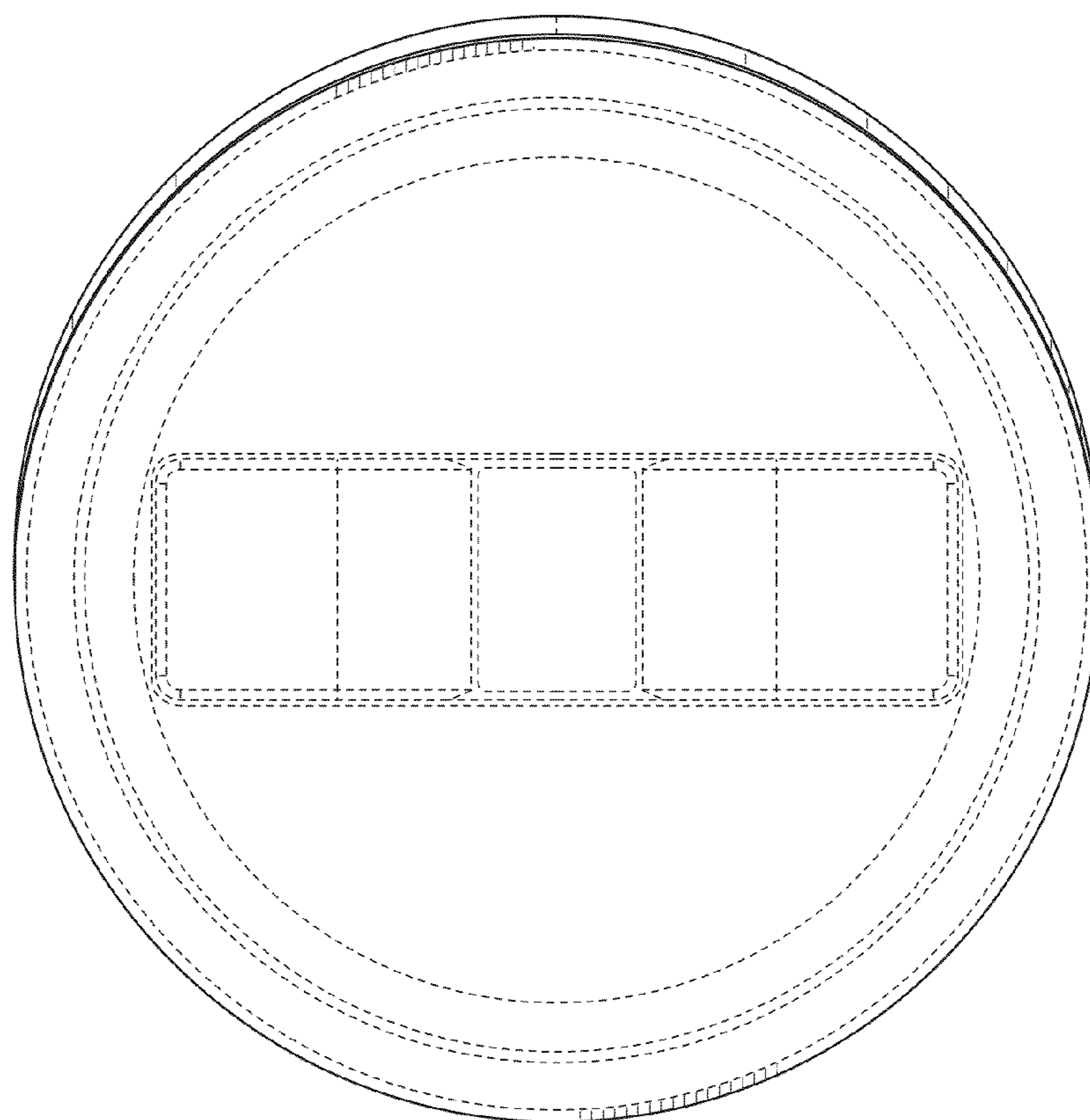

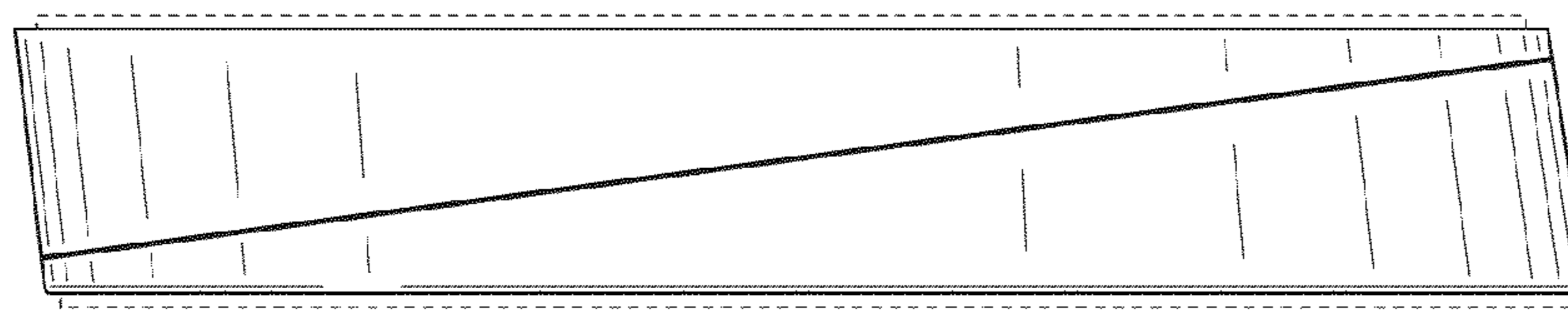

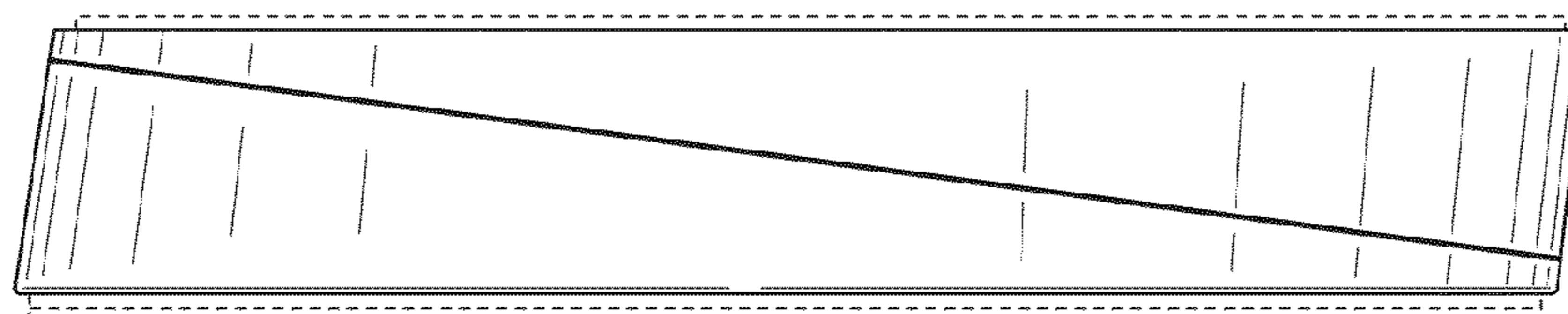
