(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a first embodiment of a display screen with animated graphical user interface showing the new design;

FIG. 2 is a front view of a second image of the first embodiment of FIG. 1;

FIG. 3 is a front view of a third image of the first embodiment of FIG. 1;

FIG. 4 is a front view of a fourth image of the first embodiment of FIG. 1; and,

FIG. 5 is a front view of a fifth image of the first embodiment of FIG. 1.

The appearance of the image transitions between the images shown in FIGS. 1-5. The process or period in which an image transitions to another image forms no part of the claimed design.

The broken lines of uneven length show the display screen. The broken lines of even length shown in the drawings illustrate portions of the display screen with user interface that form no part of the claimed design.

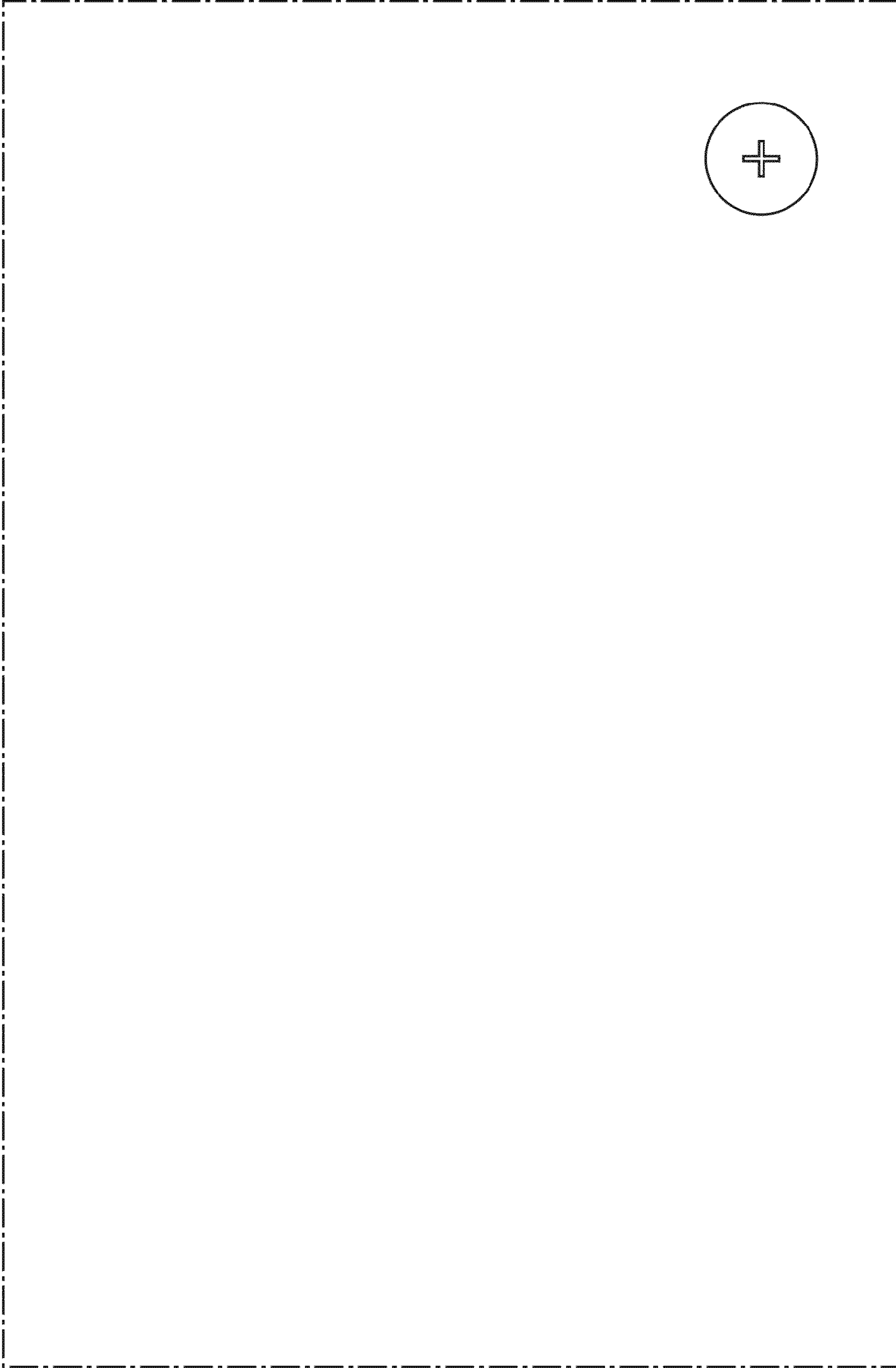

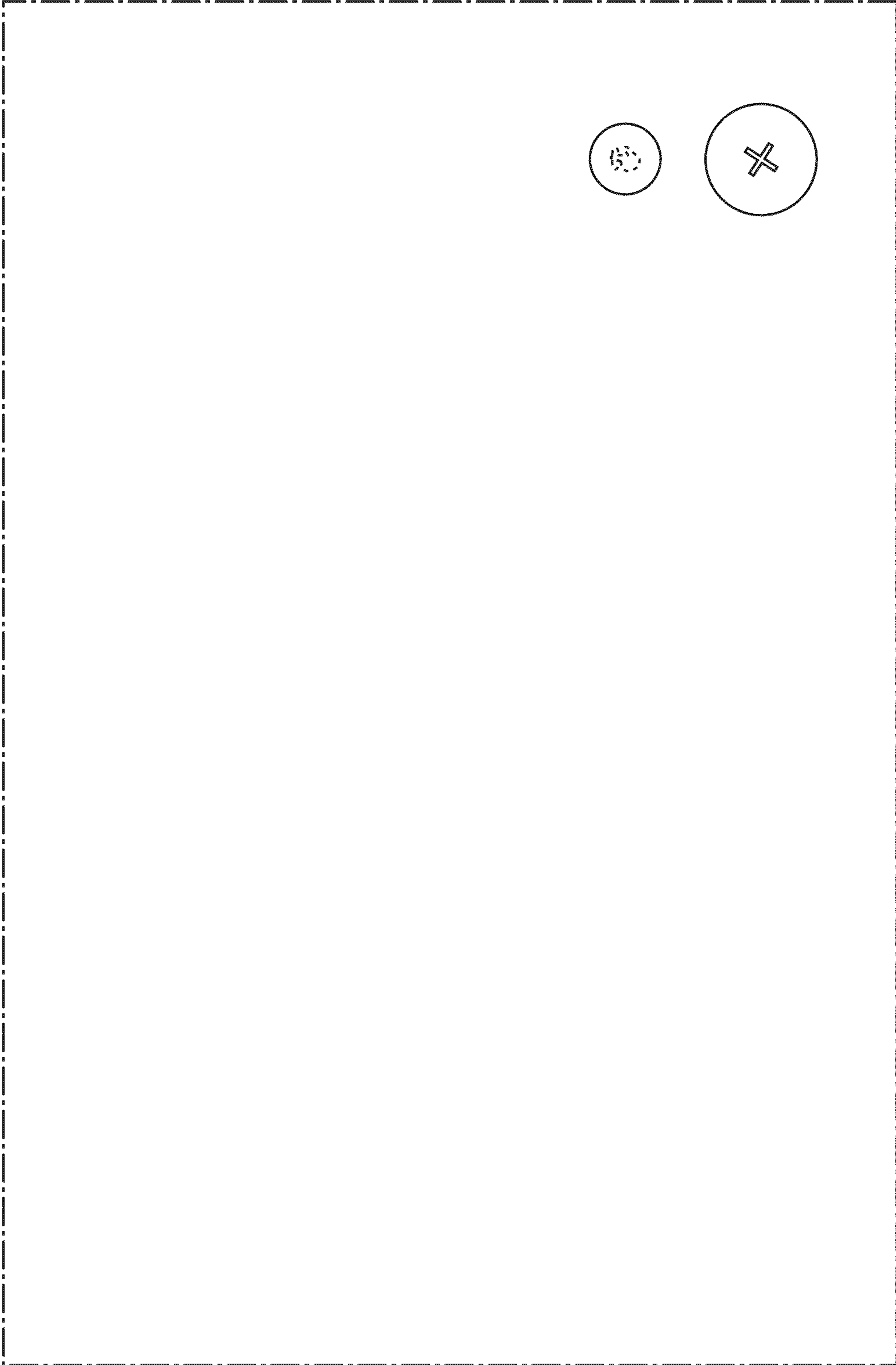

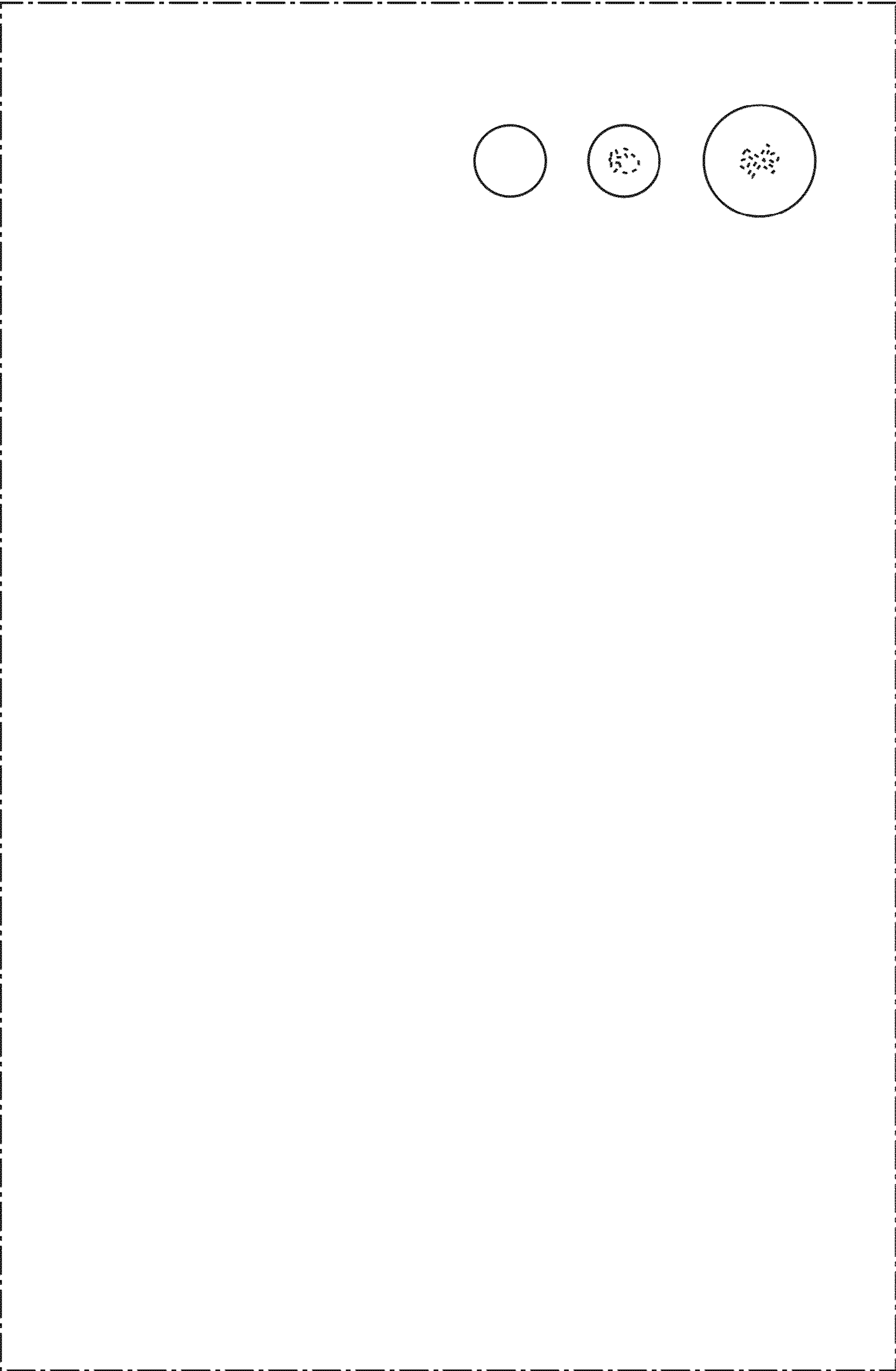

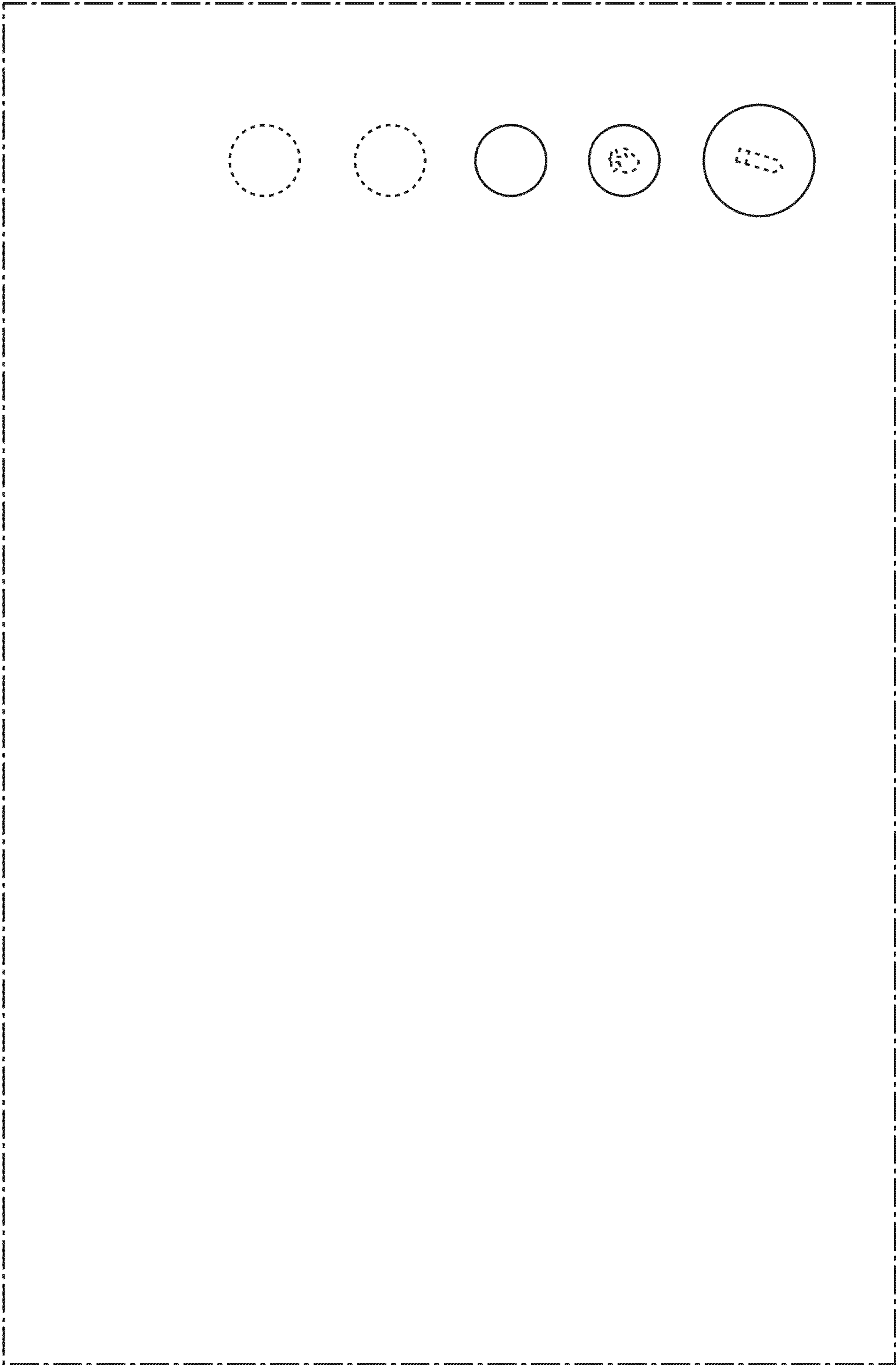
