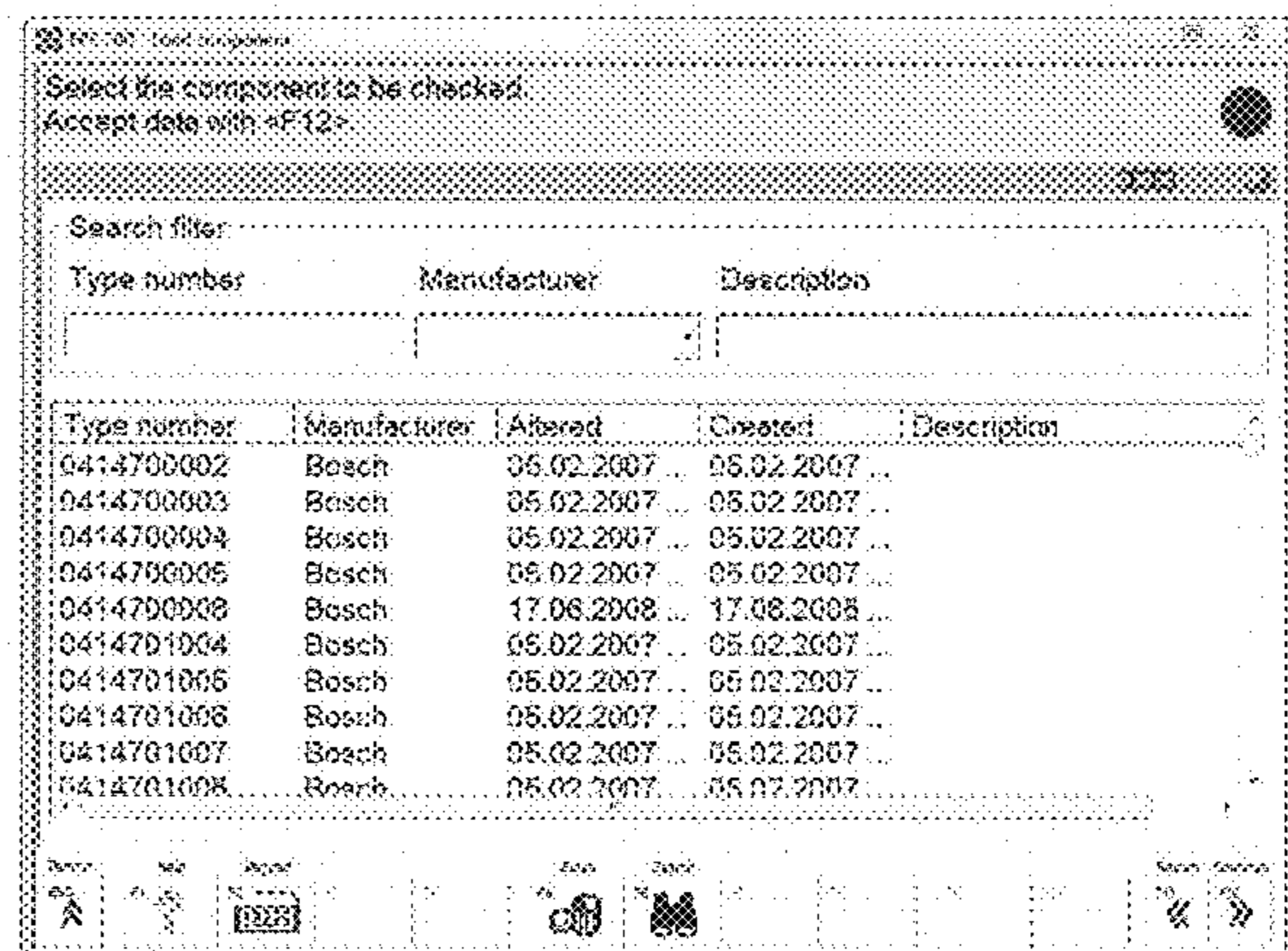
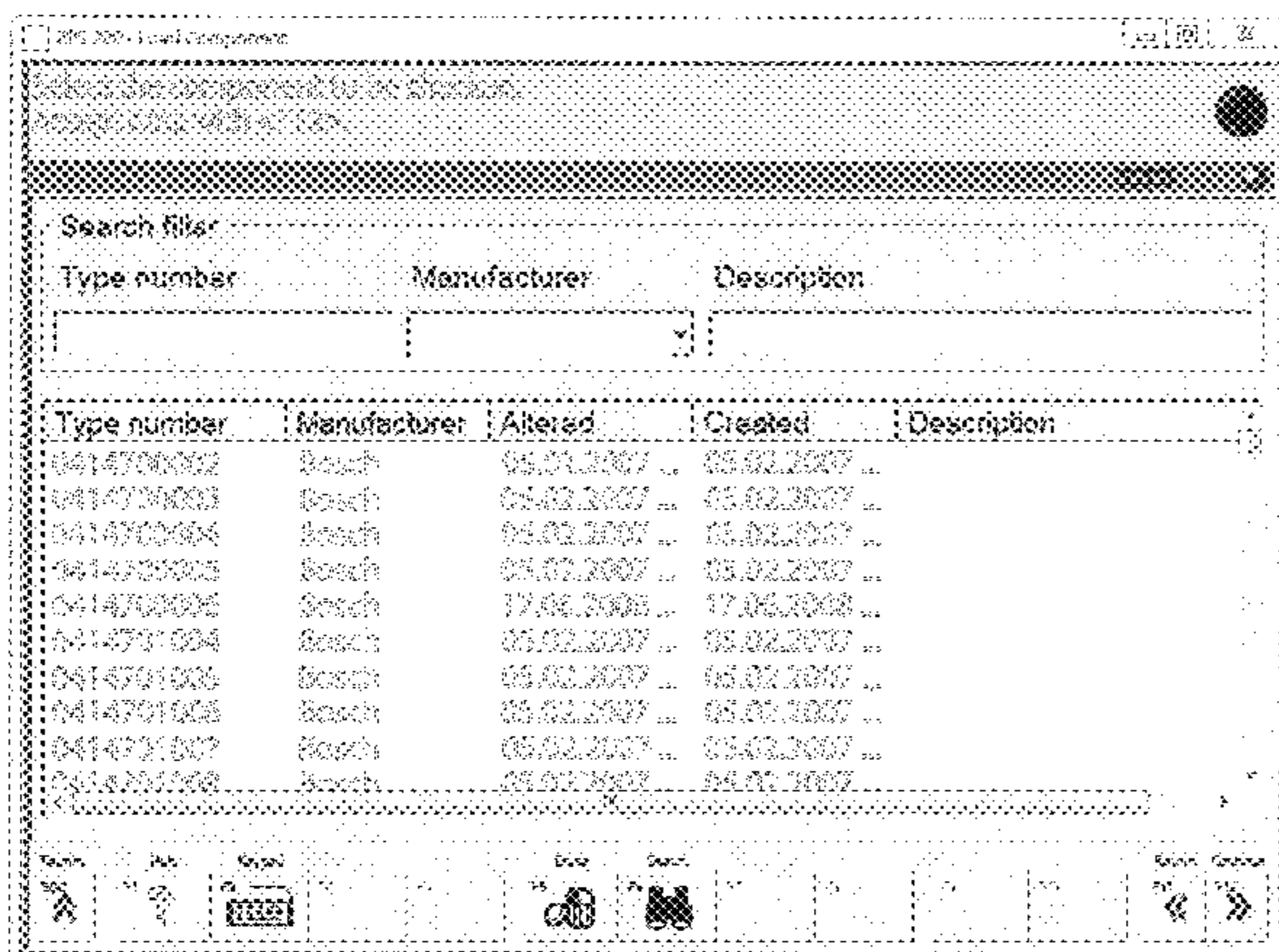
FIG. 1 is a front view of a first embodiment of a display screen with a graphical user interface showing our new design;

The outer edge of the display screen is understood to be congruent with the outer edge of the graphical user interface. The broken lines shown in FIG. 1 illustrate portions of the display screen with a graphical user interface that form no part of the claimed design.

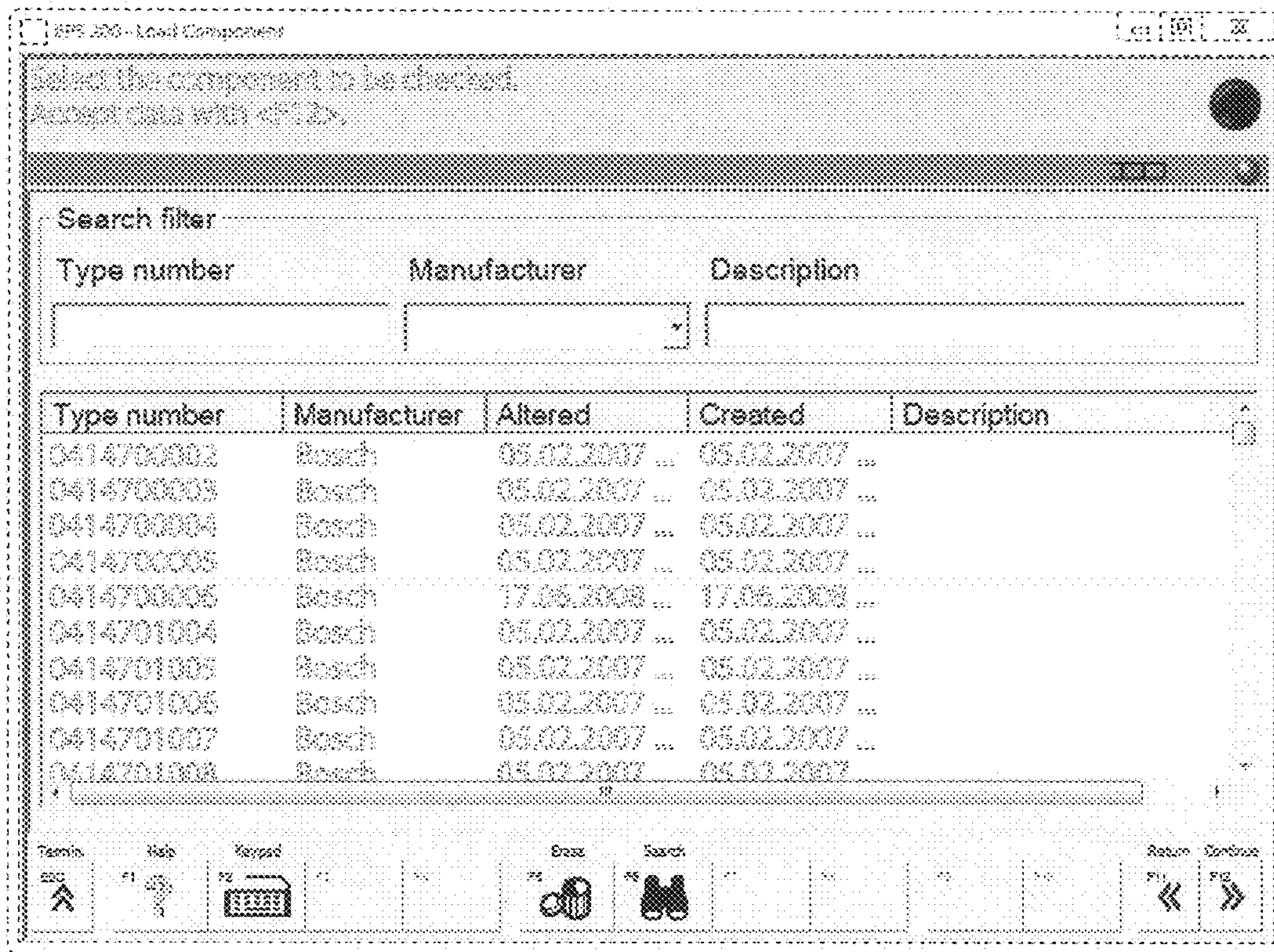

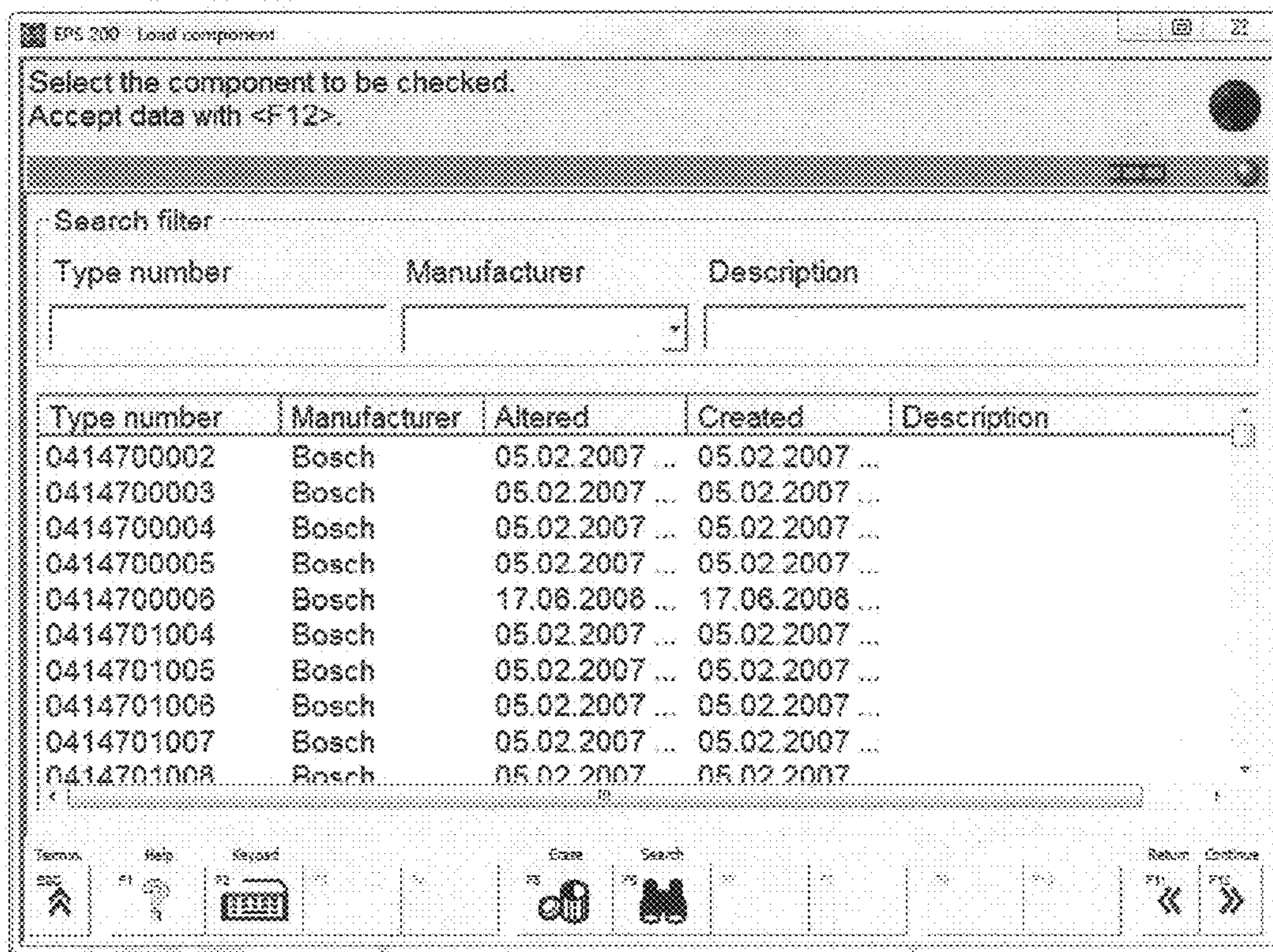

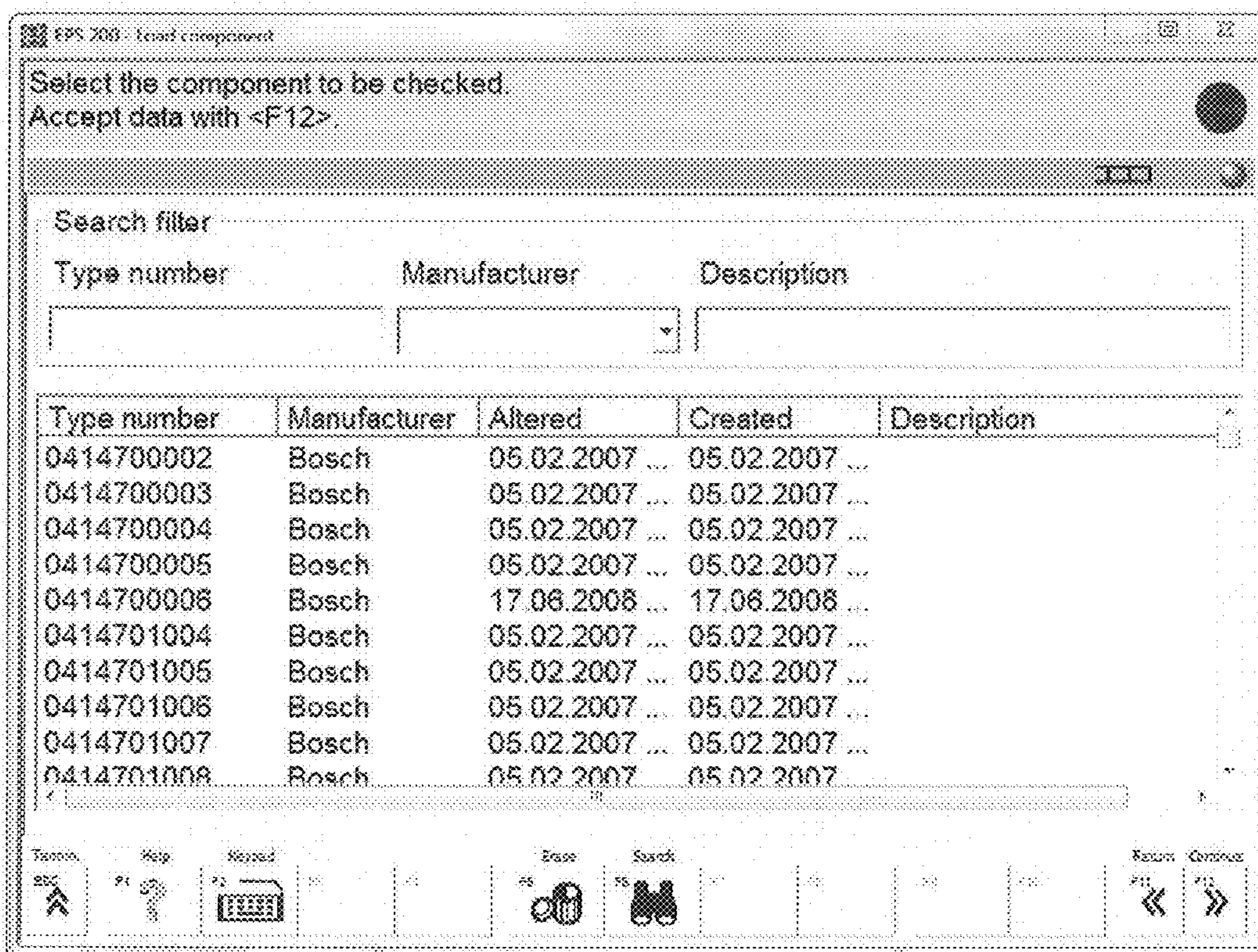
