The ornamental design for a display screen with animated graphical user interface, as shown and described.

**DESCRIPTION**

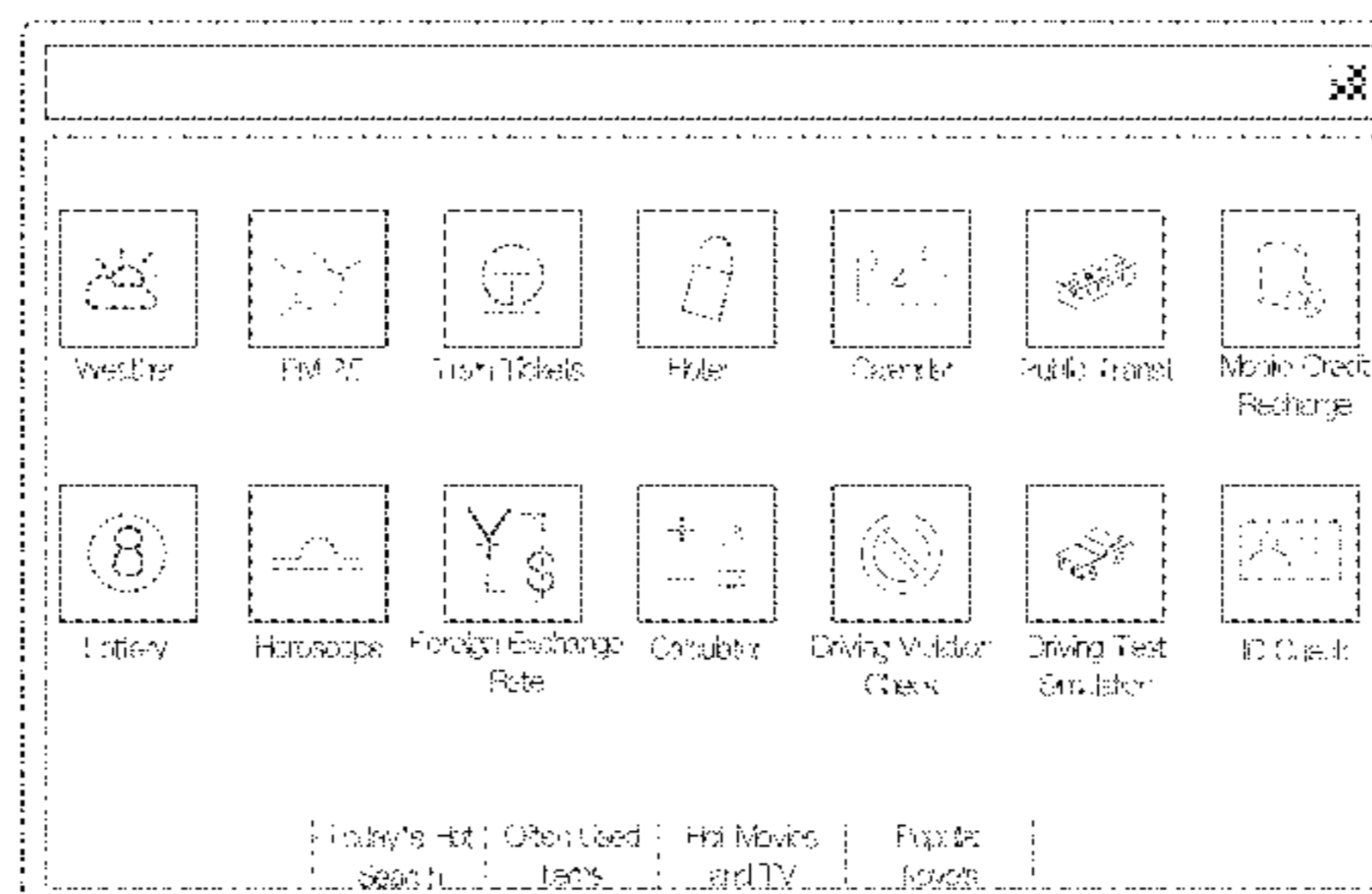
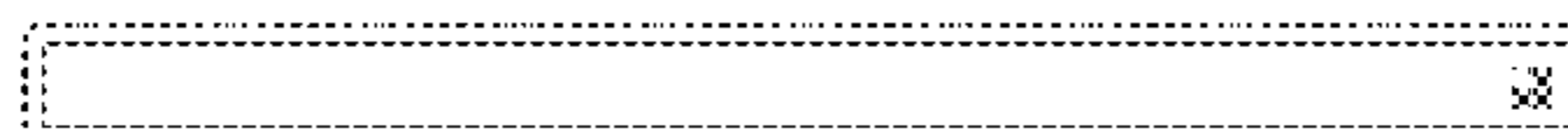
FIG. 1 is a first image in a sequence for a display screen with animated graphical user interface showing our new design; and,

FIG. 2 is a second image thereof.

The broken lines shown in FIGS. 1 and 2 represent portions of the display screen with graphical user interface that form no part of the claimed design.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1 and 2. The process or period in which one image transitions to another image forms no part of the claimed design.

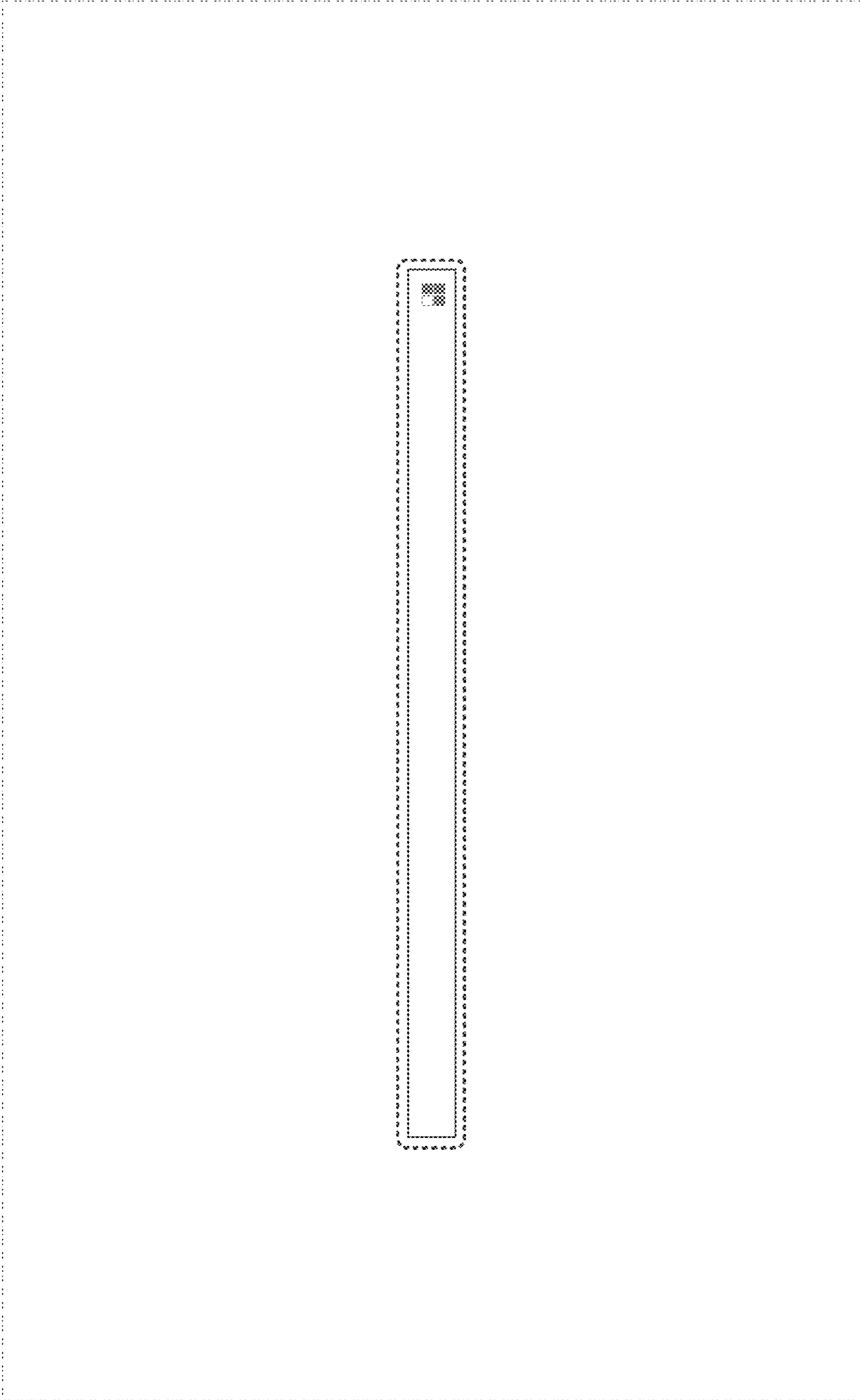

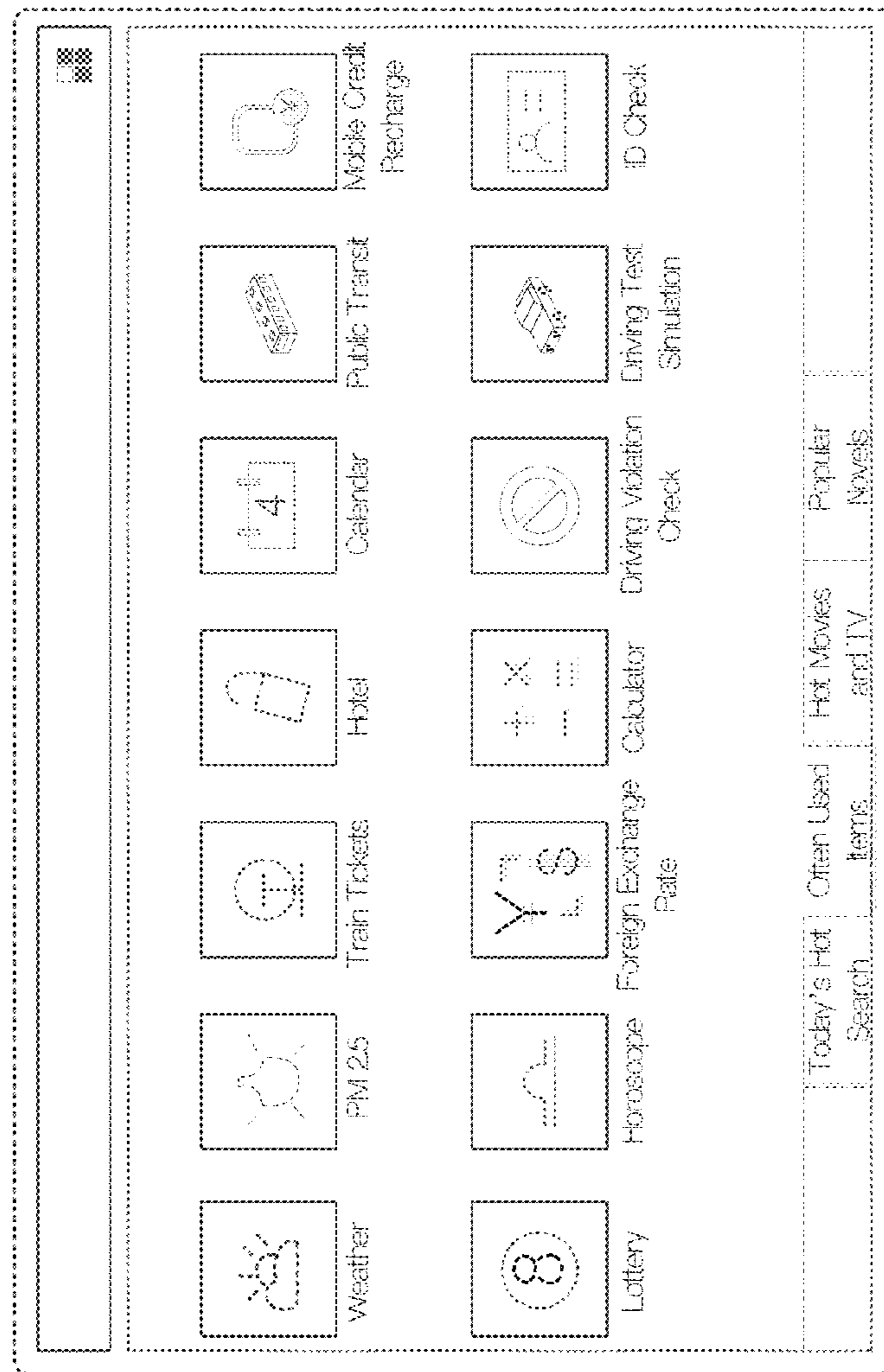
