The ornamental design for a display screen with animated graphical user interface, as shown and described.

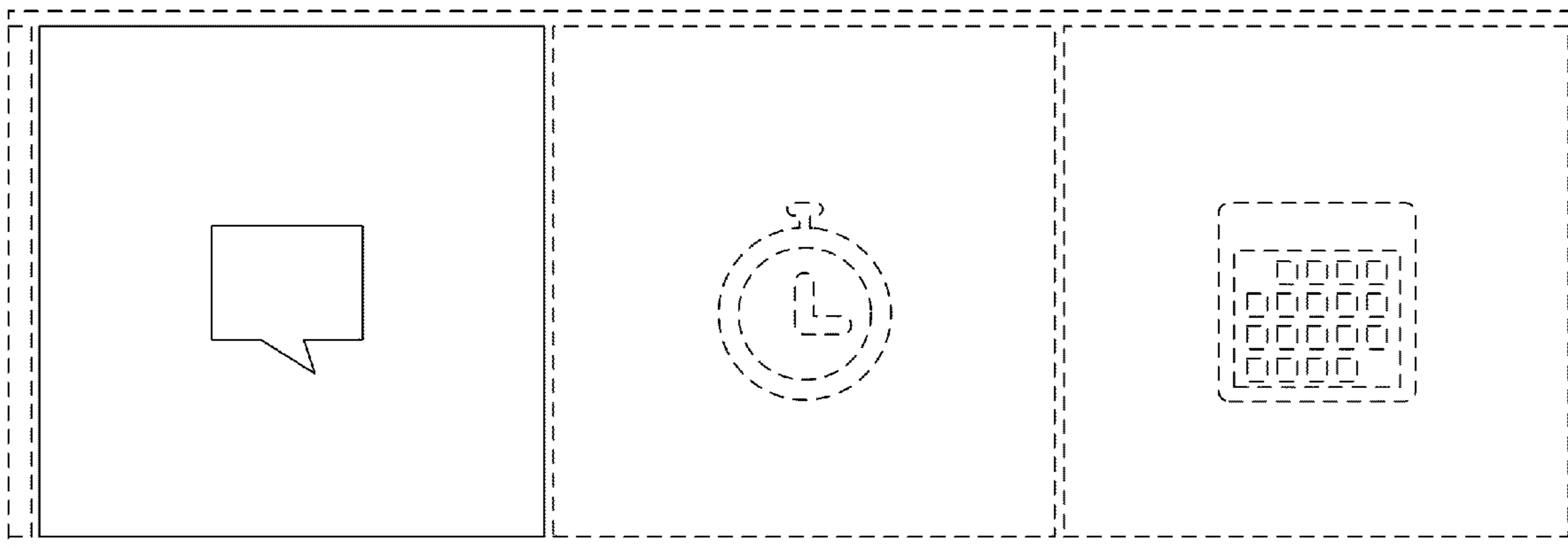
**DESCRIPTION**

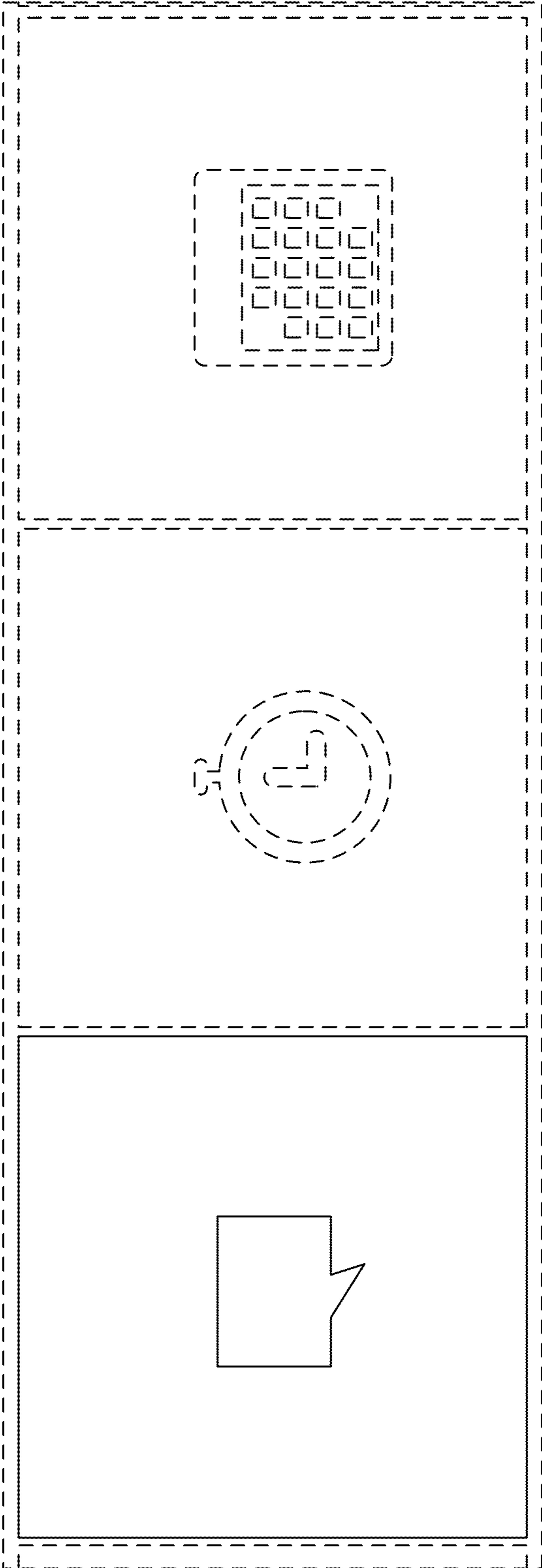
FIG. 1 is a front view of a display screen with animated graphical user interface showing a first image which is part of a sequence showing our new design;

The display screen and portions of the images shown with broken lines are for illustrative purposes only and form no part of the claimed design.

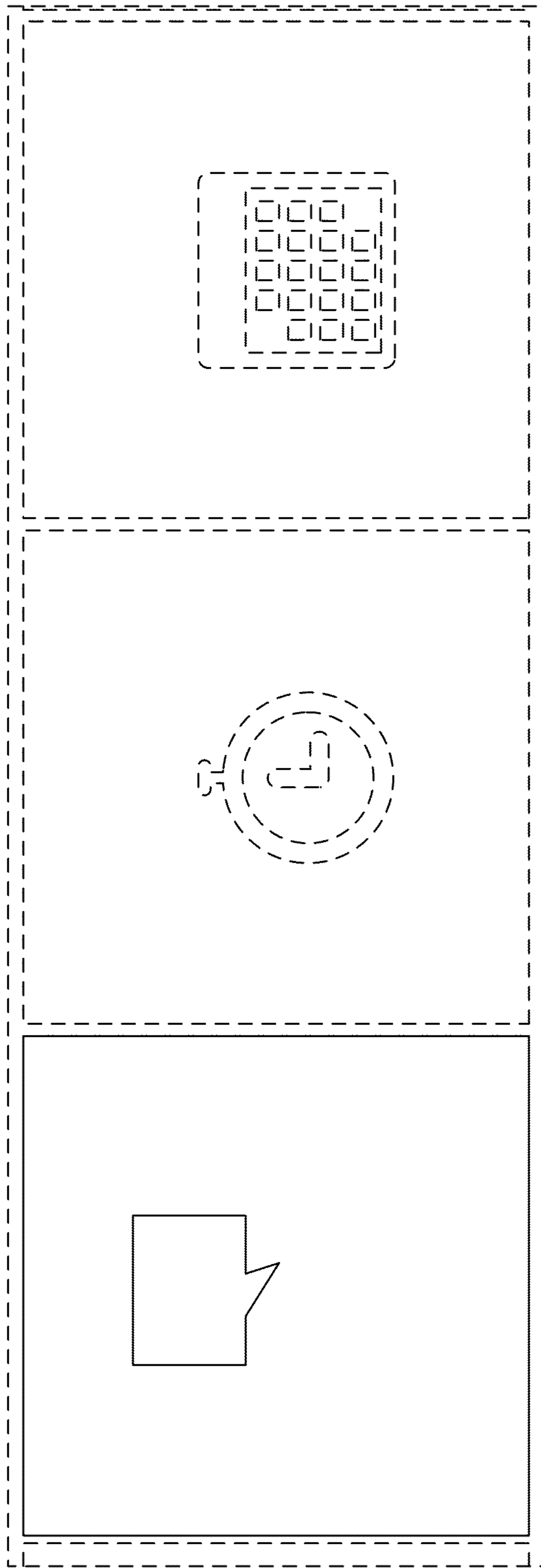

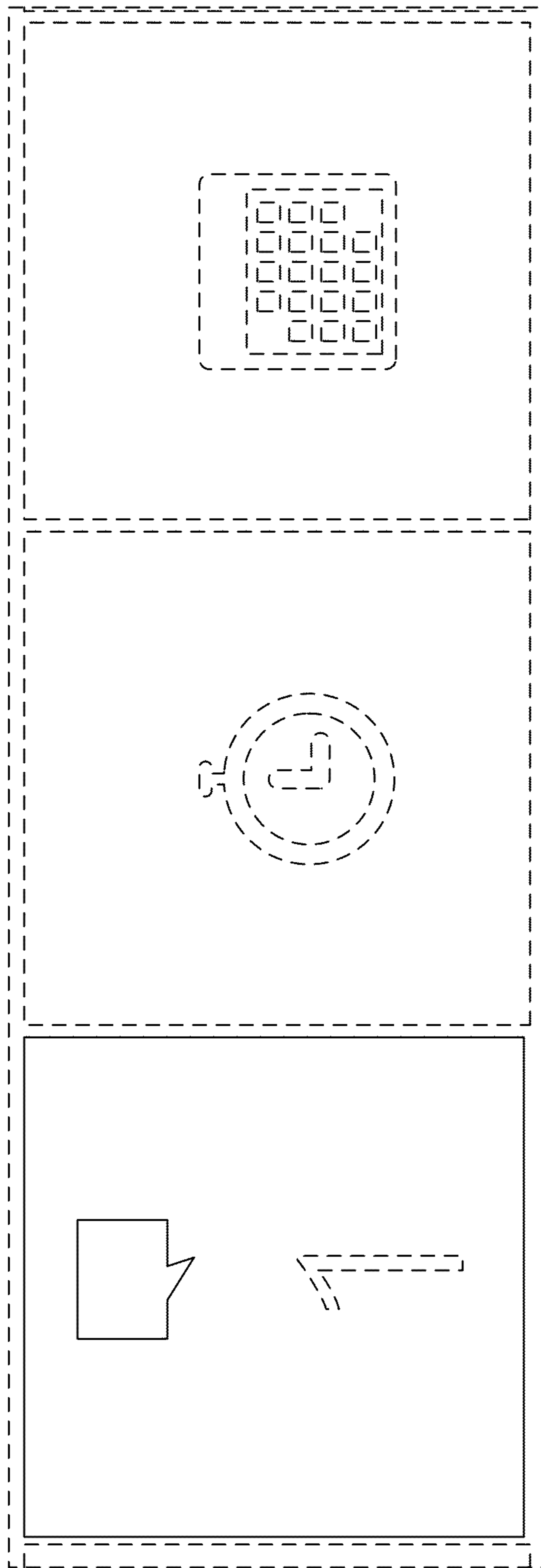
