DESCRIPTION

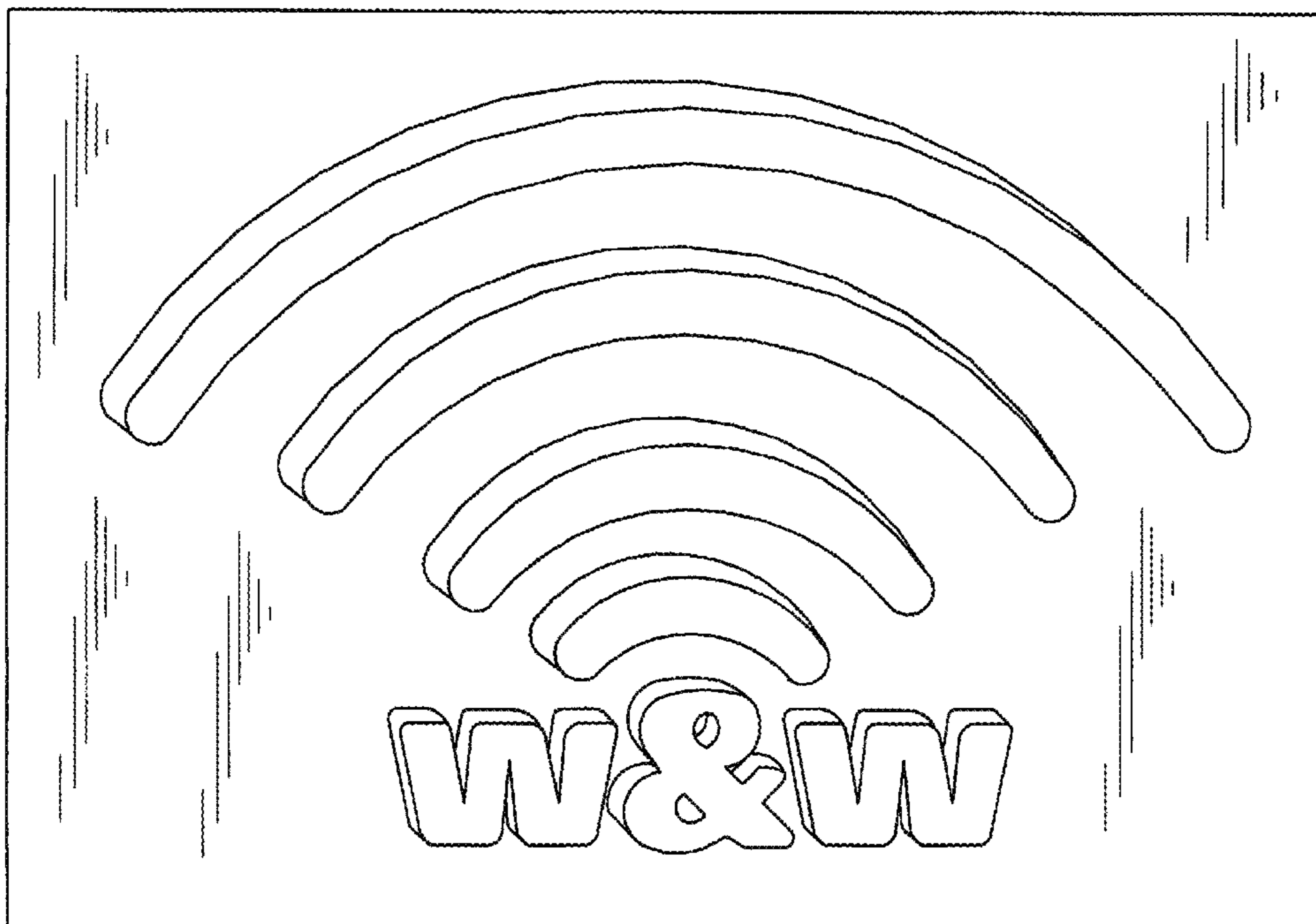
FIG. 1 is a front view of a display screen with icon showing my new design, but shown enlarged and separate for clarity of illustration; and,

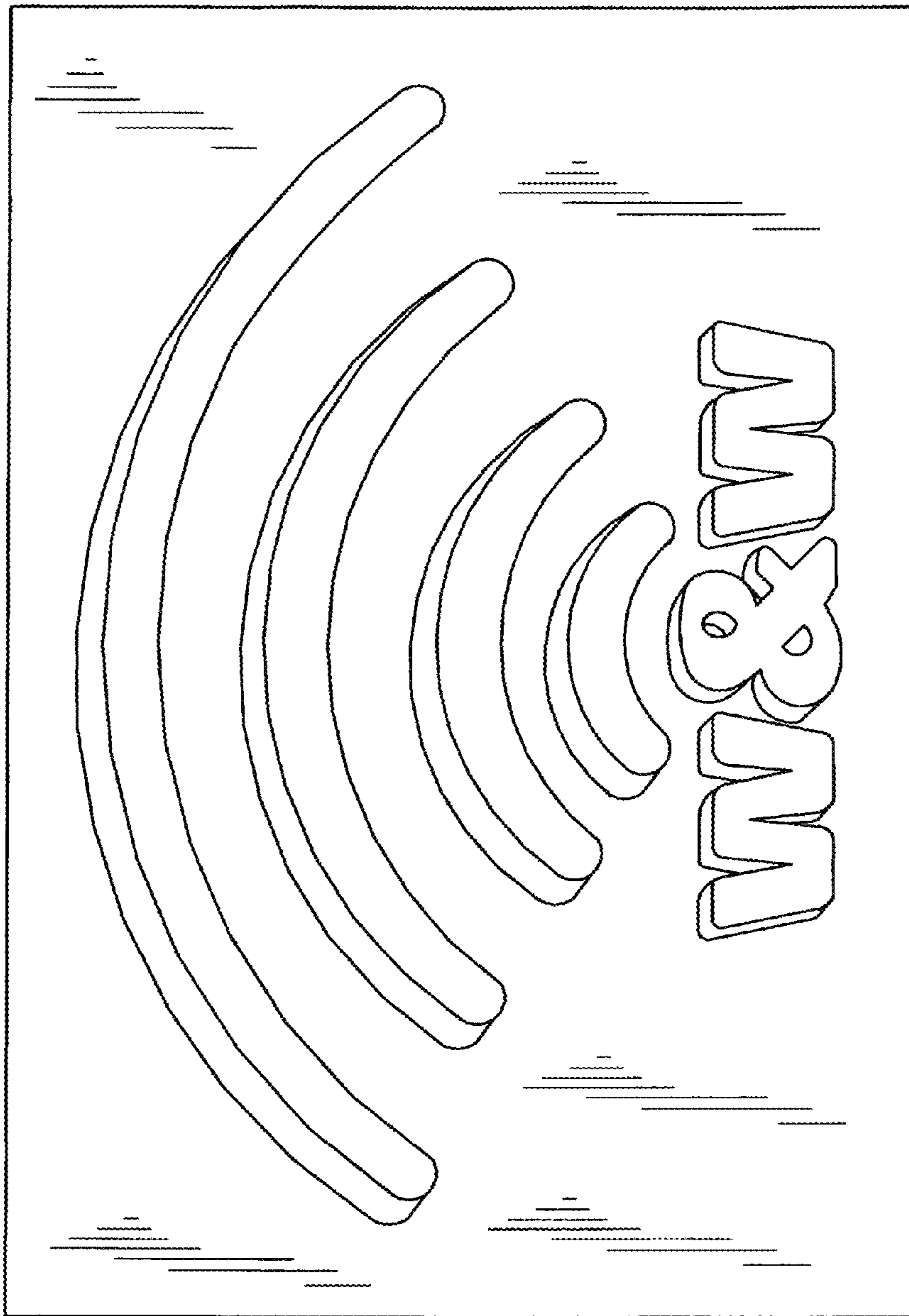

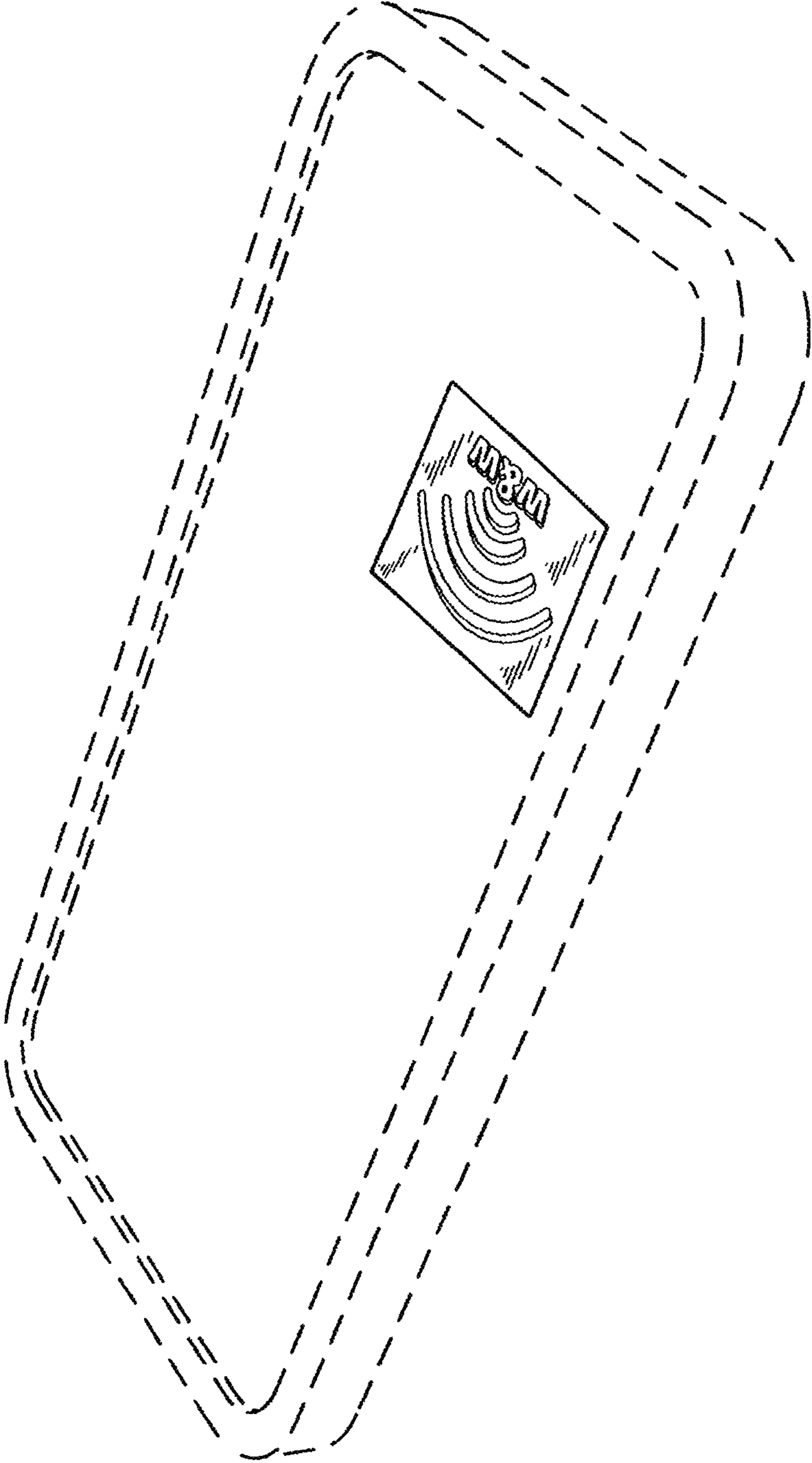
