FIG. 2 is a second image thereof;

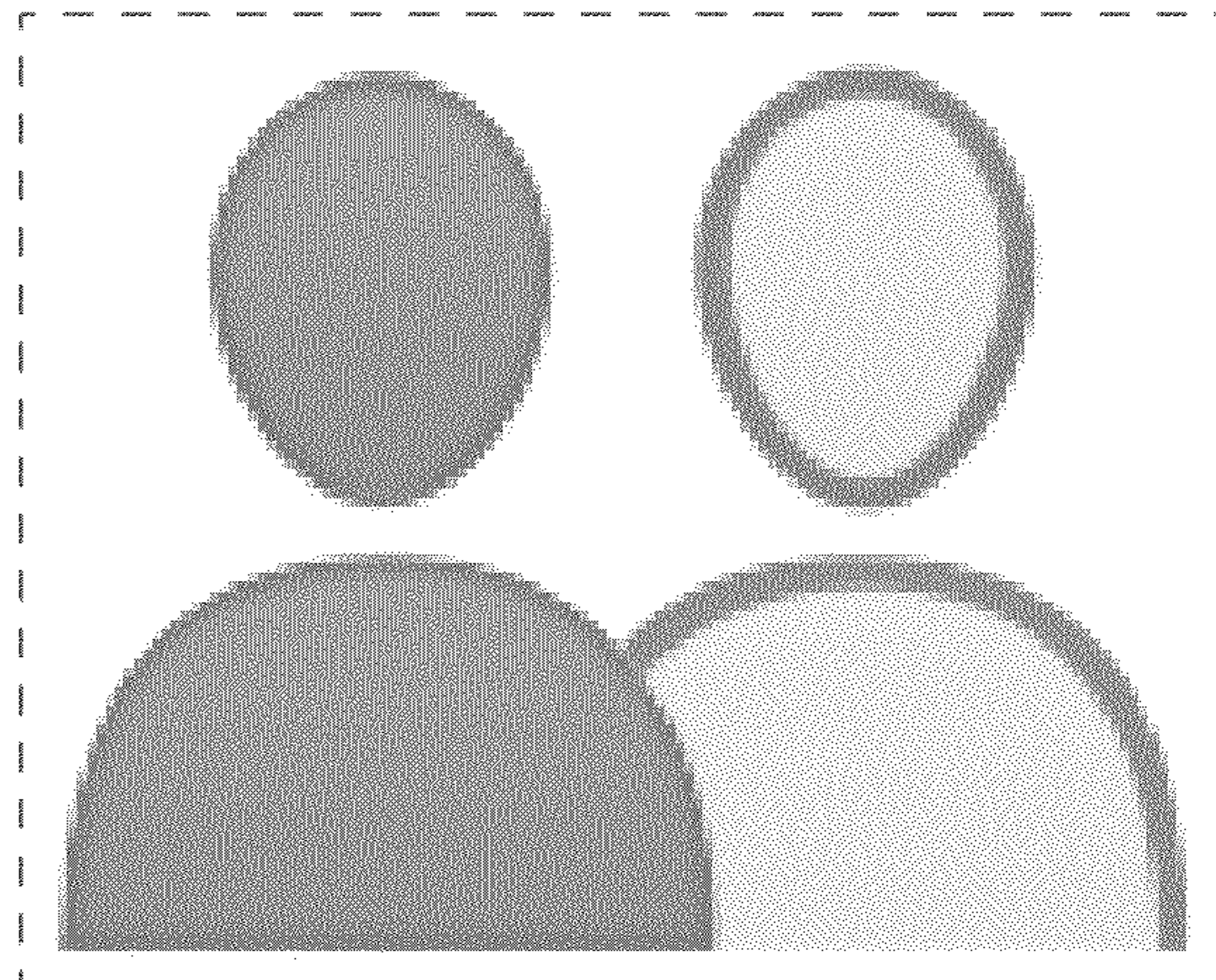
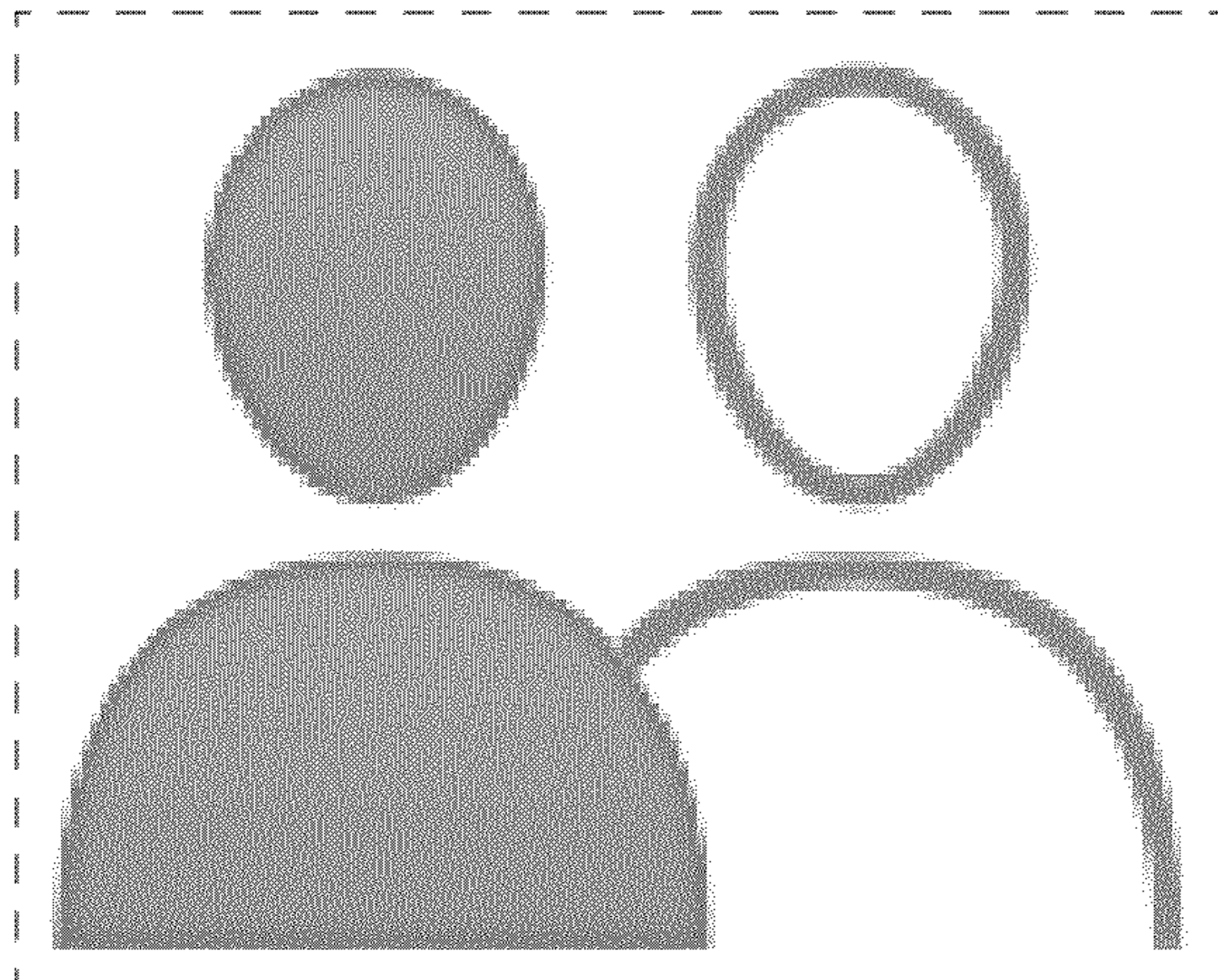
FIG. 3 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image of our new design; and,

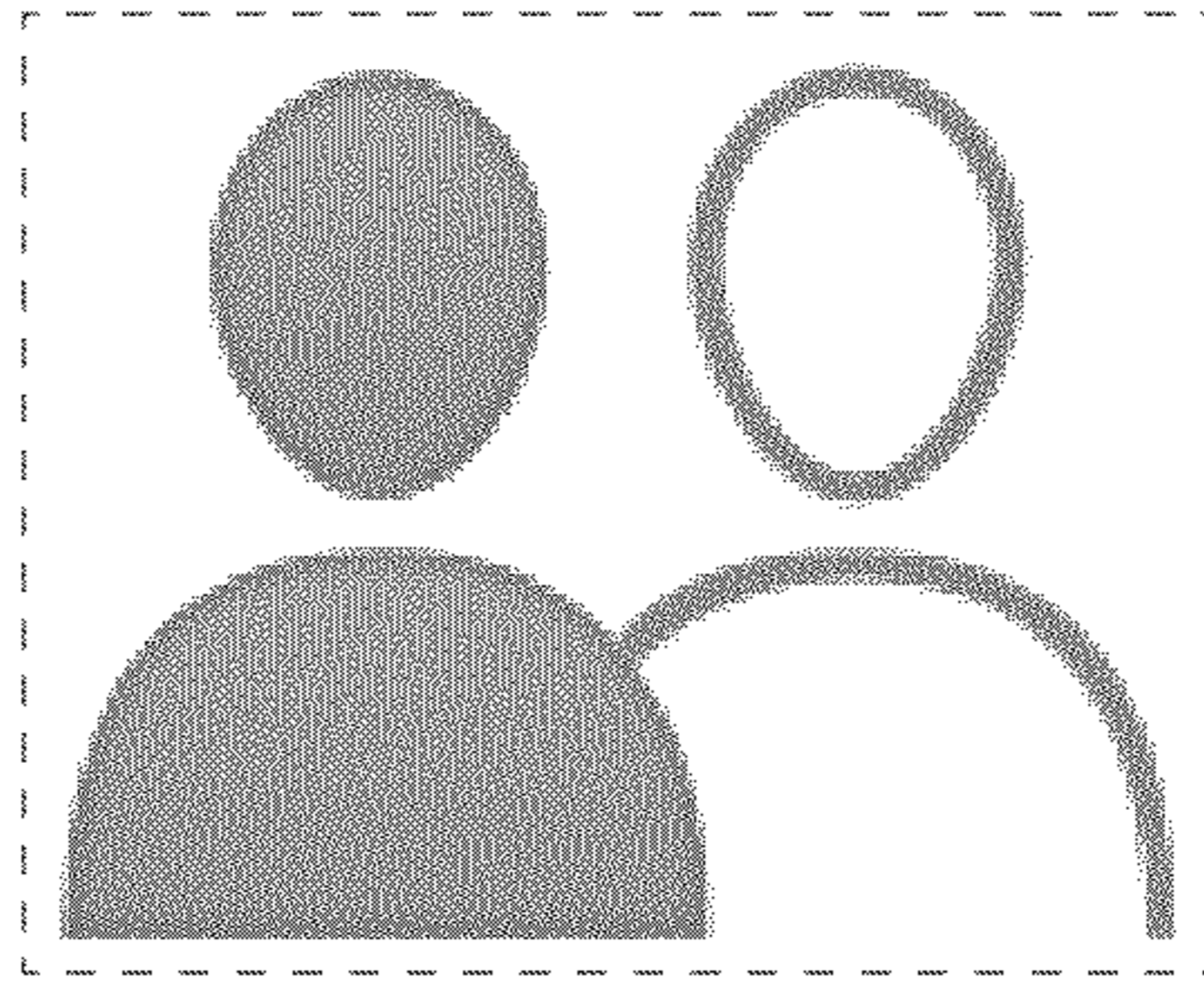

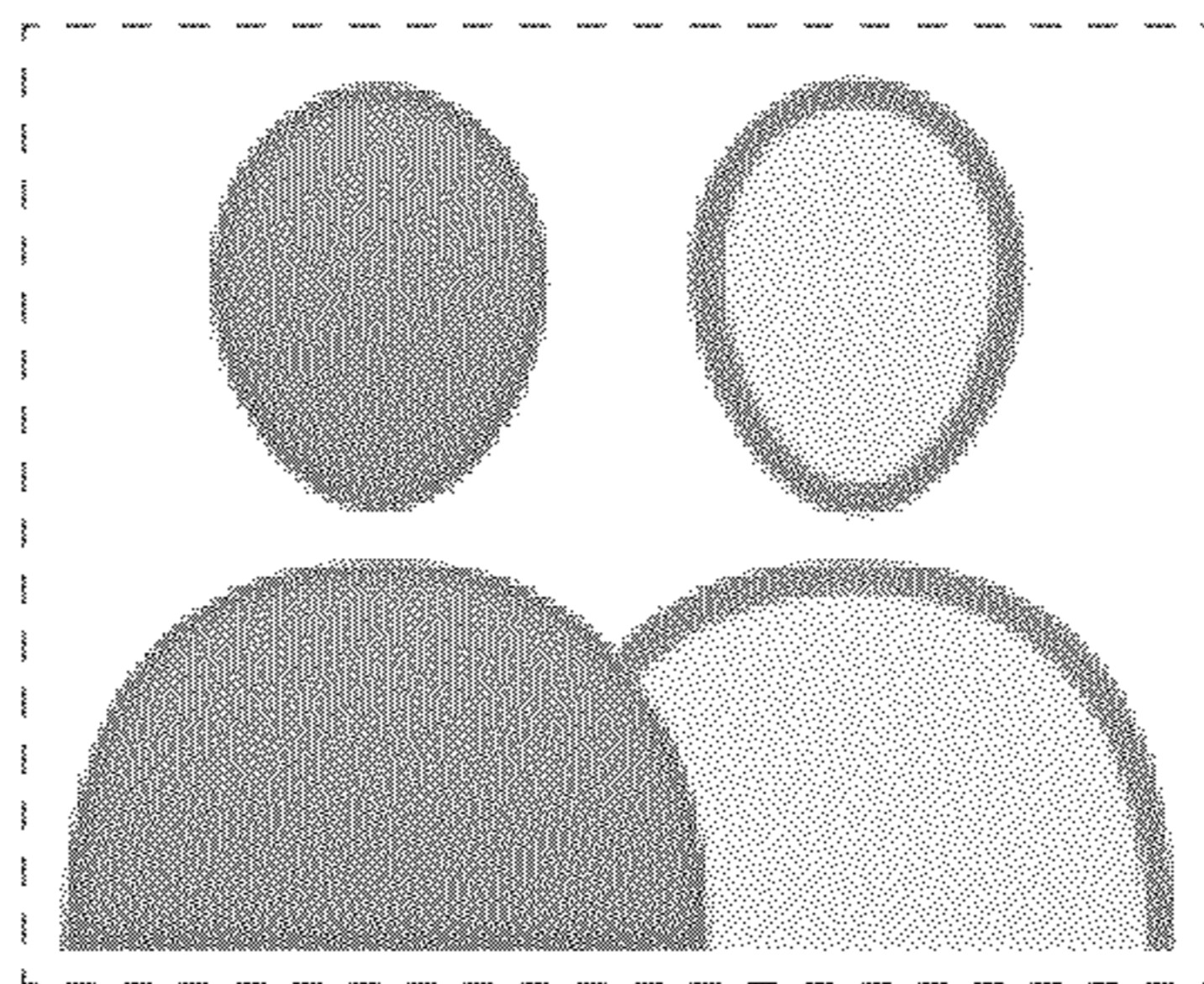

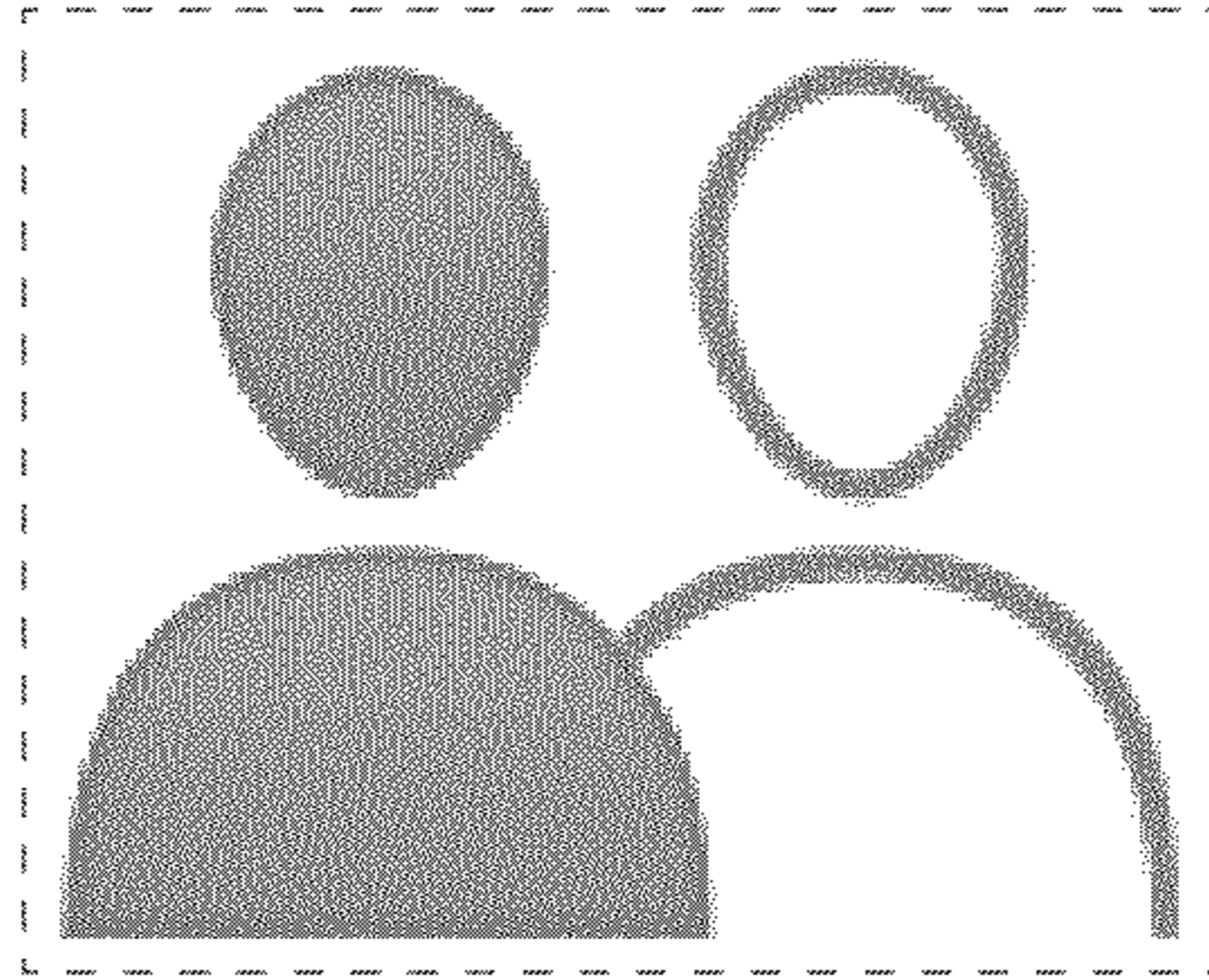

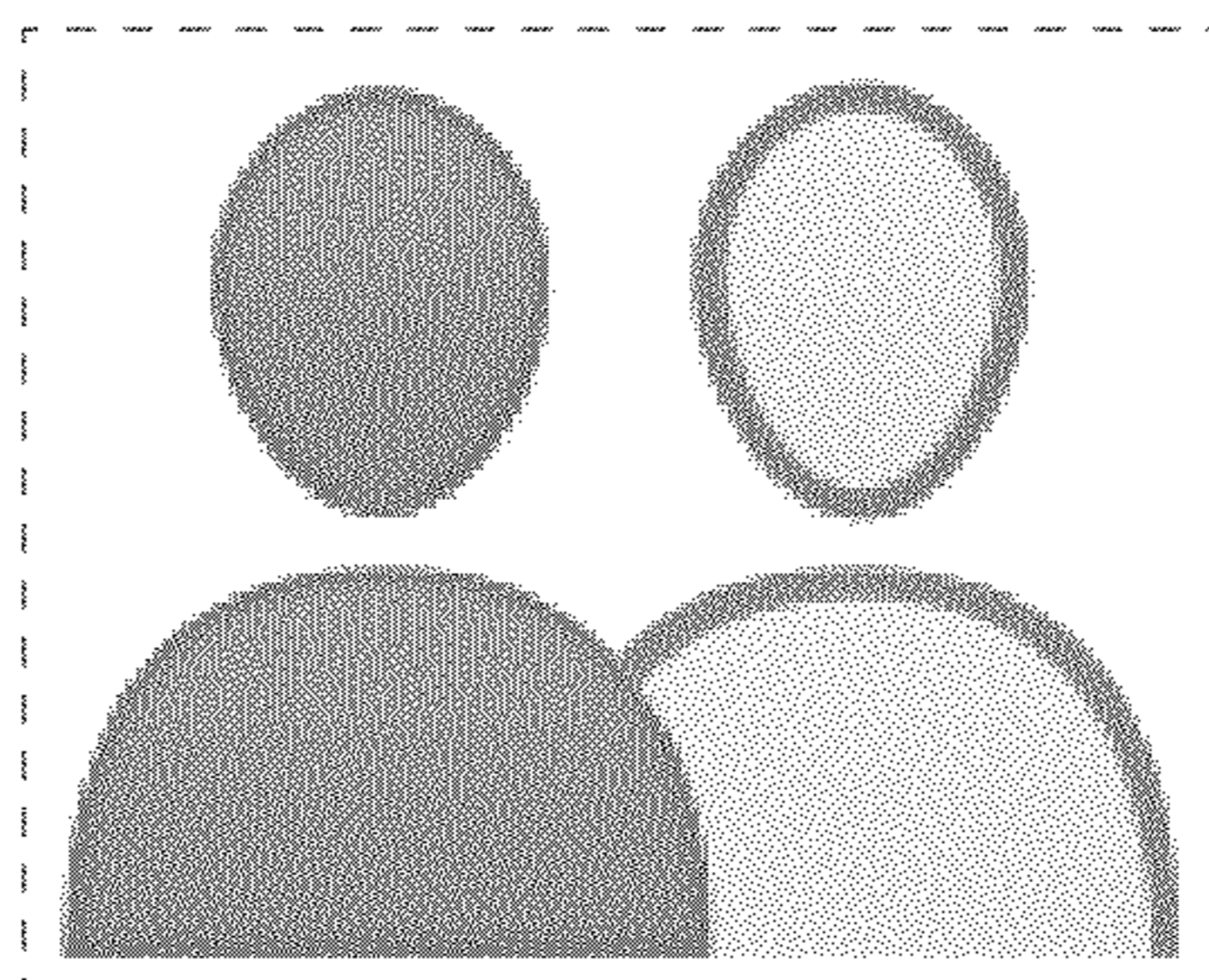
