DESCRIPTION

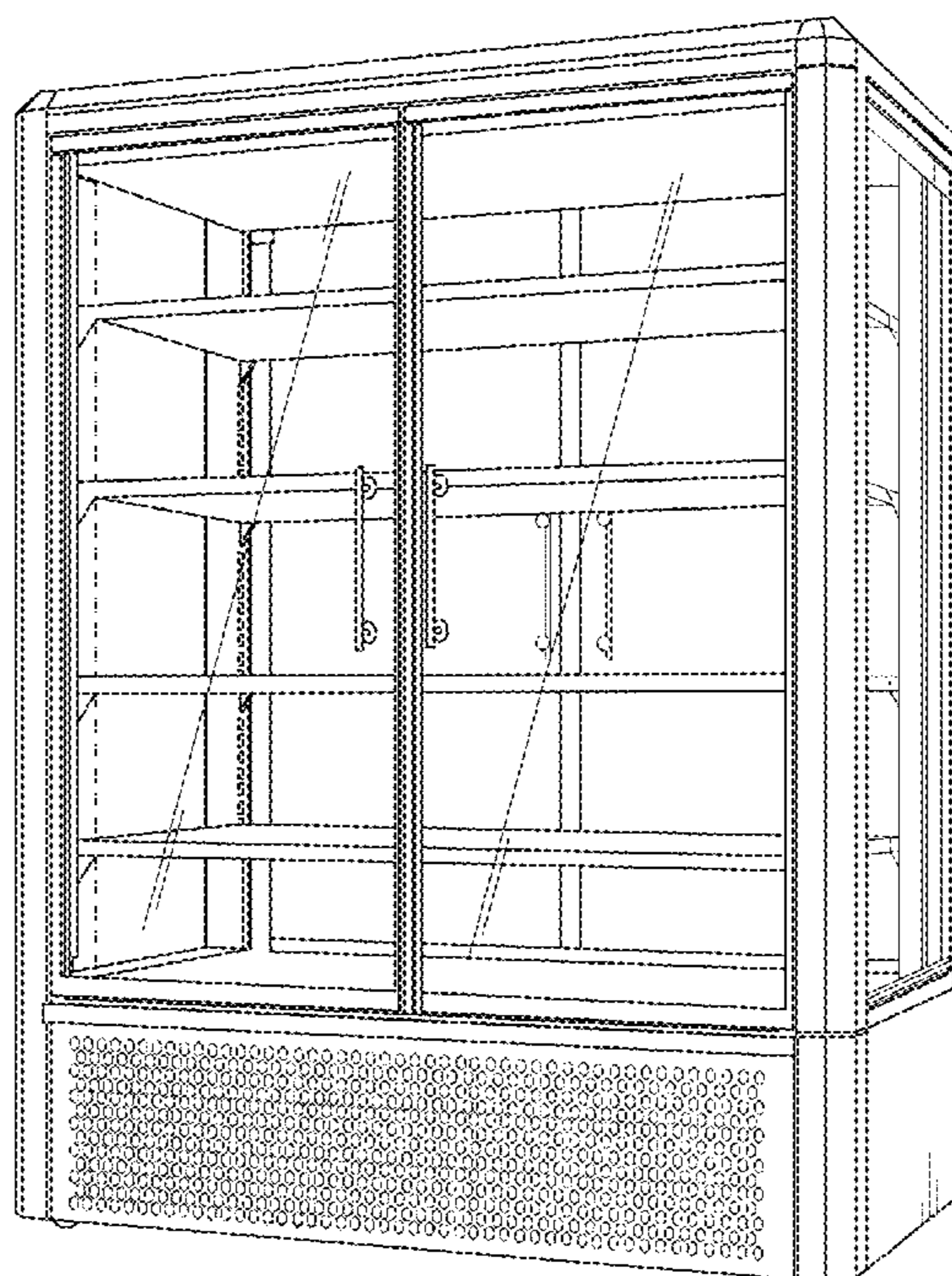
FIG. 1 is a front, left perspective view of a refrigerating apparatus showing my new design, the rear, right side perspective views being mirror images thereto;

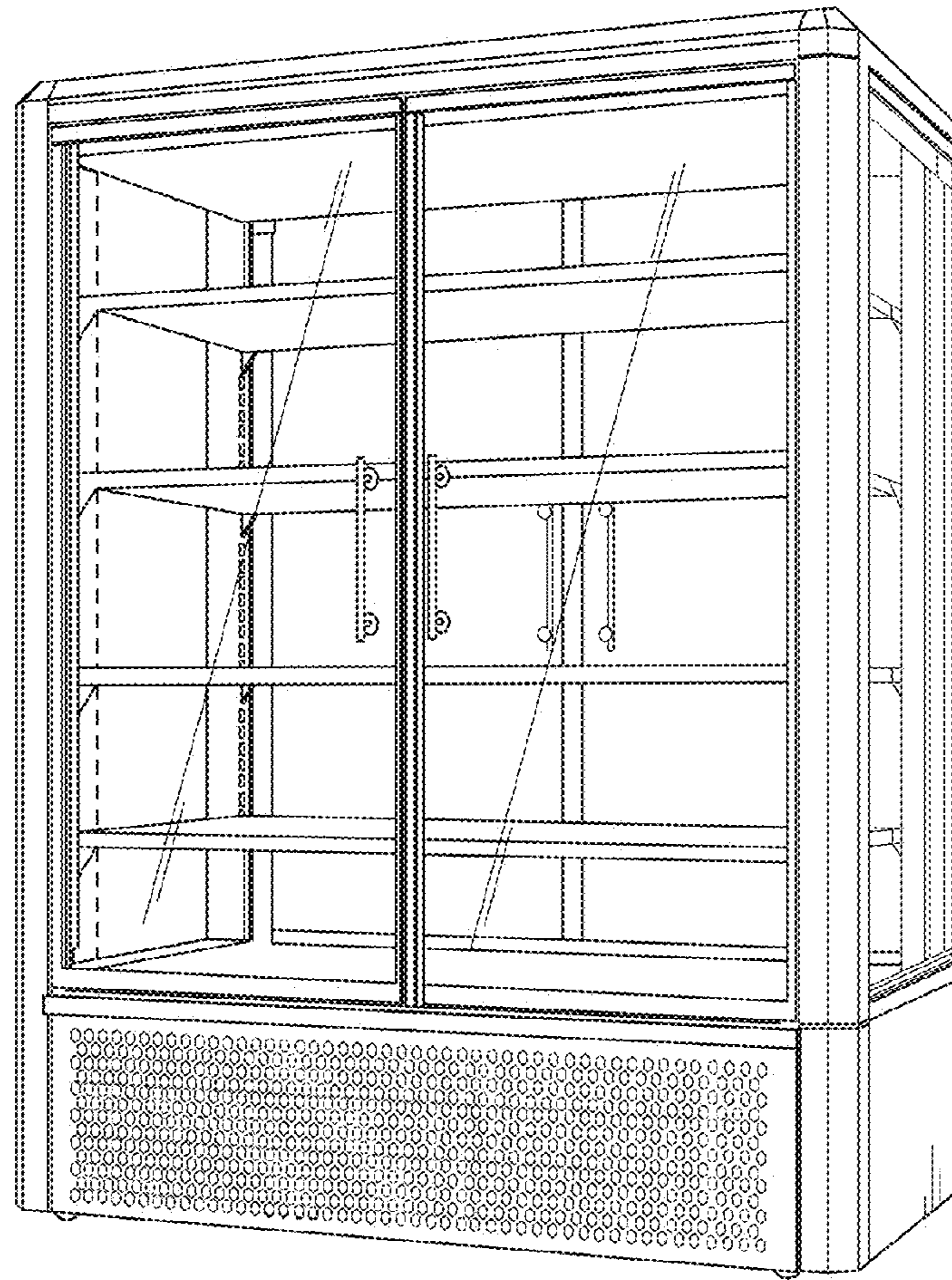

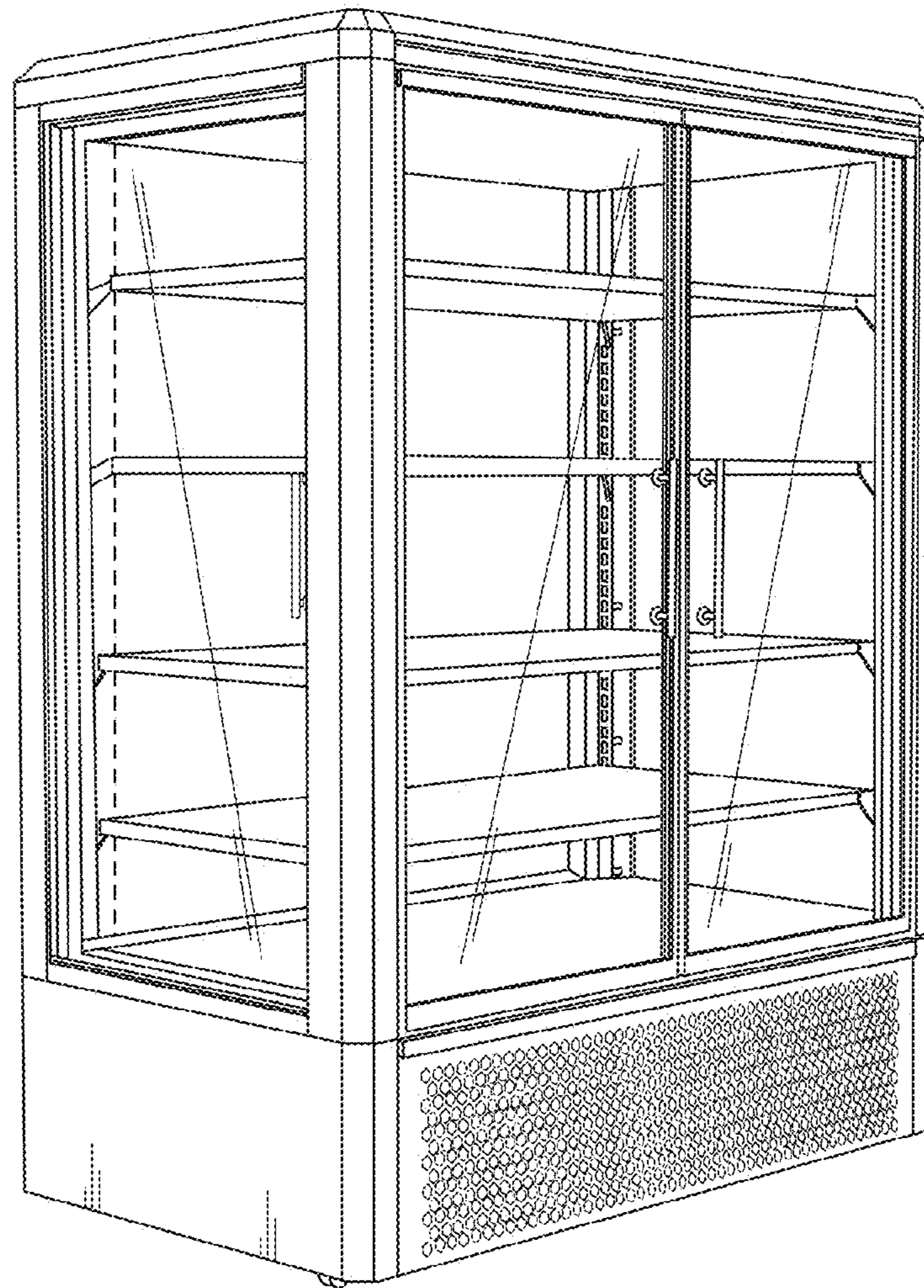

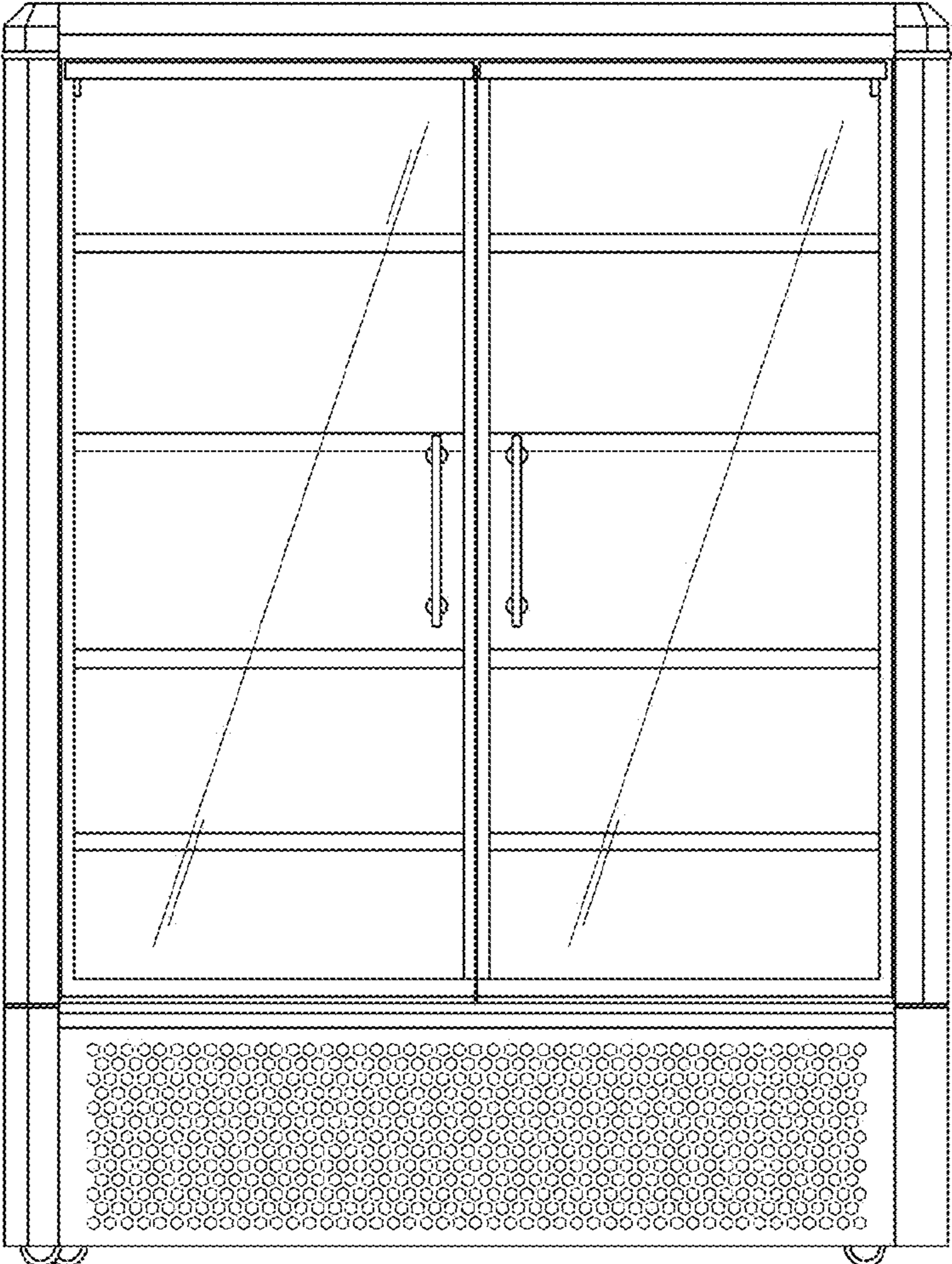

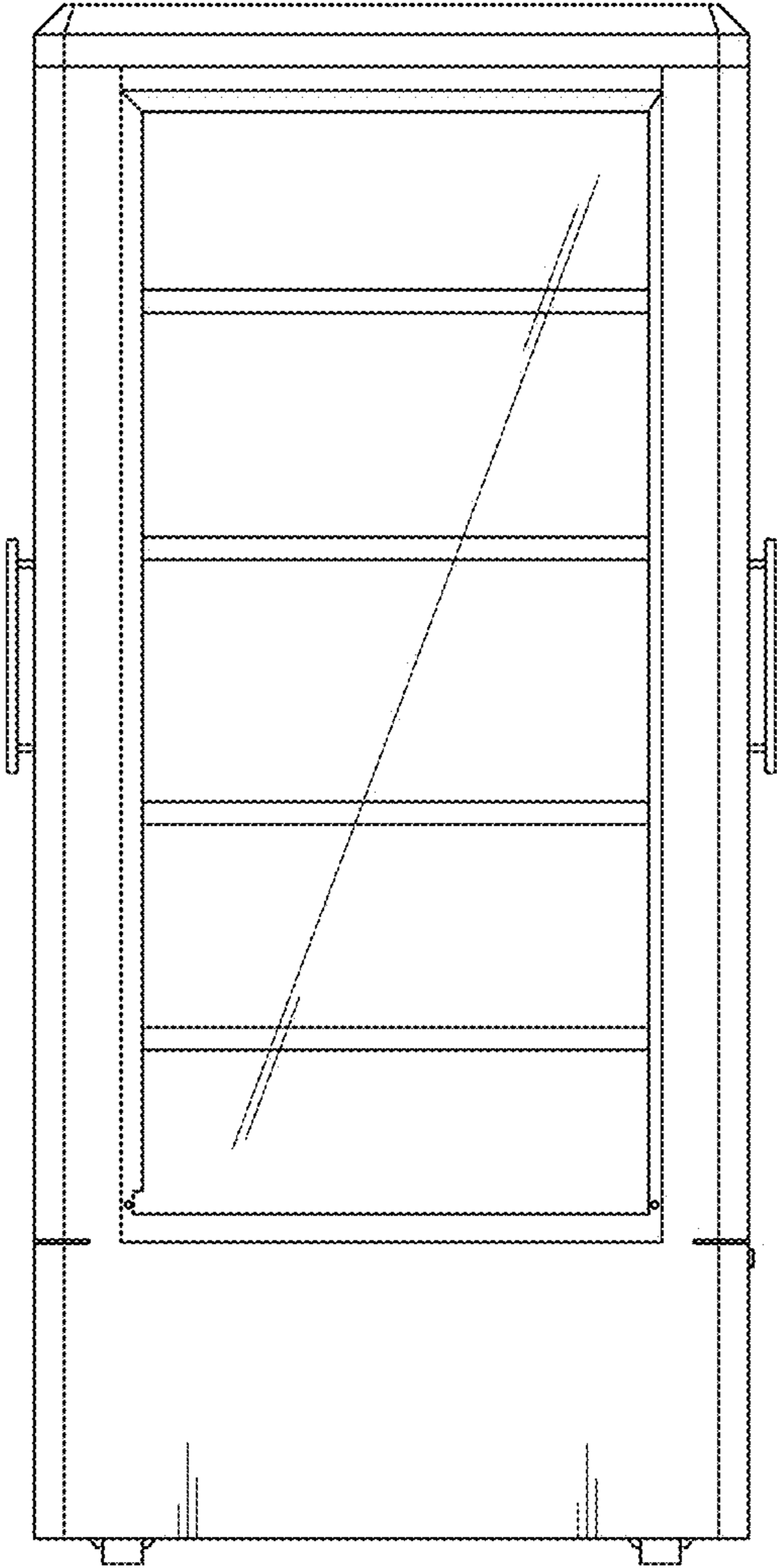
