FIG. 1 is a perspective view of the instructional drum music practice device.

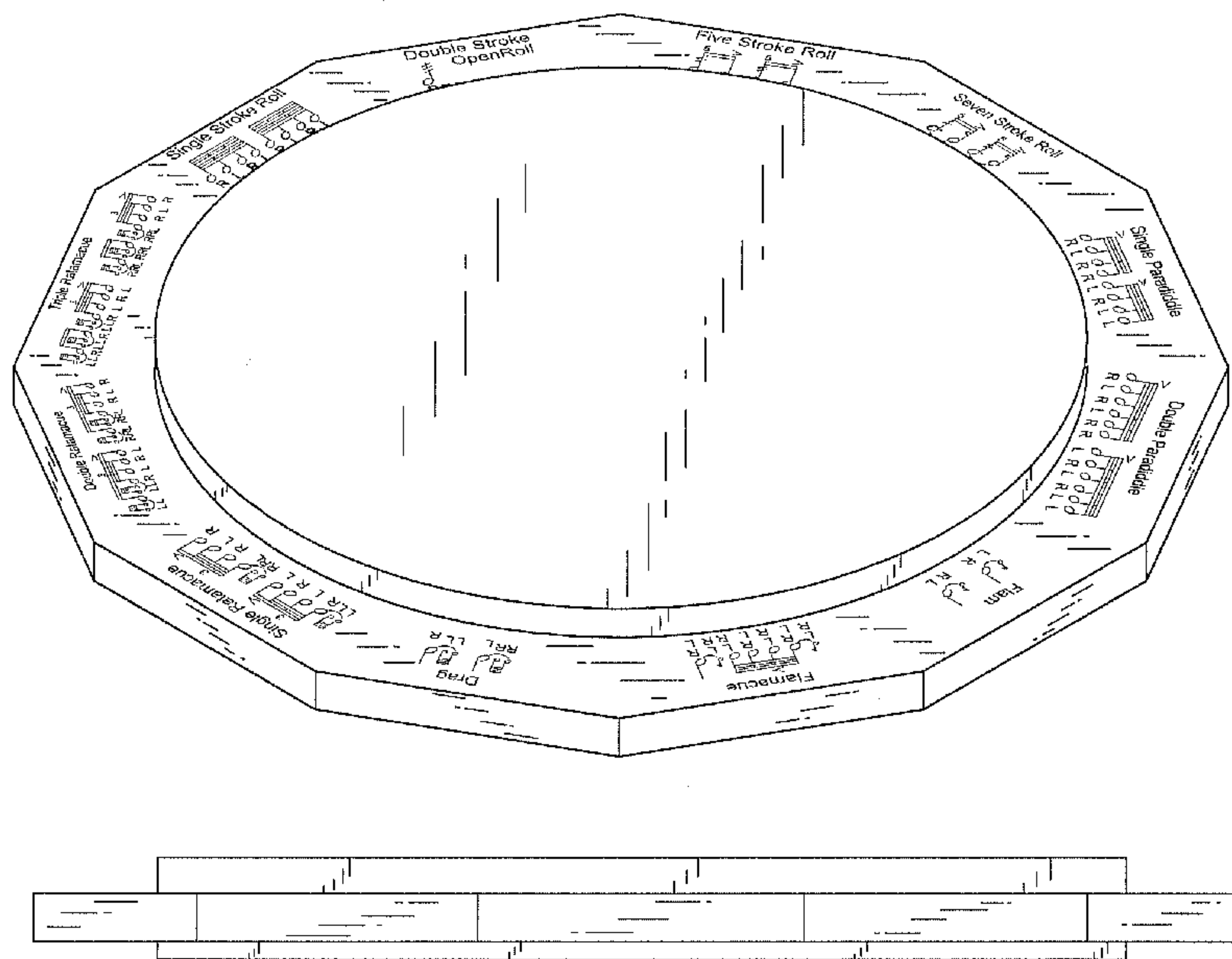
FIG. 2 is a front elevational view of the instructional drum music practice device,

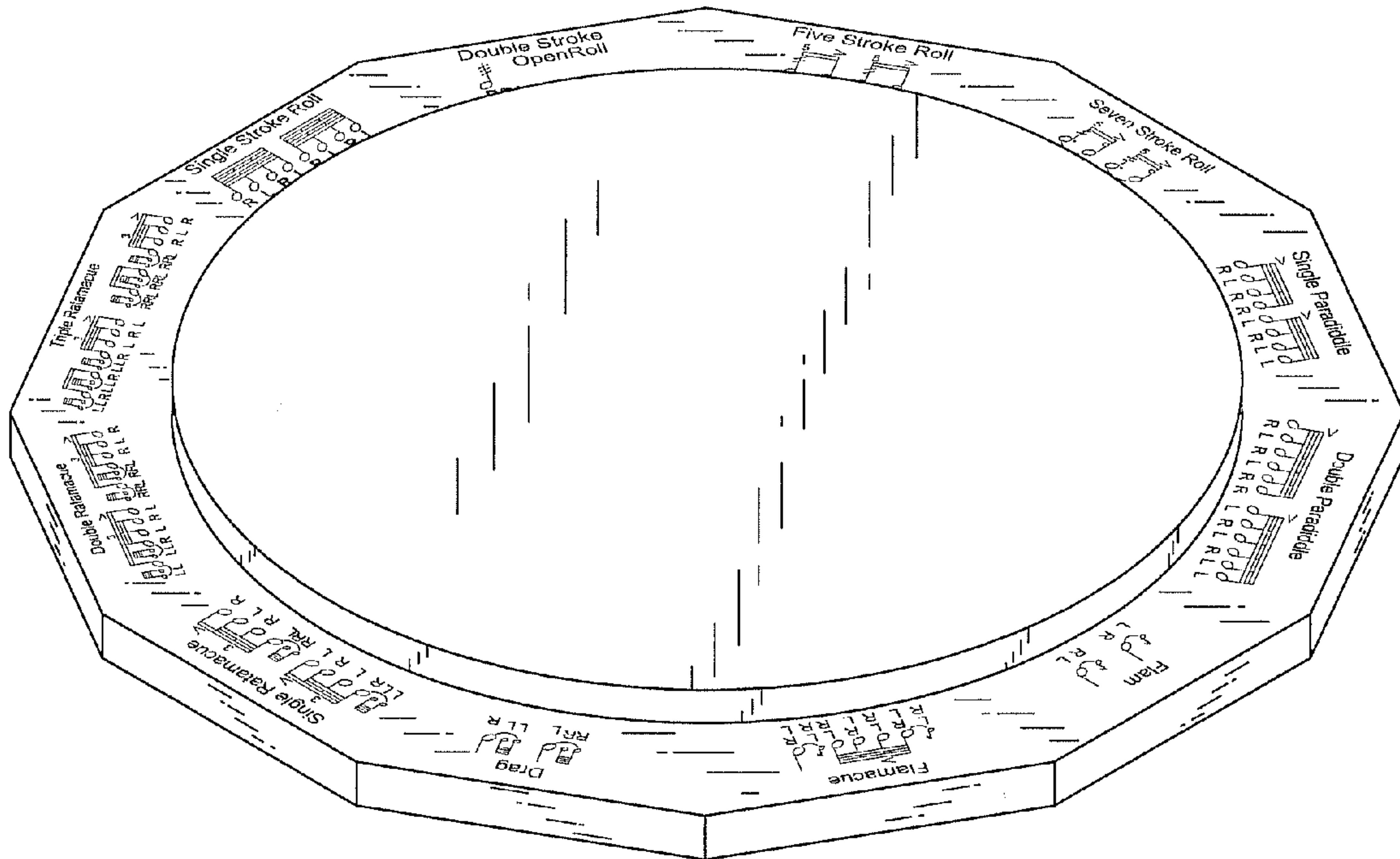

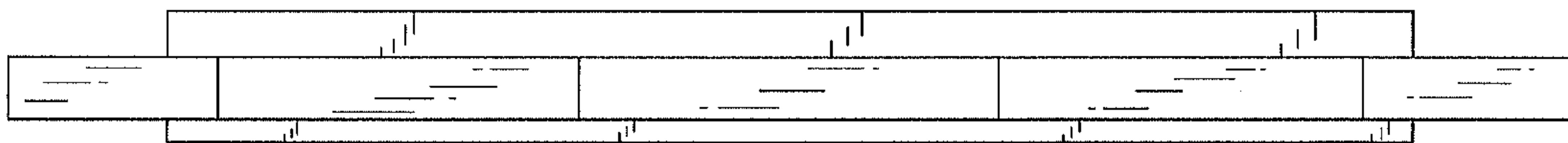

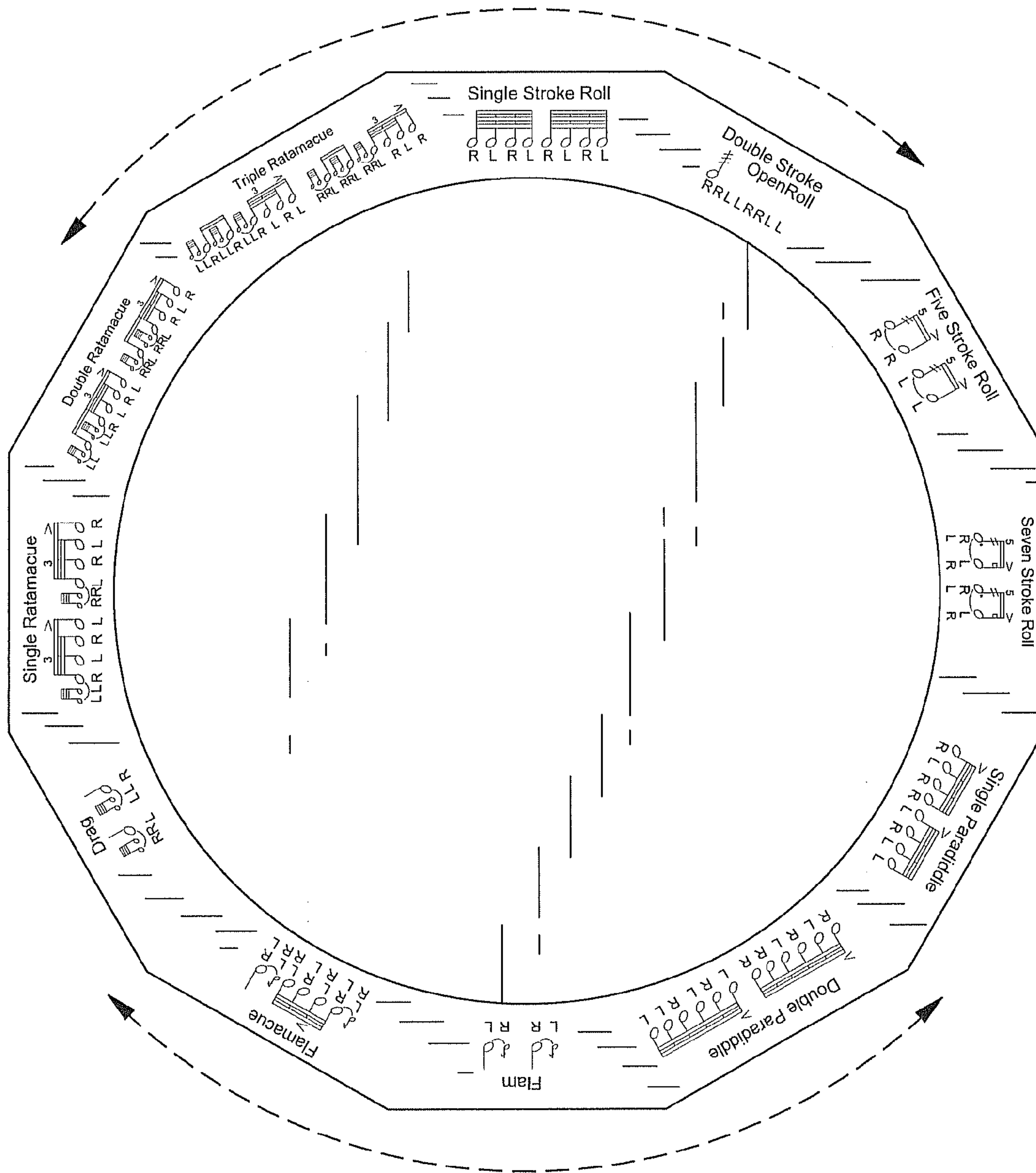

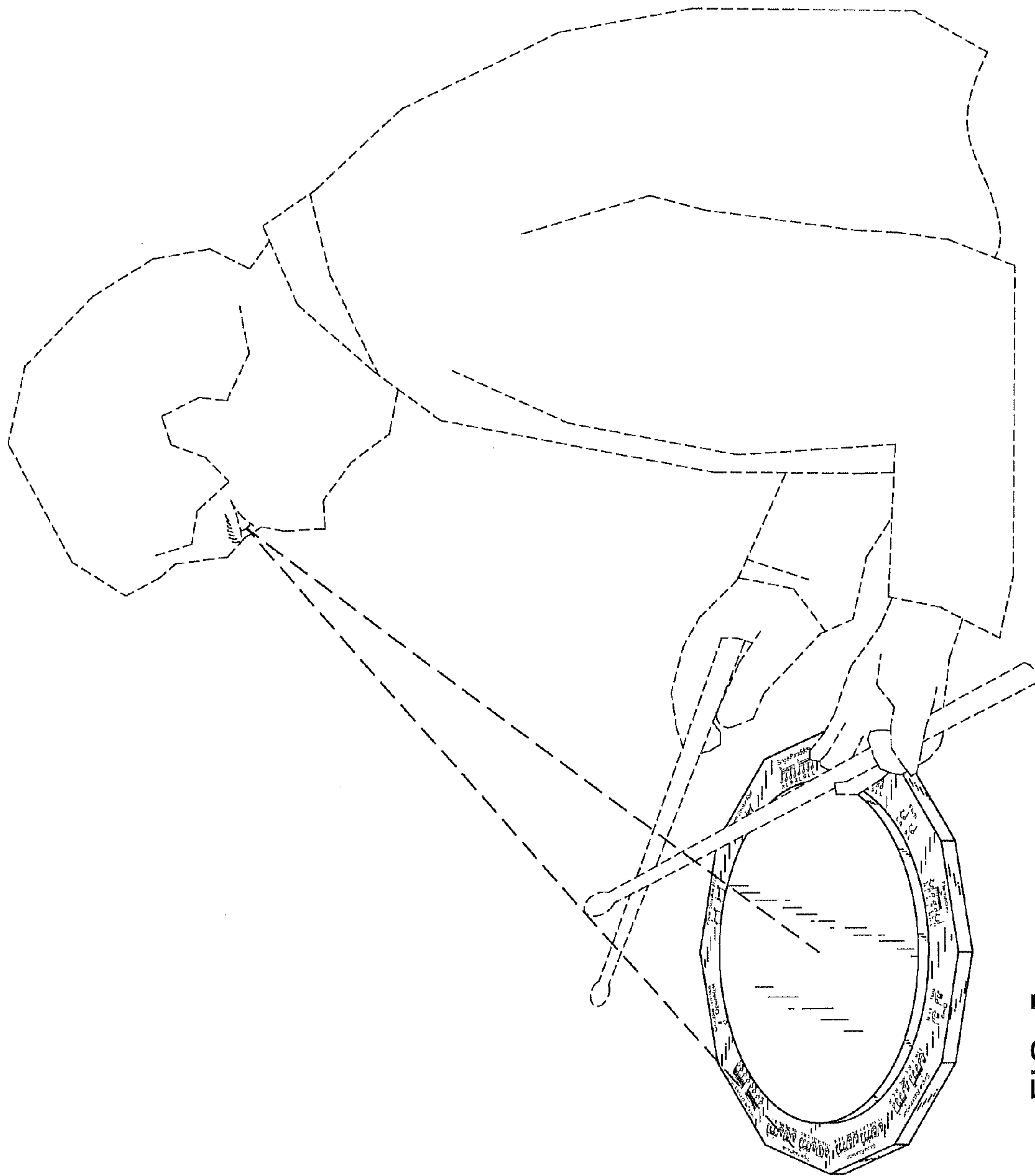
