(57) **CLAIM**

The ornamental design for a soccer themed playing card deck, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of cards A-6, A-7, A-8, A-9, and A-10.

FIG. 2 is a front elevational view of cards B-3, B-4, B-5, B-6, B-7, B-8, B-9, and B-10.

FIG. 3 is a front elevational view of cards I-3, I-4, I-5, I-6, I-7, I-8, I-9, and I-10.

FIG. 4 is a front elevational view of cards C-5, C-6, C-7, C-8, C-9, and C-10.

FIG. 5 is a front elevational view of cards P-1, R-1, A-1, G-1, and C-1.

FIG. 6 is a front elevational view of cards R-1 through R-9.

FIG. 7 is a front elevational view of cards R-10 through R-16; and,

FIG. 8 is a rear elevational view of each card of the deck. Each card is of conventional thickness, with the top, bottom, and side edges being unclaimed.

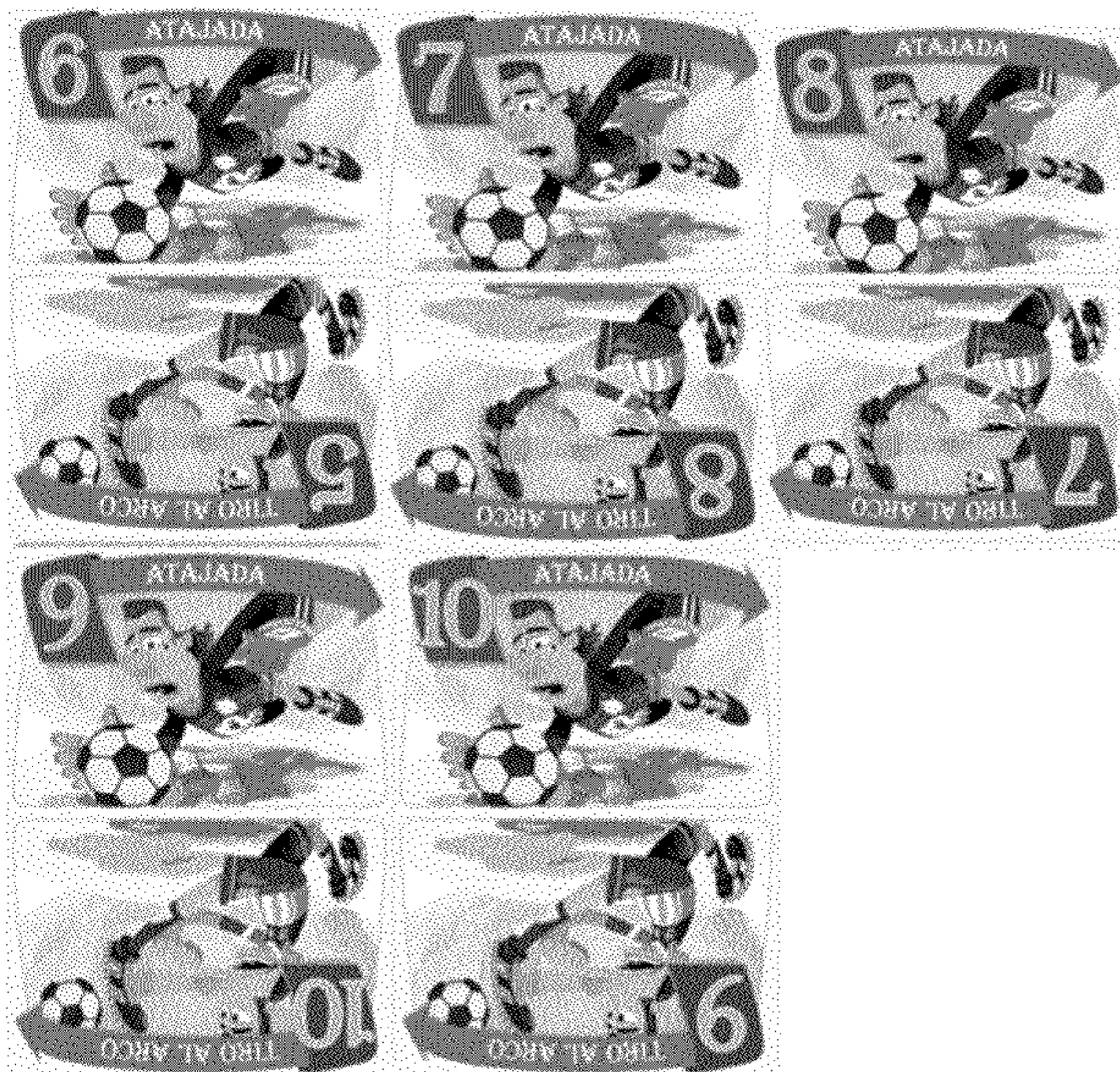

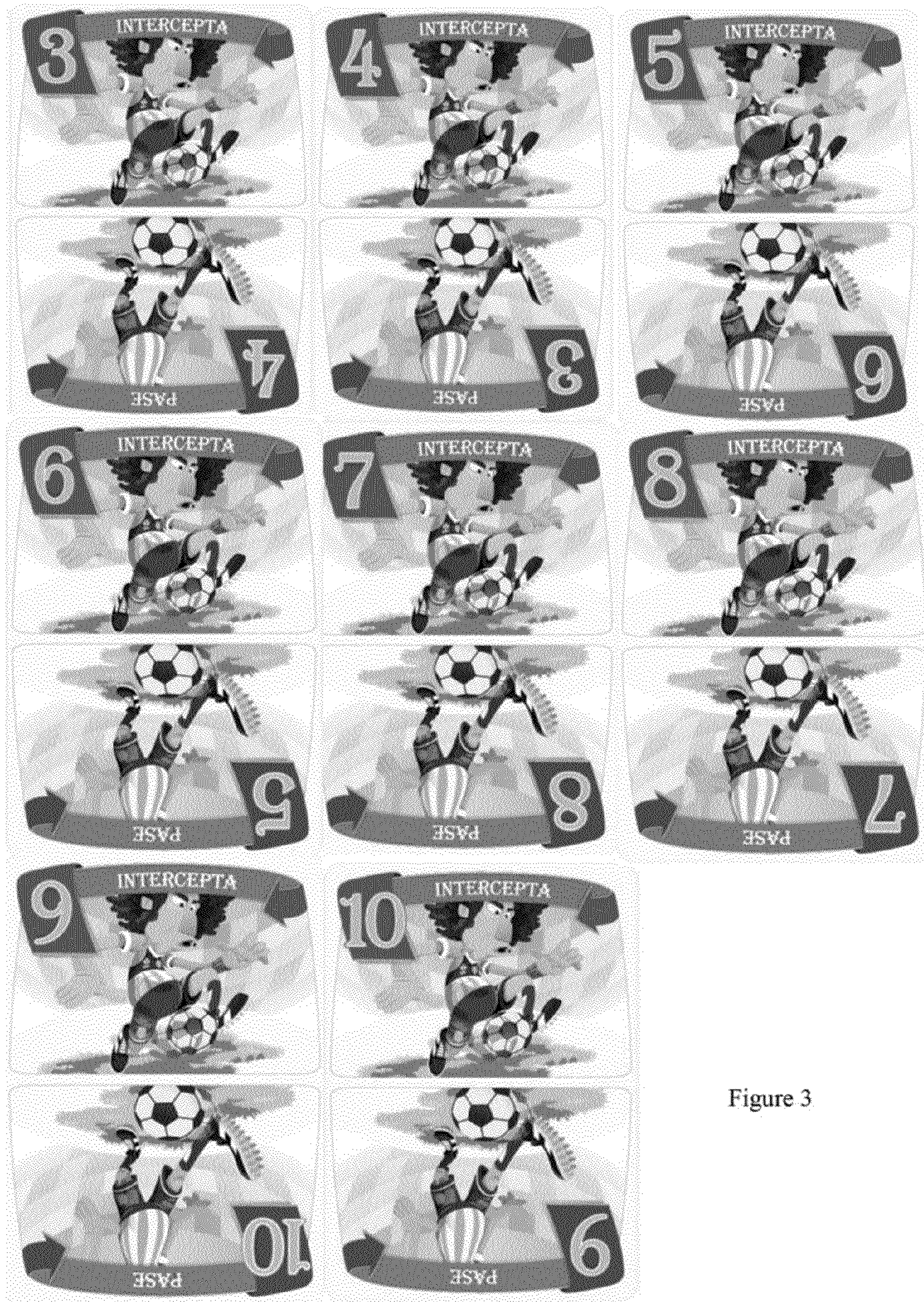

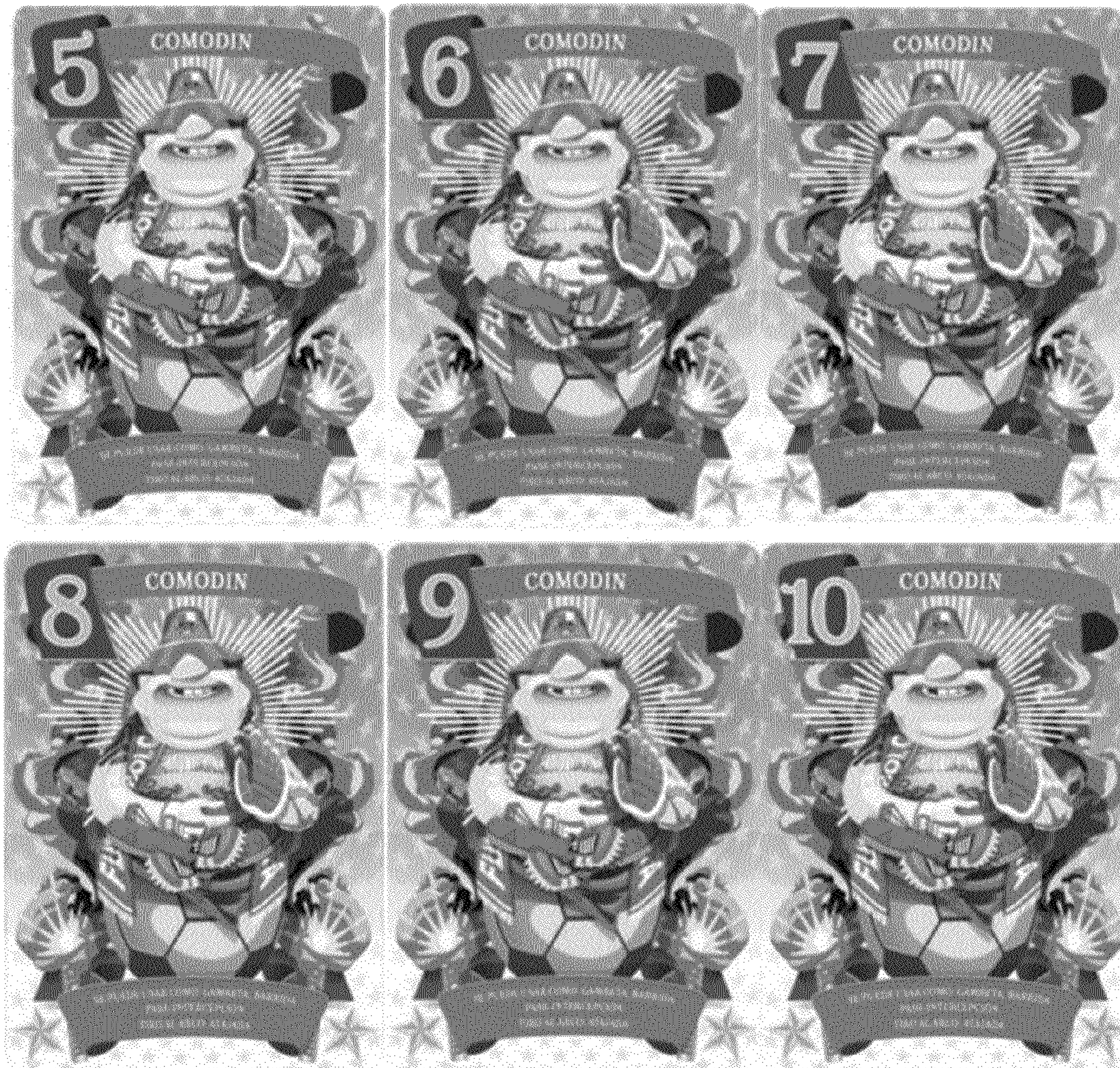
