**DESCRIPTION**

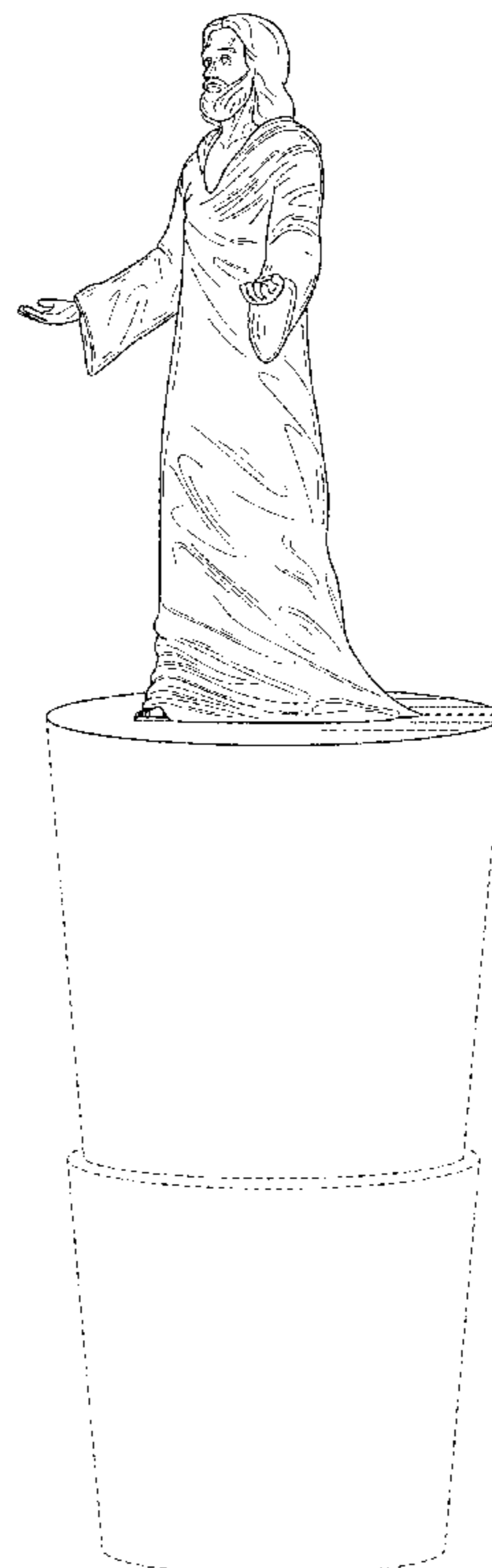
FIG. 1 is a front perspective view of an ornamental pool chlorinator shown in accordance with my new design;

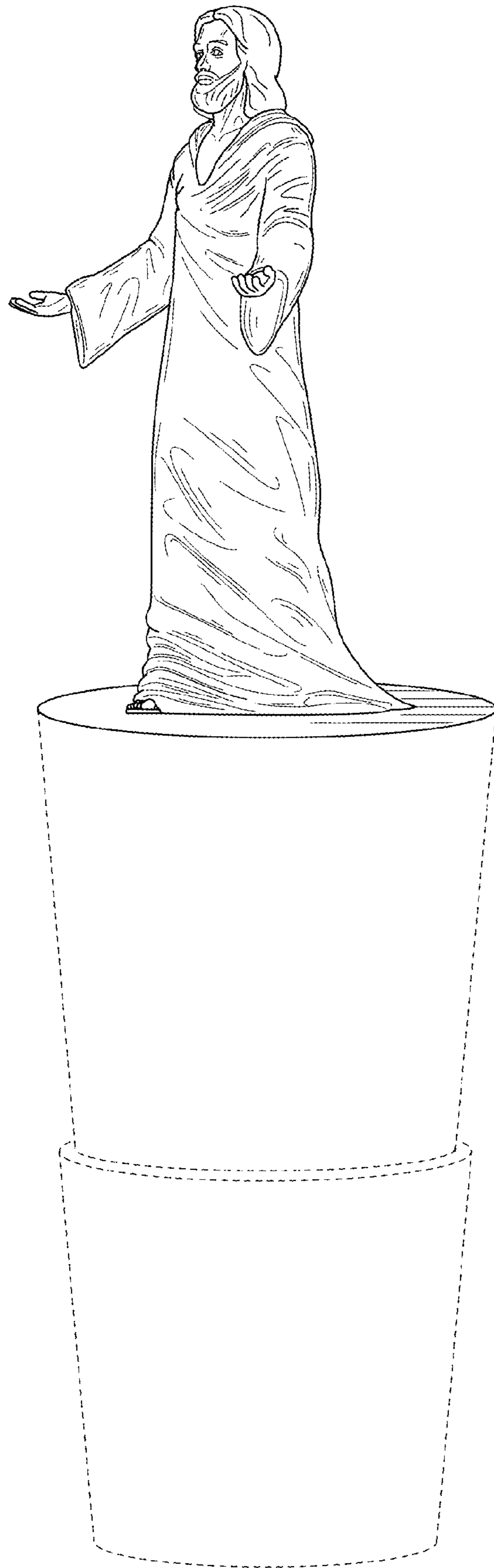

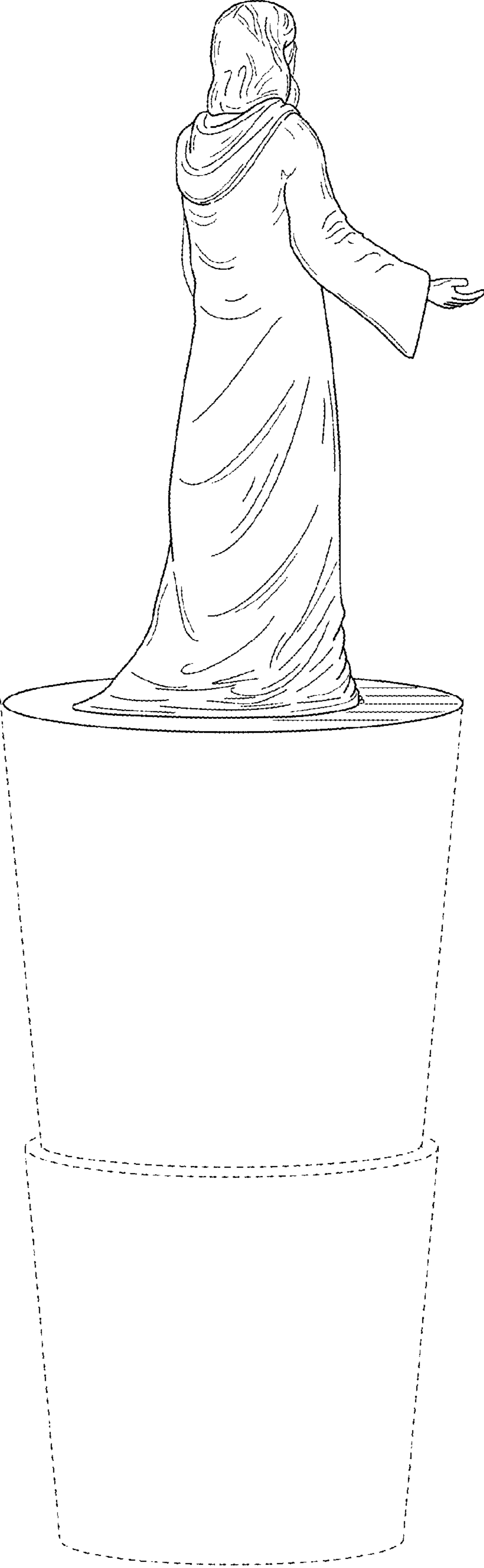

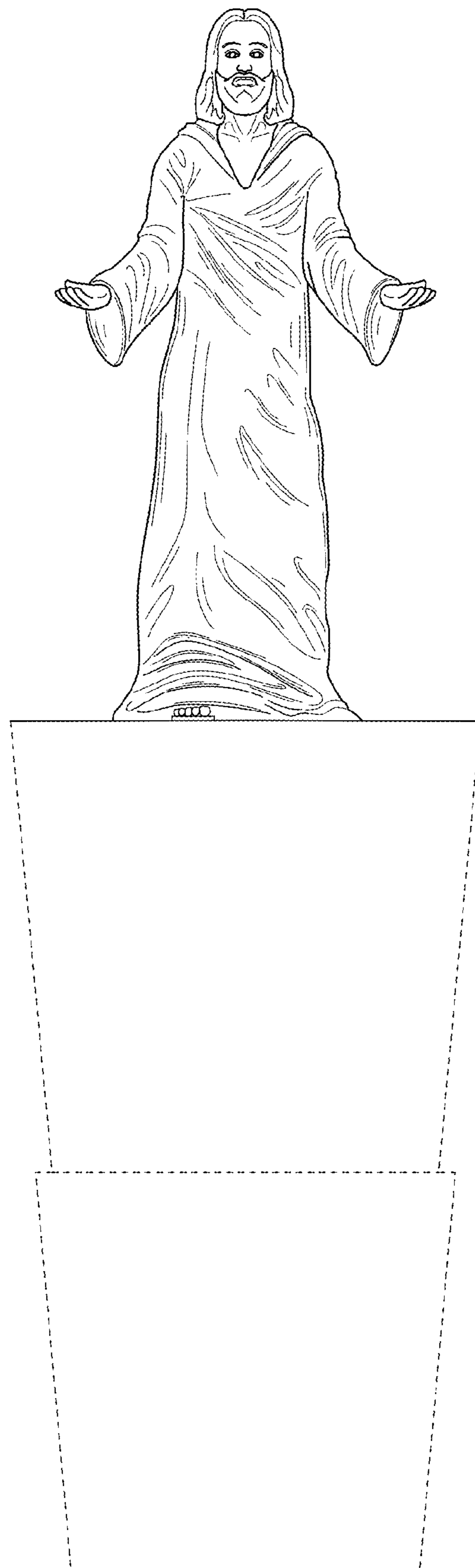

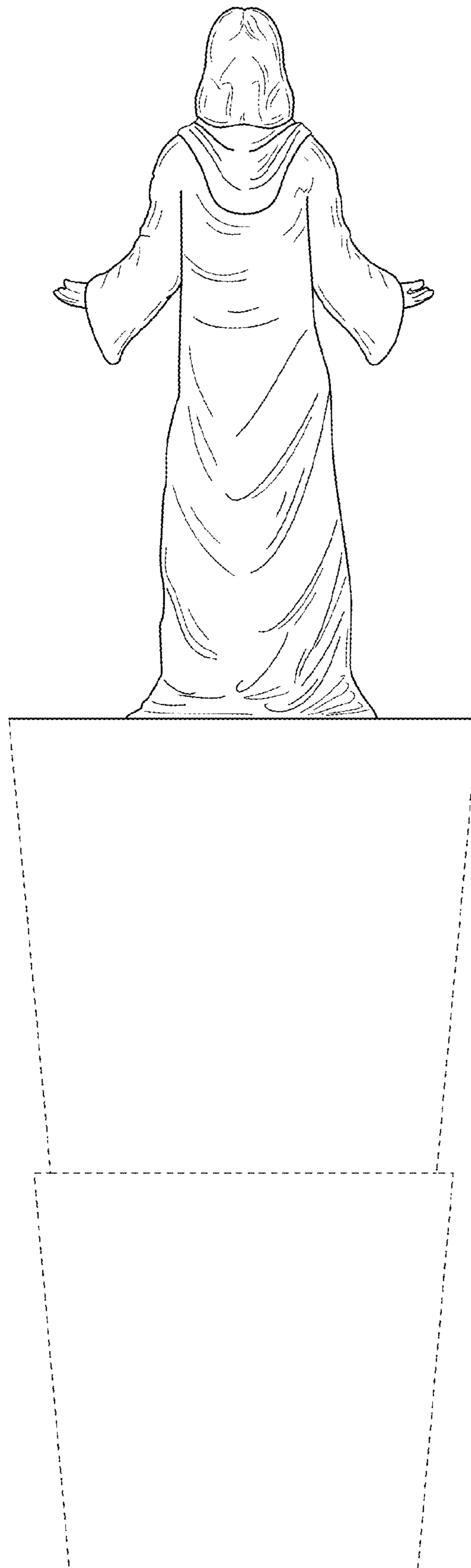

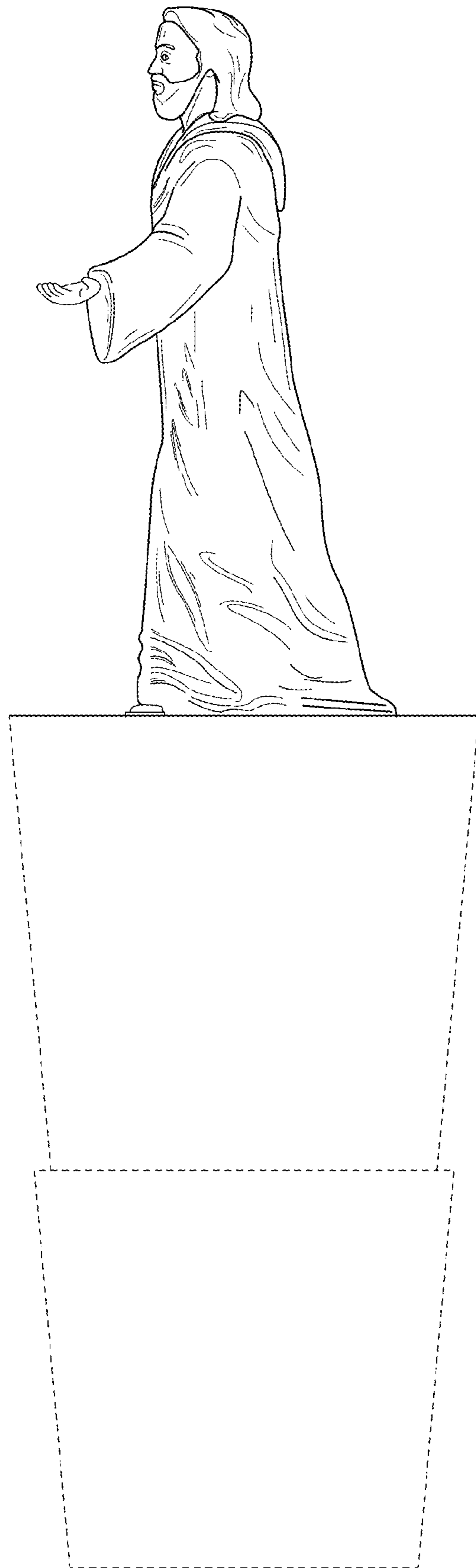

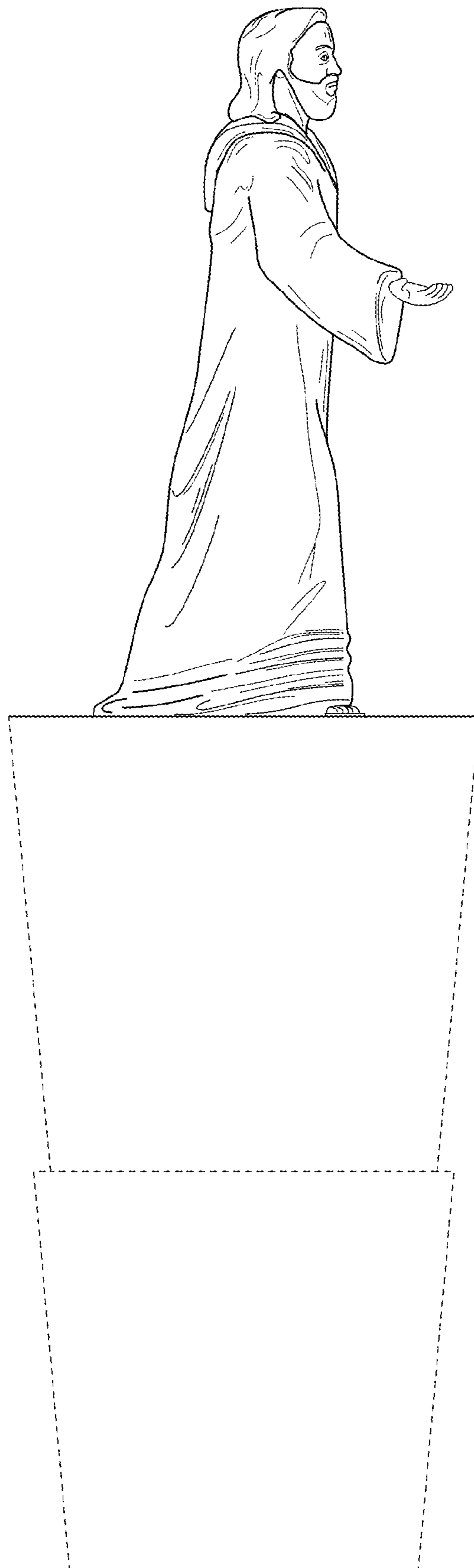
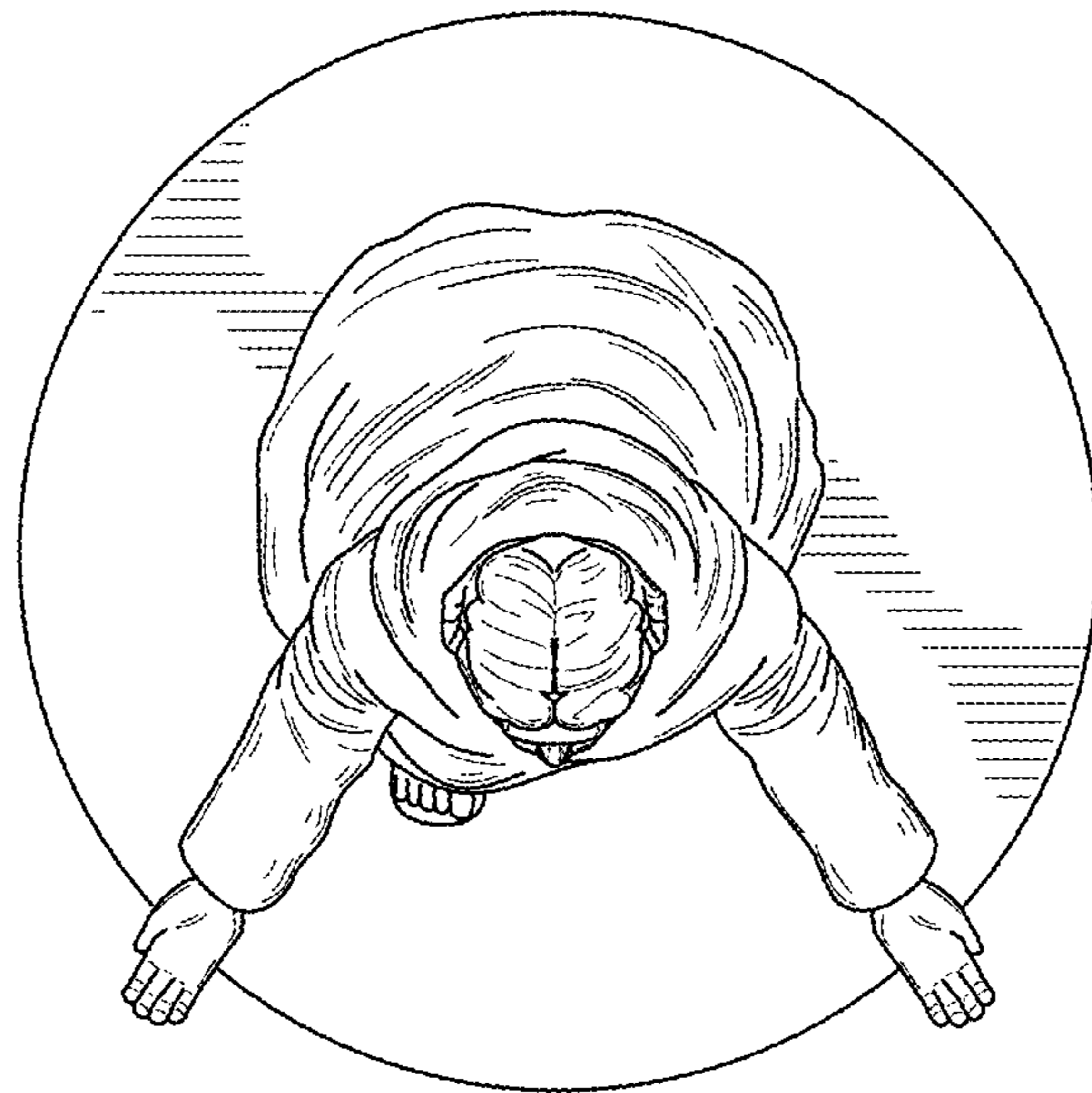
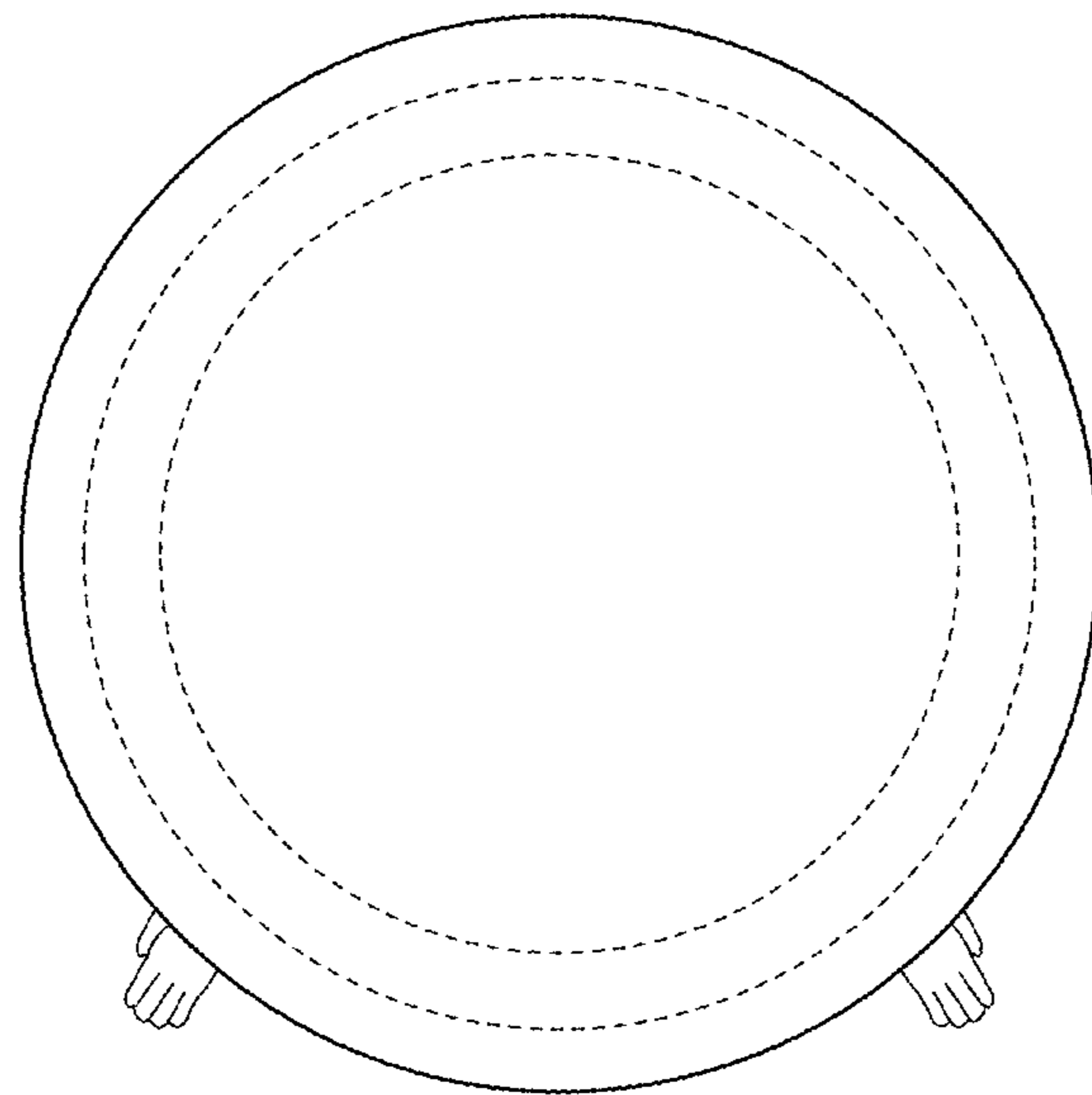
