(57) **CLAIM**

The ornamental design for a urinary assistance device, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a urinary assistance device in an unassembled, flat configuration, showing my new design;

FIG. 20 is a left side elevation view thereof;

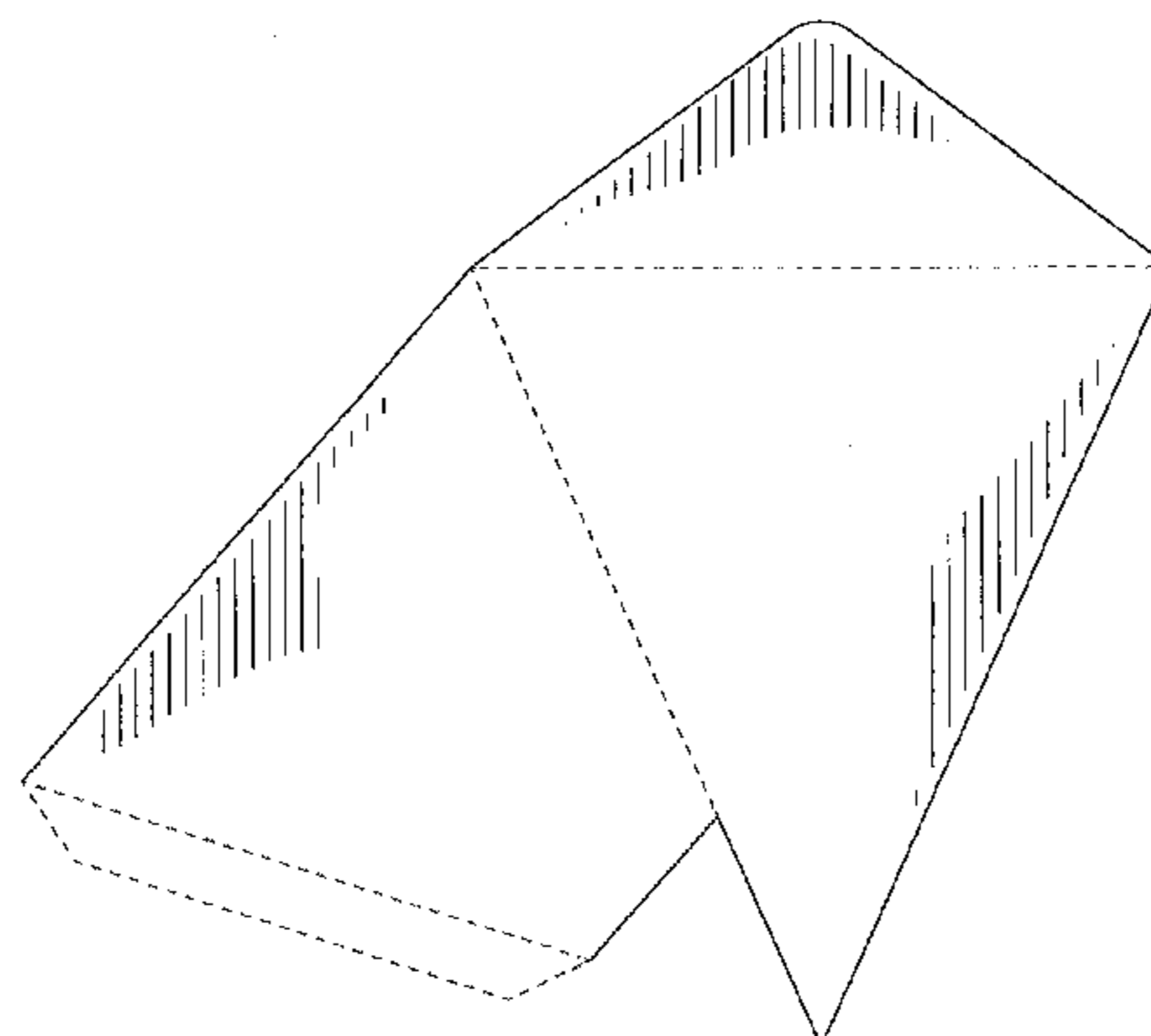
FIG. 21 is a right elevation view thereof;

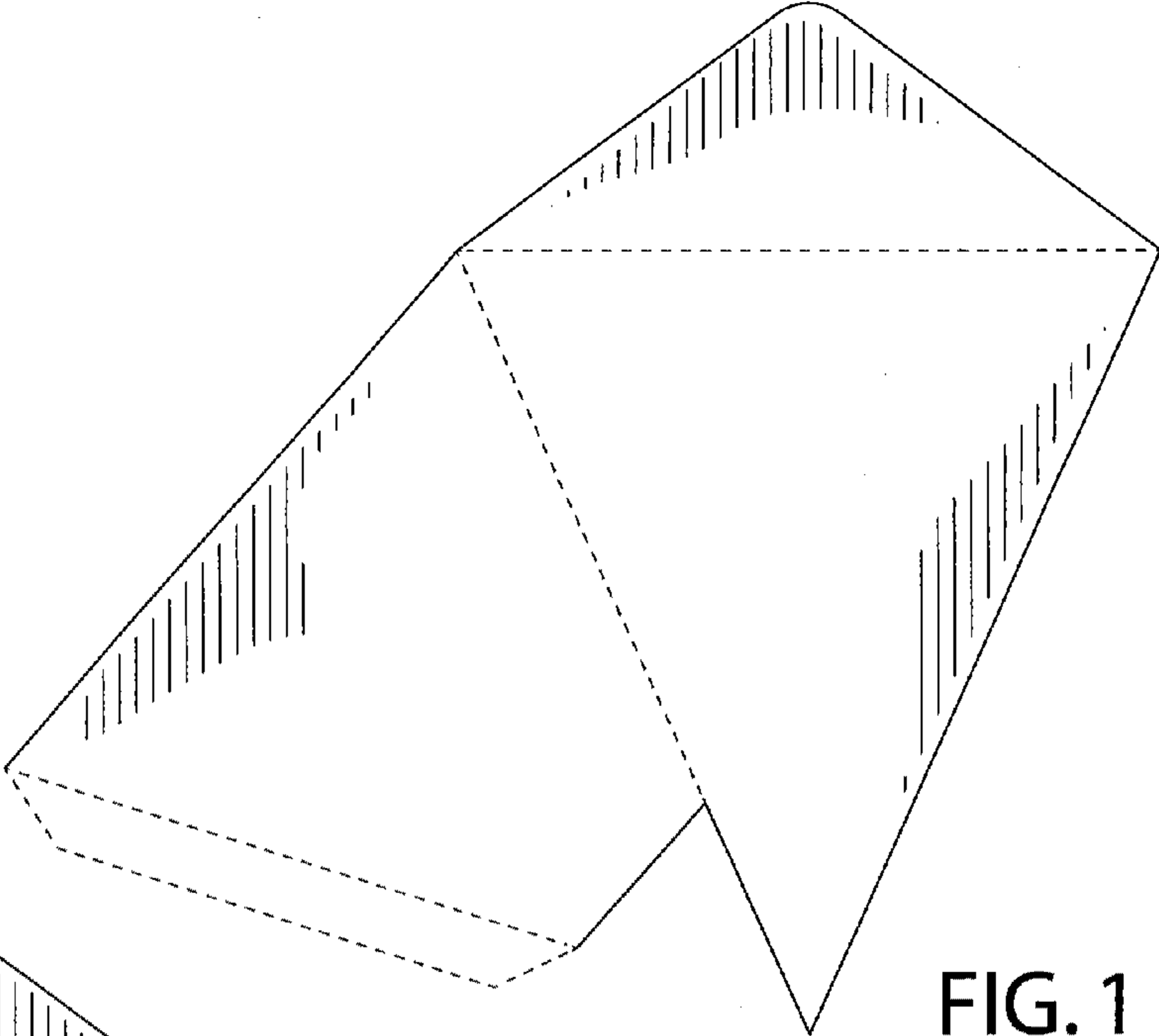

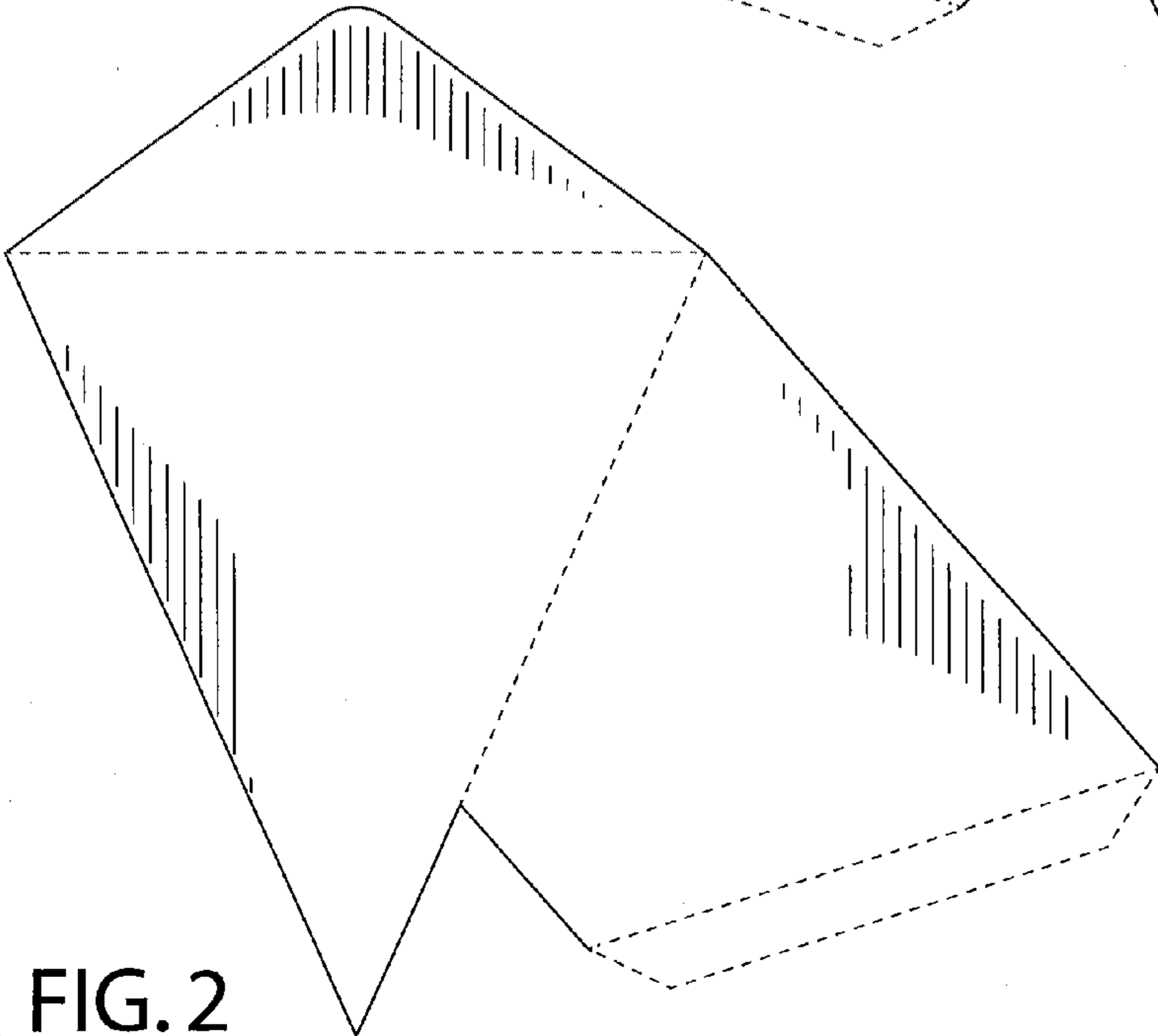

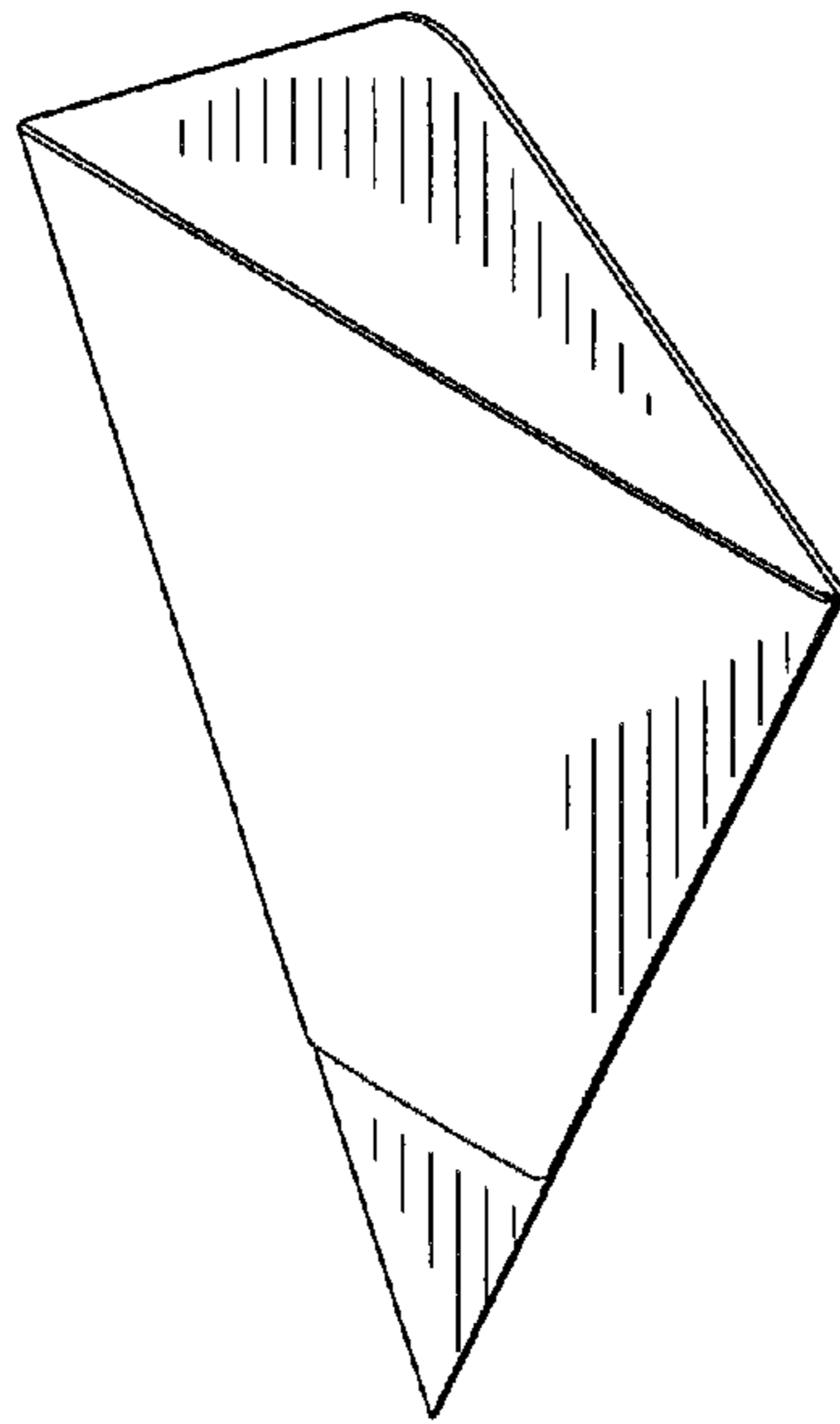

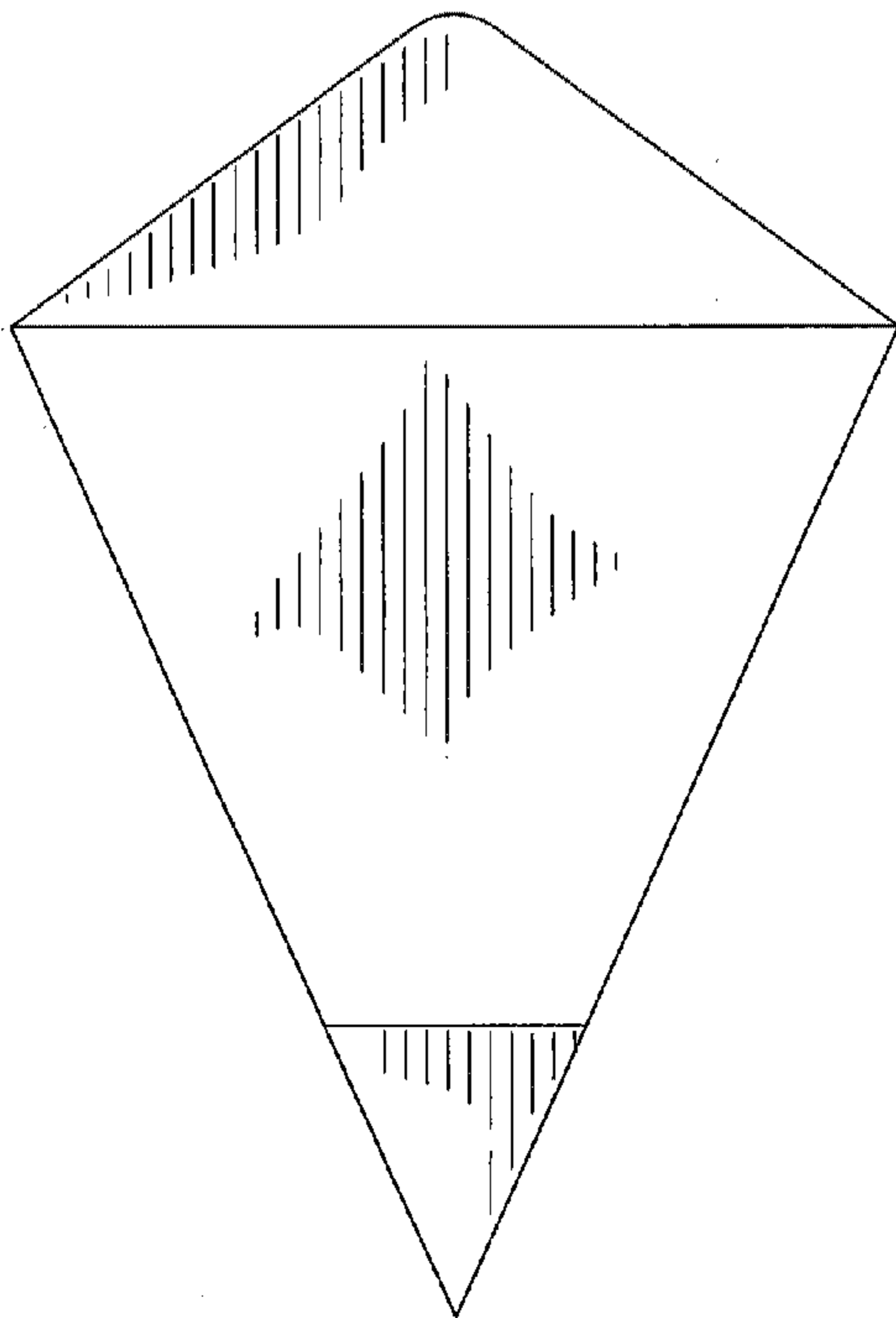

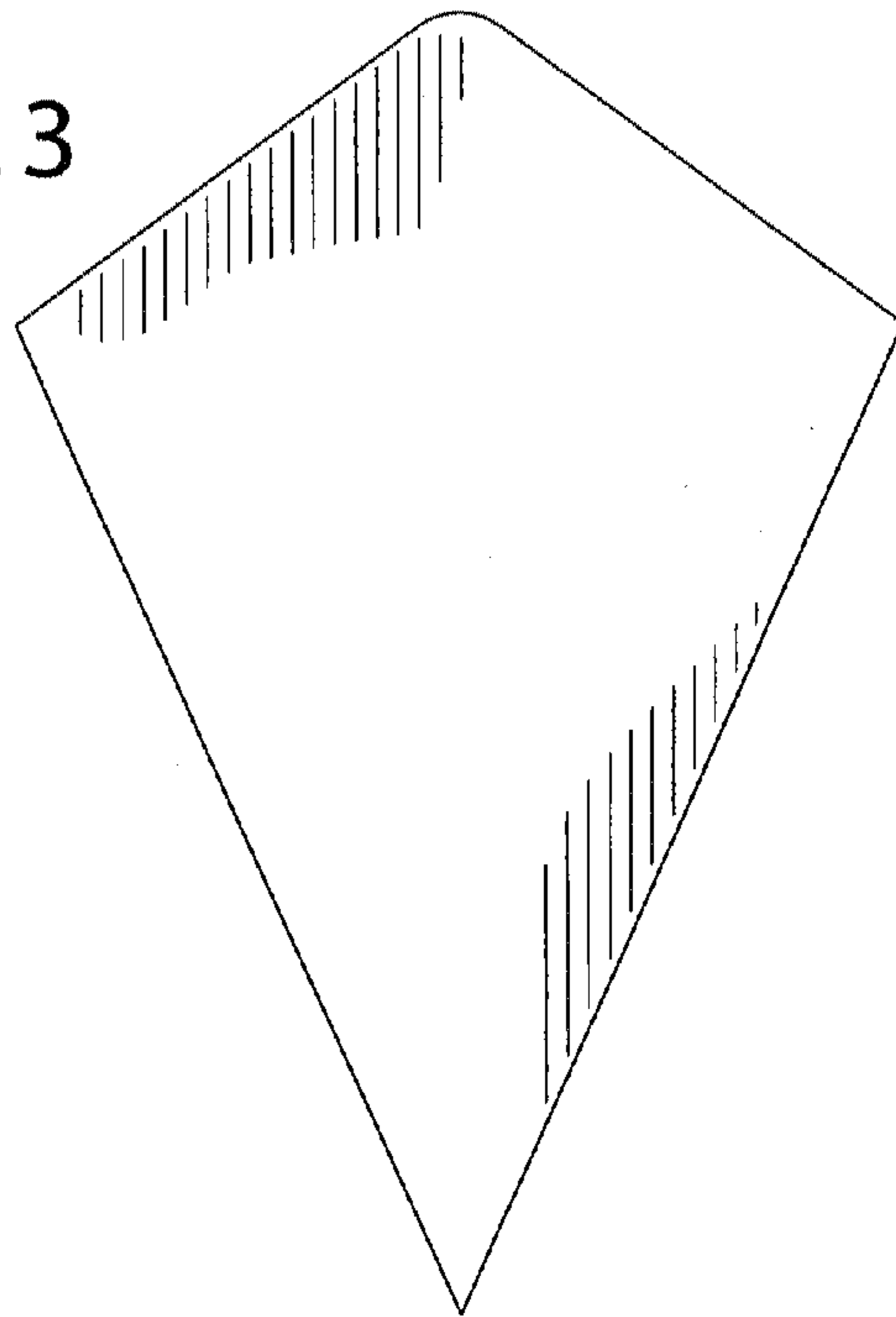

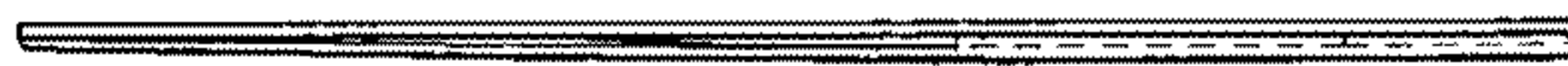

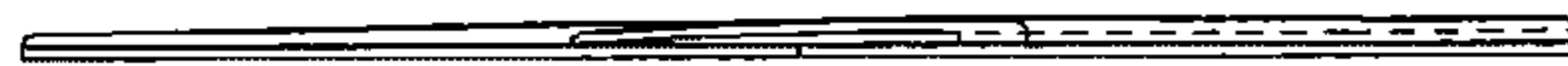

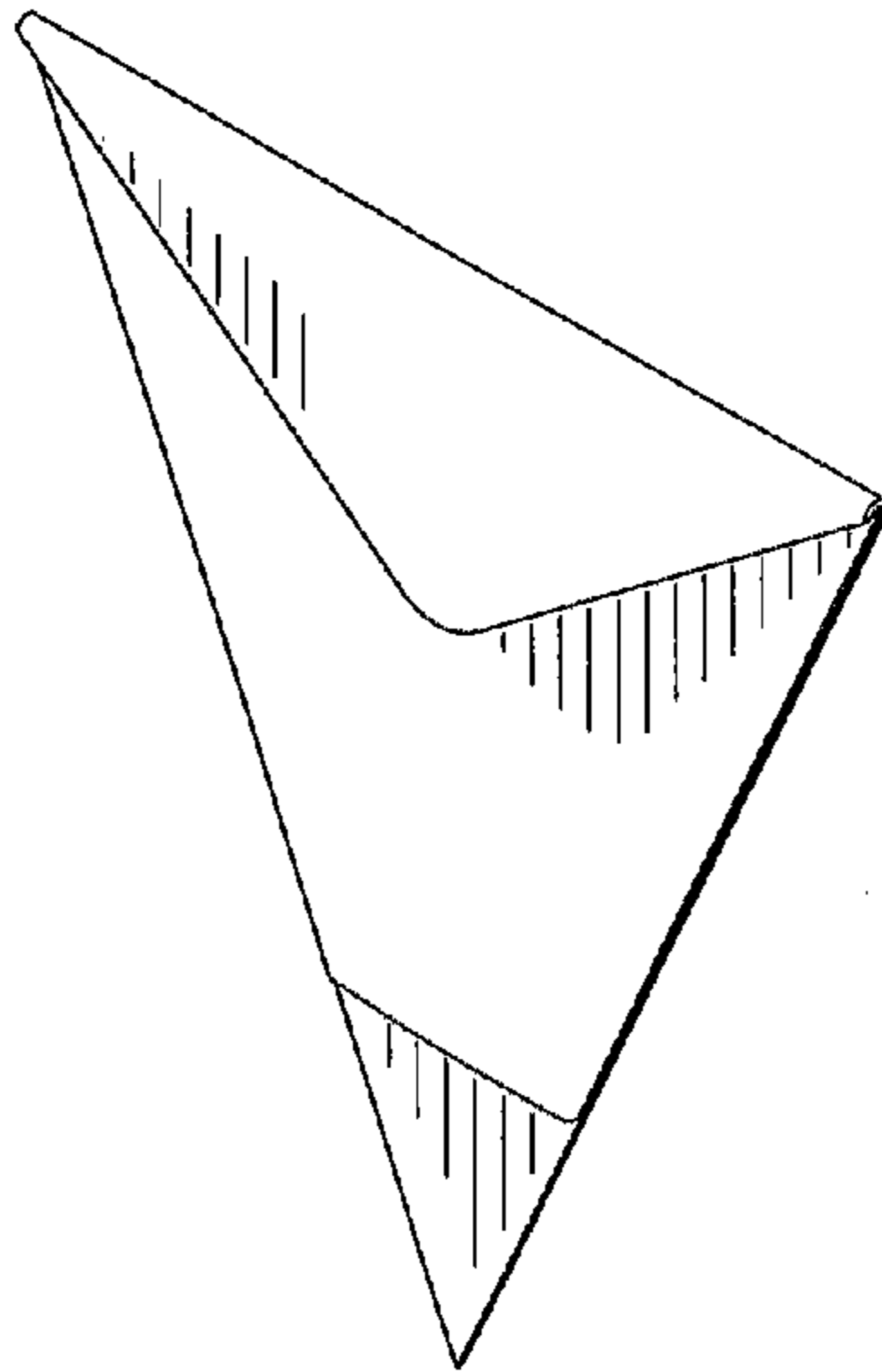

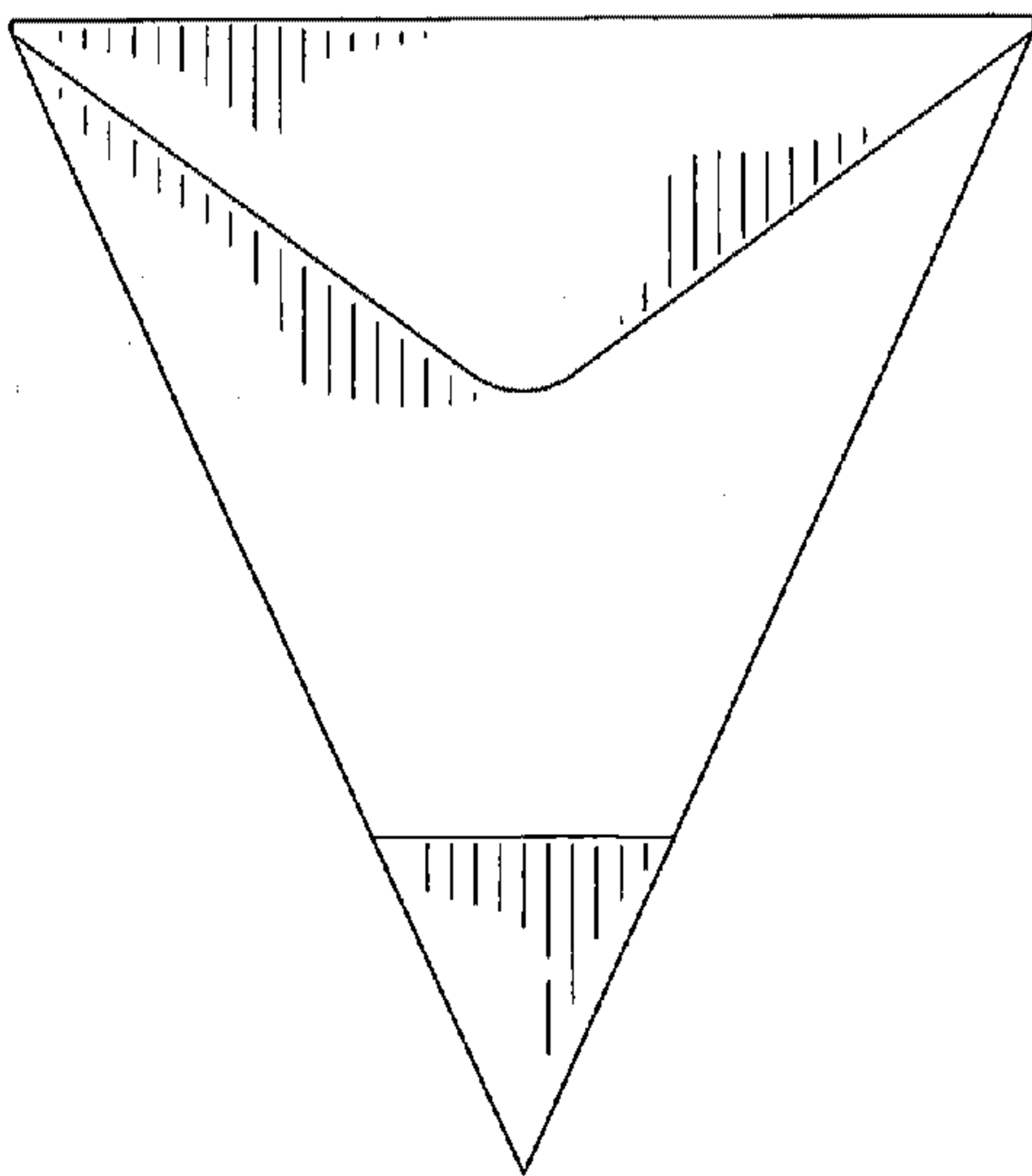

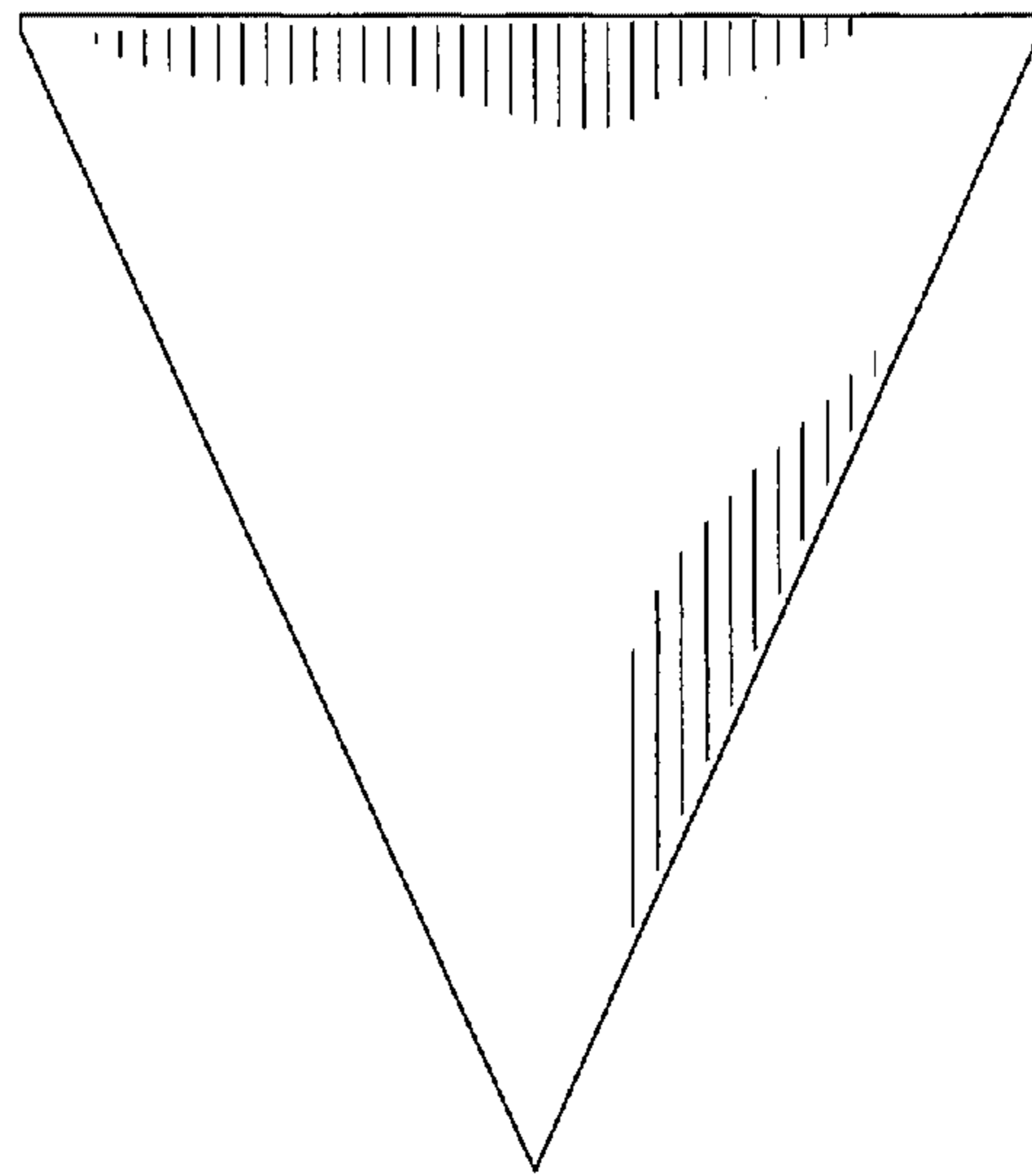

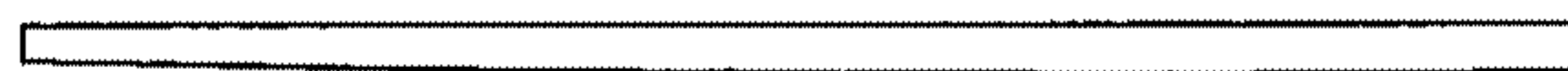

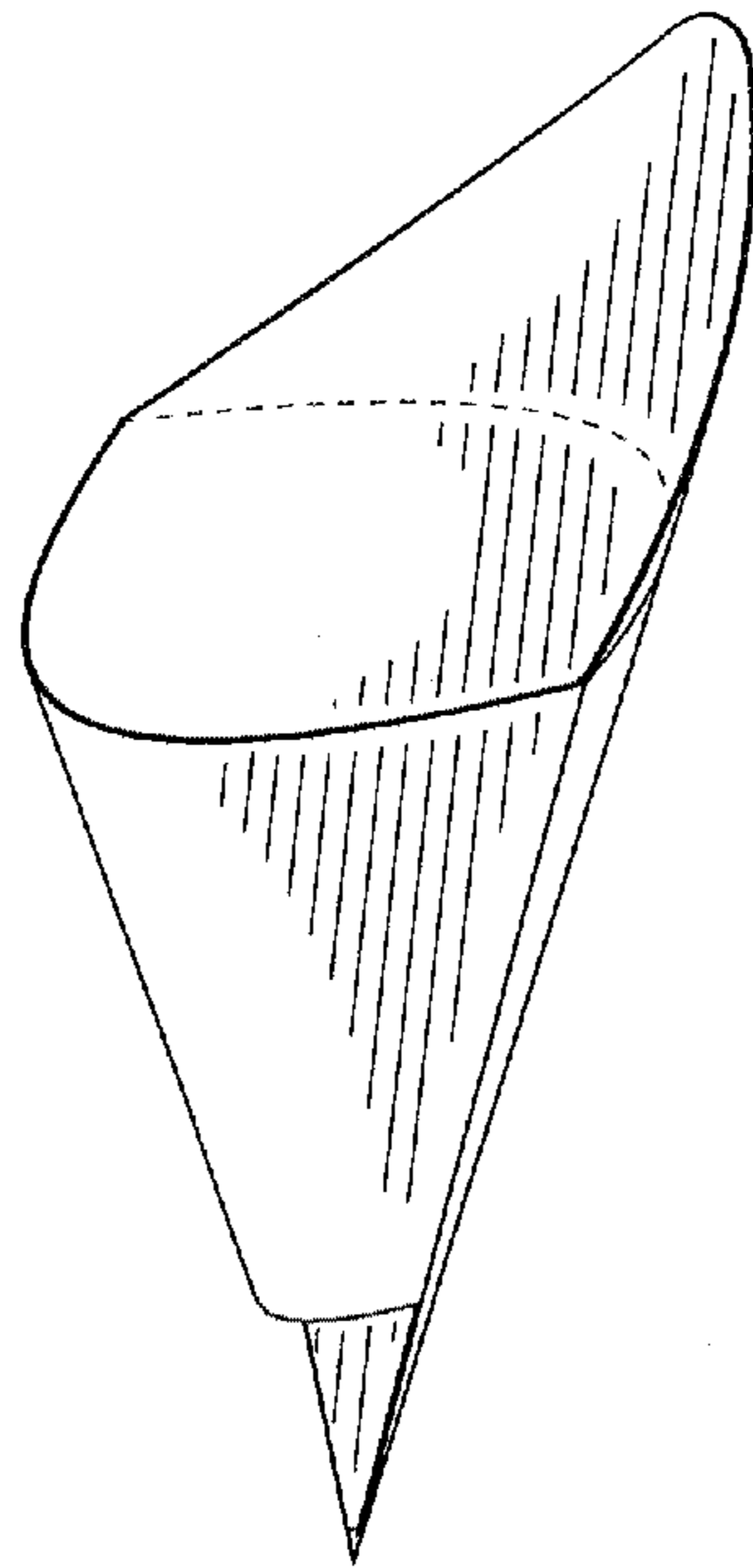

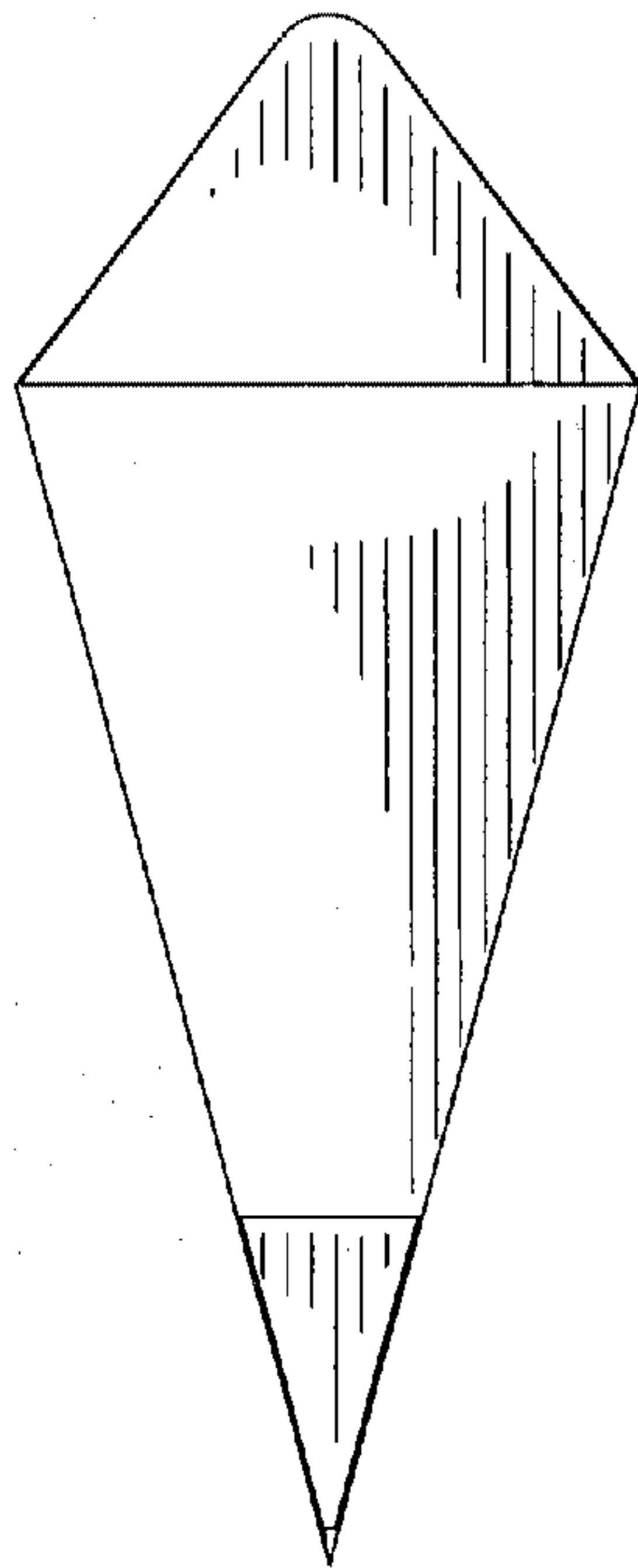

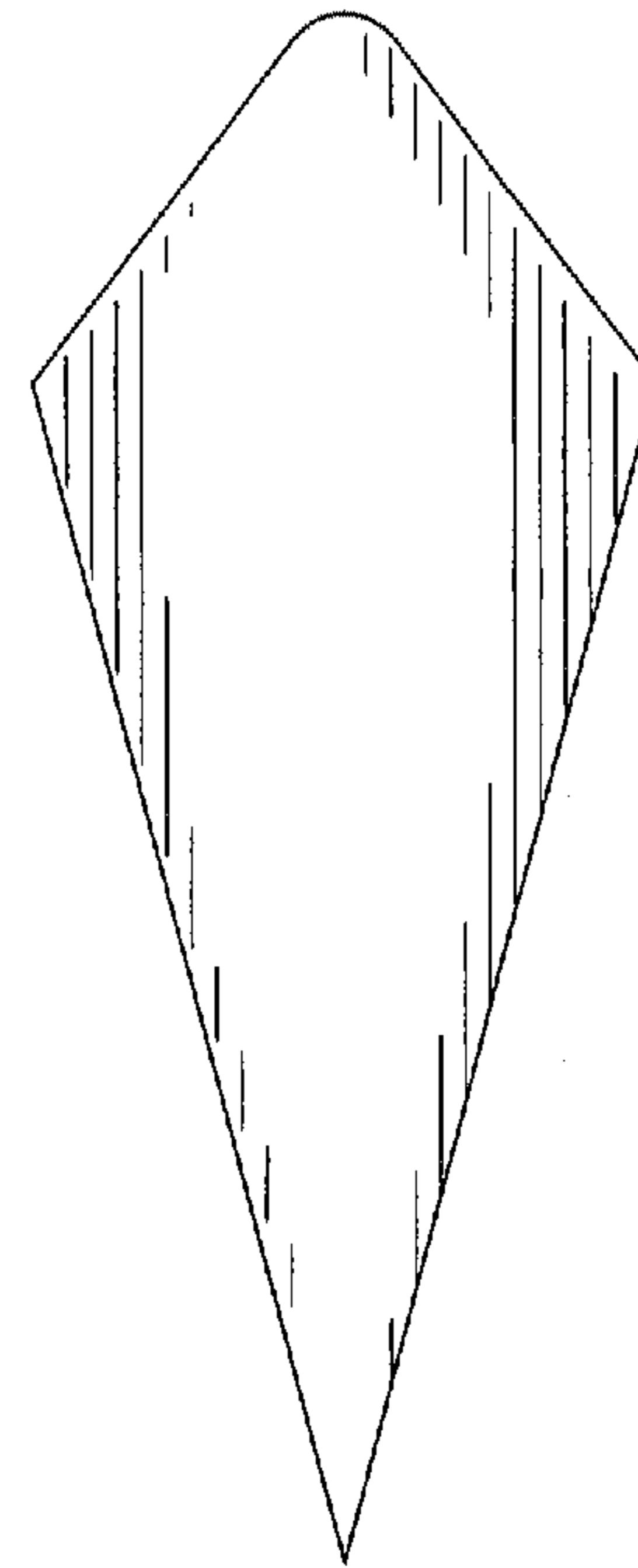

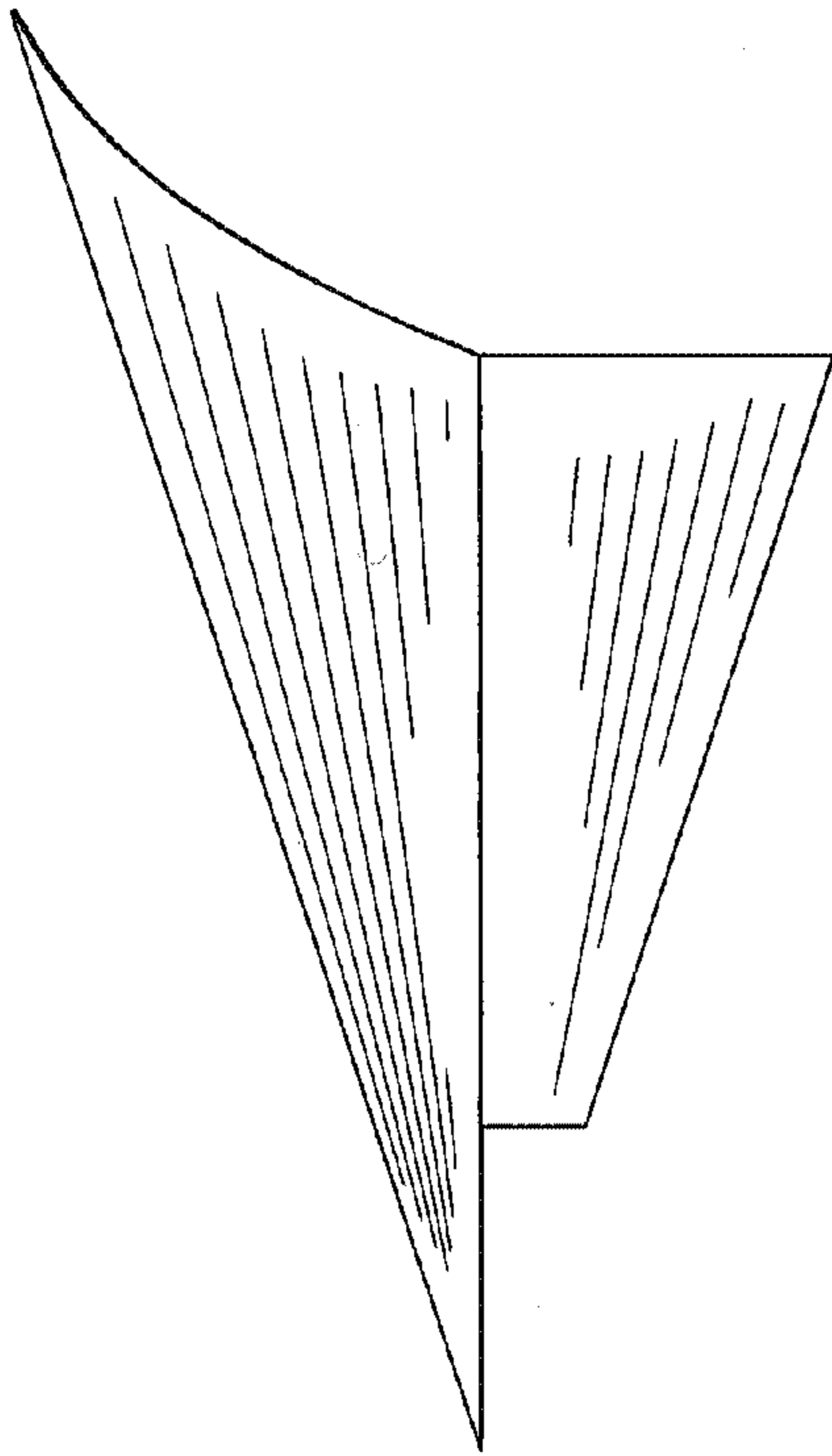

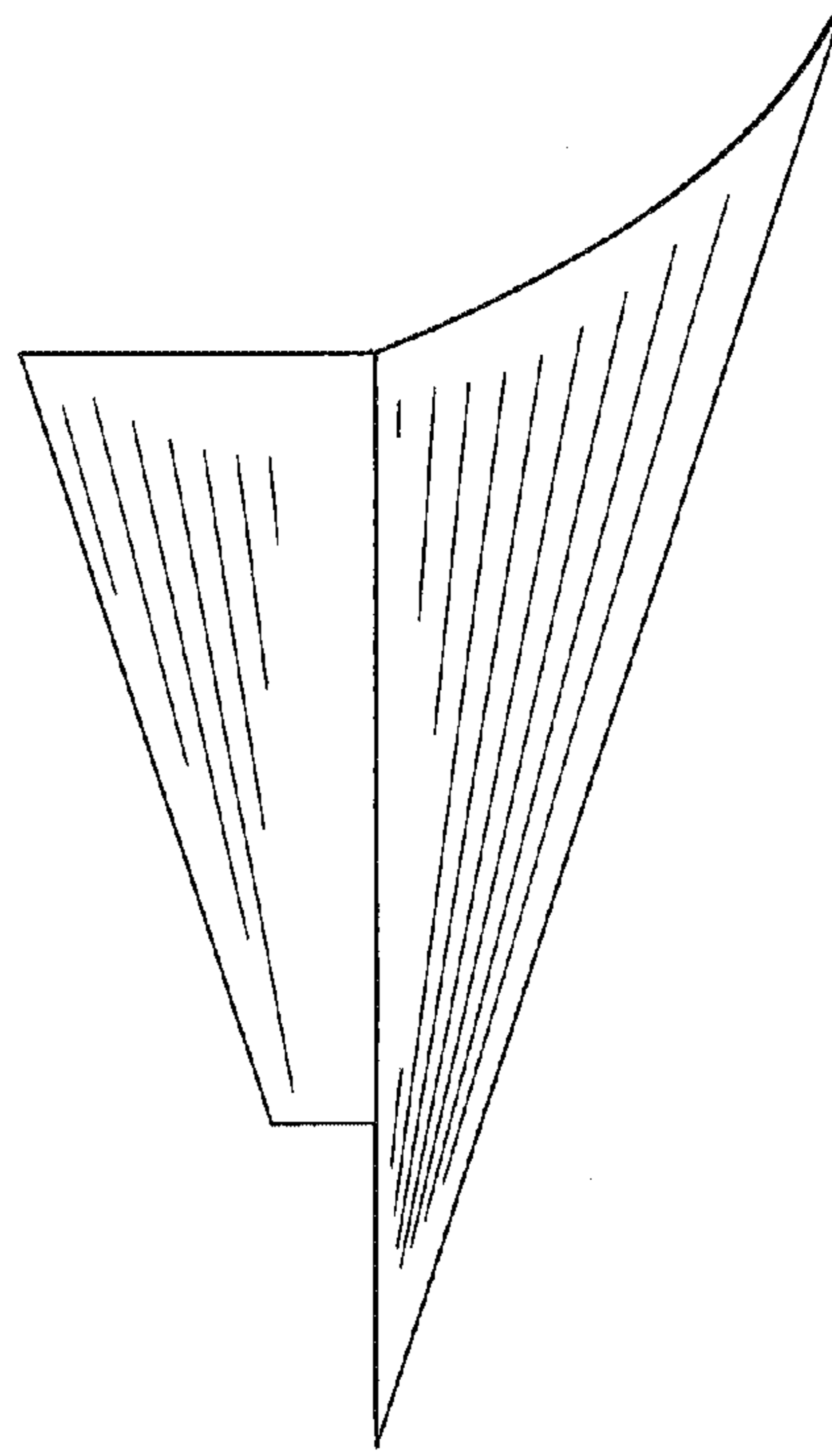

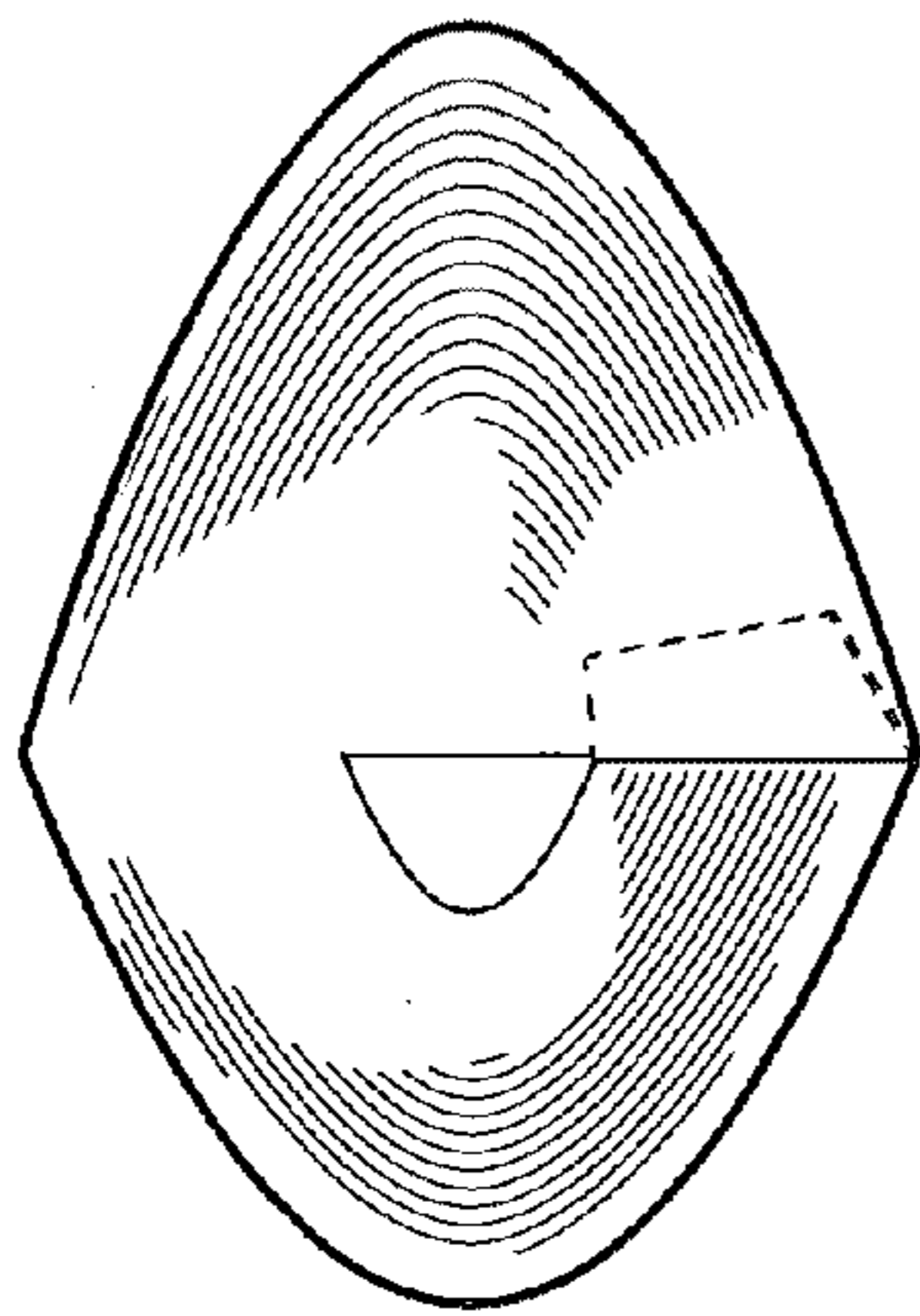

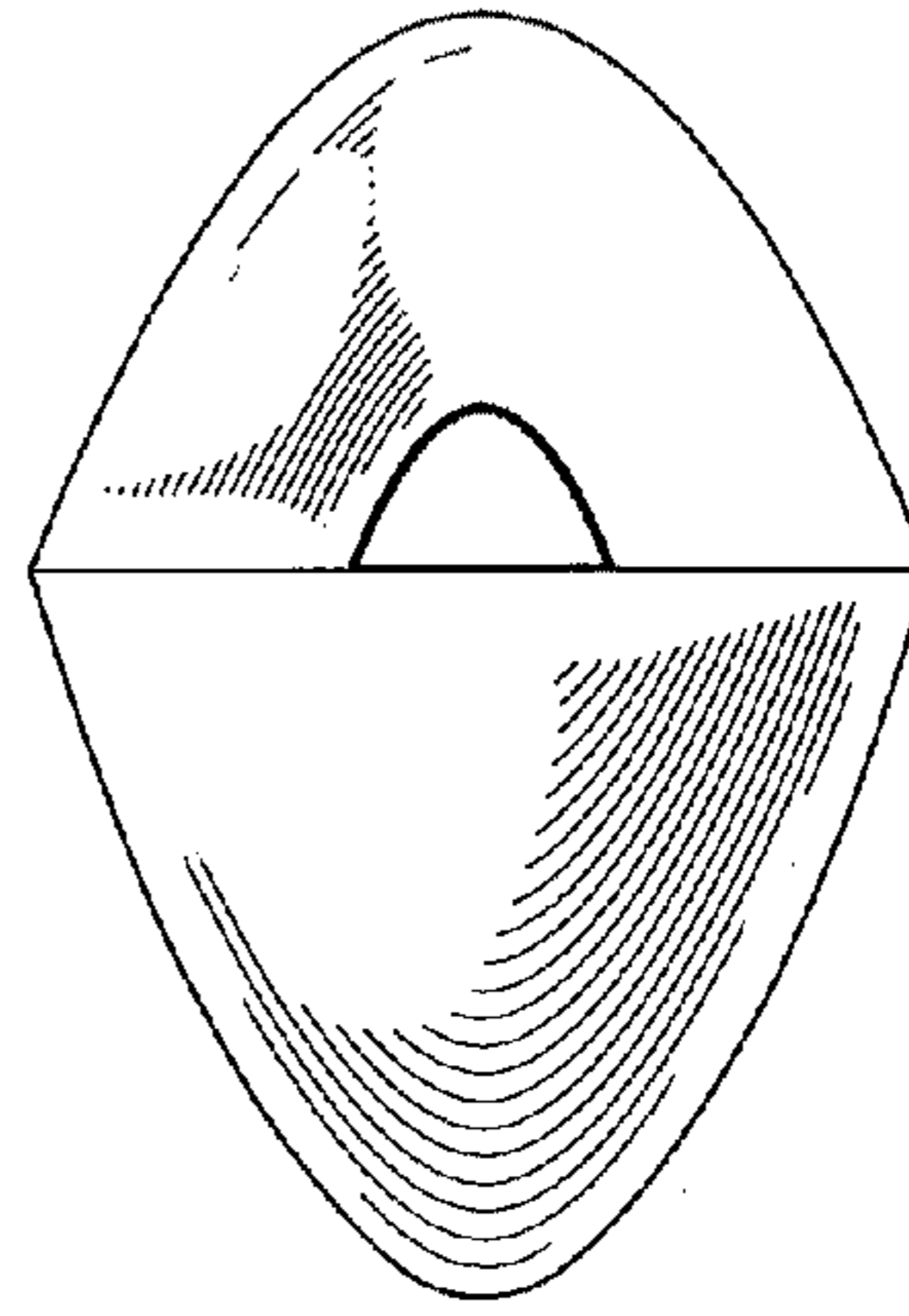
