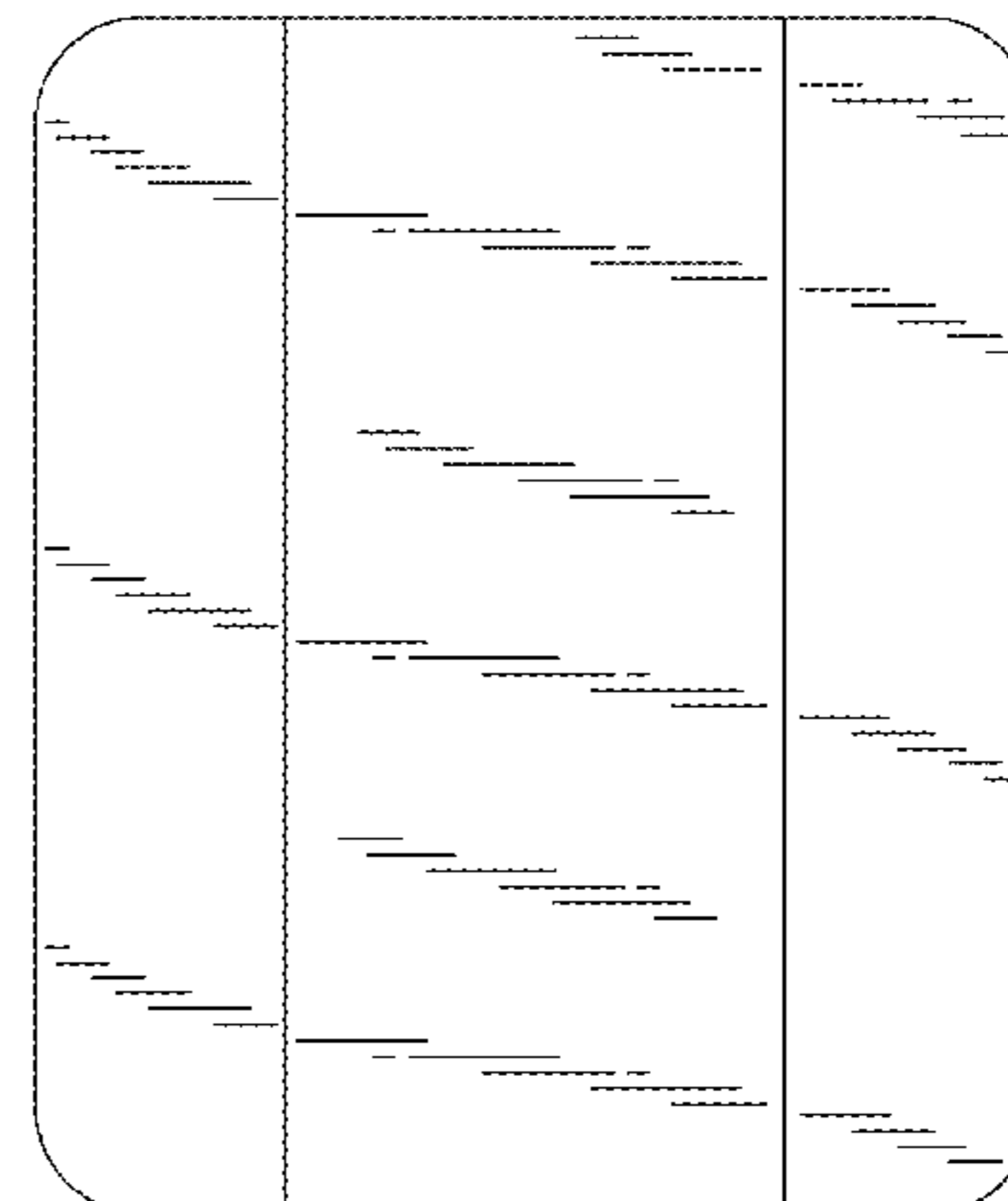
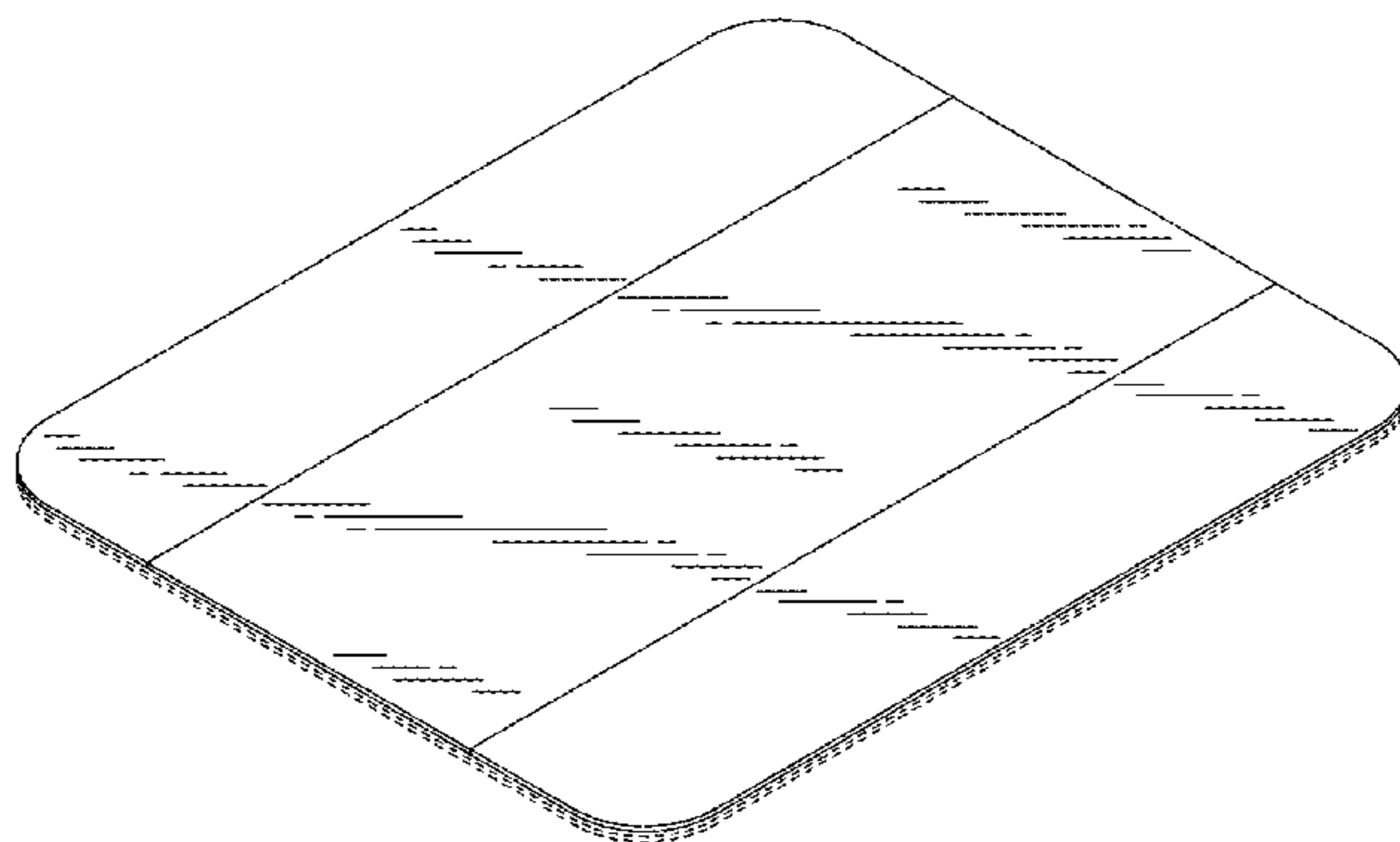
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a heat pad showing our new design;

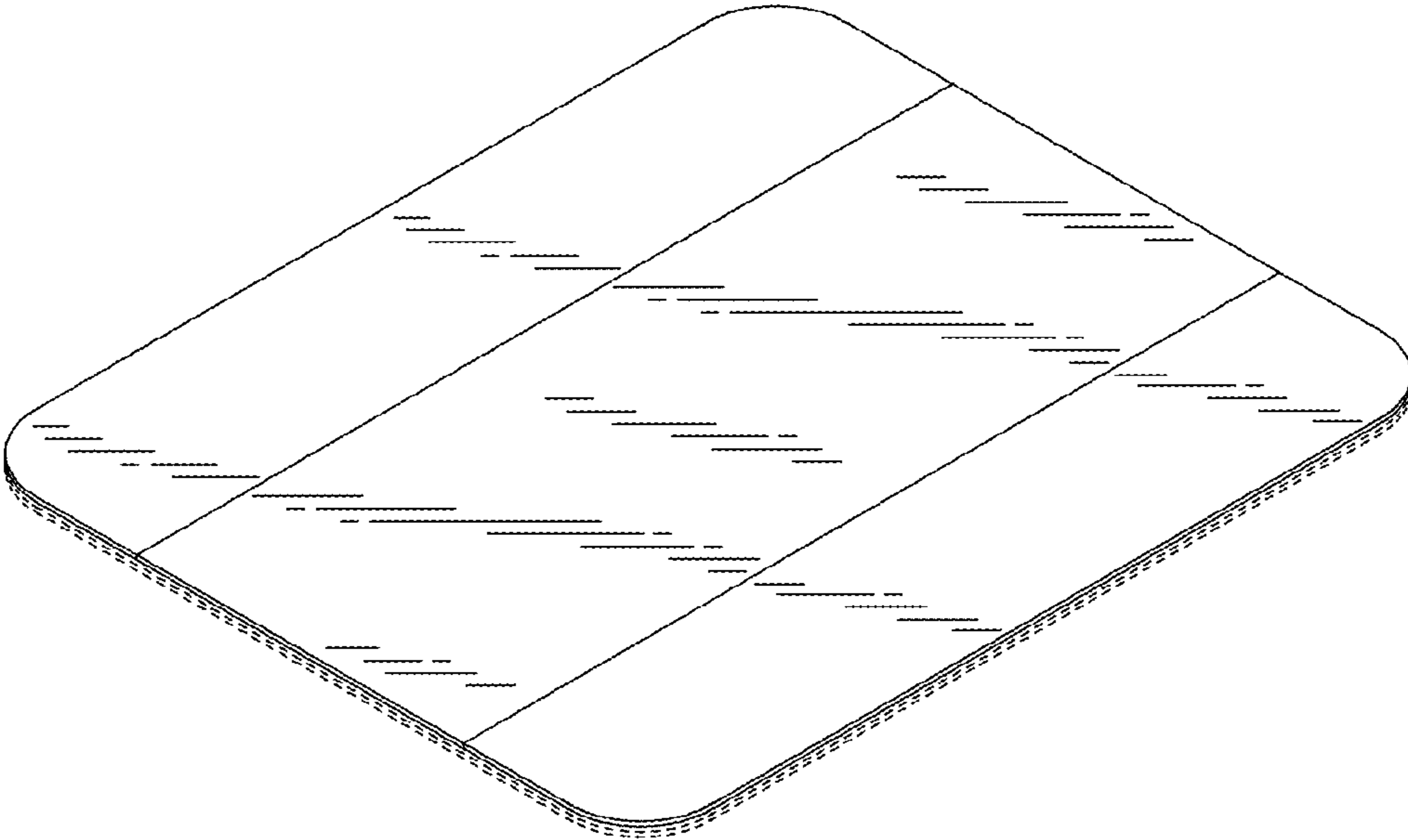

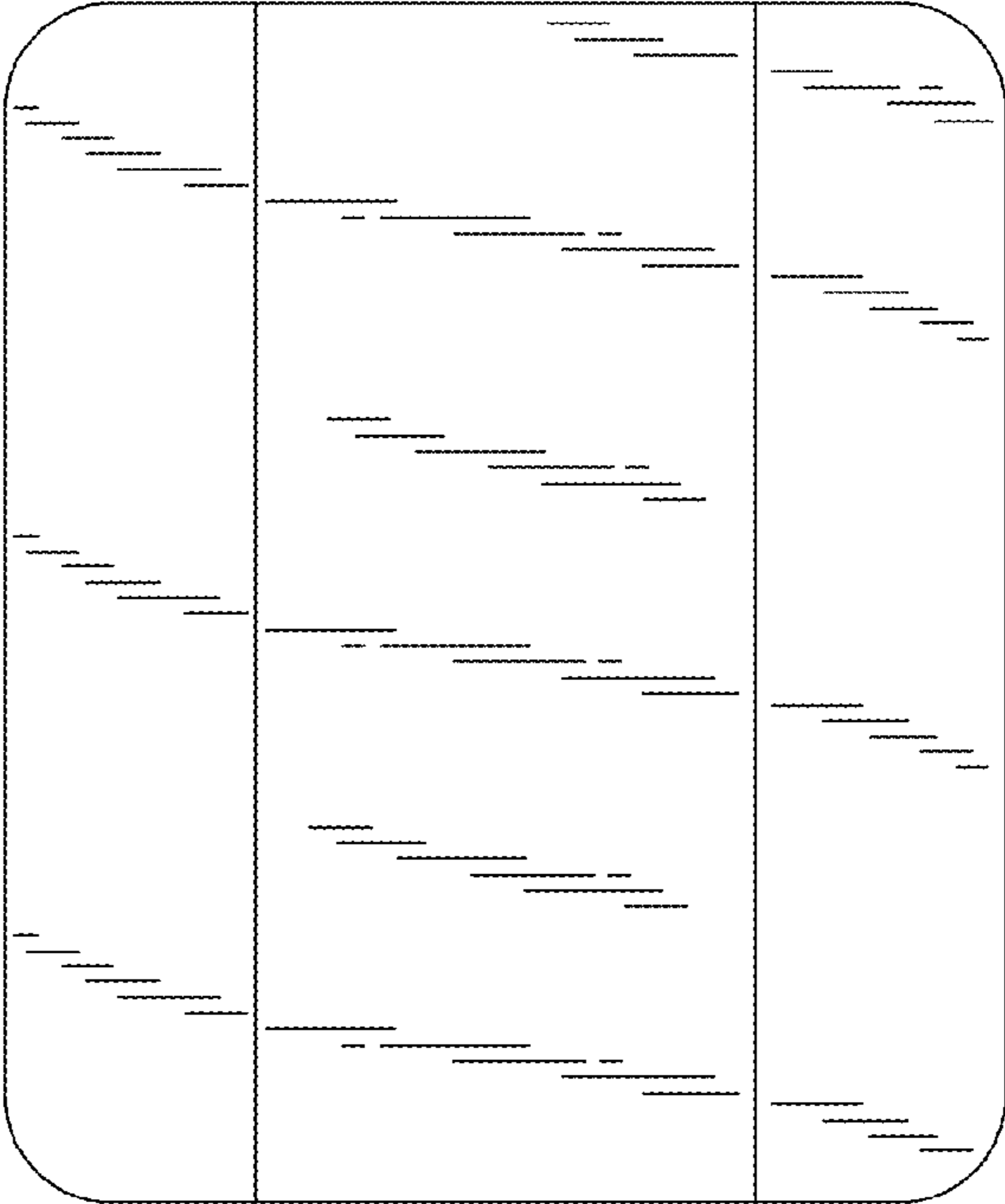

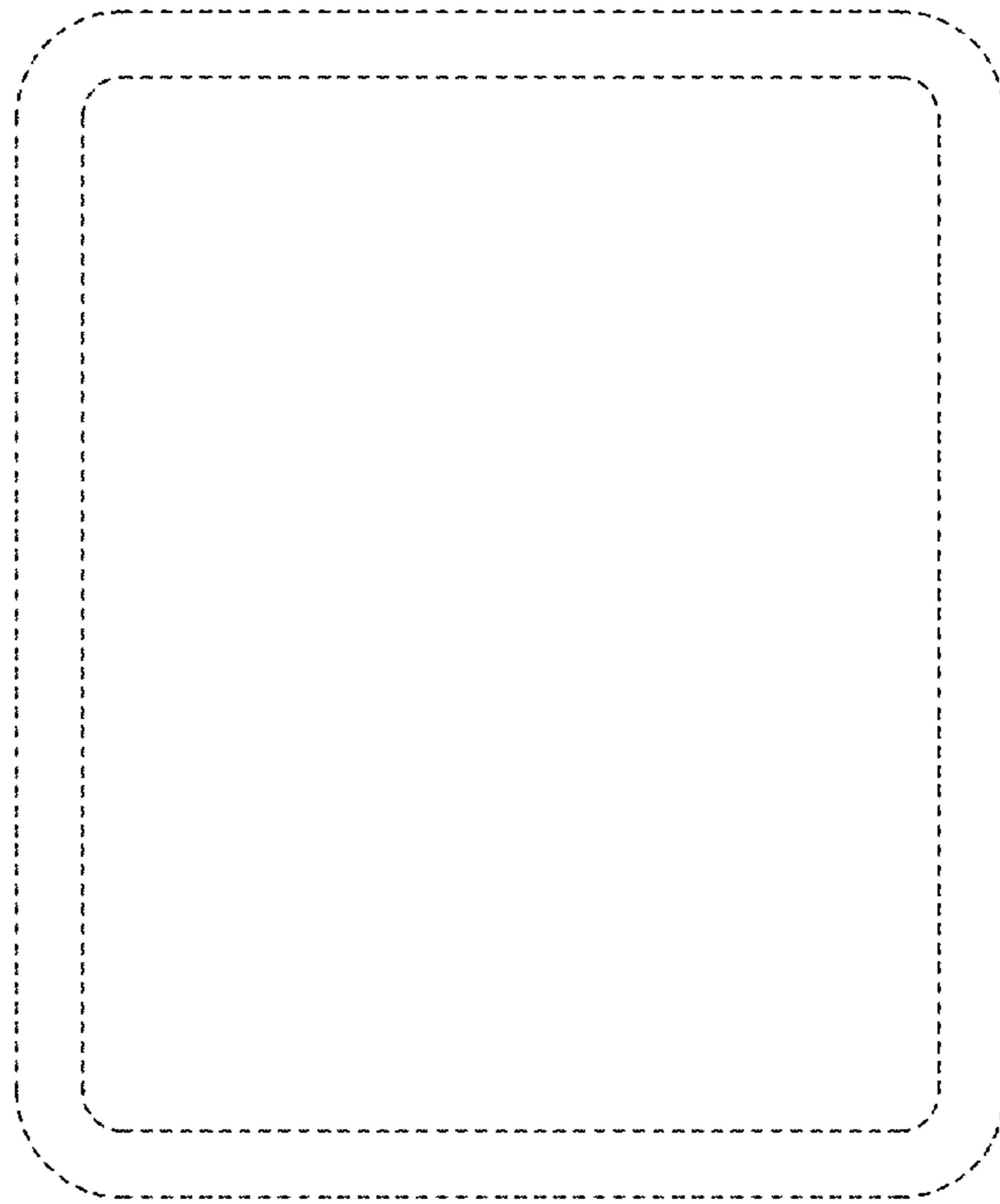

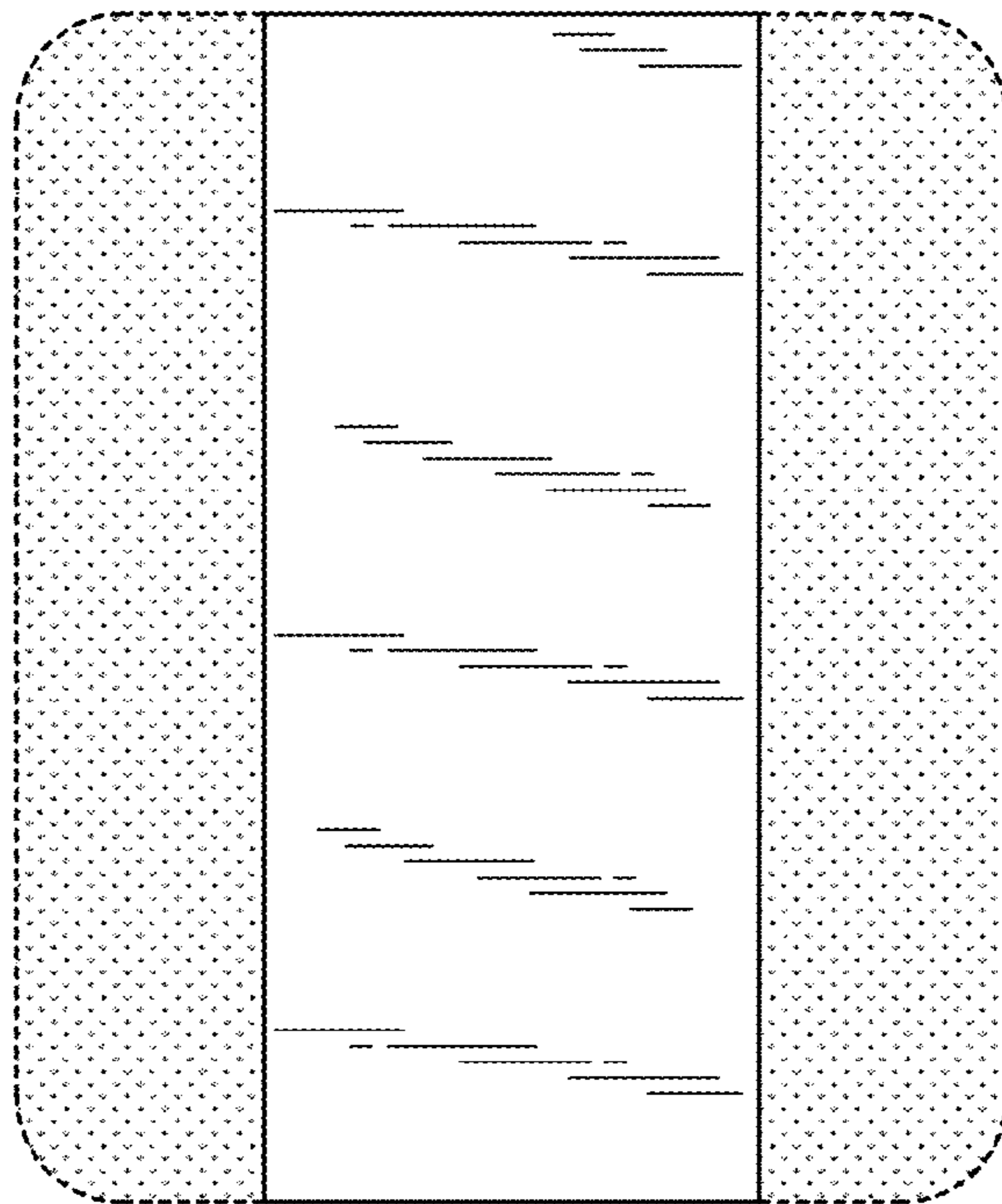

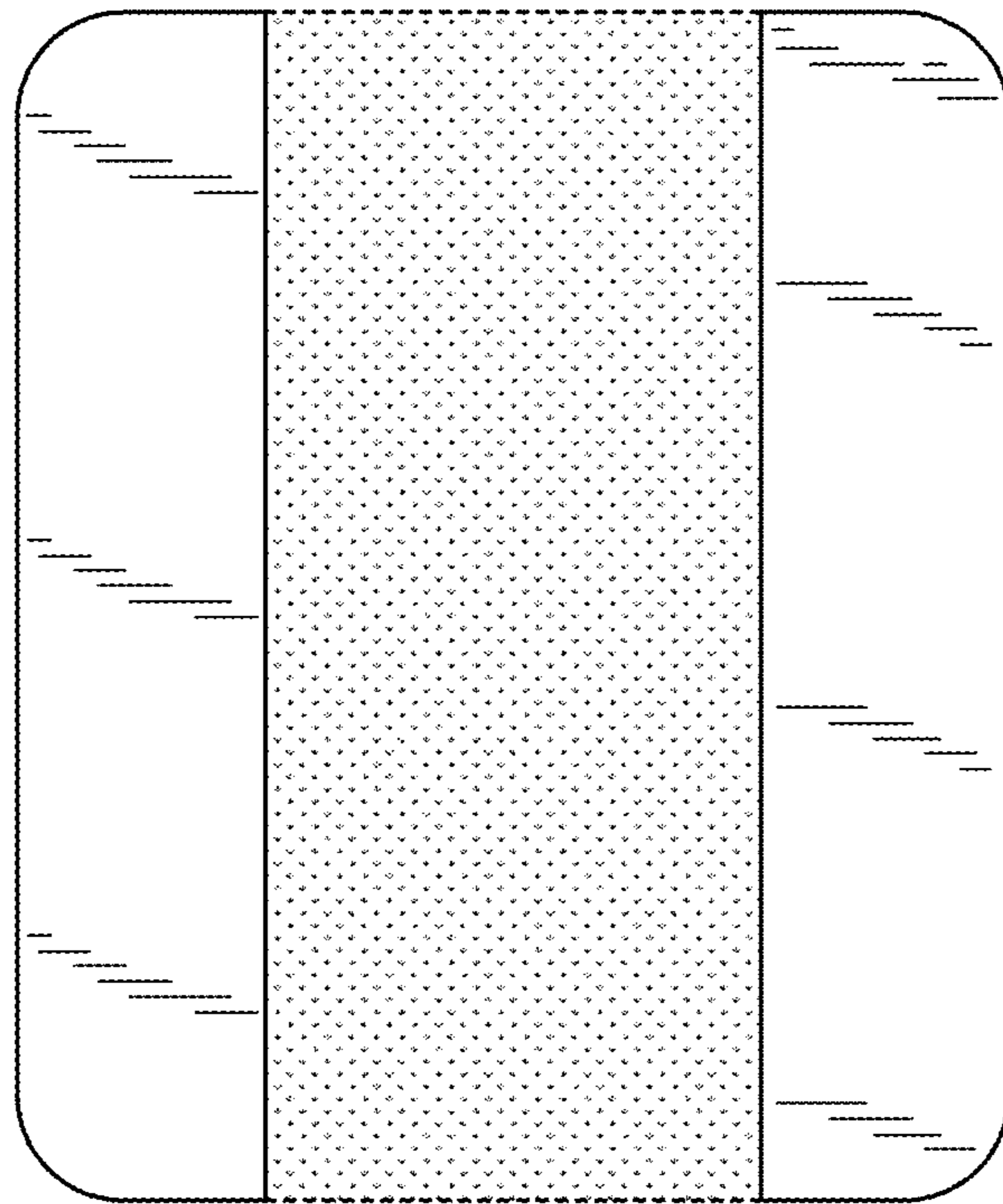
