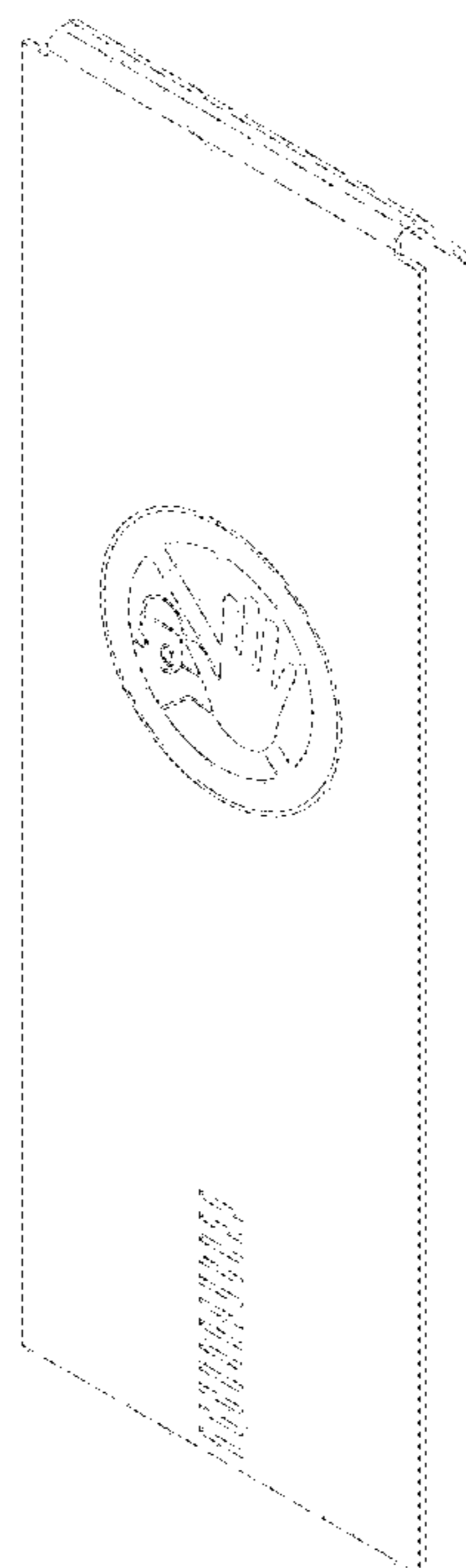

FIG. 1 is a front, left side and top perspective view of a safety barrier for a ladder or scaffold showing our new design;
FIG. 2 is a front elevation view thereof;

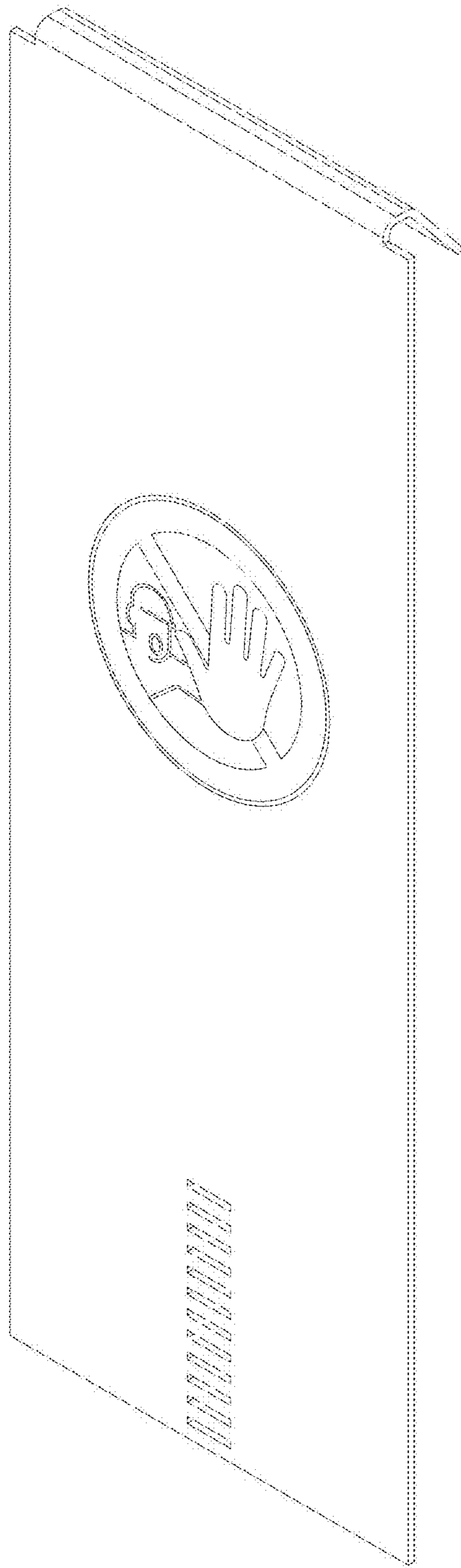

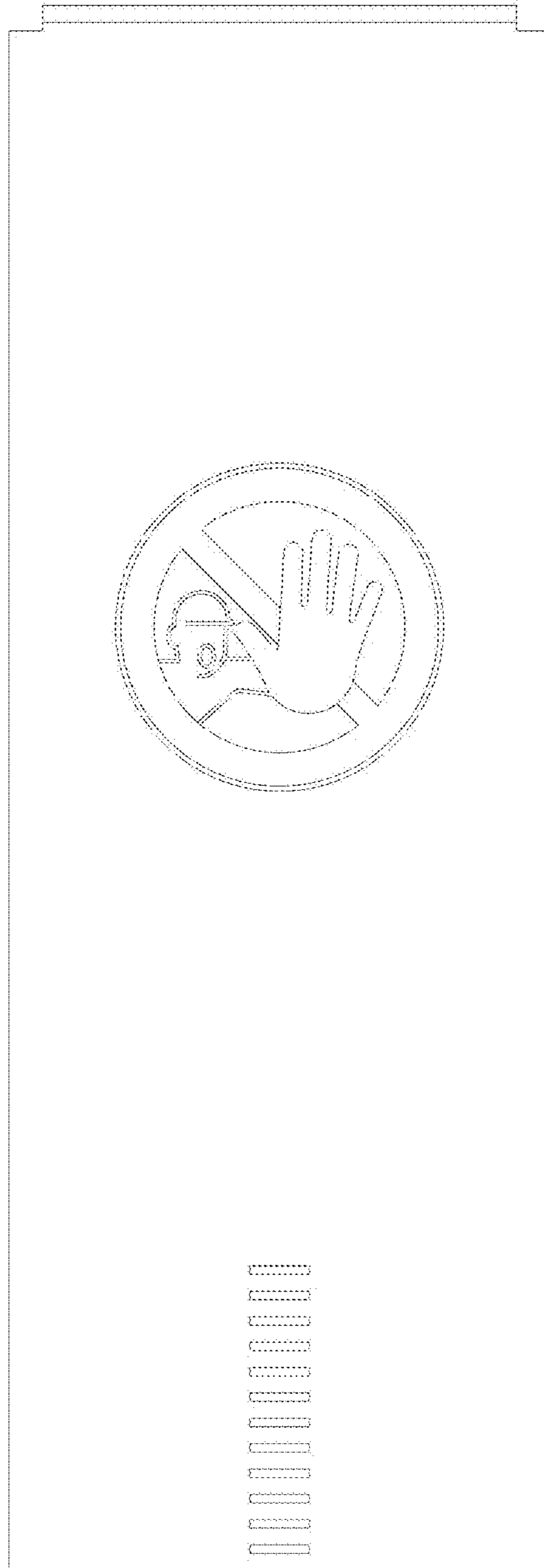

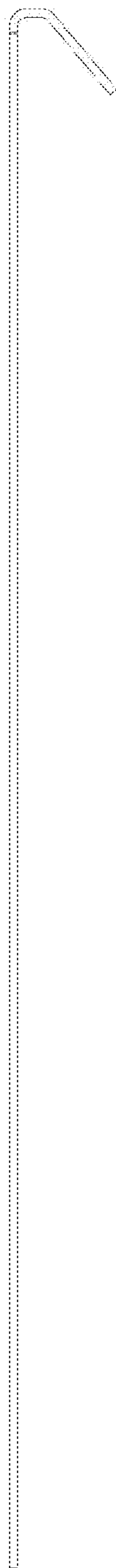

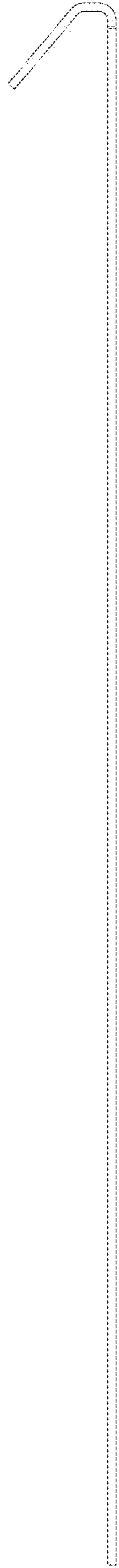

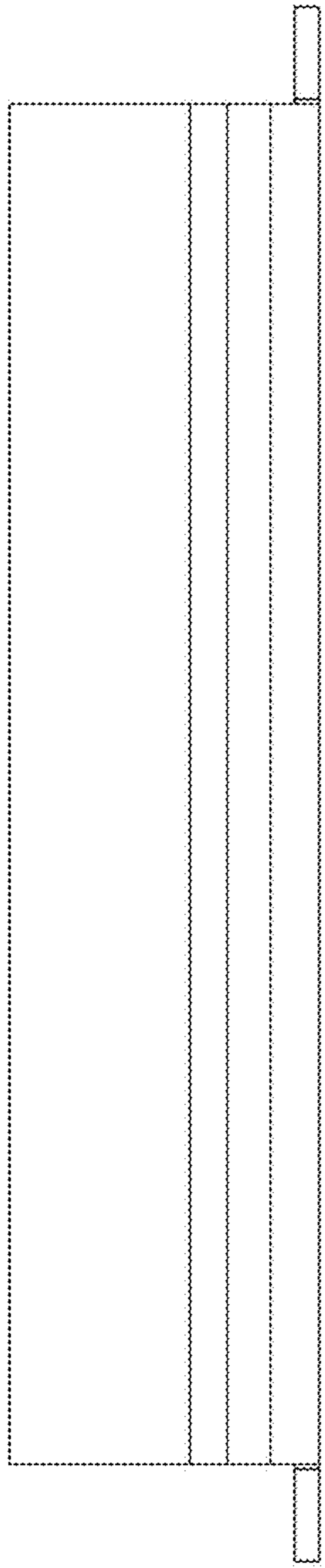

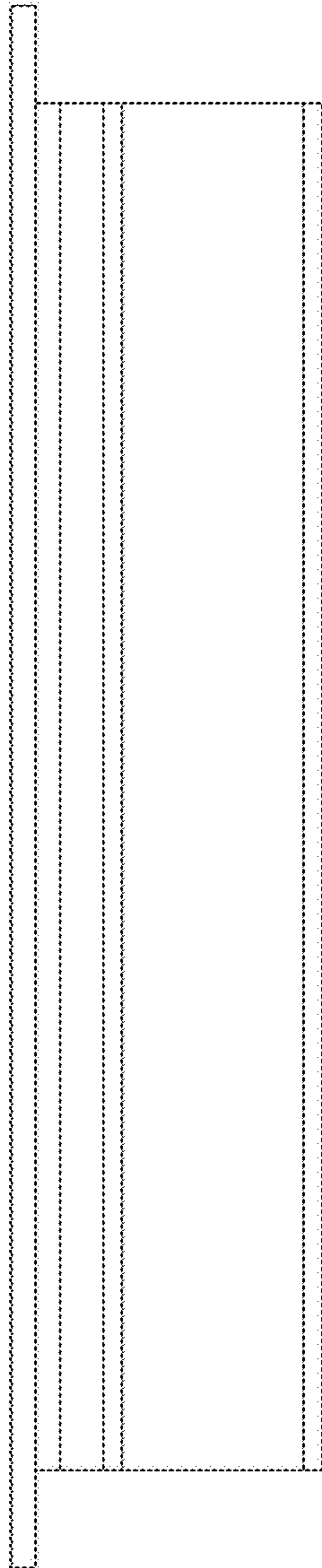
