(57) **CLAIM**

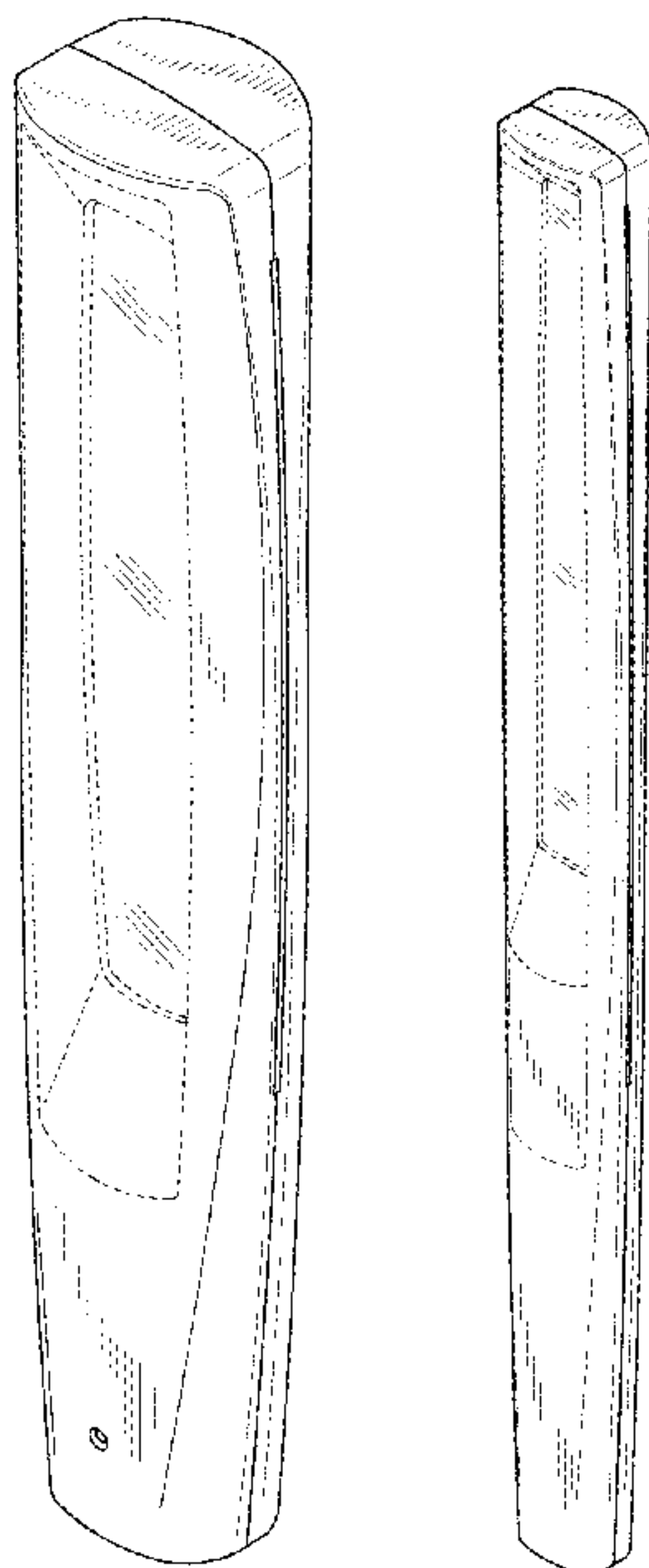
The ornamental design for a vertical luminaire, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vertical luminaire, showing our new design;

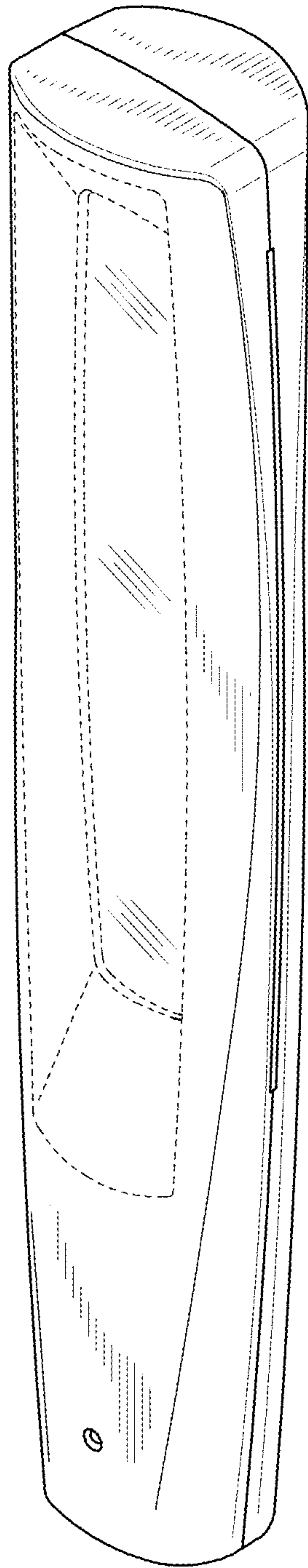

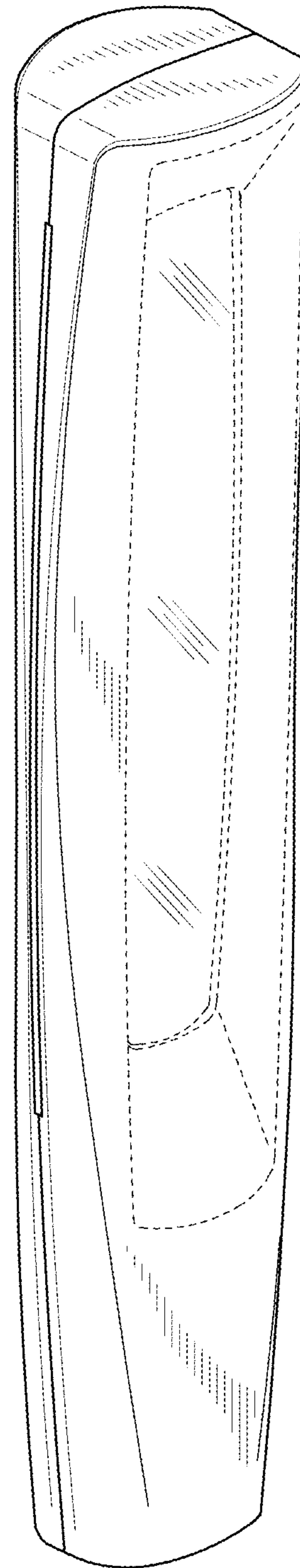

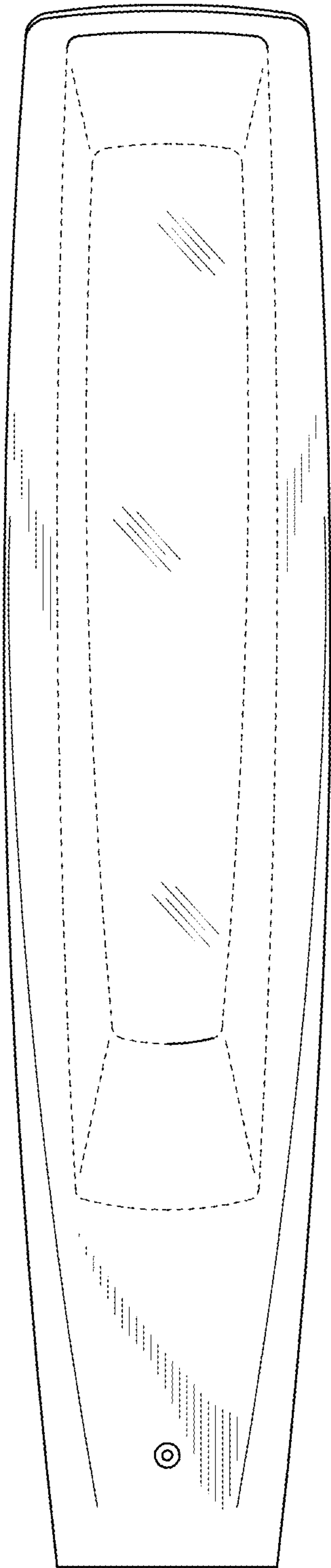

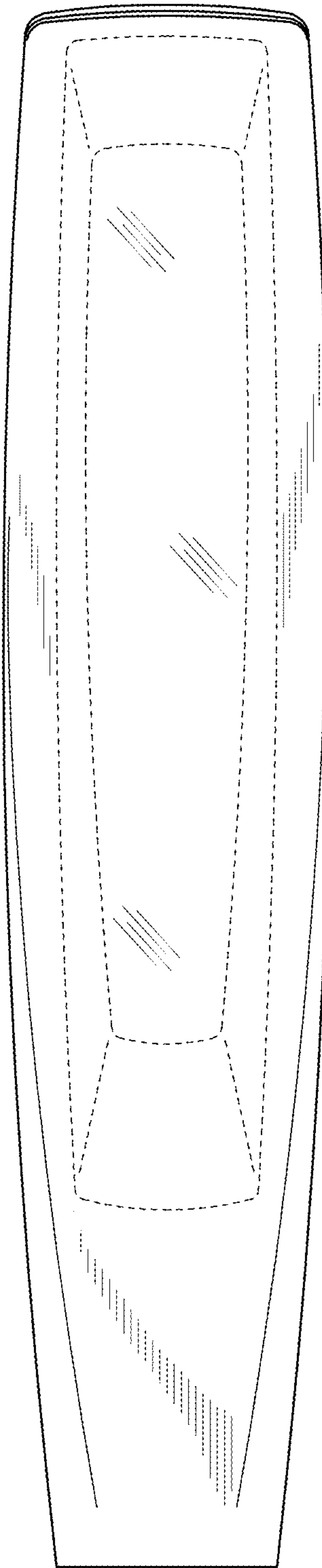

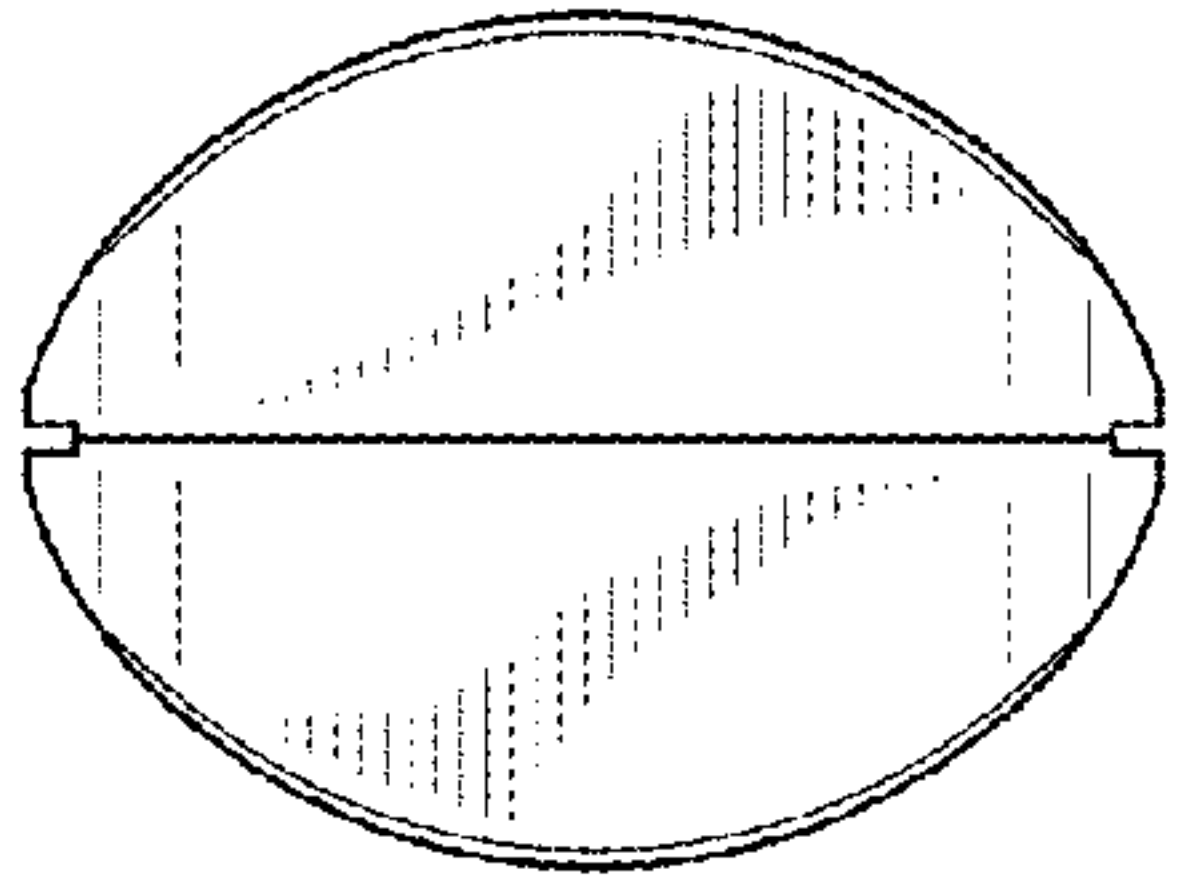

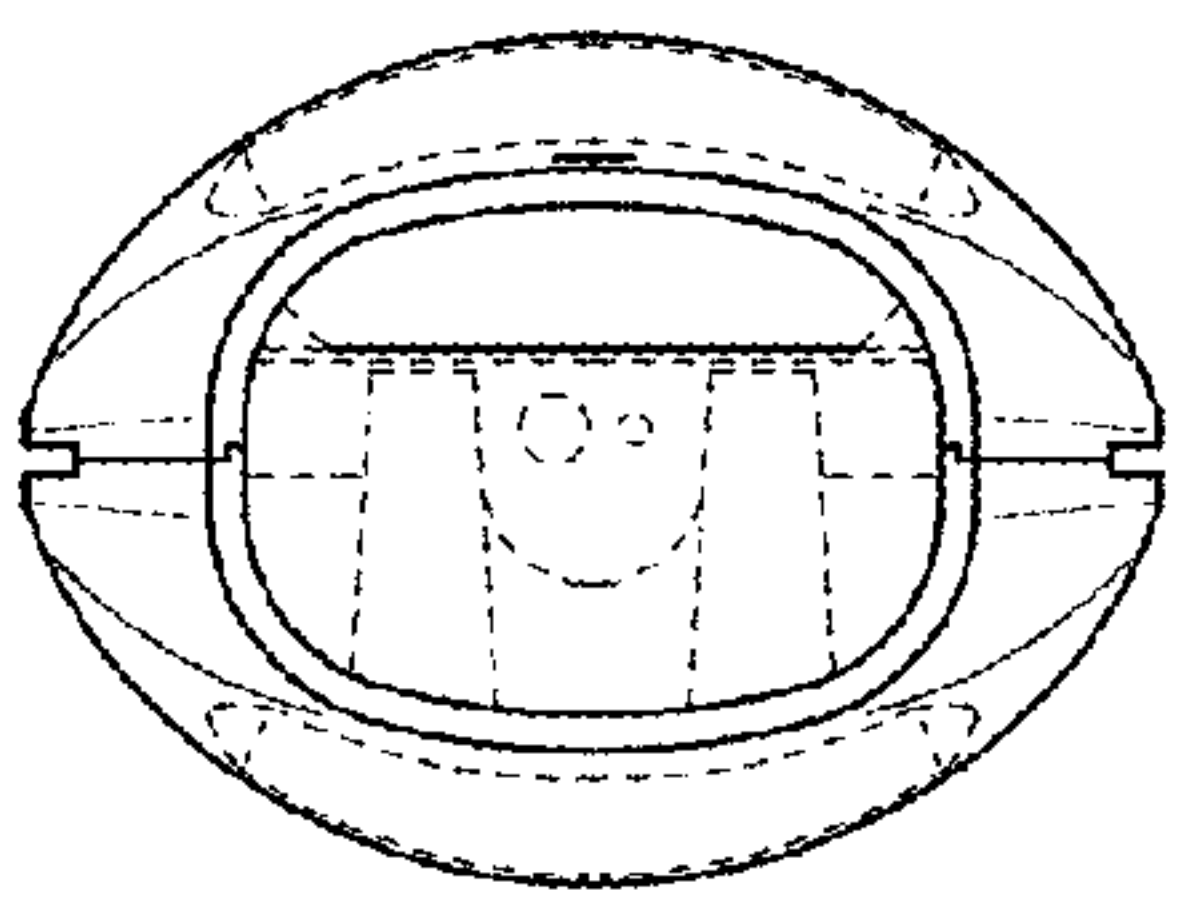

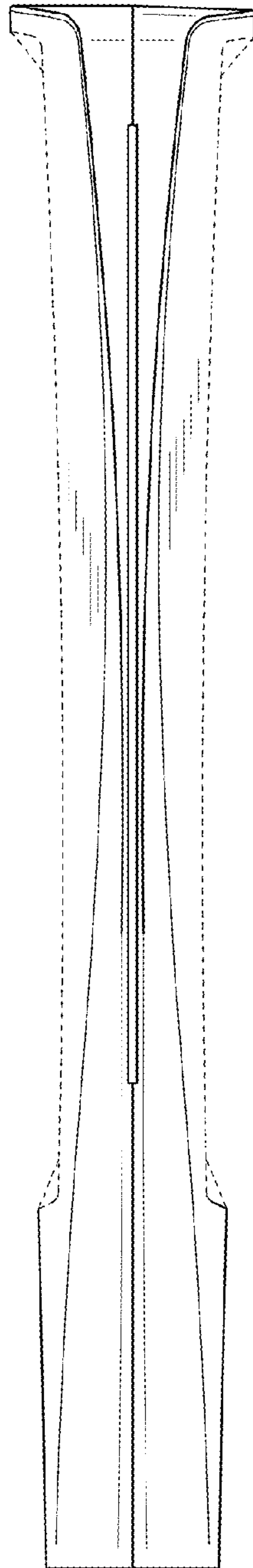

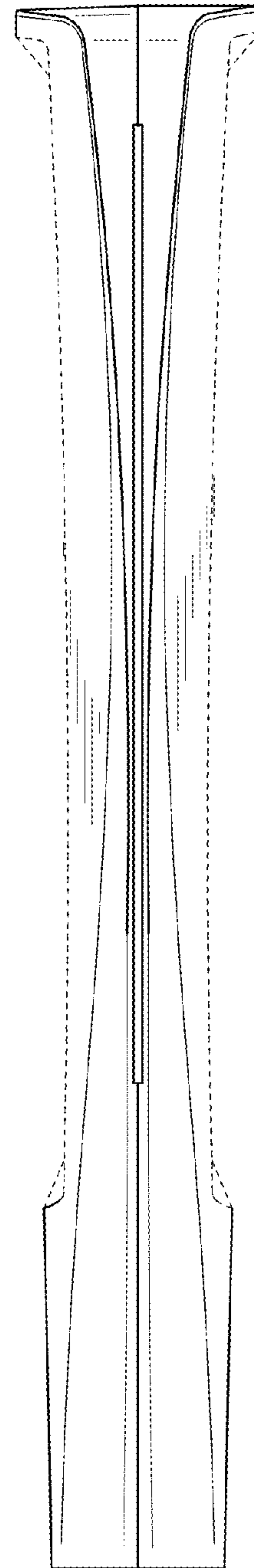

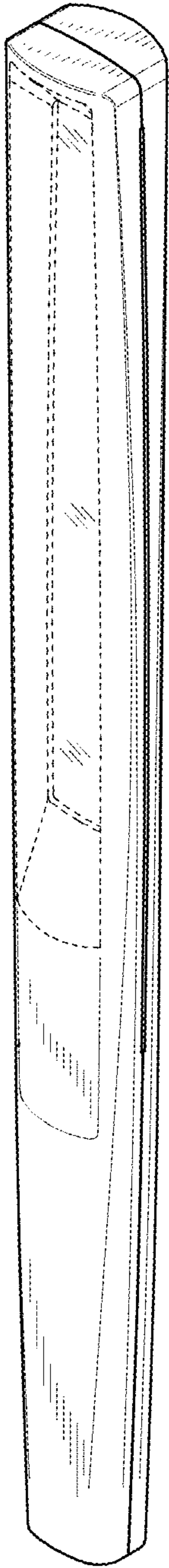

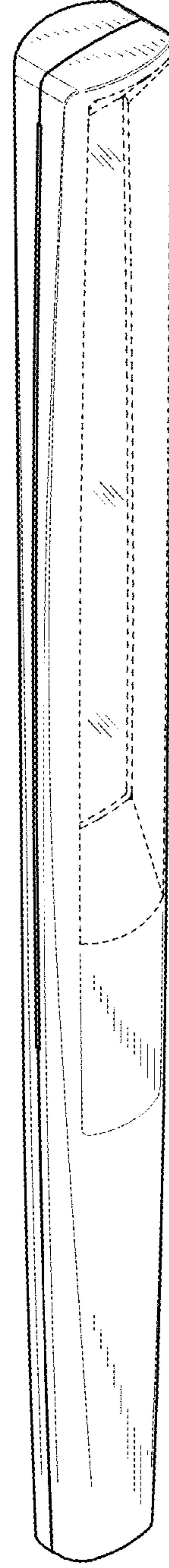

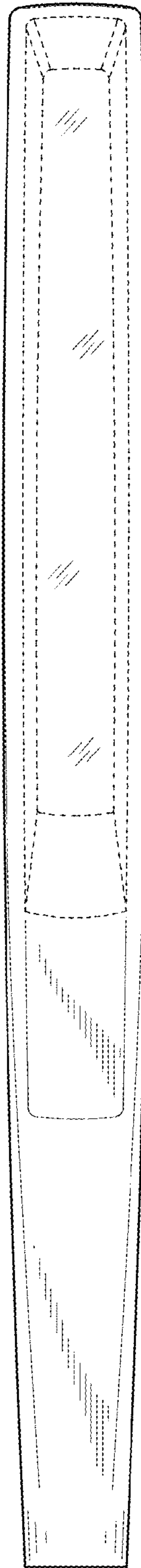

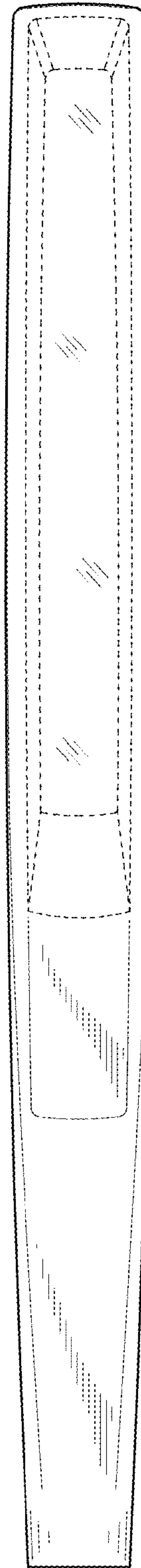

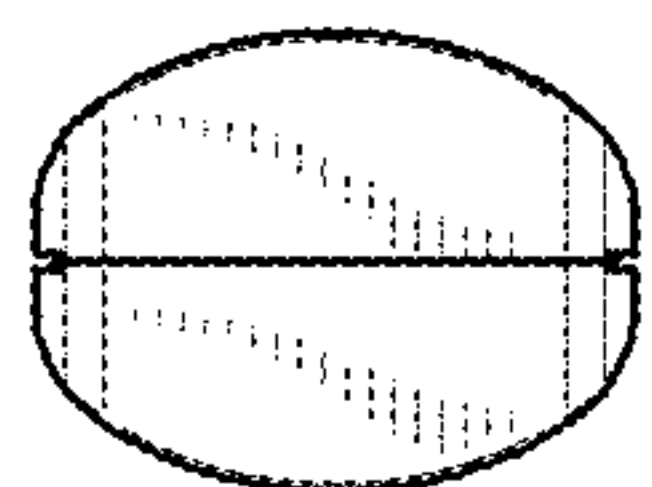

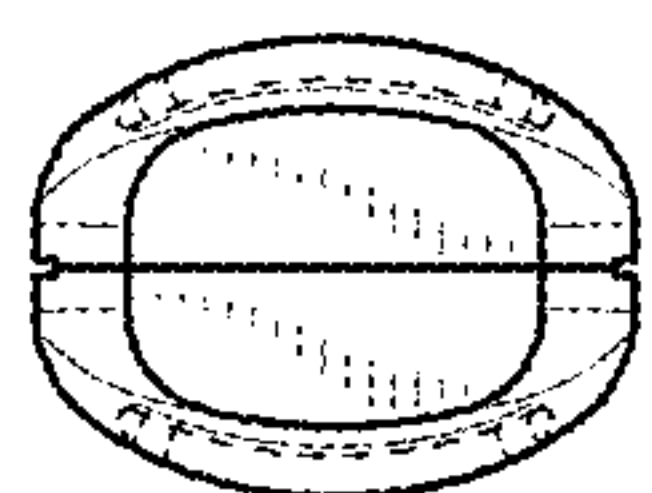

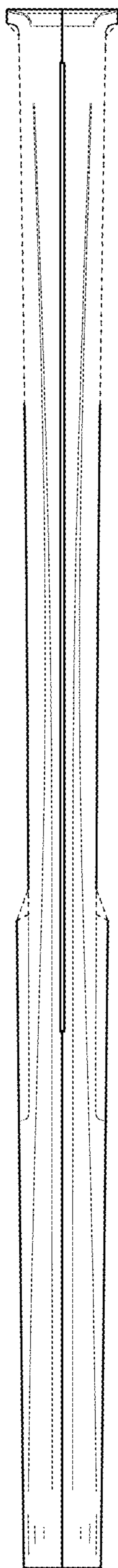

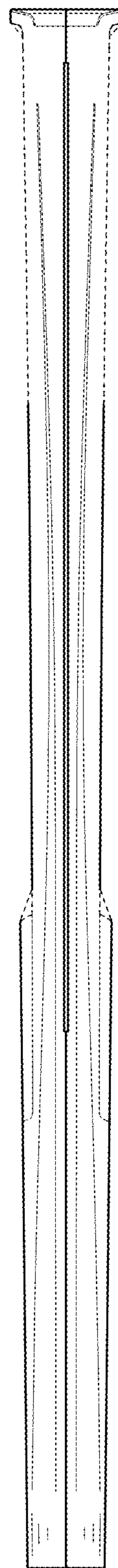
