(57) **CLAIM**

The ornamental design for my smoking pipe bowl having magnetically attached lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment of my new design for a smoking pipe bowl having magnetically attached lid in which the claimed design is shown as it would appear when formed with the stem of a smoking pipe wherein the pipe stem is shown in broken lines and forms no part of the claimed design;

FIG. 2 is a left side view of the smoking pipe bowl having magnetically attached lid shown in FIG. 1 and wherein the right side view is the mirror image of the left side view;

FIG. 3 is a top plan view of the smoking pipe bowl having magnetically attached lid shown in FIG. 1;

FIG. 4 is a bottom plan view of the smoking pipe bowl having magnetically attached lid shown in FIG. 1;

FIG. 5 is a front view of the smoking pipe bowl having magnetically attached lid shown in FIG. 1;

FIG. 6 is a rear view of the smoking pipe bowl having magnetically attached lid shown in FIG. 1;

FIG. 7 is the perspective view of FIG. 1 showing the lid removed from the bowl;

FIG. 8 is a perspective view of the second embodiment of my new design for a smoking pipe bowl having magnetically attached lid in which the claimed design is shown as it would appear when formed with the stem of a smoking pipe wherein the pipe stem is shown in broken lines and forms no part of the claimed design;

FIG. 9 is a left side view of the smoking pipe bowl having magnetically attached lid shown in FIG. 8 and wherein the right side view is the mirror image of the left side view;

FIG. 10 is a top plan view of the smoking pipe bowl having magnetically attached lid shown in FIG. 8;

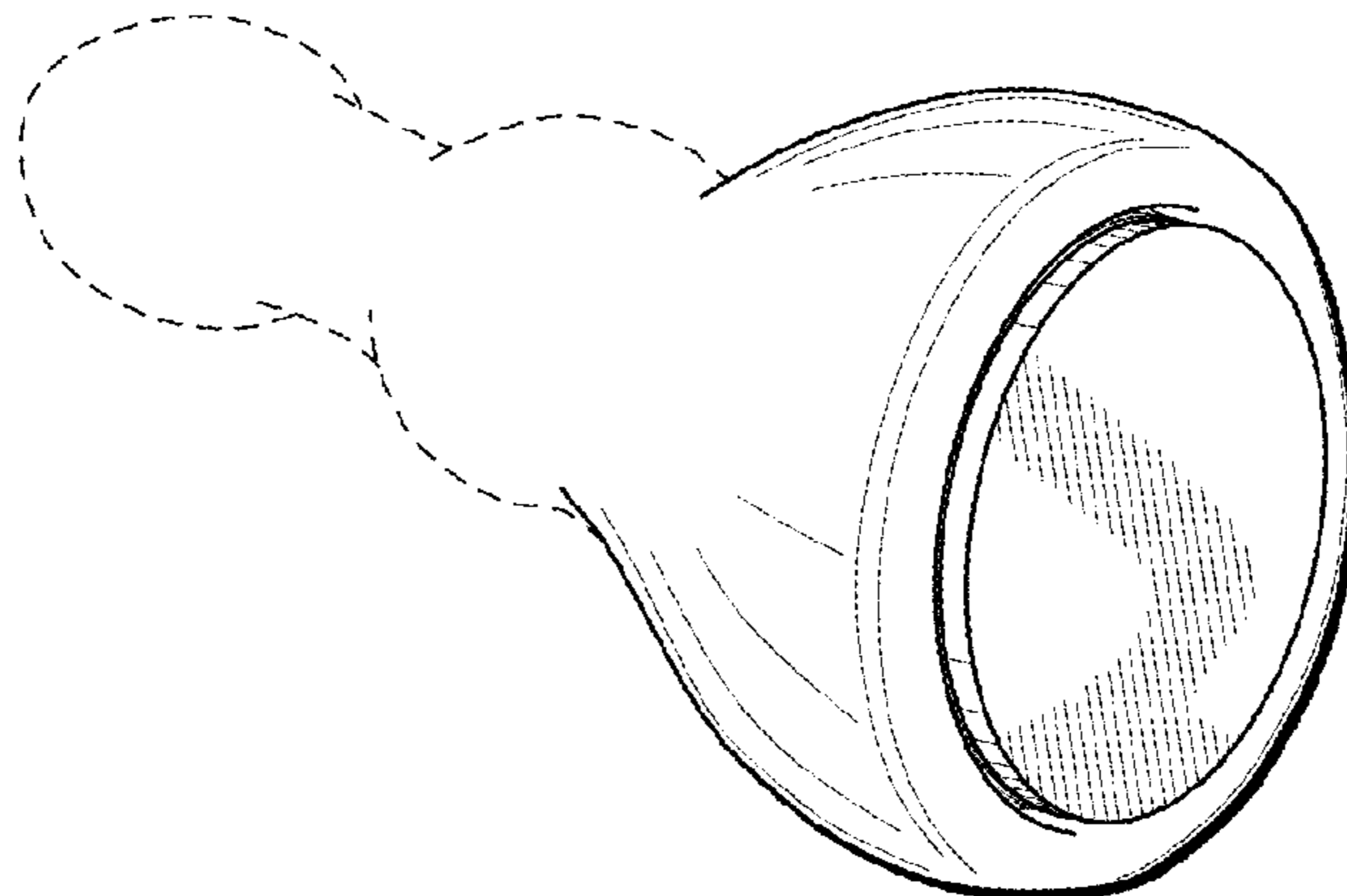
FIG. 11 is a bottom plan view of the smoking pipe bowl having magnetically attached lid shown in FIG. 8;

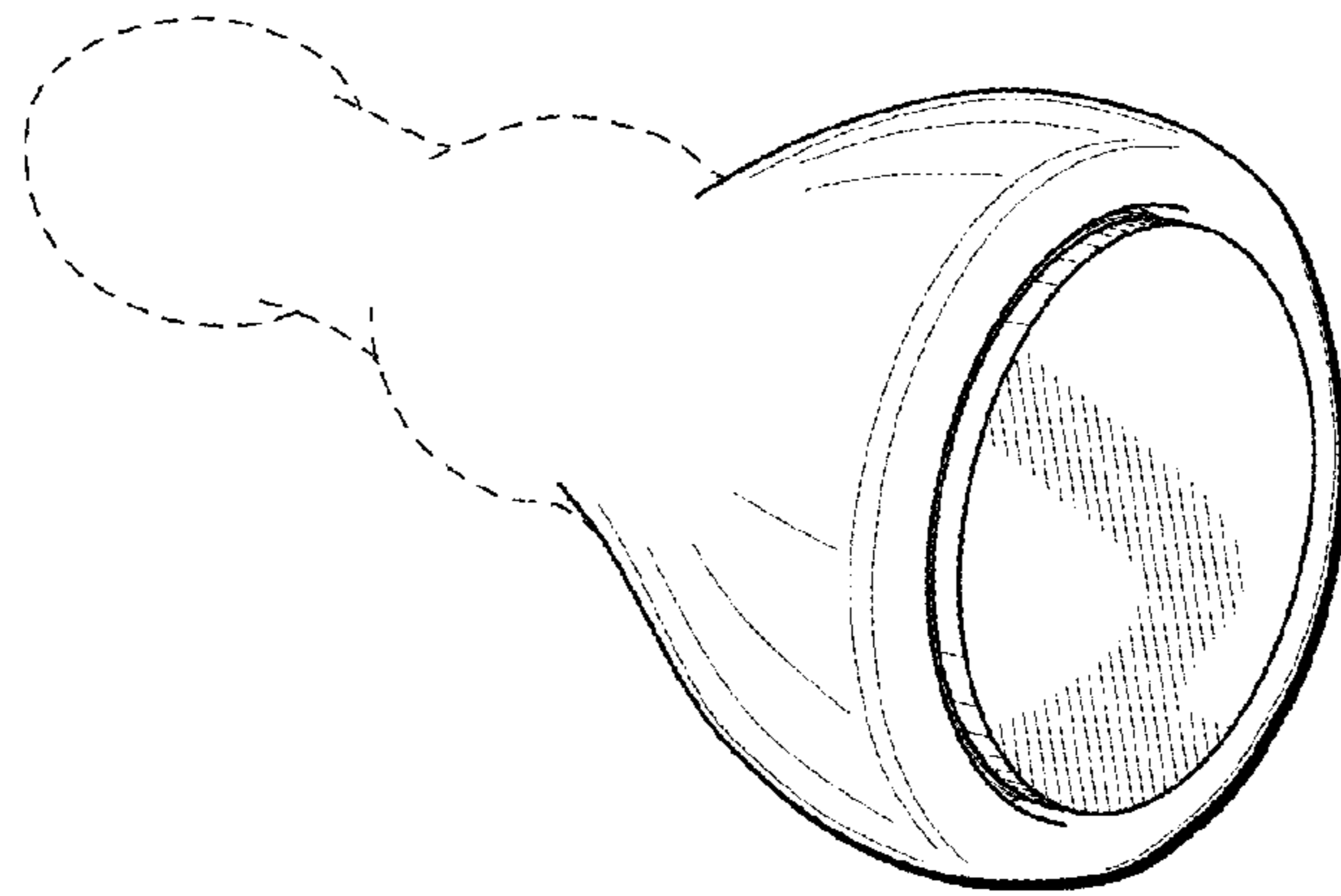

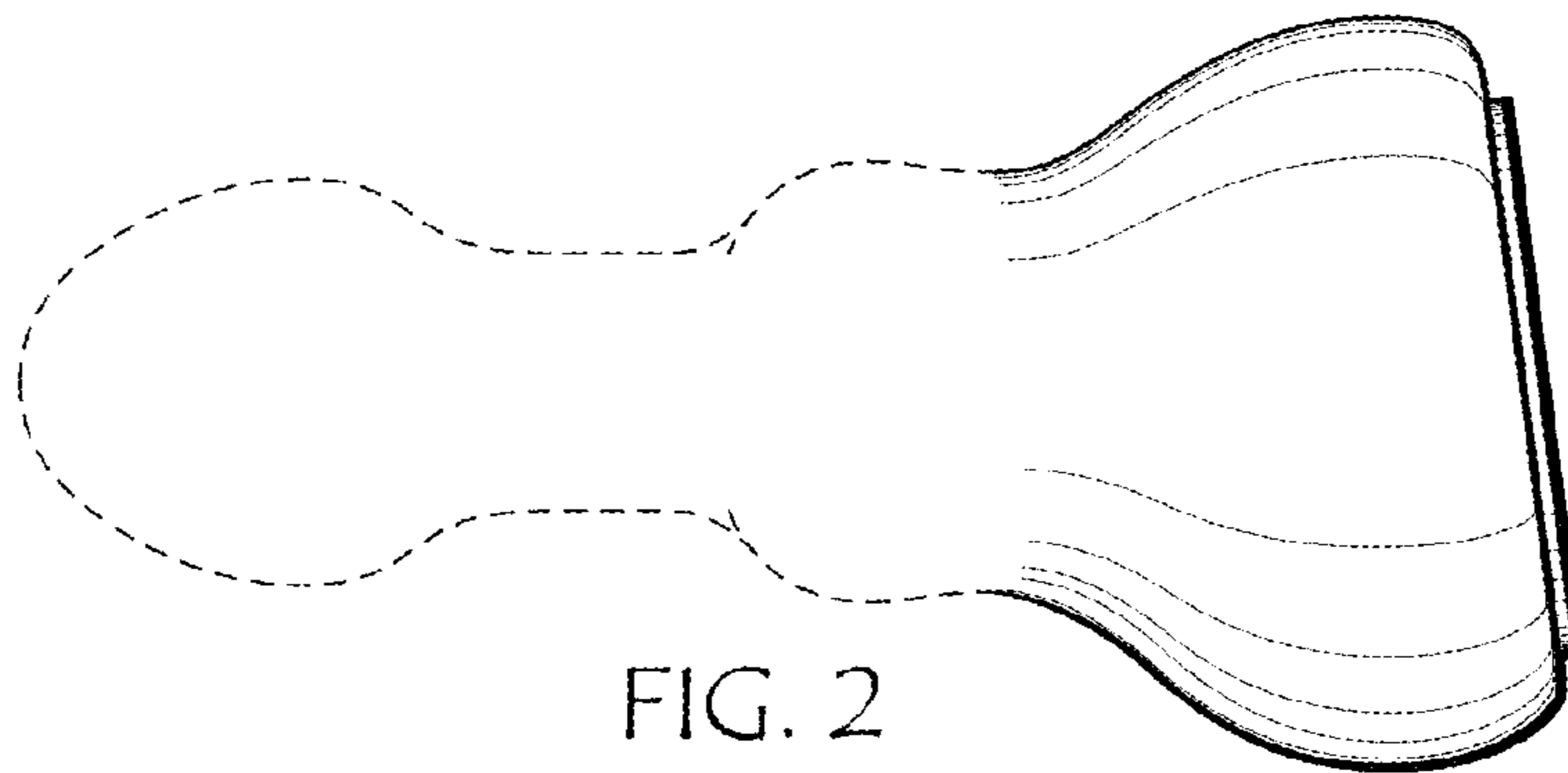

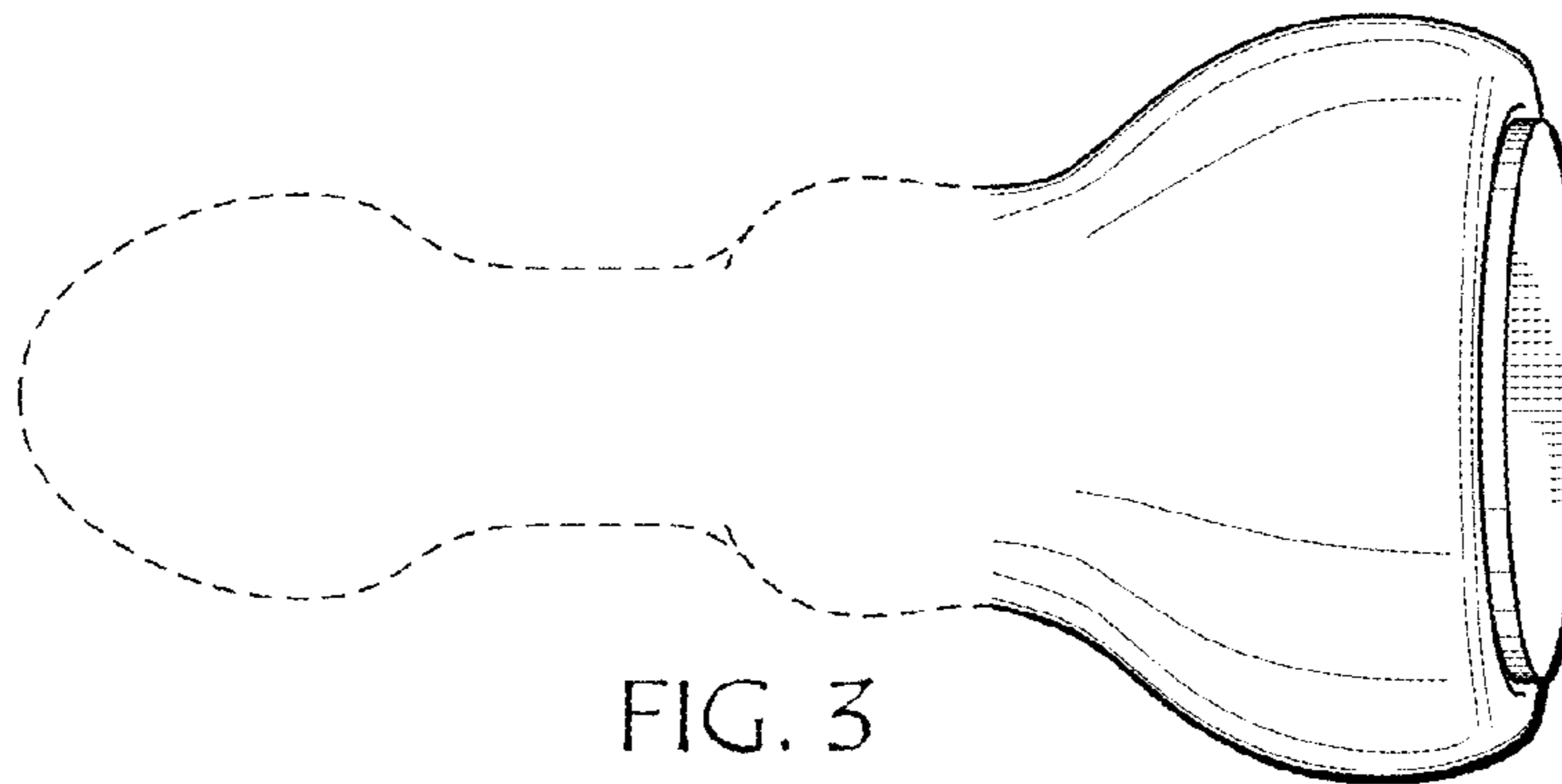

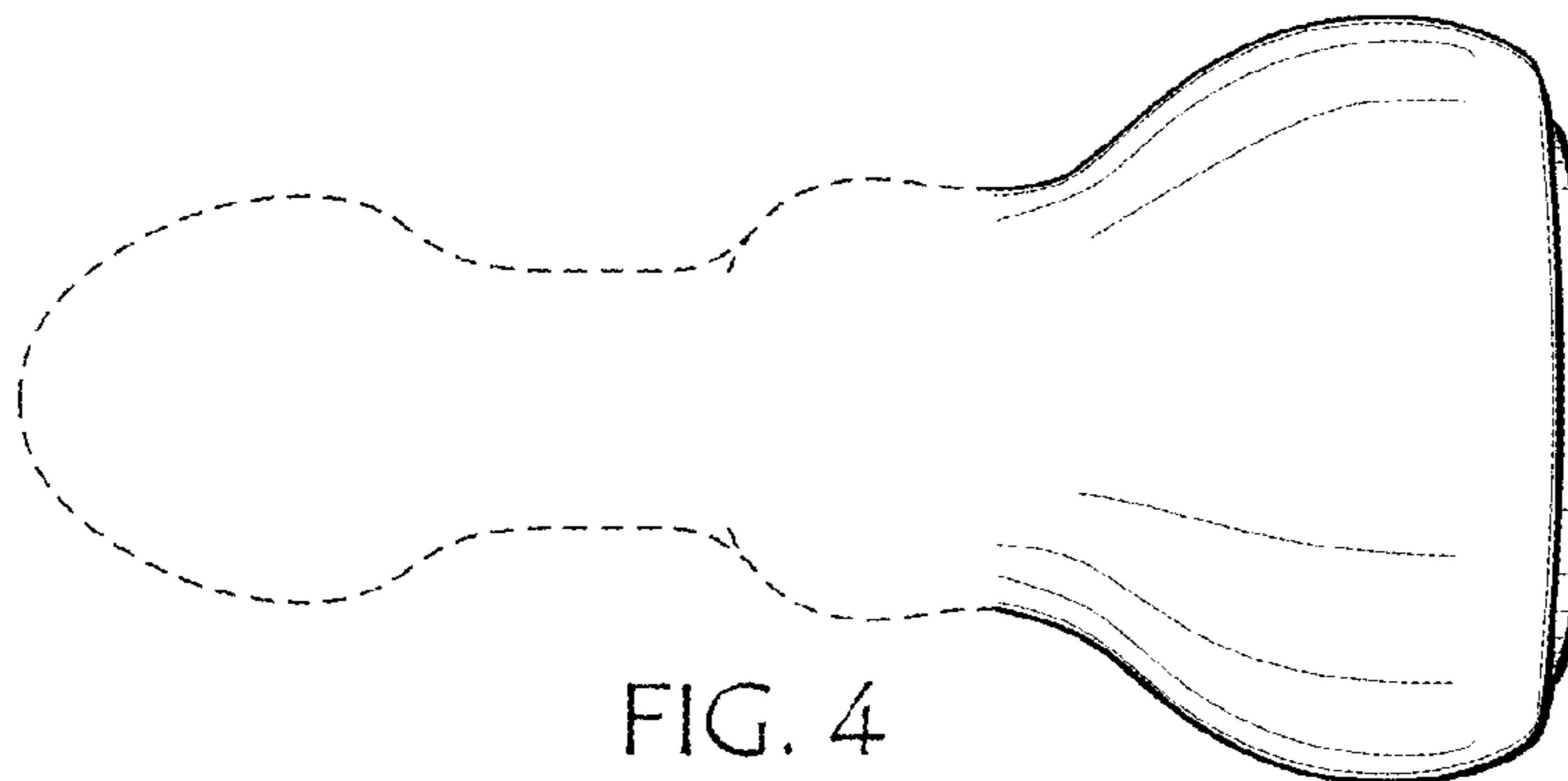

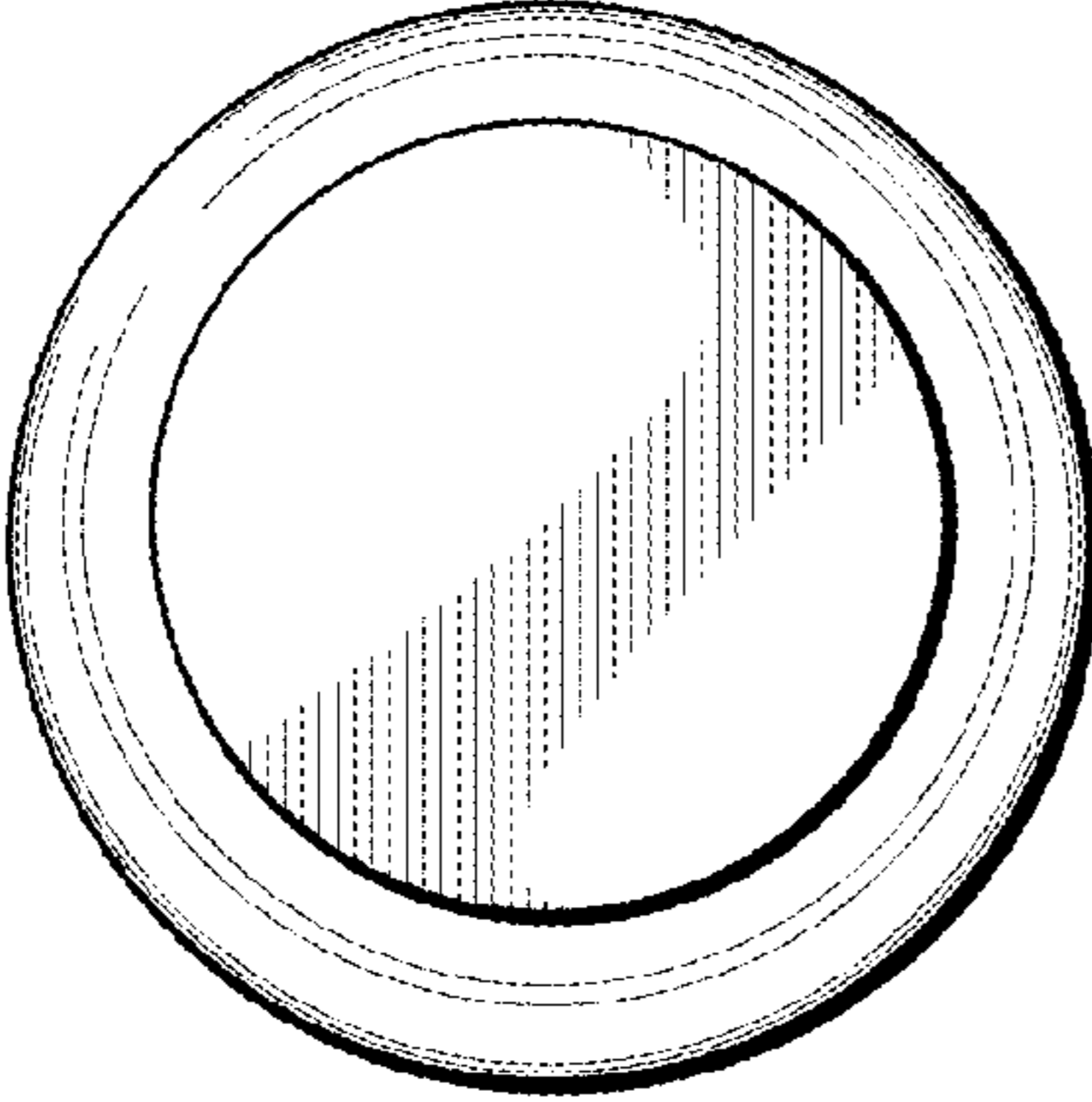

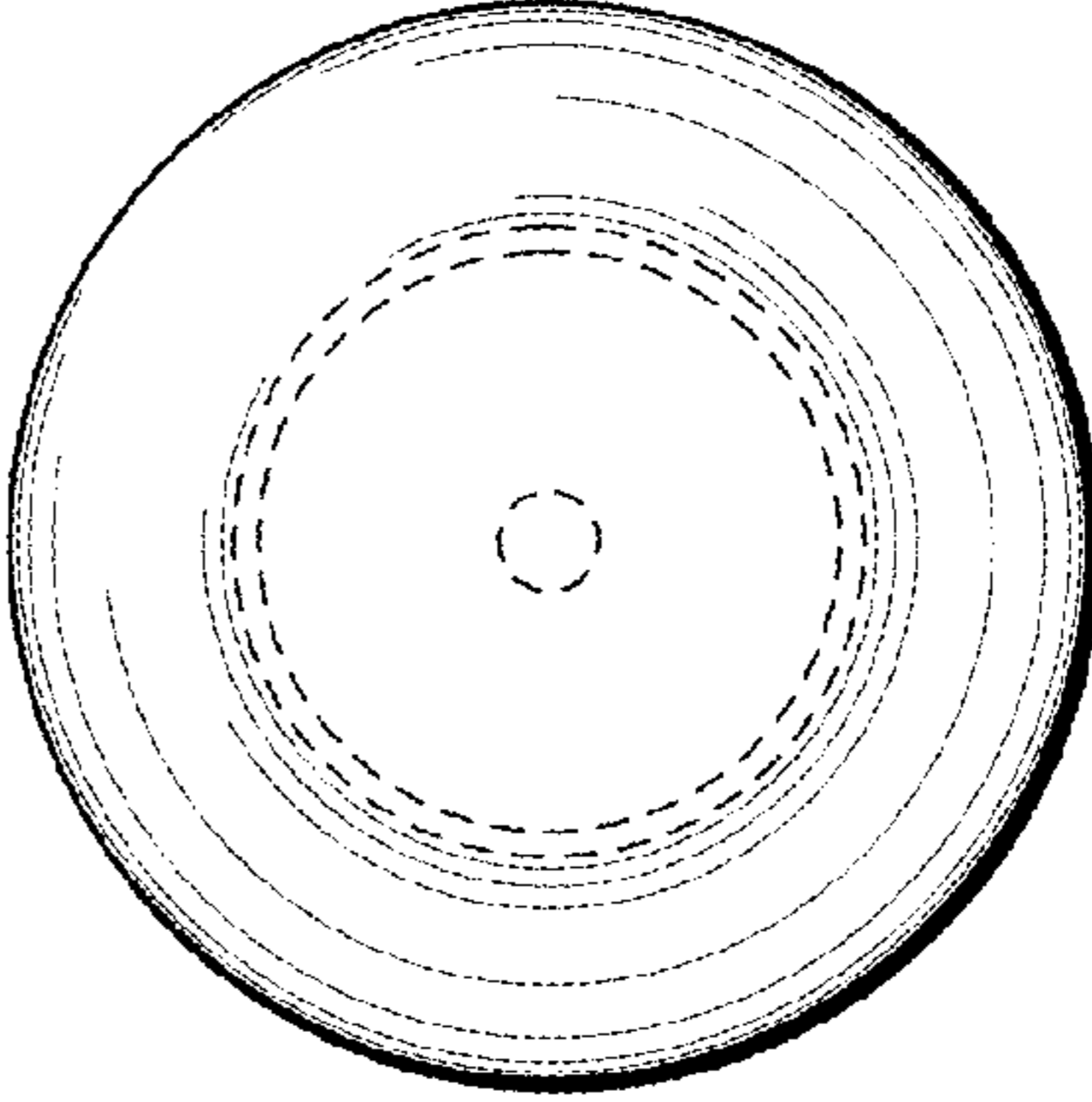

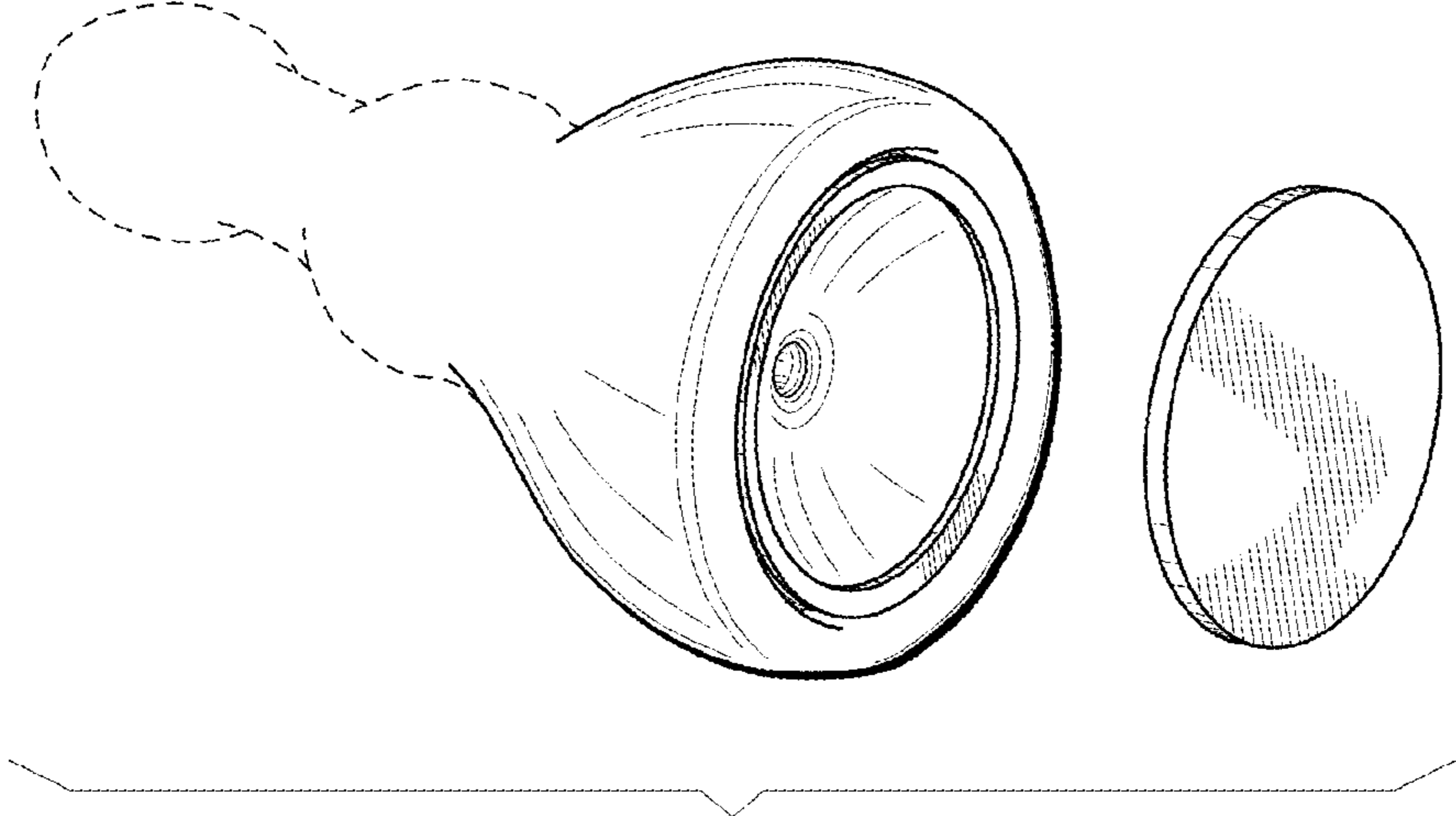

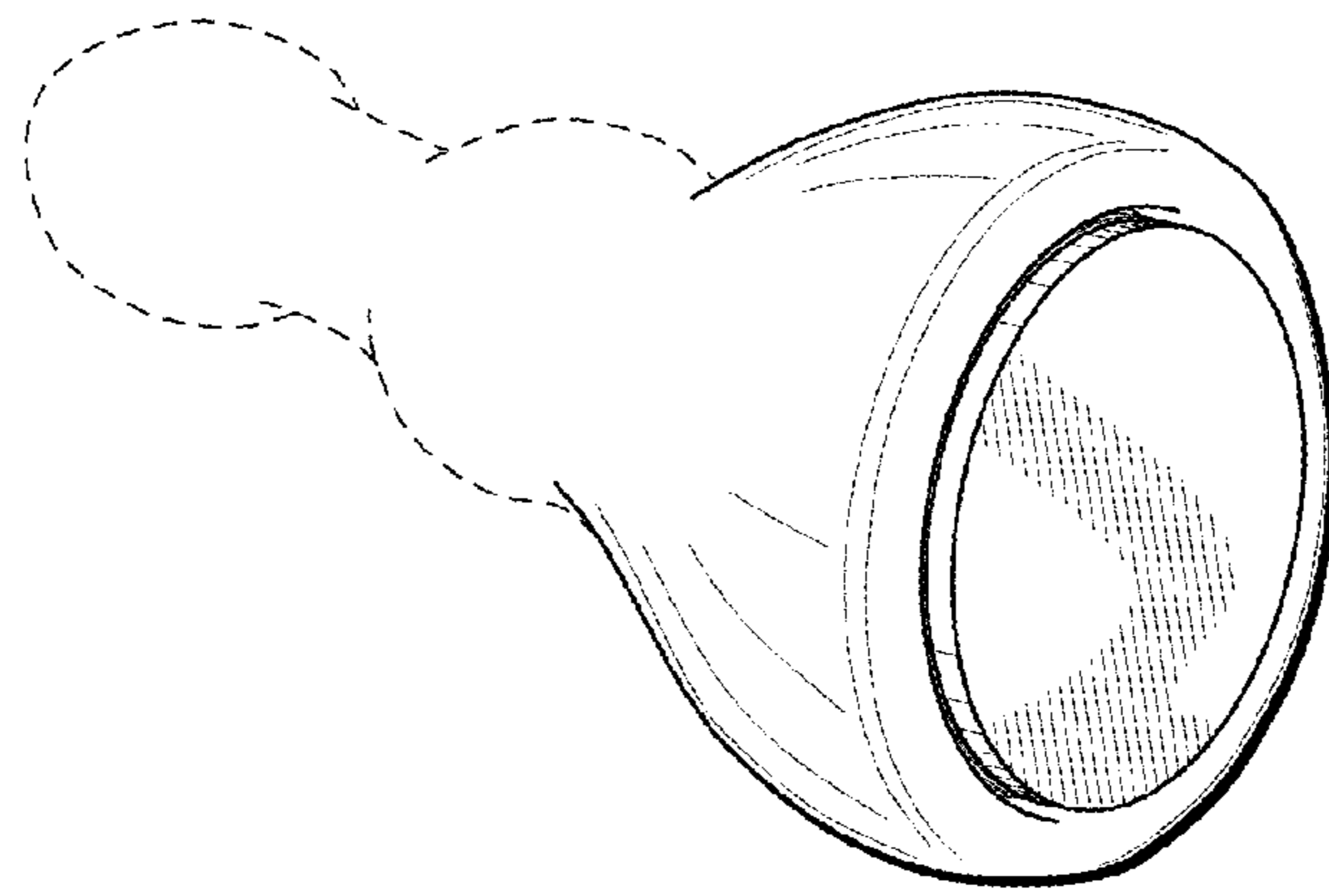

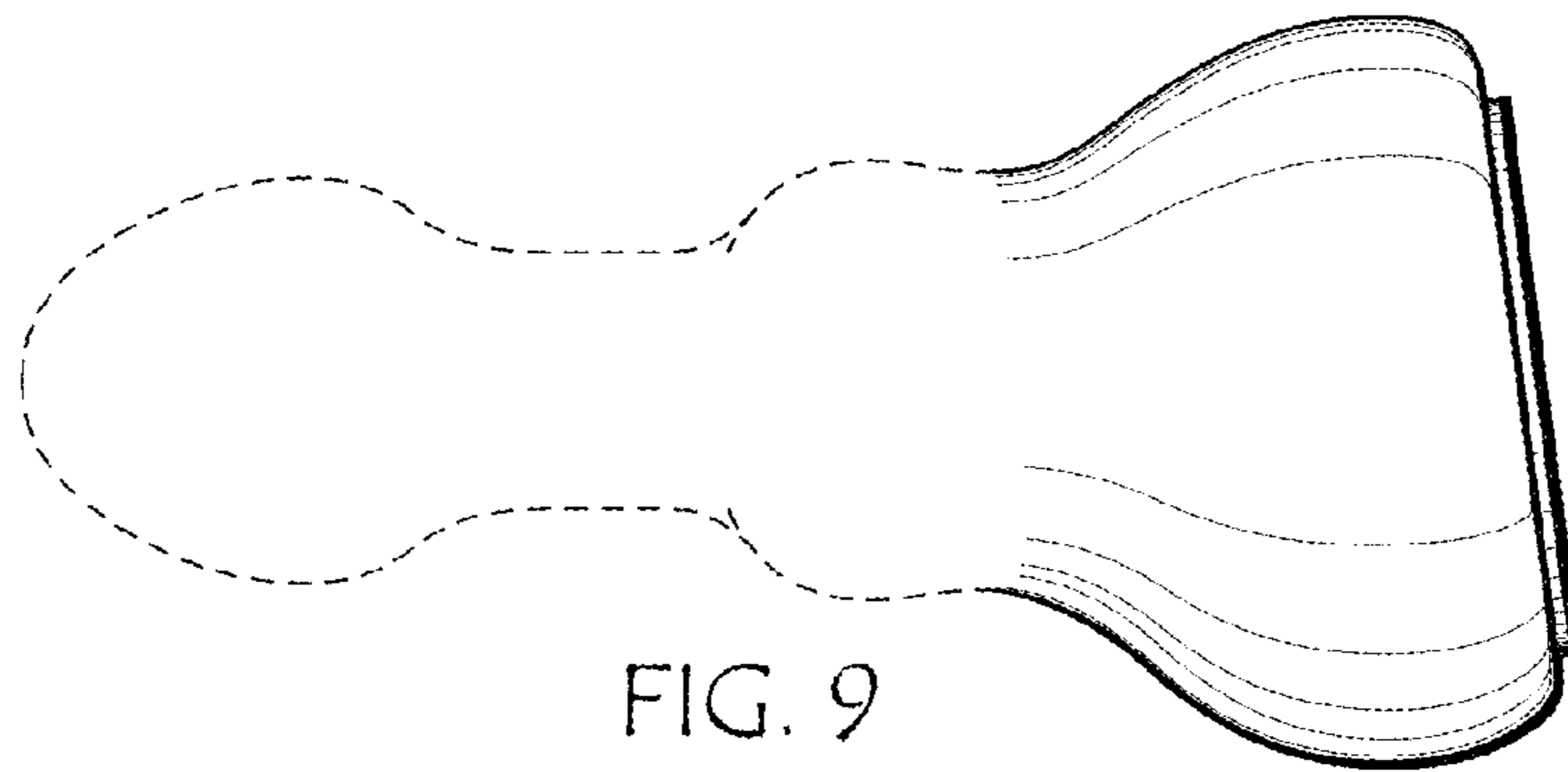

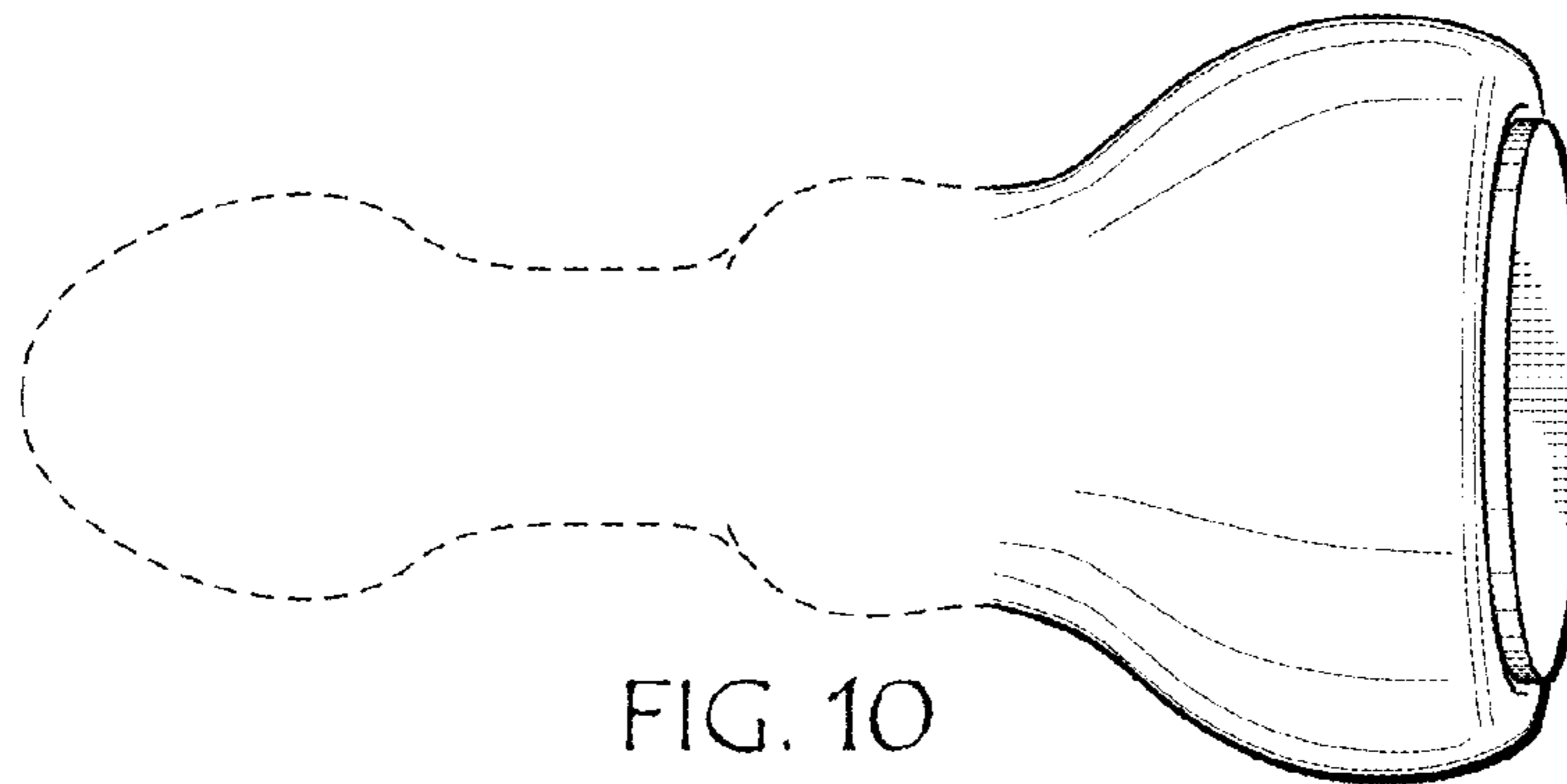

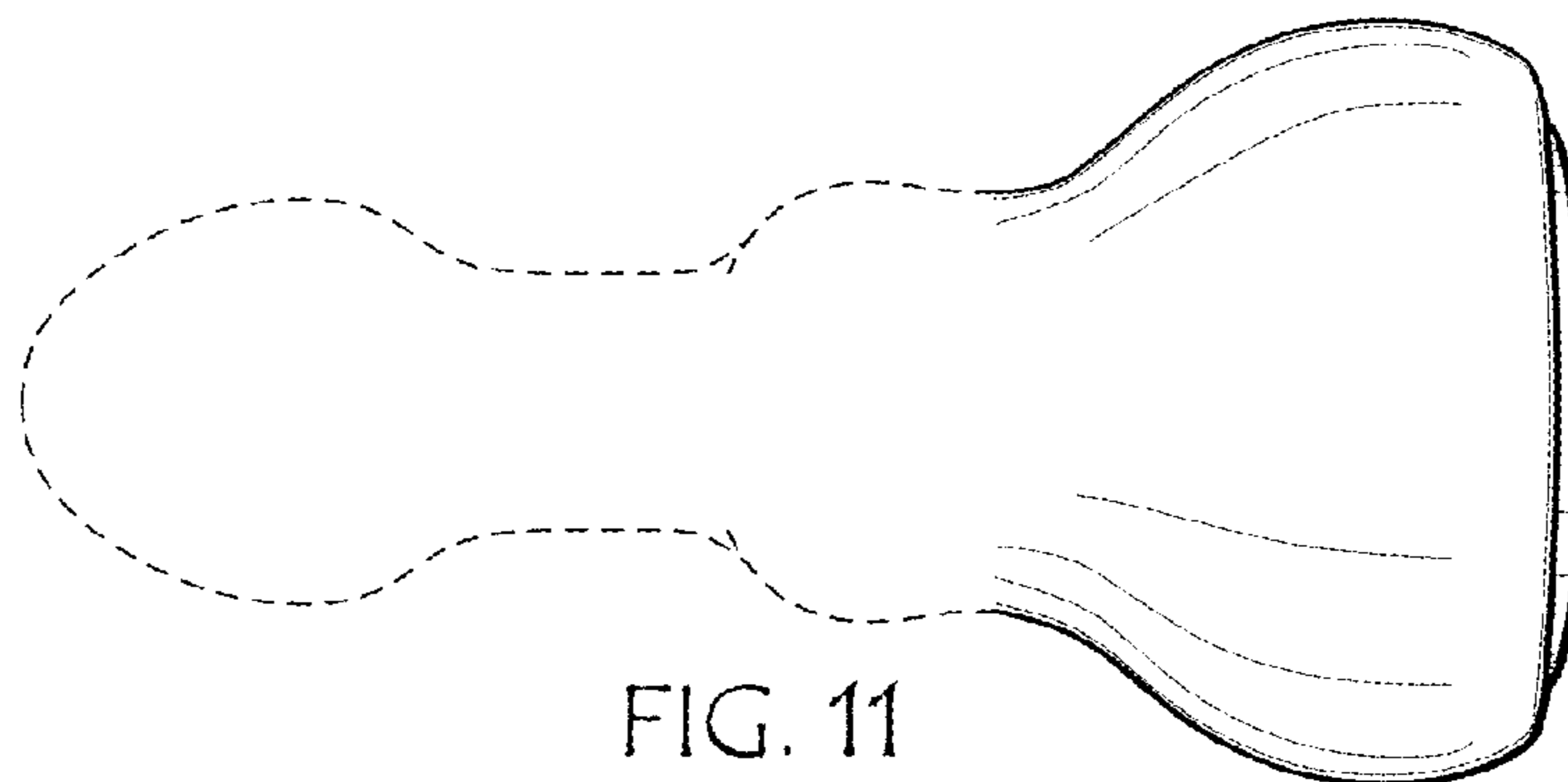

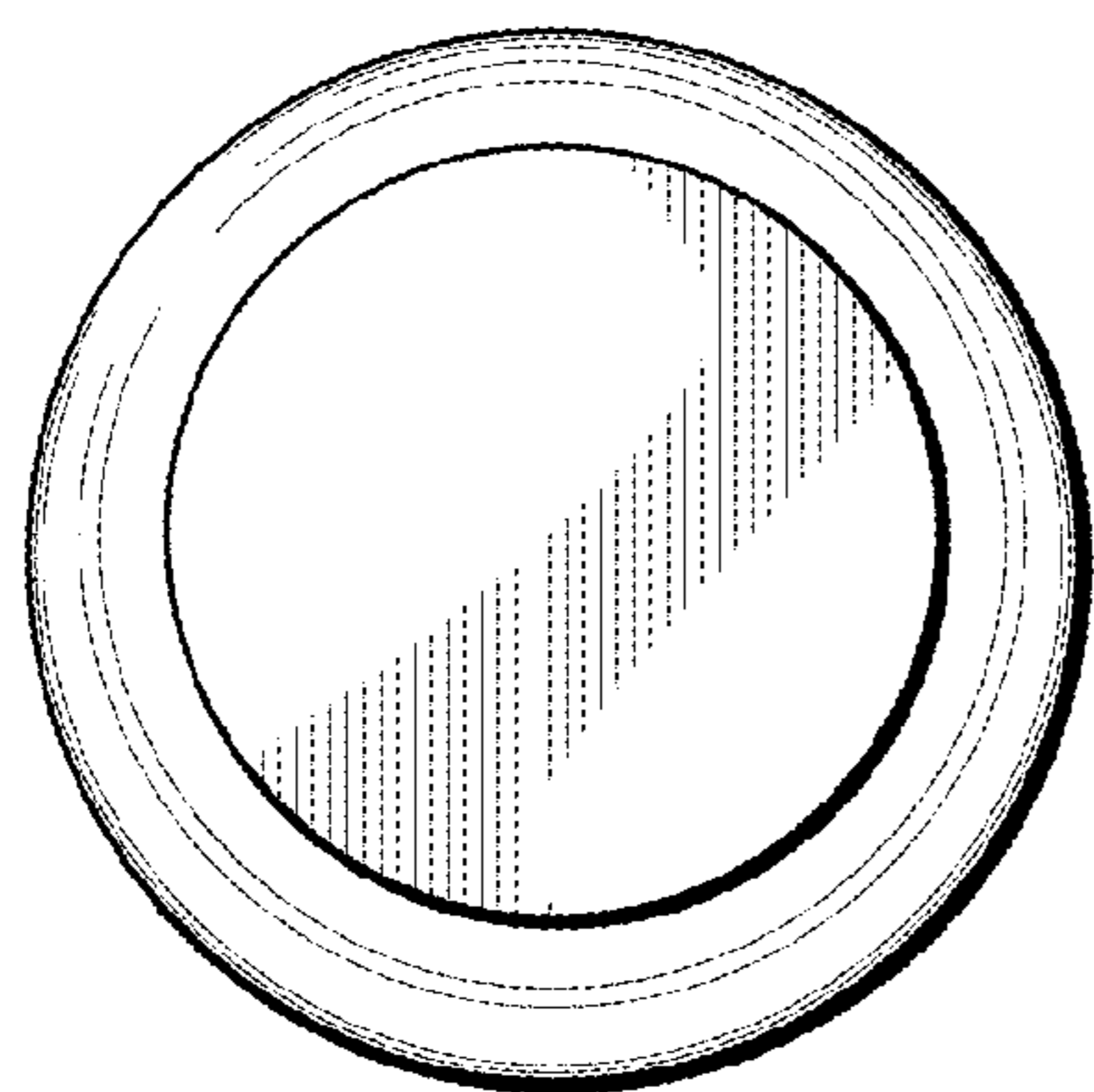

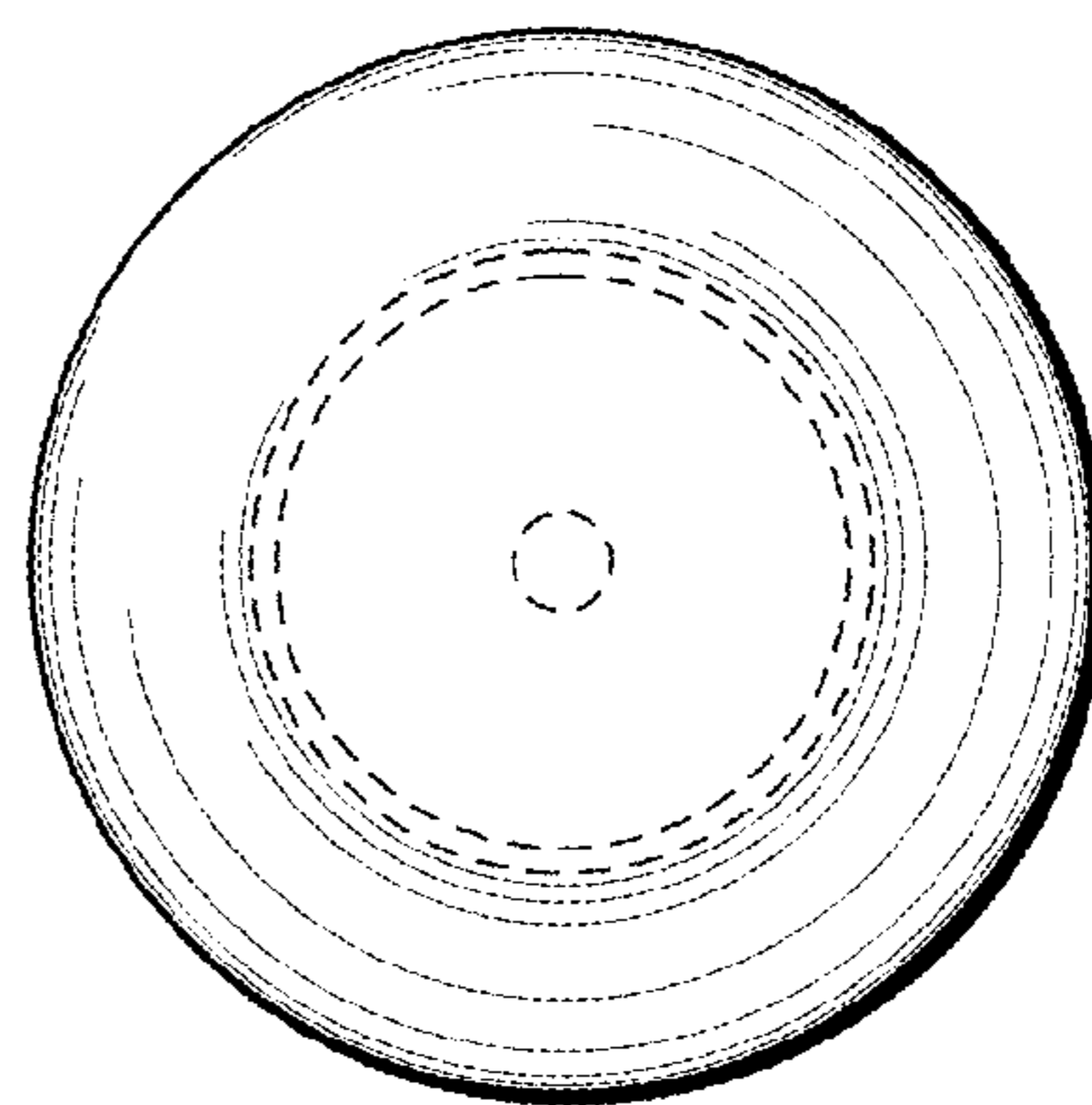

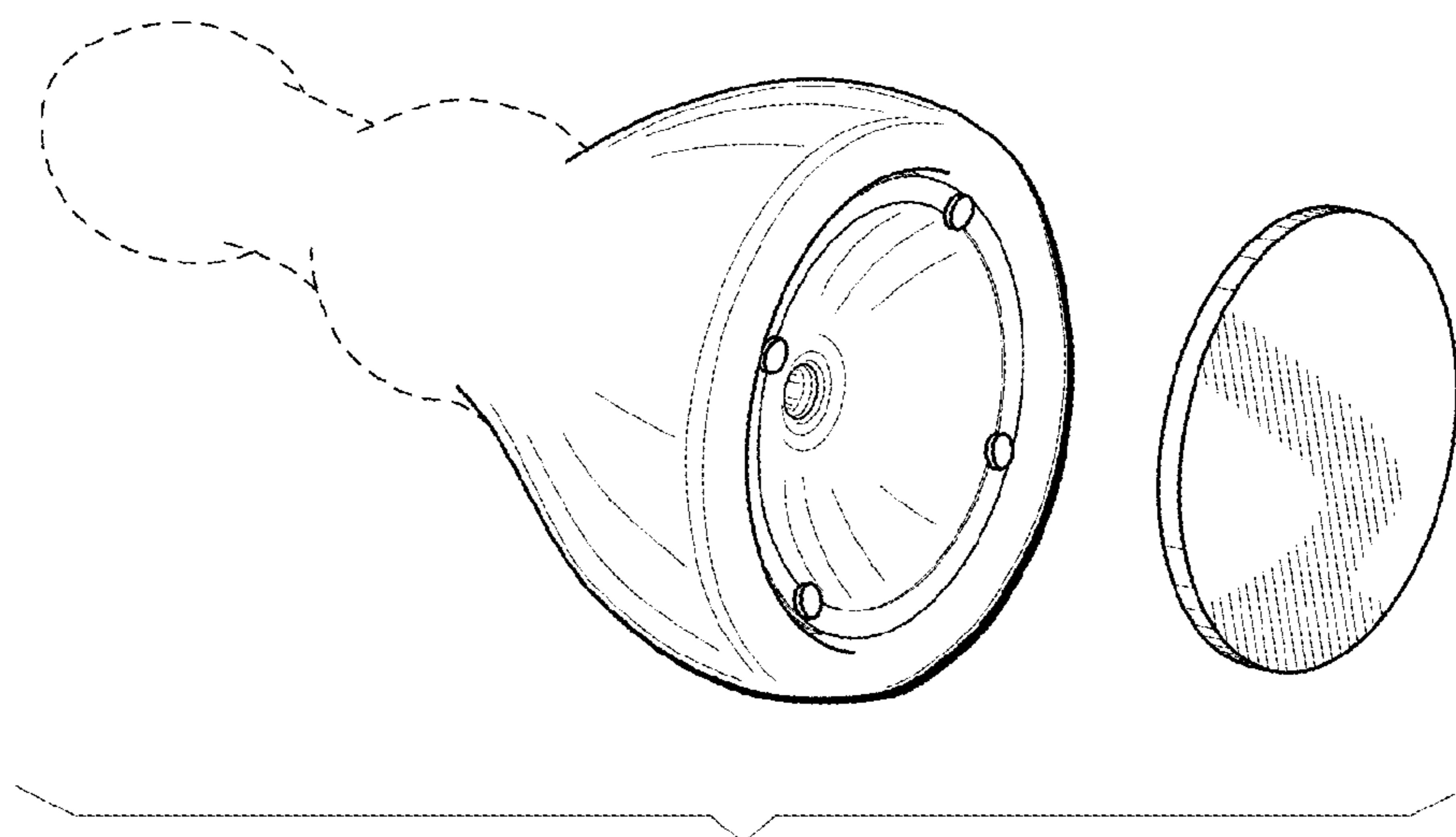
