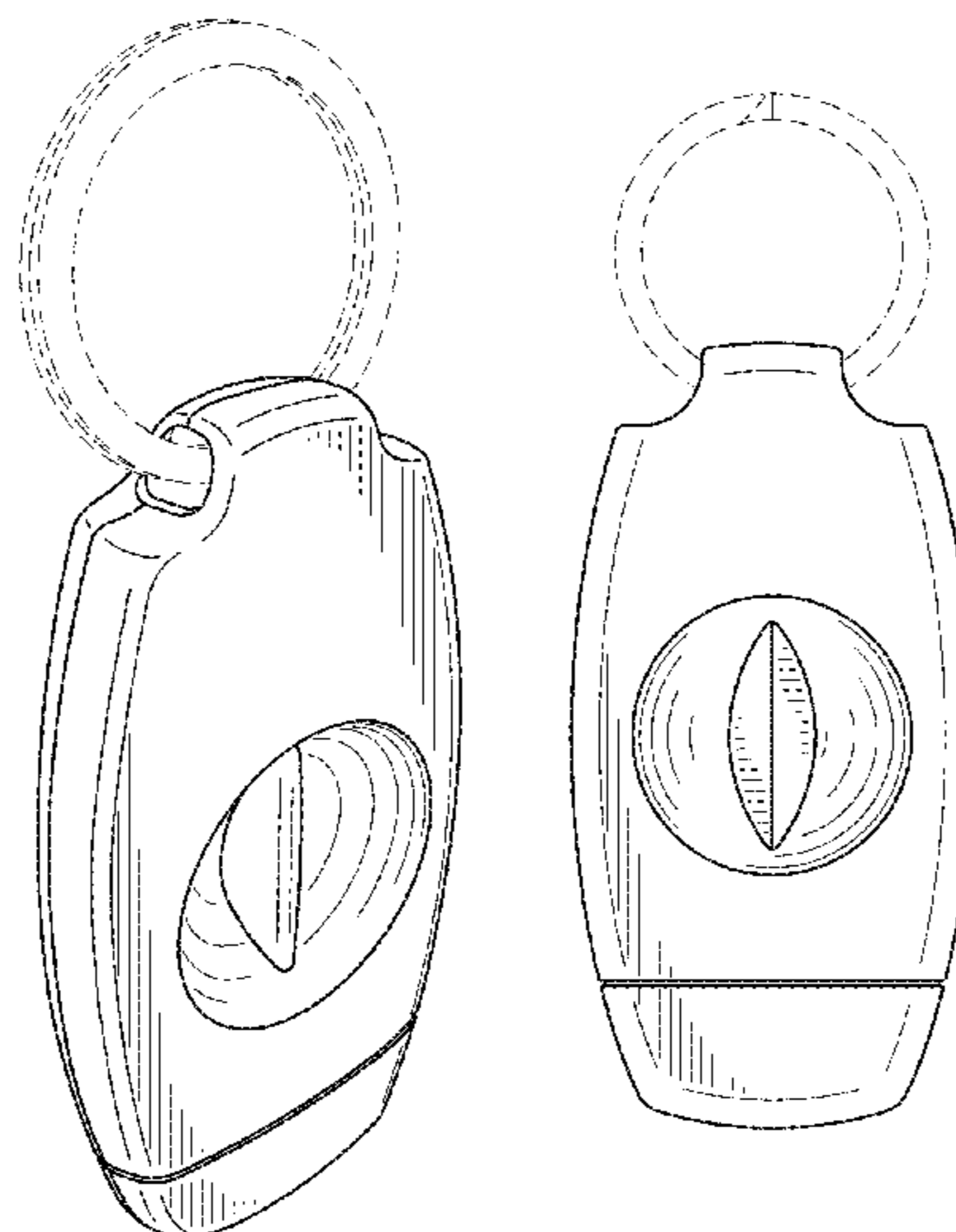
(57) **CLAIM**

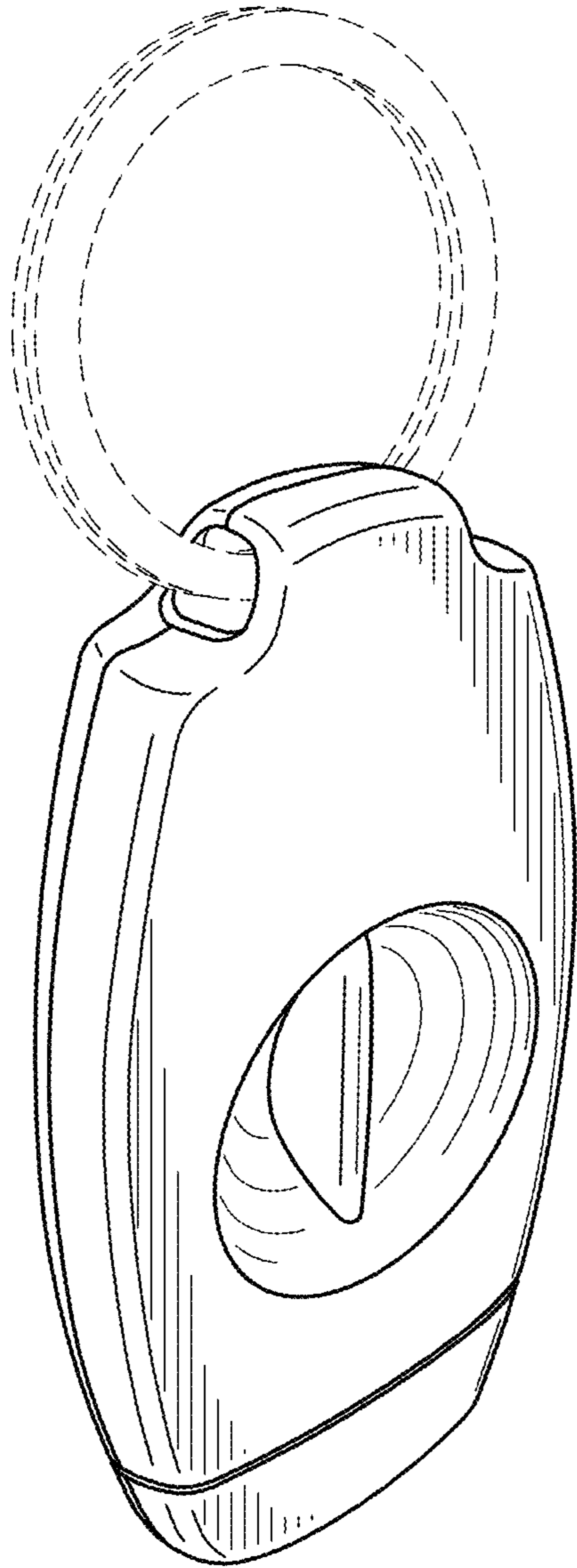
The ornamental design for a cigar cutter key chain, as shown and described.

**DESCRIPTION**

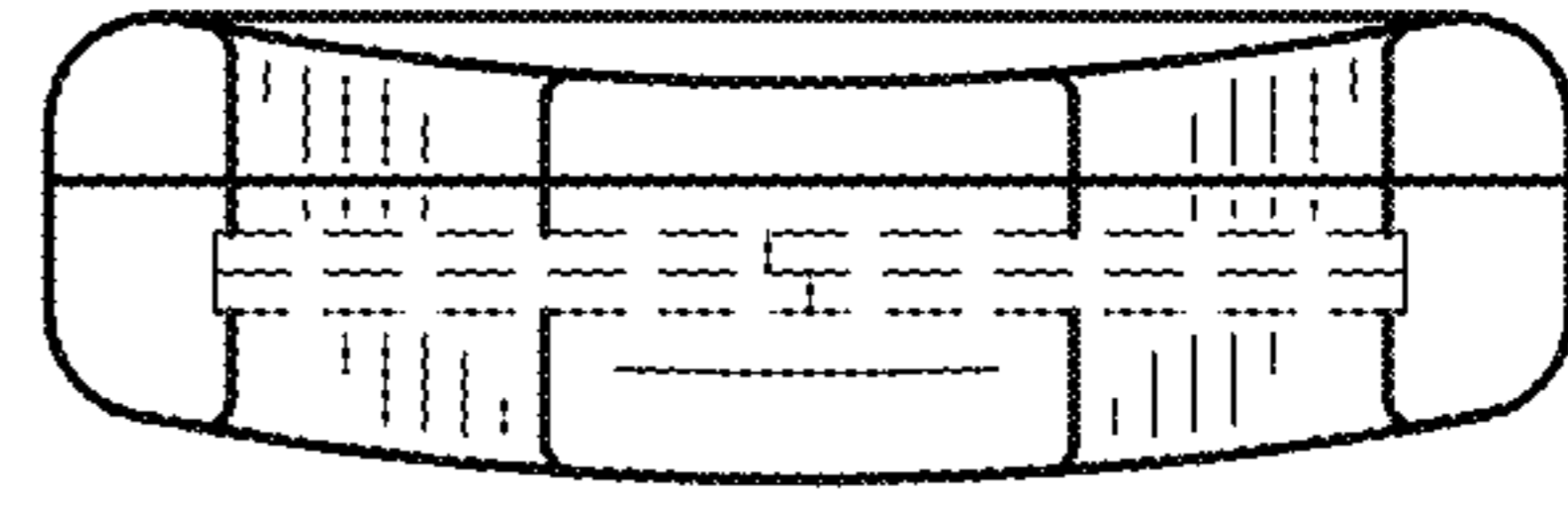
FIG. 1 is a perspective view of the cigar cutter key chain in accordance with the present invention;  
FIG. 2 is a top plan view of the cigar cutter key chain shown in FIG. 1;  
FIG. 3 is a front elevation view of the cigar cutter key chain shown in FIG. 1;  
FIG. 4 is a rear elevation view of the cigar cutter key chain shown in FIG. 1;  
FIG. 5 is an elevation view of one side of the cigar cutter key chain shown in FIG. 1, the other side being a mirror image thereof; and,  
FIG. 6 is a bottom plan view of the cigar cutter key chain shown in FIG. 1.

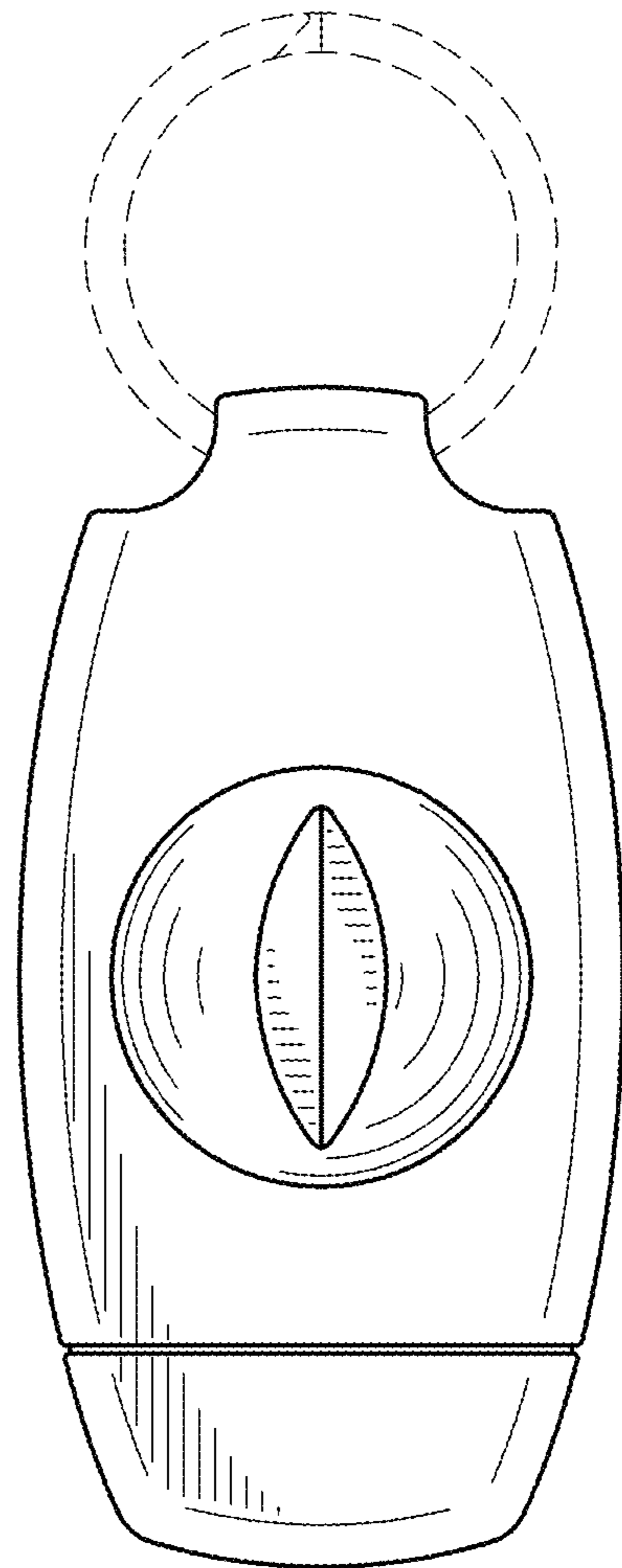




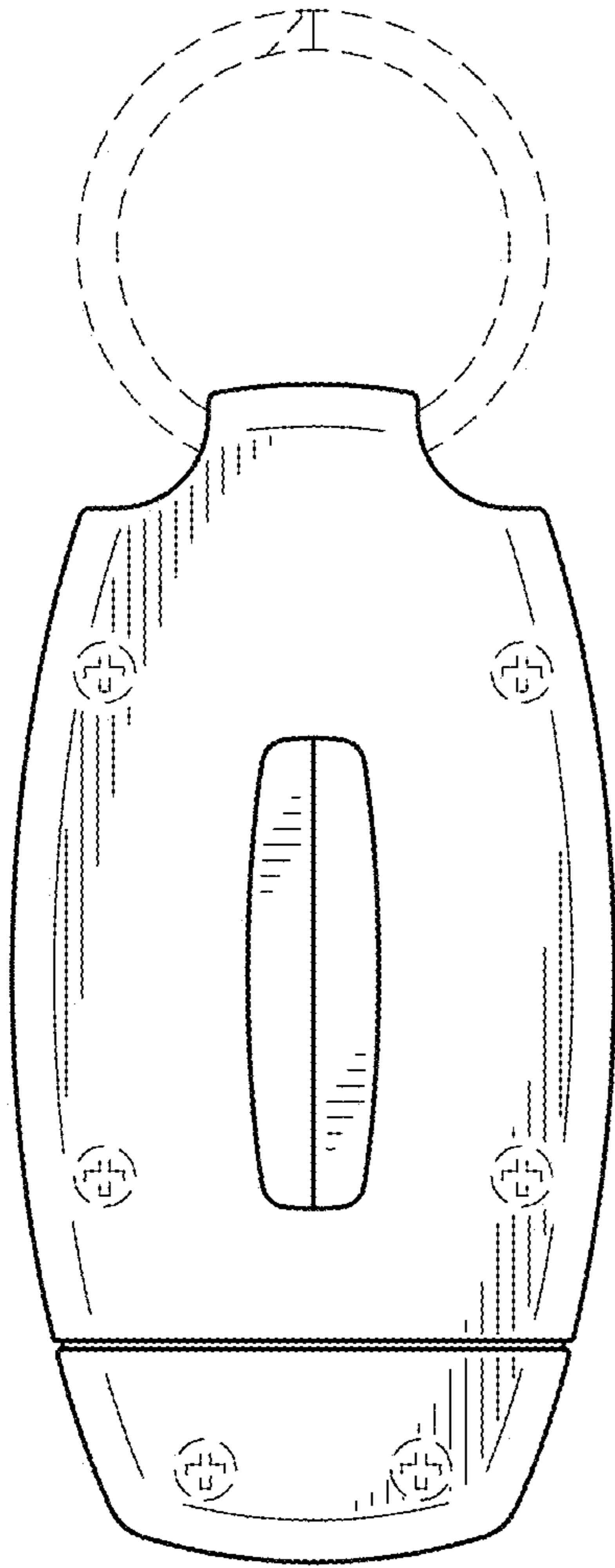

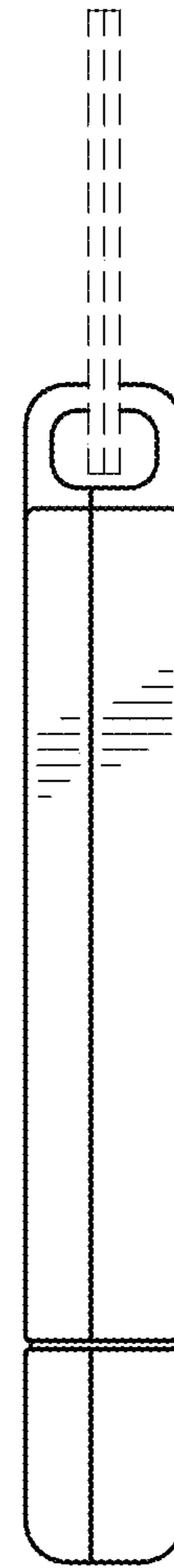

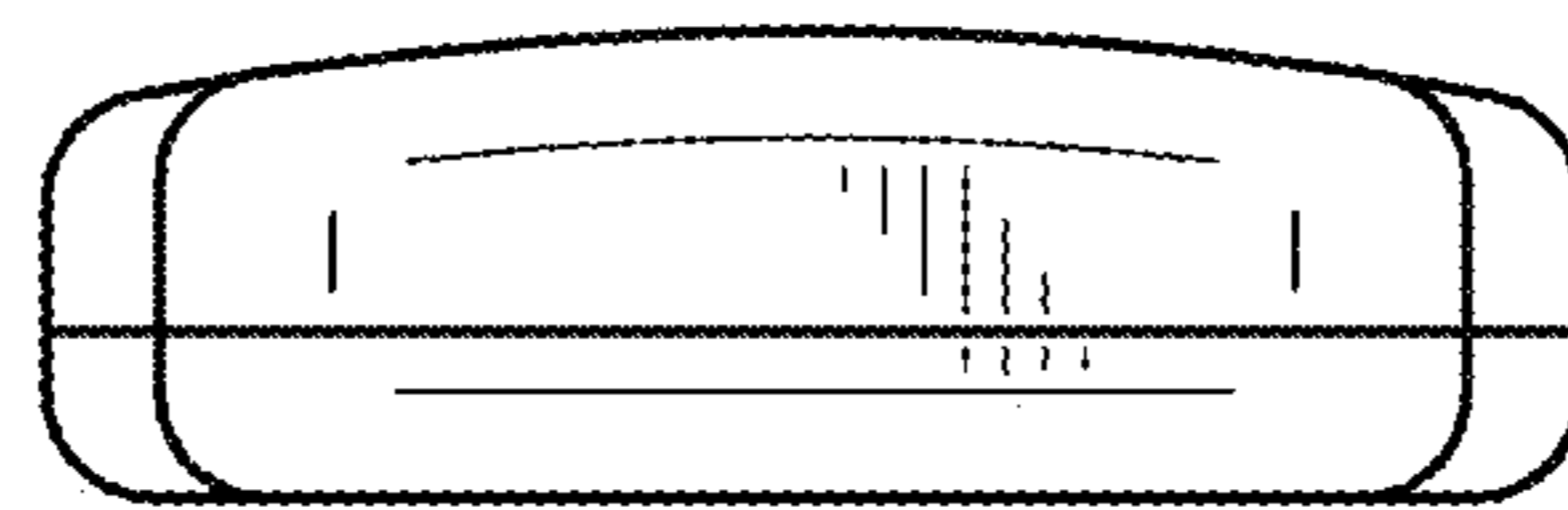
