(57) **CLAIM**

The ornamental design for nose hair cutter, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a nose hair cutter in accordance with my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof, a bottom plan view being a mirror image thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a front elevational view of the nose hair cutter with the cap removed;

FIG. 7 is a top plan view of the nose hair cutter shown in FIG. 6, a bottom plan view being a mirror image thereof;

FIG. 8 is a rear elevational view of the nose hair cutter shown in FIG. 6;

FIG. 9 is an enlarged left side elevational view of the nose hair cutter shown in FIG. 6;

FIG. 10 is a front elevational view of the nose hair cutter with the cap removed and the inside edge part rotated as compared to FIGS. 6; and,

FIG. 11 is an enlarged left side elevational view of the nose hair cutter shown in FIG. 10.

The broken lines shown in the drawings illustrate the interior portions of the nose hair cutter and form no part of the claimed design.

The cap has been removed in FIGS. 6-11 for convenience of illustration.

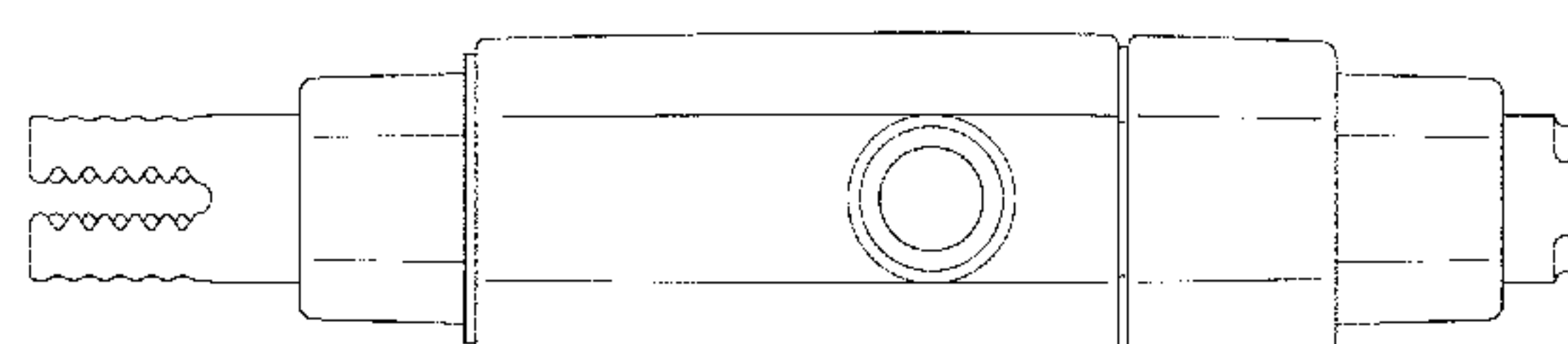
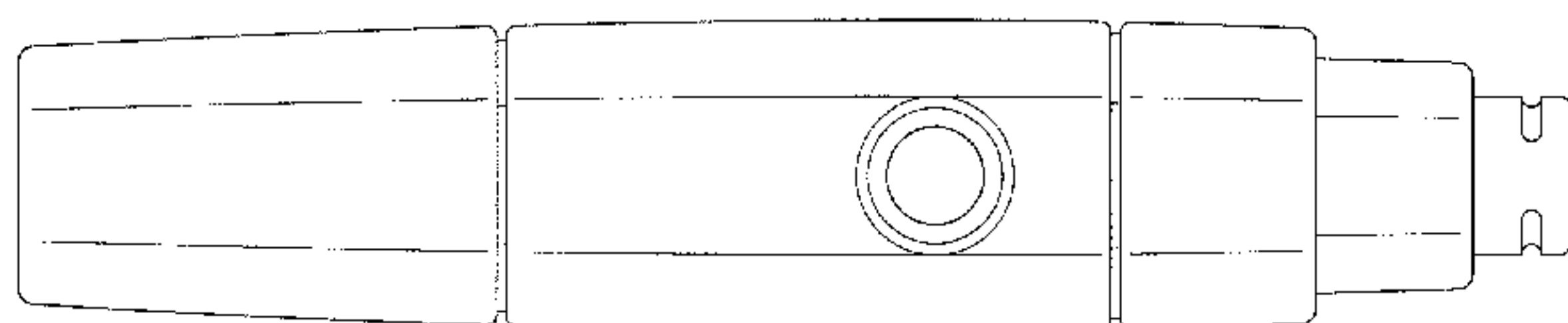

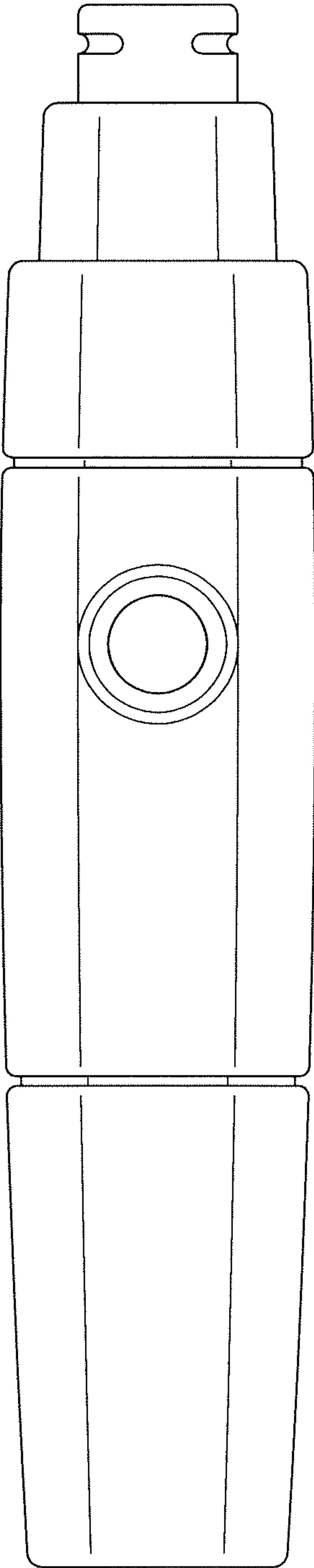

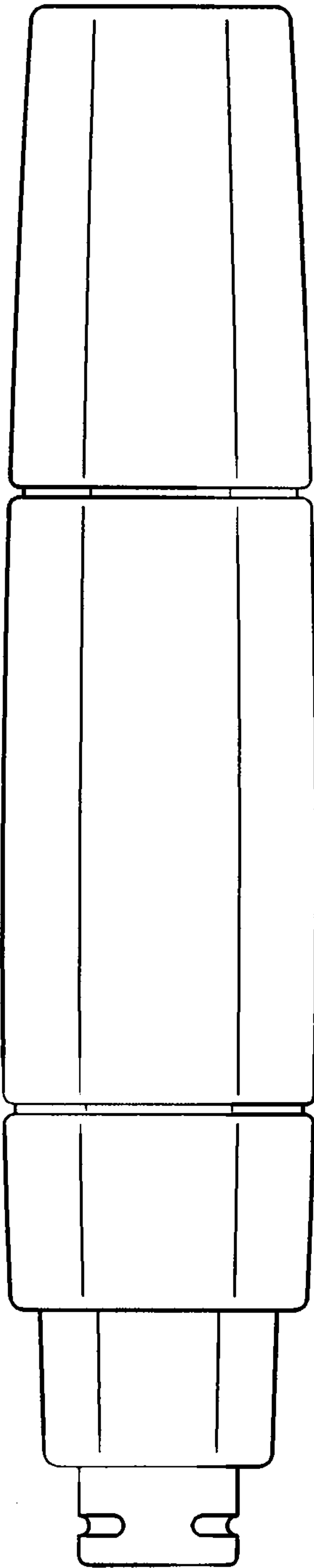

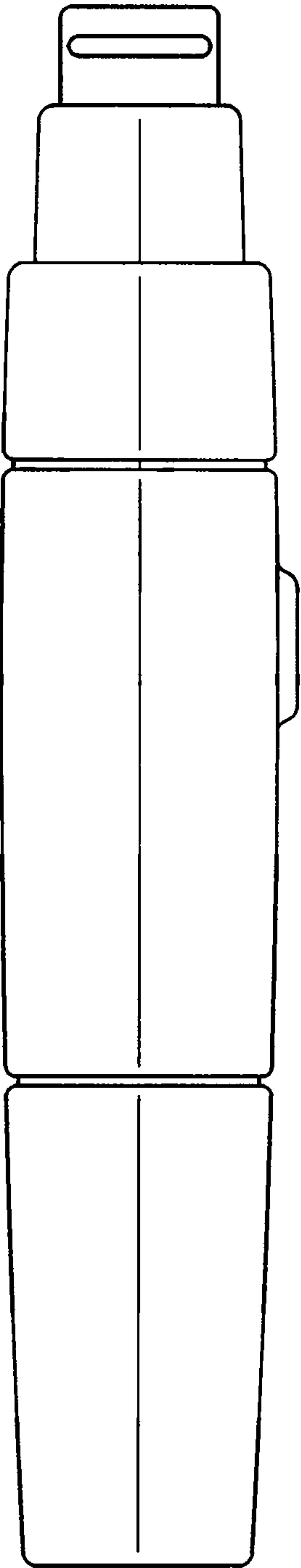

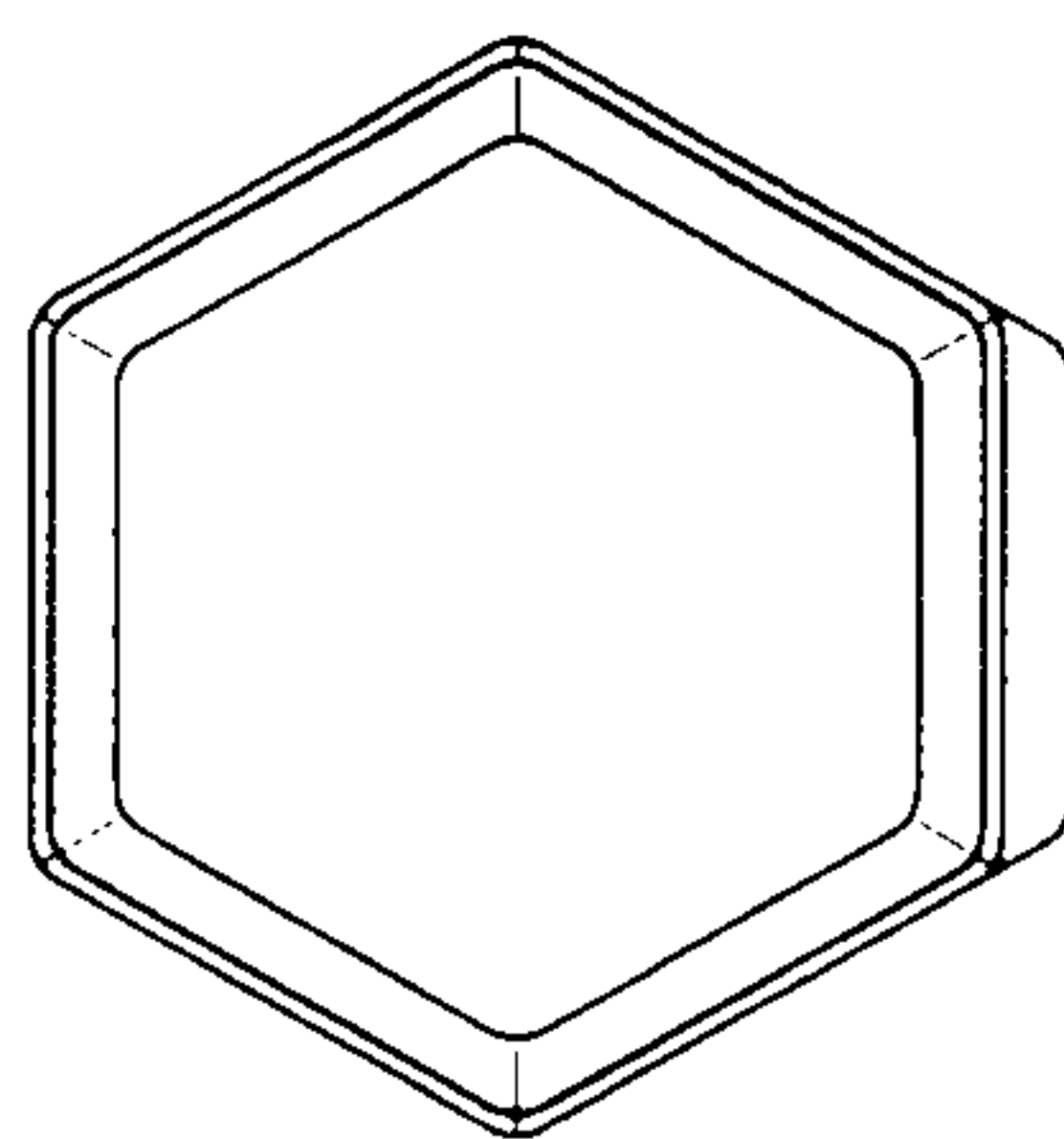

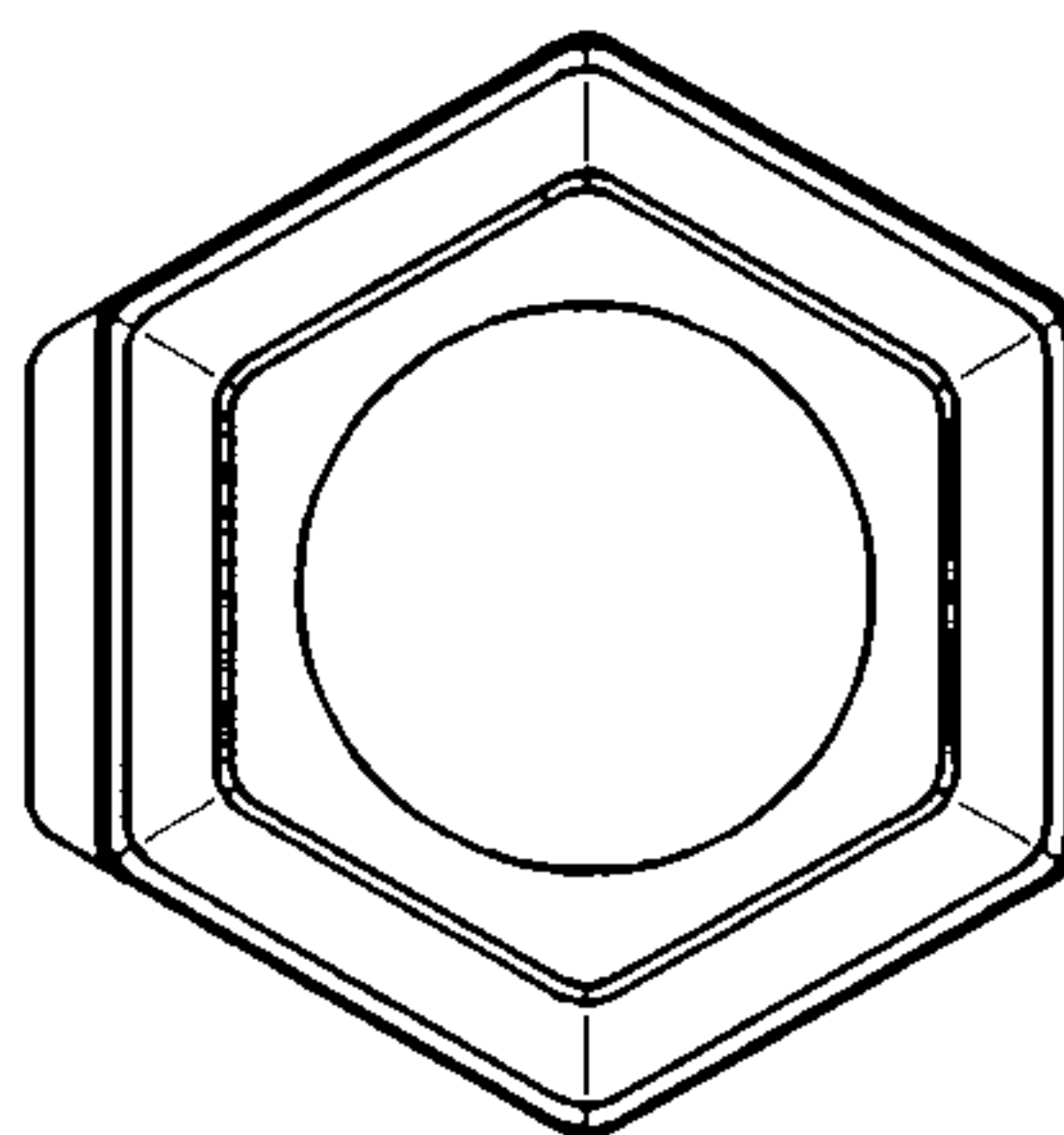

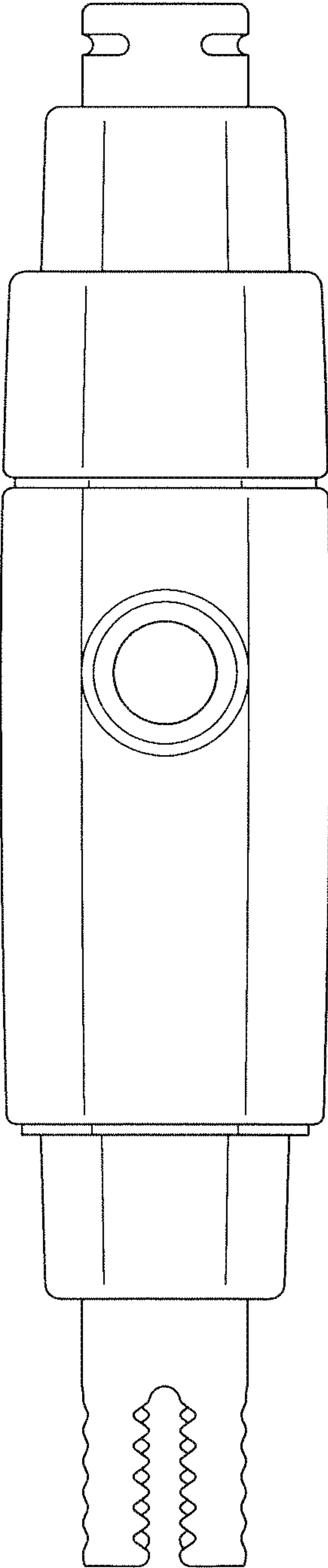

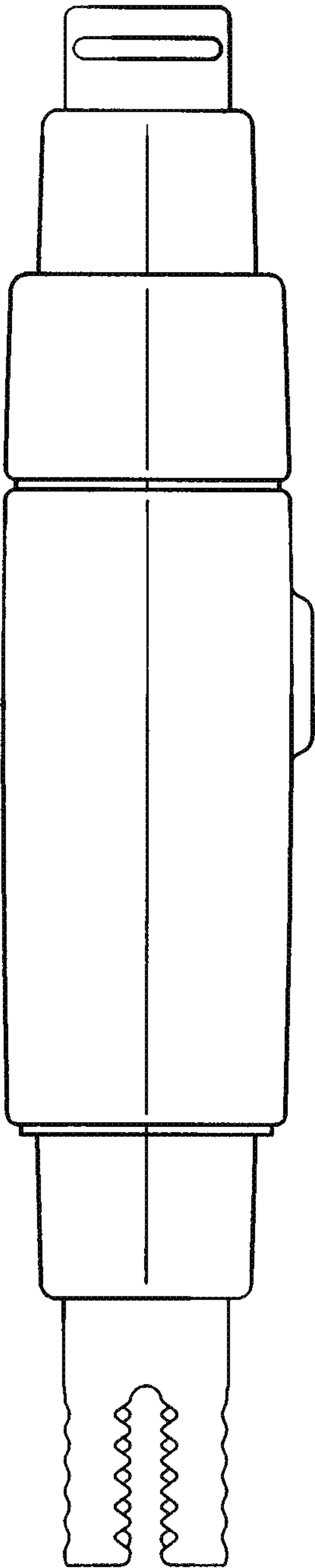

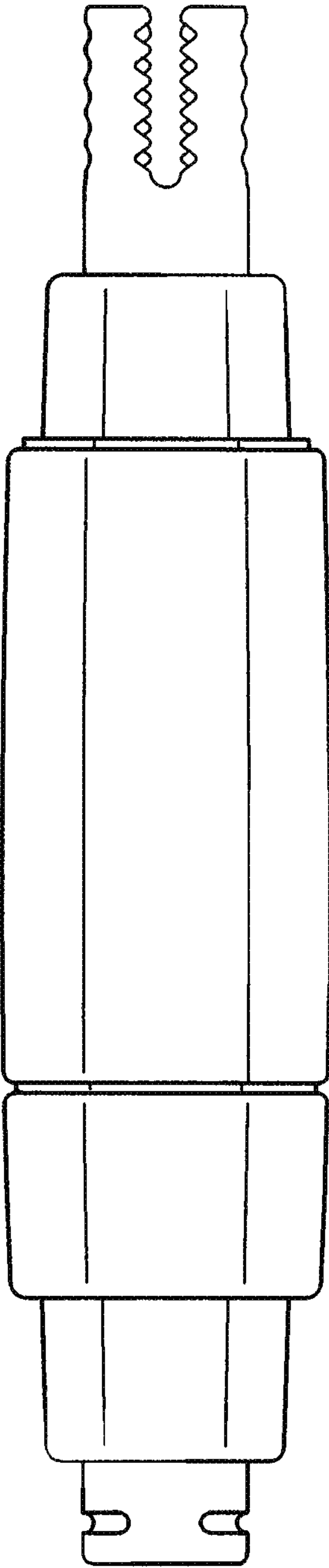

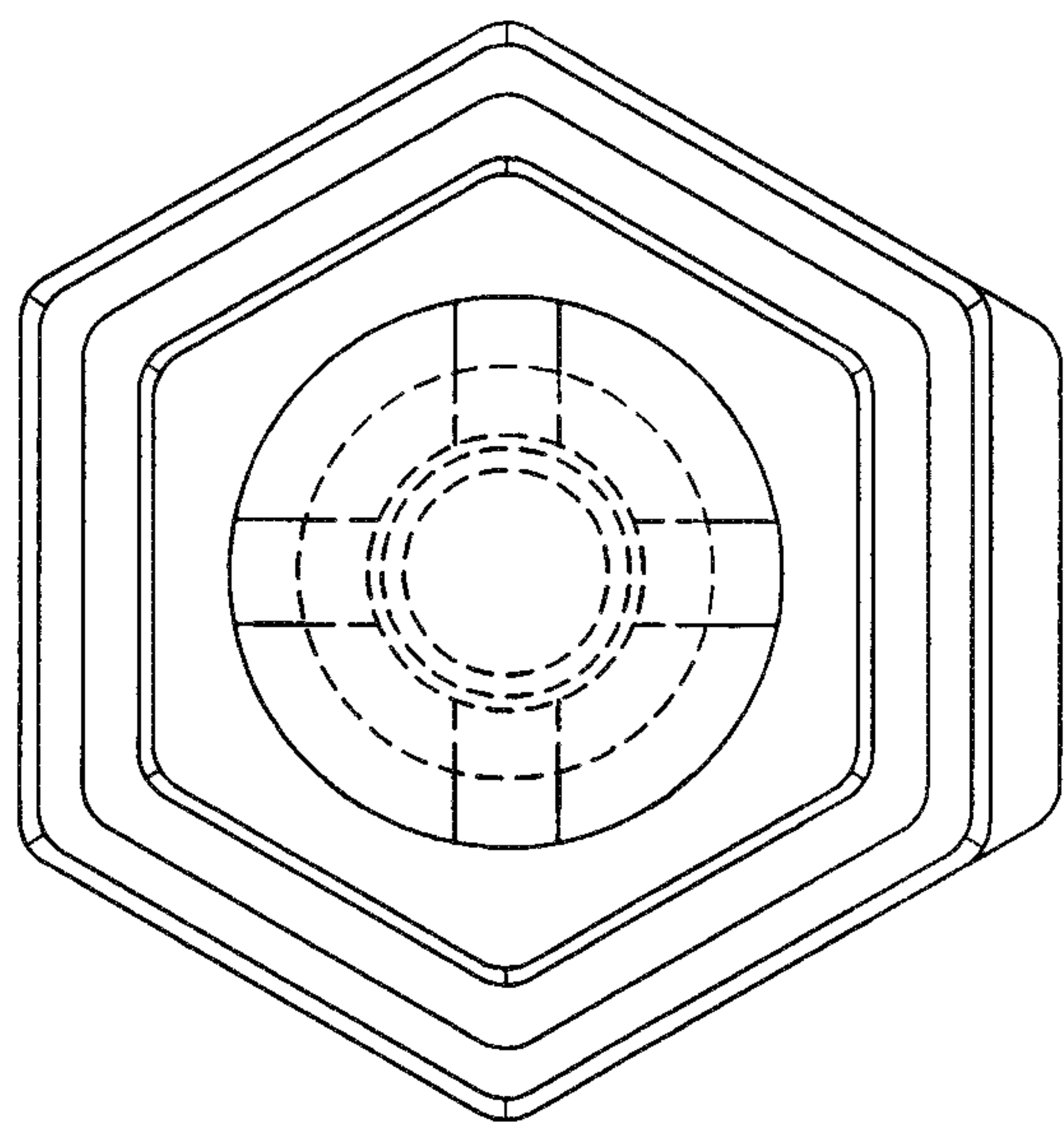

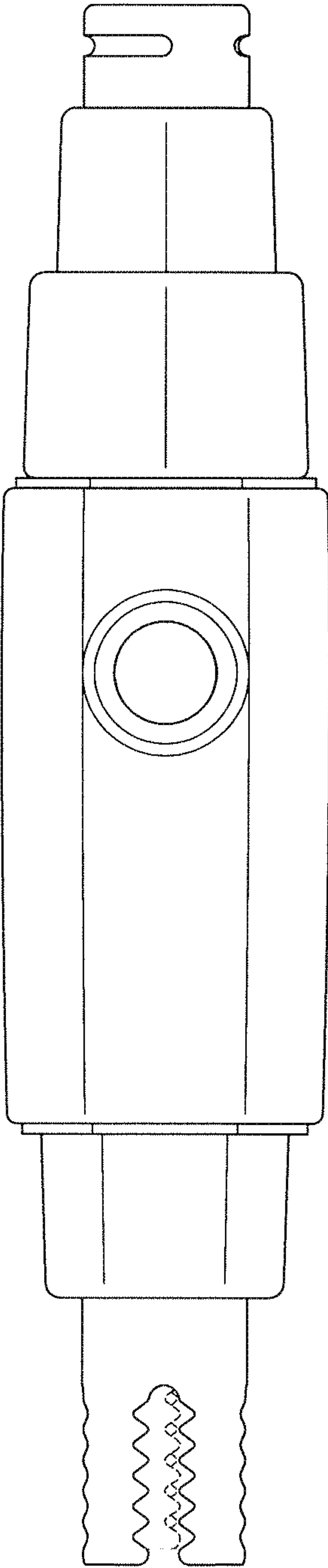
