DESCRIPTION

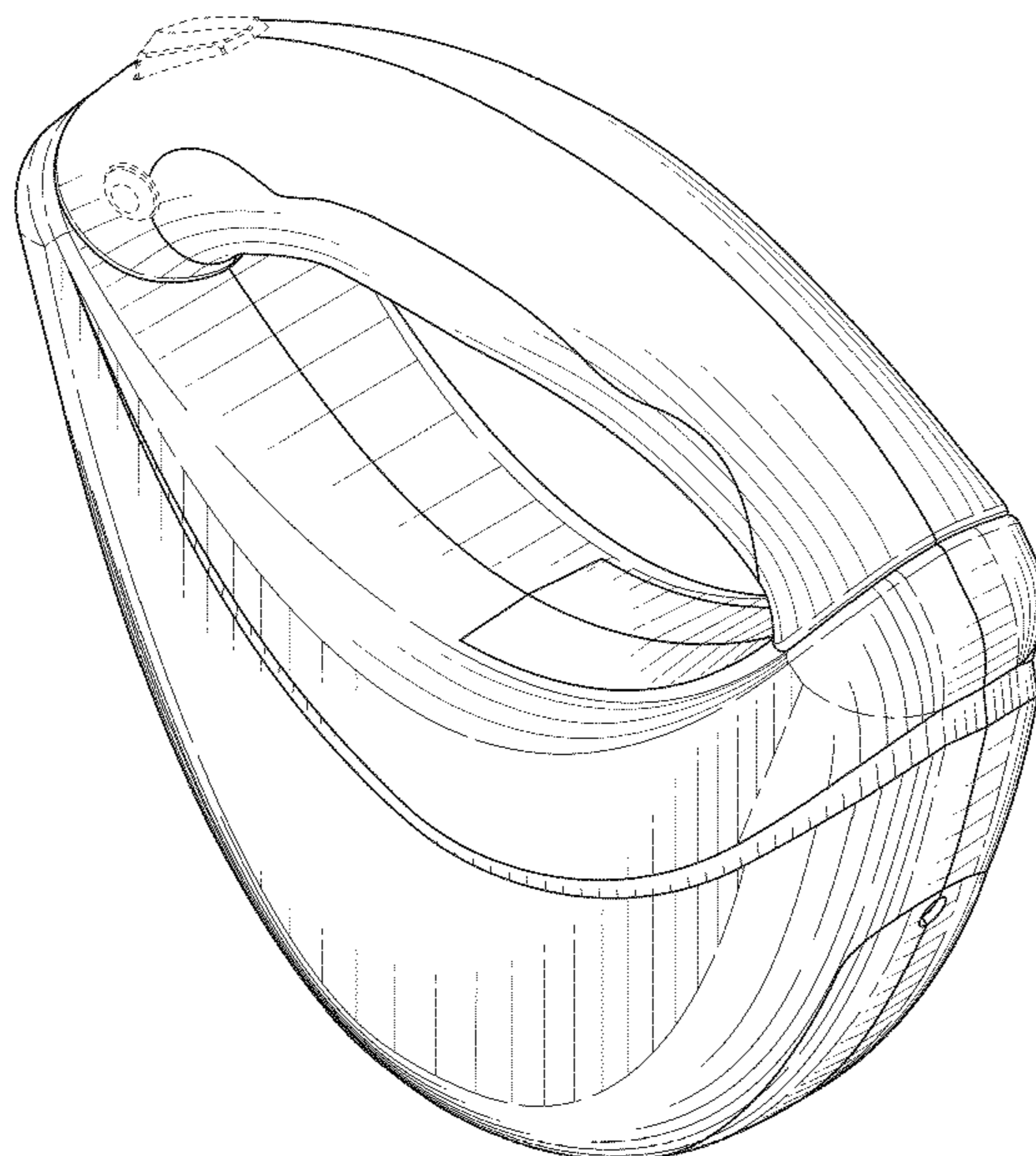
FIG. 1 is a right front perspective view of a retractable pet leash showing my new design;

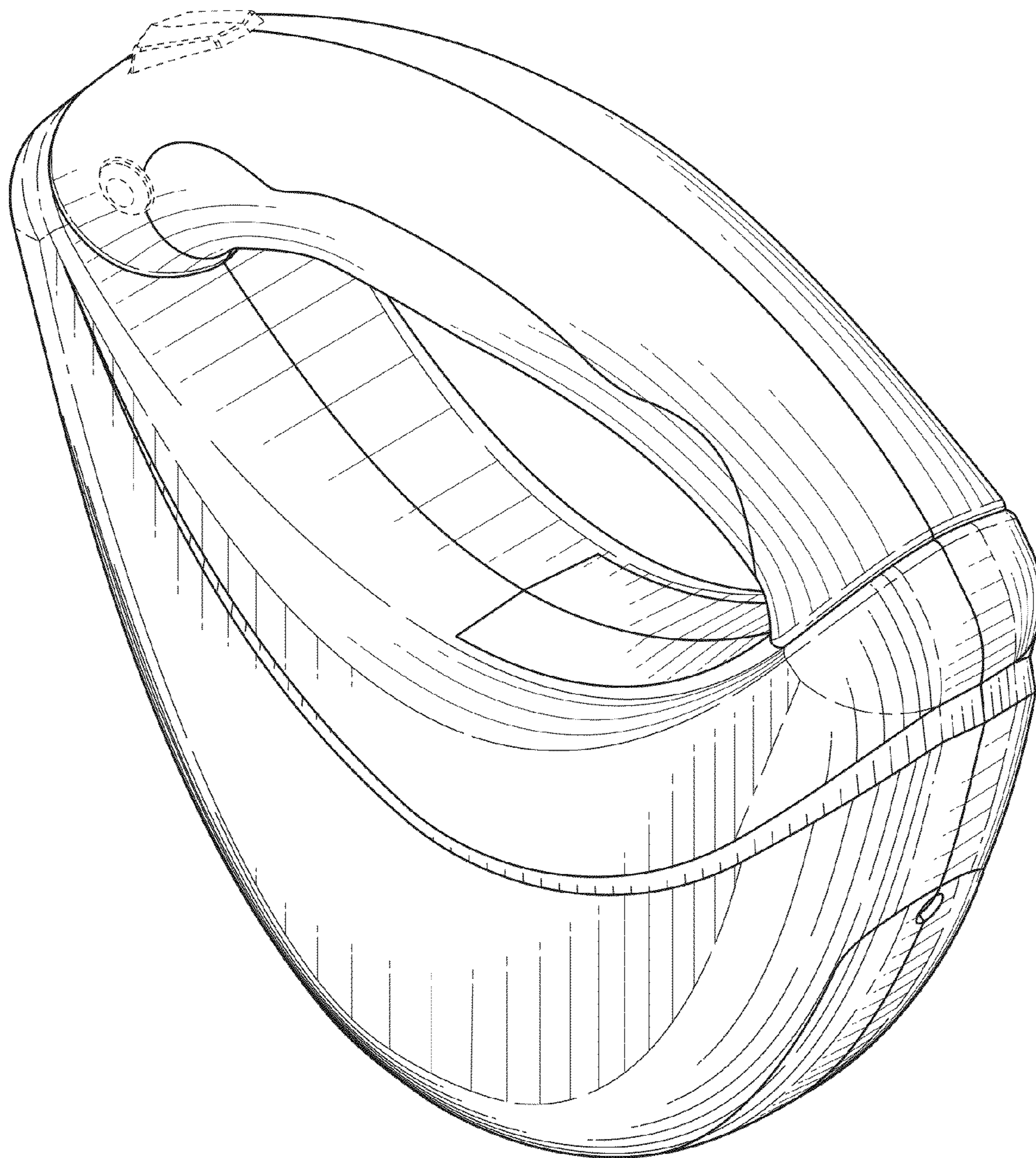

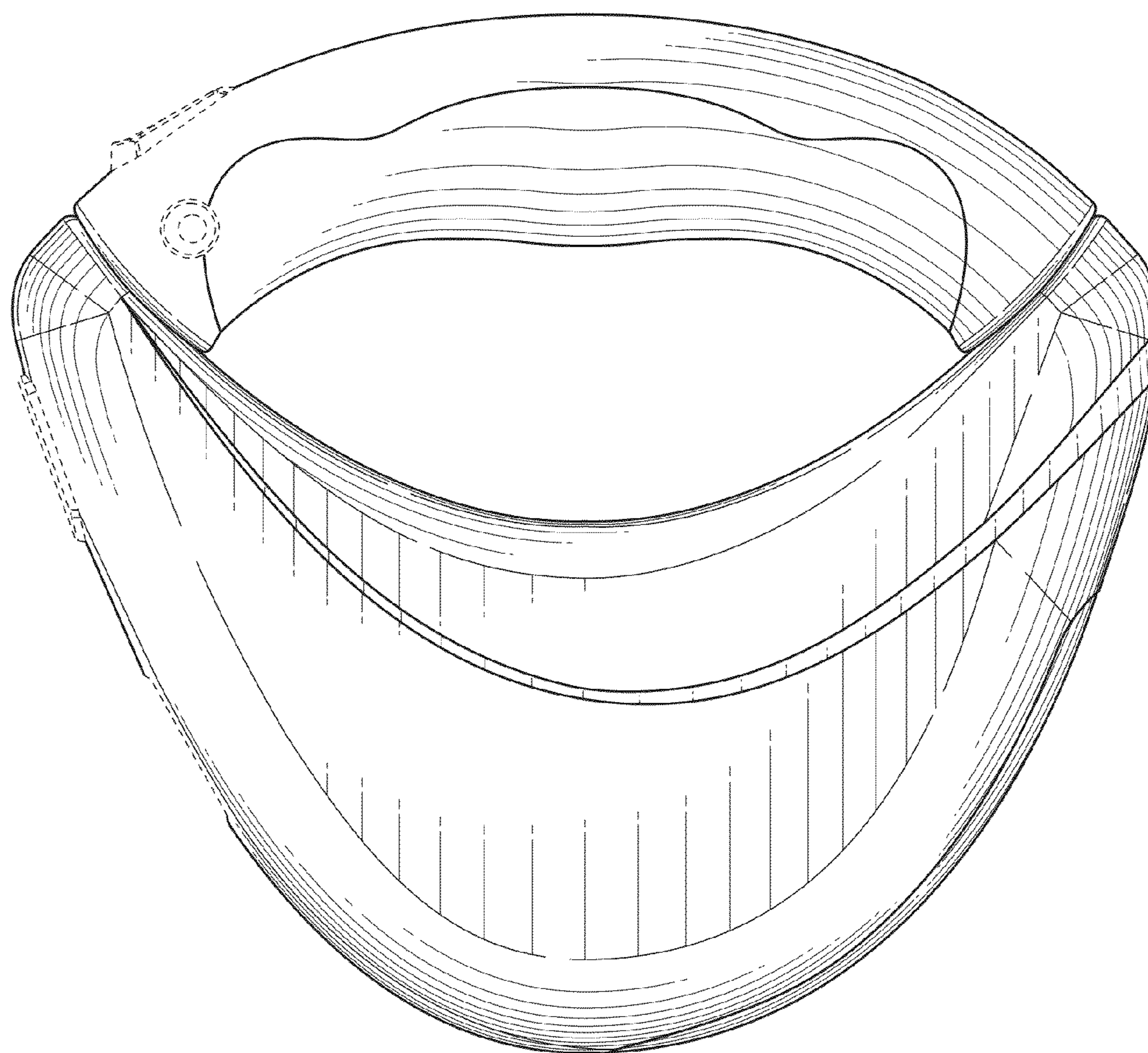

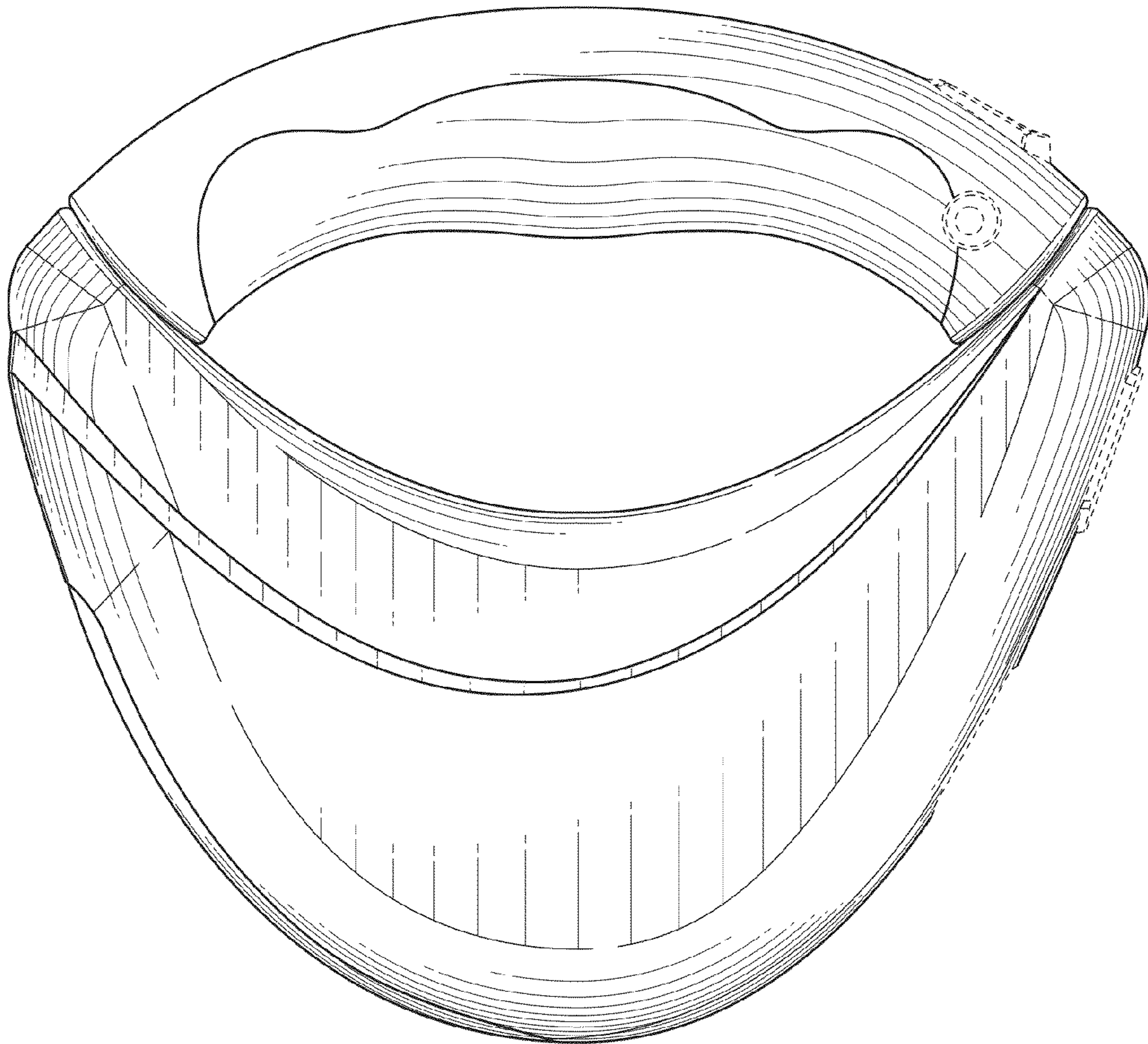

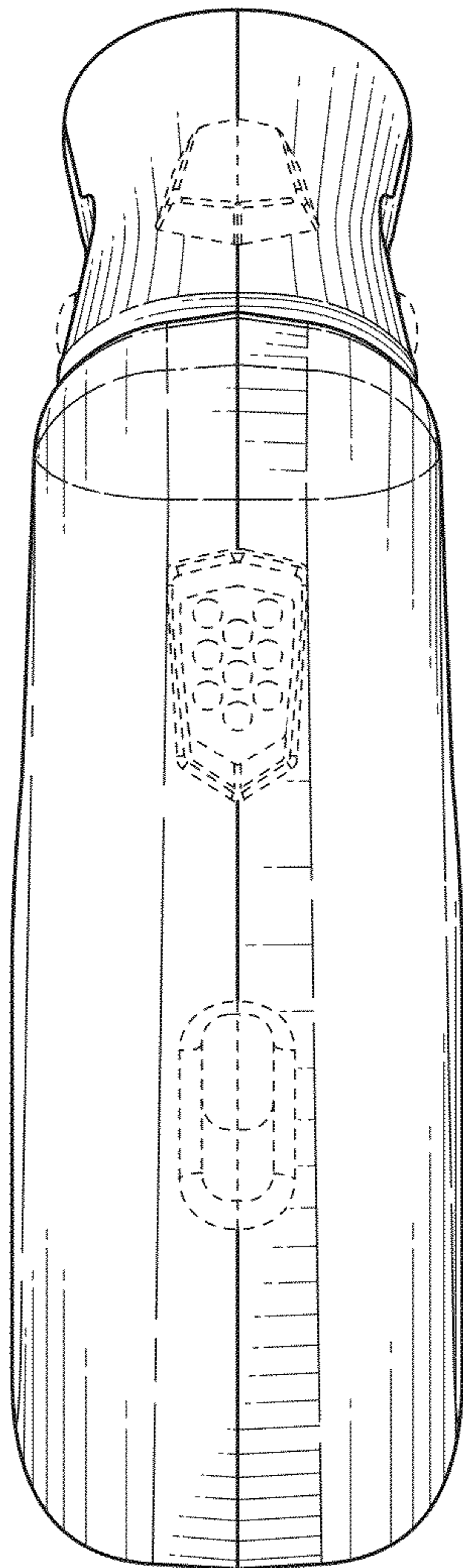

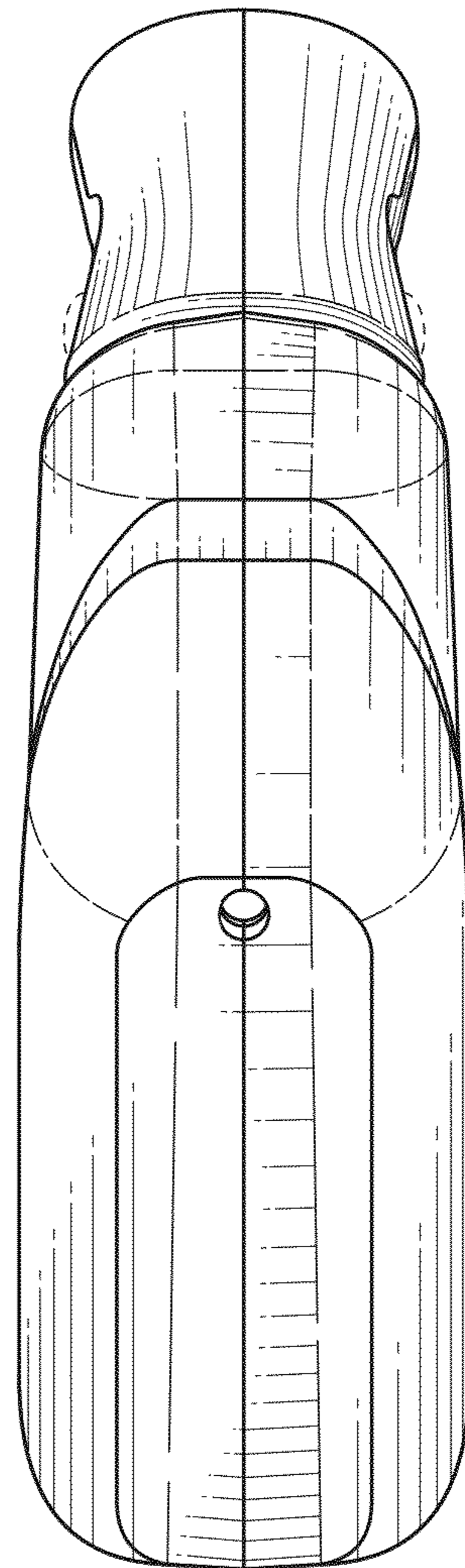

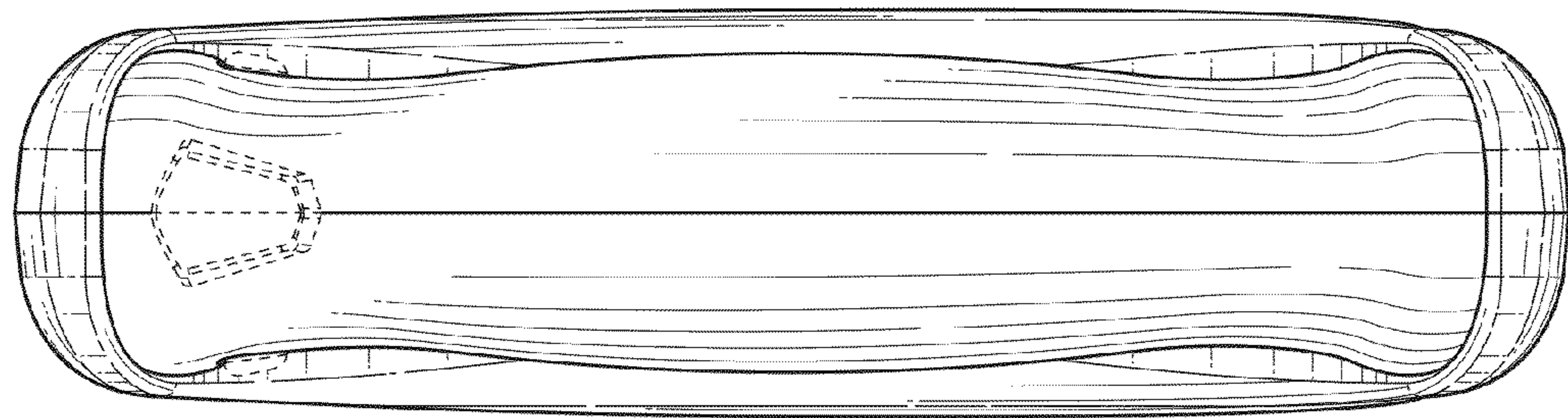

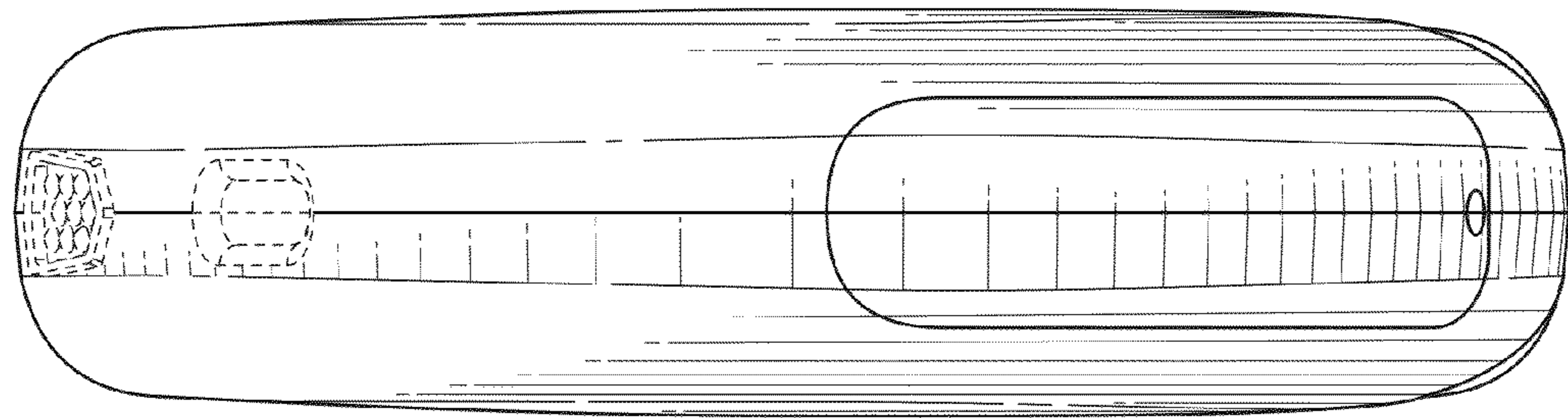
